Maj (retd) Muhammad Badr-Ul Islam passed away yesterday at Combined Military Hospital. He was 59, said a press release.

He had been suffering from hepatocellular carcinoma.

He left behind his wife Farida Yasmin, three children Zeehad Usayed, Sababa and Hisham, and siblings Qamrul Islam and Tania Parvez.

He was son of late Shamsul Islam and Qamrunnesa Begum, both physics professors at Dhaka University

Badr-Úl Islam received honors in civil engineering from Buet and graduated from Bangladesh Military Academy 7th Long Course in 1982 with the President's Gold Medal.

He served in many appointments in the Corps of Engineers, and Army Headquarters and also served as Brigade Major in the Infantry Brigade.

He took early retirement for health reasons.

Criticising a remark made by BNP's secretary general Mirza Fakhrul Islam Alamgir about "allowing no more time to the government", Quader, also secretary general of Awami League, asked, "Who is he [Fakrul] to allow the government in power?"

In the lecture, he briefly discussed the central arguments in his thesis. He also shed light on how some instrumental strategies were used in Bangladesh during and after the regime ruled by the military dictator Maj Gen Ziaur Rahman to make him popular.

With his research, he also noted that the privatisation of education is not "merely a process of tangible establishments, but rather a pointed mission of undermining the public educational establishments and popularising the private ones."

"Consequently, it is structurally related with one another - promoting images of private higher educational institutes and demoting the public ones. The process features a set of vocabularies, like 'international standards', or 'educational qualities', which are propagated in the media."

While presiding over the virtual discussion, writer, researcher, and journalist Afsan Chowdhury said, "It is very important to understand the mechanics behind any event, whether it is fuelled by popularity or seizure of popularity.

When people talk about the great achievements of Dhaka University, they always mention its role in the 1952 Language Movement, the 1969 anti-Ayub agitation, the 1971 Liberation War and others, he said.

"These are great political moments of our lives but where are the discussions about the academic milestones?" he added.

At the event, Gyantapas Abdur Razzaq Foundation Director General Ahrar Ahmad gave the welcome speech. He said, "We rely on foreigners for knowledge and surrender ourselves [to them]. We do not promote our own researchers and value them as well. It is essential to change this attitude of dependence. That is what we want to do through the foundation.

Parts of building housing Rajshahi Press Club collapse

Parts of a 76-year-old building in Rajshahi city, which houses offices of press club and local unit of Workers' Party of Bangladesh, collapsed yesterday.

The building, known as Kunjo Bhaban, was constructed in 1945 and was declared "vested property" after independence.

The ceiling of the front part of its veranda collapsed with a loud noise early yesterday,

Saidur Rahman, general secretary of the press club, said a pillar of the veranda collapsed over a month ago. They notified the Public Works

Department about the requirement of a repair, but to no avail, he alleged. Despite repeated attempts,

correspondent could not get in touch with the officials concerned of the PWD.

Prof Yunus gets ad-interim

Ayub Bachchu's family

The minister talked about the magnitude of this achievement in his speech.

"The fact that you can now earn royalties through digital media is still a new concept to most," he said. "I congratulate the copyright office for their hard work. However, I request that the same measures be taken for all our respected musicians.

The monetisation and digital syncing of Bachchu's 272 songs on various platforms like Facebook, YouTube and iTunes were ensured, and royalties were collected from two telecom companies and one local over-the-top (OTT) platform. The family will still receive regular royalties, as monitored by the copyright office.

Zooel Morshed, the project coordinator of the initiative, provided a breakdown of the royalty amount received from each of the platforms.

The ceremony ended with a note of thanks by Copyright Office Registrar Zafar Raja Chowdhury. "Without a doubt, Ayub Bachchu was one of Bangladesh's biggest artistes, and we wanted to preserve his legacy in proper fashion," he said. "I hope that more artistes will be aware of their rights, and file for copyrights through proper channels.

Bachchu was the first-ever applicant for the E-Copyright system. He applied to register his works right after Online Copyright Registration System (E-Copyright) was established on August 23, 2017.

Unfortunately, the musician passed away on October 18, 2018. Throughout his life, he was vocal about copyright and artistes' rights.

People residing in Bangladesh can enjoy Bachchu's songs free through the official website made by the copyright office and ministry. Those living abroad will be able to download his albums by paying USD 9.90, where each song will cost them USD 1.75. Through the programme, the copyright office pledged

to keep working to ensure fair royalty disbursement and preservation of music for all working artistes in the future.

Restoring the remnants

creates a stark contrast to the historical monument, almost as if to show the parallels between what was then, and what is now.

Inaugurated on October 11, 2018, the Nimtali Deuri houses four galleries, with an exhibition of Mughal coins, jewellery boxes, luxurious attires of the times as well as a resplendent diorama of Naib-Nazim Nusrat Jang's court. "Professor Sharifuddin, former trustee of the National

Museum, was looking for people to be entrusted with the job of executing the project. I was chosen to be in charge of it," said Hussain. "We formed a team of historians, archeologists, curation

experts and started our work by arranging three workshops with the oldest netizens of Dhaka, exchanged views with the board of trustees of the National Museum and went from door-to-door to collect different artifacts of the Mughal times and now, here we are," he added, when asked about how the museum came to be.

However, the design of the project had gone through multiple changes which had dragged the project on for years. For instance, an 1863 sketch by Frederick William de Fabeck, the architects found several pinnacles or small domes on the roof of the deuri which were not present in the actual site, so the curated design had to be modified to maintain its accuracy with archeological

Masons during the Mughal times used Surki made of brick dust and lime. For good binding, they used natural sticky components like betelnut tannin, catechu, thickened date syrup or even black lentils.

"They also used soft bricks that were kept in the oven for a short time so that the bricks can soak all the bindings and the surki. Unaware of the formula, the architects had gone through several trial-and-error phases. Finding authentic materials and artisans to conjure that effect turned out to be a significant feat," said Hussain.

The project had received a Tk 1.5 crore allowance from the government and three publications came out as a part of the project, all of which can be purchased from Asiatic Society's library. The museum is currently open for exhibition from 10am to 5pm.
