Pirojpur malta growers happy with good yield this year

Pirojpur growers of seasonal malta fruits are happy this year with good production and desired price of the juicy fruit. Harvesting of Bari-1 variety of malta began around a month ago and will continue for the next one month.

Farmers said that this year the yield of malta has been very good.

"I have reaped a benefit with the high yield of the fruits this year and it is for the first time, I have cultivated the juicy fruits," said malta grower Hannan Sheikh of Durgapur village under Pirojpur Sadar upazila adding that next year he is planning to expand his cultivation.

Around five years ago, Bikash Halder, a youth from Durgapur village, began the cultivation of malta as his hobby.

"Now, there are 1000 malta trees in my orchard," Bikash said adding this year the trees have borne fruits beyond his expectation and he has a plan to expand the orchard in the coming days.

Malta cultivation has also created a

business opportunity for the people in Pirojpur.

"During the harvesting period, I collect malta from different orchards and send those to other parts of the country," said Asish Kumar, a grower and also a wholesale buyer of malta at Panchpara bazar under Pirojpur Sadar upazila.

Now one kilogram of malta is being sold at Tk 80 to Tk 90 in the local market depending on the quality.

"As the soil and environment in Pirojpur are very favourable, malta grows well here," said Bijan Krishna Howlader, a sub-assistant agriculture officer at Nazirpur upazila agriculture office.

The area of malta cultivation is increasing every year as the cultivation of this seasonal fruit is very profitable, he added.

According to the Department of Agricultural Extension (DAE) in Pirojpur, there are around 1,000 malta orchards on 127 hectares of land in seven upazilas of the district. Of them, the highest number of malta orchards is located in Pirojpur Sadar upazila.

Two Tangail villages lie neglected for decades

Locals suffer as there is no paved road connecting the upazila headquarters

Sartiagazi and Pachh Arda still remained the two most neglected villages in southern part of Nagarpur upazila.

People of the two villages alleged that they haven't seen any infrastructural development at those villages since the independence of the country.

Several thousand people of the two villages, under Doptior union, have been facing immense sufferings for decades due to lack of a direct paved road to go to the upazila headquarters.

Besides, condition of the only earthen Dhunail-Doulotpur road via Sarotia Gazi and Pachh Arda has remained in an awful condition and unfit for movement of the commuters for years.

Locals said due to lack of renovation or construction of the four-kilometre muddy road, sufferings of the villagers have been mounting gradually.

They said people face serious difficulties while using the earthen road as it gets muddy after a moderate rain.

Otherwise, they have to cross a small canal on boat to go to their destinations.

Villagers said it is hard to believe that after passing 50 years of the country's independence, thousands of people have been facing communication problem only for lack of a paved road.

Amirul Islam Alok of Satoria Gazi village said during the dry season the lone earthen road becomes unusable due to the dust

while it remains muddy during the rainy season.

Moreover, students of different local school, college and madrasas often fail to reach their destinations in time and their cloths or uniforms get dirty while moving the earthen road, he said.

Local people struggle to carry any serious patients like pregnant

woman and elderly people to the upazila health complex, Alok said, adding that farmers have to face hurdles while carrying their produce to nearby local markets.

Monir Hossain of Pachh Arda village said for years they urged the local lawmakers, union parishad chairmen and other public representatives to take initiative to construct a paved road in place of the earthen one, but none of them pay heed to their appeal.

Although the road is the only means of communication for thousands of people of two villages, none seems to at least temporary renovate it, he added.

Contacted, Doptior Union Parishad (UP) Chairman Firoz Siddique said it is not possible to solve the problem with such small allocation of the union parishad.

"I have raised the issue in the upazila development coordination meeting on several occasions," the chairman said.

Ram Krishna Rama, a rights activist in Nagarpur, demanded the authorities concerned as well as other local public representatives to take initiative to construct a paved road in place of the earthen one as soon as possible.

Jhenidah police recovered the body of a minor from Chutlia village in Sadar upazila yesterday morning.

The victim, Rani Khatun, 10, daughter of Abdur Rakib of Kanchanpur village in the upazila, was a Class III student at Kanchanpur Government Primary School.

Quoting the neighbours, Officer in Charge (OC) of Sadar Police Station Sheikh Sohail Rana said Rani came to her grandparent's house at Chutlia village on Saturday.

She went to sleep on Monday night and later family members found her body lying in front of the bathroom around 2:00am, the OC said, adding that the reason behind the death will be clear after the autopsy.

Mysterious death of couple

Police recovered the bodies of a couple from Madan upazila of Netrakona yesterday.

The deceased were identified as Nandu Mir, 60, and his wife Hima Akter, 45, of Balali village in the upazila.

Quoting the victims' neighbours, Officer in charge of Madan Police Station Ferdous Alam said Nandu, a farmer and son of late Shamsu Mir of Alamsree village, had been living near his in-laws' house since their marriage around 25 years ago.

The couple has an eight-year-old boy and a five-year-old daughter.

Like the other days, the couple and their two children took their meal on Monday night and went to sleep.

Finding no response in the morning, one of their neighbours called Nandu, but in vain.

At one stage, the two kids woke up and opened the door.

Locals later entered the house and found Hima's blood stained body on the floor and Nandu hanging from the ceiling of the room, the OC said.

On information, police rushed to the spot, recovered the bodies and sent those to Netrakona General Hospital for autopsy.

Later, separate teams of Criminal Investigation Department (CID) and Police Bureau of Investigation (PBI) from Mymensingh visited the crime scene.

The OC said the incident might have occurred due to family feud and the children were in sleep then.
