The two arrestees named in the first information report (FIR) are Abdus Sattar, 45, a political aspirant and a cattle trader, and Sadek Mia, 30, who operates a dredger.

The six others accused are Omar Ali, Osman Ali, Jahangir Alam, Tara Mia, Mofiz Uddin and Ahmed Ali – all aged between 30 and 42, said Bashir Ahmed, office-in-charge of Nalitabari Police Station.

According to locals, the perpetrators and the victims are from the same village -- Palashikuri.

They said that except for two, none of the accused have political affiliations. They have formed a group and are known as local goons. They spend most of their time gambling.

Though they have no past criminal records, they were well connected to each other and committed the different crimes together, said OC

Main accused Omar Ali was a garments worker in Dhaka and lost his job during the pandemic. He came back to the village and started working as a farm labourer on his own and hired land, said Fazlul Haque, senior vice chairman of Poragaon union Awami League.

Osman, the owner of the house where the gang rape took place, works as a security guard at a garment factory in Dhaka. He still lives there with his family. He came to his empty house in the village around three days before the incident, said Fazlul Haque.

Visiting the victims, correspondent found that the teenage daughter has not stopped crying since the incident.

The family has been traumatised as the news spread across the entire village. Neighbours are rushing to provide consolation but the victims keep themselves isolated in a room.

They have ruined my daughter's future... Now I want justice and exemplary punishment to the perpetrators," said the victim mother, as tears roll downed her cheeks.

This correspondent visited Osman's house and saw that it was in a remote area with no other houses, except one, within 100 yards of it.

Locals allege that the house and a bamboo cluster behind it are used by criminals for different illegal activities, including gambling.

The primary medical test confirmed that the mother and daughter were gang raped, said OC Bashir, adding that samples will be collected from the victims as well as the accused for cross examination.

The project, which Siemens and Deutsche Bahn called a "world first", is part of a 60 million euro (\$70 million) modernisation of Hamburg's rapid urban rail system.

Deutsche Bahn CEO Richard Lutz said automated trains offer "a more reliable" service "without having to lay a single kilometre of new track".

"We are making rail transport more intelligent," said Siemens CEO Roland Busch, estimating that automated trains can transport "up to 30 percent more passengers, significantly improve punctuality and save more than 30 percent energy".

Although the train is controlled through digital technology and fully automated, a driver will still be present to supervise journeys whenever there are passengers on board, the companies said in a statement.

#### Fifteen kidnapped Nigerians escape jihadist captors

Six women and nine children kidnapped by jihadists from Christian communities in Nigeria's northeast have escaped their captors, walking for six days through the bush to freedom, an official said Monday.

The 15 hostages were seized separately from the farming villages of Takulashi in Borno state's Chibok district and Kufre in neighbouring Adamawa's Hong district several months ago.

Chibok was the scene of the 2014 abduction of more than 200 schoolgirls by Boko Haram which earned the jihadist group

Three of the hostages along with their five children were seized during a raid on Takulashi in October last year, while the other three with their four children were abducted from Kufre in May, according to Zuwaira Gambo,

Borno's women affairs commissioner. The hostages, including an eightmonth pregnant woman from Kufre "trekked for six days" from Buni Yadi forest in nearby Yobe state to Damboa town in Borno, a distance of around 90 kilometres (56 miles), Gambo said.

"They have displayed resilience, trekking in the bush for six days, Gambo said while presenting the escaped hostages to Borno state governor Babagana Zulum and

### At least 28 killed in Nepal bus accident

At least 28 people were killed and more than a dozen injured yesterday after a packed passenger bus plunged off a road in a hilly region in northwestern Nepal, officials said.

The accident in the remote Mugu region happened at around 12.30pm ocal time (0645 GMT) after a puncture to one of the front tyres, district official Rom Bahadur Mahat told AFP.

The bus was driving from the southern Banke district to the Mugu area and was believed to have been carrying at least 45 people, many travelling to celebrate the Hindu festival of Dashain.

"The accident has killed 28 people, we are trying to identify the bodies. The injured are being treated in hospitals," Mahat added.

Helicopters airlifted the injured to hospitals for treatment, with rescuers continuing to search for survivors and victims at the crash site late yesterday.

The bus drivers pick up travellers along designated routes but some passengers are not formally registered, making it difficult for officials to know the total number onboard.

ACC Deputy Director Rupok Kumar Saha, also the investigation officer of the case, submitted the charge sheet to the Chief Metropolitan Magistrate's Court of Dhaka on July 16, 2008.

The trial court accepted the charges, pressed against Babar, on July 23 the same year. It framed charges against him on August 12, 2008.

Later, Babar filed a writ petition with the High Court, challenging the legality of the lower court's order.

On March 17 in 2017, a High Court bench heard the matter and lifted a stay order. It asked the lower court to finish the trial proceedings in six months.

Earlier on October 30 of 2007, Babar was handed 17 years' rigorous imprisonment for possessing illegal firearms and ammunition found at his Gulshan residence in the capital.

AFP, Hong Kong Hong Kong battened down yesterday evening for the second time in less than a week as an approaching tropical storm prompted forecasters to raise their alert level and trigger

safety measures Tropical Cyclone Kompasu -- named after the Japanese pronunciation of "compass" -- is the second major storm to threaten the international business hub with torrential rain and

high winds in five days. As of 0900 GMT it was 480 kilometres to the south of Hong Kong packing winds of up to 110 kilometres

Hong Kong's Observatory issued a T8 -- its third highest storm warning -- at 5.22pm (0922 GMT), although skies were clear at the time.

The order stopped ferries and many bus routes from operating, although the city's subway system continued running. Schools had already sent students home earlier in the day ahead of the

order, with many offices following suit. On Saturday forecasters also declared T8 warning when the outskirts of another tropical storm, dubbed Lionrock, pounded the city with torrential downpours and high winds.

Although the epicentre of that storm remained hundreds kilometres to the south of Hong Kong the T8 warning lasted for 22 hours, the longest typhoon signal since 1978, bringing some 460 mm of rain over two davs.

Many residents were taken by surprise at the ferocity of Lionrock, which first began battering the city with heavy rain on Friday.
