Prime accused, five others on the run

Law enforcers could not arrest Omar Ali, prime accused in the motherdaughter gang rape case in Sherpur's Nalitabari, and five of his cohorts even four days after the incident.

The victims' family is now worried about justice.

Bashir Ahmed, officer-in-charge of Nalitabari Police Station, said since the incident, the six have been on the run. Police are using technology and conducting drives and he hopes the perpetrators would be arrested soon.

A 40-year-old mother and her 13-year-old daughter, both intellectually impaired, were raped by a gang early Sunday.

The woman filed a case with Nalitabari Police Station the same day, accusing eight people. Police have so far arrested two, including Abdus Sattar, 45, a cattle trader, and Sadek Mia, 30, a dredger operator.



where Hindu idols and temples were vandalised as the country observes Durga Puja. At least 50 people were injured in the clashes in Cumilla.

The administration in Chattogram deployed eight BGB platoons in six upazilas of the district last night, after several temples of the Hindu community were reportedly attacked in Banshkhali and Karnaphuli upazilas.

Talking to The Daily Star around 1:40am today, Nazimuddin, sub-inspector of Hajiganj Police Station, said three people were killed in the clash in the upazila.

"There are injury marks on the bodies but I cannot say what caused those," he said, adding that at least 15 police personnel were injured. Of them, eight were admitted to hospital.

Dr Mohammad Shakhawat Ullah, civil surgeon of Chandpur, also confirmed that three people were killed in the clash.

Local media outlets reported that at least 60 people, including journalists, police and common people, were injured in the clash.

Superintendent of Police in Chandpur Milon Mahmud said a procession was brought out from Hajiganj Biswaroad intersection area after Esha prayers last night.

Encircling the main road near Hajiganj Bazar twice when the procession was crossing the eastern side of Hajiganj Bazar, a sudden attack was launched on the Lakshmi Narayan Akhra (Trinayani) Puja Mandap.

Police fired teargas shells and shots n the air to bring the situation under control. The police action led to the clash.

According to sources at Hajiganj Upazila Health Complex, the deceased were Alamin, 18, of Barakul union of the upazila, Yeasin Hossain Hridoy, 15, of Randhunimura area and Bablu of Chapainawabganj.

Earlier yesterday in Cumilla, at least 50 people were injured as a group of religious extremists clashed with law enforcers in Nanua Dighirpar area over reports of "demeaning the Holy Quran' at a Puja Mandap. The government asked local administration to investigate the incident that created a tense situation in the district, and urged all to maintain religious harmony. BGB members have already been deployed there. The religious extremists started rushing to the Mandap area around 9:00am after a video went viral on social media. Members of law enforcement agencies arrived within a very short time at the Mandap where Hindu devotees were celebrating Durga Puja, said police. "We informed our higher authorities immediately about the matter and beefed up security there," said Anwarul Azim, officer-in-charge of Cumilla's Kotwali Model Police Station. To quell the situation, the deputy commissioner and superintendent of police in the district held a meeting with the local Hindu community and others around 10:00am. By then, several groups under banners of different Muslim religious organisations gathered in Nanua Dighirpar. As the meeting was ongoing, the mob attacked the mandap around 10:30am, said locals and police. Contacted, Cumilla DC Kamrul Hasan said all necessary measures would be taken to investigate the matter and punish the culprits. In Chattogram, BGB was deployed rom 9:00pm, Omar Faruk, staff officer of the Chattogram deputy commissioner's office, told The Daily Star. Police and administration sources confirmed three incidents of attack in Banshkhali's Chambal area, Kali Mandir municipality and Karnaphuli upazila. "There were some incidents at Banskhali and Karnaphuli upazilas but the situation is now under control," said Chattogram DC Md Mominur Rahman. Omar Faruk said, "In Banshkhali, Hathazari, two platoons of BGB have been deployed while one platoon BGB has been deployed for each of Fatickchari, Sitakunda, Patiya, and Chandanaish upazila each." 'Apart from that, two executive magistrates were also sent to six upazilas to take necessary actions," said Omar Faruk. DC Mominur Rahman said, "several more platoons of BGB will be deployed in the district and Metro area by morning. Chattogram Metropolitan Police commissioner Saleh Moĥammed Tanvir told " police are on alert in the temple so that no one can fish in troubled water destroying the harmony." In Kurigram's Ulipur upazila, several temples were vandalised and one was even set on fire.

In its second revision in August 2013, the project's tenure was

The Serum Institute is producing 220 million shots of the Oxford AstraZeneca vaccine per month, up from 150 million in August, and Bharat Biotech is supplying 30 million shots of its homegrown vaccine which is set to rise to 50 million next month, he said.

Facebook has developed a secret blacklist of over 4,000 individuals and organisations across the world that it considers "dangerous" as a part of its Dangerous Individuals and Organizations (DIO) policy, according to internal Facebook documents.

This was revealed by The Intercept, an American news organisation.

including militant The list, organisations, hate groups and politicians, also names six militant organisations and one individual in Bangladesh.

These are: Al Mursalat Media; Islamic State Bangladesh; Harakat ul-Jihad I Islami - Bangladesh; Ansarullah Bangla Team; Jamaat Ul Mujahideen Bangladesh (JMB); Saham al-Hind Media, and Tariqul Islam, who is also affiliated with Jamaat Ul Mujahideen Bangladesh.

snapshot of the complete list containing the names of the organisations and individuals. All the blacklisted entities are currently banned on the social media platform.

Users who discuss these groups or individuals on Facebook may be penalised by the social media platform according to a three-tiered system.

Those who commit "serious offline harm", such as terrorists and militant organisations, are placed in Tier 1. Tier 2 includes "Violent Non-State Actors" such as armed Syrian rebels, according to Facebook. Tier 3 consists of people and organisations that Facebook says violate its hate speech and dangerous organisation policies, but who "haven't necessarily engaged in violence to date or advocated for violence".

All the Bangladeshi names fall under Tier 1, meaning discussing them on Facebook may result in heavy penalties

CETP SAGA

According to a 2003 memorandum understanding between the government and tannery owners and footwear exporters, the government was supposed to set up a CETP by 2005 at a cost of Tk 175 crore.

But nothing happened in the next few vears.

Then in 2006, the caretaker government re-examined the cost of the proposed CETP putting it at Tk 350 crore and asking the industry owners to share the burden. But the tannery owners balked at the suggestion.

In 2009, the High Court directed the government to ensure the tanneries were relocated from the city's Hazaribagh area by February 2010 or the industries would face closure. The HC also ordered the DoE to have the industries set up ETPs by June 2010.

After coming to power in 2009, the Awami League government moved to relocate the tanneries to Savar. The industries ministry kept seeking time extensions from the HC as negotiations with the tanners dragged

Although the work for the CETP project was supposed to start in 2003, it actually began in 2012, almost a decade later.

A Bangladesh-China joint venture was awarded the construction of the CETP through a bidding process in 2012. But due to bureaucratic tangles and non-cooperation of the tanners,

government terminated the contract with the Bangladesh-China joint venture and handed over the responsibilities of the CETP to Tannery Industries Estate Wastage Treatment Plant Company Ltd, a newly formed company managed by tanners and BSCIC officials.

But the Department of Environment said the CETP has never been fully functional, and tannery industries have been polluting the Dhaleshwari since the beginning.

Although the CETP has been running for some time now, the online monitoring system has not been installed as per the agreement and testing facilities at its laboratory are inadequate.

Only four of eight kinds of testing facilities were installed in the laboratory, and a mini workshop was not constructed at the CETP site.

Iitendra Nath Paul, former project director of the Savar tannery industrial estate, said there are some components of the project that were not implemented.

So, the government may now take up a Balancing, Modernisation, Rehabilitation and Expansion (BMRE) project to make the CETP fully operational.

Regarding the Bangladesh-China joint venture company, he said the government has deducted Tk 26 crore (32 lakh USD) from the total payable amount of Tk 492 crore to the construction company as penalty, as per the agreement.

DOE OBSERVATIONS

Recently, after visiting the tanneries and testing the water quality of the Dhaleshwari, a group of experts from the Monitoring and Enforcement said.

BSCIC Chairman Mostaque Hassan said tanners are using two to three times more water in their tanneries.

Also, the tannery owners throw all types of effluent including solid waste inside the CETP, which is totally unacceptable.

'By throwing all types of effluent including chromium into the pipe line of the CETP, they are polluting the environment to an alarming extent."

The BSCIC chief also alleged the tanners were not supposed to drain out the chromium-mixed water to the main channel of the CETP. But they are doing it.

He said tannery owners are out to make sure the CETP fails in a planned manner.

Mostaque said around Tk 36 crore is needed to run the CETP, but the tannery owners are not willing to pay the money.

however, opposed the He, recommendation that the tannery estate be shut down until the CETP functions properly. Rather, he said, he wanted the tannery owners to cooperate properly and make the CETP functional.

Shahin Ahmed, president of Bangladesh Tannery Association, rejected all the allegations made by the BSCIC chairman.

Talking to The Daily Star, he said tannery owners do not have any power to bring change in any establishment of the CETP.

"BSCIC will have to shoulder the responsibilities for the nonfunctioning CETP. Because it's their project and they are yet to hand over the responsibility to us," he also

Fresh fighting in Ethiopia's Afar as army mounts 'offensive'
