## South Asian nations should work together

PM tells new Pakistan envoy

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said South Asian nations should work together to eliminate hunger and illiteracy for the wellbeing of the people of this region.

She said this when newly appointed Pakistani High Commissioner to Bangladesh Imran Ahmed Siddiqui met her at the Gono Bhaban.

PM's Press Secretary Ihsanul Karim briefed reporters after the meeting.

The premier said the cardinal principle of Bangladesh's foreign policy, enunciated by Father of the Nation Bangabandhu Sheikh Mujibur Rahman, is "Friendship to all, malice to none".

During the meeting, the high commissioner said Pakistan wants to promote relations with Bangladesh. He presented an original copy of Pakistan Prime Minister Imran Khan's message.

He also presented a photo album, the photo of the painting and video footage of Bangabandhu's visit to Pakistan as the prime minister of Bangladesh.



Bangabandhu attended the OIC Summit held in Lahore, Pakistan, on February 24, 1974.

The PM thanked the envoy for handing over the historic souvenir related to the memories of

Bangabandhu.
She appreciated the publication of the calligraphy book in Bangla by Pakistan on the occasion of the Golden Jubilee of Bangladesh's independence. Ambassador-at-Large Mohammad

Ziauddin and Principal Secretary Ahmad Kaikaus were present.

#### NOT PROVIDING NEW GAS LINKS

# HC questions legality of govt decision

The High Court yesterday issued a rule questioning why the government's decision to not provide new gas connections in residential areas should not be declared illegal

It also asked why returning the money instead of giving connections and the government's inactivity to provide them should not be declared

The HC bench of Justices M Enayetur Rahim and Md Mostafizur Rahman issued the rule during a hearing on a writ petition filed in this regard.

The bench asked the senior secretary of Power, Energy and Mineral Resources Petrobangla chairman, managing directors of Titas, Karnaphuli and Bakhrabad Gas to reply to the rule within the next four weeks.

Lawyers Md Wazi Ullah, Azim Uddin Patwary and Afroza Sultana appeared for the petitioners at the hearing while Deputy Attorney General Bipul Bagmar appeared for the state.

On April 27, in the monthly coordination meeting of the Energy and Mineral Resources Division of the ministry, a decision was taken to return money, after cross-checking through demand notes, to those who had paid.

On October 4, Alamgir Nur, president of Chattogram Gas, Electricity and Water Consumer Unity, AKM Waliullah Haque, its secretary general, and consumer MD Nurul Alam filed a writ petition challenging the decision.

Wazi Ullah said, according to the law, the government is obligated to provide gas connections within a fixed amount of time if the money has been paid through a demand note.

"Even after the stipulated time had passed, the consumers didn't get a connection and instead, a decision was taken to return the money, which is

The HC in its rule yesterday also questioned why directions to give provide connections to the petitioners should not be given, he said.

The main thoroughfare near the U-loop in the capital's Rampura has remained dug this way for over a month, shrinking the road space and causing trouble for vehicles. ### Under stress, in distress

The pay is a little low in other cities and towns where living cost is not as high as in the capital.

"I had joined the police force with a lot of excitement. Having worked for about 10 years, I now know it's not what I thought. We have to work too hard for too long," said Jibon.

At least two dozen low ranking police members gave similar accounts, but they declined to speak on the record about internal police matters. Police officials and psychologists say

such stressful workhour for a prolonged period, in some cases in life-threatening situation, may trigger trauma and depression, leading to unhappy professional, personal and family life. TO A BREAKING POINT Constables are the lowest tier cops,

who make up about 65 percent of some 2 lakh-strong police force. They are recruited through a process sometimes marked by hard lobbying and allegations of improper financial dealings.

As members of a disciplinary force, however, they must stand ready for call of duty 24/7

The job responsibility includes controlling traffic, guarding VIPs and important establishments and checkpoints, accompanying senior officers during regular patrols and daring drives that sometimes lead to gunfights with criminals and, in some cases, doing household chores of senior officials.

Upon joining, a fresh recruit in Dhaka gets a monthly salary of Tk 14,900, plus a travel allowance of around Tk 2,000 when they have duty 8km away from their lodgings, police

In addition, unmarried constables get 12kg of rice, 10kg of flour, 2.5kg of lentils, 2kg of sugar and 2.5ltr of edible oil in monthly ration. The food support can increase up to three times, counting the household as a four-member family unit maximum - the couple and two children.

Some police members have bigger families, including their parents and

siblings.
Of the cash payment, a certain portion is deducted at source as part of

For the first 15 months, each constable has to contribute Tk 2,000 a month in investment in the Police Community Bank in addition to a oneoff contribution of Tk 10,000 for the construction of a police shopping mall.

There are other monthly and yearly contributions meant for the police welfare fund.

Although these contributions have future benefits for police members and their families, some find it difficult to support their families on a day-to-day basis, especially those who prefer not to indulge in corrupt practices like some of their colleagues allegedly do. "At best, I can send Tk 7,000 for my

family after all those deductions and keeping my personal expenses," said a constable who joined last year.

In times of emergency, some rent their ration cards to their colleagues -to foot a medical bill of a relative, for example. A four-member ration card can fetch up to Tk 1 lakh. The original card holder can use the card again upon full payment of his debt against the

A recent internal police inquiry found 45 of the 185 constables at the Public Order Management in Mirpur have rented their ration cards to their colleagues for Tk 1,500-4,000 a month, said a police official, preferring not to be named.

For all this financial strain, they cannot often enjoy leave when needed, causing friction with their families.

The Police Act 1861, which regulates the force, has no provision for weekly leave, although police members can take a day off to "rest" to recover from exhaustion. LITTLE LEAVE

As public servants, they are entitled to all government holidays, but many of them cannot leave their station even during religious festivals. "I need a break, but cannot get one.

The work pressure is too heavy," said Jibon, who applied for a 10-day leave in late September and was still waiting for the approval in mid-October.

Earlier this year, Constable Mehedi Hasan of Dhaka and Sub-inspector Hasan Ali of Pabna waited for months for their leave applications to be

approved. Mehedi had been planning his wedding and Hasan had been preparing to sit for the BCS exam, their families said, although The Daily Star could not independently verify this.

They reportedly died by suicide in March and August respectively.
Police are investigating their deaths,

along with 16 other reported suicide incidents in the police force in different parts of the country over the last three

On September 29, the Police Headquarters asked all unit chiefs to grant necessary leaves to welfare" of police members. Former Nurul

acknowledged that police members' job was very stressful. He suggested appointing psychologists in major police units to deal with their mental stress that stems from long workhours and tackling serious crimes that are often gory and traumatic. Md Tawohidul Haque, assistant

professor at the Institute of Social Welfare and Research at Dhaka University, said low ranking police officials face a twin pressure from workplace and their family. "Tĥey do high-risk jobs round the

clock, and are often reprimanded by their supervisors. They constantly worry about their future and have little scope to spend time with their families. When combined together, all these can lead to severe mental breakdown," said Tawohidul, who is doing research on the police force.

Muntasir Maruf, assistant professor of psychiatry at the National Institute of Mental Health, agrees. He suggested early detection of any sign of stress to prevent a total breakdown.

Kamruzzaman Rassel, inspector general (media) of PHQ, said they started counselling their members to address the issue, saying they could not grant many leaves during the Covid-19 outbreak, as many police members contracted coronavirus and had additional duty to enforce the lockdown.

"During a crisis period, we cannot allow everyone to go on leave. But once the emergency is over, police members can take leave within the police rules,"

'All parameters of her health are good after the biopsy. She is stable now and

in the surgical unit's ICU." Zahid, also a vice chairman of the party, asked the nation to pray for her quick recovery.

Replying to a query, Zahid said, 'Biopsy does not mean treatment; it is instead a part of the diagnostic process. The treatment will depend on the biopsy report.

Khaleda is 76 years old and has health complications, he said.

Regarding the lump, he said the size of the lump is nearly 1.2 centimetres. He, however, did not disclose the location of the lump citing privacy of the patient and medical ethics.

Dr Zahid said, "Scientifically it takes 72 hours to get the biopsy report. But in some cases, it may take 15-21 days in places like the USA. So, we have to wait for the result."

When asked about a report in a news outlet which said Khaleda's physical condition is critical, Dr Zahid said, "It is sad. Media should be responsible. They must ask the doctors or the concerned persons before writing anything."

Mirza Fakhrul said doctors have been repeatedly said Khaleda needs to go abroad for better treatment and her family members applied to the

government accordingly. "Like any ordinary citizen, a former premier has the right to take treatment abroad, but the government has not acknowledged it. She was not allowed

to go outside for treatment." He said, "She needs advanced treatment in an advanced centre. This is badly needed. We think there is no legal barrier as she is entitled to get bail. It is her right. Government should

allow her immediately to go abroad." Sharmila Rahman, widow of Khaleda Zia's younger son Arafat Rahman Koko, arrived from the UK on Sunday to see Khaleda. She went straight from the airport to Evercare Hospital.

Khaleda Zia was admitted to Evercare Hospital in the city on 12 October. Her temperature had started fluctuating a few days before that. Since her admission to hospital, she has undergone several tests.

Khaleda Zia has long being suffering from arthritis, diabetes, as well as dental and eye problems. In April this year she contracted the novel coronavirus. She recovered while under treatment at home, but as other health complications cropped up, she was admitted to Evercare Hospital on 27 April.

She was placed in the coronary care unit (CCU) and remained there for almost two months. She returned home on 19 June.

Khaleda Zia was sent to jail on February 8, 2018 in a corruption case. Due to the coronavirus pandemic, on 25 March last year she was given temporary release on certain conditions. The term of her rela been extended four times so far.

Khaleda Zia's family has appealed to the government for her to be sent abroad for medical treatment, but the government has not responded.

"Brac has taken up a month-long programme to help heal the children from mental shock. Besides, a female psychiatric team has already started working at the village.

A total of 25 such psychiatric teams are currently working there.

Another survey of MJF found that 2,400 children were forced into hazardous work with lower wages than before and 2,500 children who were enrolled in primary schools with MJF partner support went to work due to their families' financial crisis.

Another 3,240 children came from rural areas to work as child labour. Children were one of the worst affected by the pandemic fallout, said Debapriya Bhattacharya, convenor of Citizen's Platform for SDGs,

"Many children entered the workforce for the first time to help support their families. Those children had to work because their families did not have enough food and their parents lost jobs when businesses were shut down," Anam said.
