He alleged that the government has not taken any step to bring the attackers under trial and punish them.
"An initiative has been taken to pick up or arrest and harass BNP leaders and activists by implicating them in false cases and thus hiding the attackers as part of a blueprint. Undoubtedly, it can be said the government has created an issue in a planned way to harass the leaders of the opposition political parties," Gayeshwar said.
He said though intelligence agencies and police have ideas about the attackers, innocent and peace-loving people have been made accused in the cases filed over communal violence.
"We won't say only the Hindus have been affected in the attacks. We think the entire nation has been attacked. We must make a concerted effort to resist these attackers," he said. He urged the media to take a stance against the real perpetrators and be vocal to ensure justice.
On October 17, BNP formed two committees for, what it said, standing beside the victims of recent communal attacks and investigating the incidents to find out the facts.
One of the committees was formed headed by Gayeshwar to visit the violence-affected temples and puja mandaps.
On October 23, the Gayeshwar-led committee visited three temples in Cumilla and Chandpur and talked to victims, including priests and eyewitnesses.

BNP leaders Khairul Kabir Khokon, Sultan Salauddin Tuku, Fazlul Haque Milon, Sarafat Ali Safu and seven others are now on bail, while Ishaq Ali Sarkar is in jail custody.
According to the prosecution, a group of BNP leaders and activists led by Rizvi brought out a procession in front of Jatiya Press Club on March 8 of 2018, demanding release of BNP Chairperson Khaleda Zia. At one stage, they threw bricks at on-duty policemen, injuring several of them.
Following the incident, police filed a case against 29 people, including Rizvi, with Shahbagh Police Station.
Detectives pressed charges against the BNP leaders and activists on January 31 this year.
The investigator dropped the names of 11 other accused as their involvement was not found during investigation.

According to the case documents, Rita Dewan was performing a "Pala Gaan" with fellow artist Shah Alam Sarkar, where the topic being debated was "Living Beings versus The Greatest". The event was held on the night of December 10, 2019 at the residence of one Shahjahan Kabir in Kalihati upazila in Tangail.
Accused Shahjahan and Iqbal had uploaded Rita's songs to their YouTube channels, the case documents said. Another video also surfaced where Rita Dewan, along with her two daughters, was shown apologising for the matter that day.

On May 24, the HC denied bail to Shahed in the case.
On August 25 last year, Criminal Investigation Department Inspector Ibrahim Hossain filed the case against Shahed and Regent Group Managing Director Masud Parvez with Uttara West Police Station on charge of laundering Tk 11.02 crore.
On July 15 that year, Rab members arrested Shahed from the border area of Sathkhira's Debhata upazila over issuing fake Covid certificates.
Rab members raided the Uttara and Mirpur branches of Regent Hospital on July 6 and arrested eight people on charges of issuing fake Covid certificates and charging exorbitant fees for Covid testing and treatment.
On July 7 last year, the head office of Regent Group, both hospitals were sealed off, and 17 people, including Shahed, were sued on charges of issuing fake Covid test reports and taking money for the services.
On Sept 28, 2020, a Dhaka court sentenced him to life imprisonment in an arms case.

Tk 10 lakh. When the candidate told him that she did not have that much money, Musa told her to pay Tk 2 lakh for the time being and pay the rest after the admission.
Musa also sent the identity card of an assistant secretary of UGC to her messaging app, along with fake texting screenshots with senior officials, to convince her into the deal. The candidate then met Musa in Jatrabari and gave him Tk 2 lakh.
A day after making the payment, she called Musa and asked for an update. In reply, Musa said that she has to give Tk 1 lakh more to pass it to the senior officials.
This got her suspicious of Musa's words, and she assumed that she had been deceived.
Musa, however, kept calling her for the money and threatened that he would not allow the candidate to be admitted anywhere if she did not pay as demanded.
After the candidate's father filed a case with Jatrabari police on Saturday, a DB team arrested Musa on Sunday.
"Musa has taken a hefty amount of money from many candidates," the police official said.
GS Mostafa, elder brother of Musa, told The Daily Star that he last contacted Musa on Thursday and could not find him since Saturday. He made a general diary in this regard with Gandaria Police Station on Sunday.
Yesterday, a DB official informed him by phone that his brother was arrested in a fraud case and sent to court.

Quader, also general secretary of the AL, made the comment while addressing a press conference at his ministry office in the secretariat.
"BNP wants to go to power not through the ballot, but through undemocratic means," he told the press conference.
He also criticised a statement made by BNP leaders that "BNP will never participate in elections under Awami League".
Quader, however, assured that the election will not take place under the AL government, but it will be held under the Election Commission (EC).
Although BNP is still pursuing their "outdated way" of participating in the

polls, it is obvious that the elections will be held timely in the country, he said.
Blasting BNP for resorting to rumours and propaganda as their political strategy, the minister said the birth of this particular political party is widely known to the people.
"BNP is now in a dilemma, as they are not triggering any movement or participating in the elections," he said.
Regarding the selection of candidates for local government elections, Quader said directives have been given to those in the grassroots for sending particulars of the party's tested leaders.
But appeals could be filed as per the party manifesto, if there is any allegation against any candidate, he added.
