PLEDGED CHINESE LOAN Coming but at crawling pace

In 2017, with the view to alleviating the capital's absurd traffic congestion, the government took up the Dhaka-Ashulia Elevated Expressway project to implement largely with Chinese funding.

The \$1.1 billion loan agreement for that project was signed on Tuesday -- four years after it got the nod of the Executive Committee of the National Economic Council.

The delay is not an anomaly but has become characteristic of the \$20 billion soft loan pledged by Chinese President Xi Jinping on his maiden visit to Bangladesh in October 2016 to usher in a new era of bilateral ties between the two nations.

Some 27 projects, including megaprojects, were earmarked for implementation with the \$20 billion pledged, but prising the funds out of China's hands has been a dawdling process, compelling the government to put the projects on hold.

So far, loan agreements have been signed for only eight projects, including the Padma rail link, Karnaphuli tunnel, installation of single-point mooring with a double pipeline, Info-Sarker 3.

Between June last year and October this

year, no loan agreement was signed with China.

The impasse was broken with the signing of the loan deal for the Tk 16,901 crore-Dhaka-Ashulia Elevated Expressway project, which was originally scheduled for completion in June 2022.

With the signing of the loan agreement, construction work for the 24-kilometre expressway connecting Hazrat Shahjahal International Airport with Abdullahpur, Ashulia, Baipail and Dhaka Export Processing Zone on the Nabinagar-Chandra highway can finally begin. SEE PAGE 2 COL 3

The High Court yesterday observed that the local administrations failed to save the people of Hindu community, their properties and places of worship in different districts during this year's Durga Puja festival from communal attacks.

The court, however, said the government has taken actions after the incidents.

The HC directed the authorities concerned to conduct judicial inquiries into the incidents of violent attacks in six districts between October 13 and 18.

The districts are Cumilla, Feni, Noakhali, Chattogram, Chandpur and Rangpur.

During hearing of a writ petition, the court asked the chief metropolitan magistrates and chief judicial magistrates concerned to submit their inquiry reports to it within 60 days.

At the same time, the HC issued a rule asking the authorities concerned of the government to explain as to why the inaction and failure of the local administrations to protect Hindu citizens, SEE PAGE 2 COL 1 All e-commerce businesses will have to register with the commerce ministry within the next two months.

Prime Minister Sheikh Hasina gave the directives at a cabinet meeting yesterday. She joined the meeting, held at the Secretariat, from the Gono Bhaban virtually.

The directives came against the backdrop of alleged forgery and misappropriation of clients' money by some e-commerce firms, including Evaly.

After the anomalies came to light, the government acted to address the issue.

Briefing reporters after the meeting, Cabinet Secretary Khandker Anwarul Islam said, "E-commerce businesses will have to register with the commerce ministry within the next two months under a precise programme."

Besides, they will have to deposit a security amount in Bangladesh Bank so that clients can be paid from it if anything happens, he said. "Bangladesh Financial Intelligence Unit and the intelligence agencies

"Bangladesh Financial Intelligence Unit and the intelligence agencies have been given clear instructions to check the characteristics of those firms."

Directives have also been given to conduct mass campaigns to make people aware of not making any transactions with unauthoriesd e-commerce companies, the cabinet secretary said, adding that the list of registered e-commerce firms will be published.

A parliamentary body has asked the National River Protection Commission to prepare a list of grabbers and illegal structures in four rivers surrounding Dhaka that includes the Buriganga, the Turag, the Sitalokkha and the Balu rivers as soon as possible.

The parliamentary standing committee on the shipping ministry also wanted to know from the NRPC how many illegal structures would be possible to evict in three months and serve notice to the respective grabbers accordingly.

NRPC has informed the parliamentary watchdog that as a model they have formed a 14-member committee to completely free the Balu river from grabbers and pollution within six months and to prepare a master plan for increasing navigability of this river within one month.

According to the working paper of yesterday's meeting of the Jatiya Sangsad committee, Kamrun Nahar Ahmed, permanent member, NRPC, was made

A 17-year-old girl has been languishing in a juvenile correction centre for a whole year because of a Facebook post that she allegedly made demeaning the Quran and hurting religious sentiment.

Exactly a year ago, Dipti Rani Das, a tenth grader from Dinajpur's Parbatipur upazila was dragged off a train and charged under the Digital Security Act 2018.

The minor girl was sued by Parbatipur police for what the first information report says "the crime of deteriorating the law and order situation by hurting religious sentiment using electronic means".

Since being booked, her bail was denied four times -- the fourth in a decision by the highest court in the land.

Dipti had almost gotten out once when the High Court granted her a six-month bail on May 11, 2021. This was after her bail was already denied thrice by the court in Dinajpur.

Eight days later the district's deputy commissioner appealed to the Appellate Division of the Supreme Court praying that the bail order be stayed.

"The interim order of bail granted by the High Court Division in a pending appeal clearly shows non-application of judicial mind having failed to appreciate that the accused respondent is named in the FIR having strong prima-facie and specific over act of committing a heinous offence under section 25, section 28, section 31 of the DSA," said the appeal.

Section 25 criminalises the spreading of false information or propaganda to "annoy, insult or humiliate" while section 28 deals with hurting religious sentiment, and section 31 is to prosecute a person who causes the law and order situation to deteriorate.
