

## Jail Killing Day observed

The nation solemnly commemorated the 46th anniversary of the killing of four national leaders inside the old Dhaka Central Jail yesterday.

At the same time, call for executing the convicted killers and unmasking the perpetrators behind the gruesome murders continue to grow louder.

The four Liberation War heroes Syed Nazrul Islam, acting president of Bangladesh government in exile in 1971; Tajuddin Ahmad, prime minister of the same government; Capt M Mansur Ali, finance minister; and AHM Quamruzzaman, minister for home affairs, relief and rehabilitation, were killed inside the jail on November 3, 1975 by some army officers.

To mark the day, President Abdul Hamid and Prime Minister Sheikh Hasina on Tuesday issued separate messages, reports UNB.

The president urged all to work from their respective positions to complete the unfinished works of Bangabandhu “to build a happy and prosperous Sonar Bangla”.

## Persons with disabilities Still hoping for proper care

Eighty percent of respondents of a recent study, which interviewed persons with disabilities and their caregivers, believe that there is a serious lack of specially trained doctors and nurses who can provide services to those with disabilities.

When asked about the quality of health services for Covid, 90 percent of respondents with disabilities termed the services they received as Covid patients “very bad”.

The study, titled “Healthcare for Persons with Disability in the Time of Corona” and conducted by Bangladesh Institute of Development Studies (BIDS), also found that 94.6 percent of respondents said lack of education and income make patients with disabilities more vulnerable.

In addition, 84.6 percent of respondents said the already present problems of patients with disabilities were aggravated after getting Covid, more than that of general patients.

Dr Anwara Begum, senior research fellow at BIDS, shared the findings at a seminar organised at BIDS in Dhaka yesterday.

The study was conducted by taking in-depth interviews of 15 caregivers from Dhaka, Chattogram and Rajshahi, and 50 persons with

disabilities living in remote areas of Bagerhat, Barguna and Sathkhira, most of whom are not well off.

Men, women and children with disabilities often face social stigma, are financially and socially dependent, and require caregivers, sighted guides and interpreters. Even during the pandemic, physical distancing is not possible for people with disabilities, she said.

Moreover, travel and moving patients in wheelchairs require more resources, workforce and structural designing -- not to mention empathy, especially when it comes to nursing and caregiving, which is in short supply.

The study also found that there is a dearth of nurses and doctors capable of managing such people, while nurses accepted that their syllabus and training was not designed for supervising such patients.

According to the WHO standard, Bangladesh has a staggering shortage of over 90,000 doctors; 2,73,000 nurses and 4,55,000 technologists. There are less than 0.4 nurses per 1,000 people, one of the worst ratios in the world, she said.

The study recommended that special training should be provided for administrators, caregivers, policymakers, and ease of access to services for persons with disabilities

### 10.76pc pass DU ‘Ka’ unit entry exam

The admission test results of “Ka” unit, under science faculty of Dhaka University, for 2020-21 session was published yesterday with a pass rate of 10.76 percent. Rampant river-grabbing by influential persons mixed with reluctance on the authorities' side to take steps against them, squeezed into a corner, the Bhairab river stands as a major waterbody being completely given to grabbing and pollution.

When this correspondent visited both sides of the river recently, he saw at least 300 business establishments -- including factories, warehouses, and some high-rise structures -- at Jaikhana ghat, Rupsha ghat, Delta ghat, Khalishpur Burma Eastern ghat, Digholia, Shiromoni and Phultala ghat areas.

As an added woe, nearly 500 shops from the neighbouring Baro Bazar, and some factories and mills throw their waste straight into the river.

Abdul Mazed Mollah, a resident of the city's Kalibari area, told The Daily Star, “The river has become like an ‘orphan’, with no authority doing anything to free it from the indiscriminate pollution and grabbing.”

“I’ve never seen any integrated work to save the river,” he added. “Without a free-flowing Bhairab, Khulna city would be inundated by

waterlogging,” he warned.

There are many government and private institutions that depend on the Bhairab for their shipments. Khulna Shipyard, BNS Titumir (Bangladesh Navy), BIWTA ghat, Forest ghat, Khulna Newsprint Mills, Khulna Hardboard Mills, nine state-owned jute mills, four power plants, three state-owned oil depots, and over 200 private jute mills were built on the banks of Bhairab.

“If the river lost its navigability, these establishments will be affected and might even be forced to shift to other places,” said Paritosh Karmokar, a Baro Bazar-based business owner.

Every day, over 300 cargo vessels

carry goods and oil from Noyapara of Jashore to different parts of the country along the river. On their way, they pollute the river by dumping waste and discharging chemicals, said locals and green activists.

In addition, at least 20 large drains of Khulna City Corporation (KCC) directly discharge waste into the river, and so do the jute mills.

Contacted, KCC Chief Conservancy Officer Md Abdul Aziz said, “We have attached nets to the openings of the drains, so waste does not go into the river. Furthermore, we have plans to process the drain water to remove pollutants before letting it enter the river.”

## Ending Deforestation by 2030 TIB concerned over govt unwillingness to respond to pledge

Transparency International Bangladesh yesterday called upon the government to immediately express solidarity with the global pledge -- made during the Conference of the Parties (COP-26) in Glasgow -- to stop and reverse deforestation by 2030.

Issuing a press statement, the anti-graft watchdog further urged the government to take specific measures in line with the pledge to stop and reverse deforestation in the country, expressing concern over the contrary.

“Although Brazil and many African countries have joined the pledge, Bangladesh's unwillingness to respond [to the pledge], despite being a most vulnerable country, is unbelievable,” said TIB Executive Director Iftekharuzzaman. He termed Bangladesh's position to

## Baghdad Group MD held in Ctg

Police yesterday arrested Baghdad Group Managing Director Ferdous Khan Alamgir from Chattogram in connection with several cases filed by different banks over loan scams.

“Ferdous Khan Alamgir has been arrested in a case filed for defaulting Tk 17 crore from City Bank's Khatunganj branch,” said OC Nazam Uddin of Kotwali Police Station.

Mohammad Naim Bhuiyan, panel lawyer for the bank, said the bank filed the case with the Money Loan Court in 2012. He said a warrant was issued against him on August 10. According to court sources, the group's bad loans amounted to Tk 300 crore with 12 banks and financial institutions.

In August 2019, Alamgir's wife Meherun Nesa (50), chairperson of the group, was arrested by immigration police at Dhaka airport after she arrived from Canada.

## EU to remain 'steadfast partner' of Bangladesh

Says envoy on Rohingya issue

Head of Delegation of the European Union (EU) to Bangladesh Ambassador Charles Whiteley has said they will continue to be a “steadfast partner” of Bangladesh in meeting the needs of the Rohingya and host community with continued pressure on Myanmar for their safe return to their place of origin in Rakhine State.

“Clearly, I think, the majority of the Rohingya do want to go back to home,” he told UNB in an interview mentioning that everyone, including the government of Bangladesh, underlined that any return has to be “voluntary and safe” for the refugees.

Responding to a question on the EU's business link with Myanmar, the EU envoy said they are very careful when it comes to the economy as some people say why the EU does not suspend the Everything But Arms (EBA) scheme.

Myanmar has been a member of the World Trade Organization (WTO) since 1995 and as a least developed country, benefits from the EBA scheme, which grants unilateral duty- and quota-free access for all exports, except arms and ammunition, to the EU.

## Former bKash territory officer arrested over fraud: CID

Criminal Investigation Department has arrested a former territory officer of bKash on charge of providing agents' and customers' information to fraud gangs, helping them swindle money.

The arrestee, Tanvir Siraji alias Siraj (38), was sacked from the mobile financial service in September upon receiving complaints against him.

A team of CID arrested him from Tongi area in Gazipur around 2:30pm on Tuesday, Saidur Rahman Khan, special superintendent (Serious Crime Division) of CID told a press briefing at its headquarters yesterday.

The arrest came as three accused in a case filed with Sakhipur Police Station in Tangail in March, in their confessional statements

## Not one event in 15 years

Lying idle, Segunbagicha Multipurpose Complex loses all lustre; still no gas, electricity supply

It's been 15 years since the Segunbagicha Multipurpose Complex was completed. On the third floor of the five-storey building, it hosts the ward councillor's office, while the first two are used as a kitchen market.

However, though constructed mainly as a community centre, the establishment is yet to see any light to this end.

Even after 15 years, the premises still doesn't have gas connection, nor electricity. The councillor's office runs on power supply from a nearby kitchen market. More importantly, there has not been a single programme on the venue during all this time.

Contacted, city corporation officials told this newspaper that the scenario may change soon, assuring that renovation works could begin from next week.

“Works for the community centre was wrapped up way back in 2006,” said Saiful Islam, additional caretaker of the community centre, “But it's yet to host a single programme.”

“The reasons? There's no elevator, no air-conditioning, not even gas supply. Who would want to rent this space?” he asked.

Dhaka South City Corporation's website cites the lack of a gas supply as the main issue,
