
#### Death anniv of Mansur Ahmed Khan today

Today is the 19th death anniversary of Mansur Ahmed Khan, a freedom fighter.



He was the first curator of Rajshahi University Martyred Memorial Archive.

Mansur, brother of renowned artist Hashem Khan, died on this day in 2002. He wrote a number of books and plays on the Liberation War. He contributed to establishing Rajshahi Art College, Mukhtijuddha Pathagar, Art School-Angkan and Muktijuddha Command Council unit at RU.

FROM PAGE 3 He said a friend of Fardin accompanied him on his way to hospital while he was taking the victim there, but the friend was not

present at the crime scene. The IO said the charges brought against Fardin were primarily proven.

The victim's father on January 7 filed the case with Kalabagan Police Station against Fardin after his 17-year-old daughter, an O-level student, was allegedly raped and murdered. As per the case statement, Fardin tricked the girl into going to his flat and raped her when his family members were away.

She bled profusely and fell unconscious. Fardin then took her to a hospital to deflect blame. On January 8, Fardin gave confessional statement before a Dhaka court. He is now behind bars.

The victim's father told The Daily Star yesterday that he thinks several others were also involved. Police picked them up after the incident but released them later.

"We will take legal steps after we get a copy of the charge sheet," he said.

## TIB concerned over delay in delivering on climate pledge

Transparency International Bangladesh (TIB) has expressed concern over the much-touted \$100 billion a year pledge by developed countries, to be paid to the developing countries to adapt to climate change.

"Developed countries are supposed to have delivered the pledge made under the Paris Agreement in 2015 by now. But since the agreement, only \$80 billion was disbursed, among which only \$20 billion was confirmed to be for climate change fund," said Iftekharuzzaman, executive director of TIB, in a press release yesterday.

"In the draft resolution [at COP26], we see the same tactic of evading the pledge," he added.

He said world leaders created high hope leading up to COP26, but failed to deliver.

"Rather, we saw the ill-attempt to take the warming level from 1.5 degree to 2 degree. There was also no specific timeline on phasing out coal use," he added.

He also urged the CVF (Climate Vulnerability Forum) to take a strong stand in ensuring the pledge.

Meanwhile, he applauded the separate mention of the "loss and damage" issue in the draft resolution.

back the one dollar into the brokerage house's fake account, they simply transfer the money into another foreign account.

They then post on social media seeking buyers for the bank account, citing its 300-400 dollar deposit. If anyone shows interest, the syndicate sells it to the buyer and receives the payment through mobile financing services in Bangladesh.

"Ziaul, owner of an outsourcing firm in Sirajganj, used to appoint people to open the accounts and paid Tk 5 for every account. Around 30 to 40 people were found working in the firm at night," said Chatak Chakma, assistant commissioner of CITC unit.

Asked how the syndicate collected the foreign nationals' information. Chatak said the arrestees collect them from social media groups where this kind of data is sold.

"We are looking at how many people are involved in such fraudulent activities," he said. A case was filed with Ramna Model Police Station against the arrestees.

Investigators said the syndicate has contacts in several foreign countries. They said they will notify those countries.

CTTC DC Kibria said awareness needs to be created among people who are involved in freelancing or outsourcing, as many of them often end up getting involved with such syndicates without knowledge.

### could come from the Chattogram court

Most of these warrants were sent over personal or property feud, or business rivalry, observed the investigators.

According to them, the fake warrants are almost identical to the original ones, as they are issued on official warrant forms, and impossible to detect if one does not cross-check with the relevant court for confirmation.

The Daily Star collected several fake arrest warrants, which were issued at different times from the court.

The warrants, issued over different complaint register cases (filed directly with the court), had case and memo numbers as well as full details of the victims' address.

This correspondent spoke to more than a dozen police officials who said the fake warrants were sent to different police stations through registered post. Since the controversy over the warrants, they have only been executing warrants which come to them through proper channels from the

"You cannot identify the fake ones, if you compare it with the original. It's very confusing, which is why we don't receive warrants through the post in my police station," said the officer-in-charge of a police station of CMP's North Zone, seeking anonymity.

"Once a warrant is issued, it goes through the desks concerned at court, then to the deputy commissioner of police. The warrant then reaches respective police stations through us," he said, explaining

the proper channel. However, OC Shahadat Hossain of maintaining proper procedures.

Earlier, on October 14 last year, the High Court issued several directives to the authorities concerned to stop fake arrest warrants. The names, designations, phone numbers and signatures of the court staff who will prepare the arrest warrant will have to be mentioned, so that the accused against whom the warrant has been issued can communicate with the court staff concerned about its authenticity, said the HC.

It also stated that the police officers responsible for executing the arrest warrants will communicate with the court staff preparing the warrants to confirm authenticity. Court sources said the court staff and court police are following the directives, but some cases are still falling through the cracks.

Chittagong District Bar Association (CDBA) General Secretary AHM Zia Uddin said, "There are some dishonest lawyers, court staff, and police involved in the racket. Without proper investigation, it is difficult to find them."

Contacted, senior lawyer advocate Ibrahim Hossain Babul said, "It's totally unacceptable. Despite repeated incidents, criminals are getting away with sending innocent people to jail."

"A comprehensive investigation can reveal the syndicate who are responsible for the incident," said the lawyer.

However, despite several orders given by the court to identify the gang members, police and other investigating authorities have failed to find the criminals behind these incidents.

OC Md Nezam Uddin of Kotwali Police Station said, "The case filed over fake warrants was shifted to Police Bureau of Investigation last month. We are now investigating the case."
