# Strict watch thru' central platform

All orders, transactions, activities to be monitored by relevant agencies



BFIU to scrutinise financial transactions

Law enforcement agencies to monitor, verify national ID, passport information and criminal records

e-Commerce Association of Bangladesh expresses concern over privacy of customer data

All e-commerce companies will soon have to come under one digital platform monitored by multiple state agencies, as the government looks to increase oversight on the sector that has become a hotbed for irregularities in recent months.

At least 13 rogue e-commerce companies wound up with several thousands of crores of taka in liabilities, amplifying the calls for a stringent e-commerce policy.

The agencies are the commerce ministry, the Bangladesh Computer Council (BCC), the Consumer Association of Bangladesh,

the Bangladesh Financial Intelligence Unit (BFIU), the law enforcement and detective police, and the National Telecommunication Monitoring Centre (NTMC), according to the draft policy.

The Daily Star has a copy of the draft policy prepared last month by the NTMC.

The digital platform will have detailed information on orders and delivery, information about dealers as well as details of their financial transactions.

One of the major features of the policy is that it will integrate both e-commerce companies and payment gateways to the **RELATED STORY ON B1** SEE PAGE 2 COL 3

### No scope for questioning **UP** polls

Claims CEC Nurul Huda, bins EC Talukdar's comments

There is no scope for questioning the entire union parishad polls as there were only stray incidents of violence, said Chief Election Commissioner KM Nurul Huda

The staggered union parishad election is competitive. The turnout is around 74 percent, which proves it is being held in a festive mood, Nurul told the press yesterday at the EC office.

The CEC made the comments when at least 26 people were killed in pre-and post-polls violence during the second phase of the UP polls on November 11.

During the first phase, in June and September, six people were killed.

## Bangladesh can make, export

PM tells Sangsad

Prime Minister Sheikh Hasina yesterday told parliament that Bangladesh has the capability of producing Covid-19 vaccines and supplying those to other

She said that during her recent tour in the UK and France, she told world leaders about Bangladesh wanting to produce Covid-19 vaccines.

"I requested them to remove all obstacles to producing coronavirus vaccines in Bangladesh... This is the right of the people of the whole world and it should be declared a public good."

She mentioned that the government has also allotted land for the purpose of producing vaccines.

Hasina, also leader of the House, said this while discussing a resolution to thank Unesco for introducing a creative economy award, named after Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

Abdus Shahid, Awami League MP and former chief whip of parliament, placed the resolution under section 147 of the parliament rules of procedure.

#### Campaign starts from Korail Bosti

The government is set to launch a campaign today to inoculate slum dwellers aged 18 and above against Covid-19.


SLUM DWELLERS' JABS

Following on-spot gistration the vaccin will start at the Korail slum, which has nearly three lakh inhabitants. The campaign will later be expanded to more slums in the capital and other cities, Health Minister Zahid Maleque announced yesterday.

He said anyone wishing to take the shot must carry their national identification (NID) card or other relevant documents, including birth certificate or passport. "Our target is to vaccinate three crore people every month."

RAPE ACCUSED'S BAIL Same judge

In March last year, the Appellate Division of the Supreme Court had asked Judge Begum Mosammat Kamrunnahar to appear before it on April 2 last year to explain why she had granted bail to a rape accused.

At that time, Kamrunnahar was a judge of Nari O Shishu Nirjaton Daman Tribunal-7 of Dhaka and she granted bail to Aslam Shikder, a former official of a TV channel. although there was an SC stay order on the bail.

The apex court had issued the summons following a petition filed by the state challenging the legality of the bail.

## Cheating thru' 36 cheques

Probe body finds how a syndicate embezzled around Tk 7 crore from accounts of Jashore Education Board over 5 years

A racket that includes officials tampered with at least 36 cheques and stole almost Tk 7 crore from a bank account of Jashore Board of Intermediate and Secondary Education in the last five years, an investigation found.

The education board's College Inspector KM Rabbani, who led a five-member committee to probe the embezzlement, said the stolen money was cleared through five different banks.

The committee's findings include the names of "a number of individuals" who could have been involved in the crime, he told The Daily Star, without going into

The probe report was submitted to Jashore Education Board Secretary Prof AMH Ali R Reza. Interestingly, Prof Reza is one of the accused in a case filed over the

embezzlement in October. Inspector Rabbani said the official procedure is to submit such reports to the secretary.

An internal audit of the education board earlier found that about Tk 7 crore was withdrawn from its account through 36 cheques containing the signatures of the board chairman and secretary. The cheques were issued to 10 business outlets and three board officials.

The education board on October 10 filed a complaint with the Anti-Corruption Commission in Jashore. Eight days later, the ACC filed a case accusing the
