Mindless tree felling continues under the nose of forest office

A section of tree looters has been continuing felling trees of social forestry under the nose of the local forest office in Manchhara bit area under Kulaura upazila of Moulvibazar.

More than 50 beneficiaries of the social forestry have fallen victims to the mindless act of tree felling. A few people have been felling trees from the area for some days in collusion with the forest officer of the adjacent forest office, the locals alleged.

Visiting the spot, correspondent saw clear evidence of massive tree felling and found seven to eight workers cutting down several acacia trees.

Workers Ershad (26), Yakub Ali (29) and Matin Mia (40) said, "We have come to cut down trees on a daily wage of Tk 600. A man named Yusuf Mia told us to cut down the trees."

"We have informed the forest department several times about cutting down the trees but to no effect," said the beneficiaries.

In his deposition, Khairul said he came to know this information about Pradeep after talking to many people in the area during the probe.

Pradeep feared (retd) Sinha might disclose Pradeep's misdeeds through his documentaries. That is why, Pradeep designed the plan to kill Maj (retd) Sinha and the killing mission was executed with the help of police inspector Liaqat Ali and others, said Khairul.

Pradeep filed two general diaries with Teknaf Police Station before and after Maj (retd) Sinha's death. There were anomalies in the GDs. It proves that Pradeep was involved in the killing, Khairul added.

Cox's Bazar District and Sessions Judge's Court yesterday recorded the statement, said the court's Public Prosecutor Faridul Alam.

The court proceedings began around 10:20am and continued until 5:00pm. All 15 accused in the case were present in the court yesterday, he added.

A total of 65 witnesses have so far testified since August 23 when the court began the case's formal

According to the charge sheet, 83 people are witnesses to the incident.

On June 27, the court framed charges against 15 accused. Of them, 12 are police personnel, including Pradeep, Liaqat, sub-

Judge Mohammad Ismail of inspector Md Shahjahan, and assistant sub-inspector Liton Mia who were all suspended.

Sinha, 36, had been making travel documentaries for a YouTube channel called "Just Go". He was returning to Cox's Bazar from Teknaf on July 31 last year when he was killed in a police firing at a checkpoint of Armed Police Battalion (APBn) in Teknaf's Shamlapur area.

Police claimed that they tried to search the vehicle, and Sinha pulled out a pistol, prompting them to shoot in self-defence. They also claimed that they had seized drugs

from the vehicle. On August 5 that year, Sinha's elder sister Sharmin Shahriar Ferdous lodged the murder case.

What has been done to repeal

Bangladesh Legal Aid and Services Trust (BLAST), Ain O Salish Kendra (ASK) and Nari Pakkho submitted the petition as public interest litigation on November 14, seeking the cancellation of sections 155(4) and 146(3) of the act.

The HC, in the order, also added that the government may reconsider the amendment of section 146(3).

According to the section, "When a witness is cross-examined, he may, in addition to the questions hereinbefore referred to, be asked any questions which tend -to shake his credit, by injuring his character, although the answer to such questions might tend directly or indirectly to criminate him or might expose or tend directly or indirectly to expose him to a penalty or forfeiture.'

During hearing yesterday, Attorney General AM Amin Uddin told the HC that the government has decided to repeal section 155(4) of the Evidence Act and has

already prepared a draft in this regard.

Petitioners' lawyer Sara Hossain argued before the HC bench saying that rape victims being harassed and discriminated against due to the two sections, which are contradictory to the constitution.

As the guardian of the constitution, the HC may issue a rule questioning the legality of the sections of the law, she said. Sara Hossain also appreciated the

government for its initiative to amend section 155(4) of the act. Lawyers ZI Khan Panna, Sharmin Akther

Sheuly and Shahinuzaman Shahin also appeared for the petitioners, while Deputy Attorney General Bepul Bagmar represented the state during the hearing.

morning to sit for their tests. Injured Md Ruman and eyewitnesses said that after all the students had come to the dormitory, a meeting was held around 11:00pm in room 107, after which 20-25 students went out on the ground floor

verandah outside the room. Right then, the concrete floor suddenly gave way, creating a hole in the ground. Many of the student fell into the hole, while others helped rescue the injured and took them to hospital.

Md Shah Alamgir, vice-principal of Patuakhali Government College, said, "A few days ago, the college grounds were filled with sand with a dredger, as a portion of the college's field was low-lying and work was being done to raise the ground level. As there was water coming in through the pipes along with the sand, the soil, along with the water, may have moved from

the bottom of the building. The matter has been reported to the Department of Education Engineering."

Md Hadiuzzaman Khan, executive engineer of Patuakhali zone for the Department of Education Engineering, said that the college grounds were filled with sand by dredgers.

"At that time, the water [that flowed in with the sand] was not removed. As a result, it started flowing through the bottom of the western pass of the building. At one stage, the sand beneath was removed and a large hole had formed

"The ground floor of the building was paved with bricks. There was no way to understand that the space below is empty. When the students gathered above a part of the empty space, the floor caved in... We have already started the renovation work."

The three-storey dormitory building was constructed by the education engineering department in 2008.

US PRIEST KILLED

The Daily Telegraph of London reported today that American Roman Catholic Priest Father William P Evans was shot dead on November 13, 1971 at Bukshnagar, 17 miles south-west of Dhaka. The boatman who used to take the priest from Gola to the Mission told Clare Hollingworth, the correspondent of the Daily Telegraph, "We were boating down the river when military guards ordered them to report to the local commanding officer as the boat was searched. Father Evans was questioned and allowed to return to the boat. But for some unknown reason they took Father and me out of the boat and forced us to sit in a ditch. Although the commanding officer was satisfied about the identity of Father

Evans the army began firing at close range.' The Father was shot dead and his body thrown into the river. ON THE WAR FRONT
