People dig deeper into their pockets

Ministry study finds the out-of-pocket cost in Bangladesh highest in South Asia

out-of-pocket (OOP) Bangladesh's healthcare expenditure has continued to rise, leaving a sizeable population with catastrophic medical bills, found a recent study by the health ministry.

Between 2015 to 2020, the OOP -- which is the expense for treatment borne directly by a patient where neither public nor private insurance covers the full cost of the health good or service -- has increased to 68.5 percent from 67 percent, according to

This is the highest among Saarc nations, said the technical study conducted by

the Health Economics Unit (HEU) of the health ministry to bring down OOP in the country. The findings of the study were shared yesterday at an event styled "Pathways to Reduce Household OOP

Thanks to the rising OOP, 16.4 percent of the households avoid getting medical help even when needed, 24.4 percent of families (at 10 percent income level) are facing catastrophic health bills and 4.5 percent of the people are pushed into poverty every year.

About 64 percent of the OOP expenditure goes for medicine, whereas it SEE PAGE 2 COL 3

Show your plan for protecting rivers

HC gives govt six months' time to list all rivers too

STAFF CORRESPONDENT

The High Court yesterday ordered the government to make a complete list of all the rivers in the country and to come up with an action plan on how the rivers will be protected from encroachers. The list and the action plan must be submitted

to the court in six months. The finance ministry, National River Conservation Commission (NRCC), Bangladesh Inland Water Transport Authority, and the divisional commissioners were asked to comply

with this directive. The HC also ordered the authorities concerned to demarcate the boundaries of the Turag river as

per cadastral survey record from 1940.

At the same time, the HC issued a rule asking the authorities concerned of the government to explain why they should not be directed to evict the land grabbers and encroachers from the rivers across the country and why their failure in this regard should not be declared illegal.

The HC bench of Justice Md Mozibur Rahman Miah and Justice Md Kamrul Hossain Mollah came up with the orders and rule while hearing a writ petition filed by Bangladesh Environmental Lawyers Association (Bela), seeking necessary directives on the issue.

MATARBARI POWER PLANT PROJECT

Cost goes up 44pc with channel expansion

The outlay for Matarbari coal-fired power plant, one of the mega-projects of the government, is set to increase by 44.1 percent to Tk 51,854.9 crore following the decision to expand the channel to bring in coal.

As per the original plan, the channel was supposed to be 3km-long, 250 metres wide and 15 metres deep.

Now, the project consulting agency -- a consortium of Japan's Nippon Koei and Tepsco, Germany's Fichtner and Australia's SMEC -- has advised the channel be usable for deep-sea vessels deep sea port.

As a result, the channel will now be 14.3 km long, 350 m wide and 18.5 m deep.

Tigresses stun Pakistan

Bangladesh started their Women's Cricket World Cup Qualifier campaign with a thrilling three-wicket victory over Pakistan in Harare yesterday.

The Nigar Sultana-led side restricted Pakistan to 201 after opting to field first before chasing down the target with three wickets in hand and two balls to spare.

An unbeaten 50 off 44 deliveries from Rumana Ahmed and a 13-ball 18 not out from former captain Salma Khatun led the victory charge after Bangladesh had stagnated hopelessly in the middle overs despite making a solid start to their chase.

Despite losing Murshidha Khatun (9) early, Bangladesh had looked comfortable when Sharmin Akter and Fargana Haque took the total to 80 in 25 overs. But the dismissal of Sharmin (31), Fargana (45) and Nigar (4) in space of 18 runs derailed the chase as the asking rate started to climb and scoring rate all but came to a halt.

Japan-born kids to stay with father

The High Court yesterday directed that two Japan-born children of Japanese national Eriko Nakano and Bangladesh-born US citizen Imran Sharif will remain with their father

It also said their mother will be allowed to meet them three times a

"Eriko can meet her daughters, Nakano Jasmine Malika, 11, and Nakano Laila Lina, 9, exclusively for 10 days at a time and Imran will bear her travel and other relevant expenses during these periods," the court said.

Besides, she can also meet her children in Bangladesh at any other time at her own expenses because she lives in Japan and is a service holder there, the HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman said.

Delivering the verdict, the bench expressed hope that both parents will take constructive and positive steps for their welfare.

"Any party involved in this case [writ petition] may win, but it is the two children who will be the victims. We have heard statements from the children three times and we are delivering the judgement considering their welfare in our conscience," Justice Enayetur Rahim said.

In the observation, the bench directed the father to ensure that Jasmine and Laila can talk to their mother over video calls twice a month.

Imran, 58, has also been ordered to give Tk 10 lakh, within seven days, to Eriko for her expenses so far in Bangladesh.

The court asked the social welfare officer concerned in Dhaka to submit a report on the status of the children before it through the Supreme Court

The excessive outlay on medicine is because of two reasons: irrational prescription and aggressive marketing, said Md Nurul Amin, director of research at HEU, in his keynote presentation at the event.

As much as 60 percent of the patients take medicines by selfmedication and excessive prescription by informal providers like drug sellers and quacks, while 25 percent of the patients are victims of prescription of costly non-listed drugs.

About 58 percent of the employees pharmaceutical companies are engaged in marketing and distribution, found the study. For instance, in 2010, 27 percent of the pharmaceutical companies' revenue was spent on marketing.

To curtail the cost of medicine, the researchers recommended revising and expanding the list of emergency medicines and following the treatment protocol by the physicians.

"We are working to reduce the diagnosis cost. I would urge the private healthcare service providers for help in this regard," he added.

Statistics show that only 3 percent of the patients get medicine from the government hospitals while only 14.9 percent of the tests are done there, Amin said.

To eliminate poverty, there is no alternative to addressing the underlying factors of high OOP, he told The Daily Star.

To reduce the OOP expenditure, researchers recommended coordination between community clinics and Upazila Health Complexes by introducing e-health services, ensuring efficiency of the public healthcare facilities and introducing social health insurance system.

They also recommended introducing an accreditation system for private healthcare facilities to control healthcare costs and standards and making use of generic names in prescriptions mandatory to discourage the drug-makers from aggressive

Court extends time for PBI to probe COURT CORRESPONDENT

COLLEGE STUDENT'S DEATH

A Dhaka court yesterday again extended the date for the Police Bureau of Investigation (PBI) to submit the probe report of the case filed against Bashundhara Group Managing Director Sayem Sobhan Anvir and seven others over the rape and murder of a college student in the capital's Gulshan.

The new date fixed for the submission of the report is December 8.

Dhaka Metropolitan Magistrate Begum Yasmin Ara passed the order after Investigation Officer Golam Moktar Ashrafuddin, also a PBI inspector, failed to submit the probe report yesterday - the previously scheduled date, court sources said.

This is the third time a date was scheduled for the submission of the report.

Earlier, the same court on November 2 asked the PBI to submit the report by yesterday.

Anvir was made the prime accused in the case, while chairman of the group Ahmed Akbar Sobhan alias Shah Alam and six others -- Shah Alam's wife Afroza Begum, Anvir's wife Sabrina Sayem, model Faria Mahbub Piyasha, Saifa Rahman Mim, the flat's landlord Ibrahim Ahmed Ripon and his wife Sharmim -- were accused of assisting Anvir in committing the offence.

The High Court on September 29 refused to grant anticipatory bail to Anvir in the case.

After police recovered the body of the 21-year-old college student in a Gulshan flat on April 26, her elder sister had filed a case with Gulshan Police Station against Anvir on charges of suicide abetment.

On July 19, Abul Hasan, investigation officer of that case and also Gulshan Police Station's officein-charge, submitted the final report to the Chief Metropolitan Magistrate's

On August 18, a Dhaka court accepted the final report and relieved Anvir from the case.

However, the victim's sister on September 6 filed another case with Dhaka's Women and Children Repression Prevention Tribunal-8 against Anvir over the rape and murder of the victim and seven others for assisting him.

This will cost about Tk 14,327 crore and an additional three years, according to the revised proposal, which will be placed at tomorrow's Executive Committee of National Economic Council meeting.

Japan International Cooperation Agency would largely be footing the additional cost of Tk 15,870.4 crore to take the donor agency's total commitment to the project to Tk 43,921 crore, up 51.8 percent from the original plan.

The additional expenditure will be for beefed-up security for employees, consultants' fee as the implementing period of the project has now been extended, and the increase in valueadded tax for the imported products, among others.

The project, which started in July 2014, will now wrap up in December 2026 instead of June 2023, meaning there would be an additional consultancy fee of Tk 327.8 crore.

According to the new guidelines of the National Board of Revenue, the VAT has been increased, as a result of which the expenditure will rise to Tk 5,186 crore from Tk 3,020 crore, the proposal said.

People from all strata of life formed a human chain on the premises of the deputy commissioner's office in Sherpur yesterday protesting the recent killing of elephants.

Jonouddyog, a citizens' platform, organised the event.

The human chain was joined by volunteers, cultural activists, journalists and professionals. It was presided over by Abul Kalam Azad, convener of the organisation.

Speakers said it is high time to take steps to protect the endangered Asian elephants.

They also expressed deep concern over the death of two elephants in Sreebordi and Nalitabari upazila in Sherpur since November 9.

Since 1995, deaths of 31 elephants were reported in the hilly regions of Sherpur. The protestors also submitted a four-point memorandum to the deputy commissioner demanding immediate steps in this regard.

Petition seeks

A Supreme Court lawyer

yesterday filed a writ petition seeking the High Court directives to stop the killing of elephants and human intrusion into elephant corridors.

Barrister Khan Khalid Adnan filed the petition requesting the HC to issue a rule asking the authorities, including the secretary of Environment, Forest and Climate Change Ministry and Forest Department to issue a gazette for the twelve corridors identified by the department and International Union for Conservation of Nature (IUCN).

"We requested the High Court to issue directives through a gazette to preserve twelve elephant corridors for their safe movement," he said.

Seven elephants in total were killed in just eleven days this month. Among them, two were in Sherpur and the rest in Cox's Bazar and Chattogram.

In a bid to manage funds for the Bhanga to Payra Port rail line, railways authorities have started talks with a UK-based company -- IM Power PLC -- over the 214km line.

During their UK tour slated to start from tomorrow, a delegation led by Railways Minister Nurul Islam Sujan will hold further discussions with the company.

"They have shown interest for both investing and providing technology [for the rail line]. They have already met with us in Bangladesh, now we will hold a meeting with them there," the minister told The Daily Star yesterday.

An eight-member delegation led by the minister will visit four European countries, including the UK, from tomorrow to December 5 to see developed railway systems there.

Besides, they will hold talks with different government agencies and businesses that showed interest in investing in BR. They were scheduled to leave the country last night.

PROJECT TIMELINE

The development comes months after Bangladesh Railway (BR) has completed feasibility studies and detailed designs for the rail line.

As part of the government's plans to bring the entire country under the rail

network and establish a direct link between the under-construction Payra Sea Port and the capital, BR intended to construct the rail line from Bhanga to Payra.

The line, which will have 19 stations, will cost around Tk 41,797.6 crores, or \$4.93 billion. The proposed deadline of the project is June 2029.

BR authorities expect the direct link between the sea port and the capital as a way to boost its income by operating freight trains on the line.

BR has already sent the Preliminary Development Project Proposal to the Railways Ministry to forward it to the Economic Relations Division (ERD) to find financiers for the project, sources said.

Bhanga has already been connected with the railway network from Faridpur and it will be linked directly with the capital once the ongoing Padma Bridge Rail Link Project -- under which a rail line from Dhaka to Jashore is being constructed -- is completed by June 2024.

Workers by day, muggers by night

CID arrests 5 members of mugging gang in connection with college student's murder

In daylight, they work as auto-rickshaw drivers, bus helpers or day labourers. But when the night gets dark, they get on auto-rickshaws, get out on the highways, and target people for robbery.

Recently, a college student in Gazipur -- Mehedi Hasan Tuhin (23) fell prey to the gang. When he refused to hand them his phone, they slit his throat and left him to die. Over the last two days, Criminal Investigation Department of police

conducted two raids in Keraniganj and the capital's Demra area and arrested five members of the gang. This was revealed by CID Special Superintendent Mukta Dhar, who

spoke at a press briefing at its headquarters in the capital's Malibagh The arrestees are -- bus helper Masud Rana (22), auto-rickshaw driver Fakhrul Islam (38), and day labourers Sumon Hossain (24), Hazrat (22),

and Aliar Rahman Raju (38). Mukta Dhar said deceased Tuhin, a final-year management student at a Gazipur college, worked as a sales staff at a mobile company's store at Runu Super Market in Konabari, Gazipur for the last six months.

On November 12, Tuhin was on his way home when the muggers stopped him on Gazipur-Tangail highway in Naojor area around 8:30pm. Following his death at their hands, his father filed a case against unidentified accused at Basan Police Station in Gazipur the next day.

"When the victim tried to stop their advances, the muggers hit him with an iron rod or stabbed them with a knife and fled," she said. The official said they carry out two-three such operations every day and

have 10-15 members in the gang. CID seized five mobile phones, including the victim's one, and an auto-

rickshaw from their possession.

Fugitive accused held after 20 years

Today is November 22. On this day in 1971, 10 members of the Harijan community were picked up and killed by the Pakistan forces.

Their crime? Aiding freedom fighters.

They all lived in the Mirin Jilla Harijan City Colony in the capital's Aga Sadek Lane. But despite their valiant efforts and eventual tragedy, they're yet to get recognised as freedom fighters 50 years on. Instead, losing the prime bread-earners, their families have lived this half-a-century mired in misfortune.

During the Liberation War, locals of the Harijan colony helped out freedom fighters in whatever way they could, up to varying degrees of danger. From supplying food to even carrying arms inside brooms.

But as news of this got to the aggressors' camp, on November 21 midnight, the Pakistan forces picked up 10 Harijans. They could never be traced again.

They are: Mahabir Lal Samund, Nandu Lal, Anowar Lal, Ishwar Lal, Khalbal Das, Ghashita Das, Sankar Das Hela, Nanda Lal, Lalu Das, and Ramcharan.

As homage to them, Harijan Sevak Samity has built a memorial inside the colony. On November 22 every year, relatives of the martyrs, along with residents of the colony, gather there to lay down floral tributes and host remembrance programmes.

Four workers die in Dhaka, N'ganj

At least four workers died in the capital and Narayanganj

over the last two days. In Dhaka, two persons died from electrocution and two others sustained minor injuries while welding at an underconstruction house in Badda yesterday afternoon.

The deceased are Ariful Islam Sohel (28), owner of Ma Engineering Workshop at Satarkul area; and Jahangir Alam (32), his employee. Nine workers were welding metal frame of a shed of the house when four of them got electrocuted around 2:00pm.

Two of them were taken to Dhaka Medical College Hospital where doctors declared them dead around

3:00pm," said one Md Hossain, who took them to DMCH. Meanwhile, two of the four workers, who were injured in a fire at City Auto Rice Mill in Narayanganj on Saturday,

have died at a Dhaka hospital. Hazrat Ali (50) succumbed to his injuries around 10:00pm on Saturday while Belayet Hossain (60) died around 9:00am yesterday at the Sheikh Hasina National Institute of Burn and Plastic Surgery.

"Hazrat had 99 percent burn injuries and Belayet 95 percent," said Dr Aiyub Hossain, resident surgeon of the institute. Another injured, Sirajul Islam (60), is in a critical state at the burn institute with 65 percent burns while Md Rana (45), a security guard of the mill, is undergoing treatment at a private hospital.

Flames engulfed the mill located at Rupganj upazila after a boiler pipe exploded due to excessive heat while the workers were packing rice husk around 2:30pm on Saturday.

TK 1.58CR GRAFT Court frames charges against ex-MP Mizanur

They mentioned Providus Investments, an Australian company, had expressed interest to fund and strike an EPC (engineering, procurement, and construction) contract early this year.

BR has sent a letter to the rail ministry seeking ERD's opinion in this regard.

During a visit to Saudi Arabia in September this year, Prime Minister's investment adviser Salman F Rahman, also sought the country's investment in the project.

In November 2019, while meeting the then chief of Bangladesh Investment Development Authority (BIDA) Sirazul Islam, UK-based IM Power Plc and TenBroeke Ltd had proposed an integrated initiative involving the development of Bangladesh's power and railway sectors.

Yesterday, the minister said they would talk with IM Power over their proposal to invest in the project. He said the Bangladesh High Commission in UK is also in touch with the company after they expressed interest in the project. "If necessary, we will provide partial funding along with the company's investment."

He said the company also expressed interest to get involved in a project for the electrification of Dhaka-Chattogram rail line, which will also be discussed during the meeting.

IM Power is an independent power producer (IPP), providing comprehensive solution for customers by combining its expertise in financing power generation, integrated power and industrial infrastructure projects together with EPC, operation and maintenance services, according to their website.

Mashuk Selim | Recognition ever-elusive

correspondent saw preparations were ongoing in fullswing ahead of today's programmes. The memorial plaque had been cleaned, while a banner was hung at the main gate of the Mirin Jilla Government Primary School. It reads "May the Martyr's Day Live Forever".

At the colony area, this correspondent spoke to Anowar Lal's wife Benodebi. Even after all this time, she gets all teared up thinking of that fateful night 50 years ago.

"I still get shivers. We had already gone to sleep with our two daughters and son. In the middle of the night, there were knocks on the door. It scared us stiff," said a griefstricken Benodebi.

"As soon as he [Anowar Lal] opened the door, the Pakistan army picked him up in the face of firearms. We never saw him again.

Reminiscing her husband's role during the Liberation War, she said, "We used to see him come home with bread, banana, flattened rice, and molasses. But he'd then hide them. If I asked, he'd tell me not to think about it. We later got to know he used to bring the food home for the freedom fighters."

"Ever since his passing, I had been living a life befitting of a nightmare. I managed to get a job at Bangladesh Biman as his wife, but I'm retired now. It's been 50 years, but we're yet to get any recognition, other than 'The Daily Star Unsung Heroes of Bangladesh Liberation War 1971' award in July 2013. But there's been no formal acknowledgment from the government," she lamented.

Like Benodebi, members of the other nine martyrs' families are also spending their days in deep distress.

Talking to this newspaper, Harijan Sevak Samity senior vice-president Nirmal Chandra Das said, "To be honest, we couldn't even speak in the early days after the liberation. Some time later, we started contacting different quarters over the recognition of our martyrs.

"Recently, we brought over Liberation War Affairs Minister AKM Mozammel Haque as a guest at one of our programmes and told him of our demands. But recognition still remains ever-elusive. If we could get it, at least the family members could get some allowances or jobs. But nothing of the sort has happened."

This year, the community isn't planning to hold any elaborate events. "Renovation work is going on at roads around the colony, which is why we aren't inviting guests. We'll just hold a remembrance programme among ourselves. There'll be floral tributes, special prayers. We'll also be cooking food for residents of the colony," Nirmal

EIGHT YRS OF BONOGRAM ATTACK

All seven key accused still on the loose

Trial proceedings of only one out of three cases began

It has been eight years since Hindus in Bonogram of Pabna's Santhia upazila came under attack, but all the seven individuals who were made key accused in three cases continue to elude capture while two of the cases still

On November 2, 2013, religious zealots vandalised, looted and set fire to houses, shops and Hindu temples in the predominantly Hindu village, claiming that a resident of the village defamed Islam by his post on Facebook.

Following the incident, three separate cases were filed against dozens of attackers, mentioning names of seven as

All the seven key accused including prime accused Khokon Mia, son of Motiar Mia, are still on the run.

Till date, the trials in the cases are yet to begin while police finished submitting charge sheets for all three cases. Advocate Abdus Samad Khan Ratan, public prosecutor (PP) at Pabna court, said, "Total 97 people were accused in the charge sheets. Seven among them, including key accused Md Khokon Mia, went into hiding."

Of the three cases, the trial of attack on police has already begun and the trial of the other two cases are being delayed as the cases are being handled at a regular court,

The process of issuing arrest warrants for the absconded is underway, but various other steps need to be followed before the trials can start, the PP said, adding that circulars would need to be published in newspapers declaring seizure of wealth of the absconded, in case they fail to appear before the court.

The primary target of attack on November 2 was the house of Rajib Saha, son of Bablu Saha, as Rajib supposedly made the defamatory post on his Facebook. Despite protesting repeatedly that his son was innocent, Babul was hit and kicked upon mercilessly and their house

Raiib's mother Shibani Saha said her son was lucky to have escaped the attack that day and he has not been able to come home ever since.

"Thinking of that day makes my eyes water. But it's more painful to watch the attackers roaming freely before us, evading punishment.

Rajib's father Bablu said he heard that Khokon Mia has been living in France. School teacher Sukumar Bishwas was among the victims

of the attack that day. He said, "Never before did we imagine of such attack. I want to forget the incident, but I'm still carrying the pain. It would be at least a consolation for us if the criminals were punished."

Contacted, Ataikula Police Station Officer-in-Charge Jalal Uddin said they arrested "most of the accused" and according to their information, Khokon left the country following the incident.

The rules assign particular organisations to investigate particular crimes under the Money Laundering Prevention Act-2012.

The rules have specified 27 types of oney laundering-related offences. Of these, the Criminal Investigation Department of police has been given the task with investigating 24 offences alone or with the National Board of Revenue, Department of Narcotics Control and

Department of Environment. According to the rules, the ACC is given the sole responsibility to investigate the money laundering offences related to graft and bribery, while NBR and Bangladesh Securities and Exchange Commission can probe the crime

related to tax and capital markets respectively. ACC Chairman Mohammad Moinuddin Abdullah at the programme said it was a difficult task to prove corruption. "But there are things like hearsay. We'll know

who is corrupt, but it is difficult to prove before the court of law. We can boycott such people. "I request you all to boycott the people

who are known to be corrupt ...," he said. Pointing out that it was not possible for the ACC alone to prevent corruption, he said, "We all need to work together to prevent corruption."

Replying to a question, the ACC chairman said they would not arrest people unnecessarily. "We'll arrest people only when it is required.

Later, the ACC chief handed over crests to the winners of RAC Best Reporting Award. This year, under three categories -- print, electronic and online -- three reporters got awards for the best reports on corruption.

If successful in supporting a sustained human presence on the moon, the next objective would be Mars. Nasa says fission surface power could provide sustained, abundant power no matter the environmental conditions on the moon

"I expect fission surface power systems to greatly benefit our plans for power architectures for the moon and Mars and even drive innovation for uses here on Earth," Jim Reuter, associate administrator for Nasa's Space Technology Mission Directorate, said in a statement.

The reactor would be built on Earth and then

sent to the moon. Submitted plans for the fission surface power system should include a uranium-fueled reactor core, a system to convert the nuclear power into usable energy, a thermal management system to keep the reactor cool, and a distribution system providing no less than 40 kilowatts of continuous electric power for 10 years in the lunar environment.

Some other requirements include that it be capable of turning itself off and on without human help, that it be able to operate from the deck of a lunar lander, and that it can be removed from the lander and run on a mobile system and be transported to a different lunar site for operation.

Additionally, when launched from Earth to the moon, it should fit inside a 12-foot (4-meter) diameter cylinder that's 18 feet (6 meters) long. It should not weigh more than 13,200 pounds (6,000 kilograms).

China downgrades ties with Lithuania over Taiwan row

China has officially downgraded diplomatic ties with Lithuania in protest, the foreign ministry in Beijing said yesterday, after Taiwan established a de facto embassy in Vilnius. Lithuania allowing Taipei to open an office using the name Taiwan was a significant diplomatic departure that defied a pressure campaign by Beijing. China baulks at any official use of the word "Taiwan", lest it lend a sense of international legitimacy to the island - which it considers a part of its territory to be taken one day. Only 15 countries officially recognise Taipei over Beijing.

With a dig at China, India unveils new warship

India yesterday commissioned its navy's first indigenously-made missile destroyer as Defence Minister Rajnath Singh said, without naming China, that "some irresponsible nations for the sake of their narrow partisan interests, keep giving new and inappropriate interpretations" to international laws relating to sea to promote "hegemonic tendencies." The destroyer is packed with sophisticated state-of-the-art weapons and sensors such as surface-to-surface missile and surface-to-air missiles. The ship is also fitted with a modern surveillance radar which provides target data to the gunnery weapon systems of the ship and anti-submarine warfare capabilities are provided by the indigenouslydeveloped rocket launchers, torpedo launchers and helicopters. The ship is equipped to fight under nuclear, biological and chemical warfare conditions, the Defence Ministry said.

15 dead in Myanmar pagoda drowning

At least 15 people drowned on Sunday while crossing a flooded causeway in Myanmar to reach a Buddhist temple for a festival, rescue workers told AFP. The tragedy unfolded as thousands of worshippers tried to reach the Kyeik Hne pagoda, which lies on a rocky outcrop around three kilometres (two miles) off the coast near the town of Thanbyuzayat in southern Mon state. Protests to go on till laws repealed

Say Indian farmers, demand price guarantees

Farmers at the Delhi borders have said that say their protests will continue till the formal cancellation of the three contentious farm laws, which Prime Minister Narendra Modi announced on Friday.

They have also demanded a law on minimum support prices, and withdrawal of the police cases filed against many of them over the last year.

The official withdrawal of the laws will take place only when parliament's Winter Session that will begin at the end of this month. The cabinet approval for the withdrawal of the laws is expected on Wednesday. Winter Session begins on November 29, during which the bill for repealing the laws will be passed.

"We have discussed the repeal of farm laws. After this, some decisions were taken. The pre-decided programmes of the SKM (Sanyukta Kisam Morcha, an umbrella body of farmers) will continue as it is," said Balbir Singh Rajewal at the Delhi-Haryana border in Singhu.

The programmes include a farmers' meet n Lucknow on November 22, gatherings at all borders on November 26 and a march to parliament on November 29, he added.

The farmers also said they will write an open letter to the prime minister listing their

In 2020, Modi's government passed three farm laws in a bid to overhaul the agriculture sector that employs about 60% of India's workforce but is deeply inefficient, in debt and prone to pricing wars.

Angry farmers took to the streets, saying the reforms put their jobs at risk and handed control over crops and prices to private corporations.

The resulting protest movement became one of the country's biggest and most protracted.

Leaders of six farmer unions who spearheaded the movement in Uttar Pradesh and Punjab states said they would not forgive a government that labelled protesting farmers as terrorists and anti-nationals.

Sudhakar Rai, a senior member of a farmers' union in Uttar Pradesh, said at least 170 farmers were killed during anti-farm law protests across the country. There are no official data to verify his claims.

Leaders of the opposition and some analysts said Modi's move was linked to state elections next year in Uttar Pradesh - which accounts for more parliamentary seats than any other state - and Punjab.

JERUSALEM SHOOTING Attacker shot dead after one killed

AFP, Jerusalem

A militant of the Palestinian Islamist Hamas movement vesterday opened fire in Jerusalem's Old City, killing one person and wounding three before he was shot dead, Israeli officials, police and medics said.

Prime Minister Naftali Bennett ordered security to be boosted and called for people to be on "heightened alert" over the risk of further attacks.

The wounded, who included two civilians and two police officers, were rushed to Jerusalem's Hadassah hospital. One of them, a man in his 30s, died of his injuries, medical sources said without giving further details.

Police said the attacker had fired a "Carlo-type weapon", a type of submachine gun.

The Old City is in the Israeli-annexed eastern part of Jerusalem, which Palestinians claim as the capital of their future state.

'Greatest attempt to destabilise Europe'

Poland says border crisis most serious challenge for the continent since Cold War

Polish Prime Minister Mateusz Morawiecki yesterday called the migrant crisis on the Belarusian-Polish border, the EU's eastern frontier, the "greatest attempt to destabilise Europe" since the Cold War.

The premier issued his strong remarks as he prepared to meet with EU leaders at a time when Warsaw is facing not only a border crisis but heightened tensions with Brussels over allegations it is breaching its commitment to the bloc's democratic principles.

The West accuses Belarus of artificially creating the crisis by bringing in would-be migrants -- mostly from the Middle East -- and taking them to the border with promises of an easy crossing into the European Union. Belarus has denied the claim, instead criticising the EU for not taking in

Caught in the middle, migrants often report being forced to cross the border by Belarusian officials, then being pushed back into Belarusian

territory by Polish authorities. Belarusian President Alexander "Lukashenko launched a hybrid war against the EU. This is (the) greatest attempt to destabilise Europe in 30 years," Morawiecki said on Twitter.

"Poland will not yield to blackmail and will do everything to defend the EU's borders.

He also claimed that Lukashenko had the "back-room support of Vladimir Putin," the Russian president and an ally of the Belarusian regime. Lukashenko told the BBC earlier that it was "absolutely possible" his forces had helped people cross into the EU but denied orchestrating the

An Indian man declared dead after a road accident shocked his relatives when they found him still breathing despite a night in the freezer of a hospital morgue.

Oman Celebrates 51st National Day of the Renaissance



51st National Day of the Renaissance on November 18, 2021. The event comes around at a time when Omanis ponder about the achievements made so far and brace for further accomplishments, with firm resolve, under the astute leadership of His Majesty Sultan Haitham bin Tarik who pledged to hold high the banner of Renewed Renaissance since he assumed power on January 11, 2020.

The Renewed Renaissance kicked off on a high note when His Maiesty Sultan Haitham bin Tarik called upon the people of Oman to do their best to enrich domestic development and foster progress in all fields. This is considered one of the major principles of the Renewed Renaissance in its quest to attain the supreme national objective of "making Oman the central point in all that we strive to achieve" — an objective whose salient features have already materialized in terms of updated laws and refurbished programmes of action across all sectors.

In the beginning of this year, Royal Decree No. 6/2021 promulgated the (updated) Basic Law of the State to serve as a pillar of continuous efforts to shape a better future for Oman and its citizens, and to build a solid ground for their Renewed Renaissance.

The Basic Law of the State lays down a stable mechanism of transfer of rule, which reflects positively on political and economic aspects and affirms the principle of sovereignty and independence of the judiciary. It also serves as a basis of rule in the State. It makes education compulsory till the end of the Basic Education stage. It establishes a scholarly method for thought, development of talents and encouragement of innovation, which all conform to the Oman Vision 2040.

Article (7) provides for the appointment of a Crown Prince under a Royal order in accordance with stipulation of Article (5) of the Basic Law of the State. The Royal order defines the powers and prerogatives of the Crown Prince, as well as the tasks delegated to him. It states that the Crown Prince shall be sworn in before the Sultan, before undertaking the powers and tasks delegated to him. The oath shall be taken in accordance with Article (10) of the Basic Law of the State.

The Sultanate of Oman stands out for its exclusive practice of Shura-based democracy, set up on solid grounds emanating from Omani life realities. Shura practice evolved through various stages till it developed into present-day "Council of Oman", with its bicameral chambers — the "State Council" and "Shura Council". Each stage saw the addition of systems and laws that reinforce the tradition of Shura and respond to the expectations of citizens. To this effect, His Majesty Sultan Haitham bin Tarik issued Royal Decree No. 7/2021 promulgating Council of Oman Law, which comprises 78 articles.

The designation of an "Omani Youth Day" on October 26 reflects the attention accorded to the young generation by His Majesty Sultan Haitham bin Tarik. It asserts the leadership's deep conviction

The Sultanate of Oman celebrated its in the potential of youth in promoting the country's development. Speaking at a meeting of the Council of Ministers he chaired in October 2021, His Majesty the Sultan underscored the significance of devising a mechanism and for opening channels of communication with the youth to explain all the requirements of the development process in all sectors. He gave directives to listen to the youth and study their needs and aspirations. He also instructed governors and the authorities concerned to hold regular meetings with the youth for this purpose. He advised the officials to raise issues of interest or concern to the youth, listen to their opinions and help

them perform the role expected of them

in contributing to the comprehensive nation-building march.

Meanwhile, HH Sayyid Theyazin bin Haitham Al Said, who presided over the Omani Youth Day celebration last October, said that the Ministry of Culture, Sports and Youth launched a smart portal supplied with the latest techniques that make it a prime website for talented youth, artists and

The attention accorded by His Majesty Sultan Haitham bin Tarik to the youth is also reflected in the Royal support to employment initiatives, a set of which came around in May 2021, when the coronavirus pandemic had its greatest toll on local and global economic conditions, leading to the shrinkage of the labor markets. The Royal attention resulted in the launch of an executive plan to provide more than 32,000 jobs.

His Majesty the Sultan also chaired a meeting of the Supervisory Committee of the National Employment Programme (NEP) on July 5, 2021. This placed employment in the realm of national priorities. His Majesty the Sultan reiterated the importance of the NEP when he presided over a Council of Ministers on June 15, 2021, during which he gave directives for "devising suitable solutions to provide jobs in all departments of the State (the public sector) and private sector firms, provide analysis of jobseekers' data and follow them up until they join the labor

Omani women's affairs take center stage in the Renewed Renaissance thought of His Majesty Sultan Haitham bin Tarik, who has been keen that women enjoy their rights guaranteed by law and operate alongside men in different fields of national service. Attention to women is one of the "national fundamentals" of the country.

On the occasion of International Women's Day celebrated last March, Her Highness the Honourable Lady Assayida Ahd Abdullah Hamed Al Busaidi, spouse of the Sultan of Oman, commended the great efforts exerted by women in Oman and the rest of the world while building their nation, supporting their families and societies and contributing effectively to the management of human and global issues.

HH the Honourable Lady addressed women on the Omani Women's Day this year. She said, "On the occasion of Omani Women's Day, the 17th of October, we would like to express thanks and appreciation for every woman who advocates good deeds and elevates the values of tolerance, amity and benevolence. Our greetings go to every woman who contributes to building this dear country from her position as an active participant delivering her social, national and humanitarian duties in all

To mark the same occasion, HH Sayyid Theyazin bin Haitham Al Said, Minister of Culture, Sports and Youth issued a ministerial decision announcing the establishment of Omani Women's Sports and Cultural Innovation Club. The move comes in implementation of the basic principles espoused by the Sultanate of Oman in the field of women's empowerment. It is a symbolic gesture to promote women's contribution to domestic development and to promote their role in sports and cultural fields.

Nations attain their prime only through education, and this has been principle espoused by Omanis since the outset of their blessed renaissance 50 years ago. His Majesty Sultan Haitham bin Tarik stressed on "attention to education figures high in the scale of national priorities". Accordingly, a motivating environment has been furnished for supporting the march of research and innovation. This translates into the allocation of a ministry mandated with higher education, research and innovation and the establishment of the University of Technology and Applied Sciences, with branches in governorates of the Sultanate of Oman.

The university's articles of association

were issued in June 2021. In the same month, the Council of Ministers approved the setting up of a branch for the university in the Governorate Musandam. It comprises a number of specializations reflecting the Royal attention towards the development of the governorate and the realization of sustainable and comprehensive development there.

In the same context, the Duqm College was established in September 2021, in the Governorate of Al Wusta at the Special Economic Zone in Duqm. The university is governed by the laws regulating universities and colleges in the Sultanate of Oman and the hopes attached on the National Research and Development Strategy 2040 in line with the Oman Vision 2040. Royal directives to set up six schools to the tune of RO 8,850,000 will raise the number of scholarly institutions to 2,430 schools, 11 government and private universities and 18 private colleges.

Under its Renewed Renaissance, Oman continued to accord attention to environment protection, both at the local and global levels. To this effect, His Majesty Sultan Haitham bin Tarik issued a Royal Decree in August 2021 to establish the Khor Kharfout Nature Reserve in the Governorate of Dhofar, taking the number of such sanctuaries to 21. The Sultanate of Oman also ratified many international agreements related to the environment protection and legislations for the same purpose at the

The decline and fluctuation in oil prices and precautionary measures to address the impacts of Covid-19 affected the economies of many countries of the world. Since Oman is not isolated from the global community, it had to take



measures to address the situation. These included the initiation of a mediumterm Fiscal Balance Plan (2020-2023). In April 2021, His Majesty the Sultan chaired a meeting of the main committee tasked with the National Programme for Fiscal Balance to follow up the progress of the programme in its second year. The programme was designed to bring down general debt and to secure financial sustainability.

His Majesty the Sultan endorsed the initiatives submitted by the departments concerned in a bid to develop the schema of social protection. This affirms His Majesty the Sultan's follow-up of the conditions of citizens to ensure the sustenance of decent livelihood for them and to alleviate the fallouts of this challenging stage.

The 10th Five-Year Plan (2021-2025), the first leg in the executive plan of the Oman Vision 2040, is based on four axes comprising 14 national priorities, 88 strategic goals and 68 performance

The 10th Five-Year Plan seeks to achieve a number of goals, such as activating the economy, upgrading the efficiency of management of public finance, realizing balance among measures for rationalization of public spending, espousing disciplined financial expansion policies, accelerating the rate of implementation of major strategic projects and governmentprivate partnership projects, attracting more direct foreign investments, visualizing growth trends based on expected oil price rate of USD 48 per barrel during years of the plan, and enhancing governorates' participation in achieving goals of the Oman Vision

The plan targets average annual growth of 3.2% in the Gross Domestic Product (GDP) through emphasis on promising economic like converting industries of high technological content, agriculture, fisheries, fish farming, food and agriculture industrialization, transport, warehousing and logistics.

Total estimated revenues of the State Budget 2021 stood at RO 8.64 billion calculated on the basis of oil price rate of USD 45.

The Governorates Development Programme, which emerged in implementation of Royal directives, will allocate RO 10 million to each governorate during the period of the 10th Five-Year Plan (2021-2025) — at a rate of RO 2 million a year. The programme envisages the execution of 28 strategic programmes and it will contribute to the goals of the Oman Vision 2040.

The Economic Stimulus Plan (ESP), endorsed by the Council of Ministers in March 2021 is based on five axes comprising incentives on taxes, fees and incentives for the improvement of the business and investment climate,

incentives for small and medium enterprises, incentives for the labor market and recruitment, banking incentives aimed to rally efforts for the alleviation of Covid-19 impacts on the national economy and other incentives to promote economic recovery, back up economic activities and attract foreign

These financial procedures, topped by the medium-term Fiscal Balance Plan, showed positive results as Oman registered growth in total revenues by 22.6% and a 58% decline in deficit by the end of September 2021.

The International Monetary Fund (IMF) expected in a report issued in September 2021 that economic activities in the Sultanate of Oman will recover and that Oman will achieve 2.5% GDP growth in 2021 and 4.2% growth by 2023. The IMF also commended the measures undertaken by Oman while addressing the fallouts of Covid-19, as well as the country's fiscal discipline and enhancement of business environment and support for stricken economic

The measures undertaken by Oman improved its credit rating in various agencies, including Moody's, which amended the Sultanate of Oman's rating from "negative" to "stable" in October 2021. Moody's expected that public debt in Oman vis-à-vis the GDP will decline from 80% in 2020 to 60% in 2024, as well as the decline of the annual government funding needs to GDP from 22% to 10%. Standard and Poor's also amended its future outlook for Oman from "stable" to "positive".

Meanwhile, Fitch pointed out last May that the Fiscal Plan contributed to the improvement of scenario for Oman's financial position and expected a 6.1% decline of budget deficit to GDP this year (2021). It also expected a 3.3% economic growth for Oman by next year

The government of His Majesty Sultan Haitham bin Tarik created an investment-encouraging environment through legislations, ports, free zones and logistics, coupled with a unique strategic location in the meeting point of global commercial markets, political stability and security.

The ports of Duqm, Salalah and Sohar boast a range of advanced facilities that enabled them to achieve quick finalization of tasks and cut the distance between world ports. This is in addition and opened wide vistas of cooperation to the free zones in Duqm, Al Mazyouna, between the two countries in different Khazaen hub in the Governorate of South Al Batinah. Investment incentives like tax exemptions extending to more than 30 years and foreigners' 100% ownership of properties, among other incentives, add another fillip to Oman's

Oman advocates principles of non-interference in the internal affairs of other countries, positive contribution to safeguarding international security, promoting common public interest through dialogue and understanding among countries and nations.

These principles were affirmed by Oman before the 76th UN General Assembly in New York last September. "Under the wise leadership of His Majesty Sultan Haitham bin Tarik, the Sultanate of Oman pursues its commitment to the basic fundamentals



Pandemic-time tours go against govt's own rules

Why fly halfway across the world when most meetings can be conducted online?

■ INCE March last year, the government has saved Tk 2,500 crore in funds that would otherwise have been spent on foreign trips taken by government officials. While certain overseas meetings and training can be very useful, questions had been raised, prior to the pandemic, on the logic behind spending taxpayers' money for frequent tours—especially since many such trips end up yielding no noteworthy results. In some cases, officials had gone on foreign tours with projects they did not even have any involvement with, and the prime minister herself had spoken out against such

In this context, we are confused as to why officials of Bangladesh Railway and the railways ministry have now planned four different trips to Europe, the US and India over the next three months. This is despite the fact that the government withheld 50 percent of this fiscal year's allocation for foreign trips, and asked officials to cancel routine tours. According to a finance ministry circular from July 1, the remaining funds can only be spent during emergencies and unavoidable circumstances.

So far, the reasons given for the scheduled trips are studies, training and visiting factories. None of these can hardly be considered an emergency, or an unavoidable circumstance. From Tuesday, Railways Minister Nurul Islam Sujan will lead an eight-member delegation on a 13-day trip to four European countries. According to the railways minister, its purpose is to observe developed railway systems and hold talks with different stakeholders. We wonder why there is this sudden need to travel to hold such talks when, during the pandemic, all the biggest government agencies and businesses across the world shifted to videoconferencing for most

It has also not been made clear how much money will be spent on the planned tours. Why the mystery surrounding these visits? Given that Europe is the only place in the world where coronavirus cases are continuing to rise, and that many states in the US are also in precarious situations, the people of this country have every right to be concerned about our officials travelling there. We would also like to know: Will the officials going to these countries quarantine on their return?

Now that the Covid-19 situation has finally come under control in Bangladesh, it is careless of railway officials to plan trips to high-risk countries—that, too, at the public's expense, and for reasons that the government's own directives would not consider essential. It is high time that the authorities dealt with the issue of different ministries and departments failing to follow the rules that are set by their own administration. In Digital Bangladesh, there is really no reason to waste precious resources and contribute to the climate emergency by flying across the world, if the purpose of such tours could be served online just as

Reforms are good only when they are fully enforced

Govt has to make sure its plans don't fall apart midway through

T is good to see the government planning to merge the development and revenue budgets, amend income tax laws and establish a procurement authority in the next three years, as part of a set of reforms aimed at boosting revenue collection and ensuring transparency in expenditure. On the one hand, revenue generation in Bangladesh is one of the lowest in the world because of tax avoidance, a long list of exemptions, lower taxpayer base, and weak enforcement. On the other hand, public expenditures face leakages and are not efficient. Therefore, there is no doubt that the tax system and other revenue policies need significant reforms, and that government expenditure has to be more efficient. What we are concerned about, however, is how serious the government is when it comes to implementing such highly ambitious reforms

The government has planned the aforementioned reforms in an attempt to satisfy its development partners, and the timeline set is also a part of that. But this is not the first time we have heard the government prepare such reformation plans. For example, we have been hearing the government talk about restructuring the tax laws since 2010. But we have yet to see the government get anything done in that regard. To some extent, the same applies when it comes to reorganising the VAT laws, where the government's execution failed to match its promises.

The main objectives of its latest reform plans have to be to streamline expenditure—by reducing the huge leakages that usually occur—and increasing the government's earnings—by ensuring that tax avoidance is cut out. And to that end, although such reformation plans are welcome, what is more necessary is their proper and timely execution. It is in the latter department that the government has failed time and again. And, because of that, we cannot help but remain somewhat cautious in regards to our expectations from the government's recent

Just forming laws is not going to lead to reforms in and of themselves; the government has to execute them properly as well. And to figure out how to best implement them, we believe the government should involve experts in its planning process. To generate enough revenue for the various infrastructure projects that Bangladesh so badly needs for its development, there is no substitute to carrying out such reforms. What the government must do is ensure that these reforms are fully implemented, instead of falling midway through, as they have done previously.

Better alignment of trade and climate policies is crucial



conclusion of the high-level 26th Conference of Parties (COP26) of the United Nations Convention on Climate Change (UNFCCC), the world is set to observe another

international conference at the ministerial level. This is the 12th meeting of the trade ministers of the member countries (MC12) of the World Trade Organization (WTO) to be held in Geneva from November 30 to December 3. As opposed to the much-hyped climate meeting held in Glasgow, MC12 apparently seems to be a quiet and low-profile meeting. But in effect, MC12 is no less important for the world as trade is crucial for economic prosperity and has a multiplier impact. Of course, there is evidence of the differential impact of trade on various economies, and trade justice has been an issue of debate in the whole discussion of multilateral trade regimes. However, trade has also impacted economies positively through higher export, import, investment, job creation, and so on. Benefits of trade depend on how the rules are designed and how cross-cutting issues are considered, and how challenges related to those issues are addressed.

One such issue is the impact of climate and environmental change. The links between trade and climate change are now clear and recognised. While trade can be a source of climate change-related challenges, it can also help reduce climate and environmental challenges and achieve climate ambitions. However, with growing awareness on climate change, countries are resorting to various climate measures, which have potential negative implications for trading nations. Poor countries will particularly be affected if such climate-related trade policies are pursued, since those will result in trade protectionism. Therefore, the WTO has an important role to play in helping countries reap benefits of trade while addressing their climate and environmental challenges.

Within the WTO, environmental issues are dealt with at the Committee on Trade and Environment (CTE). The CTE aims to promote the understanding of the nexus between trade and the environment. It also discusses how trade and environmental policies together can work for sustainability. The work on trade and environment received momentum with the new initiative with the WTO, namely

"Trade and Environmental Sustainability Structured Discussions (TESSD), which was launched on November 17, 2020. Currently, 57 WTO members are part of this initiative. The objective of the TESSD is to complement the existing work of the CTE and other relevant WTO committees and bodies on climate and environmental issues. All members can join TESSD. Another objective of the TESSD is to provide technical assistance and capacity-building support to countries particularly to least developed countries.

While the objective of CTE and other environment-related WTO rules require countries to pursue their environmental objectives, a major task is also to monitor protectionism due to climate goals. However, a number of issues which are being discussed in the WTO may have negative implications for both developing and least developed countries (LDCs). Since the launch of the TESSD, discussions are taking place on issues such as liberalising trade in environmental goods and services (EGS), reforming environmentally harmful subsidies, carbon border adjustment mechanism and climate actions, and circular economy and biodiversity.

Each of these issues have implications for LDCs and developing countries. The focus of today's discussion is liberalisation of environmental goods. Liberalisation of EGS through reduction or elimination of tariffs on EGS is a part of a single undertaking of the Doha Ministerial Declaration of the WTO in 2001. This is a critical trade and climate change agenda for these countries.

However, the current discussions on liberalisation of environmental goods in the WTO has become difficult, since many countries have submitted several proposals in line with their trade interests and specialisations. Developing countries are not interested in the negotiation either, since the list is dominated by goods produced by developed countries. The share of export of environmental goods from developing countries (including LDCs) is insignificant. They are net importers of environmental goods. The top exporters and importers of environmental goods are countries with higher gross domestic product and trade. According to the "Trade and Development Report 2021" of the United Nations Conference on Trade and Development (UNCTAD), the top 10 environmental goods exporting countries in 2019 were the EU, China, the US, Japan, the Republic of Korea, the UK, Hong Kong SAR, Singapore, Canada, and Switzerland. Together, these countries

exported 88 percent of global exports of environmentally related goods.

There is also another challenge for the LDCs related to liberalisation of environmental goods. With liberalisation, imports of environmental goods are likely to be cheaper as tariffs will be eliminated from imports. Hence, developing countries may continue to remain net importers of environmental goods instead of building their own technologies. Such dependency will restrict their capacity development. There are also apprehensions that the choice for imported advanced technologies could undermine innovation of simple, local and cost-effective technologies. Being apprehensive about becoming a dumping ground for obsolete technology from advanced countries is also prevalent among developing countries.

The other concern is about preference erosion due to tariff reduction of these goods. Many environmental goods may fall under various preferential programmes offered to the LDCs. In that case, tariffs imposed on those goods will be reduced at a faster pace when liberalised. This will erode LDCs' preferences in those markets and reduce their competitiveness. It has been estimated that 99 developing countries could lose USD 15 billion in tariff revenue annually if tariffs are removed on imports of environmental goods. Bangladesh's tariff revenue loss will be about USD 187.2 million per year.

In the run-up to the MC12, discussions on liberalisation of environmental goods and other trade and climate changerelated issues have drawn attention of developing countries as their concerns are often neglected in the multilateral negotiations. These issues could very well become trade prohibitive, rather than trade enhancing, for developing countries. Therefore, while setting global rules for a clean and green trade regime, it must be accompanied by technology transfer and adequate climate finance for developing countries. Technology should be modern, efficient and cost-effective, and should come along with capacity development for the users in developing countries. A new financial mechanism in the form of Trade and Environment Fund, as proposed by some countries back in April 2011, could help the developing countries in pursuing their green and sustainable growth. Green aid for trade should be another source of finance. These are the central issues if the development dimension is to be upheld in the trade and climate negotiations.

VTO finished without TRIPS waiver

UICKLY enabling greater and more affordable production of and access to Covid-19 medical needs are urgently needed in the South. Such progress will also foster much needed goodwill for international cooperation, multilateralism and sustainable development.

The World Trade Organization (WTO) will soon decide on a conditional temporary waiver of Trade-Related Intellectual Property Rights (TRIPS). The waiver was proposed by South Africa and India on October 2, 2020. Two-thirds of the 164 WTO members—mainly developing countries—support it.

But sustained European efforts—of Switzerland, the UK and the EU, led by Germany—have blocked progress ahead of the WTO ministerial meeting starting on November 30. Meanwhile, ongoing text-based discussions seem to be leading nowhere.

IP not needed for innovation

Affordable vaccines and drugs have been crucial for eliminating infectious diseases such as tuberculosis, HIV-AIDS, polio and smallpox. But despite strong evidence to the contrary, advocates insist that intellectual property rights (IPRs) are needed to incentivise innovation.

The development of Covid-19 vaccines and other therapeutics have been accelerated by considerable government financing. Only six major vaccine developers received over USD 12 billion in public funding. Projected revenue from their IP monopolies will exceed tens of

Supply shortages have disrupted vaccine supplies. IP monopolies block competition, making it hard to quickly increase supplies. Thanks to patent protection, for example, only four companies produce plastic bioreactor bags needed to make vaccines.

Cross-border IP enforcement was enhanced by TRIPS in 1995. The African walkout from the 1999 Seattle ministerial highlighted the WTO's rich country bias. As part of the compromise to revive WTO talks, TRIPS has included a "public health exception" since 2001.

Subject to onerous conditions and paying fair compensation, "compulsory licensing" allows making patented products using processes without patent holder consent. Yet, European negotiators still insist that voluntary licensing provisions are enough.

All licensing requires case-by-case, patent-holder-by-patent-holder, countryby-country negotiations. But licensing is only limited to patents, without requiring sharing "industrial secrets" needed to make complex biochemical compounds.

Time-consuming, onerous and costly, such negotiations are beyond the means of poorest countries. Worse, some highincome country (HIC) governments have blocked such licensing, even when agreed to by companies.

IP deepens inequalities

The World Health Organization (WHO) director-general noted that four-fifths of vaccine doses went to HICs or upper middle-income countries (MICs). Rich countries—with a seventh of the world's population—had bought over half of the first 7.5 billion vaccine doses by November 2020.

Meanwhile, only 1.5 percent in lowincome countries (LICs) were vaccinated

most MICs are excluded. Worse, some high-income country (HIC) governments have blocked such licensing, even when agreed to by companies.

Some HICs have been embarrassed into sharing millions of their unused excess vaccine doses. But of the 1.8 billion doses promised so far, only 14 percent has gone to the LICs. Such donations of funds and other needs undoubtedly help.

But such unpredictable acts of charity e.g. by HICs who bought far more than they needed—are hardly enough. Manufacturing capacity in the developing world must still be enhanced to meet overall needs. This requires the waiver.

Contrary to the claim that the South lacks manufacturing capacity, vaccines have long been made in over 80 developing countries. Although novel, mRNA vaccine manufacture involves fewer steps, ingredients, and physical capacity than traditional vaccines. MSF has

three years from the decision date, subject to annual review. It would cover products and technologies—including vaccines, therapeutics, diagnostics, devices, protective equipment, materials, components, and methods and means of manufacture.

The proposal also covers the application, implementation and enforcement of TRIPS provisions on patents, copyrights, designs and other protected information—e.g. undisclosed manufacturing blueprints and industrial

Thus, the waiver has long been urgently needed to contain the pandemic worldwide. But rich countries have successfully blocked progress thus far despite the heavy human and economic toll it has taken

Game changer

Unlike the more flexible arrangements of the General Agreement on Tariffs and Trade, the WTO framework and negotiating priorities have undermined developmental aspirations.

The South has been undermined by rich countries' betrayal of the 2001 Doha compromise. After "softly" killing the "Development Round" promised then, rich countries can now redeem themselves by supporting the waiver.

Almost two years after Covid-19 was first recognised, the pandemic continues to threaten the world, with poor countries and people now worse affected. The devastation could be partly mitigated if developing countries could meet their pandemic needs without fear of litigation for IP infringement.

A TRIPS Council meeting is scheduled for November 16, before the four-day WTO Ministerial Council meeting from November 30. The waiver would also encourage renewed international cooperation, long undermined by destructive rivalry and competition.

By refusing to make concessions, rich countries would not only jeopardise the WTO, but also the world's ability to urgently contain the pandemic. With complementary financial resource transfers, they can restore the goodwill urgently needed for international cooperation and to revive multilateralism.

Australian academic Deborah Gleeson warns that even as promising new treatments become available, they will be too costly for most in LICs and many MICs. Diagnostic tests are unequally distributed, with HICs averaging over a hundred times more than LICs.

And even when governments and companies are willing to license others to supply small LICs with low-cost generics,

for patents. These have often been "evergreened"—i.e. extended, sometimes indefinitely, ostensibly to reward additional innovation. Thus, most developing countries have been prevented from meeting their health needs more affordably.

The temporary waiver would allow companies everywhere to produce the required items and use patented technologies without infringing IP. Supplies would increase and prices fall. Currently, access to Covid-19 needs is very inequitable, deepening the yawning gap between HICs and LICs.

The revised May 21 text clarifies that the proposed waiver is for at least Sydney University and the University of New South Wales, Australia.

It's time to talk about sustainability and finance in RMG sector



industry people appear to be the best at is explaining, often in great detail, the problems and challenges that we face. The existing purchase

practices are unfair and harming suppliers and their workers, we are told. Yes, we know that already. Fast fashion is harming the environment and leading to a surplus of poorquality clothes, they say. We are aware of that, too. There is a "funding gap" in terms of supply chain upgrades and

> investment in sustainable garment production, we are informed. People have been telling us of all these for well over a decade. Garment workers are underpaid. Again, that's fairly obvious.

> The latest report outlining our woes, but not really offering any meaningful and practical solutions, came out in the wake of the recently held UN Climate Change Conference (COP26). The report, the authors of which I will not

name here, suggests that decarbonising global fashion supply chains to achieve a net zero fashion industry by 2050 will cost more than USD 1 trillion.

The report says 61 percent of the fund will be required to implement the "existing solutions," and the rest will be required to further develop, scale and implement new innovations. It says that investments should be focused on using renewable electricity and reducing coal dependence in supply chains, as well as using sustainable materials in fashion and finding options for extended use/recycling.

Most notably, as far as RMG suppliers are concerned, the report tells us that the current levels of financing are insufficient to succeed in decarbonising the industry before 2050. It is argued that the industry—that's us, the suppliers—is unlikely to achieve necessary transformation without a significant change in financing flows.

The report tells us that the USD 1 trillion fund that our industry needs to raise will come via financiers (debt and equity), manufacturers, brands, philanthropy, and governments.

USD 1 trillion is a nice round number, at least. With so many variables involved, so many different actors in play, the figure could easily have been double, and few would be in a position to question it. This figure seems quite arbitrary, but it will undoubtedly grab headlines.

A few thoughts pop up in my mind when reading reports like this, a great many of which have come out over the years. The first is that they are simply framing and rehashing a problem that the industry leaders all recognise—be it suppliers, buyers or other fashion industry stakeholders. The second thought is that these reports sell investment in sustainable supply chains as an "opportunity" quite often. In this case, the authors state that

while an investment in excess of USD 1 trillion over the next 30 years is a huge amount, the majority of it is for projects that offer an attractive financial return on investment.

Really? For whom? In Bangladesh and other garment sourcing hubs, we have seen factories spending money on water- and energy-saving initiatives over the years and, yes, these do have a return, but a small one. It is also a simple fact that many factory owners struggle to even make small, incremental investments such as this.

In any case, to my knowledge, the investment required in Bangladesh as well as in supply chains globally is much greater. And I haven't seen investors queuing up to support RMG suppliers in Bangladesh to "green" their operations these past few years. Ask any garment manufacturer here about the challenges of getting access to finance

for green investment. Yes, the money might be there, but accessing such finance is an onerous task. Moreover, things have become much, much harder since the pandemic broke out many suppliers are still paying debts incurred after the huge downturn in business in 2020.

In terms of external investment, there have been various pilot initiatives over the years which typically involve a tripartite structure of factory, buyer and a third-party environmental nonprofit entity, which can leverage public money for "green" projects over a certain period of time. Such initiatives are supposed to encourage and foster green investment, but I hear that such initiatives nearly always fall by the wayside as soon as the public money dries up. No one—certainly not the buyer or factory owner—has any desire to cover the funding of such work

We know there is a lack of capital to meet the needs of industrial upgrading required to future-proof our industry and make it more sustainable. With this in mind, it is time to move beyond framing the problem and onto actually developing clear, practical plans about how it will be tackled. We can't afford to have continued talking shops, which produce plenty of soundbites and nice corporate speak but do not move us any closer to where we want to be. The danger is that these same conversations will happen again in another five years' time, or even 10 years' time. It will be too late then if this status quo stays.

Coming back to the issue of poor purchase practices, I must say they are the root of all problems in our industry. We have all known this for years, and don't need another report to tell us so. Some mythical, outside investor is not going to come and save us all—of that we can be certain. This is a problem which, by and large, needs to be solved from within. The only real question is this: Who pays for it? Who pays to upgrade the supply chains? Is it the suppliers or the buyers, or both? And where and how do the government and other third parties come in?

These are the only questions I see as relevant moving forward. If we are going to have more talking shops, let's at least allow them to be about this issue where we can all have a frank, honest and transparent debate about how we are going to move our industry to where it needs to be.

We know the problems our industry faces. It's now time to talk in great detail about the solutions and set out clear, actionable goals about how those solutions can be achieved.

and in-laws forced her to leave her job after the birth of her first child. Though she had no intention of sacrificing her career, her position was not strong enough to oppose this pressure.

Given that Bangladesh has a patriarchal society, which places a low premium on women's paid work, the man in the family is still considered the principal breadwinner. in the workforce has increased over time, family recognition of their monetary contribution is still a long way off. Samia was forced to give up her identity as a working mother to conform to the patriarchal cultural legitimacy by becoming a conventional housewife. Furthermore, the cultural construction of "proper womanhood" in the eyes of society often limits women's power to oppose man-made

rules and regulations. Samia, soon after her marriage, realised how a woman's identity crisis problematised her survival in Bangladesh. The so-called cultural legitimacy distinguishes men's and women's identities in such a way that women are almost entirely reliant on men throughout their lives. Her father is her guardian before her marriage, her husband takes custody after marriage, and at her old age, her eldest son becomes her guardian.

can depend on their self-identity to function as independent human beings. Their struggle for survival intersects with their having or not having male guardians, resulting in a form of servitude.

Samia's second course of action was to find a job. She attended many interviews. Most of the interview board, led by men, were more interested in her personal life-e.g.,

would marry again, who was her guardian now, etc. Moreover, her age was also a topic of discussion during the job interviews.

Then came the social stigma. Samia tried to revive old friendships and restore regular communication with her relatives. But soon after her divorce, she realised many of her friends and relatives, including her own family members, had started to avoid her. She was also subjected to many suggestions from her relatives and acquaintances, who said she should "improve" her "acceptability" in society by practising a religious code of conduct. Samia found it difficult to reconcile that these were the same people who had shared many pleasant moments with her, before her divorce. After her divorce, their attitude towards her changed completely.

Samia lost her identity as a woman, a citizen of Bangladesh, and a human being in the eyes of society after getting a divorce. In her life, she donned multiple identities—a daughter, a wife, and a mother, to name a few. Men shape women's identities, and women are burdened with a plethora of those identities, some of which may be imaginary. In Samia's case, the landlords saw her only as a divorcee, her friends and relatives saw her as a woman with questionable reputation, and employers saw her as a destitute

woman in need of a job.

But what about her former husband? He got married six months after their divorce. He is now living a new life with his new wife, and continuing his job smoothly. He did not face an identity crisis to marry, rent a home, continue his career, and communicate with his family members and acquaintances. While Samia struggles in every aspect of her life today, her former husband appears to be content with his current situation. This is the case because society sets different boundaries for divorced men and

women in the country, resulting in gender discrimination.

The term "Equality before the law" in Article 27 of our constitution protects all citizens of the state, reflecting Articles 6 and 7 of the Universal Declaration of Human Rights (UDHR) and Article 16 of the International Covenant on Civil and Political Rights (ICCPR). Specifically, our constitution states against any person solely on the basis of religion, race, caste, sex, or place of birth." The term "sex" is used interchangeably with "gender"

here. The Bangladesh government's undertaking of this policy has advocated a statutory entitlement of equality between men and women. But the ubiquity of patriarchal cultural legitimacy overshadows a woman's legal rights in society. It is because the policy rhetoric per se does not necessarily guarantee policy effectiveness. As a result, the practice of woman-friendly norms and culture must be envisioned for future Bangladesh.

Batting first, openers Pinak Ghosh and Jasimuddin provided a healthy start and Mahmudul joined at one-down to strike 83 off 116, laced with nine fours. However, Sharfuddoula Ibne Shahid had other plans as he snared four wickets for 62 runs while Shahbaz Chouhan bagged three for 35 to restrict Chittagong to 223 runs. Dhaka Metro will resume at 52 for two on Day 2.

'I deserved more chances'

Not only is he the only cricketer to score over 11,000 first-class runs in Bangladesh, he was just 28 shy of 12,000 when veteran Tushar Imran announced his retirement from all forms of cricket during the National Cricket League in BKSP yesterday. Tushar, who also has the most first-class centuries in Bangladesh, spoke to The Daily Star's Mazhar Uddin during an interview where he shared his experience over the last two decades, his regrets and the areas that Bangladesh cricket can work on to improve as a whole.

The excerpts are below:

describe your two-decade long journey in first-class cricket?

Tushar Imran (TI): The end was not as I expected. I wanted to retire after scoring more runs but it hasn't been a good season for me. I wanted to play for a few more seasons but since I wasn't able to play well, it was not suiting my character. So I decided to call it a day to provide opportunities to youngsters. Overall, it's been a great journey that I will cherish for the rest of my life.

DS: After scoring consistently in the past four-five seasons, do you feel you deserved a call-up to the national team at any point?

TI: To be honest, yes. I was hoping to get a call to the Bangladesh team during the 2017-18 season and since then I can say that my motivation first-class cricket in Bangladesh, was to make a comeback to the what are the areas you think have playing the game. Let's see.

The Daily Star (DS): How was you national team. My dedication to score runs and hunger has helped me become better. I should also credit to my Khulna teammates because I tried to compete with them all the time.

> DS: Do you regret not having as long an international career as your firstclass career? What are the reasons behind that?

TI: Yes, I do regret that but the fact is that when I made my Test debut I was very young and hardly understood Test cricket. I played against top opponents and it is obvious a player will fail initially in his career. I am not as talented as Mohammad Ashraful, but I think deserved more chances after that.

DS: From your vast knowledge of

been the biggest obstacles to improving the standard of cricket over the years?

TI: I think it's important for national players to play first-class cricket regularly. It will encourage youngsters and others to set a benchmark and competing with the best will help improve the standard of cricket. I think we don't have enough sporting tracks all across the country, which is also why we fail abroad most of the time. We need good pitches that encourage both bowlers and batters.

DS: What are your plans after retirement?

TI: I want to be attached with cricket and I will probably take up coaching. It is very difficult to stay away from cricket even if you stop

Parvez the latest entrant to opener merrygo-round

It will be no easy task for the Tigers given the manner in which they lost the first two games at the same venue. Bangladesh will need to dig deep if they are to restore some pride in the final match after a barren run in the game's shortest format.

Unfortunately, it seems that the crisis with the Bangladesh team deepened after the two defeats to Pakistan. The thinktank, under the leadership of former national skipper Khaled Mahmud, drafted in some new faces to give them exposure after the T20 World Cup debacle, but after just two games they seem to have lost the plot.

In an interview with The Daily Star, Mahmud said: "You can think of it as an investment series for us." That gave rise to questions about whether they had chosen a good investment, to which he stated: "I feel the need for patience is vital for us at every level."

The last moment inclusion of young opener Parvez Hossain Emon in place of Saif Hasan for the third and final T20I hardly matches that line of thinking. Instead, it portrayed a lack of clarity within the Tigers think-tank and selection process.

Regardless of whether it is Parvez or another combination of openers today, it will be the Tigers' tenth different opening pair in 27 games this year in T20Is, reflecting a lack of consistency and patience towards players in the



The inclusion of Saif as a T20 opener had surprised many and the manner in which the right-hander struggled to deal with quality bowlers and got exposed did not exactly come as a big surprise for many. But the exclusion of the batsman after two games shows how abruptly things have been going for the players.

"Saif failed to perform in two games, which is why we ncluded Parvez for the third game. Saif will join the Tes team in Chattogram. It's an opportunity for Parvez to showcase his talents. He has been in the set-up for some time now," chief selector Minhajul Abedin told The Daily Star. Will this game of inclusion and exclusion ultimately help these two young players?

Unfortunately, history suggests this kind of quick-fix selection policy only deters players' confidence. Players should take the responsibility for not delivering on the field, but it must be pondered whether this kind of practice actually hinders the development of a player.

The confusion over a stable opening pair started even before experienced Tamim Iqbal opted out if the ICC T20 World Cup, with the Tigers trying four different opening pairs ahead of the mega-event.

Despite being the only consistent scorer in the opening slots prior to the World Cup,

Naim was surprisingly dropped from the opening firstround game at the T20 World Cup, with Soumya Sarkar opening the innings with Liton Das as Bangladesh crashed to a shock six-run defeat against Scotland.

The team management then decided to tinker with the opening pair, returning Naim to his position alongside Liton. Following a dismal show in the mega-event, selectors then opted for a major overhaul for the three-match Pakistan series. Both Liton and Soumya lost their places for the Pakistan series but the experiment of including Saif did not work out, eventually forcing the selectors to make another change in the form of Parvez.

It may not be harsh to say that an unsettled team management cannot create a settled team at all.



Sri Lanka skipper Dimuth Karunaratne slammed an unbeaten hundred to give his team the upper hand in Sunday's opening Test against the West Indies. Bad light forced an early end to the day's play in Galle with two overs remaining and the hosts finishing on 267-3. This was Karunaratne's 13th Test century and fourth this year. He has bagged more than 750 runs in 2021, including a career-best 244 against Bangladesh, despite only playing 10 innings.

Gunnar Solskjaer was appointed as caretaker boss in December 2018 with a to restore the club to former glories by tapping into its DNA.

United rediscovered their spark in a honeymoon period under the Norwegian, summed up in a breathless Champions League comeback against Paris Saint-Germain -- a result that helped persuade club bosses to hand him a permanent deal.

Despite persistent concerns over his lack of experience and technical nous, Solskjaer has come agonisingly close to delivering the club's first silverware since 2017, losing on penalties in last season's Europa League final and finishing second in the Premier League.

Club bosses were confident enough in the direction of travel to hand him a new three-year contract in July.

United Former goalkeeper Peter Schmeichel said in his recent autobiography that his former team-mate had brought the "heart and soul back" to the club after the divisive Mourinho reign but in the end that did not prove enough.

Solskjaer, 48, said after his side's chastening 4-1 defeat to lowly Watford on Saturday that he felt for the fans and understood their pain after they vented their fury at Vicarage Road.

"We've had a hard time since Sir Alex (Ferguson) left the club and fans who have been with us the last few years since I came in, they've been unbelievable, they've understood the situation," he said.

"The signings this summer with Rafa (Raphael Varane), Jadon (Sancho) and Cristiano (Ronaldo) of course raised everyone's expectations, rightly so, because we brought some top players."

The question is, who do United turn to now to take the club forward?

A club statement on Sunday stated the intention to hire an interim manager till the end of the season with former midfielder Michael Carrick in the hotseat for the forthcoming games.

By delaying Solskaer's departure, one prominent candidate is now off the market as Tottenham snatched up a former Premier League winner in Antonio Conte.

United have been consistently linked with Paris Saint-Germain boss Mauricio Pochettino and the Argentine may well be the motivation for waiting till the summer.

Former Real Madrid boss Zinedine Zidane, Leicester manager Brendan Rodgers and Ajax coach Erik ten Hag have also been linked with the role.



United, for so long a byword for stability under Ferguson, have been reluctant to sack their managers until they feel their hand is forced.

That tipping point has now been reached, with the club seventh in the Premier League, already six points off the top four and out of the title race after just 12 games.

Whoever does take over at Old Trafford will have a richly talented but bloated and unbalanced squad to work with.

Any new manager will also have to work under the American owners, the Glazer family, who remain intensely unpopular among a large section of the club's fanbase.

One thing is for certain -- whoever is next in through the door will face enormous expectations that will not be satisfied until United are top dogs again.

37 Bangladeshi migrants rescued in Mexico

Thirty-seven Bangladeshis were among 600 migrants rescued in Mexico after they were crammed into two tractor-trailers, AFP reported quoting Mexico's National

The institute yesterday said that of the rescued individuals, 145 were women and 455 men.

They were found in the southeastern state of Veracruz, the institute said in a statement.

Reuters reported that 401 of the rescued people were from Guatemala, 53 from Honduras, 40 from the Dominican Republic, 37 from Bangladesh, 27 from Nicaragua, 18 from El Salvador and eight from Cuba.

There were also six men from Ghana, four people from Venezuela, four men from Ecuador, one man from India and one man from Cameroon. The migrants were traveling "crammed" into the trailers

of two trucks, Tonatiuh Hernandez, the local head of the Human Rights Commission, told AFP.

"There are children, minors, I saw pregnant women, sick people," said Hernandez, adding that he had never seen so many migrants traveling together in such conditions.

AFP reported that a video obtained by it showed several hundred migrants, looking sullen and tired, crowded in a courtyard of the National Migration Institute as police in riot gear stood guard nearby.

After their names were read out by officials, migrants boarded a bus to be transported for further processing.

Child protections services have also been notified regarding families with children or minors traveling alone, according to Hernandez.

As the corridor between central America and the United States, Mexico has seen vast numbers of migrants flow through its territory, AFP reports.

ACC can do little with clipped wings

Says its commissioner Jahurul

Because of legal bindings, the Anti-Corruption Commission could not play an effective role in preventing money laundering, ACC Commissioner Jahurul Haque said yesterday.

Saying that some people are involved in massive money laundering, he said, "Not thousands, crores of taka are being laundered. But what can we do? We've nothing to do.

"The government has taken away the jurisdiction of money laundering from us by formulating an act," said Jahurul, adding that the commission can now only probe laundering offences related to corruption and bribery.

"We cannot go beyond our jurisdiction. We don't want to take that blame."

Jahurul was addressing a viewexchange meeting at ACC's Segunbagicha Headquarters organised to observe the anti-graft body's 17th founding anniversary.

Kissinger still hoped that war could be averted, despite the "naked case of Indian aggression", but the threshold had been crossed. As an overall strategy, Kissinger endorsed the idea of coordinated action with China in the UN Security Council. Kissinger suggested, "We ought to talk to the Chinese to find out what they'll do at the Security Council...We don't have to go as far as the Chinese, but I would lean..." Nixon interrupted, "I want to go damn near as far. Now, understand, I don't like the Indians." Nixon repeated his theme, "Let's remember the Pakistanis have been our friends...and the damn Indians have not been." Kissinger hoped to coordinate with the Chinese and other powers in order to diplomatically isolate India and its Soviet Bloc supporters. YAHYA VISITS BORDER AREA

Fifth Covid wave hitting at 'lightning' speed

Says France as infections rising at an alarming rate

Fifth-wave coronavirus infections in France are rising at an alarming rate, the government reported yesterday, with new daily Covid cases close to doubling over the past week.

The seven-day average of new cases reached 17,153 on Saturday, up from 9,458 a week earlier, according to the health authorities, an increase of 81 percent. "The fifth wave is starting at lightning speed," government spokesman Gabrial Attal told media.

Europe is battling a fresh wave of infections and several countries including the Netherlands, Austria have

Tens of thousands took to the streets in cities across Europe and Australia Saturday as anger mounted over fresh Covid restrictions imposed against the resurgent pandemic.

Dutch police said yesterday they have arrested 19 people over riots in The Hague after the country was rocked by a second night of violence over the government's coronavirus

Around 10,000 marched in Sydney and there were also protests in other major cities against vaccine mandates applied to certain occupations by state authorities.

In France, the latest seven-day increase is three times the average rise of cases recorded over the previous three weeks, indicating an exponential acceleration of infections. For now the spike in infections has not led to a massive
