'We agree, but...'

Transport owners want incentives to take half-bus fares from students

A meeting on the half-bus fare issue raised by students ended inconclusively yesterday, after private transport owners sought incentives from the government for meeting the demands.

Although the top leadership of the transport owners' association was absent at the meeting, their representatives stated their condition.

In this situation, transport owners were asked to present their formal proposal as soon as possible, said Nazrul Islam, secretary of Road Transport and Highway Division, after the meeting.

However, the government is considering concessions for students boarding BRTC buses, and Road Transport and Bridges Minister Obaidul Quader is likely to give an announcement in this regard today, he said. Following the rise of bus fares

on November 7, students have been demanding half fares for bus rides. Students and transport workers frequently got into heated debates over the issue.

On Tuesday, they issued a 48-hour ultimatum to the government to meet their demands for half fares and security while using public transport.

Against the backdrop, the meeting was held at the headquarters of Bangladesh Road Transport Authority (BRTA), with Nazrul Islam in the chair. Representatives from education and home ministries and police were also present.

Nazrul said the government has taken the students' demand cordially. "We want

"Nayeem wanted to ensure justice for all by becoming a judge," said a weeping Shah Alam, father of the Notre Dame College student who died under a DSCC compactor vehicle on

But how unjust is it that all his dreams were shattered by one wrong person behind the steering wheel?" he told The Daily Star over phone yesterday.

He said Nayeem had received a talent pool scholarship after his Primary Completion Exam, and had great results in Junior School Certificate and Secondary School Certificate exams as well.

"My son wanted to be a judge. He wanted to get into Dhaka University's law department. His dream was to ensure fair judgement, that no one would get back from his court without justice," said a grief-stricken Alam.

"After watching him do great in all of his exams, we were onboard too. We were waiting to see him go out there

Urge 27 eminent citizens

Twenty-seven distinguished citizens have demanded that the government fully implement the Chattogram Hill Tracts (CHT) Peace Accord, 1997 through upholding the CHT Regulation, 1900 to protect the rights, heritage and culture of its indigenous people.

Law ministry appoints 91 judges, promotes 65, transfers 388

The law ministry yesterday brought change to the lower judiciary by appointing 97 new judges, promoting 65 joint district judges and transferring 388 others across the

The ministry issued separate gazette notifications to this effect, stating that the appointments, promotions and transfers have been made in consultation with the Supreme Court.

The new 97 judges have been appointed as assistant judges and judicial magistrates on recommendation from the Bangladesh Judicial Service Commission, as they qualified in the relevant tests and exams, according to a notification.

Another notification said 65 senior assistant judges have been promoted to the post of joint district judge.

Besides, 48 joint district judges have been transferred; seven joint district judges, joint metropolitan judges and additional chief judicial magistrates have been attached to the law ministry; and 333 senior assistant judges and senior judicial magistrates have been transferred from their present workplaces, according to other
