### Woman, child found dead in Gazipur

Police on Wednesday night recovered bodies of a woman and child from Deshipara area of Gazipur Sadar upazila. The deceased could not be identified immediately.

Inspector Syed Rafiul Karim of Sadar Police Station said locals informed them after seeing the bodies in the

The bodies -- a woman around 27/28 years old and a child around 3/4 years old -- bore injury marks on their necks, he added.

The bodies were sent to a hospital for autopsy.

A policeman, who was njured in an attack by ishermen while enforcing a ban on hilsa fishing in October, died at a city nospital on Wednesday

Kabir Hossain (42), a constable of River Police, died at the National Institute of Neurosciences & Hospital. He was receiving treatment there for over a month, a press release issued by Police Headquarters said yesterday.

Kabir along with four other policemen was injured when local fishermen reportedly attacked them at Char Abdullahpur in Munshigani on October 21, when a ban on hilsa fishing was going on.

Hailing from Patuakhali, Kabir left behind his wife, a son and a daughter to mourn his death.

# Petition seeks Tk 10cr compensation for Sadia's death

A writ petition has been filed with the High Court, seeking its directive on the authorities concerned, to give Tk 10 crore as compensation to the family of university student, Sehrin Mahbub Sadia, who died after falling into an open roadside drain in Chattogram city in September.

Rights organisations Ain O Salish Kendra (ASK), Children's

Charity Bangladesh (CCB) Foundation and Sadia's maternal uncle Zahid Uddin Belal submitted the petition through their lawyer Aneek R Haque to the HC yesterday.

The petitioners requested the HC to direct the city corporation authorities to ensure sufficient safety measures at all their construction sites across the country to prevent. They also mentioned Sadia died due to the negligence

of Chattogram City Corporation. Lawyer Aneek R Haque told The Daily Star that the HC may hold hearing on the petition next Sunday.

Deceased Sadia (19) was a first-year honours student of computer sciences at International Islamic University Chittagong. She died after falling into a roadside drain in the port city's Agrabad Badamtoli area on September 27 this year.

Divers of Fire Service and Civil Defence recovered her body around five hours after she fell, some 100 feet away from the spot.

against eight leaders and activists of BNP, including its senior joint secretary general Ruhul Kabir Rizvi, in a case filed under the Special Powers Act.

After accepting charges against 33 accused, Judge KM Emrul Kayesh of the Metropolitan Sessions Judge's Court passed the order and directed the OC of Badda Police Station to submit a report by February 22. Former Dhaka City Corporation councillor MA Quyum is among the fugitives. BNP leader Shamsur Rahman Shimul Biswas and 24 others are now on bail in the case.

According to prosecution, Rizvi-led BNP leaders and activists brought out a procession on January 26, 2015 in support of hartal in Badda. They threw brickbats, crude bombs on police that left several injured.

been possible to establish women's human rights yet. "Despite various women's movements, human rights movements and various public-private initiatives to prevent violence against women, the incidents continue to rise at an

alarming rate, further fuelled by the pandemic," she added. BMP president Fauzia Moslem said in order to stop violence against women, the socio-cultural norms need to be challenged.

"We have to end the culture of impunity, build a sensitive judiciary for women, and reform the existing laws. Although the rape law has been amended, it is not widely publicised, and its application is limited," she said.
