Govt committed to free, fair polls

Momen tells diplomats

Foreign Minister AK Abdul Momen told the foreign diplomats stationed in Dhaka yesterday that the government is committed to free, fair and transparent elections in the country.

Referring to the recently held Union Parishad elections, he said the polls were inclusive, people had high enthusiasm and the government did not interfere.

"These [polls] are free, fair and transparent. The major opposition did not contest officially, but unofficially, they have many candidates running and some got elected too."

Diplomats from different countries, including the US and European countries, and representatives from the UN and World Bank were present at the regular briefing at the state guesthouse Padma yesterday morning.

At a press meet in the afternoon, Momen said the meeting with the diplomats mainly featured Bangladesh's participation in the COP26, the prime minister's visit to France, Rohingya issue, elections and the treatment of BNP Chief Khaleda

He said the only "bad thing" about the UP polls is that there were some fatalities, which happened "out of enthusiasm".

We don't want a single fatality in any election but we don't know how to stop it," he said, urging all political leaders not to incite people.

"They [leaders] incite their people in such a way that they resort to violence. They should stop violence and their repatriation.

Speaking to a private TV channel on Bangladesh's exclusion from Biden's Summit for Democracy, Momen vesterday said the invitation depends on the wish of the US.

"They did not invite all countries. This time, they did not invite us, but normally, they do.'

The minister said Bangladesh's relationship with the US is very good, adding, "All countries have some weaknesses regarding elections, and the UP polls are currently taking place in Bangladesh."

US Ambassador Earl Miller told the TV channel that they would be discussing the polls issue with the Bangladesh government in future.

Momen briefed the diplomats on Bangladesh Prime Minister Sheikh Hasina's successful presentation on the country's causes and on climate vulnerable countries, calling for compensating them under Loss and Damage.

Hasina also called for the developed countries to fund the promised \$100b to the developing countries every year for adaptation and mitigation.

Momen said he was happy that the UN agreed to be involved in the humanitarian activities in Bhashan Char, where some 19,000 Rohingyas have been relocated as part of the plan to relocate 100,000 from Cox's Bazar.

He also thanked all the diplomats for supporting the recent UN resolution on Rohigyas that speaks of addressing the root causes of the crisis

Islam said his brother went to meet a friend in West Rampura and was coming home when he was run over.

Mainuddin was killed when students have been demonstrating for safer roads since Notre Dame College student Nayeem Hasan was killed after a Dhaka South City Corporation bus driven by a cleaner rammed and killed him on November 24.

shut down without any delay and it is the final decision. The environment minister also agreed He said the environment ministry

would now write to the industries ministry and the Bangladesh Small and Cottage Industries Corporation (BSCIC), asking them to shut down the estate. Talking to this correspondent,

Environment Minister Shahab Uddin said he agreed to the recommendations of the parliamentary committee.

The ministry will send a letter to the industries ministry and the BSCIC in line with the decision [taken yesterday]," said Shahab, also a member of the JS body.

Contacted, Jakia Sultana, secretary, industries ministry, said they would take necessary measures after receiving the letter from the environment ministry.

On August 23, the parliamentary body recommended shutting down the estate due to widespread pollution of the local environment.

According to statistics placed before the standing committee, the estate has the capacity to treat around 25,000

cubic metres of liquid waste every day, but the tanners generate around 40,000 cubic metres of liquid waste per day.

That means 15,000 cubic metres of liquid waste are dumped into the Dhaleshwari without any treatment, causing severe pollution.

In 2003, the government took the initiative to build the BSCIC Tannery Industrial Estate on 200 acres in Hemayetpur after moving all tanneries from the capital's Hazaribagh in order to prevent environmental pollution and to protect the Buriganga. Saber Hossain yesterday said the

most alarming matter is that the estate does not have any facility to treat solid waste, including heavy metals and The waste is being dumped into the

the environment, he said. In the last three years, the estate

has dumped around 1.60 lakh cubic metres of waste into the river, Saber Hossain said, quoting statistics from the Department of Environment (DoE).

There are around 160 tanneries in the leather industrial park, sources at Tanneries and backward and forward

linkage industries related to leather goods were accommodated in the new industrial park after it was moved from Hazaribagh in 2003.

On September 9, the DoE served a show-cause notice on BSCIC. It asked BSCIC to respond by September 20 as to why the site should not be shut down as per the parliamentary standing committee's recommendation. About the notice, Saber Hossain said

the industries ministry has formed a task force in this regard. "Let the task force work on the compliance issue," he said, adding that the tannery industry would have to shut down until it becomes compliant.

Following recommendation from Dhaleshwari without any treatment, the standing committee, the meeting causing pollution and severe harm to yesterday also decided to declare tourist destination St Martin's Island a "no smoking zone".

Besides, the parliamentary body asked the ministry to ensure food for elephants where they are living now in Ukhiya and other parts of Cox's Bazar so that they don't have to come to localities in search of food.

On Sunday, Khaleda's physicians at a press conference said the probability of bleeding again in the next week was 50 percent while the probability of that happening in next six weeks was

"This [bleeding] will happen for sure. We are afraid if Madam bleeds again, we don't have the supportive technology to control or stop it. In that case, the risk of her death will increase a lot," Professor Fakhruddin Mohammad Siddiqui, a member of the medical board treating Khaleda, told journalists.

The 76-year-old former prime minister has been diagnosed with liver cirrhosis. According to the medical board, the BNP chief should be taken abroad immediately to an advanced

centre for treatment. Khaleda has long been suffering from arthritis, diabetes, dental and eye problems. She was admitted to the hospital on November 13, nearly a week after being discharged from the same healthcare facility.

She was moved to the CCU on

The BNP chief landed in jail on February 8, 2018 in a corruption case. Amid the pandemic, she was released temporarily on certain conditions on March 25 last year. The term of her release has been extended four times so far.

Meanwhile, Foreign Minister AK Abdul Momen yesterday said Khaleda is allowed to bring in any doctor from abroad and she is free to take treatment anywhere in the country.

"If Khaleda Zia wants to go abroad for treatment, she has to do it following the legal process," he told journalists at the state guesthouse Padma in the capital after briefing foreign diplomats.

Momen said the medical documents have already been sent abroad and foreign doctors can visit Bangladesh for treating her.

Asked who sent those documents, he said, "I heard about it from the law ministry. Probably, it has been sent from the family of Khaleda Zia.

Enquired if the government sent it, the minister said, "No, why would the government send it? I don't think they [family] would even share those documents with the government."

Khaleda's doctors at Sunday's briefing told journalists that there was no scope for treating the BNP chief at home, rather she needs to be treated in either of the three countries -- the USA, the UK and Germany.

As she suffered bleeding three times, she needs treatment with intrahepatic (transjugular portosystemic shunt) which is available only in some specific advanced centres in those three countries, they added.

The dead was identified as Rubel Mondol, 37, a nayek of the BGB 56 Battalion.

Supporters of a chairman candidate, who lost the election, resorted to violence at Poschim Doliram Majhapara Government Primary School polling centre around 9:00pm after the announcement of the polls results, said Lalit Chandra Roy, presiding officer at

AL on November 19 expelled him from the party for breaching the organisation's discipline.

The local government and rural

development ministry also suspended him from the mayor post on November 25 following several allegations that include illegal land grabbing, not compensating people after taking over land for development and working against the public interest.

Yesterday, Judge Mohammad Ash Sams Joglul Hossain took cognisance of the DSA case and recorded the complainant's statements.

The judge also directed the Criminal Investigation Department to submit a report before the tribunal by January 6 next year after investigation. An audio of the accused went viral

on social media in September this year where he made derogatory, hateful and false comments on Bangabandhu and the Liberation War martyrs, which hurt the country's people, the case statement says.

Section 21 of the DSA deals with punishment for making any kind of propaganda or campaign against the Liberation War, cognition of the Liberation War, the father of the nation, national anthem or national flag.

"If any person, by means of digital medium, makes or instigates any propaganda or campaign against the Liberation War, cognition of the Liberation War, father of the nation, national anthem or national flag, the person's act shall be considered an offence," section 21 of the law reads.

If any person commits an offence under the sub-section, he/she shall be punished with imprisonment for a term not exceeding 10 years, or with a fine not exceeding Tk one crore or both.
