## 3 held for pushing teacher off moving bus

Rapid Action Battalion (Rab-7) yesterday detained three transport workers over pushing a primaryschool teacher off a moving bus and running the vehicle over him, leaving him critically injured, in port city's Station Road area last Saturday.

The arrestees were identified as Mohammad Hossen (25), Mohammad Liton (35) and a 13-yearold helper.

Liton is the driver and Hossen the conductor of a bus of Showrav Paribahan in the city.

Addressing a press briefing at Chandgaon camp yesterday, Rab-7 Commanding Officer Lt Col MA Yusuf said Hossen had locked into an altercation with the teacher, Rahmat Ullah, over fare. At one point, they harassed and manhandled Rahmat.

"Later, they pushed him off the running bus and ran the vehicle over him, leaving him critically injured," the official said.

Rahmat, who teaches at Habibullah Govt Primary School at Panchlaish, was undergoing treatment at a private hospital.

#### Preservation of Pahartali Baddhyabhumi

# SC verdict yet to be effective after 7yrs

Right in the heart of the port city stands Pahartali Baddhyabhumi, the largest mass killing ground in Chattogram -- on 1.75 acres of land.

To preserve this site of immense historical value, the Supreme Court's Appellate Division passed an order seven and a half years ago. However, no effective initiative has been taken regarding this.

In March 2014, the SC ordered to acquire and preserve the Baddhyabhumi after hearing a petition of eight prominent citizens of the country, according to Manzill Murshid, their lawyer.

One of the petitioners, Prof Muntassir Mamoon, said, "We have grown old trying to realise our demand. We are no business mafia, and we have no muscle power. Even section officers don't pay heed to us."

"I don't think they care about the Supreme Court's judgment. They are employees of the republic, but now it seems like they run the country. Even if the verdicts of most of the petitions people's favour, they will not be

effective if there is no monitoring cell in the High Court," he added. Rashed Hasan, a cultural activist in Chattogram, said, "Late Dr Gazi Saleh Uddin, who was a professor of Chittagong University, even received death threats on multiple occasions as he protested to save the Baddhyabhumi."

In his book "Pramanyo Dalil Muktijodde Chattogram", Dr Saleh Uddin mentioned that more than 5,000 people were killed there. "It is very unfortunate that despite the Supreme Court direction, the implementation is being delayed for so many years. The departments or individuals responsible for the delay should be brought under accountability," said Rashed.

"In 2004, the then government formed by BNP-Jamaat alliance built a memorial in another place instead of the actual Baddhyabhumi site. Later, University of Science and Technology Chattogram constructed a building at the site," said Prof ABM Abu Noman of CU. "The Appellate Division ordered to preserve the Baddhyabhumi after acquiring the land from USTC in 2014. We have been demanding it's preservation for a long time," he added.

Contacted yesterday, Prof Md Jahangir Alam, vice chancellor of USTC, said they bought 1.73 acres of land in the area in 2001. "We donated 20 decimals of the land, where a monument was built to mark the killing site. He declined to comment further on the issue or the SC order.

Regarding the land acquisition, assistant commissioner Ehsan Murad of Chattogram district administration, said, "We have sent a letter to the Liberation War ministry asking for allocation of around Tk 6.5 crore for acquisition and preservation of Pahartali Baddhyabhumi.

Say speakers on ending gender-based violence at BMP event

Although there are various laws in the country to prevent violence against women, questions remain as to what extent these laws can provide justice to the victims, said speakers at an event yesterday.

Existing laws, including the Domestic Violence Protection and Prevention Act 2010 and rape laws, need to be reformed to ensure justice for the victims of gender-based violence, they argued.

The event was organised by Bangladesh Mahila Parishad at the capital's Shegunbagicha, as part of the organisation's 16 Days of Activism

"Despite various initiatives taken by the government and non-government

organisations to combat gender-based violence, the incidents are ever increasing. There are still many obstacles towards justice," said BMP general secretary Maleka Banu.

The speakers also called to repeal section 155 (4) of the Evidence Act, which will shift the burden of proof to the perpetrators, and take necessary initiatives to publicise and implement judgments and directives of the

According to a few studies, victims are yet to know the laws properly. Lawyers and prosecution teams need to be more active in this regard, while police stations need to be more women-friendly to deal with incidents of rape and sexual violence, the speakers recommended.

While addressing the event as chief guest, MD Shahiduzzaman Sarkar, chairperson of the Parliamentary Standing Committee on the Ministry of Law, Justice and Parliamentary Affairs, said, "There is dissatisfaction with the justice system -- but we need to rely on many things before finalising

# A day of gridlock and suffering

The student movement for safe roads, which escalated after the death of SSC candidate Mainuddin Islam on Monday night, caused gridlocks and long tailbacks in some major parts of the capital yesterday.

Thousands of students from various institutions blocked roads in Rampura, Motijheel, Mohammadpur, Dhanmondi, Science Lab and Banani areas from 10:30am.

As roads leading to the protest spots were blocked with traffic, many commuters had to walk to their destinations. However, ambulances and other emergency medical vehicles were allowed to pass through.

Road blockades in Rampura and Dhanmondi created major traffic jams, as movement of vehicles was halted for hours. The blockade also triggered huge traffic gridlocks in Rampura, Malibagh, Mouchak and adjacent areas.

The students allowed private vehicles to pass through a lane, after checking driving licences. No bus was allowed to pass.

Rasel Ahmed, who was going to Malibagh from Natun Bazar by bus, said the bus got stuck at Badda. After a long wait, he decided to reach his office on foot.

Azmal Ali, a trader from Gazipur, said he came to Malibagh in the morning, but struggled to find a vehicle to go home around 2:30pm.

Auto-rickshaw and motorbike drivers refused to go to some places,

fearing jams and other hassles.

Shirin Akhter, who was waiting for a vehicle for half an hour at Rampura's Hatirjheel intersection in the afternoon, said she started walking to Banani after finding no vehicle.

Rampura Police Station Officerin-Charge (OC) Rafiqul Islam said police were deployed to control the situation.

The agitating students said that they would continue their protest until their nine-point demand is

The protests for safe roads and half fares have been continuing for several days. Amid the demonstrations, Nayeem Hasan, a student of Notre Dame College, was rammed and killed by a Dhaka South City Corporation (DSCC) garbage truck, which was driven by a cleaner, on November 24, and Mainuddin Islam was crushed to death under a bus.

## Tales of journeys bygone



The two bookshops at the capital's Kamalapur Rail Station barely get any customers nowadays, but they're still trying to keep the tradition alive.

There's this historical relationship between train travel and literature. For a journey that requires long hours of sitting still, travellers had always found companions in books. Until, of course, smartphones and the internet arrived.

Rail travel is a much romanticised in Bangladesh. Rabindranath Tagore to Nirmalendu Goon, numerous poets wrote countless poems about this voyage. In fact, one can even find a few dramas and films that are solely based on train rides.

Since the inception of trains in the subcontinent, rail stations became a great host of bookstores. It was a

natural fit. Travellers could spend their waiting times there, while books bought from the stores could keep them occupied during the long hours inside iron compartments.

But with the passage of time, these bookshops now find themselves in a quagmire.

At Kamalapur Rail Station, the country's main station, thousands upon thousands of people can be seen every day, but almost none of them can be found at its two bookstores --Camelot Book Stall and Srijani.

"We started our journey back in the '30s. The first Camelot Book Stall was set up at Phulbaria Station," said owner
