

In the early hours of the Shab-e-Barat on July 18, 2011, a mob killed the six youths near Aminbazar bridge and took their bodies to Keblarchar, more than half a kilometre off, on the instructions of police. They then called the villagers and said they caught robbers.

The mob started bludgeoning the six, without knowing the ill-fated youths had already gone beyond all pain and this was how the murder became known as an incident of mob beating.

Of the six, Towhidur Rahman Palash, Kamruzzaman Kanto and Ibrahim Khalil were students of Government Bangla College in Mirpur, Shams Rahim Shamam of Maple Leaf International School, Tipu Sultan of Tejgaon College and Sitaf Jabi Munif of Bangladesh University of Business and Technology.

Only Al Amin survived the brutal attack, but he and the six other victims were accused in a robbery case filed by local trader Abdul Malek.

Later, Al Amin was cleared of the charges after police found that the victims were not robbers.

Following the development, Anowar Hossain, sub-inspector of Savar Police Station, filed a murder case against Malek and several others in connection with the incident.

During the investigation, 14 accused, including Malek, confessed to different magistrates about their involvement in the killings.

Israel PM calls on US to halt Iran nuclear talks

Israeli Prime Minister Naftali Bennett yesterday called for an "immediate cessation" of resumed nuclear talks between Iran and major powers in Vienna, accusing the Islamic republic of "nuclear blackmail".

In a phone call with US Secretary of State Antony Blinken, Bennett, who has been a consistent opponent of the 2015 agreement the powers have been seeking to revive, called instead for "concrete measures" to be taken against Iran. He said "Iran was carrying out

nuclear blackmail' as a negotiation tactic and that this must be met with an immediate cessation of negotiations and by concrete steps taken by the major powers," a statement from his

It said Blinken had updated Bennett on what had been happening in the talks since their resumption on Monday after a five-month hiatus.

The Israeli premier expressed concern about a new report from the UN nuclear watchdog issued during the talks which he said showed Iran had "started the process of enriching uranium to the level of 20% purity with advanced centrifuges at its Fordo underground facility".

A year after then US president Donald Trump pulled out of the nuclear agreement in 2018 and started imposing sweeping sanctions, Iran began a gradual suspension of its undertakings in the deal.

The countermeasures have seen Iran enrich uranium in greater quantities and to higher levels of purity than it had agreed, something Western governments are eager to end as quickly as possible.

Armed group attacks Mexican prison, frees ınmates

An armed group attacked a prison in Mexico Wednesday, injuring two police officers and freeing nine inmates, security officials said.

The early morning assault on a prison in Tula in central Hidalgo state saw intruders break into the facility in vehicles and leave with nine prisoners,

said a prison statement. Local media reported the nine were members of a gang involved in fuel heft, kidnappings and extortion.

A police source, who asked not to be named, said the aim of the raid was to rescue the alleged founder of a criminal group called Pueblos Unidos.
