IMPOSING TRAVEL BAN **Authorities** must take court approval

SC observes in full text verdict

Authorities concerned must take approval from the appropriate court in three working days of imposing a restriction on a citizen from leaving the country, the Supreme Court observed in the full text of a verdict explaining Article 36 of the constitution regarding citizens' freedom of movement.

"Restriction may be imposed on travel in order to prevent exit from the country by persons who leave quickly to avoid due process of law. However, this would be subject to confirmation by the appropriate court within a period of three working days," the Appellate Division of the SC said in the 18 page-verdict released on Wednesday.

Earlier on September 27, the apex court delivered a short verdict modifying, with some observations and directions, the High Court ruling that said Anti-Corruption Commission (ACC) has to take court permission to impose embargo on corruption suspects or accused from leaving the country.

A four-member bench of the Appellate Division, headed by Chief Justice Syed Mahmud Hossain, delivered the verdict on the appeals moved by ACC lawyer Khurshid Alam Khan, challenging the HC judgements and orders on this issue.

The apex court said, "The fundamental right guaranteed under Article 36 of the constitution of Bangladesh is nonabsolute. The right to leave one's country has therefore never been considered an absolute right. The right may be restricted in certain

rice, most farmers continue to grow rice due to lack of a supportive agricultural policy from the state," commented Maria.

Sixty percent rural women of working age remain engaged in unpaid agricultural activities. Their earning potential remain largely untapped because of this very reason, the study also found.

The researchers recommended three steps to increase income of rural households, namely diversification and modernisation of agriculture by focusing more on higher valueadded crops, livestock and fishing products; engagement of women to skilled and paid works; and development of small cities and towns so that more men and women can engage in non-agricultural and paid activities.

ZIRABO-BISHMAIL ROAD IN SAVAR

Commuters suffer for dilapidated road

pothole ridden Zirabo-Bishmail road in Ashulia, Savar is in an extremely poor shape, causing immense suffering to the commuters.

The road connects two major highways -- Dhaka-Aricha and Tongi-Ashulia DEPZ. Besides, around 100 RMG factories and more than 500 small and big business are established on both sides of the road. Thousands of heavy vehicles go over the road all day and night.

Due to lack of repairs in last two years, the road's state has dilapidated. This correspondent recently visited the road and talked to pedestrians, drivers, and businessmen who use the road and they shared their sufferings.

Rafiqul Amin, a private car driver, who commutes on the road regularly, said although the road is unsuitable for private cars, owing to his employer's job at a garments factory next to the road, he has to use it.

"I have to wait long hours while passing from Jirabo to Amtola area due to tailback created for the road's horrible conditions," said Amin.

Shamsul Haque, a furniture trader

at Kuturia, said, "If the road isn't repaired as soon as possible, we'll face major losses in our businesses as this effects the shipment costs."

Arzina Akter, a garments worker in a nearby factory, said, "I have to go to factory on foot, as rickshaw and small vehicles don't take this road due to its bad condition. It's extremely perilous

for me as I live almost one kilometre away from the factory."

Contacted, Saleh Hasan Pramanik, engineer of Savar's Local Government Engineering Department (LGED), said they've already selected a construction firm via tender and the repairs for the 3,600-metre road will soon start.

Rab said Abu Taleb developed a love affair over phone calls with the victim and proposed to her for marriage. He asked her to visit him at his house in Ishwarganj. When the victim went for the visit, Abu Taleb raped her.

GDP and around nine percent of the national budget, only two percent of the nutrition expenditure was on direct

Of the two percent, the Ministry of Health and family Welfare (MoHFW) spent only four percent of its nutrition budget while the Ministry of Women and Children Affairs (MoWCA) spent seven percent of its nutrition budget. These were the two major ministries working on direct interventions through 13 operational plans.

Contrary to that, the vast majority of expenditure (around 98 percent) was in addressing wide- ranging underlying causes of malnutrition, such as water and sanitation, the status of women, social protection, agriculture, education, environment and climate change etc.

Dhaka University nutrition and food science professor Dr Nazma Shaheen said, "In order to achieve our SDG and nutrition targets, it's imperative we scale up the most important and effective interventions and strengthen them by expanding coverage to include a larger number of beneficiaries.'

According to project director Md Jamal Uddin Bhuiyan, the project has been providing training and a monthly allowance of Tk 800 for three years to only 2,77,000 lactating mothers in every city corporation, municipality and BGMEA and BKMEA factory workers.

Urging for more allocation, the PD said, We have got an allocation of Tk 276 crore 65 lakh, which is not sufficient because for the past two years, we have been unable to increase the number of our beneficiaries, even though there is a huge demand amid the pandemic," he said.
