## Political govt, thus political consideration

Says youth dept DG; massive irregularities alleged

Nazrul Islam joined the Department of Youth Development under the youth and sports ministry in an entry-level post in 1990. He had topped the list in the recruitment test. After 15 years of "satisfactory" performance, he was regularised in 2005.

Now an assistant upazila youth development officer, he has a clean service record.

On a list of 1,175 officers selected for higher posts, Nazrul was sixth. The department's own committee, formed to pick officers for new posts, prepared the gradation list based on the service tenure and records.

The list was originally prepared in 2016 and finalised in October this year after years of court battle. But when the department issued the order for the posts last month, an

utterly dejected Nazrul found his name was not there. In a November 25 order, the department elevated 112 assistant upazila

youth development officers, giving them "current charge" of upazila youth development officer.

"I have no political affiliation, and no bad service record in my career. But I was left out," said Nazrul.

Like him, some 70 officers were denied new posts. Most of them have

### Challenge is to manage natural capital

Speakers tell CPD webinar

Natural resources and workers at home and abroad bear the cost of development, said speakers at a webinar yesterday.

"By 2041, Bangladesh may well b a high-income country by the measure of GDP," said Iftekhar Iqbal, professor at Universiti Brunei Darussalam. "The gravest challenge is, however, expected from diminishing natural capital, especially water."

He opined that Bangladesh will become a high-income country by exhausting its natural resources. But there is no indication that there will be financial regularities, institutionalisation of democracy, independent judiciary, social justice and a knowledge society.

The use of fertiliser per hectare has doubled in the past decade and most of it ends up polluting water, said Dr Golam Rabbani, head of Climate Bridge Fund Secretariat at Brac.

### Record number of journalists jailed in 2021

Says CPJ; at least 24 killed for their coverage

AFP, New York

The number of journalists jailed around New York-based Committee to Protect Journalists said yesterday.

China and Myanmar alone put a quarter of the 293 media workers behind bars, it said.

In its annual report, the CPJ listed 50 journalists imprisoned in China, 26 in Myanmar, 25 in Egypt, 23 in Vietnam and 19 in Belarus.

Adding those jailed in Saudi Arabia, Iran, Turkey, Russia, Ethiopia and Eritrea, the CPJ said a total of 293 journalists were in prison worldwide as of December 1, up from 280 the year before.

This is the sixth year in a row that CPJ has documented record numbers of journalists imprisoned around the world," said CPJ Executive Director Joel Simon.

## Bring it down

Expatriates' welfare writes to civil aviation

Expressing concern over the high airfare to different Middle Eastern destinations, the expatriates' welfare ministry yesterday sent a letter to the civil aviation ministry to take measures for reducing the air ticket prices.

We have taken the issue very seriously. We have already raised the issue before different forums concerned. Our minister gave a demi official (DO) letter to the interministerial meeting to address the issue," Ahmed Munirus Saleheen, secretary of the expatriates' welfare ministry, told

In the letter, Munirus said they have requested the civil aviation ministry to bring the airfare down to a logical

Asked about introducing "labour fare" for the outbound expatriate Bangladeshi workers, Munirus said his ministry

Airfares for flights to different Middle Eastern countries

have now doubled, adding pressure on migrant workers returning to their workplaces. In November, airfares for different Middle Eastern countries were between Tk 40,000 and Tk 45,000. At present, the prices are between Tk 70,000 and Tk 90,000, which is

totally illogical and unexpected, said Bangladeshi expatriates. In this situation, leaders of Association of Travel Agents of Bangladesh (Atab) and Bangladesh Association of International Recruiting Agencies have demanded that the government form a regulatory board immediately to

address the issue. They said thousands of Bangladeshi workers could not return to their workplaces in different Middle Eastern countries on time due to high airfares.

#### HC issues arrest warrants for 14 loan defaulters of PLFSL

The High Court yesterday issued arrest warrants for 14 loan defaulters of People's Leasing and Financial Services Ltd (PLFSL), a troubled non-bank financial institution, as they neither refunded the borrowed money nor contacted its board members despite the

court's earlier directive.

Among the defaulters, 11 are companies and three individuals, Mejbahur Rahman, lawyer for PLFSL, told The Daily Star.

The bench of Justice Muhammad Khurshid Alam Sarkar ordered the law enforcers to arrest and produce the three individuals and managing directors of the companies, who borrowed around Tk 300 crore but did not pay back the money, before it on January 9 next year.

The bench came up with the directive during hearing an application filed by PLFSL seeking necessary orders on this

The 11 defaulting companies are: three organisations of Nahar International Company, SS Filling Station, Badhon Food Industries Ltd, and Shova International (Pvt) Ltd, two of organisations of Jayson Pharmaceuticals Ltd, Jayson Agrovet Ltd, Jayson Breeders Ltd; and Jayson Natural Products Ltd.

Three individuals are Sameer Quader Chowdhury, Samihah Quader Chowdhury Chowdhury. and Sazia Quader

Iqbal said food grain import has been steadily increasing, reflecting the challenges of food production.

"Scientific decision making is not very strong when it comes to environmental resource management," he added. Fahmida Khatun, executive director

of the Centre for Policy Dialogue, which organised the webinar, said power has always affected environmental decisions. Monsur Ahmed Kalam, presiden of Atab, a platform of around 3,500 registered travel agencies, said the airfare for the Dhaka-Ďubai or Dhaka-Abu Dhabi route is now Tk 87,000, which was Tk 40,000 just last month.

He added that the airfare for Dhaka-Muscat route is Tk 72,000, which was Tk 35,000 a few months ago.

The airfares for Riyadh, Jeddah and Madina from Dhaka were between Tk 42,000 and 45,000. Now, they are between Tk 75,000 and Tk 80,000, said Atab leaders.

It costs Tk 1.10 lakh to Tk 1.20 lakh to go to Bahrain by Gulf Air, said sources at Hazrat Shahjalal International Airport. On the contrary, airfare of different

Middle Eastern countries in Nepal, Sri Lanka and India is lower than that of Bangladesh, they said. They also demanded additional flights to Middle Eastern destinations

# Images of carnage, hope and victory

Exhibition of unseen photos of war, independence taken by Anne de Henning starts at Shilpakala Academy

April 11, 1971. Anne de Henning, a French photojournalist in her early twenties, crossed the Indo-Bangladesh border secretly to reveal the plight of the Bangladeshis to the world.

As she crossed the border through Jashore, she captured scenes of horrified

refugees fleeing for their life, villages destroyed by occupation forces and courageous freedom fighters determined to resist the Pakistan army at all cost.

In Kushtia's Pangsha upazila, she took a photo of several freedom fighters, some of them teenagers, who being demonstrating their determination and readiness to fight with bows and arrows, saying that they were willing to die to achieve an independent Bangladesh.

A speciality of the photos Anne had taken is that they

are extremely rare, as foreign journalists bombing villages in Kushtia and Pakistan were not allowed to enter the country when Anne visited, and these photos were never exhibited before.

Today, Anne's photos will be exhibited for the first time at an exhibition titled "Witnessing History in the Making: Photographs by Anne de Henning", jointly

organised by Samdani Art Foundation and Centre for Research and Information (CRI) to mark the 50th anniversary of Bangladesh's independence.

The event will take place at Shilpakala Academy till December 31.

Anne took great risks to take the historic photos, as she felt committed to show the world the massacre committed

> by the Pakistan army and the sufferings of innocent Bangladeshis.

"I felt that the foreign press had a responsibility to convey to the outside world the plight of the Bengali people, who were ruthlessly denied their democratic rights following December elections," Anne told this correspondent.

The photographer, who is now in her seventies, is currently in France and communicated with this correspondent via email. She witnessed how

fleeing refugees. She recounted, "In Goalundo Ghat on Padma river, which I intended to cross and push on to Dhaka, the silence was broken in the middle of the night by the rattle of

## Agargaon to Motijheel by Dec 2023

Experts say partial launch to have little impact on Dhaka traffic; commuters fear transport scarcity at Agargaon point; BRTC to provide special bus service

STAFF CORRESPONDENT

While metro rail operation from Uttara to Agargaon is scheduled to begin in December next year, people have to wait till December 2023 to use the metro to travel to and from Motijheel.

Although the partial operation will be helpful for commuting to and from Uttara and Mirpur, it would have little impact on the capital's overall traffic situation, experts said.

Rather, passengers may face a scarcity of transport options, especially at Agargaon, to go to other parts of the city, because more pressure will be put on other forms of public transport, as people will get off the metro and get on buses. Besides, there is no full-fledged bus stop at Agargaon.

Metro authorities, however, said they have already reached an understanding with Bangladesh Transport Corporation (BRTC), which will operate buses from Uttara and Agargaon dedicatedly for metro passengers.

On basis of the progress made so far, it is possible to meet the target [of operating from Uttara to Agargaon by December 2022]," MAN Siddique, managing director of Dhaka Mass Transit Company Ltd, which is implementing the metro rail project, said yesterday.

He, however, said the Uttara-Motijheel route will be operational by December 2023.

As part of the preparation, performance test between Uttara and Agargaon will be carried out on Sunday for the first time, he said.

Siddique was speaking at an online news briefing to inform about the progress.

The Mass Rapid Transit Line 6 or MRT-6 is being constructed between Uttara Third Phase to Motijheel at a cost of around Tk 22,000 crores. Once completed, it will be able to transport 60,000 people per hour and would reduce travel time from Uttara to Motijheel from about two hours to only 40 minutes.

PARTIAL OPERATION WILL HAVE LITTLE IMPACT

Prominent transport expert Prof Moazzem Hossain said taking the capital's current traffic situation into account, launching of a single metro line would have very little

"And partial operation of a single line would be just for the sake of launching something," he said.

Authorities will have to launch at least two or three lines to see some impact on traffic, said Prof Moazzem, who teaches at the Buet's civil engineering department.

#### We are failing

Says environment minister on wildlife conservation



Joypurhat District and Sessions Judge Nur Islam delivered the verdict in presence of the convicts -- Sekendar Ali, 42, and his brother Shahidul Islam, 44, of Akkelpur upazila, and Babu Mia, 48, of Khetlal upazila.

According to the case statement, there had been a feud between the convicted siblings and their elder brother Abu Taher, 46, over the ownership of ancestral property.

On March 1 in 2007, Sekendar and Shahidul along with the other convict entered Taher's room and stabbed him to death.

Police arrested the trio after Ashraf Ali, Taher's father-in-law, filed a murder case with Akkelpur Police Station the following day.

## AL man building market grabbing WDB's land

No action yet even after lodging complaint with the police

A local leader of the ruling Awami League (AL) is building a market grabbing the land of the Water Development Board (WDB) in Doani area of Hatibandha upazila in Lalmonirhat.

Abu Bakkar Siddique Shyamal, the organising secretary of Hatibandha upazila unit Awami League and chairman of Gaddimari Union Parishad, has been constructing structures on some 30 decimals of land along the flood bypass road next to the Teesta Barrage in Doani area of Hatibandha.

Meanwhile, the WDB authorities on September 1 lodged a written with Hatibandha complaint Police Station against the illegal construction on the land. WDB authorities also issued a notice to the AL leader on September 15 asking him to stop building permanent structures on its land. But the construction work has not stopped yet.

Abdur Rob, assistant revenue officer of WDB in Dalia, said that although they had lodged a on September 1, the police have flood bypass road as per the rules.

Several ultra-poor people have been living on the WDB's land in Doani area for a long time building makeshift structures. "We have never dared to build

any permanent structure here. But the AL leader has been building structures occupying the WDB's land," said a resident of the area seeking anonymity.

The WDB authorities have failed to take any stern action against him. If no action is taken against this illegal occupation, others will start occupying the WDB's land and start construction, locals said.

Bakkar Contacted, Abu Siddique Shyamal said that he was written complaint with the police constructing the structures along the

He claimed that he purchased the land from the land owner but he could not give any information about who had sold this land to

"WDB authorities have illegally lodged a complaint against me with the police station. The notice issued to me is also invalid," he said.

"I will remove the structures from here if the court orders so; otherwise not," he also said.

However, WDB official Abdur Rob said there was no privately-owned land around the Teesta Barrage and the Flood Bypass Road. The landless people have been living temporarily on WDB's land.

Nobody can build any permanent structures on it, he said.

Hatibandha Police Officer-in-Charge (OC) Ershadul Alam said that Abu Bakkar Siddique Shyamal was asked to stall the construction work on WDB's land following the written complaint lodged by the WDB authorities and he was also asked to show his documents.

"As per the rules, if WDB seeks police assistance, we are ready to cooperate," said the OC.

## Early variety of potato a boon for farmers

OUR CORRESPONDENT, Nilphamari

An early potato harvest has brought fortune to the farmers in Nilphamari district as traders are paying exceptionally high prices for the kitchen staple amid increased demand in the country's major cities.

The situation is unlike the previous season when the farmers incurred huge losses due to preserving their produce in cold storage.

"Farmers in Nilphamari are the pioneers in producing the early variety of potato that can be harvested only 60 days after sowing," said Kishorganj Upazila Agriculture Officer Habibur Rahman adding that the soil of the region is highly conducive to potato cultivation.

According the Department of Agricultural Extension (DAE) in Nilphamari, it set the target to cultivate potatoes in 22.5 thousand hectares of land and the production target was 4.5 lakh metric tonnes. However, the early variety of potatoes has been cultivated on 8.1 thousand hectares.

In the meantime, 25 per cent of early potatoes have already been harvested and sold instantly as traders from Dhaka, Chattogram and other cities came to the farmers' doorsteps to purchase the product directly from fields at a competitive rate as this new potato has a high demand in the

Selected villages in the district's two upazilas out of six are blessed with the bumper yield of the variety and they are Panialpukur, Porakot, Putimari, Kalikapur, Nitai, Uttar Durakuthi, Dakkhin

Durakuthi, Uttar Bahagli, Dakkhin Bahagli of Kishorganj upazila and Chapra, Natib Chapra, Zadurhaat and Panchapukur of Sadar upazila.

Shamim Hossain Babu, 45, a potato farmer of Uttar Durakuti village in Kishoreganj upazila, said, "I cultivated the early variety of potato in 10 bighas of land spending Tk 2.30 lakh as production cost and got 15,000 kg yield in the third week of November, which was sold at Tk 6 lakh and my net profit stands at 3.70

These potatoes after reaching the kitchen markets of Dhaka are usually sold at Tk 80-Tk 100 per kg, he added.

"For an early harvest, we sow potato varieties like Grnula, Karez, Diamond etc in September-October and harvest in November-December," said farmer Zohurul Islam of Kalikapur village in the same upazila adding that late varieties of potatoes are usually harvested in the February-March period.

Farmer Sirajdoula of Chapra village in Sadar upazila said that after harvesting of early potato, they can sow the same crop again in the same land to harvest in the February-March period giving them the opportunity to make extra bucks.

Deputy Director of Nilphamari DAE Abu Bakkar Siddique said, "Early varieties of potato are a blessing to the district's farmers as they bring sure profit. As farmers can cultivate potatoes twice in the same land, hopefully, the production target will be reached by February-March

## Booster doses likely from next month

While Maleque did not give a timeline for the rollout of the booster dose campaign, The Daily Star has learnt from health ministry officials involved in vaccine management that two weeks is needed to complete the technical tasks.

The campaign for booster shots will start in January at the earliest, they said on condition of anonymity as they are not authorised to speak with the media.

The Directorate General of Health Services (DGHS) has been preparing the protocols for giving booster doses, which is a supplemental vaccine dose given to people when the immune response to a primary vaccine series is likely to have decreased over time.

People aged 60 years and above who have received the full dose of the Covid-19 vaccine will get the same vaccine as the booster dose, according to the officials.

The background tasks to roll out booster doses are underway, Toufiq Hassan Shawon, medical officer at the DGHS engaged in Covid-19 vaccination management, told The

Daily Star yesterday.

"We will stay prepared and will start giving booster dose once the higher-ups take a call," he added.

The government's move to proceed

with the booster dose campaign for the elderly goes against the National Immunisation Technical Advisory Group (NITAG). When the majority of the target people has not received full doses of

Wealthy countries may start to hoard Covid-19 vaccines again, threatening global supplies as they seek to shore up stocks to fight the new Omicron variant of the virus, a senior World Health Organization official said yesterday.

The warning by the WHO's vaccine director, Kate

O'Brien, comes as supplies to the COVAX dose-sharing programme run by the WHO and vaccine charity GAVI have increased in the past few months due to donations from wealthy countries and after India eased limits on exports of vaccines.

New Delhi's move has meant the Serum Institute of India has resumed shipments of the AstraZeneca vaccine it makes, mainly for COVAX.

"We have to make sure that it (higher shipments)

continues," O'Brien said in a briefing.

"As we head into whatever the Omicron situation is going to be, there is risk that the global supply is again going to revert to high-income countries hoarding vaccine' as they seek to protect their ability to vaccinate their citizens, she said later.

Earlier in the briefing, she said a major problem for COVAX has been wealthy countries donating Covid-19 vaccines with a relatively short shelf life, while noting that wastage rates were also high in some wealthy countries.

COVAX has shipped 610 million doses of vaccines to 144 countries or territories since February, the GAVI website shows.

## 'We stand at an inflection point'

Biden rings the alarm on state of democracy worldwide

Democracy faces "sustained and alarming challenges" worldwide, US President Joe Biden said yesterday at the opening of a virtual summit on democracy with representatives from some 100 countries.

Biden said trends are "largely pointing in the wrong direction" and that democracy needs "champions."

"We stand at an inflection point," Biden said. "Will we allow the backward slide of rights and democracy to continue unchecked?"

The two-day event, held by video link because of the coronavirus pandemic, was billed by the White House as US leadership in an existential struggle between democracies and powerful autocracies or dictatorships.

"Make no mistake, we're at a moment of democratic reckoning,"

said Uzra Zeya, the Under Secretary of State for Civilian Security, Democracy, and Human Rights. "Countries in virtually every region of the world have experienced degrees of democratic backsliding."

remarks from Biden and Secretary of State Antony Blinken, with representatives from some 100 governments, as well as NGOs,

private businesses, philanthropical and legislatures organizations But Biden went into the summit

with the United States deep in its own democratic troubles. Republican predecessor

Donald Trump continues a shocking campaign to disrupt US political norms and overturn the 2020 election in which he was defeated by Biden. And there was also tension simply

over who should be on -- and off -- the list of invitees.

China and Russia, which Biden sees as champions of the autocracies camp, were pointedly left out, something they say is stoking an ideological rift.

'No country has the right to judge The summit featured opening the world's vast and varied political landscape by a single yardstick," wrote ambassadors Anatoly Antonov of Russia and Qin Gang of China in a joint essay last month.

## China 'committed genocide' in Xinjiang

Uyghur tribunal in London rules

A London-based independent tribunal has ruled that China committed genocide against Uyghurs and other ethnic minorities in its western Xinjiang region, accusing China's senior leadership including President Xi Jinping of "primary responsibility" for acts perpetrated against Muslim minority groups.

"The tribunal is satisfied that the PRC [People's Republic of China] has affected a deliberate, systematic and concerted policy with the object of so-called 'optimizing' the population in Xinjiang by the means of a long-term reduction of Uyghur and other ethnic minority populations to be achieved through limiting and reducing Uyghur births," Geoffrey Nice, who chaired

the tribunal, said yesterday as he read out the verdict. He added that the tribunal was

'satisfied that President Xi Jinping, Chen Quanguo and other very senior officials in the PRC and CCP [Chinese Communist Party] bear primary responsibility for acts in Xinjiang."
While the "perpetration of

individual criminal acts that may have occurred, rape or torture, may not have been carried out with the detailed knowledge of the President and others, but the tribunal is satisfied that they have occurred as a direct result of politics, language and speeches promoted by President Xi and others...," he said.

The judgment follows a series of tribunal hearings in London this year, during which a panel of jurors reviewed evidence and testimony.

## **US-led anti-IS coalition** ends Iraq combat mission

Shifts to training, advisory and capacity building role

The US-led coalition against the Islamic State group has finished its combat mission in Iraq and will shift to a training and advisory role, Iraq's national security adviser said yesterday.

The change of the mission for around 2,500 American troops stationed in the war-battered country by the end of the year was first announced by US President Joe Biden in July when he hosted Iraqi Prime Minister Mustafa al-Kadhemi.

The Iraqi government has been under pressure from powerful pro-Iranian political groups with armed wings that have vehemently demanded all US troops leave the country. "We are officially announcing the end

of the coalition forces' combat mission,' national security adviser Qassem al-Aaraji wrote on Twitter "The relationship with the international coalition continues in the areas of training,

forces, he added Aaraji was speaking after a meeting between the coalition and the Joint



### Indian farmers end year-long protests

Indian farmers called off a year-long protest yesterday after assurances to consider guaranteed prices for all produce, instead of just rice and wheat, union leaders said.

The move comes after Prime Minister Narendra Modi said last month he would roll back three farm laws, seeking to end the longest-running farmers' protest that galvanized millions of growers who remained resolute in opposing the legislation.

Despite the government's climbdown, thousands of farmers had continued to camp out on major highways leading to New Delhi to press for other demands such as the guaranteed prices, as well as for legal action against protesters to be dropped.

"We have received a letter from the government which nas conceded to our requests," said Balbir Singh Rajewal, a senior farm union leader.

Farmers' leaders would meet on January 15 to review progress on the government's assurances, Rajewal told a news conference.

"We will resume our protests if the government moves away from the assurances," said Gurnam Singh Charuni, another farmers' leader.

The government will set up a panel of growers and government officials to find ways of ensuring Minimum Support Prices (MSP), as the guaranteed rates are called, for all farm produce, according to the letter seen by Reuters.

# Combatting cyber harassment through comics

Youth-led organisation N te Nari, N te Nirapotta (NAW) was the 2021 runner-up in the students/campaigns category for UNDP's Digital Khichuri Challenge (DKC), titled "The Unsafety Net: How Online Abuse is Driving Women Out of Digital Spaces".

Shahriar Pranto, Founder of NAW, formed a team of five to enter the competition and counter cyber harassment. The other members of the team are Co-Founder Nur-A-Shafee Ahnaf, who studies Economics at Dhaka University (DU), Chief Strategist Md Rakib Hossain, a marketing student at North South University, Ashim Faiaz Talukdar, the Chief Arts & Graphic Designer from Faculty of Fine Art, DU, and Sheherin Jahan, the Campaign Coordinator, who just completed her HSC from Adamjee Cantonment College.

During the competition, their research led them to find existing ways in which women can seek help if fall victim to online harassment. However, people are oblivious to such facilities due to lack of information dissemination.

There are numerous hotlines that women can use to complain about cybercrimes, including Police Cyber Support for Women, Quick Response Team of the Women Support & Investigation Division and Cyber Police Centre.

In order to tackle violence against women and children, the Ministry of Women and Children Affairs provides a national helpline, 109, which provides police

assistance and counseling services, among other things.

NAW publishes comics online, based on true stories, to enlighten people about such services. This medium allows them to portray the story of a woman being harassed, asking for help and finally, the perpetrator being punished, in a way which people can relate and empathise with. As people read the comics, they become aware of the assistance available in case anyone comes into such dangers.

NAW also organised debate and art programmes online so their message of speaking up instead of staying silent is dissipated across the nation to as many people as possible.

"Women have increasingly exposed themselves to social media, especially through e-commerce, so it is important that we promote safe and healthy online communities. We are also hoping to start campaigns and have someone from the police go to schools and teach both boys and girls about helplines," shared Pranto

In the future, NAW aspires to have printed versions of their comics. "If physical copies of our comics are distributed in debate programmes, science fairs, libraries and student clubs in schools and universities, it will be easier for us to relay the necessary information," concluded Rakib.

# Roaring drums, vivid 'Dokmandas' and a day too good to forget

Celebrating Wangala with the Garo community in the greenery of Madhupur

Jishu ni Rasong (in the name of Jesus, I greet you) read a board at the church gate as we stepped into the Saint Paul's Dharmapolli in Pirgacha, a small rural area that lies in the suburbs of Madhupur in Tangail.

The burtle and truste of the young girls the women screening.

The hustle and tussle of the young girls, the women screaming on top of their voices, giving instructions to each other and the men constructing the platform for the next morning- this is how Madhupur welcomed me for Wangala, a festival that celebrates the arrival of winter and the harvest season.

This was my very first time visiting Madhupur for a field trip, organised by my Sociolinguistics professor Fr Shankar Leonard Rozario from Notre Dame University Bangladesh (NDUB). He taught us to design ethnography last semester, but was unable to take us to any speech event to practically analyse speech acts due to the coronavirus pandemic.

Being one of his former students and an associate at the NDUB Language Centre, I was asked to accompany the junior Master's batch and help them write an ethnography report on the Wangala Festival.

The Wangala, being derived from the pagan beliefs, is a festival where the worshipers thanked the Misi Saljong (Sun God) for their rich harvest. For decades, the woods of Madhupur has been home to the Garo Christian community.

Draped in beautifully hand woven *Dokmandas*, the girls were rehearsing for the performance. Children aged between 4 and 8 were repeating their steps, as they kept forgetting the sequences.

As the night closed in, everyone gathered around the campfire, enjoying the foggy winds, local delicacies paired with *Chu* (locally made rice wine). We had the privilege to visit a Garo family who invited us for dinner.

As we sat around the dining table, a long train of dishes arrived: first the *bhortas*, then the curries and stews, and finally the spicy stirfried non-veg items and fruits. Juicy pineapples, luscious papayas, and naturally grown guavas paired with a mug of *Chu*, which seemed to be on auto-refill every time the cup went empty.

I woke up the following day with the sound of the big brass bell dangling beside the Wangala podium. Hastily finishing our breakfast, we rushed to the church field.

Adapting to their current religious faith while treasuring their cultural heritage, the Garo community began the day with performances, leading to a prayer and ending the day with a cultural event.

As the sun set and the festivities began to quiet down, it was time for me to bid farewell to this amazing organic lifestyle and wonderful hosts. Holding a large coconut on my hands while sipping its sweet water with a bamboo cane straw, I waved the cheerful yet sad faces goodbye, promising to meet them again.

# Violence against young women and girls with disabilities: An everyday affair

Worldwide, young women and girls with disabilities face up to 10 times more violence than women and girls without disabilities, and Bangladesh is no exception.

In Bangladesh, young women with disabilities are at a high risk of experiencing gender-based and other forms of violence due to social exclusion, limited mobility, lack of support structures, communication barriers, negative social perceptions, and overall culture of impunity.

According to data from the Women with Disabilities and Development Foundation, an organisation providing non-legal support to women with disabilities, 96 percent of women and girls with disabilities face physical, psychological, sexual and emotional violence.

Another 2020 study conducted by BRAC James P Grant School of Public Health, in association with the Netherlands Embassy that interviewed 5,000 people with disabilities, revealed that one fourth (74 percent) of the women and girls with disabilities faced psychological violence, while more than 33.2 percent of them faced physical violence and 10 percent faced sexual violence.

In most cases, the caregivers, either at home or in institutional settings, and violent partners, are found to be the perpetrators, as they are socially dependent on them for survival.

On the other hand, research and real-life experience show that once young

women and girls with disabilities are victims of violence, they are more likely to be victims of violence for the second or third time, as the perpetrators take advantage of their vulnerability and helplessness.

Bangladesh Legal Aid and Services Trust (BLAST) data also revealed a similar picture of the magnitude of repeated violence against them--about 78 percent of young women and girls with disabilities become victims of various forms of sexual and physical abuse due to their limited ability to protest and 18 percent of them are

However, media monitoring reports also show that incidents of violence against this vulnerable group mostly go unreported.

The process for reporting violence is often inaccessible because of family, administrative and social barriers, as almost 99 percent of women with disabilities live below the poverty line, while only 1 percent of girls with disabilities have access to education and an overwhelming majority

of them do not know sign language.

Besides, the inequalities in access to justice, including the inaccessible court buildings, lack of interpreters for young women and girls with intellectual, speech, hearing and psycho-social disabilities, inadequate policies and standards, information unavailability about services and funding make them even more vulnerable to experience multiple forms of violence.

According to experts, we need to look

for reasons why young women and girls with disabilities are being excluded from getting justice, and take necessary steps to remove these obstacles.

Arranging compensation for the victim

Arranging compensation for the victims of disabilities and giving exemplary punishment to the perpetrators is crucial, they noted. Meanwhile, laws related to disability rights must be disseminated to the victims in accessible formats (through braille, sign language), so that they can be aware of the crimes and their rights.

Ashrafun Nahar Misti, Executive Director, WDDF, also highlighted that the Persons with Disabilities Rights and Protection Act 2013 does not specify how a girl child or young woman will get remedies if they are raped.

"It would have been better if there was a separate chapter on how these particular cases could be tried and remedies were provided," she said.

#### Political parties must stop raising thugs

They, too, are liable for the misdeeds of their student activists

THE first judicial ruling on the brutal murder of a student has been delivered.

Twenty students of Buet have been sentenced to death for their direct involvement in the murder of Abrar Fahad, a second-year student of the country's premier engineering university, who was beaten to death. Five other students have also been sentenced to life imprisonment by the court for their involvement in the grisly murder that shook the country in October 2019. We appreciate the strong message delivered by the court through this verdict. Without commenting on the merit of the case, we would, however, like to express our sadness at the fact that 20 young people are now facing death

Right now, we would like to concentrate on the message sent out by the teachers: to end criminality in the name of student politics. In the case of Abrar's death, 12 of the accused were members of the Buet wing of Bangladesh Chhatra League, while the rest were their followers. Over the years, we have seen the student wings of the ruling parties becoming increasingly more violent and involved in all forms of criminal activities. Whenever a party comes to power, we see their affiliated student wing terrorising university campuses and taking over their dormitories. Our once glorious student politics has now become a hostage for criminal elements. As we celebrate the 50th anniversary of our independence, it is a great shame that the student movement, which played such a pivotal role in the emancipation of our people, has been reduced to this.

At this lowest point for our student politics, we have to restore civility back into our universities. We have to take this moment to address the moral degradation of values that is taking place at our educational institutions. For years now, we have been witnessing how politicians and major political parties have been using student activists as cronies for their criminal agendas. This is turning more and more young people on the path to becoming hardened criminals.

The misuse of student activists by their political leaders and parties must stop. #### Rising inequality a cause for concern

Planners must address the glaring wealth gap

T is flustering news that only one percent of Bangladesh's population is in possession of 16.3 revealed in the report titled "World Inequality Report 2022," released by the World Inequality Lab in Paris. The latest update of the index, published on December 7, showed that the figures did not change much from the previous year, but clearly indicated how income inequality had been rising since the 1980s. In 1981, the share of pretax national income of the top one percent of people was 11.8 percent, while the bottom 50 percent held 20 percent

According to a UN study, "one of the consequences of inequality within societies is slower economic growth. In unequal societies, with wide disparities in areas such as health care and education, people are more likely to remain trapped in poverty, across several generations. When we look at the Bangladesh perspective, we see that the root causes of inequality have not been removed. For example, Bangladesh did not create the desired number of employment opportunities for its large number of unemployed youths; also, it did not spend enough on the health and education sectors and on social safety net

As a result, the number of poor is increasing day by day and also the number of rich is increasing proportionally. It has been noted by experts that even during the pandemic, people have gone from rich to richer. Economists and social researchers tend to agree that inequality has been increasing for years as the country's GDP is not increasing inclusively. They suggest addressing the incidence of corruption and weak taxation structure, which are contributing to the rising spectre of inequality. A great deal has been deliberated on the issue of wide-ranging corruption in the country and its impact on the economy. But, despite some small steps taken towards addressing the issue, the enormity of the burden remains hanging around the neck of the nation like the proverbial "dead albatross."


#### No faith in e-commerce

## Why the chasm between state commitments and access to rights?



**ECEMBER** 10 marks the Human Rights Day (HRD). It was on this day that a landmark document, the Universal Declaration of **Human Rights** (UDHR), was proclaimed by the United Nations

(UN) General Assembly in Paris in 1948 as a common standard of achievement for all peoples and all nations. Not only have most states in their constitutions espoused the tenets of the UDHR, but the document has also been the source of at least 70 human rights treaties at global and regional levels.

The principles of equality, nondiscrimination, justice, accountability, diversity, participation, and the rule of law are some of the core blocks on which the UDHR rests. States and societies that ensure protection and promotion of human rights for everyone are not only more resilient and sustainable, but are also better equipped to withstand challenges of all kinds—including wars, pandemics, and the climate crisis. The successful attainment of the much celebrated 2030 Agenda for Sustainable Development with concomitant commitment to "leave no one behind" makes it mandatory for the states that they respect and promote rights and dignity of everyone, irrespective of their

While the UDHR encompasses a whole range of civil, political, economic, social, and cultural rights, which were subsequently expanded through various international human rights treaties, this essay will essentially examine the status of enjoyment of the freedoms of assembly and expression by people in Bangladesh. The UDHR acknowledges that "(e)veryone has the right to freedom of opinion and expression ... without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers" (Article 18). It also guarantees that "(e)veryone has the right to freedom of peaceful assembly and association" (Article

Both these principles have been further elaborated in a number of international treaties that Bangladesh is a state party to. As a member state of the UN, the country is obliged to honour each and every article of the declaration as well as the provisions of those treaties. Needless to say, the principles laid out in the UDHR have also been enshrined in the country's constitution, the supreme law of the land. Hence, it is incumbent on the state of Bangladesh to ensure that its citizens enjoy all those rights and freedoms without encumbrance. However, a cursory examination of the human rights situation pertaining to the freedoms of assembly and expression prevailing in the country leads one to surmise that there exists a wide chasm between the state commitments and the lived experiences of citizens

Though the right to peaceful assembly has been guaranteed in Article 19 of the UDHR as well as the Article 37 of the constitution, it has increasingly become restricted in the country. Under the law, if political parties and organisations plan to hold rallies, meetings, and marches, they are required to secure prior permission from the police commissioners in the metropolitan cities and superintendents of police at the district level. In the past, granting such permission was a routine matter; over more than a decade, the applicants find it increasingly difficult to secure permission. The reasons for refusal of permission are not communicated.

Experiences show that, while the ruling party and its associate organisations do not face any problem in holding public programmes, opposition political parties have reported facing severe restrictions (Prothom Alo, November 26, 2021). There have been instances in which opposition

permission, police action and attacks by pro-government loyalists. On several instances, leaders and activists were detained, imprisoned and charged for holding unlawful meetings, creating public disorder and the like. The attack on civic protests marked a new low when a number of people protesting the visit of a foreign leader were killed or injured by police fire and arrested in different parts of the country. On March 14, 2021, during a press conference, the Dhaka Metropolitan Police (DMP) banned political programmes during the state celebrations of independence, declaring that parties that would fail to comply "will be considered as traitors" (Dhaka Tribune, March 14, 2021).

Freedom of expression/speech is another fundamental prerequisite of any democratic polity and has been recognised as such (Article 18 of UDHR). Yet, over the decades, this has been subjected to serious

erosion under successive regimes. Despite

also come in handy to tame the press. The Special Powers Act, in particular, accords substantive powers to state functionaries to detain individuals—including journalists and whistleblowers—for committing "prejudicial acts." The relatively recent legislations such as the Information and Communication Act (ICT), 2006 and the DSA have taken a serious toll on freedom of expression—including that of the media.

Apart from legislative measures, the state can exercise control over the media by exercising its discretion on issuance of licence, directing the flow of advertisements, and influencing the formats and contents of reports/ programmes through "informal advice," a practice that has its roots during the military

In recent times, the DSA has turned out to be the most important instrument to control freedom of expression. Quoting the Department of Prisons, a recent Amnesty International (AI) report informs that 433 individuals have been imprisoned under the DSA as of July 11, 2021. The report further informs that more than 1,300 cases have been filed against about 2,000 people under the law, and nearly 1,000 people have been arrested since the law was enacted in October 2018. Amnesty claims more than 100 journalists have been sued under the law between January 2019 and July 2021, and at least 40 of them have been arrested. The vague wording of the law provides the state agencies the scope to clamp down on dissenting voices on social media, websites and other digital platforms. The punishment that can be meted out under the law extends to life imprisonment.

In addition to the legislative instruments, journalists and dissenting voices face threats and intimidation from various official and private quarters as well. The absence of an enabling environment that encourages free and unfettered reporting and analysis leads to the practice of self-censorship. Various national and international media watch reports have time and again expressed concerns about the constraints in which journalists, particularly those at the grassroots level, have to work in Bangladesh.

Thus, freedoms of expression and assembly have largely remained a chimera for the Bangladeshis. This failure of the state to uphold its constitutional and international legal obligations in upholding the rights to free speech and freedom of assembly amounts to undermining the very spirit of the Liberation War. The Human Rights Day exhorts people to stand up for their own rights and those of others. The onus, therefore, rests on all conscientious citizens, organisations, civic bodies, learned bodies and academics, artists, poets, and writers' guilds to contest and challenge the state and hold it accountable. Being humans, we all are innately entitled to enjoy these rights—rights are no charity.

In addition, spontaneous rallies and demonstrations by groups of students and the youth, mobilised on issues such as revoking the VAT on student fees, road safety, and government service quota reform, were also subjected to denial of

through continuation of colonial vestiges, such as the provisions of the Penal Code, 1860 pertaining to defamation and sedition, and the Official Secrets Act, 1923. The defamation provision in the Digital Security Act (DSA), 2018 and the Penal Code are legal instruments to intimidate journalists and free-thinking individuals. ## The global coal hypocrisy



somehow L emerged as the villain of last month's United Nations Climate Change Conference (COP26), blamed for resisting cuts to coal consumption even as toxic air envelops its capital,

New Delhi. The country's supposed crime in Glasgow was to join China in insisting on a last-minute change to the conference's final declaration, in which countries pledged to "phase down" rather than "phase out" coal. For that, India, whose per capita carbon dioxide emissions are a fraction of those of the world's leading emitters, was widely criticised for obstructing the global fight against climate change.

The irony is that India has done far less to intensify the planet's greenhouse effect than either China or the developed West. True, the country is a major coal consumer, and derives about 70 percent of its energy from it. But, as recently as 2015, at least a quarter of India's population couldn't take for granted what almost everyone in the developed world can: to flick a switch on a wall and be bathed with light.

Worse, Indians are among the biggest victims of climate change, periodically enduring devastating floods and unseasonal droughts, in addition to choking on polluted air. Delhi is a poster child for poor air quality, which hovers between "severe" and "hazardous" for much of the year. The causes include PM2.5 particles emitted from coal-fired power plants, fumes from dense traffic, industrial pollution, and the burning of crop stubble by farmers in the neighbouring states—all combined with

But given India's traditional role as a leading voice of the developing world, it became the face of the last-minute change of language at COP26. The "phase down"

wording regarding coal consumption had already appeared in a US-China bilateral climate agreement, signed earlier in the conference. Nevertheless, India became the focus of global opprobrium.

India does not deserve to be the fall guy. For starters, the country has 17 percent of the world's population but generates only seven percent of global CO2 emissions. (China, with 18.5 percent of the world's people, generates 27 percent of emissions, and the US, with less than five percent of

the world's population, accounts for 15 percent.) Whereas wasteful consumption and unsustainable energy-guzzling are rife in the West, most Indians live close to the subsistence level, and many have no access to energy. To expect India to meet the targets that rich countries currently tout is unfair and impractical.

Economic development—indispensable to pulling millions of Indians out of poverty—requires energy. Coal may be polluting, but it is not feasible for any developing country to switch rapidly to cleaner alternatives that need scaling up.

Moreover, despite having vast financial resources and access to cleaner fossil fuels, such as natural gas (which India must import), Western countries have done little to help. They have failed to keep climate finance promises to poor countries (notably the USD 100 billion per year they committed to provide at COP15 in

Copenhagen in 2009), and refused to transfer advanced green technologies. And COP26 singled out the coal used by developing countries, not the oil and gas used extensively in the West.

India's energy requirements are expected to increase faster than those of any other country in the next two decades. Since COP21 in Paris in 2015, India has announced ambitious plans to scale up its production and use of renewable energy, which currently accounts for only 18 percent of its electricity generation. And at COP26, India complemented its explicit commitment to phase down coal with a pledge to achieve net zero emissions by

India has also updated its nationally determined contributions (NDCs), which it must fulfil by 2030. The country is now pledging to increase its installed renewable energy capacity to 500 gigawatts (GW), and meet 50 percent of its energy requirements from non-fossil-fuel sources. Furthermore, India aims to reduce its CO2 emissions by one billion tonnes and lower its emission intensity (which measures emissions per unit of economic growth) by 45 percent from the 2005 levels.

For now, there is no viable alternative to coal. Blessed with abundant sunshine, India has become a solar power enthusiast and plans to generate 40GW of green energy from rooftop solar installations by 2022. But it has achieved barely 20 percent of that target so far. Vast amounts of solar energy cannot be generated overnight, and battery storage remains expensive, while green hydrogen technology and facilities are still unavailable in India. Wind energy is minuscule, and the country lacks significant oil and gas reserves. Nuclear power accounts for less than two percent of India's electricity, and nuclear power plants constantly face opposition from the residents of surrounding areas.

As a result, India's performance on greenhouse gas emissions will get worse before it gets better. According to a study by BP, India's share of global emissions

will increase to 14 percent by 2040. Coal will by then account for 48 percent of the country's primary energy consumption, and renewable energy only 16 percent. And because of India's high dependence on agriculture, which engages nearly two-thirds of its population, and its vast number of cattle, the country did not sign the global deal announced at COP26 to reduce methane emissions.

Of course, reducing emissions is not the only way to combat climate change. India plans to bring one-third of its land area under forest cover, and to plant enough trees by 2030 to absorb an additional 2.5-3 billion tonnes of atmospheric CO2. It has made a start, with forest cover increasing by 5.2 percent between 2001 and 2019, though progress has been uneven, with the northeast losing forest cover while the south visibly improves.

Still, the Intergovernmental Panel on Climate Change (IPCC) says that achieving global net zero emissions by 2050 is the minimum needed to limit global warming to 1.5 degrees Celsius above pre-industrial levels. Climate Action Tracker calculates that—based on the countries' current 2030 climate targets—the world faces a temperature rise of 2.4 degrees Celsius by 2100. Some scientists warn that global warming could eventually exceed four degrees Celsius.

If this happens, the resulting heat waves, droughts, floods, and rising sea levels would cause devastating loss of human life, mass extinction of animal and plant species, and irreversible damage to our ecosystem. India would be a major victim of such a calamity. The country will therefore make a good faith effort to help avert climate disasterbut only within the limits of what it can feasibly do.

16 Days of Activism against Gender-Based Violence

## How much have we done to end violence against women?



THE 16 Days of Activism against Gender-based Violence, which began on November 25, is ending today. As many of us know, it is a global campaign to bring attention to the scourge of violence against women and girls, and to call for its elimination. The global

theme for this year's 16 days of activism is: "Orange the world: End violence against women now!" The colour orange symbolises a bright and optimistic future free from violence against women and girls.

The campaign received widespread coverage from the media this year, which in itself is an achievement. This increased awareness means that more and more people are realising the urgency of the issue of violence against women and girls (VAWG), and the necessity of addressing it. However, this has not stopped such incidents from occurring. As per newspaper reports, during this period, at least 74 women and six children have been raped and at least 75 girl children have been married off.

So, what can we do about it? Of course, the activism, protests, and raising awareness have to continue. However, we need stronger political commitment and actions. We must question institutions responsible for preventing VAWG regarding how much of the National Action Plans to end VAWG and child marriage has been implemented. Or what changes have been made within institutions, or what mechanisms have been put in place to hold accountable those responsible, such as law enforcers, healthcare officials, elected representatives and local authorities, etc, to address and prevent VAWG.

VAWG is a multi-dimensional issue and

requires multi-dimensional strategies to be combatted. It is as much an issue of the law working to prevent it, as it is about the attitude towards women and girls and their position within families and society. We have to analyse the upbringing of girls vis-a-vis that of boys. Are they brought up with a sense of self-worth and confidence, or taught to be docile, submissive and subservient? The differences in the ways boys and girls are raised determine their personality in adulthood. Society still perpetuates genderdefined roles for boys and girls, creating an imbalance and discrimination from childhood. Patriarchy negatively impacts men too, who face pressure to be the main bread-earners and take on all familial responsibilities. Thus, they showcase traits such as dominance, arrogance and aggression. Women, on the other hand, are not taught to rebel, take charge or protest, leaving them with lower levels of self-worth and confidence. That is why feminist discourse is around redefining masculinity/femininity and unpacking patriarchy.

There is also a need to review existing laws that often prevent women from getting justice. Women rights activists have been campaigning for changes in archaic laws related to rape. One of them is a certain clause in the Evidence Act, which allows for character evidence to be presented in court. While this law needs to be reviewed in its entirety, this specific clause in particular has been used to denigrate and humiliate women when they are being cross-examined by defence lawyers. Women are often intimidated to the extent that they do not want to continue with the cases

As we look to reduce gender-based violence in the near future, we must also ask the government to take a more proactive stance in preventing child marriage. The progress in this regard was much eroded during the pandemic. There is evidence of

high rates of child marriage using the excuse of income loss and closure of schools. However, child marriage is a symptom of a negative attitude towards girl children, who are thought of as burdens to be sent away at the first opportunity.

Violence is a symptom of a wider issue that revolves around respect and dignity and the status of women and girls in their families. Highlighting their contributions can be an effective strategy to make families aware of the critical role they play in maintaining harmony and well-being of their families. In this regard, Manusher Jonno Foundation (MJF) has launched a national campaign to highlight women and girls' contributions to their families and society, especially in terms of their unrecognised and unpaid care work, with the assumption that this will raise their

status in families and prevent VAWG.

The other important issue to address is the culture of impunity that perpetrators enjoy. It is nearly impossible for the victims of sexual violence, such as rape, to get justice as the conviction rate for such cases is between two to three percent—meaning 97 percent of perpetrators believe that they will get away with it. VAWG thrives in a system where people are not held to account for negligence of duty and where bribes, extortion and misuse of power determine the outcome of cases filed for rape and sexual assault. The MJF conducted an analysis of 20 rape cases in the last five years, and found that, out of 34 accused in these cases, 28 were out on bail (although rape by law is a nonbailable offence) using money, power or loopholes in

At the end of the 16 Days of Activism, we must also turn our attention to review the much-talked-about progress of women (which is without a doubt impressive) and find out who has actually benefited from the development that Bangladesh now enjoys after 50 years of independence. We have to admit that this progress has been partial, as a huge number of women have been left behind. Although VAWG cuts across classes, it is evident that women from low-income groups are more vulnerable to violence both at home and outside. Therefore, the economic independence of women, along with elevating their position within families, is central to the elimination of VAWG. Keeping girls in schools to complete their education, conducting skills training and creating jobs or enterprise opportunities are necessary to this end.

The last day of the 16 Days of Activism falls on Human Rights Day. Why was this day chosen particularly? The reason is to demonstrate that "Women's rights are human rights!"—a slogan used by rights activists globally. Quoting a UN source, "Attaining equality between women and men and eliminating all forms of discrimination against women are fundamental human rights and United Nations values. Women around the world, nevertheless, regularly suffer violations of their human rights throughout their lives, and realising women's human rights has not always been a priority."

Finally, achieving equality between women and men is fundamental to ending discrimination and violence against women and girls. On Human Rights Day, we must reiterate that every woman has the right to a life free from violence, injustice and discrimination. Fifty years after independence, is that too much to ask for?

## The crisis of wastage

**¬** ROM my flat on **⊣** the 5th floor, I could hear a beggar beseech anyone who would care to listen for alms. I had enough cash in the house, and even food, to give him. But going all the way down to the street to meet him was not a plausible

option for me for several reasons. Feeling guilty was the best I could do. His need and my intention were both betrayed by a faulty supply chain.

We have food on our table because, down the line, farmers fared well in fair weather and were able-bodied for labour. Then followed effective collection, storage and transportation, due to which the produce reached the market, and we were able to purchase them. At every step, there was a forward button that ensured that the food reached us within its shelf life. But food cannot always make the right journevs.

Due to ineffective distribution chains, while some of us are feasting—and perhaps shamefully wasting—there are millions who are half-starving, if not fully. Pictures of children searching for food in waste bins have shocked us, but not many of us have been awakened.

Erroneous misconnections between the beginning and literally "the end" has led to about one-third of the world's produced food go to waste. According to The World Counts, approximately 1.3 billion tonnes of food manufactured for human consumption worldwide gets wasted every year. Edible items are lost at every step of the food "life cycle": farming fields, agricultural production, post-harvest handling, storage, processing, distribution, consumption, and end of life. But a lot of it is wasted by us fortunate ones. Keep an eye on the food—or how much it is wasted—at the next wedding you attend. If the surplus of food could be channelled to

the hungry, we would have millions of happy people—mostly mothers and children. And we, too, could be happier.

Every now and then, we come across reallife tragedies that we think we could have avoided. More simply said than done. Every Eid, it is not unusual to read news about how a rickshaw-puller father could not afford a Tk 100 red frock for his daughter. She could not bear the pain and humiliation in the midst of her friends, all agog with new clothes. She then unfortunately took her own life. Our hearts were not ripped by this tragic loss, because we

thought her father had failed her, but she would never know that we did.

Lehengas, wherever that came from, are expensive, going by hundreds of thousands of taka. Sarees are similarly pricey. Modest ones cost several thousands. The red frock that the 10-year-old girl had her eyes on had a price tag of Tk 500. We cannot say "just 500," because that much was now the whole world's worth for her father.

The 12-year-old boy came home to a bed of tattered papers on the pavement beside a busy avenue in the capital. He had a long day,

are that much strong.

We have thousands—nay, hundreds of thousands—of red frocks lying around in our wardrobes, but the supply chain has failed again. Now, each of us wanted to give her an Eid gift, and even more, but she did not want to hang about to be gifted with our pity. She

trying to find some money for himself and his mother. She was finishing up making the bed by dusting off pebbles and dried mud. The boy placed his head into the comfort of an imaginary pillow that many of us do not find in a spring mattress.

have five-bedroom residences, or even larger houses, if you can call them home. What the boy on the street would find really obnoxious are 150-room buildings for a dozen or so occupants. Electricity is not wasted that much, because we have to pay for it. But, you will see a light switched on in the stairwell at 11 am. Switch it off. Water is regularly misused because it is cheap. But, even in this day and age, there are long queues to collect drinking water in our cities and towns. Stop the running tap when you don't need it. Metering has somewhat reduced abuse of cooking gas. The most effective meter is our own conscience.

Okay, unlike almost every other pundit on our LNBT shows, I would not want to complain only. Nor would I want to impose myself with ideas that I did not care to implement when I had the authority to do so. That is a direct reference to some of the retired

government officers, who now say that this kora uchit, and that is a bhoyongkor mistake. On the contrary, I would really urge you to stop and take a hard look at our current living style. The solutions lie in us—what we will do or not do next. We don't have to get down from our fifth floor residence to give alms, but we can try to find more permanent measures to mitigate need and hunger.



#### Innovative Education Ecosystem (IEE) is the key to Realize the Dream of 4IR

Now-a-days, a genome sequence can be acquired by using computing power in a few hours at the cost of less than one thousand dollars, while the first human genome project took 10 years at a cost of 2.5 billion dollars to map the human genome sequence. Therefore, to obtain the faster solution of a problem like this, an interaction between computing and genetic engineering is inevitable, enabling the exploration of new avenues of knowledge. Certainly, an integration between these two disciplines, obtained by this interaction, takes them to the new level of knowledge, and can be termed as evolution. Because of the presence of continuous interaction, integration and the evolution between the entities such a method should become dunamic in nature. The combined result of such an approach, resulting in blurring the difference between biology and computation, which is called convergent. Sensors are now widely used to collect data from the physical world (for instance, agriculture, atmosphere, route network, traffic management and many others), facilitating the development of data analytics/prediction models by using machine learning tools. Therefore, prediction of a phenomenon is becoming cheap and accurate, playing an important role in the decision making process. The integration of the physical world with the computer world is rightly delineated with this example. Such an integration opens a new avenue of knowledge, which was out of the scope of this domain before. The above outlines the appearance of a novel civilization, coined by the interaction and integration among physical, computing and biological worlds through a process of continuous evalution or dynamism over time. Such evolution takes place in the cyber-physical space, which is extensively known as Fourth Industrial Revolution (4IR) or Industry 4.0.

Artificial Intelligence, Robotics, Internet of Things (IoT), Cognitive Computing, Cloud Computing, 5G, Quantum Computing, Biotechnology, and Nanotechnology are at the heart of this 4IR. In the other parts of the world, especially in the Scandinavian countries, they are preparing their manpower to take advantage of 4IR. This is the reason, these countries have integrated Artificial Intelligence and Robotics in their education, starting from primary level to higher education with an objective to prepare the cognitive mind of their human resources to lead the 4IR. The charm of this 4IR is that it is expanding faster than from the other three industrial revolutions and empowering human beings equally.

It took 120 years for the first industrial revolution to get out of Europe, which was powered by steam engines, where the production system was mechanized. 1.2 billion People are still out of electricity until now because of the benefit of the second industrial revolution, which was powered by electricity and led to mass production. Half of the world population is still out of internet access because of the third industrial revolution, which is underpinned by the electronics and information and communication technology, known as digital revolution. However, this is not the case with the Fourth Industrial Revolution (4IR) because in this novel civilization, systems are embedded in society as well as in the human body. We are moving towards a time where we can recognize the presence of ambient intelligence, known as pervasive computing because of the presence of Internet of Things, Robotics, Artificial Intelligence, 5G, Blockchain, cognitive computing and nanotechnology. In this era of skill is important and without this it is difficult for a human People will become rich within a short period if they are equipped with 4IR skills. Hence, the exponential economic growth of a country would be observed as long as the presence of people with 4IR skills are available. For example, 5G technologies will completely change the present business model and hence, the business education should be equipped to cope with

The present computer science education requires a serious shaking because it lives in the third industrial revolution. The same is true for the Electronics and Electrical Engineering education, where the concept of smart grid is emerging, which requires the integration of Al thoughts and nanotechnology. The education of medical science should be equipped with the core subjects of 4IR. This is true in other disciplines such as biological sciences, business sciences, social sciences and arts. In addition, all over the world the optimal utilisation of the university resources remains unutilised, because of the absence of an Innovative Educational Ecosystem (IEE), allowing the linking between industry and academia. As mentioned the core of 4IR is the convergence, which in this case consists of taking advantage of industry and academia linkage. Such convergent is really absent, especially in the higher education system of Bangladesh since our universities are yet to set their mind to change the course curriculum to realise the patential of such an innovative educational ecosystem. Hence, it can be argued that our current education system is not equipped with appropriate research, teaching and learning methods and tools, enabling the realization of the huge potential of 4IR. Certainly, university graduates do not possess the skills to live in the era of 4IR with dignity and dynamism.

The hierarchical organization management structure, which is very much centralized, is replaced by decentralized architecture in the era of 4IR. For example, the water supply system of a town is very much centralised and is unable to solve the water crisis for its inhabitants in a sustainable way. This is true for the traffic management system and this is the reason, no cities in the world are able to solve traffic jams.

The implementation of 'Digital Bangladesh' in the last thirteen years by developing huge information and communication technology (ICT) infrastructure all over the country, almost in every sector as well as in everyday life of the people has created an appropriate platform to kick-off 4IR in our country. Indeed, such realization of 'Digital Bangladesh' is considered as the implementation of the dream of the Father of the Nation Bangabandhu Sheikh Mujibur Rahman. The eminent computer scientist of our time Sajeeb Wazed, Honourable ICT Affairs Advisor to the Prime Minister is considered the architect of 'Digital Bangladesh'. 

## BCL in focus after international debacle

For a long time, there have been media reports, talks and criticism regarding improving the competitiveness in the domestic circuit. The main

agenda, more or less, remains the standard of pitch, or the lack thereof, that ultimately acts as a major factor behind the substandard cricket played in domestic arena.

Following a string of losses in the international arena, the latest being whitewashes in T20I series and a Test series at the hands of Pakistan, coupled with the apparent vacuum in the immediate pipeline of players, it has now become more important than ever to shift the focus back to the development of the cricketing culture and process at the domestic level.

And the Bangladesh Cricket Board (BCB) is seemingly taking steps which are set to be implemented in the upcoming Bangladesh Cricket League (BCL).

"Our aim will be to make four-day cricket attractive again in the country and to also grow players' interests for



playing longer version cricket," BCB chief This, in fact, is only the second time that selector Minhajul Abedin told The Daily Star yesterday. The ninth edition of the franchise-based competition is being planned to start from December 12.

After the usual four-day encounters, all the four teams will also play one-dayers.

one-day matches will be played in the BCL after the edition in 2015.

According to Minhajul, there are plans afoot to make this tournament more competitive and exciting. "Obviously, longer version cricket is now our priority. It

has been for a while. And to make it [BCL] more competitive, we decided to have at least six millimetres of grass and to have bouncy tracks at all the venues," informed Minhajul.

The primary focus of the BCB will be to have bouncy and grassy tracks to encourage the pacers and to enable the batters get used to a more challenging condition.

"We also provided separate instructions to all the coaches and team management. There are also two sides with leg-spinners, so we will be focusing on them as well.

BCL will be played across the country at four different venues - Rajshahi, Chattogram, Dhaka and Sylhet. The first round of the tournament is supposed to begin in Rajshahi and Chattogram while the one-dayers are all set to be played in

Sylhet. Plenty of promises were made regarding the development of pitch and standard of cricket in the domestic arena in the past as well, however, those never materialised. Promises better be materialised this time or else there might be no arresting the slide

Brazilian football legend Pele has been hospitalised for treatment of a previously identified colon tumour, his doctors said Wednesday, the latest health issue for the 81-year-old icon.

The three-time world champion was admitted to Albert Einstein Hospital in Sao Paulo "for followup treatment of the colon tumour identified in September this year," his medical team said in a statement. "The patient is stable, and is expected to be released in the coming days." It did not say when Pele was hospitalised.

Pele underwent surgery for the tumour on September 4, spending a month in the hospital before being released to

continue chemotherapy. The star's public relations agency described the latest hospital stay as routine. "He went in for chemo He always has to go to the hospital for the treatment," it said in a note. "Papi is Great," said Pele's daughter Flavia Kurtz under a photo of him at the hospital after the procedure she posted to Instagram just after 7:00 pm. Her sister Kely Nascimento, who has provided fans with updates on her father's condition, posted the same photo to

Instagram. "This was not a surprise. It was already scheduled and is part of the treatment," she said in the caption. "In two or three days he will be back home to enjoy Christmas."

Considered by many the greatest footballer of all time, Pele has been in poor health in recent years, and has spent a number of stints in the hospital.

## Head pinching himself after Ashes ton



Travis Head blasted the third-fastest century in Ashes history to crush England hopes on the second day of the opening Test at the Gabba on Thursday.

At the close of play a dominant Australia were 343-7, a lead of 196 on England's dismal first-innings total of 147.

Head was on 112, alongside Mitchell Starc, who was notout 10, on another dispiriting day for England in Brisbane. England had threatened a comeback after tea when Ollie Robinson took two wickets in consecutive balls, but Head's aggressive innings put paid to any hopes of a

miracle recovery. The 27-year-old Head, controversially recalled to the Australia side ahead of veteran Usman Khawaja, justified his selection by passing 100 off only 85 balls.

He smashed two sixes and 12 fours in his century -- the third-fastest in the Ashes behind only Adam Gilchrist's 56ball ton in Perth in 2006 and Gilbert Jessop's 76-ball effort at The Oval in 1902.

"I'm still pinching myself -- I can't quite work out what transpired over the past couple of hours," Head said. "I took some chances -- technically and mentally I was really composed, really relaxed," he added. "I found the first 20 runs really tough, but the game opened up and I was able to take the chances, which is pleasing.

Head attacked from the outset and was particularly harsh on spinners Jack Leach and Joe Root, the English skipper. Head came to the crease with Australia 189-3 after Steve Smith edged Mark Wood to keeper Jos Buttler just

He then watched David Warner (94) and Cameron Green depart to Robinson's accurate seamers after the break, with Australia still only 89 runs ahead.

Earlier, Warner rode his luck in the first two sessions The gritty Australian batsman was bowled by a no-ball by Ben Stokes before lunch, then dropped by Rory Burns in the first over after the break, before Haseeb Hameed bungled a simple run-out.

Warner's good fortune began when Stokes bowled him when he was on 17, but the all-rounder had overstepped to give the Australian opener a mighty reprieve.

Television replays showed that Stokes had also

overstepped on the first three balls of his over, but nothing was called. It later transpired that technology issues were at the centre of the no-ball drama.

## Death reference reaches HC

The documents of the sensational Aminbazar six-student murder case reached the High Court as death reference in order to examine the trial court verdict that sentenced 13 accused to death in the case.

A Dhaka court on December 2 sentenced 13 people to death and 19 others to life imprisonment for killing six students in Aminbazar, on the outskirts of the capital, more than 10 years ago, an incident that shook the nation. Twenty-five others were acquitted as their involvement

in the killings was not proven.

In the early hours of Shab-e-Barat on July 18, 2011, a mob of villagers killed the six youths near Aminbazar bridge and took their bodies more than half a kilometre

away to Keblarchar on the instructions of police.

They then called other villagers and said they caught

Later, Al Amin -- the only survivor among the students -- was cleared of charges after police found that the victims were not robbers.

## HC commutes jail sentence of BNP MP Harun

"A person shall be disqualified for election as, or for being, a member of Parliament who has been, on conviction for a criminal offence involving moral turpitude, sentenced to imprisonment for a term of not less than two years, unless a period of five years has elapsed since his release," according to the article 66 (2) of the constitution.

KISSINGER'S MESSAGE TO FARLAND

In a backchannel message, Henry Kissinger, the US president's Assistant for national security affairs,

informed US Ambassador to Pakistan Joseph Farland, "We are making strongest démarche to Soviets today which proposes that they join with us in supporting provisos: (a) India and Pakistan should agree to an immediate ceasefire with the separate armed forces "standing fast"; and that the United Nations or other international organization provide observers to see that the ceasefire is effective; (b) that India and Pakistan "at any effective level" immediately open negotiations aimed at a settlement of the war and troop withdrawal; and coincident therewith negotiations be started looking towards the political satisfaction of Bengali aspirations; i.e., a political settlement."

Kissinger asked Farland to discuss the provisos with Pakistan President Yahya Khan and added, "You should emphasize that the president [Nixon] has made the strongest démarche to the Soviets and included warning to them that we have obligations towards Pakistan which will not permit aggression against West Pakistan. The president added that should Indian offensive be launched in the West, with Soviet acquiescence, a US/Soviet confrontation would ensue."

Later, on the same day, after having a discussion with Yahya, Farland informed Kissinger that the Pakistan president "bought" the original proposal as delivered. He, however, added that Yahya
