

The Institute of Chartered Accountants of Bangladesh is proud to organize 21st ICAB National Award for Best Presented Annual Reports

Today's Ceremony celebrates the occasion of the declaration of the awards in following 4 categories: (ii) Best Presented Annual Reports (ii) Corporate Governance (iii). Integrated Reporting and (iv) Overall Winner. For Best Presented Annual Reports Awards participating entities are divided into 13 groups, i.e., (i). Public Banks, (ii) Private Banks, (iii). Financial Services, (iv). Manufacturing, (iv). Insurance, (iv). Service, (ivi). Communication and Information Technology, (viii) NGOs (ix). Agriculture, (x). Public Sector, (xi). Diversified Holdings, (xii). Power and Energy and (xiii). Infrastructure and Construction. The participating entities are evaluated and awarded for their disclosures in the annual

2020 as a distinctly glorious event to promote transparency and accountability through the financial and non-financial disclosures in the

Energy and (xiii). Immade an advantage of the participant of entires are evaluated and wantee for their describers in the annual reports on Corporate Governance and Integrated Reporting as well. Besides, recognizing 1st, 2nd and 3rd positions in each category, entities which achieved a minimum threshold of scores are awarded the "Certificate of Merit." Overall winner has been selected from the winners which achieved maximum awards and scored highest point by assigning 3 for first, 2 for 2nd and 1 for 3rd position. The Annual Reports of these organizations have been evaluated following the criteria formulated by the South Asian Federation of Accountants (SAFA) which judges the compliance of the entities in respect of adequate disclosures and meaningful reports on transparency, accountability & integrity; thus ensuring good governance in the financial activities, operations and management of these entities. It also

brings a greater sense of responsibility among the management of these entities towards safeguarding the interest of the stakeholders. The evaluations are subject to stringent vetting procedures of a seven-member Jury Board drawn out from amongst the eminent personalities of the country. They reviewed the whole process of the evaluations and nominations of the winners. It may be mentioned here that this year's entire evaluation processes were carried out using the software developed by ICAB for this purpose. During the year, RCPAR received annual reports from 72 entities. Award for Infrastructure and construction category could not be considered because of scoring lesser than threshold marks by the participating entities. Therefore, this year Best Presented Annual Reports awards are given to 24(twenty-four) number of entities under 13 sectors. Also 5(five) number of entities are given award for Corporate Governance and 3(three) number of entities are given for Integrated Reporting category. Finally, 01(one) entity has been selected as an 'overall winner' being the best performer in three categories.

Thus, the awards are the outcome of the evaluation of the publicly disclosed audited financials and un-audited other information and

therefore do not in any way represent any attestation by the ICAB for the operational performance, financial position, liquidity, capital adequacy or earning status of the evaluated entities. The Awards should not be construed to reflect upon future financial health or profitability of the awarded entities and for making any decision for investment, lending or otherwise. On behalf of the RCPAR of the Council of ICAB, as well as on my own behalf, I take this opportunity to convey my heartiest "congratulations" to the winners and my sincere "felicitations" to all participating entities, in the different categories, which have made these Awards competition challenging and meaningful. My deep gratitude to each member of the Jury Board for their valuable contribution. My

special gratitude to the respected Chairman who contributed immensely through his wise wisdom and guidance to make the adjudication process blemish free even from the public perception point of view.
