Half fare, but on condition

Govt issues gazette notification; students term it unrealistic

Amid raging protests, the government has issued gazette notification regarding the demand for half fare for students for "city service" buses in all metropolitan areas.

On Sunday, transport and bridges ministry issued notification with five conditions, saying it was issued in light of the decision of Bangladesh Road Transport Owners Association to agree to students' demands.

They announced it on December 5 at a press briefing at Chattogram Press Club.

The half-fare system will be valid between 7:00am and 8:00pm in metropolitan cities, where "city services" are available, the notification said. To avail the reduced fare, students will have to show valid ID cards of their institutions. However, the fare will not be applicable on government and weekly holidays, according to the notification.

Half fares will also not be applicable for long-haul buses, it added. The notification further said the revamped fares will be considered effective from December 1 in Dhaka metropolitan and from December

Speakers express concern over plight of female migrant workers

Despite an increase in numbers, Bangladeshi female migrant workers still face multiple challenges, including sexual violence at workplaces, humiliation from their families and social stigma for working as domestic workers abroad, said speakers at an event yesterday.

They also face obstacles in immigration due to lack of proper information about agencies, coercion of brokers, inadequate language skills and lack of skill-based training.

The event titled "National Consultation on Women Migrant Workers' Rights and Dignity' was organised by Karmojibi Nari, Shobujer Ovijan Foundation and WARBE Development Foundation at the capital's Cirdap International Conference Center.

"Female migrants feel completely isolated since their very first step abroad, because they don't have any

Bir Shreshtha Captain Mohiuddin Jahangir sacrificed his life for the freedom of his

On December 14, 1971, just two days before victory arrived, he led a group of Mukti Bahini fighters of Sector-7 and launched an attack on Chapainawabganj town from Rehaichar area, beside Mahananda river.

That battle was unique, in that it was conducted entirely by civilians, said Bazlur Rashid Sonu, who took part in the battle. Fifty years on, he retold the story to The Daily

"When I joined the Liberation War in April 1971, I was still only a 10th-grader."

"After it was decided that I was going to get trained to join the war, I made it to West Bengal's Maldah town through the Telkupi border from my native Kalupur village in Chapainawabganj's Shibganj upazila.

"After spending a month at a training camp in Shiliguri, I was sent to Dinajpur's Balurghat in May, from where I was sent to Mohodipur camp. This is where I met Mohiuddin Jahangir for the first time."

As a fighter and commander, he was very isciplined, loval and committed to liberate the

With each passing day, the number of dengue patients in the port city has been increasing across different government and private hospitals in the current month.

Over the past few years, the period between March and September always saw the highest number of dengue patients. However, the scenario seems to have changed this year.

Just this month, a total of 56 patients were admitted to different hospitals till December 12. Of them, 23 were admitted to Chattogram Medical College Hospital. Alarmingly, 17 of them

were admitted last Monday. Contacted, Brig Gen SM Humayun Kabir, director of the hospital, said they have introduced a dedicated corner for dengue patients due to the rise in their numbers

Conjoined Twins **DMCH** postpones surgery

Due to complications involving their reproductive organs, doctors at Dhaka Medical College Hospital (DMCH) have postponed the surgery to separate two year-old conjoined twins Labiba and Lamisa.

"We will wait 6-8 weeks to start the surgery again. We plan to complete it on time," Prof Dr Asraf Ul Haque, head of paediatric surgery at DMCH who leads the 32-member surgery team, told The Daily Star.

Surgeons started the surgery at 8:00am and continued till 12:30pm, but stopped after a tissue expansion.

Hailing from Nilphamari, the conjoined twins were admitted to the hospital on September 28 last year. Since then, they have been preparing

Jail super, jailer sued over torture

Court orders CID to investigate

Chattogram Central Jail's superintendent, jailer and three other staffers were sued yesterday over allegedly torturing an inmate inside the jail.

Parvin Akhter Hira, wife of convicted accused Md Shamim, filed the case with the court of Chattogram Metropolitan Session Judge Sheikh Ashfaqur Rahman under the Torture and Custodial Death (Prevention) Act 2013, said court sources.

The accused are senior jail super Md Shafiqul Islam, iailer Dewan Md Tarikul Islam, deputy jailer Md Saimur, prison guard Sabuj Das, and Subedar Emdad Hossen.

Advocate Fakhruddin Chowdhury, public prosecutor of the court, said it has recorded the complainant's statement and taken the case into cognisance.

The court has also ordered Criminal Investigation Department to investigate the case and submit the report. According to the case statement, Md Shamim was convicted by a court in a case in 2004. He has been behind the bar ever since.

In the case statement, his wife alleged that the five accused tortured him inside the jail on various occasions. On July 17, 2021, the accused tortured Shamim after tying him to a mango tree and later shifted him from

Chattogram to Cumilla Jail. The case statement said Shamim's wife got to know about the incidents after meeting him at Chattogram Court building premises on November 11.
