Now landlessness bars Barguna youth's police job

Family seeks the intervention of the prime minister

After Barishal's Aspia Islam was barred from joining as a police constable, despite passing the written, viva, and health tests, due to being "landless", this time uncertainty looms over Barguna youth Sajal's getting the job for the same reason.

The issue of landlessness stands in the way of Sajal Chandra Karmakar's finally getting selected for the post of Trainee Recruit Constable (TRC).

Sajal hails from Hosnabad village in Betagi upazila of Barguna.

Although Sajal's father Amal Chandra Karmakar claimed to be landless, the police said that Sajal had hidden the information. The family is now passing their days amid uncertainty over Sajal's getting

According to police and family sources, Sajal Chandra Karmakar alias Antar applied for the post of TRC. On November 14, the physical fitness test was held at the Barguna Police Lines, which he successfully passed and likewise, he also passed the written test, viva-voce and psychological test held on November 17 and 24 respectively.

"Although I passed all the steps, I was not appointed. After the general medical examination and fingerprint impression at Barguna District Police Lines on November 25, I also underwent a medical examination at Rajarbagh Police Lines Hospital in Dhaka on the morning of December 4. Then the police verification started. Betagi police station and DSB

came to inspect my rented house. I

submitted my landless certificate to

them," Sajal said. "Later, I went to the office of Barguna Police Super but I couldn't meet him," he said, adding that, "The additional SP told me that even if you are alright, we can't give you the job because you don't have a permanent

Barguna Additional SP Moharram Hossain said, Sajal's ancestral home is in Laukathi village under Patuakhali Sadar upazila but they live in Betagi.



Although Sajal stood fourth in the merit list for the post of Trainee Recruit Constable (TRC), the issue of landlessness has blurred the possibility of his getting the job.

They did not give that information in the application form. He could have applied from Patuakhali but he did not. Meanwhile, Sajal's father Amal Karmakar said that the current and permanent address of all their family members is in Betagi, Barguna. Their national identity card, birth registration all are in Betagi so they have applied from here.

However, Barguna Additional Superintendent of Police (Sadar Circle) Mehedi Hasan gave a different statement. He said Sajal stood fourth on the merit list. To be recruited in the police, you have to be a permanent resident of the district. Just having a birth certificate or NID is not adequate. He will need a permanent address, which Sajal doesn't have. His uncle and father have some land in Patuakhali. If he had applied from Patuakhali district, there would have been no problem.

Barguna SP Jahangir Hossain Mallik said, "We can't do anything because they don't have permanent

Barguna Deputy Commissioner (DC) Habibur Rahman told this correspondent, "I heard the matter through you. I assure you that the district administration will look into the matter of their not having land." Sajal's father Amal Karmakar said,

"I have been living in Barguna since 1992. My children were also born here. There is an ancestral home in the name of my father in the village of Laukathi in Patuakhali district, but there may be half a decimal of the land in my name. There is no land in my name anywhere. I informed the matter to the police during the investigation. I am drawing the attention of the prime minister so that she also salvages my son like Barishal's Aspia.'

Police yet to arrest accused husband

Though seven months have already elapsed, police have made no progress in arresting the accused killer of Tangail District Cultural Officer Khandakar Redwana Islam.

Slain Redwana's husband Delwar Hossain Mizan, the only accused of the sensational murder case, is still at large due to unknown reason.

Mirzapur police recovered the body of Redwana, who gave birth to a daughter at Kumudini Hospital on March 22, from inside a cabin of the hospital on March 27 this year.

The following day, victim's younger brother Khandakar Arshadul Abid filed a murder case with Mirzapur Police Station accusing Redwana's husband Mizan.

According to the case statement, Mizan used to torture Redwana both physically and mentally for dowry since their marriage two years before the murder.

However, relatives of both were acknowledged over their conjugal life.

As a sequel, Mizan first suffocated

Redwana with a pillow and then strangled her with a scarf at a cabin of Kumudini Hospital, five days after she gave birth to

Besides, accused Mizan, 38, son of Mohammad Elahi Mollah of Charbhangaria village in Pabna's Hemayetpur upazila, was serving at Social Islami Bank in Bhola Sadar upazila branch, while his wife Redwana, 34, daughter of Khandakar Rafiqul Islam of Islampur village in Rangpur Sadar upazila, was district cultural officer at Tangail Zila Shilpakala Academy.

Abid, plaintiff of the case, said they are getting frustrated as police are seem reluctant to yet to arrest his sister's killer even after seven months of the brutal

Officer in Charge of Mirzapur Police Station Rizaul Haque said not only they, but Rapid Action Battalion and other law enforcing agencies are also trying to arrest Mizan.

The authority concerned has issued an order to hand over the investigation of the case to Police Bureau of Investigation (PBI) recently, he added.

Infant drowns in water bucket

A 10-month-old child drowned in a bucket of water while playing at her house in Islampur area of Chapainawabganj town yesterday.

The deceased was identified as Shirin. daughter of Mohammad Saddam of the village in Sadar upazila of the district.

Quoting the deceased's family members, Officer in Charge (OC) of Sadar Model Police Station Mozaffar Hossain said, at one stage of playing, the infant girl crawled to near a bucket full of water kept at the house yard and fell on it around 8:30am.

Family members rescued the kid and took her to a hospital, where the doctors declared her dead, he said.

A senior official the Economic Relations Division acknowledged receiving a letter on the time extension.

creativity and observation skills [on the part of] the artists who made them," he said. "Also [of] abstract thinking, as they were not able to see the dhow (a traditional ship) from above.'

There are about 12 notable petroglyph sites in Qatar, located mostly along the country's coasts though some carvings can even be seen in the heart of Doha's Al Bidda Par, overlooking the Corniche, a popular waterfront promenade.

Al Jassasiya, about an hour north of Qatar's ubermodern capital and near the old pearling port of Al Huwaila, was discovered in 1957. Over six weeks in late 1973 and early 1974, a Danish team led by archaeologist Holger Kapel and his son Hans Kapel undertook a study which painstakingly cataloged the entire site in photographs and drawings.

Of all the documented single figures and compositions, more than a third consist of cup marks in various configurations, shapes and sizes.

The most prominent pattern involves two parallel rows of seven holes, leading some to believe that these were used to play mancala, a board game popular in many parts of the world since antiquity in which two contestants drop odd and even numbers of small stones into the depressions.

Others have disputed this theory, pointing to the fact that some of the holes at Al Jassasiya are too small to hold any of the stones, while others can be found on slopes -- an impractical choice that would have resulted in the counters falling out.

Further suggestions include the cup formations being used in some way for divination; or for the sorting and storage of pearls; or as systems to compute the time and tides

"We had conducted several drives in aircraft and recovered a huge quantity of gold bars abandoned in toilet, galley and some other parts of the plane. Such smuggling is not possible without the involvement of aircraft staffers," he told The Daily Star.

Contacted, Tahera Khandaker, general manager of public relations at Biman Bangladesh Airlines, said the flag carrier is yet to receive any information about the incident.

The customs officials should be able to determine how the gold bars entered the aircraft and who were involved in the incident. "If they complain to us naming specific

Biman employees, we will suspend them." Moreover, if someone is arrested by the customs or the police for committing such an offence, action is taken based on the final investigation reports of the agencies,

she added. Between January 2015 and October this year, 3,681 abandoned gold bars weighing about 438 kg have been recovered from flights of different carriers, according to Chittagong airport customs officials.

The biggest haul of gold bars at Chattogram airport was reported on April 8, 2019, when CIID seized 200 gold bars worth about Tk 12 crore from the galleys of a Biman aircraft coming from Abu Dhabi.

In April 2019, the commissioner of the Chattogram Custom House sent a letter to the National Board of Revenue asking it to identify the main culprits behind such smuggling. However, the authorities failed

Custom House and CIID in a joint drive to identify anyone. Fertiliser plenty, yet prices high

And yet, farmers, who were already struggling following the recent hike in diesel price, continue to bear the brunt of the situation.

"Dealers and retailers have hiked the prices cashing in on the current situation," said Aminur Rashid, a farmer in Sirajganj's Belkuchi upazila. Farmer Mohammad Nazim from

Chuadanga's Damurhuda upazila told The Daily Star that he needs at least 40 sacks of non-urea fertiliser a season to cultivate corn, bananas, cotton and rice. Recently, he bought 10 sacks of TSP from

a dealer for Tk 1,700 each, instead of Tk 1,100 fixed by the government. "I asked the dealer about the price hike and he replied that they have a supply

crisis," he said. Azizur Rahman, a farmer in Dinajpur Sadar's Gopalganj Hat area, said he went to the market two weeks ago to buy MOP but

did not find any. One dealer in the district said the government allotment could not fulfil the local demand. So, they had to buy fertiliser

from outside and hence the higher prices. Wishing not to be named, a dealer in the district said they were facing a supply crisis and that led to the price hike. They bought fertiliser from importers at higher prices, due to which they are not able to follow the government rates, he added.

Asked, Md Asadullah, director-general of the Department of Agriculture Extension, said there is no crisis of any fertiliser in the country at the moment.

"As the prices are going up in the international market, some dealers and retailers might try to manipulate them. However, we are conducting mobile court drives to stop the illegal practice. If we find any specific complaints against any dealers, we will cancel their dealership," he added.

At present, only the most widely-used fertiliser urea, which is applied to the fields following the cultivation of crops and vegetables, is selling at the government fixed rate of Tk 800 for a 50 kg sack.

US Senate confirms Emanuel as envoy to Japan
