Plastic menace worsening

Bangladesh's plastic consumption in urban areas tripled in the 15 years to 2020, found a World Bank study, in what can be viewed as a setback for the government's efforts to beat plastic pollution.

A large part of the plastic waste is dumped in water bodies and rivers, said the report titled "Towards a Multisectoral Action Plan for Sustainable Plastic Management in Bangladesh", which was unveiled yesterday.

Of the 977,000 tons of plastic consumed in 2020, only 31 percent were recycled, according to the report. The rest were mismanaged, ending up in landfills, rivers and canals, and drains and unserved areas.

The unmanaged plastic waste can seriously pollute the environment and have far-reaching consequences on human health," Abu Hasnat Md Maqsood Sinha, a consultant for the report and executive director of Waste Concern, told The Daily Star.

The plastic waste mixes into the ecosystem -- into the soil, water bodies, air and food chain, he said.

"With rapid growth and urbanisation, Bangladesh faced a sharp increase in both plastic use and pollution," said Dandan Chen, acting country director of the WB.

And the pandemic has worsened plastic pollution, especially from single-use plastic used in masks, gloves and personal protective equipment,

In 2020, the country's annual per capita plastic consumption in urban areas stood at 9 kg, up from 3 kg in 2005, according to the report.

"The average per capita plastic consumption in European countries is more than 100 kg -- much higher than in Bangladesh. But Bangladesh is one of the top plastic polluted countries due to mismanagement of plastic waste," said Bushra Nishat, environmental specialist of the World Bank, while presenting the report at the event.

The problem is worse in Dhaka city, where plastic usage is significantly higher than the national average.

In 2020, the per capita plastic consumption in Dhaka stood at 24 kg, up from 9.2 kg in 2005.

About 646 tons of plastic waste is generated daily in Dhaka, which is 10 percent of all wastes generated in Bangladesh. Only 37.2 percent of the plastic waste in Dhaka is recycled

In this circumstance, sustainable management of plastic will be crucial for Bangladesh to tackle the increasing plastic pollution and ensure green SEE PAGE 2 COL 3

The government is procuring around 20 million Covid-19 vaccine doses from China, using funds given by the Asian Development Bank, under bilateral arrangements.

The vaccines, manufactured by Chinese state-owned company Sinopharm, would start arriving in the country from early next year, said finance ministry officials.

To buy the doses, the government will use the remaining funds from the loan it had gotten from ADB, they said.

The Manila-based multilateral lender has already disbursed \$894 million of the \$940 million pledged for vaccine purchase as part of its "\$9 billion Asia Pacific Vaccine Access Facility" launched in December last year. SEE PAGE 2 COL 3

US declares \$5m reward

Information on Avijit's Killers

US State Department yesterday announced a \$5 million reward for information on the killing of Avijit Roy and the concurrent attack on his wife Rafida Ahmed Bonya in Dhaka in February 2015.

The Rewards Justice Programme counterterrorism (RFJ), the rewards programme of the department's Diplomatic Security Service, made the announcement in a statement

vesterday. On February 26, 2015, the Bangladesh-born US citizens were visiting Dhaka to attend Amar Ekushey Boi Mela when unidentified assailants attacked them with machetes.

Avijit was killed and Bonya survived with critical injuries. As an author, blogger, and activist, Avijit challenged fundamentalism in Bangladesh by advocating for freedom of expression. He coordinated international protests to raise awareness of the plight of imprisoned bloggers in Bangladesh and was a well-known critic of social

repression, the RFJ said. He was targeted and killed for his outspoken beliefs and activism.

The Ansarullah Bangla Team, a Bangladeshi militant group that claimed responsibility for the attack, seeks to radicalise youths to kill those deemed by it to be "anti-Islamic". Those responsible for the attack are believed to be in Bangladesh, the RFJ added.





Omicron raging through world

Warns Fauci, says traveling increases risk of infection among vaccinated people

US pandemic advisor Anthony Fauci Sunday warned of a bleak winter ahead as the Omicron coronavirus spurs a new wave of infections sparking and concerns



(Omicron's) extraordinary capability of spreading," Fauci told NBC News. "It is just... raging through the world."

Traveling will increase the risk of infection even among vaccinated people, he said.

Since it was first reported in South Africa in November, Omicron has been identified in dozens of countries, prompting many to reimpose travel restrictions and other measures.

Despite indications it is not more severe than the Delta variant -- currently still the dominant strain -- the heavily mutated Omicron has been shown in early data to have a worrying resistance to vaccines and higher transmissibility.

Fauci also cautioned against too much optimism over Omicron's severity, noting that in South Africa, while the hospitalization-to-case ratio is lower than with Delta, this could be due to underlying immunity from widespread previous infections.

"No matter how you look at it," he said, "when you have so many, many infections, even if it is less severe, that overcomes this slight to moderate diminution in severity.

"Our hospitals, if things look like they're looking now in the next week or two, are going to be very stressed," particularly in areas of the country with low levels of vaccination, Fauci

On Sunday, US Senators Elizabeth Warren and Cory Booker each said separately on Twitter that they had tested positive for Covid-19 despite being vaccinated and boosted, and were experiencing mild symptoms.

Neither indicated whether they had been infected with Omicron.

urged unvaccinated Americans to get a shot and the vaccinated to get boosters, which have been shown to reup protection.

TOUGH FEW WEEKS

The administration of President Joe Biden, who is due to address the nation on pandemic developments today, has been campaigning hard for vaccination.

While a little more than 70 percent of the US population has had at least one shot, according to the Centers for Disease Control and Prevention, another 50 million eligible people remain unprotected, Fauci said.

"With Omicron... it is going to be a tough few weeks to months as we get deeper into the winter," he added.

Omicron now accounts for around three percent of cases in the United States, a figure that is expected to rise rapidly as has been seen in other countries.

On Saturday, New York state announced a record number of daily cases for the second day in a row, with almost 22,000 positive results.

Meanwhile, Europe's medicines watchdog yesterday approved a Covid jab by US-based Novavax, which uses a more conventional technology that the biotech firm hopes will reduce vaccine hesitancy.

The protein-based vaccine of the kind used around the world to protect against many childhood illnesses is the fifth coronavirus shot authorised for use in the European Union.

"EMA has recommended granting a conditional marketing authorisation for Novavax's Covid-19 vaccine Nuvaxovid to prevent Covid-19 in people from 18 years of age," the European Medicines Agency said in a

growth, the report said. While Bangladesh has taken steps in curbing plastic pollution over the

years, the outcomes were varied. For instance, in 2002, Bangladesh was the world's first country to ban plastic shopping bags.

However, after some time, plastic pollution increased again.

The Jute Packaging Act 2010 for six essential items (paddy, rice, wheat, maize, fertiliser, sugar) promoted an alternative to plastic packaging. In 2020, a High Court directed

concerned authorities to ban singleuse plastic in coastal areas and all hotels and motels across the country. And yet, plastic pollution prevails. The National Action Plan for

Sustainable Plastic Management has set a target of recycling 50 percent of plastics by 2025, phasing out targeted single-use plastic by 90 percent by 2026, and reducing plastic waste generation by 30 percent by 2030 from 2020/21 baseline.

The plan, which is aligned with the eighth five-year plan, focuses on the circular use of plastic based on the 3R strategy: reduce, reuse and recycle.

A circular economy will help create new value chains, green skills, employment, and innovative products while addressing social and environmental challenges, the report concluded.

To implement the National Action Plan, commitment from all stakeholders, including citizens, the government, private sector, development partners and citizens will be important, said Eun Joo Allison Yi, senior environment specialist at the WB, and co-author of the report.

To implement the action plan, the report identified policy reforms, infrastructure, technologies, investment and institutional capacitybuilding needs.

The report, which was prepared in collaboration with the Department of

Environment and ProBlue, a multidonor trust fund, provided a blueprint for managing plastic pollution over the short-term (2022-2023), mediumterm (2024-2026) and the long-term (2027-2030).

"Going forward, sustainable plastic management -- from designing a product to minimising plastic use, to recycling -- will be critical to ensure green growth for the country. We commend the government's commitment to implement a National Action Plan to beat plastic pollution," Chen said.

Speaking as chief guest, Md. Shahab Uddin, minister of forest, environment and climate change, stressed the enforcement of the law to reduce plastic pollution.

"The government wants to implement the 3R strategy through social inclusion. We have to encourage people to reduce the use of plastics,

Of the amount, the finance ministry used \$741 to buy 105 million vaccine doses from two Chinese drugmakers under the global arrangement -- Covid-19 Vaccines Global Access (Covax) facility.

Fear of syndicates still remains

Recruiters say over reopening Malaysian labour market

STAFF CORRESPONDENT

After the Malaysian labour market reopened for Bangladeshi workers on Sunday, recruiting agencies yesterday voiced concern over the re-emergence of syndicates to send workers to Malaysia, a factor that led to corruption and closure of the market in the past.

The labour market reopened following signing of a memorandum of understanding (MoU) between the two countries in Kuala Lumpur.

However, organisations of recruiting agencies expressed their aforementioned concern, saying that they are still uncertain over how to send workers to the reopened market.

Fakhrul Islam, former finance secretary of Bangladesh Association of International Recruiting Agencies (Baira), told this newspaper that none of the governments have publicised the details of the MoU yet. They have concerns over whether there are any clauses on the document that may facilitate syndicates.

Meanwhile, welcoming the signing, recruiting agencies under the banner "Sammilita Ganotantrik Jote" organised a press conference at the capital's Dhaka Reporters Unity

Addressing the conference, Monsur Ahmed Kalam, former secretary general of Baira, said they are yet to know about the procedure regarding their scope to send workers to Malaysia.

Baira member and lawmaker Lt Gen (retd) Masud Uddin Chowdhury said they might have to stage a protest, if the procedure does not fulfil their expectation.

Welcoming the MoU signing, another platform, "Owners of General Recruiting Agencies", organised a views-exchange programme on opening the labour market for licensed agencies at a city hotel on Sunday evening.

Tipu Sultan, president of Recruiting Agencies Oikya Parishad, who addressed the session, said although the government reiterated that there will be no syndicates, fear

Democracy, free press vital for peace

Dictatorship is a dangerous way of rule. It can demolish a country and poses risks for more conflict, said Turkish writer and journalist Ahmet Coskunaydin.

"If a country is living under a dictator or a president of that kind of system, it is very dangerous. If a country has democracy and free press, waging a war is not that easy," said Coskunaydin, a member of Global Journalism Council based in Turkey.

...we have seen this in Libya and Iraq. They [dictators] demolished their own countries and their systems," he

Coskunaydin, who wrote a book on Prime Minister Sheikh Hasina in Turkish, visited Bangladesh recently. The book is expected to hit the shelves

He was invited as a speaker at the World Peace Conference, organised by the foreign ministry in Dhaka on December 4-5.

Peace activists and a number of former heads of governments from 50 countries spoke at the conference, organised as part of "Mujib Year" and golden jubilee of the country's independence. It also marked the celebration of five decades of Bangladesh's peace-centric diplomacy.

In a conversation with The Daily Star, Coskunaydin lauded Bangladesh

for its socio-economic growth and for sheltering more than a million Rohingyas, who had fled brutal military atrocities in Myanmar's Rakhine State.

He said he is a great admirer of Bangabandhu Sheikh Mujibur Rahman, who advocated for social justice, freedom, democracy and peace with neighbours and all other countries, which he observed is similar to the values of Turkish founding father Kemal Ataturk.

The fact that Bangladesh organised such a global gathering means this country carries the flag for global peace. This has made its responsibilities even greater, he said. "It means you have the willingness to solve global conflict, to realise peace all over the world," Coskunaydin remarked. "Every conflict should be solved over the table through peaceful process."

He said Bangladesh has the commitment to establish peace, and this conference is a testimony to that. However, he said, there should be actions, rather than only words.

He went on to say that it is important to establish peace at home first.

"If your family has problems and fight each other, how can you help the neighbours for peace? Bangladesh... does not have internal problem. It is positive, it is an advantage," the journalist said.

BCL leader, ringleader?

Police suspect after arresting four over yaba trade

STAFF CORRESPONDENT

In the name of going to the beach for picnics, they used to smuggle yaba from Cox's Bazar to Gazipur.

Purchasing the pink tablets at Tk 70 each, they used to sell it in Gazipur for Tk 250. For carrying the consignments, they made a special chamber beneath private cars so that no one would be able to trace the pills even after inspecting the vehicle.

Police's Detective Branch (DB) disclosed the findings following the arrest of four people from the capital's Jatrabari area, with 25,000 yaba pills last Saturday.

The arrestees are Rubel Islam, Rakibul Hasan, Surja Barman Shanto, and Rony Ahmed.

DB is now interrogating the arrestees on a three-day police remand in a case filed with Jatrabari Police Station. Of the arrestees, Rubel is the personal car driver of Mohammad Jahangir Sarkar, organising secretary of Gazipur

district's Chhatra League (BCL) Rubel was also arrested earlier in Dinajpur and is wanted in a

narcotic case filed in the district. Investigators said the arrestees have already admitted to smuggling over two lakh yaba pills from Teknaf in the last three months alone and handing them over to Jahangir. This has lead police to suspect that the BCL leader has been leading the

narcotics syndicate over the years. able to verify the claim, as Jahangir's phone was found switched off when this correspondent tried to contact him. Police said he has been on the run ever since Rubel and his three associates were arrested.

This newspaper also tried to reach Jahangir's father Iqbal Hossain Sarkar, a former member Ward-2 of Tilahati Union Parishad of Gazipur, but he was not at home, while his phone was also found switched off.

deputy Mashiur Rahman,

commissioner of DB Gulshan Division, told The Daily Star that the arrestees had brought yaba consignments from Teknaf to Gazipur through Dhaka several times.

"We have come across some during investigation. Everyone who's found involved will be brought under law," he said.

Mohammad Amir Hossain, inspector of Gazipur district The Daily Star, however, wasn't DB police, said they have come to know Jahangir has several associates to smuggle yaba. "Once the consignments reach Gazipur, he distributes them to different areas.'

Police sources said Jahangir is accused in at least six cases with different police stations in Gazipur and Dhaka under explosives and narcotics acts. He was also found involved in extortion and illegally grabbing property.

Meanwhile, allegations are rife against Jahangir even among his BCL cohorts.

Mahim Sarker, publicity secretary of Sreepur Upazila Chhatra League unit, claimed that last August, Jahangir and his followers took over their generator business for not paying tolls.

Rona Mia, a BCL activist of Gazipur's Mawna, claimed Jahangir and his followers beat his associates for protesting his extortion activities in MC Bazar area.

Regarding the criminal activities, Zahidul Alam Robin, general secretary of Gazipur BCL unit, said they have already sent a letter to central BCL committee, requesting stern action against Jahangir.

SM Shafiullah, superintendent of Gazipur police, said they are investigating the incident and conducting drives to arrest those involved. "No matter their identity or how powerful they are, action will be taken against all those found involved with narcotics trade.'

Stolen from 30ft below sea level!

13 held for stealing construction materials from sunken ship

Chattogram river police early yesterday arrested 13 people for allegedly stealing construction materials of Padma

The materials were stolen from a sunken ship about 30 feet below sea level.

"We seized the engine boat and arrested 13 people from Shahamirpur area of Karnaphuli river, with 4.5 tonnes of galvanised iron angles, which was meant for construction work of Padma Bridge, around 3:10am," said Kritiman Chakma, additional superintendent of river police, Chattogram region.

Two divers were also among the arrestees, said the police official.

"The arrestees confessed that they had stolen the precious iron angles... with the help of some scrap dealers in Chattogram," said Kritiman.

"The contractor has already been able to remove about 45 percent materials from the sinking ship. As the contractor has stopped its work for the last ten days, the gang started stealing the materials" said the ASP.

On July 13, the vessel MV Hang Gang-1, carrying 1,200 metric tonnes of iron angles, capsized in the Bay of Bengal after hitting a sunken lighter vessel near Bhasanchar, the official said.

Ten held in Savar over extortion

Ten people were detained by Rab officials in Savar for extortion, Rakib Mahmud Khan, company commander of Rab-4(CPC-2) confirmed to The Daily Star yesterday.

The detainees were identified as Masud Rana (40); Iqbal Hossen Ratan (42); Md Biplob (30); Pannu Hawladar (34); Md Jahangir (48); Anowar Sheikh (42); Alam Mollah (37); Abdullah Al Helal (20); Shahadat Hossain (30); and Shanchay (30). All of them live in Savar's Ashulia.



Dewchhara Beel: Once full of lives, now a wasteland

Poaching, siltation and abundance of bushes make the water body an inhospitable place for guest birds

Dewchhara beel in Kamalganj upazila of Moulvibazar used to be a sanctuary for thousands of migratory birds and different species of native fish but for the last two years, the water body has not been frequented by the guest birds mainly because of poaching, depletion of water, siltation and abundance of bushes.

During the winter season, different species of native birds, including thousands of guest birds, used to roam here for a long time. But that is not the scene to be seen

Joynal Mia, a resident of the area said, the waterbody used to be buzzing with the chirping of migratory birds at the beginning of winter every year. Although there are many other ponds and open spaces in the vicinity, the migratory birds used to roost in the beel. Sometimes they would fly in the sky in groups, and of the lake filled with water lilies.

He said that the number of birds on the beel has been slowly declining over the last six years. Last two years, the migratory birds have not been coming in the beel and there is hardly any fish here. Lots of native fish were also found in the past. Due to excessive growth of aquatic herbs and depleting water, the waterfowls have stopped coming here, he added.

Muhibur Rahman, a farmer from Dhupatila village near the Dewchhara beel, said, "Thousands of guest birds would flock the waterbody in winter every year. We used to wake up in the morning with the chirping of birds. From the time immemorial, there have been various species of birds including ducks and hawks.'

The quality of water of the beel has exacerbated creating a shortage of food for the bird population. Therefore, the the beel, birds are not coming here.

sometimes they would float in the water birds have stopped coming to the beel, he added.

He also said that some poachers are active with net and poison traps. Some are fishing in the beel violating rules. These have harmed the roosting of guest birds in

He expressed concern saying that many species would be extinct as the hunters are using poison traps.

Nurul Muhaimin Milton, general secretary of Bangladesh Poribesh Sanbadik Samitee of Moulvibazar unit, said that aquatic animals including fish and guest birds are now in dire straits.

The miserable condition of the water body is causing irreparable damage to local agriculture, aquatic life and biodiversity, said Durud Ali, a social worker from Keshuluti

Jubel Ahmed, general secretary of Dakshin Dhupatila Fishermen's Cooperative Society Ltd, said that due to the shortage of water in

"We have long been demanding dredging of the waterbody for the sake of agriculture and fishing," he added.

Kamalganj Upazila Fisheries Officer Siddiqur Rahman said, "I have heard that this place is a wonderful place for birds and fish. The population of birds and fish can be increased by excavating the Dewchhara beel. Proposals have already been sent to the higher authorities for its excavation."

Sylhet Divisional Forest Conservator Rezaul Karim Chowdhury of the Wildlife Management and Nature Conservation Department said, "I will try to take the next step by visiting the place.'

Kamalganj Upazila Nirbahi Officer (UNO) Ashekul Haque said, although the proposal was sent earlier, it is yet to be approved.

"However, I will try to take initiative to increase water supply by renovating the reservoir in Dewchhara through the Upazila Agriculture Department," the UNO assured.

Billah said Dewanganj Municipality Mayor Shah Newaz Shahanshah has been expelled from the party to restore the discipline and image of the ruling party. Earlier around 7:00am on Thursday, Mayor Shahanshah

along with his other employees went to the Shaheed Minar to place floral wreaths when the official was announcing names of different organizations according to the list.

But, the mayor became furious when the name of the municipality came at number five, and locked in an altercation with the officer.

At one stage, the mayor slapped the government official in presence of a huge crowed.

Upazila Secondary Education Officer Md Meher Ullah said he informed Upazila Nirbahi Officer (UNO) Kamrunnahar Shefa of the matter soon after the incident.

Terming the incident unexpected, UNO Kamrunnahar said she immediately informed the Jamalpur deputy commissioner about the incident.

UK's former Brexit minister gives backing to PM

Britain's former Brexit minister, David Frost, yesterday insisted he had not stepped down to mount a leadership challenge against Prime Minister Boris Johnson, and gave his backing to the beleaguered leader. Frost's shock resignation, announced late on Saturday, comes not only at a crucial time in talks with the European Union but also as Johnson's position looks increasingly under threat. But Frost maintained: "I left the government because I couldn't support certain policies," most recently on Covid restrictions. "If you're a minister, you have to support collective responsibility... and I couldn't and that's why I had to leave," he told Sky News outside his London home.

J&K delimitation draft triggers huge row

A major political row has erupted in Jammu and Kashmir over a draft proposal that has suggested six new legislative seats for Jammu and only one for Kashmir in a move that local parties have described as gerrymandering and an attempt to tilt the balance of power towards Jammu. The draft by the union government's Delimitation Commission was distributed among five MPs from Jammu and Kashmir who are associate members of the body during its meeting in New Delhi yesterday and was rejected by all political parties in Kashmir who have termed it biased and unacceptable. National Conference President and MP Farooq Abdullah who attended the meeting confirmed the draft proposal and said that the party will respond to it via a formal communique on December 31.



Chile celebrates as leftist Boric elected president

The streets of Santiago erupted in celebration Sunday after leftist millennial Gabriel Boric became Chile's youngest-ever president-elect with an unexpectedly large victory over his far-right rival in a polarizing race. Boric, 35, garnered nearly 56 percent of the vote compared to 44 percent for ultra-conservative Jose Antonio Kast, who conceded even before the final result was known. Tens of thousands of Chileans took to the streets of the capital and other cities after Kast's concession,

honking car horns in approval, brandishing pro-Boric placards, waving the rainbow LGBTQ flag and shouting: "Viva Chile!" Fireworks lit the skies for hours on end. "I'm thrilled, I am crying with joy. We dealt a blow to fascism!" pharmacy worker Jennie Enriquez, 45, told AFP. "I am happy because there are going to be many changes that will help the people and the working class," added construction worker Luis Astorga, 58.

Europe mulls Christmas curbs

UK reports 12 deaths; Thailand considering reinstating

Britain refused to rule out curbs on gatherings yesterday, a day after the Netherlands imposed a lockdown prompted by the fast-spreading Omicron variant of the coronavirus and as other European nations considered putting a squeeze on Christmas.

Omicron infections multiplying rapidly across Europe, the United States and other parts of the world, doubling every two or three days in London and elsewhere and taking a heavy toll on financial markets which fear the impact on the global economic recovery.

The variant was first detected last month in southern Africa and Hong Kong and so far been reported in at least 89 countries. The severity of illness it causes remains unclear.

Dutch Prime Minister Mark Rutte announced a shutdown on Saturday, ordering the closure of all but essential stores, as well as restaurants, hairdressers, gyms, museums and other public places from Sunday until at least January 14.

Minister Dominic Raab said yesterday, refusing to rule out a tightening of social restrictions before

"I just can't make hard and fast guarantees," he told Times Radio. "In assessing the situation we rely very heavily on the real data coming through and it will take a little bit more time to assess this critical issue of the severity of Omicron."

The German government's scientific advisory panel said in a statement on Sunday it was necessary to further limit contact, with data so far showing that boosters alone would not be enough to contain the spread of

the virus.

The state premier of North Rhine-Westphalia, Hendrik Wuest, did not rule out contact restrictions on people who have been fully vaccinated or had a booster shot, reports Reuters.

UN investigator targeted by spyware THE GUARDIAN ONLINE


The mobile phone of a UN-backed investigator who was examining possible war crimes in Yemen was targeted with spyware made by Israel's NSO Group, a new forensic analysis has revealed.

Kamel Jendoubi, who served as the chairman of the now defunct Group of Eminent Experts in Yemen (GEE) – a panel mandated by the UN to investigate possible war crimes was targeted in August 2019, according to an analysis of his mobile phone by experts at Amnesty International and the Citizen Lab at the University of Toronto.

The targeting is claimed to have occurred just weeks before Jendoubi and his panel of experts released a damning report which concluded that the Saudi-led coalition in the Yemen war had committed "serious violations of international humanitarian law" that could lead to "criminal responsibility for war crimes".

Jendoubi's mobile number also appears on a leaked database at the heart of the Pegasus Project, an investigation into NSO by the Guardian and other media outlets. The leaked list contained numbers of individuals who were believed to have been selected as potential surveillance targets by NSO's government clients.

The data suggests that Jendoubi was selected as a potential surveillance target by Saudi Arabia, which was a longtime client of NSO before it was dropped earlier this year after allegations that it abused the surveillance tool.



That stigma or phobia that is attached that there is something abnormal about them that is something one was trying to stay away from, and create a sense of normalcy. So that people can accept them.

However, the actress added that when she first signed on for the film, she feared how her portrayal would be perceived by members of the transgender community themselves. She did not want it to be a half-baked attempt to play a transgender woman in Hindi cinema.

Let the world share our burden

Strong message from the UN on Rohingya crisis

THE United Nations special rapporteur on the situation of human rights in Myanmar, Tom Andrews, has categorically said that Bangladesh cannot and should not carry the burden of Rohingya refugees alone. Rather, he called for the world community to share the huge responsibility, taking into cognisance the ground reality that the Bangladesh government needs and deserves a stronger international partnership in handling the situation. We feel that he could not have been more discerning when commenting that a stronger commitment of resources is required for the Rohingya refugees and the host communities.

There is no denying that the sooner the world realises that the cause of this crisis and its solution are not in Bangladesh but in Myanmar, the easier it would be to act in the right direction. Bangladesh has done its parts; now it's the world's turn to reciprocate. We are happy to note that the UN special rapporteur has seen the contribution of Bangladesh in this regard, and acknowledged it in the following words, "Bangladesh saved untold numbers of lives when it opened its arms and hearts to (the) Rohingya people who survived these most unspeakable horrors inflicted on them by the Myanmar military. All who value human rights owe Bangladesh a debt of

Since the day Bangladesh opened its borders to the Rohingyas, who are genuine nationals of Myanmar fleeing from the genocide launched by its military, police and armed goons, more than 700,000 of them took shelter on Bangladesh's soil. The immediate burden of providing a roof over their head, food and water fell on Bangladesh's shoulders. The government and the people welcomed these unfortunate people with open arms completely on humanitarian grounds. The Bangladesh government started to address the issue through all available diplomatic channels, including keeping the UN updated on a day-to-day basis. But the Myanmar government remained incommunicado almost on every

As the refugee camps in Cox's Bazar and the surrounding areas became overcrowded with the burgeoning Rohingya population, which began to threaten our environment and law and order situation, the Bangladesh government built shelter homes in Bhashan Char, where about 19,000 refugees have been

Following his visit to the island, the UN emissary expressed his satisfaction at what he saw there and said that he would continue to work with Bangladesh on this major issue. He, however, urged the Bangladesh government to ensure availability of essential services at the new location before relocating more refugees. He welcomed the commitments made in the memorandum of understanding (MoU) between the Bangladesh government and the UN, and urged that they be put into

It is good news that the UN special rapporteur said, before his departure on Sunday, that he would act to push for a stronger, more coordinated international response to this crisis, including exerting pressure on Myanmar and to hold the military junta fully accountable for this crisis. It is also significant that he put emphasis on the safe, sustainable and voluntary return of the Rohingyas to their homeland in Myanmar.

Farmers burdened with high fertiliser prices

Any disruption in the supply chain alongside artificial crisis must be checked

T is most unfortunate that farmers across Bangladesh are being charged exorbitantly for fertilisers by the dealers and retailers, despite the government's claim that there is no crisis of fertilisers in the country. According to a report in this daily on December 19, while a 50kg sack of Triple Super Phosphate (TSP) should sell for Tk 1,100, Diammonium Phosphate (DAP) for Tk 800, and Muriate of Potash (MOP) for Tk 750, as per the government fixed rates, these fertilisers are currently being sold at much higher prices: TSP at Tk 1,400-1,700, DAP at Tk 950-1,050, and MOP at Tk 950-1,000. Only urea, the most widely used fertiliser, is being sold at the government-fixed rate: Tk 800.

While the government keeps saying that there are enough stocks of all these fertilisers in the country, and that a section of unscrupulous dealers and retailers are charging extra citing hiked prices in the international market, the dealers are saying otherwise—that the government's allotments are not enough to meet the local demand, so they have had to import the fertilisers

The authorities may be correct in saying that there are sufficient supplies of fertilisers, but it is also true that farmers are not being able to buy them at the proper rates. And in many cases, there are no supplies in the local markets. According to our report, a farmer in Dinajpur Sadar's Gopalganj Hat area went to the market to buy MOP two weeks ago, but could not due to its unavailability. Clearly, there is a serious lack of market monitoring by the authorities concerned.

In order to ensure a stable supply of fertilisers in the local markets, and to stop unscrupulous businessmen from cashing in on the situation, the authorities must have a strong mechanism to monitor the situation on the ground. Only claiming to have enough supplies will not help the farmers in any way. They are already burdened with high production costs following the fuel price hikes, and the high prices of fertilisers are just too much for them to bear. While regular mobile court drives may be helpful in checking any malpractices by fertiliser dealers and retailers, the authorities must also make sure that the supply chain is not disrupted in any way, which might create a crisis in the market.

Misleading analysis of US sanctions must be avoided

enforcement force, the Rapid Action Battalion (Rab), which has been subjected to a sanction by the US, has now been applauded by the same government

for its role in tackling terrorism, according to some media reports. The 2020 Country Reports on Terrorism, published by the US Department of State on December 16, 2021, which gives an overview of global counterterrorism environment, has reportedly praised Rab for its success in cutting down terror acts in Bangladesh. Some of these Bangladeshi media outlets have also quoted at least two noted experts on international relations saying that this praise proved that the sanctions were not a well-thought-out action, and could have been the result of intense lobbying by some anti-Bangladeshi elements. They argued that these contradictory acts were indicative of a lack of coordination

the Rapid Action Battalion established 'deradicalisation and rehabilitation programmes,' in addition to conducting community policing efforts and investigations and arrests of suspected FTFs." Clearly, this description neither praises nor criticises the Counter-Terrorism and Transnational Crimes unit (CTTCU) of police and Rab.

Before going into continental and country-specific reports in a brief note, under the subhead "The Human Rights Report," it suggests that alleged human rights abuses by security forces may have acted as impediments to counter-terrorism programmes. It says, "In the countries listed below, significant human rights issues influenced the state of terrorist activity in the country and may have impeded effective counterterrorism policies and programmes or supported causes and conditions for further violence. Such human rights issues included, among others, unlawful and arbitrary killings, including extrajudicial killings, forced disappearances, torture, and arbitrary detention (all of the preceding by both government and non-state actors); harsh and life-threatening prison conditions;

When the government seems serious about assessing the likely impacts of the US sanctions and considering possible ways out of any adversarial impact, this kind of misleading analysis may prove harmful. The statements issued by two associations of cadre and noncadre police officers seem quite strange as well, as they spoke about only the seven officials against whom individual sanctions have been slapped, but they

remained silent about the sanctions against Rab. The sanctions against those seven individuals, however, were due to their role in Rab. Collective punishment of a whole unit of a country's security forces is quite rare and, therefore, perhaps has greater significance than any individual or individuals.

In the past, sanctions—either economic or military-were used against a regime and a country. But such sanctions have proven to be less effective without a consensus among major powers and getting the maximum number of countries on board. And in many cases, such sanctions also proved counterproductive as the politicians of those countries subjected to sanctions could rally their population, alleging such punitive actions as collective punishment of a nation, and that victimhood made sustaining such sanctions difficult. Hence, came the tool called Smart Sanctions that are targeted to specific persons and entities, and the Global Magnitsky Act has become the most effective tool for the Western democracies. After the US, Canada and the UK have enacted their own Magnitsky acts; a similar legislation is currently being considered by the European Parliament.

The US sanctions have two components: a) Travel ban by the Department of State; and b) the Department of the Treasury ban involving freezing of assets and restricting all kinds of transactions with the subject(s) of the ban. In this context, the gravity of the sanctions against Rab could not be

overstated. The Treasury announcement says, "As a result of today's actions, all property and interests in property of the persons designated above that are in the United States or in the possession or control of US persons are blocked and must be reported to OFAC (Office of Foreign Assets Control). In addition, any entities that are owned, directly or indirectly, 50 percent or more by one or more blocked persons are also blocked." It is, therefore, quite likely that any security equipment and technology coming to Bangladesh would be falling under additional scrutiny to ensure that the end users are not the subjects of the sanctions. It also makes it almost impossible for global banks having interests in the US to release any assets of Rab they hold or allow any transactions, like paying import bills.

It is still unclear whether these sanctions will have any impact on the UN peacekeeping role of those officers who have or still are serving in Rab. A leading human rights campaign group, the Human Rights Watch (HRW), has long been pushing the US and other Western countries for imposing sanctions against Rab and has also called on the UN to take

Though ministers and politicians have blamed the so-called anti-Bangladeshi elements for the US actions, press reports about the meeting between the foreign secretary and the US ambassador after the latter was summoned at the ministry seems to suggest that Bangladesh's main disappointment was "the unilateral announcement instead of prior consultation." This is a flawed argument as, in October 2020, 10 leading senators in a show of bipartisan unity and urgency wrote to the then secretary of state to impose sanctions on Rab commanders. And again in August this year, the Congress caucus on human rights, the Tom Lantos Human Rights Commission, also heard calls for actions against Rab during a public hearing.

Questioning the moral authority of the US or pointing out their dismal records at home against minority communities may be good for politicking, but lacks any practical solution. Claiming innocence or simple denial after years of allegations of gross human rights violations is not going to result in any exoneration. Therefore, setting up a truly independent and transparent investigation mechanism—perhaps a judicial commission—to probe into the alleged abuses should be considered with urgency. Eight years of negotiations and lobbying to end another exclusion, the suspension of GSP to Bangladesh over workers' rights, have yet to succeed.

The WHO's penny-wise and health-foolish members


T beggars belief, but it's true: In the midst of the Covid-19 crisis, the ■ member states of the World Health Organization (WHO) are still pondering whether, and by how much, they should increase their regular financial contributions to the organisation, whose work continues to save lives within and beyond their borders.

While some may think that the WHO is sufficiently financed, it's the opposite. The WHO's current budget structure cripples and undermines its mandate to act as the world's principal international public-health organisation. Less than 20 percent of the WHO's budget comes from regular fees—"assessed contributions"paid by the member states. The heavy reliance on voluntary contributions by member states and other funders severely hampers the WHO's ability to work on its core activities, leaves it vulnerable to political pressures, and skews its priorities toward individual countries' preferences.

The acute need to support the WHO's critical work to overcome the pandemic

crisis and achieve "Health for All" is self-evident, as is the organisation's indispensable leadership role in health globally. The WHO is the most important global coordination mechanism to prepare for and respond to pandemics and other health threats, providing a vital public good that serves all countries.

It is, therefore, imperative that the member states support the proposals from a WHO working group to reform the organisation's financing, including increasing assessed contributions as a share of its budget from 16 percent to 50

Improving both the quantity and quality of financing for the WHO is a matter of global urgency. Member states waste no time paying lip service to the WHO's relevance. But how well it can deliver is predicated on how well it is financed. And as we note in our work for the WHO Council on the Economics of Health for All, finance is not neutral: the type of finance available affects the allocation and, ultimately, the outcome of

Strengthening the WHO provides the best return on investment for health. Billions are being proposed—such as by the G20 High Level Independent Panel on Financing the Global Commons for

Pandemic Preparedness and Response to set up and finance new global health security institutions that cannot guarantee broad political buy-in, especially from the Global South. There simply is no logical reason why member states should place heavy bets on a new venture that might not gain broad support over investing in their existing organisation, which most certainly can deliver more if funded accordingly.

It is simple: the greatest potential for global health solidarity lies with the WHO. Reliable financing by its owners—the 194 member countries would make all the difference to global health cooperation and demonstrate the effectiveness of multilateral solutions to international challenges

The time to walk the talk is now. Too many member states have long been indifferent to the need to strengthen the WHO or invest in global public health. It should not have been this way before

Covid-19, and it should not continue being this way now, in the middle of the

The hesitancy and reluctance that brought us to this point sharply contrasts with the spirit and determination shown half a century ago, when humans overcame seemingly insurmountable challenges in order to make it to the moon and back. In today's money, President John F Kennedy's moonshot cost a colossal USD 283 billion-without any guarantee of success. Of course, it did succeed, and in the process it catalysed cross-sectoral innovation that, in time, gave the world camera phones, better home insulation, and the modern software industry

In other words, Kennedy's moonshot boosted economic dynamism and growth through mission-oriented innovation. In comparison, the current financing proposal would only cost all 194 WHO member states USD 1.2 billion a year, with the certainty that it would significantly strengthen the organisation's effectiveness. We believe it should actually

Today's moonshot must be "Health for All." Most immediately, that means ensuring that Covid-19 vaccines are accessible globally. But it is not a moonshot for the WHO's member states to finance their own organisation so that it can do its job. That is just common sense: the WHO saves the lives of its member states' people. We already have very affordable, practical, and straightforward solutions for global public health, including financing common goods for health; what we need now is just a fraction of the policymaking ambition we once had.

Understanding a freedom fighter's prison letters



in various **L** torture chambers by the Pakistan Army during Bangladesh's Liberation War in 1971, Mohiuddin Ahmed, MP, wrote

letters to his wife, describing the systemic cruelties of his oppressors. Taken together, these letters paint a granular picture of how traumatic and dehumanising life was inside these wartime black holes.

I had the good fortune of reading Mohiuddin Ahmed's prison letters, carefully archived by his daughter. At one level, these letters simply chronicle a political prisoner's personal anxieties, desperation to see his young family again, and dream to live in a liberated Sonar Bangla. At another level, the letters, written in both Bangla and English, also reveal archetypal mysteries of the human condition in incarceration.

I was particularly struck by one letter written on October 16, 1971. In addition to describing the daily brutalities that were inflicted on freedom fighters and political prisoners, Ahmed lamented not being able to see his infant children. He wrote how his captors threatened to kill his children and bring their severed heads to him in the prison unless he divulged information about the resistance movement, its operation centres, and the whereabouts of its leaders.

Understanding the pain of being locked up within four walls for one's political views is heartbreaking. The then Dhaka Central Jail is now being turned into a museum and an urban park following a national design competition, in which my team from Brac University's Department of Architecture and I were a finalist. As participants in the competition, we had a chance to visit the Dhaka Central Jail in Old Dhaka. In the juvenile section of this iconic prison, a wall writing is forever seared into my mind. An adolescent prisoner etched on the wall, "Ma, jail boro koshto (Mother, jail is so much painful)."

I have always wondered how people manage to stay alive in a cage. How does one endure enforced isolation? Is time infinite inside a prison cell? In "The Shawshank Redemption" (1994), one of the most captivating films about jail life, the protagonist Andy Dufresne stated, "Hope is a good thing, may be the best of the things. And a good thing never dies." Does hope power a prisoner to stay alive? Hope of what? Freedom? A chance of reuniting with family? Is the prison a ghetto of the soul? Are political prisoners the quintessential characters of the modern era, characterised by all sorts of ideological conflicts, ethnic strife, and genocidal hostilities?

Mohiuddin Ahmed's home district was Barishal, an area that remained free from the invading Pakistan Army until April 25, 1971. After a massive blitzkrieg in the last week of April, the marauding Pakistani soldiers occupied the district. Ahmed left for India along with other members of Mukti Bahini. They regrouped in a town at the Indian border called Hasnabad, right across the border from Khulna. In the first week of May, they embarked on a stealthy return journey to southern Bangladesh in two launches filled with arms and ammunition. Besides Ahmed, the resistance leadership in the launch included Major Jalil and Nurul Islam Manju. Escorted by an Indian gunboat up to the border, the two launches entered the Bangladesh territory. When they

came near Paikgachha in Khulna on the Burigowalini River, the launches came under heavy attack from Pakistani gunboats and eventually sank. The group dispersed in different

Mohiuddin Ahmed, along with 19 other comrades, were captured by one Maulana Salam, a local collaborator of the Pakistan Army and a Jamaat leader, who also served as the local secretary to the notorious Peace Committee. In front of the captive Mukti Bahini members, he pontificated that it was the moral responsibility of all Bengali Muslims to support the political unity of both wings of Pakistan, because the country was founded on the theological nationalism of pan-Islamism. Ahmed and others were

declared as the "enemies of Islam," for they opposed the idea of Pakistan and demanded self-rule for Bengalis.

All the prisoners were taken to the Khulna Circuit House and interrogated with different torture methods. Thereafter they were blindfolded, pushed into a truck, and transported to Jashore Cantonment. Ahmed was locked up in the same room where Mashiur Rahman, member of parliament and secretary of Awami League's Jashore unit, had been beaten to death just a few days earlier. His blood stains were still fresh in the room.

A few days later, 17 prisoners, including Mohiuddin Ahmed, were flown to the Dhaka Cantonment in a helicopter. For the next few weeks, all of them suffered extreme

torture, including electric shock, indiscriminate beating, and being hung upside down from the ceiling. Shamshuddin Ahmed, sub-divisional officer from Sirajganj, was tortured to death while the captives watched. His body was left in front of their cells for psychological intimidation.

For the next eight months, Mohiuddin Ahmed's life turned into a veritable hell. Not only did he endure inhuman cruelty, but he also heard nonstop screams of imprisoned Bengali women used as sex slaves. One day, one Major Bashir terrorised a group of prisoners by barking what encapsulated the Pakistan Army's central war project in 1971, "We will make this country a land of prostitutes, a land of slaves, a land of

Ahmed was sent to Dhaka Central Jail in November. His lopsided military trial began on December 6. Under a brief tribunal led by one Colonel Alvi, Mohiuddin Ahmed was formally charged with treason, cooperating with India to disintegrate Pakistan, and aiding Mukti Bahini. On December 9, he was sentenced to

Nelson Mandela survived 27 years in prison. Many times, I tried to imagine prison life using him as a lens. The South African antiapartheid revolutionary, political leader, and philanthropist was held in a tiny, two-metre-by-two-metre cell in Robben Island prison, located in Table Bay north of Cape Town, for 18 years. His prison writings offer an insight into how the human mind may or may not process captivity. He wrote, "... We drew strength and sustenance from the knowledge that we were part of a greater humanity than our jailers could claim... Prison is itself a tremendous education in the need for patience and perseverance. It is, above all, a test of one's commitment." One of the most intriguing aspects of Mandela's dealing with the inhumanities of long incarceration was his ability to be a father. He often wrote letters to his daughters to comfort both them and himself.

Another political prisoner who produced an extraordinary body of political literature in the jail was Antonio Gramsci, one of the founders of the Italian Communist

Party and an anti-fascist activist during the period between the two world wars. Gramsci penned more than 30 "prison notebooks" that covered philosophy, political theory, and the politics of history, among other subjects. He also wrote from the prison approximately 500 letters to friends, supporters, and family members. One could map the evolution and the turmoil of his mind through a scrutiny of these letters and his prison notebooks.

Does writing help mitigate the unbearable claustrophobia of confinement? Mohiuddin Ahmed's prison letters are modest in scope, but they shine a bright light on not only the state of a freedom fighter's mind, but also an illogical war's dehumanising effects on people. He found refuge in writing letters to his wife, who relentlessly tried to secure her husband's release from the prison, despite the constant physical threat she endured herself. As he wrote to his wife, Mohiuddin Ahmed imagined the nature of freedom and justice for his beloved country.

I like to argue that as much as we celebrate macro-histories of 1971, we must also robustly preserve its microhistories—personal narratives, oral histories, prison letters, memories, and diaries—to nurture the spirit of the Liberation War as everyday reckonings.

December 19 was set for Mohiuddin Ahmed's execution. However, three days before his hanging, Pakistan surrendered and Bangladesh was liberated. He got lucky to breathe the fresh air of a liberated country, and went on to serve his country as a member of parliament. As a people's politician all his life, he remained committed to the welfare of his constituency with extraordinary loyalty and honesty.





'If you want to catch someone, then must prepare accordingly'

Bangladesh returned to international hockey after 40 long months through the Men's Asian Champions Trophy hockey tournament but finished with the wooden spoon from their maiden campaign in Asia's top competition after suffering four defeats on the trot. Despite a disappointing yet expected outcome of a last-place finish, Arshad Hossain, the 20-year-old promising forward was inclined to focus on the positive aspects while talking to The Daily Star's Anisur Rahman yesterday.

The Daily Star (DS): How did Bangladesh perform overall in their first-ever Asian Champions Trophy campaign? Arshad Hossain (AH): You know, since all participating teams have been quality sides, both in terms of paper and ranking, I think we had a good campaign and gained much experience overall. In all four matches, we played better than anticipated, considering we stayed out of the international circuit for 40 months. I believe, if we are given more international exposure and necessary facilities to improve in

played international hockey in 2018 Asian Games before taking part in Champions Trophy this time. If you observe India, they are playing international matches regularly. Recently, they even managed to beat Olympic-gold medallist Argentina because of their planning and willingness to improve. If you want us to catch someone, then you must prepare us accordingly. We also have the problem of irregular domestic competitions, which are badly needed to draw the attention of upcoming players and to maintain an effective pipeline for the national team as well.

DS: But the fact remains that Bangladesh conceded 24 goals in four matches, of which the biggest 9-0 defeat was against India. Do you think the margins of defeats were justifiable?

AH: Both India and Japan play in the Olympics. And since Japan also conceded a 6-0 defeat to India, so in that case, I will say that our margin of defeat against India wasn't bad indeed. Besides, we played the first match against India after venturing into the tournament on the back of only a 10-day training. We did try our best to implement the plan that the coach had designed for the India match

DS: That implies you reckon Bangladesh could have produced better results if they were given more time to prepare.

AH: It's not that we would have beaten them if we were given more preparation time but we could've certainly produced a much better performance than what we showcased. However, there was no shortage of effort from us to display something good but the fact is that we last

DS: Bangladesh lag behind other participating teams, no doubt. Can you point out the areas where Bangladesh have been trailing more than others? AH: First of all, Bangladesh lag far behind in experience than other teams like India, Japan, Pakistan. After being used to a particular style of play, you also need to play more matches to experience match situations but we don't have such opportunities on a regular basis. Fitness was the second area we lacked because we recently played the domestic competitions after more than three years. The problems overall were a combination of experience, fitness and technique.

DS: You struck three of the four goals Bangladesh scored in four matches. How do you evaluate our own performance? AH: Spectators always expect from the forwards to get goals and they only remember the scorers irrespective of the performances on the turf. I always tried to cash in on the opportunities because you don't get many in such big matches. Moreover, I tried to reduce the pressure on the players by contributing to an early lead.

Australia ground down a battling England to win the second Test in Adelaide Monday and

go 2-0 up in the Ashes series, leaving the visitors' dreams of winning back the hallowed urn in tatters.

It might have taken longer than most onlookers expected to achieve the result they almost unanimously did, but Australia secured their second hefty win in as many Ashes Tests and are all-but assured of retaining the urn.

In the 117-year history of five-Test Ashes series, only one team has recovered from a 0-2 deficit to win the last three matches and that was largely due to the individual mastery of Don Bradman in the summer of 1936-37.

The win, by 275 runs, was achieved with Jhye Richardson completing his maiden Test five-for, and with a minimum 21 overs remaining in the final session.


Richardson was hugely impressive in his return to Test cricket after almost two years battling shoulder injuries, and selectors face a tough call in finalising their attack for the next Test at the MCG starting Boxing Day with captain Pat Cummins and Josh Hazlewood expected to return.

And in finishing the match with five wickets, spinner Nathan Lyon joins legendary leggie Shane Warne as the most successful Test bowler at Adelaide Oval.

The result extended England's winless streak in Tests in Australia to 12 stretching back to the final match of their successful 2010-11 campaign.

Only New Zealand (18 Tests from 1987-2011), as well as Sri Lanka (15 from 1988), West Indies England keeper Jos Buttler had defied the eightpronged Australia attack and his own reputation as a
belligerent white-ball basher only to push the match
into its last phase. Buttler, who had a wretched time
behind the wicket, dropping several catches, produced a
spectacular rearguard, spread over 207 deliveries, for an
uncharacteristically dogged 26 that kept alive England's
faint hopes of saving the match. The right-hander dogged
resistance, however, ended in a bizarre fashion as Australia
thrashed England by 275 runs in the day-night second test

to go 2-0 up in the five-match Ashes series on Monday. It was soon snuffed out when the batsman, retreating deep into the crease to work a Jhye Richardson delivery on the off-side, trod on his own stumps.



(14 from 2000) and Pakistan (14 from 1999) who are all yet to win a Test here this century, have endured longer droughts in Australia.

England captain Joe Root said his side cannot afford to feel sorry for themselves after losing the second Test.

"The Ashes are on the line here, if that is not motivation, I don't know what is," Root said.

Buttler's 26 runs from 207 balls delayed Australia's victory charge for a while and Root said that should be the blueprint for the remaining matches in Melbourne, Sydney and Hobart.

"Ultimately that is the attitude and the mentality we have to harness over the next five days. I am extremely proud of the way the guys fought today, that attitude and desire that's how we need to go about a whole test match. I thought Jos's innings was outstanding on that pitch. He should have gained a lot more confidence from this," he added.

Interim Australian skipper Smith said: "We wanted to stay calm because we knew it would take a couple of good balls and a couple of wickets to get the win. I had fun this week, enjoyed it," he added. "The guys played well, controlled the game from the first day."

Marnus Labuschagne won player-of-the-match for scoring a century and a fifty but it was "exceptional" Mitchell Starc who was praised by Smith.

"They all bowled exceptionally well as a group, led by Mitchell Starc. Mitch led the attack really well. He summed it up quickly, not a great deal of swing so he bashed a good length, across the right-handers, in great rhythm."

The third Test begins in Melbourne on Sunday.





Commute APPALLING

Journey on Rokeya Sarani turns nightmare due to poor maintenance, construction work

Large potholes, contraflow lanes, overflowing drains and long tailbacks make the commute through the capital's Begum Rokeya Sarani an exercise in patience.

The situation has been more or less the same since the construction of metro rail began in 2016. On rainy days, the large potholes get covered in muddy

water, making it harder for motorists to avoid them. The authorities do not seem too keen on repairing the road. Besides, no traffic police can be seen on the road

between Mirpur 10 and Agargaon most of the time. For the last couple of months, long tailbacks are often caused by the around one-and-a-half kilometer contraflow between Taltola and Kazipara. Sometimes it takes over half

an hour to travel the distance in a vehicle. The absence of traffic police means vehicles and rickshaws park on the road and buses pick up and drop passengers completely blocking traffic flow.

"The number of trips we could make have halved, thanks to the state of Rokeya Sarani," said Jibon, driver of a Mirpur Link Paribahan bus.

Hasan, driver of a Bikalpa Paribahan bus, said the road wouldn't be in this state if VIPs were using it.

DNCC and Metro rail are pointing fingers at each other. Shawkat Mahmud, superintendent engineer of Drainage circle of Dhaka North City Corporation, said the metro rail authority requested the corporation not to work on its underground sewer pipes.

Probe reveals mass murder

At least 40 civilians tortured, killed in revenge attacks by military



At least 40 extra-judicial killings were conducted by the Myanmar military in July this year, according to a report.

The killings allegedly took place in central Myanmar's Kani Township in four separate incidents in the span of less than a month, the BBC reported yesterday following an investigation with Myanmar Witness, a UK-based NGO.

Evewitnesses said the military rounded up villagers before separating the men and killing them. The men were allegedly tortured before they SEE PAGE 5 COL 5

uncontested in the UP polls. Polls will be held in 714 unions that day, which will be the fifth phase of the election.

Elections to 2,203 unions have taken place so far in three phases. The fourth phase will be held in 840 other unions on December 26.

In 2016, a total of 207 chairmen were elected unopposed in 4,107 UPs, meaning one in 20 chairmen were elected uncontested.

Most of the chairman candidates elected unopposed are Awami League nominees, said election observers.

The BNP and many other political parties are not taking part in the polls.

Election Commissioner Mahbub Talukdar had expressed dismay over the phenomenon.

"I want to say metaphorically that elections are now in ICU and democracy is on life support... Literally, this cannot be called an election. There is no election when there is no competition," Mahbub said last month.
