Demand for commercial vehicles climbing after Covid

The demand for commercial vehicles in Bangladesh has increased as economic activities in the country boomed soon after a prolonged nationwide lockdown aimed at curbing the spread of Covid-19 ended earlier this year.

Besides, the use of commercial vehicles has grown exponentially over the past decade, according to market

the 3,000 units sold annually ten years

"But the demand was 50 per cent less in 2020 due to the economic impact of Covid-19," Ahmad said.

At present, the domestic market size of commercial vehicles is about Tk 4,400 crore while it was about Tk 2,000 crore in 2010, he added.

Of the total demand for commercial vehicles, truck, pick-ups, lorries, and

following the implementation of health increasing contributions to the safety guidelines in coping with the pandemic.

Various market players say that Indian automakers TATA, Ashok Leyland and Eicher cater to most of the demand for trucks in Bangladesh.

However, the presence of Japanese and Chinese truck manufacturers is very insignificant.

The Indian companies were able to

commercial vehicle industry as they need to transport numerous heavy raw materials.

Moreover, the booming e-commerce industry is directly fuelling vehicle purchases as they need to transport goods all over the country.

Meanwhile, the government policy on axle loads that limits the weight carried by each truck in order to reduce damage to roads forces the use of more trucks and other such vehicles.

Echoing Ahmad, Taskeen Ahmed, managing director of IFAD Autos Limited, said sales started to boom after economic activities resumed in the country.

As such, the commercial vehicle segment of the automobile sector will continue to blossom in line with the rising economic activities.

"But the sector needs at least another year to recover from the pandemicinduced losses." Ahmed said.

However, there is no reliable data on how much money was lost by the industry.

"Not only the sellers but also the operators of transport faced huge losses," he added.

Hafizur Rahman Khan, chairman of Runner Group, had previously told The Daily Star that Bangladesh is a potential market for commercial vehicles as its economy is booming.

"The demand for commercial vehicles will continue to grow as you need vehicles for moving products as well as people's movement," he said.

The market size of commercial vehicles grew 15 per cent to 20 per cent annually over the last one decade, Khan added. Around 7,808 trucks were registered

in the seven months leading up to July this year, shows data from the Bangladesh Road Transport Authority. The total number of trucks registered

stood at 21,212 units in 2019, 7,275 in 2016, 6,330 in 2015, and 8,136 in

As of August this year, the state agency has registered 3,504 trucks, 2023 covered vans, 819 delivery vans, and 6,399 pickups.

The commercial segment of the automotive industry in Bangladesh is dominated by imports, mostly from India, China and Japan.

Commercial vehicles are imported from India mainly due to competitive pricing and availability of spare parts, Khan said.

He went on to say that Indian commercial cars are viable due to their lower price and fuel efficiency compared to Japanese vehicles.

The local automobile manufacturing and assembling industries in Bangladesh have not grown adequately in the last three decades because of a lack of raw materials, according to a review of IDLC, a non-bank financial institution.

Now, Runner Motors, Nitol Tata, Ifad Autos and Rangs Motors have set up small-scale assembly plants in collaboration with foreign companies such as Hino, Mitsubishi, Tata Motors, and Ashok Leyland to assemble cars, trucks, pickups and buses.

In the commercial vehicle segment, Nitol is the market leader in Bangladesh followed by Ifad Auto Runner Motors, according to the IDLC

Khan of Runner Group said local entrepreneurs will soon go for automobile manufacturing in the country.

"The first step for an automobile manufacturer is to set up an assembly plant before going for manufacturing. Some local entrepreneurs have set up assembly plants and now, the country is on track to manufacture automobiles," he added.

There are 14 to 16 large automobile retailers in the country. Of them, five or six have assembly plants while the rest are sole distributors or importers of selected international brands, according to industry insiders.

Ifad Autos, Aftab Auto, Navana, Rangs, Rancon Motors, Nitol Motors, Runner Motors and AG automobiles are major distributors in Bangladesh.



"Around 2,500 trucks, cargo vans, pickups and tankers have been sold in September, up about 70 per cent from 1,200 units to 1,500 units previously," said Abdul Matlub Ahmad, chairman of Nitol-Niloy Group.

"But we still cannot cope with the full demand," he added.

At least 38,000 units of commercial vehicles, including buses, trucks, autorickshaws and tankers were sold in 2019, which is significantly higher than share of between 60 per cent to 65 per

The chairman of Nitol-Niloy Group went on to say that the commercial vehicle sector will be able to recover from the coronavirus-induced losses incurred in the past 18 months by this year as market demand increased with the country's return to normalcy.

In addition, people have realized that ensuring smooth continuation of economic activities takes first priority

as they entered the country back in the 1980s and have since gradually overtaken their fellow asian and european counterparts.

Market players in the commercial vehicle segment said most of their demand comes from the country's garments industry, which uses a vast number of trucks and other cargo carriers to transport products.

The growing cement, steel, and shipbuilding sectors are also making

Growing demand encouraging local manufacturing

Thanks to continuous economic growth and increasing connectivity in Bangladesh, the domestic demand for commercial vehicles is soaring rapidly. As a result, local entrepreneurs are investing in establishing assembly plants in the country, which would make the economy more vibrant as well as generate new jobs.

"As Bangladesh's economy is growing rapidly, so too is the demand for commercial vehicles," said Abdul Matlub Ahmad, chairman of Nitol-Niloy Group.

Besides, since the government has taken measures to phase out illegal commercial vehicles such as Nasimons and Korimons, the demand for legal replacements is surging.

"In fact, the demand has risen to such an extent we are now moving towards manufacturing rather than simply assembling," he added.

The company assembles pickup trucks at a factory of the Nita Company, a joint venture of Nitol-Niloy Group and Tata, in Kishoreganj.

Consumers will benefit more from

local manufacturing as prices would be lower and remain unaffected by abrupt changes in the foreign exchange rate.

Regarding the recent trend in commercial vehicle purchases, Ahmad said the market was impacted by the ongoing coronavirus pandemic but the situation is now getting better.

"I hope 2022 will be a great year for the commercial automobile sector," he

Taskeen Ahmed, managing director of IFAD Autos, also opined, "since the local infrastructure is improving, the domestic demand for commercial vehicles is rising as well," he added.

Since 1988, IFAD Autos has been distributing commercial vehicles of India's leading automobile manufacturer, Ashok Leyland.

Ahmed went on to say that demand will continue to rise in the coming years.

People in the country's south currently depend on launch services but connectivity of at least seven districts in the region will change after the Padma Bridge is complete.

"So the demand for commercial vehicles would be higher," he said.

Similarly, the opening of Payra port within a few years will have the same effect while increasing trade with neighbouring countries will also continue to boost demand.

Realising the potential, many companies are trying to assemble their products in Bangladesh.

As such, foreign investment will come to the country and a huge number of jobs will be created, Ahmed added

The Energypac Power Generation Company recently announced that it would assemble double cabin pickup in association with a Chinese carmaker at Energypac's state-of-the-art industrial park at Sreepur in Gazipur. They inaugurated the industrial park earlier

this year.

"The demand for commercial vehicles moves with the movement of an economy," said SM Jashim Uddin," chief business officer of the motor vehicle division of Energypac Power

"Seeing a good prospect in our economy, we started our commercial assembly in 2015. Now, we are launching new models like the T8. In the last six months, the sale of commercial vehicles rebounded as the industrial wheel started turning," he

Launch Fire on Sugandha River

Everything they did was wrong

Faulty engine, pathetic responses to blame

An overheating and larger-than-approved engine running at full-throttle was probably what caused the fire in the illegally modified engine room of the MV Abhijan-10, officials said.

Besides, the crew members simply abandoned the vessel, letting it drift downstream for over half an hour, an inferno on the Sugandha river with hundreds of people

Death toll from the fire reached 41 as of last night.

The owner, Hanjalal Sheikh, mounted two new engines on the launch last month, replacing the governmentapproved ones that could produce a total of 1,100 horsepower. The owner had the structure of the vessel tweaked to be able to mount the engines, said probe

committee members investigating the deadly fire.

Hanjalal did all of these without permission of the design committee led by the Shipping Department's chief engineer, which in itself is a punishable offence.

Only one of the engines was running on the fateful night of Friday. There was not enough lubrication, causing the engine to heat up, said Mostafa Miah, a master of the Sundarban-13, who was with the probe committee members when they inspected the launch in Jhalakathi.

At least 100 people were injured in the fire and a total of MORE ON PAGE 3

In hospital bed, they recall the horror

When the massive fire engulfed the ill-fated MV Abhijan-10 early Friday, Monika Rani Halder, 40, a high-school teacher of Barguna, could not find her 16-year-old son after a desperate search for 30 minutes in the launch.

Although three of the family members including her husband Bankim Majumdar, 60, and son Bikash Majumdar could swim, Monika decided that she would not leave her son in the burning vessel. By then, the couple was burnt severely.

The couple finally jumped into the Sugandha river while the villagers rescued them and took them to Barishal's Shere-Bangla Medical College Hospital where they found their son with mild injury.

But Monika's condition took a turn for the worse. She is now fighting for life at the intensive care unit of Sheikh Hasina Burn

The Election Commission, in a clear violation of the law, accepted nomination papers after the stipulated time for the Chandipasha Union

Parishad polls in Myemensingh's Nandail upazila. The last date for nomination paper submission

was December 9. On December 8, Iftekhar Hossain had submitted his papers as an independent candidate while the

next day Amdadul Haque Bhuiyan submitted his with Awami League's recommendation attached. However, on December 10 -- the day after the final date for submission,

Iftekhar again submitted nomination papers but this time with AL's

recommendation. The EC received it and also cancelled Iftekhar's independent candidacy after accepting the new papers. They also cancelled Amdad's AL nomination. According to locals, the union's polls officials initially refused to receive the paper after the scheduled time but local MP Anwarul Abedin Khan put

them under pressure. They then received the papers without issuing any "receipt" and sent a letter to the EC for a decision in this regard.

On December 12, the EC secretariat accepted Iftekhar's papers, after

Workers' Migration to Malaysia

Some old issues still remain

Kuala Lumpur is set to resume hiring Bangladeshi workers, more than three years after the then Malaysian government, led by Mahathir Mohamad, froze fresh recruitment from Bangladesh citing forced labour and high migration costs.

Both sides struck a memorandum of understanding (MoU) in this egard on December 19 and if everything goes well, Bangladeshis will start joining their new jobs in the Southeast Asian country in January, say

Those working to protect the rights of migrants, however, pointed out that some key issues, which led to forced labour and high costs in the past. remain unaddressed.

The MoU, signed in Kuala Lumpur on December 19, has not been made public, they also said. In a statement, the Bangladeshi expatriate ministry said the recruitment costs in the Malaysian end would be borne by the Malaysian employers.

These include flight fares, health examination, visa and immigration fees

as well as costs for Covid-19 tests and quarantine. But the statement does not say who will pay the migration costs at the Bangladeshi end. Neither does it answer what will happen in case the

workers face exploitation or are not paid properly in Malaysia. In such a situation, chances are there that the migrants are set to find

themselves in trouble again, the rights activists said. As per the ethical recruitment model of the International Labour Organisation (IOM), all recruitment costs should be paid by the employers.

Thousands of flights canceled globally; UK sees record number of cases

Pope Francis yesterday called for dialogue to counter the isolation wrought by the Covid-19 pandemic as billions around the world marked a second Christmas under the shadow of the coronavirus.

An explosion in cases driven by the rise of the Omicron variant has meant a Christmas season tainted by the pandemic for a second year running, with longed-for family reunions overshadowed by the prospect of yet more Covid-19 restrictions.

During the Christmas Eve mass attended by some 2,000 members of the public wearing masks and respecting social distancing, the pope urged people to appreciate the little things in life.

In Bethlehem's Manger Square, visitors in Santa hats and scouts beating drums marked Christmas Eve, but numbers were lower than usual.

The city where Christians believe Jesus was born is usually a focal point of the holiday, with thousands packing the streets and filling hotels.

But Israel, which controls all entrances to the occupied West Bank where Bethlehem is located, has also barred its borders to foreigners in an effort to rein in infections from the Omicron strain of the coronavirus.

In his homily for midnight mass celebrated in St Catherine's Church in Bethlehem, the Latin Patriarch of Jerusalem Pierbattista Pizzaballa said celebrations were "certainly more joyful this year".

PROBE COMMITTEE FINDS FAULTS **IN ENGINES**

The seven-member probe yesterday visited the launch anchored in Diakul, inspected different parts of the vessel and talked with witnesses and locals.

Secretary Tofayel Islam said, "We have preliminarily detected some faults in the engines...

A member of the committee said they were almost certain that the fire originated in the engine room. "People working there were supposed to solve the engine issue easily. We don't know why the fault couldn't be solved," he said, requesting not to be named.

Family members of those who were onboard the vessel said after the launch caught fire, it was steered to the bank in the Charkathi area. The crew then fled without mooring it.

But the launch drifted away and reached Diakul on the other side of the river half an hour later. By then, the whole launch was burnt.

The launch owner said his manager alled him after fleeing the launch.

A probe committee member said the casualties might have been more had the launch not floated to the bank at Diakul.

The committee, formed on Friday, is supposed to submit its report in three

If a worker is injured at work, they will be compensated. In case the injury is permanent, they will get a lifelong pension upon arrival in Bangladesh. If a worker dies in an accident at work, their family will get a one-time compensation as well as a long-term pension, the statement also said.

Asked about the high migration costs and what will happen in case workers are exploited, Expatriates' Welfare and Overseas Employment Minister Imran Ahmad said those would be significantly less this time. He did not go into details.

Rights activists said each Bangladeshi worker, on average, had to spend Tk 4 lakh for a job in Malaysia during 2016-18, whereas the agreed amount was Tk 39,500. It was Tk 2 lakh during 2007-08 period against the agreed Tk 84,000.

During both periods, the private sector was engaged in recruitment.

This time, private agencies are being involved again. A new addition to the process is the Malaysian recruiting

According to the recruiting agencies, if the MoU is enforced properly, the actual migrant cost in the Bangladesh end will be less than Tk 50,000 -- recruiting agency's fees Tk 30,000 and a maximum of Tk 20,000 for medical check-up, documentation, and government charges.

Rights activists said recruitment fees in both countries should be borne by the employers under the IOM's ethical recruitment model.

Says Rizvi about dialogue on EC reconstitution

BNP yesterday termed the ongoing dialogue on the reconstitution of the Election Commission (EC) a farce, as the party thinks it will not pave the way for holding a credible national election in the country.



'Rifts in Awami League'

Ctg ward councils postponed

Arun Bikash Dey, Ctg

The ward-level councils of Chattogram city Awami League, which was supposed to begin today, have been postponed at the last moment due to "intra-party rifts".

AL's central committee took the decision after several party leaders raised allegations against a top leader of the city unit, according to sources.

This correspondent spoke to a number of AL leaders in the central and city committees, who pointed to intra-party rivalry for the postponement.

AL's 41 ward committees in the city have three organisational units on average. Out of the total 129 organisational units, the formation of the councils of 93 units have already finished.

It was decided in a recent meeting of AL's working committee that ward-level councils would be held after holding meetings at the

In the meantime, a number of AL leaders lodged complaints with the central committee regarding violation of instructions of the party's constitution.

According to sources, the AL city unit has three factions at present. One is a follower of AL city unit general secretary and former Chattogram City Corporation (CCC) mayor AJM Nasir Uddin; another follows AL city unit vice president and former administrator of CCC Khorshed Alam Sujan; and the other one follows deputy minister for education Mohibul Hasan Chowdhury Nowfel.

The leaders loyal to Sujan and Nowfel

filed complaints with the central committee, saying that the unit committees have been formed, violating the party constitution. They are being formed to make committees loyal to a specific leader, alleged sources in

Contacted, Badiul Alam, joint secretary of AL's city unit, said during formation of organisational unit committees, it was seen that a special form, made locally, was provided for new membership, and those who became members through the forms later on became councillors for the wardlevel councils as well.

"It is violating the party constitution. The central committee gave forms for primary membership, and there is no scope to provide locally-made forms," he said.

"After the complaints, the councils got postponed," he said.

Contacted, Sujan said, "Some leaders in Chattogram are trying to run the city unit like it's their private property. No leader can violate the party constitution.

AJM Nasir could not be contacted for

Contacted, AL joint general secretary Mahbubul Alam Hanif said they received some complaints over forming unit

"A misunderstanding occurred among leaders, and so a central delegation team would go to Chattogram to sit with them on January 8 to resolve the issues," he said.

"The ward-level councils will be held after consulting with all the leaders in

4 workers burnt in gas explosion

At least four workers sustained burn injuries in a gas explosion at Jamuna shipbreaking yard in Chattogram's Sitakunda upazila yesterday morning.

The injured are Sohel Rana (26), Md Jahid (27), Mizanur Rahman (40) and Firoz Pramanik (22), said ŚI Faruq Hossain of Sitakunda Police Station.

Dr S Khaled, associate professor of burn and plastic surgery unit of CMCH, said, "Two workers who sustained 10 and 12 percent burn injuries were referred to Sheikh Hasina National Institute of Burn and Plastic Surgery in the capital."

All the victims were initially admitted to Chattogram Medical College and Hospital, he said.

"The four were injured after the tank of a scrap ship, which the workers were cutting, exploded around 8:30am," the SI said.

"There were lack of proper safety measures at the scrap ship where the explosion took place," the SI added.

He also informed that on April 3, another gas explosion at the same shipbreaking yard injured three workers.

Contacted, Mesbah Uddin, manager of the yard, denied the allegations and said there are no lack of safety measures in the yard.





President invites four more political parties for dialogue

President Abdul Hamid has invited four more political parties for dialogue with him at Bangabhaban over formation of the next Election Commission.

The five-year tenure of the incumbent commission, led by Chief Election Commission KM Nurul Huda, will expire on February 14



Gonotontri Party was invited to hold dialogue at 6:00pm on January 3 while Communist Party of Bangladesh at 7:00pm on the same day.

The president began the dialogue with registered political parties from December 20 and so far held dialogue with the main opposition party in parliament --Jatiya Party -- and Jatiya Samajtantrik Dal, a component in the Awami League-led alliance.

As of yesterday, the president has invited 13 political parties to join the dialogue till January 3.

There are 39 registered political parties at present, according to the EC website. But only nine parties have representation in the parliament.

Friday morning, all three members of the family have gone traceless. No one knows what has become of them yet. They may have drowned in the river or burnt to death beyond recognition. Land donor demolishing community clinic without approval

Health services for the villagers in Guabaria union of Barishal's Hizla upazila are being hampered as the land donor of 'Kalikapur Community Clinic' has been demolishing it without the approval of the health department.

However, the land owner Dalilur Rahman Shikdar of Guabaria union is building another structure some hundred yards away from the clinic in a bid to shift it without taking prior permission of the authorities concerned, confirmed the upazila health officer.

According to the office of the upazila health officer, the community clinic has been operating on five decimals of land donated by Dalilur Rahman Shikdar of the union.

The land donor wanted to shift the hospital to some hundred yards away from the boundary wall of his residence which was not officially approved, said Upazila Health and Family Planning Welfare Officer Dr Mamunur Rashid.

Guabaria Union Parishad Chairman principal ShahjahanTalukder said the land donor in a meeting at the UP sought permission to relocate the clinic in order to continue the beautification works of his

He (the land donor) pledged to construct the building where the old clinic will be housed and that is why he was given the primary permission, said the chairman.

What is the problem with the person who has given the land and funding the relocation of clinic elsewhere?" he asked.

Visiting the spot, it was found that the old clinic was being demolished and a one-storey building was being constructed some one hundred yards away from it.

The land donor has been constructing a two-storey building 'Moni Palace' adjacent to the building of the old community clinic.

Construction workers said it would take at least two more months to complete the works of the new hospital building.

A number of villagers said that they were being denied of necessary services of the clinic as it remains inoperative due to the relocation of the clinic.

Hizla Upazila Nirbahi Officer (UNO) Bakul Chandra Kabiraj said, "I am not aware of the

However, when the UNO was contacted again over his phone, he advised talking to the civil surgeon.

Shikdar, land donner of the community clinic and also the former president of the Upazila Awami League, said that there were some problems running the hospital in its old place and so they were constructing a hospital

Dr Monowar Hossain, the civil surgeon of Barishal, said that the relocation of a hospital requires the approval of the ministry.

No approval was taken in this regard and the land donor cannot relocate the hospital if he wants, he said.

'I have instructed the upazila health officer to file a general diary with the police station in this regard," he added.

Jhenidah orange farmers counting losses

Growers claimed they cultivated BARI-2 china variety after watching a video on Youtube

Farmers, who cultivated BARI-2 China variety of orange, in Jhenidah, Chuadanga and Jashore districts are now counting losses due to low prices and less demand in the market.

Out of frustration, many farmers in those district have cut down their fruit bearing orange plants.

Growers said the demand for the china variety is very little in market as it bears seeds inside and its juice gets shrunken.

While talking this correspondent many growers said they got inspiration in farming this variety after watching a video on Youtube uploaded by Chuadanga Sadar Upazila Agriculture Officer Talha Jubayer Masrur.

In his video, the upazila agriculture officer said this variety is tasty and more profitable than the other China varieties available in the market.

Masrur also said that those who are interested in farming this variety can collect the orange plants from one Omar Faruk of Nidhikundo village in Chuadanga's Jibonnagar upazila.

Golam Rasul, an ASI of police, of Mashlia village in Jhenidah's Kaliganj upazila said he watched the video on China orange farming on Youtube in 2018 and came to learn that Tk 4 lakh can be earn from only a hundred

He then took Tk 4 lakh loan and planted the China orange plants on his five bighas

Although the plans bore huge fruits, he

could not sell those due to its bitter taste. Alamgir Hossain of Shishutala village in Jashore's Chougachha upazila said he

collected china orange plants from Faruk

and planted those in two bighas of land. The yield was good, but traders in Dhaka failed to sell his produces as it bears seed inside and also taste bitter.

After incurring loss of Tk 4 lakh he became frustrated and cut down all his orange plants last month, Alamgir added.

Contacted, Omar Faruk said farming of this variety mostly depends on soil and weather, adding that he sold 120 mounds of the orange variety at Tk 70 to Tk 80 per Kg in the last two months.

Chuadanga Sadar Upazila Agriculture Officer Talha Jubayer Masrur said none of the affected farmers, who cultivated the orange variety, contacted him yet in this

law and order runs its own course. But that is not the case. Those who are in the higher positions, or who are highly wealthy, spread their web of influence to justify their own crimes by different ways and means," Barua added.

Police should have taken the case immediately, said Muhammad Nurul Huda, a former inspector general of the police.

"As a rule of thumb, it is the police's duty to accept and record assumed cases as they come. Next comes an investigation to determine the truth. Not accepting the case is a weakness.

Huda went on to call for a thorough investigation of the issue.

Supervising officers or the court can ask for an explanation in this regard,

Nur-e-Azam Mia, the OC of Banani police station, said an all-out investigation is going on. "We can share the details after the investigation is complete," he told The Daily Star.

The media also was complicit in the violation of basic rights of Hajong, a retired Border Guard Bangladesh member: it did not take Hasan's name

"Here, a power abuse took place due to the existence of power play. His name was not published because the media is biased towards the powerful," said Robayet Ferdous, a professor of the University of Dhaka's mass communication and journalism department.

Another reason behind not publishing his identity could be the media's fear of the court.

Had Mohua Hajong been higherranked police, a senior official from a different force or a prominent businessman instead of being a lowerranked sergeant, her case would have been filed and she or her family would not have faced any kind of harassment,

Ten killed in Iran road crash: state media

Ten people were killed and more than a dozen injured in Iran yesterday when a truck collided with a minibus transporting workers in southwestern Khuzestan province, state media said.

The accident occurred at around 7:15 am (0345 GMT) on the road between the cities of Ahvaz and Khorramshahr, Khuzestan's traffic police chief Reza Dolatchahi said.

"The number of people killed in the crash on the old Ahvaz-Khorramshahr road has reached 10," Dolatchahi said, according to the official IRNA

The collision caused a pileup involving three other vehicles, Dolatchahi added.

At least 13 other people were injured, IRNA said, citing a Khuzestan

emergency services spokesperson. Those who died were the truck

driver and passengers on the minibus, Fars news agency reported, citing an official from the province's Red Crescent.

The Ahvaz-Khorramshahr road is 100 kilometres (62 miles) long and sees significant truck activity to and from the Shalamsheh border crossing with Iraq, according to Iranian media.

Governor of Iraq's Najaf resigns after protests

The governor of Iraq's Najaf province resigned on Friday, a day after another governor also quit following demonstrations against conditions and corruption.

Louai al-Yasseri resigned from his leadership in Najaf, in central Iraq, a day after the governor of Nasiriyah province in the south quit following the violent suppression of protesters. Their departures underline the

challenges facing war-scarred Iraq and how little has changed despite protests that swept Baghdad and the South two years ago. Tens of thousands of demonstrators

took to the streets to express their anger at corruption, unemployment and crumbling public services, and hundreds lost their lives in protestrelated violence. Yasseri announced at a press

conference that he was leaving his post in the holy Shiite city, according to the official Iraqi News Agency. His resignation follows harsh

criticism from prominent Shiite leader Moqtada Sadr, who emerged as kingmaker following legislative elections in October. Sadr paid a public visit to the

Common long COVID symptoms

Long COVID is not medically definitive but a term that describes a portion of the population struggling with symptoms for weeks or months after being infected with COVID-19, not just those who were seriously ill.

Fatigue is the most common, but breathlessness, chest tightness, brain fog, gastrointestinal issues, joint pain, headaches, and vertigo are other reported manifestations, ranging from mild to debilitating. For many, the psychological effects are profound. Some people are still suffering symptoms seven months after infection, and those who had a mild illness at the start can have worse ongoing symptoms than patients who needed intensive care treatment. Meanwhile, some people are living with symptoms that move around the body.

Researchers from the National Institute for Health Research who reviewed the available evidence said ongoing symptoms examined reports from people of all ages and backgrounds. While most cases of coronavirus resolve in 3-4 weeks, long COVID is a reality for a lot of COVID-19 patients. Also referred to as post-COVID. It can last for several weeks and impact recovery in the



Post-multiplication viral debris can cause fatigue. The body's response to a virus can be overdriven, tiring the system. Some say fatigue and exhaustion take the longest to recover from infection. So, give your body plenty of rest and fluids to reenergise it. Maintain a healthy diet and avoid chores after recovery. Working too hard will only worsen the situation. After COVID fatigue, people experience lethargy, muscle ache, pain and exhaustion.

Again, increased inflammation in the body from COVID-19 can

cause body pain. Muscle pain is caused by virus-induced damage to muscle fibres and abnormal tissue breakdown in some COVID patients. Cough, one of the most common COVID symptoms, can last for five to six weeks or longer if the virus is still present in the upper respiratory tract

Coughing can be dry and productive, causing more stress to the respiratory tract and throat. Steam inhalation, saltwater gargles, herbal teas, and a vitamin-C-rich diet can help you recover faster. Shortness of breath or pain or discomfort while

breathing can indicate worsening COVID symptoms. It may be a long-term issue affecting their quality of life for many long-

Brain fog, confusion, delirium are some of the common ways COVID-19 could impact your brain and make it age by at least ten years, studies say. They also make for some of the most commonly recognised post-COVID symptoms, which could degrade the quality of life for some with severe symptoms.

Many people believe that brain fog and other symptoms of post-

COVID brain damage are signs of mental illness, which is why doctors stress the importance of post-COVID brain checks and exercises. Insomnia or chronic sleep issues are another common COVID-19 symptom; nearly half of the recovered patients complain the same. Psychiatrists are also seeing recovered patients with sleep issues, fear and panic, leading to sleepless nights. Meditation, calming teas, and rest can help reduce stress and rehabilitation. If these issues become too frequent, patients should seek help.

People who suffer from anosmia and loss of taste find it challenging to regain this vital function for weeks or months. Smell training is a non-pharmaceutical therapy that helps patients regain their smell and taste. Long covid is not just people recovering from intensive care. Even mild infections can cause severe health issues.

To conserve energy, avoid overdoing it and get plenty of rest. Think about what you need to do and what can be put off, and plan your days accordingly. If you are not recovering as quickly as you would like, ask your hospital team or doctor for assistance.

Chronic opioid users are at excess risk for initiating injection drug use

The opioid epidemic is driven largely by use or misuse of prescription oral opioids, but injection drug use also has increased in recent years. Qualitative studies suggest that injection drug use in prescription opioid users might be precipitated by events such as developing tolerance or interrupted access to medications.

To assess the association between long term prescription opioid treatment medically dispensed for non-cancer pain and the initiation of injection drug use (IDU) among individuals without a history of substance use, Canadian investigators evaluated a retrospective cohort of almost 60,000 patients without cancer but with periods of chronic prescription opioid use between 2000

These patients were matched to patients with periods of episodic use, acute use, or no use during the same interval. After adjustment, initiation of injection drug use was 8 times more common among patients with chronic opioid use than among those with no use. Such initiation was more frequent among younger patients and those using higher opioid doses.

The authors of the research published in the Brititsh Medical Journal caution that chronic prescription opioids should not be involuntarily tapered or discontinued. Clinicians should be alert to initiation of injection drug use among chronic opioid users, particularly those who are younger or using higher opioid doses.

Manage your osteoarthritis of knee

Osteoarthritis affects millions of older adults globally. Knee, hip, hand, and foot joints are commonly affected. It causes knee pain and stiffness, but it can also cause severe disability and loss of quality of life, especially in the elderly. Gradually, it is becoming clear that osteoarthritis is not just a mechanical or agerelated condition. Certain factors accelerate the disease, such as diet, trauma, and other comorbidities.

Although older adults usually suffer from osteoarthritis, young people can also get it. It may be familial or acquired (injury, infection, overweight).

The following common factors increase the chance of developing arthritis and the severity of the disease.

- Osteoarthritis is directly connected to wear and tear on joints. More than one-third of adults over the age of 65 have symptoms of osteoarthritis (OA). The ability of cartilage to heal decreases as the persons get older.
- Weight increases the pressure on all joints, especially the knees. Every pound increase in weight adds three to four pounds to the knee.
- Genetic mutations make a person more likely to develop osteoarthritis. It may be due to inherited abnormalities in the shape of the bone that surrounds the
- Women aged 55 years and older are more likely than men to develop osteoarthritis.
- People with jobs that need a lot of stress on joints, such as kneeling, squatting or lifting heavy weights (55 pounds), are more likely to

- Athletes involved in soccer, tennis or long-distance running may be at higher risk of developing knee osteoarthritis in later life.
- For people with rheumatoid arthritis, certain metabolic disorders such as an iron overload or excess growth hormone are at a higher risk of osteoarthritis.

Changing your lifestyle can help improve joint health and prevent osteoarthritis.

• Regular moderate exercise strengthens joints and can decrease the risk of osteoarthritis. It can help maintain healthy joints, reduce pain and fatigue, relieve joint stiffness, and increase muscle and bone strength. Excess weight puts extra stress on joints, speeding the deterioration of joint cartilage. Losing weight also helps to reduce pain and improve symptoms.

• After a prolonged sitting, journey or work, the joints involved

- become swollen or achy, rest them and try to avoid using a swollen joint for at least 12-24 hours which will reduce the risk of developing OA in future. • High glucose levels can speed
- up the formation of molecules that make cartilage stiff; it also triggers inflammation that can accelerate cartilage damage. Keeping diabetes under control can help to prevent OA.
- Food heated in very high temperature, grilled or even pasteurised a toxin known as advanced glycation end product appears which can damage specific protein enhancing damage to the tissue.

There is no such cure to osteoarthritis except maintaining lifestyle modifications.

Make up for vitamin D deficiency

Vitamin D is a fat-soluble vitamin that promotes calcium absorption in the gut and maintains adequate serum calcium and phosphate for healthy bones, teeth and muscles. Now-a-days, vitamin D deficiency is a silent and neglected global public health problem. Almost one billion people worldwide suffer from vitamin D deficiency or insufficiency.

Vitamin D deficiency symptoms have been linked to different health problems, including heart disease, depression, and cancer. Signs you are not getting enough vitamin D are -- bone softening of fractures, fatigue and generalized weakness, muscle cramps, joint and bone pain, impaired wound healing, dizziness, anxiety, hair loss.

To fulfil the deficiency of vitamin D, the following measures can be adopted:

• Go out in the sun

- Take vitamin D rich food every day. for examplemushrooms, liver, meat, fish, liver oil, shrimp, egg yolk,
- Take supplements by consulting with doctors • Routinely test the 25-hydroxy vitamin D blood.
- Spending enough time in the sun and eating vitamin D rich food is the best way to get a daily dose of vitamin D. Only eating vitamin D rich food is insufficient to fulfil your daily dose.

Check your vitamin D level twice a year and consult with your health care professional before taking a vitamin D supplement.



A tragedy of our own making!

Blatant disregard for passengers' safety led to so many deaths and injuries

TE are saddened and outraged at the deadliest incident of launch fire in our history that has taken at least 40 lives until now, with over a hundred passengers injured and many more still missing. According to our reports, a few hours after the launch, MV Abhijan-10, left for Barguna with over a thousand passengers on board from Dhaka—at 6pm on Thursday the staffers of the launch noticed some problems. However, they kept the vessel going while trying to fix them. Many of the passengers noticed that the engine of the launch was acting strange—it was making loud noises from time to time, black smoke was emanating from the engine room and sometimes, flashes of fire were exiting the exhaust pipe. With all the signs of an imminent disaster, the launch, however, kept going. Even when the people on the bottom floor of the vessel felt the deck getting hotter—after it left the Barishal Launch Terminal around 1:30am—the master still kept the launch moving towards its destination. Then, at 2am, there was an explosion which caused the huge fire that engulfed the entire launch.

The questions that we have regarding this deadly fire incident are many: Why didn't the launch master and staffers do the routine check-up of the engine and other machinery before starting the journey? Why did the launch master not cancel the trip when they found out that the engine was giving trouble? Why were barrels of fuel kept in the engine room and on a major portion of the lower deck? Why was there a kitchen right next to the engine room? Why didn't the master stop the vessel at the Barishal launch terminal when the heat at the lower deck was so obvious and could be felt by all? Lastly, why were there more than a thousand passengers on board, when the launch had the capacity of carrying only 420? This fatal fire could have been easily avoided if some basic rules had been followed by the launch master and staffers, and if only they cared a little about the passengers' safety.

It is heartbreaking to see the cries and screams of the relatives of those who died on the spot, being burnt alive or having suffocated to death. Many are still waiting for their loved ones who went missing after they jumped into the river to save themselves from the fatal blaze. The hospitals in Barishal, Jhalakathi and Dhaka that are providing treatment to the burn victims are struggling with so many critically wounded patients. We hope all of them will get the best treatment in the country and that no more lives will be lost.

Apparently, some committees have been formed to investigate the incident and find out the real cause of the fire. Although the fire officials have primarily identified the engine room to be the source of the blaze, we will know for sure when the committees give their reports. And regarding the negligence of the launch master and the staffers, we think all of them should be brought under the law for not playing their due roles. Such blatant disregard for passengers' safety should never be tolerated.

Bring children back to school

Govt action needed to make education inclusive and accessible for all

THE fact that at least 2.5 million children of school-going age are not receiving formal education is deeply concerning. As this daily has recently reported—citing data presented at a CSO Alliance, CAMPE and Dhaka Ahsania Mission webinar titled "Achievement, challenges and way forward in Bangladesh's Golden Jubilee" —the dropout rate for primary education is currently 17.9 percent, but even higher for secondary education. It was also found that the student-teacher ratio remains too high with there being only one teacher for every 46 students. This, coupled with the dropouts and learning loss caused by Covid-19 pandemic-induced school closures of the past nearly two years, certainly casts a shadow on the future of school education in Bangladesh.

Amongst those excluded from education, most belong to vulnerable groups either due to their financial conditions or because of various disabilities. It is unfortunate that our education sector does not cater well enough to children with disabilities, with a uniform education system for those with disabilities still nowhere in sight. What is more disappointing is that teachers, headteachers and managing committees of many schools are apparently unwilling to allow such disadvantaged students to fully integrate into schools. It was also mentioned during the webinar how only 26 percent of teachers had acquired leadership training while very few were proficient in braille. As a country that is in the process of stepping into the category of being "developing", our educators need to be actively working towards accommodating students from all backgrounds instead of doing the opposite.

In order for progress to take place, it is crucial that such issues in our education sector are remedied on a priority basis. We would urge the government to work on recruiting and training teachers in a manner which would help make education completely accessible for all primary and secondary school-aged students. As experts have suggested, there also needs to be a comprehensive set of national education targets, the progress towards which would be monitored regularly by teachers, NGOs and government bodies. Specialised education materials should be produced for children with disabilities. It should also be ensured that, not only urban students, but children in remote areas and those from underprivileged families are also being taught with up-to-date educational techniques. The government must buckle up now to bring back to school those students who have dropped out due to pandemic-related reasons, and to also make sure the enrolment rate does not decline further. Otherwise, the nation may be set back by years' worth of educational and socioeconomic progress.

Let us not become dependent on LNG import




decreasing volume of annual natural gas production from the gas fields of Bangladesh means that the country is moving towards joining the net energy importers club sooner than one would have liked to think. Import dependency for oil and coal are well set as major primary energy sources in the country and imports of natural

gas, in the form of LNG, has begun to fill the shortfall of supply from local gas fields. The annual production of indigenous natural gas has decreased from a peak of 973 bcf (billion cubic feet) in FY2016 to 882 bcf in FY2020, according to Petrobangla. It is forecasted that the volume of local production will continue to decrease further into the future. Bangladesh started LNG imports in late 2018 and since then, has faced the uphill task of procuring the fuel from an unstable and volatile market.

quicker way of demise for a gas field is often noticed as in the Sangu offshore gas field, which had its production rate slashed over a much shorter period of time before being abandoned. Reasons for such quicker demise may be varied, but is usually due to a sudden drop of reservoir pressure, engaging in over-production and/or disregarding of healthy reservoir management.

There are, at present, 20 producing gas fields in the country. The Bibyana gas field in Sylhet, operated by Chevron Oil company, may reasonably be referred to as the jewel in the crown, for this gas field alone supplies 1200 mmcfd, which is about 51 percent of the total 2310 mmcfd from all gas fields in the country. For how long Bibiyana can sustain its present level of production is of paramount importance. The daily gas production reports of Petrobangla showed the production rate of the field exceeding its capacity for several years in the past. How it is translated in terms of reservoir management is perhaps better judged by Chevron personnel. But sceptics wonder if this is a case of over-production, a possibility suspected by many in the offshore Sangu gas field. Whatever may



Bangladesh is forecasted to be increasingly dependent on imported LNG. If the present trend of decreasing supply from own gas fields continues, volume LNG import may one day outweigh indigenous gas supply. How the economy would face such a precarious situation is anybody's guess. If the above situation occurs, a temporary halt of LNG import due to fund crunches will certainly put a lot of gas-powered plants in the dark.

The solution to this problem is simple. Bangladesh has for a long time ignored its gas exploration activities and let the gas demand-supply mismatch grow. The deltaic build of mainland Bangladesh and its offshore, for all geoscientific reasons, have been rated as highly prospective areas for natural gas. Proof of such rating is evidenced in the adjacent areas bordering Bangladesh, notably the offshore Rakhaine basin in Myanmar where large-scale gas fields have been discovered since the maritime dispute with Bangladesh was settled in 2012. Bangladesh, on the other hand, has hardly taken any steps to explore its offshore since that time. As such, Bangladesh should move faster with its exploration activities to lift its gas out of the ground. A quick fix of the gas supply problem with imported LNG may work out in the short-term, but in the long-run, the price volatility and economic uncertainty would make import unsustainable. It will be much more rational for Bangladesh to depend on its own gas resources rather than on the import of expensive LNG as long as such a resource base is scientifically reckoned.

With no new discovery of any significant gas reserves over the last two decades, the decreasing rate of gas production has set alarm bells to ring in earnest. Most of the major gas fields show signs of aging in forms of reservoir pressure drop and a downward trend in gas output. Titas, the largest gas field in the country, has had its production rate reduced from a peak of 500 mmcfd (million cubic feet per day) in 2016 to 384 mmcfd in Dececember 2021. Similar or even larger drops in production rate have been recorded in other major gas fields such as in Habiganj, Kailashtila, Rashidpur and Bakhrabad. Generally speaking, a gas field runs with robust production at an initial stage and gradually becomes less productive, before it eventually "waters out"—meaning it produces water rather than gas. A

be the case, a major drop in the production level of even just Bibiyana will be a big blow to the frantic efforts of the government to address the national demands.

The introduction of LNG in the supply chain is meant to supplement the local gas supply, which has run short of demand for several years. Considering the fact that demand is increasing at a fast rate and local supply decreasing, the gap between demand and supply will grow. But is depending on imported LNG the right solution? Or is there an alternative way of addressing the

New variant, same old travel woes



has taken a big toll on the tourism industry in countries that rely on foreign visitors. As new waves of infections take hold and everchanging rules to curtail the spread

of the disease are

put in place, the overall effect is increased uncertainty—which undoubtedly is harming global tourism. "I'm so frustrated that they keep changing the travel rules," Cath Colbridge of the UK told a reporter. "It's got to the point now that we've given up planning holidays abroad and bought a camper van, so we can at least get away for a few days.

In this piece, I will offer tidbits of news, some bad and some good. The bad ones pertain to how the Covid-19 variants have been endlessly eating away at the travel and tourism (T&T) industry. The good news is about how, in the midst of the busy travel season, the valiant workers at the Dhaka Airport are making every effort to give the weary travelers a helping hand.

As if the T&T sector hasn't had enough, on December 20 many nations announced new rules on gatherings and travel ahead of the busy holiday season. With the Omicron variant spreading fast across the globe, governments and health organisations, including the WHO, are now advising travelers to exercise caution, and if necessary, to postpone their trips within their respective countries and abroad. One hardly needs to be reminded that last summer, as people got vaccinated and started to move about after more than a year of "confinement", the Delta variant put a damper on the travel plans for many, and as governments tried to cope with a resurgence of illnesses, infections, and spread of Covid-19, the initial optimism soon gave way to another round of frustrations.

We are now in the midst of winter and the holidays, which is a busy travel season in the northern hemisphere. The tourism industry is trying to get back on its feet. While talking with many of my associates in Bangladesh, I have gathered that the average tourism revenue is low except for

a few large and resourceful resorts. Locals are travelling, but visitors from abroad have dwindled to a trickle. Eco-tourism is almost nil, and the Hospitality and Tourism Sector (HTS) has been crying out, unsuccessfully, for government support since the pandemic started in March

Tourism takes another hit The new Omicron variant, the changing rules for travel, and the continuing uncertainty are adversely affecting tourism once again. The rules for traveling to each country are different. The quarantine

Omicron variant. Even if infections prove mild, the variant's speed will have grave consequences. The big reason is that Omicron appears to spread far more readily than the delta variant that has been dominant worldwide since the summer—Omicron is 25 to 50 percent more transmissible, according to some UK estimates.

One of my relatives travelled from Dhaka to Bangkok with his family. The next few days while in quarantine were chaotic for them. There were tests every day, self-isolation, and food was delivered to the hotel room. And all this at your

"If you have a burst of infection worldwide, a shock, what does the world look like on the other side of it? Is it, 'The war is over,' or, 'The war has just entered another phase?' We haven't begun thinking about any of

Getting a PCR test in Dhaka Earlier this month, I was in Dhaka when the American government announced that, effective from December 6, all passengers traveling to the USA would need to have a PCR test done one calendar day before travel.

When I contacted the testing clinic in Dhaka operated by PRAAVA, I was told

that if I was travelling, say, on December 15, that I could not get my test on December 14. So, I inquired about taking the test on the evening of December 14 to be within the 24-hour window. But I was informed that PRAAVA did not take any samples after 12 noon. Therefore, I had to take the test on the morning of December 15. When I told them that I planned to fly out on the night of December 15, a staff member asked me to stop by the clinic at Banani to pick up the result at 5pm, just before I was to head out for the airport.

The reason I mention all this in great detail is to relay my belief that the average Bangladeshi (and I later learned many foreign travelers) would be misled by the wrong information that the clinic was operating under. On the Centers for Disease Control and Prevention (CDC) website, it was announced that the new Global Testing Order shortens the timeline for required testing for all international air travelers to one day before departure to the United States. But, there is a big difference between 24 hours and the one calendar day requirement, as the CDC itself clarifies, "A passenger whose flight to the United States is at any time on a Sunday would need to have a negative test taken at any time on

At Dhaka airport, a fellow passenger mentioned that we needed to get a stamp from a DGHS official in one remote cubicle. We then realised that the counselor at PRAAVA had failed to inform us of two important steps after the results (in PDF form) were available: 1) Unlike in the USA, a hard copy of every test result must be printed from a government database, and 2) The printout had to be stamped at the DGHS counter in the airport.

There was a long queue at the departure lounge with almost 50 people ahead of me waiting to get a seal on their printout. Compounding our problem, PRAAVA failed to upload our results on the official database. A DGHS staff member directed us to Room 2 at the end of the departure lounge. There, Ashiq and his co-workers were very eager to help, but could not find our test results using either our passport numbers or phone numbers. Ashig made calls to PRAAVA, and after two hours of running around, we finally got the documentation we needed.

As Myanmar is shred into pieces, can its people unite to stop the Tatmadaw?



E couldn't stand to watch it so we kept our heads down, crying . . . We begged them not to do it. They didn't care. They asked the women, 'Are your husbands among them? If they are, do your last rites'," a woman from Myanmar's Keni

Township, whose brother, brother-in-law and nephew had been brutally murdered by the notorious Myanmar military—also known as the Tatmadaw—told the BBC during an investigation.

In July this year, the Tatmadaw had gone on a revenge-killing spree in the Keni Township—a stronghold of sorts for the forces opposed to the ruling military junta. The People's Defence Force, a militia of civilian groups fighting for democracy, had earlier intensified their anti-military activities in the area, including clashes with the soldiers. The outcome was the Tatmadaw's ruthless and brutal mass killing of the locals of the township. In multiple attacks in July 2021, the Myanmar soldiers had gone from door to door in four villages-Yin, Zee Bin Dwin, Taungbauk and Shikoetat forest—rounding up the men, torturing them with rifle butts, beating them up with stones, and then burying their mutilated bodies, at times in half-alive state, in shallow graves.

At least 40 corpses have been recovered from mass graves in the four villages, including a small body, most likely that of a child.

Among the murdered was a 60-year-old man, who had been tied to a plum tree and tortured for hours—the numerous marks on his lifeless body a testament to the unspeakable horrors he had to endure in his final hours. Some of the soldiers involved in the bloody killings were as young as 17-18. The Myanmar military junta did not deny the allegations, saying, "It can happen ... When they treat us as enemies, we have the right to defend ourselves." The comment of General Zaw Min Tun, Myanmar's

Deputy Minister for Information and military spokesperson, holds ominous portents for the future of democracy and human rights in the country

The Myanmar junta carried out multiple air strikes since December 22, on the Karen State's Lay Kay Kaw town, in southeastern Myanmar—a stronghold of the Karen National Union. This was the result of fresh raids by military soldiers to subdue the Karen fighters, protesting against the military rule. The clashes since last week and the subsequent air

San Suu Kyi, in the early hours of February 1, 2021. Since then, the country has been embroiled in a bloody struggle between the usurpers and the civilians calling for the return of democracy. At least 1,300 protesters and civilians have been killed since then, as conflicts between the two parties continue, according to data from Assistance Association for Political Prisoners—a Thailand and Myanmar based human rights organisation—as cited by UK-based news outlet The Independent.

raids—in which the military has not only been firing artillery at the locals but also dropping bombs—have led to the displacement of more than 4,200 Karen people, who fled to Thailand. Unofficial estimates put the figure at nearly 10,000. Some shells even fell on the Thai side, according to The Irrawaddy news site.

The Tatmadaw, in a swift coup d'état, ousted the democratically elected government of National League for Democracy led by Aung Countless children have also fallen victim to the atrocities committed by the Tatmadaw. A BBC report from April 2021, citing Save the Children, revealed that since February 2021, at least 43 children have been killed in Myanmar by the country's military. The Tatmadaw not only unleashed a bloody nightmare on the civilians but also ensured that they do not get access to medical care, as they attacked hospitals and medical staff tending to the injuries of the protestors.

In response to the attacks on the Karen community, the Ambassadors, Chargés d'Affaires, and Heads of Mission from Australia, Canada, the Delegation of the EU and European Union Member States with presence in Myanmar—Czech Republic, Denmark, Finland, France, Germany, Italy, Netherlands, Spain, and Sweden—as well as New Zealand, Norway, Switzerland, the United Kingdom and the United States, have signed a joint statement in which they have reiterated "condemnation of the serious human rights violations committed by the military regime across the country" and called on the "regime to immediately cease its indiscriminate attacks in Karen State and throughout the country, and to ensure the safety of all civilians in line with international law"

While the international community has condemned the misadventures of the Myanmar military after the coup, with the US and some other countries even imposing sanctions against the military generals involved, the measures are too little, too late.

Myanmar has a history of bloody military rule and suppression of civilians. Starting from the regime of General Ne Win to the dissolution of military rule in 2011, the country has witnessed numerous clashes between the military and civilians. During this time, the Rohingya, along with some other minority groups including Karen and Kachin, have been systemically cornered and persecuted by the country's military. The Rohingya especially had been forced to endure genocidal and ethnic cleansing attempts by the country's military. And the Tatmadaw continued these atrocities almost unchecked, with muted, templated responses from the international community.

Over the years, the Tatmadaw has wielded enormous power and in the process has amassed even more. The vicious crimes of the Tatmadaw now feels like a déjà vu, at times it even reminds one of Nietzsche's philosophy of the Eternal Return: "This life as you now live it and have lived it, you will have to live once more and innumerable times more; and there will be nothing new in it, but every pain

and every joy and every thought and sigh and everything unutterably small or great in your life will have to return to you, all in the same succession and sequence—even this spider and this moonlight between the trees, and even this moment and I myself. The eternal hourglass of existence is turned upside down again and again, and you with it, speck of dust!"

The silence of the international community over the ethnic cleansing of the minority communities in Myanmar, and in the heydays, their bolstering trade tied with the Myanmar military held business conglomerates and holdings—some countries have also directly invested in the economic zones in Myanmar, built on lands once belonging to the now uprooted Rohingya—have empowered them with not only the acknowledgment but also economic resources to carry on with their nefarious activities.

In addition, the inaction of the majority during the persecution of the minority communities has also added to the Tatmadaw's power. The communal divide within Myanmar has created just the right environment for the military to continue to belligerently violate the basic human rights of its people.

The Tatmadaw has turned into a monster—a Wendigo to be specific—that is now feeding on its own people to quench its insatiable craving for human flesh. And now this monster cannot be controlled, neither with sanctions nor any other form of threats form external actors. The only way this monster can be contained is by creating a united internal front against it. It is only the people of Myanmar—majority and minority alike, irrespective of religion or ethnicity—united together that can put up a resistance against the crimes of this monster and put an end to its killing spree. That is the only way out for the civilians.

But the question remains, can the people of Myanmar rise above their communal rifts for the greater benefit of the nation, of the future generations? Only time will tell.

Circularity in SMEs: The what, why, and how



HE world is being plagued by a global pandemic, climate change, biodiversity loss, rising demand for food and scarcity of natural resources, to name a few. Our irresponsible consumption and

consumption and production are the root causes of humanity's multifarious problems.

The traditional consumption and production process is based on a linear economic system that follows the "takemake-use-waste" resource utilisation pattern. The circular economic system is an alternative to the linear economic system since it utilises resources in a restorative and regenerative manner, resulting in no waste. That is, the circular economy is a model of consumption and production that focuses on reducing, refurbishing, recycling, and reusing resources—benefiting both the economy and the environment.

The World Resource Institute (WRI) postulates that we can cut global greenhouse gas emissions by 39 percent (22.8 billion tons) simply by implementing circular strategies in our existing linear consumption and production process. The Washington-based think tank also estimates that the circular economy offers USD 4.5 trillion worth of economic opportunity through sustainable economic growth.

Recently, at the 26th UN Climate Change Conference of the Parties (COP26), the biggest climate conference on earth, Bangladesh presented the "Mujib Climate Prosperity Plan" to tackle climate change. We have committed to implementing the plan by 2030. Furthermore, we have committed to achieving the United Nations' 17 Sustainable Development Goals (SDGs) by 2030. One of the SDG goals is responsible consumption and production (SDG 12). Achieving SDG 12 is impossible without effectuating circularity

in our consumption and production process. Surely, it will help us achieve not just SDG-12 but also the other SDGs.

Numerous economic entities are involved in our consumption and production process. All economic actors need to embrace circular thinking to unleash the power of a circular economy in terms of socio-economic and environmental benefits. The World Bank (WB) estimates that small and medium-sized enterprises (SMEs) account for more than 90 percent of businesses worldwide. According to the BBS Economic Enterprise Census 2013, SMEs (including cottage and microbusinesses) account for more than 99 percent of all enterprises in Rangladesh Hence SMFs have a crucial role in implementing a carbonneutral circular economy as an integral part of our economy.

SMEs have enormous economic and environmental impacts as a group, though individually, their impacts are small in most cases. Moreover, SMEs have vertical and horizontal linkages with large enterprises. Such connections make SMEs strategically important to a true circular transition.

Generally, being more malleable than their larger counterparts, SMEs are more likely to adopt circular business practices. Nevertheless, SMEs face many capacity constraints because of their size, whereas the capacities of large enterprises facilitate the acceptance of and realisation of returns from a circular economy-based business model. Some critical limitations include limited access to finance, lack of knowledge and understanding of the circular economy, the dearth of technical and managerial capacity, and the absence of an SME-friendly regulatory framework.

Of course, there is no single way to support SMEs to surmount these obstacles. Through collective transition efforts, SMEs can integrate circularity into their operations; all they need to know is what, why, and how to do so. This is where business leaders, financiers, policymakers, international

development agencies, and other stakeholders

In most instances, large corporations can finance the circular transition internally through their retained earnings or other internal sources of finance, whereas SMEs are often dependent on external financing to design, manufacture, and use products in a circular way. Unfortunately, many a financier aren't acclimated to the correct assessment of the risks and opportunities associated with circular project financing. By formulating a circular economy financing strategy to improve understanding and knowledge of circular economy concepts among banks and other financial institutions, we can bridge the

financing gap in SME circular projects.

Thanks to technological advances in

Thanks to technological advances in both recycling and upcycling, we have an opportunity to leapfrog to a circular economy now. However, because of the upfront costs of installing circular technologies, most SMEs may not find it financially feasible to overhaul their current linear business models. That is why we need to make technologies more accessible and affordable for SMEs to redesign their manufacturing processes to increase reuse of industrial waste potential and recyclability.

We all know that SMEs, particularly startup SMEs, are receptive to new ideas and innovations. Initiating reforms in the ease of doing business will help attract foreign direct investment (FDI) as well as circular management skills and expertise from multinational enterprises to our local SME landscape.

A regulatory framework for the circular economy is imperative. Policymakers should come up with a streamlined and SME-friendly regulatory framework to promote circularity practices among our SMEs. For instance, we may reward eco-inclusive SMEs through tax breaks, subsidies, and other financial incentives for a systemic transformation.

Finally, to foster the uptake of circularity systems among SMEs, awareness of the circular economy is a must. Appropriate policy initiatives to raise awareness about responsible consumption and production will invigorate the acceptance of circular business models among SMEs. Finland, a global forerunner in the circular economy, has already taken such an initiative—called the "Program for the Promotion of Low-Carbon, Circular Economy and Digital Transformation", to encourage SMEs to accept circular economic approaches.

Bangladesh is one of the world's fastest booming economies, and it is anticipated to double its USD 409 billion economy by 2030, aiming to become a higher middleincome country. Concomitantly, our stellar economic growth is intertwined with sustainability challenges. As a country that has a pivotal role to play in the climate change debate, Bangladesh must make solid strides in transforming into a circular economy. Otherwise, we will be one of Asia's largest carbon emitters while being a higher middle-income country by 2030, which is inconsistent with our zero-carbon growth stance. So, let's walk the path of circularity by supporting our SMEs to ensure inclusive and sustainable development and prosperity.

Coalition launches 'largescale' Yemen operation

AFP, Riyadh

The Saudi-led coalition yesterday launched a "large-scale" assault on Yemen after missiles fired by Iran-backed Huthi rebels killed two people in the kingdom, the first such deaths in three years.

The Huthis warned Yemen's oil-rich northern neighbour of a "painful" response if the coalition does not stop its "aggression" against the conflict-riven country.

Yemen has been wracked by civil war since 2014 pitting the internationally recognised government supported by the Saudi-led military coalition against the Huthis who control much of the north.

Tens of thousands of people have since been killed, in what the UN has described as the world's worst humanitarian crisis.

The latest violence came overnight when two people -- one Saudi and the other Yemeni -- were killed in the projectile attack on Jazan, said Saudi's civil defence.

"A military projectile fell on a commercial store on the main street, resulting in two deaths," it said, adding six Saudis and a Bangladeshi national were wounded.

Images from the official Saudi Press Agency purportedly of the aftermath of the attack showed a large crater in the ground and destroyed vehicles.

The Saudi-led coalition said shortly afterwards that it was "preparing for a largescale military operation". It later launched



an air strike in which "three civilians including a child and a woman were killed, and six others were wounded", Yemeni medics told AFP.

The coalition will hold a news conference today to address the latest developments, the Saudi authorities said.

Earlier Huthi spokesman Yahya Saree said the rebels had launched three ballistic missiles on Jazan, a southern region of the kingdom bordering Yemen.

The insurgents often launch missiles and drones into Saudi Arabia, targeting its airports and oil infrastructure. The latest was the first in more than three years that has resulted in fatalities in the kingdom, which recorded its first death from a Huthi missile attack when a missile struck Riyadh

It also comes as fighting between the two sides intensifies, with the coalition ramping air strikes on Sanaa

PROTEST MARCH AGAINST MILITARY RULE IN SUDAN

Tear gas fired, internet cut

Sudanese security forces fired tear gas to disperse protesters in the capital Khartoum yesterday as the opponents of military rule marched towards the presidential palace, a Reuters witness said, while internet services in the city were also cut.

It is the 10th day of major demonstrations since an Oct. 25 coup, with protests continuing even after Abdallah Hamdok was reinstated as prime minister on Nov. 21. The demonstrators have demanded that the military have no role in government during a transition to free elections

In neighbouring Omdurman yesterday, security forces also fired tear gas at protesters around 2 km away from a bridge connecting the city to central Khartoum, another Reuters witness said.

Internet services were disrupted in the capital, Khartoum, and soldiers blocked roads early in the day, the witnesses said.



Locals were also unable to make or receive calls domestically.

Despite the internet being cut off, people were still able to post on social media, with images showing protests taking place in several other cities including Madani and Atbara.

At the same time, soldiers and Rapid Support Forces were out in force blocking roads leading to bridges

linking Khartoum with Omdurman, its sister city across the Nile river, they

The SUNA state news agency reported that the province of Khartoum closed bridges on Friday evening in anticipation of the protests.

UN Special Representative to Sudan Volker Perthes urged Sudanese authorities not to stand in the way of yesterday's planned demonstrations.

"Freedom of expression is a human right. This includes full access to the Internet. According to international conventions, no one should be arrested for intent to protest peacefully," Perthes said.

The military could not immediately be reached for comment.

A march planned for Saturday is due to converge on the presidential palace and the demonstration will end at 5:00 pm (1500 GMT), organisers

Forty-eight people have been killed in crackdowns on protests since the coup, the Central Committee of Sudanese Doctors said.

Won't enrich uranium beyond 60pc if talks fail

Says Tehran ahead of resumption of nuke talks

Iran has no plans to enrich uranium beyond 60 percent if nuclear talks in Vienna fail, the head of the country's atomic agency said yesterday.

Atomic Energy Organization of Iran director Mohammad Eslami said the enrichment levels were related to the needs of the country, in remarks published by the Russian news agency RIA Novosti.

"Our targets related to enriching uranium are meeting our industrial and production needs... and those of our people," he was quoted as saying.

Asked whether Iran plans to enrich beyond 60 percent purity if the talks fail, he said "No'

Eslami was speaking ahead of the resumption on Monday of talks in Vienna aimed at reviving the 2015 Iran nuclear deal.

Iran's arch-rival Israel, which staunchly opposes the nuclear deal, had reportedly warned in November that the Islamic republic had taken the technical steps to prepare to enrich uranium to military-

grade levels of around 90 percent. Tehran insists its nuclear programme is

for peaceful purposes. The 2015 deal offered Iran relief from sanctions in return for curbs on its nuclear programme, but was derailed in 2018 when

the US unilaterally withdrew under then

president Donald Trump. Other parties to the deal have taken part in the talks, but the United States has only engaged indirectly.

While the US and its Western allies have repeatedly called on Iran to offer assurances on its nuclear programme, Tehran has insisted sanctions must be lifted first.

US negotiator Rob Malley on Tuesday warned of a "period of escalating crisis" if diplomacy failed to restore the agreement. In his interview with RIA Novosti, Eslami

said Iran's nuclear activities comply with the regulations of the UN's International Atomic Energy Agency. The IAEA recently expressed concerns

over Iran's stockpile of highly-enriched

uranium, however.

'Let's Go Brandon'

Caller taunts Biden during White House

Christmas event

President Joe Biden was trolled by a caller Friday who said "Let's Go Brandon" -- a coded insult that has become a rallying cry for supporters of Donald Trump -- during a White House Christmas Eve event.

The incident, which quickly went viral online, took place after Biden and First Lady Jill Biden spoke by video conference with North American Aerospace Defense Command (NORAD) officials, who track Santa's travel across the globe.

After being assured of St Nick's progress, the president fielded calls from several American families.

One man identified himself as "Jared," a father of four. Biden spoke briefly with the caller's children, asking what presents they wanted for Christmas and telling them they needed to be in bed before midnight. He also remarked on how he and Jared both had sons named Hunter.

Wrapping up the call, Biden wished Jared a "wonderful Christmas."

"I hope you guys have a wonderful Christmas as well, Merry Christmas, and let's go Brandon!" Jared replied.

"Let's go Brandon, I agree," returned Biden, without reacting to the dig. It was not immediately clear if the president

had understood the reference, though Jill Biden chuckled uncomfortably and

Biden asked Jared where he was calling from, but by then the call had been disconnected. A clip of the moment spread widely on social media, with some praising the president for his calm response.

"Let's Go Brandon" is a euphemism for a vulgar insult that originated when a reporter at a NASCAR event misheard chant of "F- Joe Biden" while interviewing driver Brandon Brown in September.


Since then it has been taken up as political slogan by supporters of Trump, Biden's predecessor.

Trump had his own headlinegrabbing Christmas Eve moment when, in 2018, he raised doubts about Santa's existence in a call with a seven-year-old

30 killed, 'bodies burnt'

Say reports; rights groups condemn brutal killings

More than 30 people, including women and children, were killed and their bodies burnt in Myanmar's conflict-torn Kayah state on Friday, according to a local resident, media reports and a local human

Karenni Human Rights Group said they found the burnt bodies of internally displaced people, including elders, women and children killed by the military that rules Myanmar, near Mo So village of Hpruso town yesterday.

"We strongly denounce the inhumane and brutal killing which violates human rights," the group said in a Facebook post.

The Myanmar military said it had shot and killed an unspecified number of "terrorists with weapons" from the opposition armed forces in the village, state media said. The people were in seven vehicles and did not stop for the military,

The Myanmar military could not immediately be reached for comment.

Photos shared by the human rights group and local media showed the charred remains of bodies on burnt-out

The Karenni National Defence Force, one of the largest of several civilian militias power.

opposing the junta that led a Feb. 1 coup, said the dead were not their members but

civilians seeking refuge from the conflict.

"We were so shocked at seeing that all the dead bodies were different sizes, including children, women and old people," a commander from group told

Reuters, asking not to be named.

A villager who asked not to be named for security reasons said he was aware of the fire on Friday night but could not go to the scene as there was shooting.

"I went to see this morning. I saw dead bodies that had been burnt, and also the clothes of children and women spread around," he told Reuters by phone.

Myanmar has been in turmoil since the military overthrew the elected government of Nobel Prize laureate Aung San Suu Kyi almost 11 months ago, claiming fraud in a November election that her party had won.

Civilians enraged by the coup and subsequent crackdown on protesters have been taking up arms. Many local resistance forces have sprung up across the country.

The military has outlawed many opponents, labelling them traitors or terrorists, including a self-proclaimed National Unity Government that seeks to lobby the international community and prevent the junta from consolidating



'Value the little things in life' Pope calls for dialogue, humility

in Christmas message

Pope Francis yesterday urged dialogue on both personal and political levels as he celebrated a second Christmas under the shadow of a coronavirus pandemic that was pushing people into isolation.

In his traditional Urbi and Orbi Christmas Day message to the faithful gathered in St Peter's Square at the Vatican, the pontiff also deplored that the "immense tragedies" in Syria, Yemen and Iraq were "being passed over in silence" and cautioned against fresh violence in the simmering conflict in Ukraine.

Around the world, "we continue to witness a great number of conflicts, crises and disagreements. These never seem to end; by now we hardly even notice them. We have become so used to them that immense tragedies are now being passed over in silence," he said.

On Friday, the Pope called on the faithful to value the "little things in life" and show solidarity with the poor in his Christmas Eve mass in St. Peter's Basilica.

The 85-year-old Argentinian pontiff recalled the shepherds in the tale of the nativity, who lived modestly and were witness to the birth of Jesus. "That is where Jesus is born: close to them, close to the

forgotten ones of the peripheries. He comes where human dignity is put to the test. He called for people to seek out "littleness" -- in "our

daily lives, the things we do each day at home, in our families, at school and in the workplace". "Jesus asks us to rediscover and value the little things in

life," he said. Francis, formerly the Archbishop of Buenos Aires Jorge Mario Bergoglio, called for more solidarity with those

'Putin wants to destroy Ukraine'

Russian President Vladimir Putin is bent on destroying Ukraine but there is no major risk of an imminent invasion, a senior Ukrainian security official said on Friday.

Speaking to AFP in an interview, Öleksiy Danilov, secretary of the National Security and Defence Council, said that talk of Moscow's invasion could destabilise Ukraine and play into Putin's hands.

Putin wants to destroy our country. Will he succeed? No, he will not," said Danillov.

"Our citizens will protect our country," he said, adding that both the army and civilians will form a broad national "resistance" movement if Russia attacks

"We are going to protect our country. Full stop." Tensions have been building since mid-November when Washington sounded the alarm over a massive Russian troop build-up on Ukraine's border and accused Putin of plotting

But Danilov, 59, downplayed the risk of a major military escalation, saying Ukrainian officials have not seen any "critical build-up.

an invasion.

According to Kiev's estimates, the number of Russian troops along Ukraine's borders has increased from around 93,000 troops in October to 104,000 now.

"We don't think this is a big surge," Danilov said.

Iran: Drills in Gulf warning to Israel

War games conducted this week by Iran in the Gulf were intended to send a warning to Israel, the country's top military commanders said on Friday, amid concerns over possible Israeli plans to target Iranian nuclear sites.

The Revolutionary Guards' war games included firing ballistic and cruise missiles. State television showed missiles flattening a target which resembled Israel's Dimona nuclear reactor at the conclusion of the exercises "Through a simulation of the Dimona atomic facilities,

the Revolutionary Guards successfully practiced attacking this critical centre of the Zionist regime in its missile exercise," the semi-official news agency Tasnim said. "These exercises had a very clear message: a serious, real

. warning to threats by the Zionist regime's authorities to beware of their mistakes," Guards chief General Hossein Salami said on state TV. "We will cut off their hands if they make a wrong move.

.. The distance between actual operations and military exercises is only a change in the angles of launching the missiles," Salami added.

Armed Forces Chief of Staff Major General Mohammad Bagheri said 16 ballistic missiles of different classes had been fired simultaneously and had destroyed predetermined targets.

Britain condemned the launch of ballistic missiles during the war games.

"These actions are a threat to regional and international security, and we call on Iran to immediately cease its activities," the Foreign Office said in a statement. Iran's Foreign Ministry spokesman, Saeed Khatibzadeh,

rejected the British statement as "meddling in Iran's defensive capacity," state media said. Iran says its ballistic missiles have a range of 2,000 km

and are capable of reaching arch-foe Israel and U.S. bases in the region.

Iran has one of the biggest missile programmes in the Middle East, regarding such weapons as an important deterrent and retaliatory force against US and other adversaries in the event of war.

Israel, which opposes efforts by world powers to revive Tehran's 2015 nuclear deal, has long threatened military action if diplomacy fails. Iran says its nuclear ambitions are peaceful.

Israeli Defence Minister Benny Gantz has called on world powers not to allow Iran to play for time at the nuclear negotiations, in recess at Iran's request and scheduled to resume next Monday.

Israel is widely believed to be the only Middle Eastern country with a nuclear arsenal.

MALAYSIA FLOODS Death toll rises to 46

The death toll from Malaysia's worst floods in years rose to 46 yesterday, with five people still missing, officials said, as work crews continued a massive clean-up on Christmas day.

Days of torrential rain caused rivers to overflow last weekend, swamping cities, cutting off major roads, and forcing tens of thousands of people to flee their homes

Selangor -- Malaysia's most densely populated and wealthiest state, encircling the capital Kuala Lumpur -- has been one of

the worst-hit areas. The Southeast Asian nation is hit by floods annually during the monsoon season, from November to February, but those at the weekend were

the worst since 2014. Global warming has been linked to worsening floods. Because a warmer atmosphere holds more water, climate change increases the risk and intensity of flooding from extreme rainfall.

Russia blocks rights monitor website

Accuses it of promoting 'terrorism' and 'extremism'

Russia has blocked the website of a rights monitor tracking political persecution, saying it promoted terrorism and extremism, amid an unprecedented official crackdown on

The move comes in a year that has seen the opposition dismantled and scores of independent media and rights groups branded as "foreign agents" or banned outright. OVD-Info, which tracks opposition protests and also

provides legal support to victims of political persecution, said the Roskomnadzor media regulator had blocked its "At the moment, we have not received a notice and do not know the reason for being blocked," the group tweeted.

A Roskomnadzor registry of blocked websites showed that a Moscow region court had issued a ruling dated December 20 to "limit" access to the site. The website was not accessible by AFP journalists in

Russia yesterday. Later, Russian news agencies cited Roskomnadzor as confirming that it had blocked OVD-Info's website because the Moscow region court had ruled that the group's activities were aimed at promoting "terrorism and extremism" in Russia. Roskomnadzor added that it had sent "demands" to social media networks to "delete the

organisation's accounts". The pressure on social media companies to remove OVD-Info from their platforms comes after a Moscow court on Friday slapped Google with an unprecedented fine of nearly \$100 million, while Meta (formerly Facebook) received a fine of \$27 million for failing to remove banned content.

Fed Cup fiasco brings to fore myriad conflicts of interest



The Federation Cup descended into farce on Friday after defending champions Bashundhara Kings declined to participate, explaining their position to the game's local governing body 24

hours before the start of the tournament. They found Muktijoddha Sangsad as a spiritual ally and ahead of the scheduled kickoff, Uttar Baridhara and a number of other

clubs joined the bandwagon of withdrawal as both the scheduled matches on Saturday -- Bashundhara Kings v Swadhinata KS and Uttar Baridhara v Abahani -- did not see the ball roll.

This was an embarrassment in waiting for the Bangladesh Football Federation (BFF) even though it probably did not anticipate the rebellion would come from one of its own -- the Bashundhara Kings,a club owned by the Bashundhara Group, title sponsors of the tournament, and helmed by Imrul Hasan, one of its vice-presidents.

The premise for withdrawal of the most glamorous club in current football scene was a valid one as their appeal to shift the venue from the Birshreshtha Shaheed Mostafa Kamal Stadium, a venue which witnessed a number of serious injuries during the Independence Cup earlier this month, fell on deaf ears. What was more disturbing to Kings was the last-minute tweaking of the tournament fixtures, allegedly aimed at giving advantage to another club.

"We thought that the changes in fixture format was done to give advantage to a specific team. These sorts of events occurred many times before including in the Independence Cup. We had pent up grievance over time and our withdrawal was a reaction to that," Imrul told media, citing other issues where he felt the BFF was biased and hoping this 'jolt would help make BFF and its competitions committee more professional and honest in

BFF's senior vice-president Abdus Salam Murshedy appeared at an impromptu press conference at the venue in the evening, making a brave face and appearing adamant not to bow



"The Federation Cup will continue. If the scheduled matches don't take place tomorrow [Sunday], then we will see. Those who haven't come have made mistakes. Everything will go as per the bylaws of the tournament," Murshedy, also the chairman of the professional league committee, told reporters.

Whether Imrul and the revolting clubs had more weight in their arguments than the BFF is a matter of argument, but there is no denying that the points raised by the Kings exposed an age-old issue of our domestic football: conflict of interest. And that there are not just one or two cases of conflicts, in fact the structure of our domestic football is riddled with multiple such

For a starter, there is a weird case of such conflict regarding this very tournament, namely the Bashundhara Group Federation Cup. Isn't this quite unheard of that a major group of companies of the country sponsors a tournament where one of its clubs are title contenders? Can we rule out any undue

partiality from some other clubs including Sheikh Jamal DC in the past and Police FC more recently -- are to be true. When the president of a top-tier club also acts as a vice-president of the federation, aren't such questions and suspicions obvious?

While Imrul did not take any names, it is not hard to imagine that he was pointing his finger at Abahani, the club purportedly the subject of the tweak in fixture and one that is helmed by one of his colleagues at the BFF.

These are some of the issues that have been swept under the carpet for far too long, stunting the growth of domestic football. In the past, we've seen cases of match-fixing proved, albeit after initially being denied by the federation and some small-time culprits bearing the brunt. 

collective effort worth drawing inspiration from. However, Mahmud did mention that rare Test upon which the Tigers are looking to improve on in the crucial two-Test series, part of the World Test Championship, starting from January 1.

"The Wellington Test in 2016 (in January 2017) was different. We only lost that game after tea on the final day. We are taking inspiration from that Test. If we were able to declare the innings after scoring 595 for the loss of eight wickets in that game, then we want to do something better this time around," Mahmud added.

In that game, Shakib Al Hasan's 217 and skipper Mushfiqur Rahim's 159 coupled with fifties from Tamim Iqbal, Mominul Haque and Sabbir Rahman helped Bangladesh pile up a mammoth first-innings total that eventually helped them take a 56-run lead in the second innings. That first innings was probably one of the very few occasions when Bangladesh's batters were able to display a collective approach in New Zealand. However, despite taking the game into the last session, a torrid final day and a disappointing batting display in the second innings saw the Tigers lose by seven wickets.

The Tigers, who arrived in Tauranga from Christchurch on Friday, enjoyed a break yesterday. The Mominul Haque-led side will have three more practise sessions and a two-day warm-up game against New Zealand XI on December 28 and 29 before the first Test.

India have enjoyed recent success in Australia and England, but South Africa remains a mighty challenge for the top ranked Test side, though they will arguably never have had a better chance against a home team going through a transition period and with far less experience than in the past.

'Ît is a great challenge and a great opportunity for everyone," Dravid told reporters on Saturday. "It is something you look forward to as a batsman, the chance to play away from home and test yourself against picking five bowlers, which he

some really good opposition in their home conditions.

"A lot of your career is defined by those sorts of performances, so it is a great opportunity for everyone in the group to put in the performances that are something that they can remember, and people will remember them for."

South African captain Dean Elgar said he thought the teams were evenly matched.

In South Africa's favour, Centurion has been a fortress for the home side, with 21 wins and only two defeats in 26 Tests at the venue.

'Players deserve credit for Villa's rise'

London

Steven Gerrard said Friday his players deserved the credit for Aston Villa's climb up the Premier League table since he took charge of the Birmingham

Villa had lost five straight league matches and were just two points above the relegation zone when Gerrard left Scottish champions Rangers to replace Dean Smith, sacked as manager in November.

Since Gerrard's arrival at Villa Park, the club have climbed from 16th to 10th and will be bidding for a fifth win in seven league games when they are at home to Chelsea on Sunday.

"I had confidence and belief that we could come in and have the impact that we've had," said Gerrard, who brought several of his coaching staff with him from Glasgow giants Rangers.

"The players deserve the credit for going and carrying those performances out."

The former Liverpool and England captain added: "Once I started talking to Villa, the very first thing I did was look at the fixtures in the short-term.

"There were a lot of fixtures to be excited about, and I think the players have done extremely well in terms of the points return."

Under Gerrard, Villa have beaten Brighton, Crystal Palace, Leicester and Norwich while losing narrowly to title contenders Manchester City and Liverpool.

'Barrel', **Boland** and the MCG



Australia have illustrated the depth of their fast bowling stocks by handing Scott Boland a surprise debut in the third Ashes Test against England.

Boland's transformation from a 118kg batting allrounder at Frankston-Peninsula to Australia's second Indigenous male Test cricketer in 144 years completed when Australia dropped a Christmas Day bombshell after confirming Boland will make a dream home Test debut and be given the chance to bowl Australia to Ashes glory at the MCG.

The MCG specialist, who hails from the Gulidjan tribe near Colac in western Victoria, joins Faith Thomas, Jason Gillespie and Ashleigh Gardner as players of Indigenous descent to feature at Test level.

Boland, who played the last of his 17 international limited-overs matches in 2016. has an enviable record at the MCG which, until recent seasons, had a reputation for being a bowlers' graveyard.

The 32-year-old's record of 91 wickets at 25.71 in 26 first-class games at the 'G is impressive given most of his matches there have been on docile, unresponsive surfaces.

Australia skipper Pat Cummins said Boland record at the Melbourne Cricket Ground factored into their thinking. Boland's 272 first-class wickets have included

42 in his past six games at the 'G at an average of

Govt's borrowing from banks surges

The government's borrowing from the banking sector surged this fiscal year mainly due to the lower investment of general people and firms in national savings tools. The government took loans of Tk 22,344 crore from banks between July 1 and December 14, data from the Bangladesh Bank showed. It borrowed Tk 26,078 crore last fiscal

Although the accelerated borrowing is yet to put any adverse impact on the private sector, this may bring about a credit crunch in the banking sector in the coming months if the current trend of public borrowing continues.

At least 30 killed in Greece

Greek coast guards scoured for survivors in the Aegean Sea yesterday after the latest in a series of migrant boat accidents that have killed at least 30

Late Friday, the coastguard found 16 bodies, including those of three women and a baby, and rescued 63 people from a boat that overturned and sank near the island of Paros.

According to those rescued, around 80 people had been on the vessel that was bound for Italy.

Smugglers operating from Cesme and Bodrum on the Turkish coast are packing migrants in yachts to send them to Italy using new, more dangerous routes, according to the ERT television channel. Three coast guard patrol boats, private vessels, a coast guard plane as

vell as divers searched for more survivors, officials said.

The latest tragedy -- the third since Wednesday -- came amid high smuggler activity not seen in Greek waters in months.

Hours earlier, 11 bodies were recovered from another boat that ran aground on an islet north of the Greek island of Antikythera on Thursday

Coast guard said on Saturday that two of the rescued migrants -- both men suspected of being the smugglers -- were arrested. Ninety people stranded on the islet were rescued.

And on Wednesday, a dinghy carrying migrants capsized off the island of Folegandros, killing at least three people. Thirteen people were rescued, while dozens remain missing, Greek

authorities said. Survivors gave conflicting accounts: Some said there had been 32 people on board, while others put the number around 50, a coast guard

official told AFP.

Most powerful telescope launched



The world's most powerful space telescope yesterday blasted off into orbit, headed to an outpost 1.5 million kilometres (930,000 miles) from Earth, after several delays caused by technical

The James Webb Space Telescope, some three decades and billions of dollars in the making, left Earth enclosed in its Ariane 5 rocket from Kourou Space Centre in French Guiana.

It is expected to take a month to reach its remote destination.

It is expected to beam back new clues that will help scientists understand more about the origins of the Universe and Earth-like planets beyond our solar system.

Israel orders 100,000 Pfizer's new Covid pill

Israel has ordered 100,000 units of Pfizer Inc's anti-viral COVID 19 pill Paxlovid for people aged 12 and older at risk of severe illness, an Israeli official said on Saturday, confirming a television report.

Channel 12 TV said Israeli Prime Minister Naftali Bennett agreed the deal in a phone conversation with Pfizer CEO Albert Bourla. There was no immediate confirmation from the company.

The first oral and at home treatment for COVID-19, Paxlovid was nearly 90% effective in preventing hospitalizations and deaths in patients at high risk of severe illness, according to data from Pfizer's clinical trial. Recent lab data suggests the drug retains effectiveness against the Omicron variant, it said.
