JSD places plan for interim govt

Jatiya Samajtantrik Dal (JSD) yesterday proposed an interim government plan called the "national government", which will encompass representatives of all political parties.

The plan is similar to what then Jasad proposed in 1972, the "national revolutionary government", said JSD president ASM Abdur Rab while placing the plan at its programme at Jatiya Press Club.

"The government has proved that it doesn't believe in any neutral election model. They are using the Election Commission to fulfil their personal interests.

The national government will radically reform the constitution based on the fundamental spirit of the Liberation War -equality, human dignity and social justice -said Rab, an organiser of the Liberation War.

The proposed government will work to revive the constitutional institutions, establish rule of law, release political prisoners, form an independent EC and hand over power to elected public representatives.

It will form a constitutional commission to make the reformation, bring back "referendum", and democracy will be

established as the only rule of governance. Power of the PM and president will be balanced. A clause will bar anyone from becoming the PM after they complete two consecutive terms. The government will ensure separation of judiciary and administration, decentralisation of power, and self-ruled local governments.

Khelafat Majlish yesterday demanded that the president take initiative to form an election-time government to hold national polls in a free, fair and acceptable manner.

A seven-member delegation of the party said this while holding a dialogue, over formation of the next Election Commission (EC), President Abdul Hamid at Bangabhaban.

The president also held talks with Bangladesh Tariqat Federation, which is a part of the ruling Awami Leagueled alliance, at his official residence yesterday.

At the dialogue, Hamid regretted that all successive governments since independence failed to enact a law, in line with the constitution, on formation of the EC, according to party leaders.

Hamid yesterday held the two separate meetings with the parties as part of his ongoing dialogue process with registered political parties on formation of the next EC.

'TRANSITIONAL GOVT AHEAD OF

Emerging from the hour-long meeting around 6:00pm, Ahmad Abdul Kader, secretary general of Khelafat Majlish, administrative culture of Bangladesh has reached such a stage that it is be made to the constitution," the

By amending the constitution, a non-partisan, neutral election-time interim government must be formed, which will merely act as a 'supervisor', meaning that it will only carry out day-to-day work of the government and provide overall assistance to the Election Commission in the conduct of elections.

In its five-point proposal, Khelafat Majlish also proposed to enact a law, in line with the constitution, to strengthen the EC, and bring ministries of public administration, home affairs, and law under the EC, after announcing the election schedule.

'GOVTS FAILED TO ENACT EC'

Meanwhile, after the dialogue with the president around 5:00pm, Tariqat Federation Chairman Syed Nazibul Bashara Maizvandari, who led a sevenmember delegation, told reporters that the president regretted when they raised the issue of successive governments failing to enact a law on EC formation.

"The president expressed the same opinion as us and supported our proposal, that a law should be enacted as soon as possible.

Quoting Hamid, Nazibul said the president told them that questions will not arise if the law is enacted.

LAUNCH FIRE TRAGEDY

It was too much,

Professionals recount their side of the story

Professional duties called numerous people to Jiakul village and neighbouring areas in Jhalakathi. The areas are adjacent to the Sugandha river, where MV Abhijan-10 caught fire early Friday, resulting in 42 deaths and over hundred cases of injury.

Tanvir Ahmed, a journalist of private television channel Jamuna TV, went to collect information of the accident from Pirojpur. Speaking to this newspaper, he said in his 13 years in journalism, he is yet to see a worse incident.

"After reaching the spot, I broke SEE PAGE 4 COL 3 down mentally seeing the horrific

scenes all around. Living passengers with burn injuries, ashes of those burnt to death, distraught relatives, the area had the makings of a bad nightmare," he said.

"I would've surely lost it, if not for my professional responsibilities, as I knew it was my duty to cover the incident for the media," he said.

Khan Aktheruzzaman Shohag, a Pirojpur based videographer who went to the spot to record videos of the tragic accident, said "I could only keep working because of my years in this profession, otherwise I wouldn't be able to keep my calm and grind my way through all the terror that befell me.'

The saddest part is that although smoke and fire were observed early, the untrained and ignorant crew did not know any better to prevent the ultimate escalation. Is there a different brand of crew on other river crafts? The ship did not have a shred of means

to fight the growing heat and fire, nor did it have enough life-jackets and boats to evacuate the mortified people. The "sarengs" (masters and drivers) did not have the presence of mind to veer the ship to the riverbank. They could have saved countless lives had they yielded to the pleas

RECRUITING AGENCY Service charge must not cross

Says BMET DG at workshop

Tk 10,000

The service charge taken by recruiting agencies in Bangladesh to send workers to Malaysia should not exceed Tk 10,000, said Bureau of Manpower, Employment and Training (BMET) Director General Shahidul Alam yesterday.

"It [service charge] should be reasonable,' he said, responding to a question from the media during a workshop organised by BMET at its conference room in the capital.

Malaysia and Bangladesh recently signed a memorandum of understanding for employing Bangladeshis in the Southeast Asian

country.
According to the expatriates' welfare ministry, costs incurred in Malaysia, including service charge taken by Malaysian recruiting agencies, will be borne by employers.

The government is yet to fix a migration cost, which will be incurred in Bangladesh to send workers to Malaysia.

A CONTRACT OF TK 2.8CR

DB arrests 14 so far over question paper leak

An organised syndicate leaked the question papers of recruitment tests for five state-run banks in a contract of Tk 2.80 crore, an arrestee said in his confessional statement.

A team of detectives arrested Mizanur Rahman Mizan (37), an investor in the capital market, from Dhaka's Hatirjheel area on Sunday in this connection.

Shahadat Hossain, additional deputy commissioner of DB (Tejgaon), told The Daily Star that Mizan's name came up in the confessional statements of Jahangir Alam Jahid, a stenotypist at a Rangpur court and Rabiul Islam Robi, president of Peshajibi League in Rangpur -- who were arrested on December 13.

DB arrested 14 people, of whom eight, including Mizan,

confessed before a Dhaka court so far. During previous recruitment tests, Mizan acquired question papers from his relative Rashed Ahmed Bablu and gave those to Jahid and Robi.

Bablu and Mizan came to an agreement about the question papers of the five state-run banks in return of Tk 35 lakh, according to Mizan's statement.

Mizan offered to trade the papers to Jahid for Tk 1.20 crore. Jahid then offered to trade them to another suspect named Sohel for Tk 2.80 crore.

He paid Tk 20 lakh to Mizan in advance, from which Mizan paid Tk 6.25 lakh to Bablu.

Bablu sent the questions to Mizan via a messenger app around 9:00pm on November 5, who then forwarded them to Jahid.

When Mizan asked Bablu about his source, Bablu mentioned Mubin's name as his associate.

Following the leak, Bangladesh Bank had to cancel preliminary tests for hiring 1,511 cash officers in five stateowned banks.
