SATCHHARI FOREST CTTC recovers 15 mortar shells, huge bullets OUR CORRESPONDENT, Aoulvibazar

The Dhaka Metropolitan Police's Counter-Terrorism and Transnational Crime Unit (CTTC) recovered 15 mortar shells and four boxes of bullets during a search operation at Satchhari National Park in Habiganj yesterday.

Since 2014, yesterday's raid was the ninth consecutive arms recovery drive conducted in the park, also a popular tourist spot.

A number of senior law enforcement officials were monitoring the raid that was continuing as of filing this report around 6:00pm. Mohammad

Asaduzzaman, deputy inspector general (DIG) of police, said the operation was ongoing in some areas inside the park.

At the end of the search operation, more information will be shared, he further added.

On March this year, the Border Guard Bangladesh (BGB) members recovered 18 rocket launchers wrapped in polythene bags from the forest.

In another haul, the BGB members in a drive recovered 12 guns and 19 bullets from the same park on August 13.

Earlier, on November 24 in 2019, several explosives, including 13 rocket launchers were recovered from the forest.

Before that, 10 high explosive 40mm anti-tank rockets were recovered during a search operation at the park on February 2, 2016.

Moreover, Rapid Action Battalion (Rab) recovered 334 artillery shells, 298 rocket chargers, a rocket launcher, 16 machine-guns, a beta gun, six SLRs, an auto rifle and five empty machine gun barrels during separate operations from June 1 to September 17, 2014.

"We have been the worst sufferers of the devastation. We neither can cross the river free of cost nor can transport goods because of the disaster," he said.

Abu Bakkar Siddique Shyamal, the chairman of Gaddimari union parishad, said that he has already written to the Local Government Engineering Department (LGED) seeking its intervation to repair the flood-ravaged road. LGED authorities have inspected the area and confirmed that the road will be repaired soon.

"Even though it is a temporary ghat, teachers, students and farmers are not being charged for crossing it," he said.

Ashraf Ali Khan, executive engineer of Lalmonirhat LGED, said that preparations were being made to repair the road with emergency funds.

In the future, a bridge will be built on the broken part of the road. Funds would be sought to the higher authorities for the construction of the bridge, he said.

Ousted Swechhasebak League man extracting soil from river bank

Illegal soil extraction from the bank of Bhairab continues unabatedly in Jashore's Chaugachha upazila

An expelled leader of Awami Swechhasebak League has been illegally extracting soil from the bank of Bhairab river in Chaugachha upazila of Jashore district in the middle of the night despite an administrative ban on such activities.

Siddiqur Rahman, the expelled president of Awami Swechhasebak League Patibila village unit, has allegedly been carrying out the illegal act despite being warned by the local administration not to carry out the act.

Trucks loaded with the soil are being driven through farmlands crashing Robi crops, farmers said.

Farmers of Niamatpur, Ichapur, Muktadaha, Rostampur and Sadipur villages said the clique helmed by Siddiqur intimidated them saying that they were extracting soil 'managing' the administration.

Based on the allegation, the Chaugachha upazila nirbahi officer (UNO) verbally instructed Siddiqur to stop the act immediately.

However, one day after that order, the miscreants started soil extraction by changing the location.

According to the locals, they were first extracting soil from the banks of Bhairab at Niamatpur village in Patibila union of Chaugachha upazila.

Several mobile courts headed by Assistant Commissioner (Land) Kafi Bin Kabir conducted drives but the gang could

not be stopped.

On December 20, in response to the complaint of the locals, a team of Chaugachha Police Station seized a dump truck carrying soil. However, police released the driver along with the vehicle after taking an undertaking stating that they would not extract soil anymore, sources said.

Newly-elected UP member of Patibila Union Parishad (UP) Monirul Islam said that soil extraction is going on unabatedly at night.

On the other hand, the vehicles carrying soil are speeding through the village in the middle of the night. The crop fields are also being marred due to the movement of the vehicles, he said

It was seen that the poor drivers were the victims of jail and fines, however, the main culprits remain out of reach, said the UP member.

Ziaur Rahman Rintu, the convener of the Upazila Swechhasebak League, said that Siddiqur was expelled from all the posts of the party as he had extended his support to BNP-backed chairman candidate Ataur Rahman Lal in Patibila UP election held on November 11.

Contacted Siddiqur Rahman said that he stopped soil extraction after being warned by the UNO.

Upazila Nirbahi Officer (UNO) Erufa Sultana said mobile courts will be conducted to prevent the illegal act.

If necessary, regular cases will be filed against the culprits, said the UNO.

As many as 15 of the journalists prosecuted this year were arrested and subsequently jailed.

These journalists were accused in a total of 32 DSA cases, the speakers of the organisation went on to add.

"It is evident that the existing mechanisms have been struggling to protect citizens' right to express their views online and to address the challenges produced by the digital revolution in Bangladesh, said a statement circulated by Article 19.

Saudi Arabia yesterday executed a Yemeni man accused of plotting a suicide attack in the kingdom and of links to the Islamic State jihadist group, the interior ministry said.

The wealthy Gulf country, with one of the world's highest execution rates, has been the target of a series of deadly IS shootings and bombings since late 2014.

The seven arrestees are: Mohammad Nasir, Omar Khaiam, Jiban Hossain, Farhan Masum, Naveem, Kawsar Ahmed

However, Moshiur Rahman, president of Jhalakathi district unit of Bangladesh Red Crescent Society, said they prepared a list of 51 missing passengers.

Family members of the missing people are still desperately looking for their near and dear ones. They are visiting hospitals and offices of deputy commissioners (DC). Riding on trawlers, many are searching the Sugandha river to find their missing relatives.

Yesterday, family members of 35 missing people gave samples to Barguna General Hospital for DNA testing. The samples would be cross-matched with those from the bodies buried as unidentified launch passengers.

Md Harun, a resident of Barguna town, said: "My daughter Hanufa Akhter is a student of Islamic University. Hanufa along with her daughter was travelling on the launch to come to Barguna. They are still missing. Now I have come here to give samples for DNA testing."

Jony Hawlader, a resident of the capital's Demra area, said four of his family members, including his son, sister and niece, went missing.

"They were travelling to Barguna from Dhaka to visit a relative," he added.

Kalam Meer from Barguna town said his son was still missing. "I looked for him in the Sugandha River in the last three days, but in vain.'

Speaking to The Daily Star, volunteers of Bangladesh Red Crescent Society said many people on trawlers were still searching the Sugandha river for their missing relatives.

Najmul Alam, additional deputy commissioner of Jhalakathi, said a body

was recovered from the Sugandha river yesterday, but they were yet to ascertain whether it was of a victim of the launch fire.

"As the Barguna district administration is preparing the list of missing people, we have sent a photo of the body to Barguna," he added.

AM Saiful Islam, director at Barishal Sher-e-Bangla Medical College Hospital, said a total of 35 people, who sustained burns, were receiving treatment at the hospital. Three of them were at the intensive care unit.

Meanwhile, the parliamentary standing committee on the shipping ministry yesterday asked the authorities concerned to provide financial compensation to the families of the deceased and those injured.

It also asked the ministry officials concerned to make all arrangements to ensure free treatment of the wounded.

Russia increases jail sentence for Gulag historian

A Russian court yesterday increased to 15 years the jail sentence of a prominent Gulag historian who supporters say is being targeted for exposing horrors from the Soviet era.

In 2020, Yury Dmitriyev was sentenced to 13 years in prison on a controversial child sex charge in north-western Russia. In December, prosecutors requested that his sentence be extended by two years.
