AL sinks in its strongholds

Ruling party candidates' performance declining with every passing phase

Awami League candidates in Faridpur have never faced defeats as comprehensive as the ones they suffered in the fourth phase of union parishad polls held on Sunday.

Contenders of the ruling party had won all national elections from 1991 to 2018, except two by-polls, in Faridpur -- a district considered a bastion of AL.

But the picture was starkly different in Sunday's fourth phase of union parishad elections to 836 UPs.

Take the case of Boalmari upazila. Out of 10 union parishads in the upazila, AL nominated candidates lost in nine.

In the third phase on November 28, the picture was also very dismal as AL aspirants lost in 14 out of 15 unions in Bhanga and

Charbhadrasan upazilas. Faridpur's is not an isolated example. Ruling-party candidates fared miserably in Sunday's polls in many places like



Mymensingh, Kishoreganj and Sunamganj, regarded as strongholds of AL.

The Election Commission released unofficial results of 796 UPs out of 836 on Monday. Forty-eight AL candidates got walkovers.

Out of the 796 unions, AL aspirants could not even compete with their rivals in 230. Shockingly, AL candidates in 28 UPs lost their security deposits as a result of getting less than one-sixth of the total ballots cast.

Take some examples of the ruling party's humiliating defeats.

In Chiringa union under Chakaria upazila of Cox's Bazar, ruling party candidate Shahnewaj Rumel bagged only 67 votes. The total number of voters of the union is 10,436.

Awami League candidate Hasina Begum of Khatamadhupur union under Nilphamari's Syedpur upazila got 93 out of 17,496 votes.

A racket forging documents to evade tax for years

On the face of it, Teknaf Land Port is as clean as a

The lone gateway to trade with Myanmar has little or no record of confiscation of Yaba or reported cases of tax evasion through the false declaration of goods.

But the ground reality suggests something else. The land port with the poor scanning system, lack of security and absence of proper importexport documents has long been exposed to smuggling of illegal and contraband items like Yaba and tax evasion by dishonest traders.

The clandestine activities at the land port came to the fore following the arrest of Nurul Islam, a computer operator-turned-billionaire, on September 14.

Islam used to lead a racket that helped in the smuggling of Yaba and other goods and forged documents to evade tax in the land port for years, according to the Rapid Action Battalion.

He made a fortune of about Tk 460 crore, a far cry from his start as a computer operator at the port's customs house for a daily wage of Tk 130,

BNP decides not to join

The BNP, if invited, will not join the dialogue with President Abdul Hamid over forming the new Election Commission.

Party leaders say they made the decision as they believe the talks will not yield any fruit. Upon the invitation of the president, the party may send a letter to him

detailing why it will not join the talks and the overall political situation in the country. The BNP will also ask Hamid to take initiatives to form a polls-time interim government to oversee the next general election, said party sources. Speaking to The Daily Star yesterday, BNP Secretary General Mirza Fahkrul Islam Alamgir said, "We will not join the talks. Joining will mean

nothing. We held talks twice earlier but we found those to be pointless." The BNP standing committee, the highest policymaking body of the party, in a meeting on Monday unanimously decided that the party would not join the dialogue as it sees the initiative as "an attempt to snatch the

people's voting rights". BNP leaders said the president can hold talks but he cannot do anything without consultation with Prime Minister Sheikh Hasina and that's why participating in talks is nothing but "giving legitimacy to the process of

"The entire electoral system has been destroyed. In our political culture, a free and fair election is not possible under a partisan government. So, dialogues should be held on formation of a polls-time government,"

Dhaka wants discussion before US decision

Bangladesh wants prior discussions with the US before the latter takes any decision regarding security cooperation.

Foreign Secretary Masud Bin Momen commented to journalists after an inter-ministerial meeting on the US' Leahy Law at the secretariat.

"We will communicate with the US. If they have any allegations against any organisations of Bangladesh, they should let us know before making any decision," he said.

If the US says they have credible information on any organisation, Bangladesh would seek to learn about the sources of the information, he said.

"We will seek adequate

time to explain the measures taken by Bangladesh and its position," he added. The meeting discussed

Another rail project taking forever

In June 2018, the Bangladesh Railways took up a Tk 3,602 crore project that would substantively enhance its operational capacity in three years.

Come June 2021, let alone complete the project -- which entails procuring 40 locomotives, 125 luggage vans and 1,000 wagons -- it has failed to complete the signing of agreements with all vendors, in a development that has become characteristic of the BR.

Of the 37 projects it is implementing, 26 -- including this one -- has been extended at least once.

At present, this project's deadline is June 2022. Given that only yesterday the BR has signed the fourth of the five contracts needed for the project, another lengthy extension is most definitely in the offing.

Another three years after the expiry of the revised deadline of June 2022 is needed, Project Director Mizanur Rahman told The Daily Star yesterday. Prodded on the delay, Railways Minister Nurul Islam

Sujan largely blamed the pandemic. "But I would not say that there was no laxity on our

Apart from the two reasons, Rahman said the lengthy tendering process retarded the pace of the project, which is largely being funded with a loan from the Asian

Development Bank. "We have to take concurrence from ADB at every step -time extension is normal in almost all the projects," he added.

The BR is implementing is nine projects with loans from the Manila-based multilateral lender and the deadline for all but two had to be extended, document shows.



AL leaders, while talking to The Daily Star, said the results of the fourth phase UP polls is totally unexpected at a time when many political parties are not participating withtheir electoral symbols

Providing nominations candidates chosen by influential MPs and leaders, anti-AL sentiments, ignoring candidates' lists proposed by party grassroots and conflict between local AL leaders and MPs were the major reasons for such a debacle,

Most importantly, they pointed out, infighting in grassroots units and picking up many incumbent chairmen as candidates backfired once more.

Besides, AL failed to contain its rebel candidates despite taking measures such as issuing show-cause notices, warnings of punitive actions and expulsions from the organisation. Party leaders think victory of rebel candidates are encouraging the party's grassroots leaders to contest against

The results released on Monday showed that ruling party candidates performed poorly in the fourth phase compared to the previous three

In Sunday's polls, independents

chairman posts while AL candidates won 49.74 percent.

In the first phase held in June and September, AL candidates won 76 percent chairman posts, in the second phase they won 56 percent and 53 percent in the third phase, before dipping below 50 on Sunday in the fourth phase.

Talking to the Daily Star, AL presidium member Abdur Rahman termed the fourth phase election result "unexpected". He, however, said the party will move forward and act accordingly after learning lessons from the fourth phase.

Elections held in 10 unions of Faridpur's Boalmari upazila, where nine AL candidates were defeated and of them five candidates lost their security money.

Locals said conflict between local MP Manjur Hossain and former MP Abdur Rahman was responsible for this humiliating result.

Speaking to The Daily Star, Boalmari upazila AL General Secretary Pikul Mirdah said, "We sent a list of probable candidates to the AL central committee mentioning their contribution to the party and their role in previous elections.

"But candidates that were our top choices did not get party nominations. Instead, candidates who were our third or fourth choices got party nominations and thus our candidates were defeated," he said.

In the third phase UP polls, AL's poor results in Bhanga and Charbhadrasan upazilas were also due to the conflict between incumbent MP Mojibur Rahman Chowdhury Nixon and former MP Kazi Zafarullah

Election to 22 UPs were held in Hossainpur, Katiadi and Bhairab upazilas under Kishoreganj, which is also considered a stronghold of AL, on Sunday and of them AL sponsored candidates were defeated in 13 UPs.

In Katiadi, AL candidates won in only two out of nine UPs.

Voting was held in 21 unions under Sunamganj district where nine AL sponsored candidates lost their security deposit. Ruling party candidates won in seven UPs while party rebels achieved victories in six.

Sherpur is also known as an AL bastion. Elections to nine UPs were held in Sreebardi upazila of the district and AL candidates were defeated in

Independent candidate Abdul Karim, also a local BNP leader, won as chairman in Bhelua union where ruling party sponsored candidate Rezaul Karim, union unit AL president, finished fourth.

going on for a long time in connivance with a section of corrupt customs officials and dishonest traders, The Daily Star learnt after speaking with people in Teknaf. In the absence of any automatic

scanner machine, customs officials only check at best 2 percent of the goods by random sampling and that too manually, which is not sufficient to detect illegal goods inside any import consignment, they said.

Several traders said some dishonest traders import falsely declaring high tax items as low taxable goods.

The rackets including that of Islam's used to help release those, bribing a section of corrupt customs officials.

For instance, it is not possible to identify coffee in the pickle bag without a scanning machine, said a trader wishing anonymity. The tax on pickles is only Tk 5 per kg while the tax on the same amount of coffee is Tk 500, he said.

As far as security measures are concerned, the correspondent found cargo boats from Myanmar were entering the port without any checking by the port authority. The staffers of the boats were seen roaming freely in the markets surrounding the port.

Local traders, clearing forwarding agents and port workers were also walking into the boats from Myanmar unrestricted.

Most of the workers of the port are Rohingyas, who have been sheltering in various camps in Bangladesh for a long time, said Nazrul Islam, the proprietor of Teknaf Trading, which provides all the labour at the port. The locals did not want to work as

labourers in the port, where onions, wood, fish, shoes, betel nuts, rice and cosmetic items come through "It is very surprising that no Yaba consignment has so far been seized at

Teknaf land port, which is believed to

be the major route for its smuggling

Scanner machines or dog squads are needed to check such smuggling through the Teknaf port, he said, adding that both are becoming a mainstay at borders and ports across the world to prevent smuggling.

Abdun Noor, revenue officer of Teknaf Land Port Custom, said that they weigh all imported and exported

But Teknaf Land Port -- where about 4.15 lakh tonnes of goods worth about Tk 3,400 crore were imported between 2017 and 2020 -- is an exception, said customs officials.

Unlike any other port, traders can import goods through Teknaf showing only a single document: the bank draft. Sonali Bank and Myanmar

Economic Bank are nominated to issue bank drafts on border trade by their respective governments under an agreement signed on May 18, 1994. The bank draft only mentions the name of the importing company and

the dollar amount. In the absence of standard documents, customs duty is levied based on the information given by the traders after import.

There is no opportunity for the customs authority to verify the

authenticity of the document with the institution or bank of the exporting country, according to Noor. Manpower shortage

US President Biden signs \$770 billion defense bill

the case and Bashundhara Group Chairman Ahmed Akbar Sobhan alias Shah Alam and six others are accused of assisting Anvir. The other accused are Shah

Alam's wife Afroza Begum, Anvir's wife Sabrina Sayem, model Faria Mahbub Piyasha, Saifa Rahman Mim, Ibrahim Ahmed Ripon and his wife Sharmin.

The High Court on September 29 refused to grant anticipatory bail to Anvir in the case.

On April 26, police recovered the body of a 21-year-old college student in a Gulshan flat. Her elder sister then filed a case with Gulshan Police Station, accusing Anvir of abetting suicide.

On July 19, Abul Hasan, officerin-charge of Gulshan Police Station, submitted the final report in the case to the Chief Metropolitan Magistrate's Court of Dhaka.

On August 18, a Dhaka court accepted the final report and relieved Anvir from the case.

However, the victim's elder sister on September 6 filed the another case with the Women and Children Repression Prevention Tribunal-8 of Dhaka, making allegations of rape and murder.



Workers Party calls upon president at dialogue RASHIDUL HASAN

Rejecting the government's argument that there is not enough time to enact a law on forming the next Election Commission, Workers Party of Bangladesh (WPB) yesterday said the caretaker government bill was passed in parliament within one night in 1996.

While holding dialogue with President

Abdul Hamid at Bangabhaban on the matter, the party called upon the president to instruct the government to place a bill on EC's formation i the next session of parliament in January.



"You [Abdul Hamid] will address the parliament in January, which will be the first session of next year. In the speech, you assure the nation that the law will be enacted in that session," Rashed Khan Menon, president of WPB, which is a part of the ruling-Awami League alliance,

told reporters after the dialogue. Pointing to Law Minister Anisul Hug's argument that the law cannot be enacted before expiration of the present EC on February 14 next year, Menon said it is very much possible, if the government

However, it is still not clear who will be appointed as the next (23rd) chief justice of Bangladesh, and when will president announce the appointment.

And so, there is a buzz at the Supreme Court premises over this issue.

"The honourable president will appoint the new chief justice. I don't know whom and when he [President Abdul Hamid] will appoint. He has the sole authority to do so, as per

the constitution," Law Minister Anisul Huq told The Daily Star on Monday.

Meanwhile, some SC lawyers told this correspondent that was appointed as the 22nd chief Article 96 (1) of the appointed from the four judges Appellate Division, other provisions of this article, considering political issues and the next parliamentary election.

There is a precedent of appointing chief justices by superseding other judges of the apex court who were their seniors. Some of the superseded judges had resigned from office due to this, they said.

Of the sitting Appellate Division judges, Justice Muhammad Imman Ali will retire on December 31, 2022, Justice Hasan Foez Siddique on September 25, 2023, Justice Md Nuruzzaman on June 30, 2023, and Justice Obaidul Hassan on January 10, 2026, SC sources

the next chief justice will be justice on February 2, 2018, superseding Justice Md Abdul Wahhab Miah, who had been discharging duties of the chief justice for four months.

Later in the day on February 2, 2018, Justice Wahhab resigned as an apex court judge.

Earlier, six other apex court judges -- Justice KM Hasan, Justice Syed JR Mudassir Husain, Justice MM Ruhul Amin, Justice Md Tafazzul Islam, Justice ABM Khairul Haque and Justice Md Muzammel Hossain -- were appointed chief justice, ignoring seniority of their colleagues.

He said during today's trying times, there are more leaders who feed off of strife than people willing to come to an understanding.

Bulbul explained how Ahmed was a staunch supporter of inclusive democracy and had the courage to speak up to the most powerful in state and society. Reazuddin Ahmed's son Mashrur Reaz spoke about how his father had retired from his role of leading the management of a media organisation only to launch a newspaper two years later.

2 Rab members hurt in clash with 'drug peddlers' in Ctg

At least two Rapid Action Battalion (Rab) members and several locals were injured in a clash with suspected drug peddlers during an anti-narcotics drive in Baromasia Tea Garden, under Chattogram's Fatikchhari upazila, on Monday night.

Two Rab vehicles were also vandalised during the clash, which occurred around 9:00pm.

The force had to open fire to bring the situation under control, said Rab officials.

The injured are Rab-7 media officer Flight Lt Niaj Uddin Chapal and deputy assistant director Samad, among others. Of the injured, Chapal was shifted to Dhaka CMH, Rab-7 Commanding Officer Lt Col MA Yousuf told The Daily Star. Rab claimed that a group of drug peddlers used to produce alcohol in the guise of tea garden workers. The racket produced huge amounts of liquor to sell on December 31, ahead of thirty-first night celebrations.

"Based on a tip-off, Rab went to Baromasia Tea Garden area to destroy the liquor factory. As they were returning after destroying the liquor items, a gang of drug dealers swooped in on the law enforcers with lethal weapons, injuring two Rab men," he said. "Rab detained five persons in this connection so far. The drive is still ongoing."

Local sources and police, however, said the team of Rab went to the tea garden in plain clothes, in a microbus and

Seeking anonymity, an elected public representative of Suabil union who visited the spot, said the Rab men were in plain clothes, which created confusion among tea workers. After the incident, the workers went into hiding.

Bangladesher Samajtantrik Dal and Communist Party of Bangladesh have declined to participate in the dialogue. BNP yesterday said they will also not participate, even if it is invited.

The country has 39 registered political parties, according to the EC website, and only nine of them have representation in parliament.

RMG workers protest 'assault' on colleague

Workers of an RMG factory in Ashulia yesterday demonstrated inside the premises over an alleged incident of sexual assault of one of their female co-worker.

Hundreds of workers of Yagi Bangladesh Garments Ltd in Jamgora area started demonstrating inside the factory around 8:00am after hearing news that the female worker, aged around 20, was sexually assaulted a couple of days ago, said ŚI Samiul Islam of Ashulia Police Station.

"Police are investigating the incident," he said.

The agitated workers said on December 23 during lunch break, an unidentified person approached the female worker and introduced himself as a medical worker.

The female worker is new to the factory, joining just five days ago on December 18, which is why she doesn't know that many people at the workplace, her colleagues said.

After she told the unidentified person she wasn't feeling very well, he told her she needed to be administered an injection and took her aside for it. She soon lost consciousness, at which point she was allegedly sexually assaulted, they claimed.

She would remain at home ever since the incident, only returning to work yesterday. After coming in, she told her co-workers of the events, which triggered the demonstration.

The workers have demanded immediate identification of the culprit.

Contacted, Md Elias Patwary, managing director of the factory, said, "There is no chance for such a heinous incident to take place inside our premises. However, I have asked factory officials and police to investigate.

He further said they are suspecting that a group might have spread rumours regarding the incident to create unrest among workers and damage the factory's goodwill.

10 brick kilns demolished in Dhamrai

Department of Environment (DoE) demolished 10 brick kilns and fined the owners Tk 42 lakh for causing severe environmental pollution in Dhamrai's Kalampur and Mohudanga area yesterday.

Modina, MSB-2, MS/Faruk, Nur Bricks, Tuhin Bricks and Marks Bricks were fined Tk 6 lakh each as they did not have necessary documents, while Mokka-Modina and Khan bricks were fined Tk 5 lakh each over the same allegation.

Rahat Bricks and Kalampur Bricks were fined Tk 2 lakh each as they could provide some documents but lacked full clearance, said Tamzid Ahmed, executive magistrate of DoE.

Law says that no brick kiln is allowed within 1.5km of residential areas, educational institutions and hospitals, which made the demolished kilns illegal in the first place. Drive against illegal brick kilns will continue, Tamzid

According to experts, over 200 illegal brick kilns are currently operating in Dhamrai and Savar, contributing to the deteriorating air quality in the country.

editorial board and vice president of NOAB, also spoke at the event, while Dewan Mahmud, editor of Bonik Barta, moderated the event. Reazuddin, who served as the deputy editor of The Daily Star during 1991-1992, received the Ekushey Padak

Jaaldugi brings high profit to growers

Cultivation of the early variety pineapple helping many farmers make a fortune

OUR CORRESPONDENT, Mymensingh

Cultivation of Jaaldugi, an early variety of pineapple, has changed the fortune of many farmers in Phulbaria upazila over the last couple of years.

A larger number of farmers in different villages of the upazila are cultivating the early variety pineapple for a higher profit for the last few years.

Ayub Ali, one of the top fruit growers of Santoshpur village, is expecting to earn a good profit from the early variety pineapple, cultivated on his eight acres of land, this season.

The 51-year-old, who lives near the Santoshpur Reserved Forest, said he cultivated Jaaldugi, a small sized early variety pineapple, on eight acres land and expecting to harvest those in between February and early March.

As the fruit is harvested in early of the year, which is usually adding that growers can sell their pineapple at a high and earn a good profit from it.

Ayub, who started from cultivating Jaaldugi variety on one acre land five years ago, has gradually expanded the cultivation area and now there are about one lakh and fifty thousand plants in his field.

If everything goes well he is expecting to earn a profit of Tk 25 lakh this season, Ayub said.

Ayub said he has been involved in pineapple farming for over 30

In 2019, he earned a profit of Tk 2.5 lakh from Jaaldugi cultivation, Ayub said, adding that the profit was about Tk 10 lakh in 2020.

Like Ayub many pineapple growers of Santoshpur and other adjacent villages in the upazila have been getting a good profit from their produce for the last couple of years as they are enjoying off-season for pineapple, so it a high fair price of the early variety

has a good demand, he said, pineapple.

Farmers said some of the growers are earning double profit from their mixed orchard round

Another farmer of the village Fazlul Haque said he has been growing Jaaldugi variety pineapple on one acre land for the last three years. He earned a profit of Tk 4 lakh this year and eyeing a double profit in the coming season.

With the development of communication and information technologies, now farmers can directly contact their clients to know the actual market price of their produce, another grower Abdul Hye said.

Maznu Mia of the locality said many growers of Santoshpur and adjacent Krishnapur, Balughat, Harirambari and Kastagara through pineapple cultivation in recent years.

Locals said alongside pineapple she further said.

cultivation of different fruits has created seasonal job opportunity for nearly 50,000 people in the upazila.

Naugaon Union Parishad (UP) Chairman Mozammel Hossain said pineapple is cultivated at a large scale in different villages under Naugaon and Rangamatia unions of the upazila and it is a cash crop for several thousand farmers.

Contacted, Phulbaria Upazila Officer Agriculture Nahar said there are over 15,000 pineapple growers in the upazila.

Of them, about 1000 farmers are involved in mixed fruits cultivation and getting a good profit every year, she added.

The pineapples, especially Jaaldugi and Honey Queen variety, produced in the upazila villages have changed their lot are famous for its taste as both the soil and weather of the area are suitable for pineapple cultivation,

Dotara artiste Shuklal struggling for survival

Once Dotara artiste Shuklal Roy used to pass busy days attending one programme to another enthralling his audience with his musical rendition. But since the onset of Covid-19 pandemic, there is hardly any musical programmes in the village leaving Shuklal who is fondly called Dotara Shuklal in a perennial crisis for survival.

This Dotara artiste hails from Kalisthan village of Kamalabari union of Aditmari upazila in Lalmonirhat.

"As there is no programme because of the pandemic, nobody calls me," he said.

Though the veteran artiste as well as his family is struggling for survival, he still wears a big smile on his face.

"Somedays I can manage some food and somedays we go unfed. I try to run my family working as a day labourer but people often refuse to give me work as I am a person belonging the community of musicians," he also said.

Despite suffering from hunger pangs, Shuklal is trying to preserve the tradition of music in rural Bengal. Alongside playing the Dotara, Shuklal is also a prolific singer having prowess on different genre of Bengali songs especially Bhawaiya.

He is adept in folk songs and kirtan songs. He can play flute, harmonium, drum, ektara, sarinda and all other traditional musical instruments

His family comprises of his wife Sudha Rani and two sons Ripon Chandra Roy and Jiban Chandra Roy. The elder son Ripon is studying at a college and the younger one is in a school.

His wife Sudha Rani has to work as a day labourer in the village now. Shuklal does not have any land property except for the homestead.

Shuklal said that he had three Dotaras. Due to financial crisis, he has sold two of them for Tk 3,000. He cannot repair some other musical instruments due to

"I'm a man of music. I don't like other works. Besides, I can't do any other works properly," he said.

"There is a severe crisis of money in the family and now I have only one Dotara left. I don't know how long I will be able to retain this one," he further said.

Shuklal's wife Sudha Rani (38) said "My husband regularly plays the Dotara suffering from hunger pangs. All my frustration and agonies are dispelled with the mellifluous rendition of his Dotara."

VIENNA TALKS Israel open to 'good' Iran nuke deal

Prime Minister Naftali Bennett yesterday said that Israel would not automatically oppose a nuclear deal with Iran but world powers must take a firmer position.

"We are not the bear who said 'no'," Bennett said in an interview with Israel's Army Radio, referring to a popular naysaying character from children's literature.

"For sure there can be a good agreement. For sure. We know the parameters. Is that expected to happen now in the current dynamics? No. Because there needs to be a much firmer position," he said.

"Iran is negotiating with a very weak hand. But unfortunately the world is acting like Iran is at a strong point."

Bennett declined to comment on Israel's military strike capabilities against Iran, saying he preferred the approach of "speak little and do a lot".

On Monday, Iran and the US resumed indirect talks in Vienna on salvaging the 2015 Iran nuclear deal with Iran focused on one side of the original bargain, lifting sanctions against it, despite what critics see as scant progress on reining in its atomic activities.

India boosts arsenal

Okays Merck pill, two more vaccines against Covid

REUTERS, Bengaluru

India has approved Merck's Covid-19 pill and two more vaccines for emergency use as the world's second most populous country braces for a possible spike in coronavirus cases due to the rapidly spreading Omicron variant.

Asia's third-largest economy has already said it will allow Covid-19 booster shots for some of its population as some Indian states logged an uptick in Omicron cases.

The emergency approvals come at a time measures are being taken to ramp up oxygen supplies and strengthen the country's health infrastructure.

Molnupiravir will be manufactured in India by 13 companies for restricted use under emergency situation for treatment of adult patients with COVID-19, the country's Health Minister Mansukh Mandaviya said yesterday.

Merck's anti-viral pill molnupiravir was authorised by the United States last week for certain high-risk adult patients and has been shown to reduce hospitalisations and deaths by around 30 percent in a clinical trial.

Earlier this year, Aurobindo Pharma, Cipla , Sun Pharmaceuticals and some others signed non-exclusive voluntary licensing agreements with Merck to manufacture and supply molnupiravir in India.

Two other Covid-19 vaccines, Serum Institute of India's version of Novavax Inc's shot, Covovax, and homegrown drugmaker Biological E's Corbevax were also granted emergency use approval, Mandaviya said on Twitter.

Medical experts have said India needs to double down on its vaccine campaign

and some states have imposed night curfews and other restrictions in the run up to New Year festivities to prevent a spike in infections and a repeat of summer 2021 when a devastating second wave of infections left tens of thousands dead.

The country's inoculation drive so far has been dominated by a domestically produced version of the AstraZeneca Covid-19 shot by Serum Institute and Bharat Biotech's inactivated vaccine Covaxin.



India has so far administered 1.43 billion Covid-19 vaccine doses and 62 percent of its eligible population have received both doses. The country plans to start vaccinating those aged 15-18 from Jan. 3.

The coronavirus has killed at least 5,404,577 people since the outbreak emerged in China in December 2019, according to a tally Tuesday from official sources compiled by AFP.

Overall, the United States has recorded the most Covid deaths with 818,371, followed by Brazil with 618,534, India with 480,290 and Russia with 306,090.

Afghan women protest against Taliban killings of former soldiers

A crowd of women marched through the Afghan capital yesterday, accusing Taliban authorities of covertly killing soldiers who served the former US-backed regime.

Around 30 women gathered near a mosque in the centre of Kabul and marched a few hundred metres chanting "justice, justice" before they were stopped by Taliban forces, an AFP correspondent saw.

The Taliban also tried to prevent journalists from covering the march, organised against the "mysterious murders of young people, particularly the country's former soldiers", according to social media invitations.

Taliban fighters briefly detained a group of reporters and confiscated equipment from some photographers, deleting images from their cameras before returning them.

Since the hardliners returned to power in August they have effectively banned unsanctioned protests and frequently intervene to block demonstrations against their austere brand of Islam.

The protest comes weeks after separate reports by the United Nations, Amnesty International and Human Rights Watch said there were credible allegations of more than 100 extrajudicial killings by the Taliban since their takeover.

"I want to tell the world, tell the Taliban to stop killing. We want freedom, we want justice, we want human rights," said protester Nayera Koahistani.

In a statement read aloud by protester Laila Basam, the demonstrators called on the Taliban "to stop its criminal machine".

The statement said former soldiers and government employees of the old regime are "under direct threat", violating a general amnesty announced by the Taliban in August.

The protesters also aired objections to the ratcheting restrictions women are facing under Taliban rule.

The government issued new guidelines at the weekend banning women

from travelling long distances unless escorted by a close male relative.

"Women's rights are human rights. We must defend our rights," said

Video footage posted online on Tuesday showed another women's protest held elsewhere in the capital that also called for women to be allowed education and work opportunities.

India restricts foreign funding for Mother Teresa charity

India has moved to cut off foreign funding to a charity founded by Mother Teresa, a decision critics described as further evidence of harassment of Christians under the Hindu nationalist government. The Missionaries of Charity was founded in 1950 by the late Mother Teresa, a Catholic nun who devoted most of her life to helping the poor in the eastern city of Kolkata. Her organisation runs shelter homes across India. According to the Hindu daily, it received around \$750 million from abroad in the 2020-21 financial year. The statement issued on Monday said the reason was "not meeting the eligibility conditions" under the Foreign Contribution Regulation Act after "adverse inputs were noticed", without giving further details.

Japan aims to put a person on the moon by late 2020s

Japan revised the schedule of its space exploration plans yesterday, aiming to put a Japanese person on the moon by the latter half of the 2020s. According to the draft schedule of the plan, Japan aims to put the first non-American on the moon as part of the Artemis programme, a US-led initiative that aims to return astronauts to the moon. The plan also spells out Japan's aspirations to launch a probe to explore Mars in 2024, as well as to find ways to generate solar electricity in space.



Death toll from Brazil flooding rises to 20

The death toll from heavy rain and flooding that has plagued the northeastern Brazilian state of Bahia since November rose to 20 on Monday, amid incessant torrents that have displaced almost 63,000 people, authorities said. Two new fatalities were recorded in the town of Itabuna: a 21-year-old man who was swept away by currents and a 33-year-old woman was killed in a landslide, according to a local government report. Houses were under water and streets turned into rivers in several municipalities in the south of the state, pounded since Thursday by heavy rainfall that caused dams to burst and rivers to overflow at the weekend.

France closes mosque after 'unacceptable' preaching

France has ordered the closure of a mosque in the north of the country because of the radical nature of its imam's preaching, regional authorities told AFP yesterday. The mosque in Beauvais, a town of 50,000 people some 100 kilometres north of Paris, will remain shut for six months, according to the prefecture of the Oise region where Beauvais is located. It said the sermons there incite hatred, violence and "defend jihad". The move comes two weeks after Interior Minister Gerald Darmanin said he had triggered the procedure to close the site because the imam there "is targeting Christians, homosexuals and Jews" in his sermons. This, the minister said, was "unacceptable". The French government announced earlier this year that it would step up checks of places of worship and associations suspected of spreading radical

Islamic propaganda.

US, Russia to meet early Jan in Geneva

The United States and Russia will hold much-anticipated talks in January on European security and the Ukraine conflict after Moscow listed demands including to end Nato's expansion.

A spokesperson for the US National Security Council told AFP on condition of anonymity late Monday that the talks with Russia will take place on January 10.

Russian Deputy Foreign Minister Sergei Ryabkov yesterday confirmed the date and said that they will take place in Geneva, where US President Joe Biden and his Russian counterpart Vladimir Putin met for their first summit in June.

The Kremlin has grown increasingly insistent that the West and Nato are encroaching dangerously close to Russia's

Moscow earlier this month presented the West with sweeping security demands, saying Nato must not admit new members and seeking to bar the United States from establishing new bases in former Soviet republics.

Moscow and Nato representatives are then expected to meet January 12, while Russia and the Organization for Security and Co-operation in Europe (OSCE), which includes the United States, will meet January 13, the spokesperson added.


After working in the industry for so many years, what are your expectations from acting?



Season 2 of 'The Witcher' takes folklore fantasy to new heights

Based on Polish author Andrzej Sapkowski's stories that spawned an incredibly popular gaming franchise, Netflix's "The Witcher" recently released its much-anticipated second season

You don't have to be a die-hard fan of "Game of Thrones" or even fantasy shows to watch "The Witcher". With sweeping multitudes: rich mythology, political tectonics, monster fables, peripatetic adventures, and unique characters, the new season has something refreshing to offer every step of the way.

The star of the show, Geralt of Rivia, a genetically enhanced monster slayer, now has a "Child Surprise" - Cirilla, a princess in exile - which means he is a surrogate father. From the very first episode, the audience learns about Ciri's conspicuous animosity towards the Nilfgaard Empire, which lay siege to her home, the Kingdom of Cintra. She is determined to take her revenge, for which she believes it's crucial that she transmutes into a Witcher.

Not long after meeting more of the Witcher clan in Kaer Morhen, Ciri learns to be one as well, under the tutelage of Geralt. Meanwhile, the world is hardly barren of calamities. In between wellchoreographed and gnarly fight scenes, the story progresses further as conflict rises between empires, terrifying monsters attack and a host of new and captivating characters add to the breadth of lore. On one hand, we are introduced to Geralt's mentor Vesemir and on the other, Yennefer's mentor Tissaia makes a return. Other familiar faces such as the mage Triss

Merigold and Nilfgaardian commander Cahir also reappear.

When stories are blended together, it makes for a fun watch and also allows the writer to string in diverse plot elements. Each episode unfolds across three nonlinear timelines, which is a testament to how the world-building in this season is more expansive.

The earliest timeline portrays the origin of the sorceress Yennefer of Vengerberg, played by the brilliantly versatile Anya Chalotra. Although Yennefer's love interest Geralt is under the impression that she is dead, the opposite is true. After being stripped off of her magical powers, she embarks on quite the winding journey

with fellow mage, Fringilla. We follow Geralt as he is thrown in the deep end of many desultory adventures. We meet Ciri in the present timeline as she battles between playing safe and playing hard. Despite sparse timelines, these three main characters' fates are intrinsically bonded

Freya Allen carefully channels the dichotomy of vulnerability and control into her role of Ciri. As for Geralt, Henry Cavill personifies the character exactly the way fans envisaged it. From Geralt's gruff mannerisms and his stoic profile to his sly sense of humour and affectionate nature, Cavill interweaved several quirks to create this character.

While "The Wheel of Time" and "The Last Kingdom" are wrestling to fill the void left by "Game of Thrones", "The Witcher" is at the forefront of this new era.

Why are we stifling critical expressions on social media?

DSA is incompatible with our fundamental rights

TE have said it before and we are saying it again: the Digital Security Act (DSA) is a repressive law, which curbs the constitutionally guaranteed right of citizens to freedom of expression. We expect the votaries of the draconian law to retort that no freedom is without the attendant obligation to exercise it without abridging the rights of others. To that, we say: there are existing laws to address any transgression in this regard, without applying a reprehensible instrument such as the DSA.

If one analyses the cases lodged in the last two years, the fear that it would be used as a shield to protect the government and the administration from criticism—particularly from the mainstream media and stifle the opposition is borne out by the number of cases targeting journalists for mere criticism of the agencies or the elected or nominated public office holders, and the opposition politicians. So much has the law become the Sword of Damocles that the print and electronic media (even those not attached to the government apron string) choose to err on the side of

No political party that claims to have the mandate of the people can afford to be so conceited as to consider itself and the functionaries under it above all criticism, unwilling to countenance critical comments and dissenting voice from the public and political opponents. What should one make of the fact that, reportedly, more than 1,500 people—mostly politicians and journalists—were sued under the DSA between the years 2018 and 2020, and a similar number of cases were filed between January 1, 2020 and September 15,

Having neutered the media thus, the other platforms of communication, i.e. the social media platforms, are now being targeted—another prediction that has, sadly, come true. According to data by ARTICLE 19, a UK-based human rights body that focuses on freedom of expression, 83 percent of the 225 DSA cases lodged between January and November this year were filed over social media posts and individuals' online expressions. Individuals affiliated with the ruling party filed 40 percent of these cases. Similarly, 40 percent of the cases were filed against people for allegedly criticising the prime minister, ministers, members of parliament, and affiliates of the ruling party.

These statistics are a sad commentary on the country's state of democracy, rights and freedom. The DSA has infused a sense of fear among the public and the media which is supposed to reflect public opinion. We have no issue with the intention of the government to secure the variegated communication media, but we regret to say that the draconian provisions have been motivated by the administration's unwillingness to servants are above reproach. It is time to bin the unconstitutional provisions of the DSA

Bangladesh on course to reach another milestone

As the economy recovers, we must remain alert

T is encouraging to see our economy recovering well from the pandemic, to the point where the government's finance division is projecting that it will become a half-a-trillion-dollar economy next fiscal year. According to the forecast, the size of Bangladesh's economy would be USD 510 billion in the 2022-23 fiscal year after growing at 10.7 percent. A large part of this growth, it has been estimated, is being driven by a successful vaccination campaign and steady growth in agriculture and industry.

The pandemic considerably slowed down the country's economic growth. Hence, it is of no surprise that once its effects start to fade away, our GDP growth will increase quite substantially. As the daily infection rate dropped below five percent from October, we have seen domestic demand rebound, which gave a massive boost to growth. Bangladesh's exports and remittance inflow figures have also been notable of late. Even during most of the pandemic period, our agriculture sector has continued to impress. This is a most remarkable achievement on part of our farmers, whose hard work has been a major driver of our success as a nation.

On the other hand, certain sectors such as the leather industry, textile industry and other non-metallic minerals industry have been performing extremely well. Thus, it is incumbent upon the government to provide them with all the necessary support to help continue

Having said all that, we agree with the experts that we are not yet completely out of the woods. The Omicron variant of the coronavirus, which has been tearing through certain parts of the world, continues to be a real and present danger to us. It has already caused massive setbacks for some of the developed countries and their economic recoveries, and Bangladesh must take all precautionary measures to ensure that it doesn't suffer a similar fate. Therefore, while the recovery we have seen so far does give us a cause for celebration, we must remain vigilant to ensure that this recovery does not fall by the wayside. Additionally, the increased wealth gap and poverty that the pandemic has caused must be addressed by the government, so that our growth can be truly inclusive and meaningful.

The crime of negligence

The guilty, including those in the authorities, must face justice



hours of December 24, the deadliest launch fire in Bangladesh's history wreaked havoc on the launch MV Abhijan 10, burning so many people alive; as of December 28

afternoon, the death toll from the tragedy stood at 42, with more than 50 people still missing. According to reports in this daily, more than 50 passengers out of the 100 who sustained burn injuries are undergoing treatment at hospitals in Dhaka and Barishal. Among them, 15 critically injured patients were admitted to the Sheikh Hasina National Institute of Burn and Plastic Surgery in Dhaka. Three of them are now on life support.

and inspecting the vessel and suspending its operation.

Although investigations are in progress to find out the exact reasons for the fire, primary inquiries done by the probe committees have identified faulty engines to be the main reason. Reportedly, the two engines of the launch were replaced with ones bigger in size last month, without getting approval from the Department of Shipping. Among them, only one was running on the night of the fire. What the probe committees have found is that the engine overheated due to a lack of lubrication, which might have caused the fire. Other factors that might have helped the fire spread so quickly include an illegally modified engine room and a kitchen next to it, and the barrels of fuel and gas cylinders stored in there. Apparently, all the changes to the vessel were made without taking approval from the authorities concerned.

Many other irregularities and violations

Barguna on the evening of December 23. Although the crew noticed that the engine was acting strange, they kept the vessel moving without fixing the problem. And when people on the bottom floor felt the deck getting hotter—after it left the Barishal launch terminal at around 1:30am—the master still kept the launch sailing towards its destination. According to a member of the probe committee, it should have been an easy task for the crew members to identify and resolve the engine issue. But apparently, they didn't bother to check the engine.

And what did they do when the entire launch was engulfed with fire, with hundreds of passengers crying for help? They steered the launch to the bank of Sugandha River in the Charkathi area of Jhalakathi district, and fled without mooring it. Had they moored it to a tree in the area, there could have been much fewer casualties. What is even more shocking is the fact that the launch crew

kept the main gate closed during the fire, limiting the passengers' chances to escape.

The extent of apathy and negligence that the launch masters and staffers showed towards the passengers' lives is incredible—and nothing short of a criminal offence. Legal action must be taken against them without any delay.

But while we demand punishment of the launch owners and crew members for this man-made tragedy, we must also hold the Department of Shipping and the BIWTA authorities accountable. If the owners of the launch are at fault for replacing the engines, changing the masters and crew members, and modifying their vessel without the authorities' approval, the shipping authorities and the BIWTA are also at fault for not inspecting the vessel that was operating on this river route regularly.

The common excuse that we hear from the BIWTA and the Department of Shipping is that they don't have enough manpower to inspect all the water vessels in operation. Reportedly, the BIWTA has only 25 traffic inspectors across the country, seven of whom are deployed at Sadarghat in Dhaka, while the Department of Shipping has a total of 18 inspectors—only one of them stationed at Sadarghat. Besides, there are only six surveyors in the shipping department to survey around 14,000 registered vessels across the country. The question that arises here is: What is stopping them from recruiting more inspectors and surveyors to cover the inspection and monitoring of all the active water vessels?

In the absence of proper monitoring and inspection, the number of unregistered and unfit vessels are increasing in our waterways, with unskilled and novice sailors running them, leading to many tragedies like the MB Abhijan one. The MV Mayur accident on June 29, 2020 is still fresh in our memory, where 34 people died as the launch hit a small water vessel in the Buriganga River.

Furthermore, the issue of fire safety is always overlooked by the authorities as well as those working in the sector. Reportedly, while many water vessels in the country have lifts, well-furnished rooms, Wi-Fi, radio communication and modern gadgets, they hardly have any fire safety equipment. According to the Fire Service and Civil Defence in Barishal, no fire drill for the crews of water vessels has taken place in the last four years.

The responsibility to ensure that all the water transports are compliant with fire safety regulations also falls on the Department of Shipping and the BIWTA. When will they start playing their parts?

It is good news that a case has been filed with the marine court by an inspector of the Department of Shipping against the four owners of MV Abhijan 10 and eight others, and the Rapid Action Battalion (Rab) has already arrested Hamjalal Sheikh, one of the launch owners. We hope that the rest of the owners and the crew members will be arrested soon. All of those who are guilty of this crime must be arrested and punished, as well as those in authority who failed to do the job they have been recruited for. However, given the inefficiency of the marine court and its dismal case disposal record—only one case has been disposed of by the court in the last four years—can we really expect them to ensure justice for the victims of this massive tragedy?

The gruesome details of negligence, indifference and inefficiency of the crew members of MV Abhijan 10—as well as others in positions of authority—have been the highlights of news reports published over the past few days. From these reports, what we understand is that there are three parties that should be held accountable for this tragedy: 1) The master and staffers of the launch, whose inefficiency and negligence caused the fatal fire; 2) The owners of the launch who didn't bother to comply with any of the rules regarding the operation of water vessels; and 3) the Department

of rules were found as well. The launch owners reportedly appointed masters and other crew members without the approval of the authorities; on the night of the fire, the launch was being driven by two second class masters instead of a first class one. Also, they didn't have the necessary fire safety equipment, nor were its crew members trained on fire safety. Moreover, there were around a thousand passengers on board while the launch should have had 420 passengers at night, as per the rules.

Then comes the issue of inefficiency and negligence of the crew members. According to a report published in this daily on December 26, nothing was done right by the launch crew from the moment MV Abhijan 10 left Dhaka for

Christmas finally arrives in Saudi Arabia



ONG banned, Christmas has finally—at least tacitly—arrived in Saudi Arabia; just don't use the name in marketing or be ostentatious about your tree.

Coffee shops serving beverages in red cups with

snowflakes on them are okay. So is the sale of soap bars named 'Tis the Season and Vanilla Bean Noel.

Christmas trees that sell at up to USD 3,000 apiece are slightly more complicated. The religious police no longer harass shopkeepers for selling items that reference a non-Muslim holiday. But shopkeepers remain uncertain about trees and sometimes still keep them in a backroom. Religious references and carols remain beyond the pale.

The loosening of the rules of the game in a country that still bans non-Muslims from worshipping in public and the building of non-Muslim houses of worship is part of an effort to ensure that the kingdom does not lag in the competition with the UAE and Qatar to project itself as an enlightened, modern country that can attract foreign investment and vie for foreign talent and tourists.

The loosening is also part of an effort to position the kingdom as a beacon of Muslim moderation in competition with the UAE, Qatar, and Indonesia.

While Indonesia, the world's largest Muslim-majority country and democracy, is struggling with creeping conservatism, and Qatar is seeking to ensure football fans that it will welcome diversity of any kind during next year's World Cup, the UAE has sprinted ahead by leaps and

In the last year, the UAE, where public references to Christmas and carols are not an issue and non-Muslim houses of worship exist alongside mosques, farreaching legal reforms have been enacted that legalised alcohol and non-married cohabitation and ended censorship of cinematic releases. The caveat, like elsewhere in most of the Muslim world, is that the reforms are anchored in secularnot in Islamic—law and jurisprudence.

Nahdlatul Ulama, the world's largest Muslim civil society organisation, which is at the forefront of the projection of Indonesian moderation, has started a process of reform of Muslim jurisprudence, but has so far shied away from hot button

issues that top the agenda of its Middle Eastern rivals.

Saudi loosening of norms also serves to distinguish the kingdom from other competitors for religious soft power and leadership of the Muslim world, like Turkey and Iran that are governed by Islamists, who either are inspired by or more strictly apply conservative interpretations of Islamic law. The loosening further aims to bolster economic reforms and efforts to diversify the economy and create jobs.

To be sure, Saudi Arabia has been signalling for several years that it is travelling down a road of greater religious tolerance and social liberalisation. Meetings between Saudi leaders and

Evangelical and Jewish leaders and support for interfaith dialogue served the purpose.

Crown Prince Mohammed bin Salman has turned the Muslim World League, once a major vehicle for the global propagation of Wahhabism, the ultra-conservative interpretation of Islam that dominated Saudi Arabia for its first 85 years, into the propagator of his vaguely defined concept of moderate Islam.

Bin Salman has also lifted the ban on women's driving, liberalised gender segregation, created greater job and leisure opportunities for women, and generated a Western-style entertainment industry. But, like the UAE and Qatar, he has stopped short of fully abolishing male guardianship.

Saudi shops started catering several years ago to Valentine's Day, long a no-go in the kingdom, by selling red roses, and in October Halloween costumes appeared electronic dance festival, the MDLBeast Soundstorm, held near Riyadh in recent days and reportedly attended by 732,000

Some reports suggested that some attendees had been publicly intoxicated and had displayed behaviour that raised

suspicions that they were queers. The kingdom punishes homosexuality by death.

LGBTQ Qataris insist that the same tolerance is not extended to them.

For Saudis, Al-Sheikh's fatwa contains a cautionary note. Saudi Arabia may have enacted significant social liberalisations, but beyond red lines they rest on a fragile fundament as long as they are not anchored in changes of religious doctrine and jurisprudence.

"While the changes (in Saudi Arabia) are potentially far-reaching, their ultimate direction is uncertain. Most ... remain quite reversible. And while state structures and officials have accepted and even applauded the moves, some social resentment and resistance is still possible—and unintended consequences might still materialise," warned scholars Yasmine Farouk and Nathan J Brown.

Brunt of Covid-19 on female-headed households



life is full of struggles and misery; I don't think I'll ever be happy.", Aliya Begum, head of her household, narrates sadly.

Aliva (not her real name), a 50-year-old widow living with her daughter in a congested slum in Chattogram, is one of the many women household heads who are bearing the brunt of the Covid-19 pandemic. Before Covid, Aliya worked as a domestic help while her 15-year-old daughter worked at a garments factory. During the onset of Covid-19 and the associated lockdown, they both were laid off from their jobs without prior notice. With no income or external support, Aliya found herself in a deep pit of desolation. Although the lockdown was finally lifted when we were having this conversation in September 2021, Aliva had hardly outrun her misery.

According to the World Bank, in 2018, approximately 15.8 percent of the total households in Bangladesh had female heads. It doesn't take much effort to understand the unfavourable situation of femaleled households in a patriarchal society like ours. Up until the late 90s, female-headed households were considered as the "poorest of the poor" in development discourse. Although this notion has been contested and claimed to be misguiding when poverty is understood as a multidimensional phenomenon, female-headed households are still visibly and readily an identifiable group in income poverty.

Aliya is not alone in her plight. Female-headed households have evidently been one of the hardest hit groups during the ongoing pandemic. Recent statistics from a field survey conducted by Centre for Peace and Justice, Brac University—and funded by the Covid Collective Platform of IDS, University of Sussex—illustrate an appalling profile of households with female heads. The survey, which included 14 percent of the total sample from female-headed households, highlighted a number

of critical issues. Nearly half of the female heads had attained only primary level education and more than a quarter had no literacy at all. A quarter of the female heads reported loss of work due to the pandemic. Decrease in income was also reportedly high (61 percent) in September 2021, and was even higher in June 2021 (77 percent). More than half of these households are facing increasing food deficit and 23 percent of them face food crisis. Not having adequate education, coupled with lack of skills, made it nearly impossible for the participants to opt for another job after being laid off.

As Aliya illustrates her situation, "When strict lockdown was imposed, the garments factory my daughter worked at was closed down and my employer also told me not to go to my job. At one point, we had no money to buy food. There were days when we only ate once."

Like many other female heads from our survey, Aliya also relied on borrowing money to survive the pandemic. Access to formal financial institutions such as banks is very limited for under-served groups of women, in general, in Bangladesh. These women mostly relied on neighbours or relatives for borrowing cash, and sometimes even from moneylenders, at high interest rates. She is still repaying those loans, but by borrowing more money, which makes her susceptible to a vicious never-ending cycle of debt.

One other problem for female heads of households is that, traditionally women are considered the primary caregivers of the family. Strict social distancing limited their ability to get external help to take care of dependent household members such as children, elderly persons and persons with disabilities. This often reduced women's working hours and hence also reduced income. Such households reported being forced to opt for debilitating mechanisms—such as 53 percent of them reducing food consumption to cope with increased expenses and income loss.

Historically and traditionally, women as a group have had limited access to community support and social capital. There is also mistrust towards community, stemming from previously experienced discriminatory behaviour. All of these combined makes female heads of

households more vulnerable to crises and shocks. The evidences from the survey reiterate that more than half of the female-headed households received no support from their community during the pandemic. Sometimes, they have even eschewed seeking support as they cannot reciprocate the same due to constant resource constraints. Their access to social support programmes is also very limited. 61 percent femaleheaded households reported that they are not enlisted under any social safety net programmes.

Bangladesh has shown visible improvements in women's empowerment. This gives rise to the assumption that being head of the household would give women more power to exercise agency and transition to a better-off position. However, the reality as reflected in our survey starkly contrasts with this hypothesis. Having said that, it is also erroneous to assume or imply that having male earners in the household will automatically mitigate the same risks during crises like the pandemic. Instead, the inferences indicate that it is mostly structural challenges that are creating new fault lines for female-headed households. Lacking access to financial and community support and lack of transparency prevent these women from benefiting from social welfare programmes which were designed to support vulnerable people like them.

The statistics and numbers on empowerment ranking mean little to Aliva, as she is all too familiar to the quandary and fears that keep her awake at night. We are now almost two years into the pandemic and, with a decrease in infection rates, the focus is now on economic rebuilding. However, the reductionist focus of public policies that seldom takes account of female household heads' realities will only exacerbate their existing conundrums. It is, therefore, critical to amplify their needs and concerns in the policy-making space and devise policies that take into account their realities. We cannot risk leaving these female-headed demographics worse-off as we ambitiously plan to build back better as a country.

2021 was a critical year for climate actions



THE year 2021 has been significant in climate change discussions, in a decade that is already quite important in terms of tackling the climate crisis. This was the year when the world finally acknowledged that humaninduced climate change due to the emissions of greenhouse gases (GHGs)

from burning fossil fuels for over a century had already raised the global mean temperature by over one degree Celsius, and that this was now causing losses and damages to human lives, livelihoods and infrastructure.


This was definitively proven by the 6th Assessment Report of the Intergovernmental Panel on Climate Change (IPCC), published by the panel's Working Group 1 in August 2021, where scientists said that, for the first time, they now had unequivocal evidence of climate change impacts that can be clearly attributed to human actions. This report was duly acknowledged at the 26th United Nations Climate Change Conference, also known as the Conference of Parties (COP26), held in Glasgow, Scotland in November, and it is now clear that we have entered a new era of climate

members, played a critical role at COP26 on behalf of the vulnerable nations. Bangladesh needs to keep up its political leadership role in this regard over the coming years. Even though Bangladesh is set to hand over the leadership of the CVF to Ghana in 2022, it will remain a part of the troika that governs the CVF for two more terms, and hence will be able to play a leadership role at the political level for another four years.

Political work on tackling climate change will be a daily phenomenon from now on, and not only confined to the annual COPs. So, the entire diplomatic corps of Bangladesh as well as other vulnerable developing countries need to build capacity in climate diplomacy. This also means that tackling climate change has now become a matter for all conscious and educated citizens of every country to become engaged in, and not just leave it to their leaders to deal with. This means that a whole-of-society approach is required to tackling climate change.

A particularly important group to look up to is the youth from all over the world, many of whom are already engaged in the Fridays for Future movement led by Swedish climate activist Greta Thunberg.

This is something that Bangladesh has an opportunity to lead the world in as the new Mujib Climate Prosperity Plan (MCPP) is launched to go

change discussions.

In early 2022, we expect to see the publication of the IPCC Working Group 2 report on impacts, vulnerability and adaptation, which is expected to reinforce the evidence on loss and damage attributable to human-induced climate change. This will take us forward in terms of trying to deal with the reality of climate change around the

In terms of political actions to tackle climate change, considering the successful completion of COP26, the world is moving—albeit not fast enough—in the right direction. It is expected that more progress will be made at COP27, which is scheduled for November 2022 in Egypt and is expected to have greater emphasis on adaptation, resilience, and loss and damage.

As Bangladesh Prime Minister Sheikh Hasina, as the current chair of Climate Vulnerable Forum (CVF), which has 55 developing countries as

beyond merely adapting or even building resilience to tackle climate change, and to become prosperous despite the setbacks that climate change will inevitably cause going forward. It is heartening that many of the CVF countries have vowed to follow Bangladesh's example and develop their own climate prosperity plans as well. Bangladesh will be able to share its experience with other vulnerable developing countries over the coming decade.

As we move forward towards 2030, which is the deadline by which both the Paris Agreement as well as the Sustainable Development Goals (SDGs) are targeted to achieve their objectives, Bangladesh has an opportunity to become a global leader in combining successful development with tackling climate change. We only have nine more years to do it, so there is no time to lose.

Djokovic mystery deepens as stars begin to arrive

Novak Djokovic has not withdrawn from the ATP Cup despite claims he was almost sure to do so, Tennis Australia said

Tuesday, as other top players led by Naomi Osaka began arriving ahead of the Australian Open.

There has been serious doubt as to whether men's world number one Djokovic would travel to Australia, having refused to confirm if he has been vaccinated against the coronavirus.

An unnamed member of his team told Serbian newspaper Blic that they were "99 percent" sure that he would not play in the ATP Cup, which comes ahead of the Australian Open, adding to the intrigue over whether Djokovic would be at the first Grand Slam of the year. But Tennis Australia told AFP the Serbian had yet to pull out of the teams event, which is due to start on Saturday in Sydney with Djokovic drawn to play Norway's Casper Ruud on the opening day.

"We haven't heard of any withdrawals from Team Serbia for the ATP Cup," a spokesperson said.

Tennis Australia has organised charter flights to bring international stars into Melbourne and Sydney, with the first arriving Tuesday.

Defending women's Australian Open champion Osaka was among those to touch down, but Djokovic was not on board, TA said. Players can

also opt to fly commercial Nine-time Australian Open champion Djokovic could win a record 21st Grand Slam title if he plays at Melbourne Park, but to enter Australia he and members of his entourage have to be vaccinated.

The 34-year-old has previously expressed his opposition to the vaccine and his father Srdjan said in late November that Djokovic would probably not play the Australian Open, accusing the organisers of "blackmail".

The ATP Cup has already been hit by several players testing positive for Covid, including Russian world number five Andrey Rublev and Canada's Wimbledon semi-finallist Denis Shapovalov

Spanish superstar Rafael Nadal, who was due to play a warm-up event in Melbourne next week, also contracted the virus. They all played in an Abu Dhabi exhibition tournament this month.

Three female players at the same event also tested positive -- Olympic gold medallist Belinda Bencic, US Open champion Emma Raducanu and Wimbledon quarter-finallist Ons

Tennis Australia has organised the charter flights to help minimise the risk of getting the virus on the trip over, with all passengers having to provide proof of a negative test in the 72 hours before flying.

The Australian Open is due to start on January 17.

ENGLAND'S HUMILIATION

Calls for 'red-ball reset'

England's humiliating surrender of the Ashes to Australia exposed not only a gulf in class between the two old rivals but also laid bare, in brutally emphatic fashion, the deep-seated problems in English Test cricket.

The faint hope of a turnaround in their fortunes in this series ended with them being scuttled out for 68 in their second innings and 14-run loss in

It has been an abysmal 12 months in red-ball cricket for England, who lost four series in a year for the first time -- the crushing in Australia following home losses to New Zealand and India, and a defeat at the start of the year in India. Never before have England lost nine Test matches in a calendar year.

For all the micro-debates that will rage about

coach Chris Silverwood, selection decisions, tactical approaches, Joe Root's captaincy and the limitations of specific players, the big picture is the one that will surely be on the agenda for the England and Wales Cricket Board (ECB).

Former England captain Michael Vaughan has no doubt that test match cricket has slipped down the priorities in English cricket.

"They've not been focused enough on the test

match team. The focus has been on the whiteball team and it delivered a World Cup. But we're not a good enough cricketing nation to take our eye off the ball of test match cricket. We can't just arrive and play," he told Australia's Fox Cricket.

Another former captain, Michael Atherton,

believes that the structure of English cricket is to blame for the shocking results.

"Beyond questions of responsibility which cannot be avoided, it may be that this latest hammering brings pressure to bear upon systemic change," Atherton wrote in The Times.

"The hollowing out of English first-class cricket, pushed to the margins of the season and sacrificed at the altar of one-day cricket, has resulted in a domestic standard that is routinely revealed to be sub-standard when players come to this part of the world. Over five tests, an Ashes series is partly a referendum on respective systems, and the result of this year's is clear," he added.

Former England captain Ian Botham said he was "embarrassed" by the performances of Joe Root's side.

"I'm a little embarrassed, to be honest," Botham said on Australia's Channel 7. To lose the Ashes in 12 days ... I just think that England have lost their way. The performance today summed it up.

"It's been a walk in the park for the Australians. It burns me to say that but they have completely outplayed England."



'A bunch of whingebags!'

Former Manchester United defender Gary Neville described the current side as "a bunch of whingebags" and singled out Cristiano Ronaldo and Bruno Fernandes for their attitude during Monday's 1-1 Premier League draw at Newcastle United

Substitute Edinson Cavani's opportunistic 71stminute goal cancelled out Allan Saint-Maximin's early strike as interim United boss Ralf Rangnick's unbeaten start stretched to four games in all competitions.

'They've not done one single thing right as a team, and not one single player can go in and say they've done their jobs, or even done themselves justice," Neville told Sky Sports. "They're whinging at each other... a bunch of whingebags!"

"They're the two senior players. It's devastating for younger players when the two best players are looking at every other player like they're not good enough," he said. United, who host Burnley on Thursday, are seventh on 28 points.

Omicron may overwhelm healthcare

Warns WHO; China, Europe impose new Covid curbs

The WHO yesterday warned that the Omicron coronavirus variant could lead to overwhelmed healthcare systems even though early studies suggest it leads to milder disease, as China and Germany brought back tough restrictions to stamp out new infection surges.

China put hundreds of thousands more people under lockdown, while infections hit new highs in multiple US states and European countries.

Covid-19 surges have wreaked havoc around the world, with many nations trying to strike a balance between economically punishing restrictions and controlling the spread of the virus.

The United States has halved the isolation period for asymptomatic cases to try and blunt the disruption, while France has ordered firms to have employees work from home at least three days a week.

Contact restrictions were in place in Germany for the second year in a row heading into the New Year, as Europe's biggest economy shuttered nightclubs and forced sports competitions behind closed doors

Despite facing a much smaller outbreak compared with global virus hotspots, China has not relaxed its "zero Covid" strategy, imposing stay-at-home orders in many parts of the city of Yan'an.

Post-polls violence claims 3 lives

At least three men got killed and many others were injured in post-polls violence in several districts over the last two days.

In Pabna, Shamim Hossain, 35, publicity affairs secretary of Hemayetpur Union Awami League, was shot dead last night over rivalry between AL chairman nominee Monjurul Islam Modhu and Tarikul Islam Nilu who ran as an independent after failing to get the ruling party's nomination. "Shamim came forward to protect me and got shot. The attackers fled the scene quickly. Shamim died on the way to a hospital," said Modhu.

The AL candidate alleged that the attackers were Nilu's supporters. Nilu could not be reached over the phone for comment. Assistant Superintendent of Police Rokonuzzaman said the matter was

being investigated. In Cumilla, Farhad Hossain, 20, who was a supporter of the Awami League chairman nominee, was stabbed dead by supporters of an

Indonesia rejects Rohingyas

Sends stricken boat with 120 on board to Malaysia

Dozens of Rohingya refugees intercepted after their boat ran into trouble off the coast of Indonesia's Aceh province were being sent into Malaysian waters, authorities said

At least 100 mostly women and children aboard a wooden vessel said to be taking on water were denied refuge in Indonesia and instead pushed into the neighbouring Southeast Asian country.

Despite calls from non-governmental organisations and the United Nations agency for refugees, Indonesian authorities are attempting to send the group back after providing supplies, clothes and fuel, as well as a technician to fix their damaged boat.

"We hope (the supplies) can help the Rohingyas to continue their journey to Malaysia as they planned and intended," Winardy, an Aceh police spokesman who, like many Indonesians, goes by only one name, told AFP.

"We will monitor them until they reach their destination," he said. The wooden boat was first sighted two days ago,

stranded about 70 nautical miles off the Indonesian coast, according to a local navy commander. Indonesian authorities have not pushed back Rohingya

refugees as strongly as Malaysia or Thailand, instead reluctantly accepting them upon arrival by sea. But Amnesty International and the UNHCR have called

on the government to let the stranded group of Rohingya refugees land. This is about life and death. There are women and
