All her children dead, mother still unaware She is fighting for life

A six-month pregnant mother with two children jumped into the Sugandha river to save their lives in Jhalakathi on December 23.

However, none of her children, including the one in the womb, could

On December 23, Jiasmin Akhter, 28, boarded the MV Abhijan-10 launch, with her six-year-old girl Mahinur and eightyear-old Tamim, to return to her home in Barguna after a visit to her father's home in Keraniganj upon her grandmother's death.

As the launch caught fire in the middle of the night, she stayed on board for as long as possible with her children as she was not physically fit to try an escape due to her pregnancy.

When the launch was near the shore, the fire caught up to them and Jiasmin, in desperation, jumped into the river with her children.

After being rescued, they were initially admitted to Jhalakathi hospital and later shifted to Barishal's Sher-e-Bangla Medical College Hospital.

They were then brought to Sheikh Hasina Burn and Plastic Surgery Institute in Dhaka. Mahinur died on their way from Mawa ferry terminal.

As Jiasmin was six-month pregnant, doctors conducted an emergency C-section on her on December 25, but found the baby dead in the womb.

Her eight-year-old son Tamim died yesterday from 30 percent inhalation burn injuries. He was kept in the ICU from the start and, as his condition deteriorated, he was put on life support.

The mother, with 15 percent inhalation burns, is now fighting for life in the ICU.

Speaking to this newspaper, Jiasmin's uncle Monir Hossain said, "Her husband Khalilur Rahman has a small shop in Barguna Bazaar. After receiving the news of her grandmother's death 10-12 days ago, she came to Keraniganj with her two children. Khalilur could not leave the shop at that time.

"Despite knowing how to swim, Jiasmin could not get off the launch, worrying about her children, including one in the womb. They suffered burns as they were on the launch till the last moment.'

He added that she is still unaware that all her children are dead.

The death toll in December 24 launch fire rose to 48 as another injured died yesterday evening in a Dhaka hospital.

The blaze broke out around 3:00am in the engine room of the Barguna-bound launch carrying some 800 passengers from Dhaka. It engulfed the entire vessel within 10 minutes

Curbs return in West Bengal

Night curfew imposed; schools, colleges shut

West Bengal yesterday announced a slew of Covid-19 restrictions, including closure of schools and colleges and imposing a night curfew, as India reported more than 27,000 new cases. with infections sharply rising for a fifth consecutive day.

A 10:00 pm – 5:00 am night curfew has been ordered, following in the footsteps of Haryana, Delhi and Uttar Pradesh. Only essential and emergency services can operate in this time.

Starting today, schools, colleges and universities in West Bengal will be closed, as will swimming pools, gyms, spas and beauty salons, and wellness centres, reported our New Delhi correspondent.

Restrictions have also been imposed on shopping malls, market complexes, restaurants, and bars which will be allowed to operate with only 50 per cent of their total capacity.

Local trains have been permitted to run with half of their capacity and government and private offices would operate with 50 per cent of staff attendance from tomorrow.

Attendance at gatherings for marriages and other social, religious and cultural occasions will be limited to 50 persons, while those for funerals or burials will be limited to 20.

The state reported 4,512 new Covid-19 cases on Saturday, which takes its active caseload to 13,300 the third-highest in the country after Maharashtra and Kerala states.

West Bengal has also reported 20 cases of the more infectious Omicron variant.

According to one report, the number of Covid-19 cases in the state rose ten times in the last six days from 439 from Monday last to 4,512 yesterday with more than half of them in Kolkata alone.

Kolkata, along with India's national capital Delhi and financial hub Mumbai, is showing an exponential rise in daily new Covid cases over the last one week.

Chief Minister Mamata Banerjee dispensation has put on hold the resumption of its flagship social welfare scheme "duare Sarkar" to take stop crowding.

Delhi logged 3,194 new coronavirus cases over the last 24 hours, 15 per cent higher than Saturday.

Although the number of active cases in Delhi has tripled in just the last three days, Chief Minister Arvind Kejriwal said that hospitalisations had not gone up, reported Reuters.

"This means that most people who are coming down with (Covid-19) are not requiring hospital care. They are mild cases," Kejriwal said in an online briefing.

"Cases are going up but there is no reason to worry. There is no need to panic," he said.

Delhi was among hardest hit cities during the second wave of the pandemic in India last year, with hospitals running out of beds and lifesaving oxygen, leaving patients gasping for breath.

Mumbai reported 8,063 new cases of coronavirus in the last 24 hours, 27 percent higher than Saturday, NDTV reported.

India has recorded a total of 34.88 million COVID-19 infections, with health ministry data showed yesterday.

Chaos at US airport as more than 2,700 flights cancelled

Air travel continued to be severely disrupted in the United States on Saturday, with bad weather in parts of the country adding to the impact of a massive spike in Covid-19 infections fuelled by the Omicron variant.

The United States had 2,723 cancelled flights, more than half of the 4.698 cancelled worldwide, around 11:00 pm (0400 GMT Sunday), according to tracking website FlightAware.

In November last year, the country witnessed another student agitation after two college students were killed in two crashes in Dhaka.

According to police, 2,513 people were killed in 2,562 road accidents in 2017 while 3,502 people lost their lives in 1,701 crashes in the first eight months of last year.

The WB report, available on the website of RHD, says nearly 60 percent of the road crashes take place on the national and regional highways.

"A substantial number of the highway crashes occur at 754 uncontrolled junctions of these highways and minor roads," it reads.

Citing another WB study, the report said halving the mortality and morbidity from road injuries in a developing country like Bangladesh would likely yield an additional 7-22 percent GDP per capita over the period of 24 years.

The functioning of committees has been hampered by internal communication, a lack of coordination and integration between them and NRSC, and a scarcity of resources.
