People suffer as chaos grips Mugda centre

Hundreds of vaccine seekers, not enough space for social distancing, inadequate number of attendants to organise jab recipients and confusion about whether certain doses will be administered.

This was the state of Covid-19 vaccine administration at the vaccine centre in Nagar Matrisadan in the capital's Mugda

On the first day of fresh government restrictions to curb the spread of coronavirus and its highly transmissible Omicron variant, hundreds gathered at the centre to be vaccinated, enduring hardship as well as the risk of contracting

This correspondent spent about three hours in front of the centre from 9:00am and talked to at least 20 vaccine recipients about the management. After entering

RUNNING AT HALF CAPACITY

Bus owners won't go by govt decision

Curbs mostly ignored on first day

STAFF CORRESPONDENT

A top transport association yesterday asked its members to operate their vehicles at full capacity, violating the government directive to carry only 50 percent passengers on public transports.

Dhaka Road Transport Owners' Association gave the instruction yesterday, saying the ministry concerned has "verbally" informed them that the government would allow public transport to operate at full capacity.

Speaking to The Daily Star, Khandaker Enayet Ullah, the association's general secretary who signed the letter said, "We came to know from BRTA about the decision [to allow full-capacity operation] verbally. So, we have asked our members to work accordingly.

On Monday, the Cabinet Division issued an 11-point directive, including one that says all public transport must operate at half capacity, to curb the recent rise in Covid-19 transmission.

On Wednesday, transport leaders at a meeting with Bangladesh Road Transport Authority demanded that the government change its decision and allow them to operate at full capacity.

However, on Wednesday, BRTA reiterated that from Saturday all public transport will have to run at half capacity.

Contacted vesterday, BRTA Chairman Nur Mohammad Mazumder said they have forwarded the transport association's demand to the road transport and bridges ministry and the Cabinet Division will take a final decision in this regard.

FORCED DISAPPEARANCE Coerced by cops

Victims' families allege they're being forced to sign statements deflecting blame from police

With the heat turned up on human rights violations in the country, police have re-established contact with families of enforced-disappearance victims.

Some of the families alleged that they were being harassed and coerced into signing pre-written statements saying they deliberately misled the police by concealing information.

They claim that the move was aimed at deflecting blame from the law enforcers. According to human rights activists, families of most enforced-

disappearance victims were not allowed to sue law enforcers even though there was enough circumstantial evidence suggesting their involvement.

Instead, the families were made to file general diaries (GDs) or mention in case statements that the victims went "missing" or "never returned" or "picked up by unidentified people"

On Monday, several officials from the Sabujbagh Police Station went to the house of Mahbub Hasan Sujon in the capital's Basabo area, his brother Jahid Khan told The Daily Star yesterday. Sujon, a Sabujbagh Thana-level Chhatra Dal leader, was picked

up by armed plainclothes men from Narayanganj's Sonargaon on December 8, 2013. "The officials came around 11:00pm on January 10. They

"I was instructed to write that I 'concealed information' when I filed a GD following my brother's disappearance," said his brother-in-law Saidur Rahman Dollar.

"I had to sign it because we are not 'influential' in our area," he said, adding that they were forced to hide the truth in the GD. At least 10 such families have been visited by police recently,

according to Sanjida Tulee, who runs Mayer Daak, a platform for families of enforced-disappearance victims. Tulee's brother Sajedul Islam Sumon was picked up in 2013

and has not returned yet. These 10 cases were included in the United Nations Working

Group on Enforced and Involuntary Disappearance's (WGEID) list of 76 unresolved cases in this regard.

Ivy, Taimur make last-minute push as campaign ends at midnight

With the Narayanganj city polls campaign ending at midnight tonight, major mayoral candidates Selina Hayat Ivy and Taimur Alam Khandakar are making last-minute efforts to woo women and first-time voters who may make the difference.

Many voters believe that Ivy, as the nominee of ruling party Awami League, may get an advantage over her rivals while independent candidate Taimur, also a BNP leader, may captialise on anti-government sentiments to win more

Voters said the turnout will be a key factor in the election. A total of 5,17,357 voters, including 2,57,519 women, are eligible to exercise their franchise in Sunday's polls.

The Election Commission will use electronic voting machines (EVMs) in all

35 children hurt as helium cylinder explodes

6 in critical state; cause of blast in Cumilla not known yet

Thirty-five children were among some 40 injured when a helium cylinder, used to inflate balloons, exploded in Cumilla's Nangalkot upazila yesterday afternoon.

Six of the children were in critical state, said Dr Sajeda Khatun, deputy director of Cumilla Medical College Hospital (CMCH).

She said around 30 were brought to the hospital as of 12:15am today.

The other injured were admitted to Nangalkot Upazila Health Complex. Fazilatunnesa, a witness, said her neighbour Anwar was inflating and selling balloons near his house ahead of a fair set to start at Hasanpur today.

After Asr prayers, I heard a bang and found my daughter Habiba and 30-40 others injured."

Farukh Hossain, officer-in-charge of Nangalkot Police Station, said they were yet to ascertain the cause of the blast.

He said there was no permission for the fair amid the coronavirus pandemic and that a team may be formed to investigate the incident.

Moderna to be used as booster dose: DGHS

The government has decided to use the Covid-19 vaccine of Moderna as a booster dose instead of Pfizer jabs

The Directorate General of Health Services (DGHS) yesterday issued a notice in this regard, asking everyone involved with the government's vaccination drive to comply with the directive.

Doses of Pfizer vaccine will be reserved for students, aged 12-17 years, and others who have received the Pfizer vaccine as the first dose, reads the notice.

The government introduced the booster dose for the frontline workers and senior citizens on December 28 in Dhaka, which was expanded countywide gradually.

Since the beginning, Covid-19 shots of Pfizer, Moderna and AstraZeneca were being used as the booster dose.

Send Khaleda abroad using 'moral authority'

Kalyan Party urges president STAFF CORRESPONDENT

The president should use his "moral authority" to send ailing BNP Chairperson Khaleda Zia abroad for better treatment and take measures to enact a law in line with the constitution on the next Election Commission's formation, Bangladesh Kalyan Party proposed while holding dialogue yesterday.

Two other parties -- Bangladesh Jatiya Party (BJP) and Zaker Party -- also held separate talks with the president at the

Bangabhaban yesterday. An eight-member delegation of Kalyan Party, led by Chairman Syed Muhammad Ibrahim, also proposed taking steps to form a neutral caretaker government to

hold the national election. Led by Andaleeve Rahman Partha, a seven-member delegation of BJP, recommended that the president take measures to enact a law on formation of

In a written statement to the president, a six-member team of Zaker Party, led by Chairman Mostafa Amir Faisal, placed a

four-point proposal. The dialogue, which started on December 20, is likely to conclude on January 17 with the participation of ruling

Awami League. The president will later form a search committee that will propose names to the president for appointing the chief election commissioner and election commissioners.

Tenure of the present EC will expire on February 14.

PROFESSIONAL DRIVING LICENCE

Dope test now a must

STAFF CORRESPONDENT

Negative dope test reports from government-affiliated hospitals or laboratories would be mandatory to get or renew professional driving licences from January 30 this year.

A person with a positive dope test report or negative comments would not be entitled to get a professional driving licence from Bangladesh Road Transport Authority (BRTA).

However, the dope test would not be required for a non-professional

A professional driving licence is a must for operating commercial vehicles or rental cars or doing government jobs as a driver.

BRTA going to introduce the system more than one year after Prime Minister Sheikh Hasina gave directives to bring public transport workers under a dope testing system.

The drug addiction of bus and truck drivers is considered to be one of the major reasons behind road accidents.

BRTA Chairman Nur Mohammad Mazumder on Wednesday sent a circular in this regard to all divisional and circle offices to implement the decision.

The dope test can be done at all district-level government hospitals, six hospitals in Dhaka city and all laboratories approved by the Department of Narcotics Control, reads the circular.

The six hospitals in Dhaka city are Dhaka Medical College Hospital; National Institute of Mental Health and Hospital; National Institute of Laboratory Medicine and Referral Centre; National Institute of Diseases of the Chest and Hospital; National Institute of Traumatology and Orthopaedic Rehabilitation, also known as Pongu Hospital; and Kurmitoal General Hospital.

Says expatriates' welfare minister about media reports on recruiting syndicates for Malaysia

"Media reports on recruiting syndicates for Malaysia are nothing but trash," remarked Expatriates' Welfare and Overseas Employment Minister Imran Ahmad, while talking to The Daily Star yesterday.

"The documents being circulated are fake," he said in reference to a report in the Malaysian newspaper

On January 10, the newspaper reported that it saw the document that mentions 25 Bangladeshi recruitment agencies (BRA) and 250 sub-agents who are expected to be involved in recruiting new workers bound for Malaysia, indicating manipulation of the process.

The issue surfaced after the minister and Malaysian Human Resources Minister Datuk Seri M Saravanan signed a memorandum of understanding on December

Mentionable, this newspaper has obtained a copy of the document, which describes various stages of the recruitment process, starting from the application by employers to procedures upon arrival.

Under a section titled "Quota Auto Allocation to BRA and Engaging BRA", it states that workers to Malaysia will be recruited by 25 main BRAs that will be supported by 250 sub-BRAs. They will be automatically selected by the Foreign Workers

In light of this, recruiting agents and labour migration activists said they're afraid that the syndicate will manipulate the recruitment process in a rehash of the 2016-18 period.

Back then, the Malaysian government allowed only 10 recruiting agencies from Bangladesh to send workers there, though Bangladesh

government had sent a list of more than 700 recruiting

Although the agreed migration cost was Tk 39,500, each Bangladeshi worker had to spend Tk four lakh on average due to malpractice. Eventually, Malaysia froze recruitment from

Bangladesh on September 1 in 2018, saying that the labour recruitment practices were leading to forced labour and debt bondage.

Speaking on the issue, Imran Ahmad said he was not the minister then and so he doesn't want to hear of the

"What I want is a system and policy through which our people can find jobs in Malaysia at a low cost," he said, without specifying what the cost could be and how it could be ensured.

He said he does not want to see visa trading -- a malpractice that increases the cost of recruitment, with a lot of agents and sub-agents competing to secure job demands from Malaysia.

Asked if the government knows any such online system, which would be applied this time too, he said this has not yet come to the table during discussions between the two countries.

He said he cannot deny it if such a system was proposed by the Malaysian government.

'Whatever system it is, it will be online, but it won't be like the previous one. We will also have a different system from our side," he said, adding that the specifics are yet to be finalised.

He also mentioned that Malaysian Home Minister Hamzah Zainudin is scheduled to visit later this month to discuss the recruitment process in detail.







QAWWALI EVENT AT DU

Police foil protest rally

Silsila, a DU-based Qawwali band, organised a performance yesterday evening at the same venue, protesting Wednesday's attack.

Meanwhile, Ain O Salish Kendra yesterday demanded action against the perpetrators behind Wednesday's attack.

87pc left without jobs during lockdowns

Finds BILS study on workers of transport, restaurant, retail sectors

The lockdowns were grim for workers of the transport, hotel-restaurant and retail sectors, as they saw their jobs, incomes and savings disappear.

The combined unemployment rate in the sectors during lockdown periods in 2020 and 2021 was 87 percent, found a study. Among the three sectors, the highest rate, 95 percent, was recorded in the transport sector, while it was 83 percent in retail and hotel-restaurant sectors.

The numbers were revealed at a press conference of Bangladesh Institute of Labour Studies (BILS), held at the institute's premises in the capital.

BILS conducted the research titled "Study on the status of social protection and job security of private-sector workers; experiences amid Covid-19 pandemic and way forward" from April 5 to August

"Among the unemployed workers, seven percent are yet to find a job," said Md Manirul Islam, deputy director (research) of BILS, who presented the

The findings noted that the combined percentage drop in income in the three sectors was 81 percent. The highest, 96 percent, was witnessed in the transport sector, while it was 83 percent in

the other two sectors.

The general average monthly income of a worker was Tk 13,578, which came down to Tk 2,524 during lockdown. After the lockdown, the income rose to Tk 12,529, said Manirul.

Part-time jobs increased by 215 percent during lockdown periods, he said.

Twenty percent of workers sold off their properties, reduced their meals and sent their children to work to cope with the financial crisis, he added. Besides, 80 percent of workers' families took out loans and reduced their savings after the lockdown period, the study found.

The three sectors were covered in the study as they were heavily affected due to two major country-wide restrictions on public movement in 2020 and 2021.

Speakers at the programme recommended preparing a complete database of privatesector workers and introducing an emergency humanitarian assistance programme for them.

They also suggested creating a policy provision to provide unemployment benefits to private-sector workers in emergencies.

Among others, BILS vice chairperson Amirul Haque Amin and directors Kohinoor Mahmood and Nazma Yesmin were present.

'Whom do you actually serve?' Shujan says EC depriving

voters by not revealing candidates' wealth info

The Election Commission (EC) is "depriving voters from their rights" by not disclosing wealth information of candidates, claimed Shujan Secretary Badiul Alam Majumdar.

"We've seen that the [Election] Commission stopped disclosing wealth statements of candidates since the Dhaka City Corporation polls (held in 2020). A similar situation was observed in the Narayanganj City Corporation polls," he said.

Wealth disclosure can help a voter make informed choice when electing candidates, he

"The EC is a constitutional organisation. It is a free organisation. We want to ask the Election Commission whose interest is it serving?" he asked.

Shujan Treasurer Syed Abu Naser Bukhtear Ahmed said the rights organisation has observed over the past five years that wealth statements of public representatives have swelled four to five times.

"How is this possible? Information regarding this can help voters to choose the right

candidate," he said.

They said this at a virtual press conference, centred on disclosing information of candidates for the Narayanganj City Corporation election and demanding free and fair polls.

According to Shujan, seven people are vying in the mayoral race, with 148 running for councillor posts and 34 in reserved seats.

Of them, 120 candidates have either passed SSC or failed to complete school education. Of the seven mayoral candidates, two are entrepreneurs, one lawyer, one physician and two are service holders. The other candidate didn't disclose his occupation.

Of them, three candidates are facing criminal cases, while 40 councillors are facing cases, eight of whom are facing charges in murder cases.

NCC's running mayor and a candidate for the upcoming polls Selina Hayat Ivy, who declared her profession as doctor, has the highest annual income -- Tk 19.38 lakh, earned through mayorship. Fifty-eight candidates have wealth less than Tk five lakh while 14 candidates have wealth over Tk one crore.

Meanwhile, Shujon's Badiul Alam Majumdar said there's allegation of violating election's code of conduct by AL lawmaker Shamim Osman.

He said violating the election code of conduct is a punishable offence. "CEC Nurul Huda's comment in this regard is not clear to us," he

Huda on Wednesday said, "He [the lawmaker] violated the electoral code of conduct, but he did not flout it to such an extent which would warrant issuing a notice, handing out punishment or bringing him to book."



"Authorities cracked down on critics, journalists, and even children who criticized the government or dared to question its response to the Covid-19 pandemic," reads the report that was released yesterday.

Bangladesh security forces continue to commit enforced disappearances and extrajudicial killings with impunity, it added.

"Relatives of some of those forcibly disappeared said that police refused to accept any complaint that included allegations against law enforcement, and that some families threats faced harassment," mentioned the report.

It also read that the government denied the findings of a report after HRW released it in August 2021 documenting enforced disappearances by "Bangladesh security

League-led government between 2009 and 2020. Officials also denied

the allegations made during a briefing held by the Tom Lantos Human Rights Commission of the United States House of Representatives.

In the 752-page "World Report 2022", its 32nd edition, the HRW reviews human rights practices in nearly 100 countries.

"The first goal of most autocrats is to chip away at the checks and balances on their authority. Democracy worthy of its name requires not only periodic elections but also free public debate, a healthy civil society, competitive political parties, and an judiciary independent capable of defending individual rights and holding officials to the rule of law," said HRW Executive Director Kenneth Roth in his keynote.

Referring to the death of writer Mushtaq Ahmed in iail and torture of cartoonist Ahmed Kabir Kishore in detention, the report mentioned that the law enforcement and intelligence agencies in Bangladesh, as well as police and soldiers seconded into the Rapid Action Battalion (Rab) were credibly accused of torture and ill-treatment of detainees and suspects.

Food crisis puts Baikunthapur's tea workers, families in misery

MINTU DESHWARA, back from Habiganj

Mala Santal is an indigenous tea worker at Baikunthapur Tea Garden in Habiganj's Madhabpur. Since December, she has not received a single penny from the ration-wages she's owed. After a period of digging into her savings, she's now exhausted, leaving loans as the only means to sustain her family of four.

"I saved up some money for my three children's education. But without any ration-wages since December, I've spent up all of my savings," she told this correspondent yesterday. "I'm now taking out loans to ensure the minimum of meals for my family, but I don't know how I can pay it back.'

Her eldest daughter Smriti Santal was supposed to get into ninth grade in Jagdishpur High School this year. But after the family ran out of money, this had to be put on hold.

In disarray, Mala has decided to leave her vocation of long and started to work as a construction worker these days. Though this new job will be difficult, at least it can pay for her family's meals.

When this correspondent went to visit tea worker couple Parbati and Sagar Kul's mudhouse, he only found their four kids at home, with the youngest sibling, Gaurab Kul, crying loudly.

"Mother and father went out to look for work," said their eldest child eightvear-old Prashanta. "They haven't left any food for us. Out of hunger, Gaurab has been crying non-stop.'

Far from being isolated incidents, this food crisis is currently gripping all of Baikunthapur Tea Garden's 400



permanent workers' families. Children waiting out of hunger, their parents running to-and-fro for work, mothers feeding their child a mix of salt with boiled tea-leaf in water, it's as if the entire neighbourhood is crying out in despair.

NO POUSH SANGKRANTI THIS YEAR

The traditional Poush Sangkranti is scheduled for today. One of the biggest festivities observed by indigenous tea workers, the merriment was supposed to begin yesterday night, as the night before the Sangkranti is meant to be spent making pithas for the day.

The day was supposed to see families indulging in delicacies made out of muri, flattened rice, and molasses. But at a time when the families don't have

money to even afford rice, the joys of the Sangkranti will stay further away from

ORIGINS OF THE CRISIS

Baikunthapur.

The crisis began after the tea garden closed down due to an untoward incident, which cut out the workers from earning their ration-wages.

According to the management and workers of the garden, the debacle began after the firing of tea worker Dilip Keut, a permanent worker of the garden who began constructing a house for himself on the agricultural land inside the garden in November last year. He was expelled earlier this month.

This followed meetings and clashes between the management and workers, which peaked after the workers allegedly assaulted acting manager of the garden Mohammad Shamsul Haque Bhuiyan, prompting the authorities to close down the garden on December 8.

On December 14, Shamsul filed a case against 12 workers with Madhabpur Police Station.

Garden worker Mira Kairi said, "We work for Tk 120 per day and some ration. This was never enough to run the family, but now we don't even have that."

Talking to The Daily Star, ex-worker Dilip Keut said, "I am a permanent garden worker, working here for 15-16

"As I didn't have a house, I used to live at my brother's. It was too small for both of our families, so I decided to build a house in a vacant place with the garden authorities' permission."

"But as the works neared completion, they suddenly objected, and even expelled me," he alleged.

However, acting manager Shamsul Haque said Dilip hadn't taken permission to build the house. "While the saga was going on, a few workers came to my office and attacked, which left me and another staff member injured. After that, in the interest of our safety, the owner stopped the activities of the garden."

"We have given the workers some conditions, but they're refusing to meet them. We won't reopen the garden until

they meet the conditions," he said. Nahidul Islam, deputy director of the Department of Labour, Srimangal, said, "I have visited the tea garden. Hopefully, both parties will reach an agreement

Harmful bacteria, fungi found in buffalo yoghurt Reveals research

Researchers in Chattogram have found harmful bacterial and fungal presence in various brands of buffalo yoghurt in different districts of the country. Most cow yoghurt from popular brands, however, have been found to be safe with the expected nutrition level.

The research paper, titled "Insights into the nutritional properties and microbiome diversity in sweet and sour yoghurt manufactured in Bangladesh", was recently published in the scientific journal -- Nature.

Dr SM Rafiqul Islam, professor of genetic engineering and biotechnology at Chittagong University, led the research. Dr Adnan Mannan, associate professor of the same Department, was one of the co-researchers.

The researchers collected yoghurt from different areas including Dhaka, Chattogram, Cumilla, Manikganj, Rangpur, Munshiganj, Bogura and Cox's Bazar for three consecutive

"Harmful bacteria including enterobacter, acinetobacter and aeromonas have been found in the buffalo yoghurt," said Dr Mannan, adding, "These bacteria can cause gastrointestinal tract

Different types of fungus, including candida, iodofenuses and trichosporon, have been found in buffalo yoghurt, which can infect skin and intestine, he said.

On the other hand, useful bacterial presence, including lactobacillus and streptococcus, was found in moderate amounts in sour cow yoghurt, as microorganisms cannot survive persistently in presence of sugar, said Dr Mannan.

According to Prof Rafiqul Islam, buffalo yoghurt is made locally and the milk is not boiled at the ideal temperature while processing.

The research was initiated in July 2019 and completed in August 2021, said Prof Islam. Dr Mannan said it is the first research in the

country initiated to identify the presence of microorganisms in all sorts of yoghurt available in the country.

Prof Junaid Siddiki, of Chattogram Veterinary and Animal Sciences University, and Dr Nazmul Haque, associate professor of Bangabandhu Sheikh Mujibur Rahman Agricultural University, were also among the researchers.

3 killed, 14 hurt in road crashes

Three people were killed and 14 were injured in road accidents in two districts yesterday, according to reports from our correspondents.

In Munshiganj, one person was killed and 10 were injured as a bus hit a cement-laden covered-van from behind on Dhaka-Mawa Expressway in Sreenagar upazila. The deceased was identified as Md Ripon (22).

All the victims were passengers of the bus. Seven of the injured were taken to Dhaka Medical College Hospital in serious condition, said Mahfuz Riben of Sreenagar Fire The accident took place in Bejgaon area around

8:00am, when the bus driver heading towards Shimulia Ghat from Dhaka lost control over the vehicle. Police seized the bus, though its driver and helper managed to flee, said Md Humayun, sub-inspector of

Hashara Highway Police Station. In Brahmanbaria, two people were killed and four were injured after a CNG-run auto-rickshaw and a truck collided head-on at Kasba upazila.

The accident took place on the Cumilla-Brahmanbaria regional highway in Kharera area around 8:00am.

Two people -- the CNG driver and a passenger -- died on the spot, said police. One of the deceased was identified as Kawser Mia

(35), the auto-rickshaw driver, said OC Shahjalal Alam of Brahmanbaria Khantihata Highway Police Station. The injured were taken to Brahmanbaria General

Hospital, said the OC.

Young, experienced makes the difference

The combination of experience and the spirit of youth could become good partners, whether in building society or running any organization. I have seen many successful examples built with this combination. A few days back, I went to see a wonderful initiative at Kachina village in Mymensingh's Bhaluka upazila. Four visionary youths and three experienced farmers have joined hands to build an integrated farm. Such agricultural initiative is now an example of success to many. They have a project to cultivate malta, lemon and fish on 20 acres of land, combining agricultural experience of three profarmers and four tech-savvy young men.

"While studying, we always thought about how our higher studies in computer science would have an impact in our lives and we could stay close to the nature as well," shared one of the youths. "Your agricultural reports on YouTube opened our eyes and we thought cultivating high-value fruit crops can be a great option," added another young entrepreneur. "We had the indomitable will and knowledge to use technology for the betterment of farming," said another entrepreneur Shariful, who was talking

to me while working on a laptop. I felt good that intelligent youth are coming closer to the soil. Finally, their initiative started in 2017.

Shamsul Haque Suruj, aged around 60, is also a part of this initiative. "I have been working in the farming sector, especially paddy, jute, wheat and sugarcane, for many years now. But, I never thought I would join these boys and cultivate malta and orange. It was new to us. The young boys showed us your YouTube videos and we learned everything very fast. The video on the malta orchard of Shakhawat Hossain of Chuadanga inspired us a lot," Suruj said.

"After visiting Shakhawat's orchard I bought 1,700 malta saplings," Suruj said. Besides, the government's agriculture department first gave them 120 saplings and guidelines and later provided them another 300 saplings. "We bought another 230 saplings and extended our cultivation on one acre," Suruj added. Let's talk about the harvest. They sold about three tonnes of malta. Usually, the yield comes low in the first year. During the second harvest they got a bumper yield. "We sold 18 tonnes of malta and after all the expenses, we made a profit of Tk 15 lakh (USD 17492)," he added. They do not use pesticides, instead they use

sex pheromone traps that costs only Tk 5000 (USD 58) a year. Sometimes they all stay at the farm, because it is a

dream for them. Now farming has become technology-based. It can be said that technology is the foundation of such entrepreneurs. Another entrepreneur Engineer Moazzem Hossain Badal left his job opportunities in the IT sector. Now he is contributing his ICT skills in farming. His main goal is to build a modern farm, not just a conventional one. He wants to bring the world's most advanced high-yielding crops into production. Badal said, "We decided to cultivate organically, because currently the world has a huge market for organic agricultural products.

Although local malta prices are half that of the imported ones, they are not unhappy with the price, compared to their production costs. Shariful Islam is working on the price, market policy and strategy. He said more fruits are sold online. He, however, mentioned some problems. Many people order for five or ten kilogram of malta, but there is no opportunity to deliver such a small amount online. The same happens during the mango season. Now, there are many courier services available for mango delivery and it would be nice

Today, agricultural projects of young entrepreneurs are the evidence of such success. Success in farming at Kachina village is an example. The hard work of educated youth, mixed with experienced farming brains, is just a perfect match. Successful aspects of technology-based organic farming practices are becoming popular now. I believe this will play a vital role in overall agricultural development in Bangladesh.

HRW: Leaders failing to defend democracy

Human Rights Watch yesterday criticised US President Joe Biden and other Western leaders for a weak defense of democracy and for failing to meet challenges from the climate crisis and Covid-19 pandemic to poverty, inequality and injustice.

In contrast to what Human Rights Executive Director Kenneth Roth described as former US president Donald Trump's "embrace of friendly autocrats", Biden took office in January 2021 with a pledge to put human rights at the center of his foreign policy.

"But he continued to sell arms to Egypt, Saudi Arabia, the United Arab Emirates, and Israel despite their persistent repression," Roth wrote in Human Rights Watch's annual World Report, released yesterday.

"Other Western leaders displayed similar weakness in their defense of democracy," Roth wrote, naming French President Emmanuel Macron and former German Chancellor Angela Merkel.

Roth also said that during key summits Biden "seemed to lose his voice when it came to public denunciation of serious human rights violations."

"If democracies are to prevail in the global contest with autocracy, their leaders must do more than spotlight the autocrats' inevitable shortcomings. They need to make a stronger, positive case for democratic rule," Roth

Heartfelt enough?

UK PM's future uncertain after lockdown party apology

British Prime Minister Boris Johnson's premiership was in the balance yesterday as he faced calls from within his Conservative Party to resign after he admitted attending a party at his official residence during a coronavirus lockdown.

Johnson on Wednesday issued "heartfelt apologies" for attending the gathering at Downing Street in May 2020, telling parliament he understood the public's rage at the revelations.

Senior ministers rallied around to offer support to their leader, who won a landslide election victory in 2019, although media said the backing of finance minister Rishi Sunak, taking advantage of the lovely weather. "Bring your own booze", it said.

At the time, social contact was limited to a bare minimum and many people were furious that they had been unable to visit loved ones on their deathbeds or attend funerals.

In response to opponents' demands for his resignation, Johnson said people needed to wait for the outcome of an internal investigation being carried out by senior civil servant Sue Gray, whose report is expected in the next two weeks.

The revelation about the party follows similar allegations about rule-breaking by Johnson and his officials earlier in May 2020 and during a Christmas lockdown at the end of that year.



regarded as a potential successor to Johnson, appeared lukewarm.

Others were more direct. The Conservatives' leader in Scotland, along with a handful of other prominent lawmakers, called for Johnson to resign, saying his position was untenable.

"The mood isn't great," Conservative member of parliament Jake Berry told BBC radio. "There is a lot of concern amongst my

"There is a lot of concern amongst my colleagues about the damage that these revelations are doing to the Conservative Party. But I think yesterday there was a bit of a turning point of opinion."

Johnson admitted for the first time on Wednesday he had joined a gathering held in the garden of Downing Street on May 20, 2020, saying he had stayed for about 25 minutes to thank staff at what he thought was a work event. He said he regretted his action.

Media reports have said tables in the garden were set out for food and wine, while an invitation sent to around 100 people suggested

A YouGov poll for the Times newspaper, carried out before Johnson's apology, put the opposition Labour Party 10 percentage points ahead of the Conservatives, whose lead has evaporated.

The Conservative Party is notoriously ruthless in dispensing with leaders who are feared to damage their electoral chances, most recently forcing Theresa May from power after three years amid bitter internal squabbles over Brexit.

To trigger a leadership challenge, 54 of the 360 elected Conservative members of parliament (MPs) must write letters of no confidence to the chairman of the party's "1922 Committee", with a small number saying they had already penned such letters.

Many MPs are said to be waiting for the outcome of Gray's report before taking any action, newspapers said, while May's local council elections could also be crucial in determining whether Johnson will face an insurrection.

West-Russia talks so far 'unsuccessful'

The Kremlin yesterday gave a bleak assessment of Russia's security talks with the United States and Nato this week, describing them as "unsuccessful" and saying there was disagreement on fundamental issues.

Kremlin spokesman Dmitry Peskov also said Moscow viewed a sweeping sanctions bill unveiled by US Senate Democrats "extremely negatively" and that its timing meant it looked like an attempt to put pressure on Moscow.

Peskov said two rounds of talks so far this week between Russia and the West had produced some "positive nuances" but that Moscow was looking for concrete results, not nuances.

The talks, which moved to Vienna yesterday for a meeting of the Organisation for Security and Cooperation in Europe, are centred around an array of security demands that Moscow has made of the West, while building up forces near Ukraine.

Moscow wants legally binding promises that Nato will never allow former Soviet Ukraine to become a member and that the alliance will pull back troops from former Communist states in central and eastern Europe.

The proposed sanctions legislation, backed by the White House, would target top Russian government and military officials, including President Vladimir Putin, and key banking institutions if Moscow engages in hostilities against Ukraine.

Global firms failing to protect forests: report

Global companies and financial institutions with the highest potential for curbing deforestation are largely failing to do so, undermining pledges to protect forests made at the COP26 climate summit in November, a report said yesterday.

The Forest 500 analysis by non-profit research group Global Canopy graded 350 companies most responsible for producing, using or trading commodities that drive deforestation, along with the 150 biggest banks, investment firms and pension funds that finance them.

One-in-three companies assessed had no forest commitments at all, and 72 percent addressed some but not all of the forest-related commodities in their supply chains. Even those with commitments keyed to specific commodities — especially soy, beef and leather — "are failing to provide evidence of how they are implementing them", the report concluded.

Cargill, Colgate-Palmolive, Nestle Corp., Unilever and PepsiCo were among 15 companies sharing a favourable ranking, while many from China, Brazil and Argentina had the lowest score possible in the five-tier rating.

Progress is even more halting among financial firms, which provide more than \$5.5 trillion every year to companies in forest-risk supply chains, according to the report.

The Glasgow Leaders Declaration on Forests and Land Use was signed during COP26 by 141 countries committing to halting and reversing forest loss and degradation by 2030.



Russia-led troops begin pullback from Kazakhstan

Over 2,000 Russia-led troops yesterday began withdrawing from Kazakhstan after being deployed when peaceful protests over an energy price hike turned into unprecedented violence claiming dozens of lives. "The peacekeeping operation is over ... the tasks have been fulfilled," said Russian General Andrei Serdyukov, commander of the CSTO contingent that saw troops from Russia, Belarus, Armenia, Tajikistan and Kyrgyzstan sent to the former Soviet republic on January 6. US Secretary of State Antony Blinken earlier warned Kazakhstan that "once Russians are in your house, it's sometimes very difficult to get them to leave".

US lays out case against China maritime claims

The United States on Wednesday laid out its most detailed case yet against Beijing's "unlawful" claims in the South China Sea, rejecting both the geographic and historic bases for its vast, divisive map. In a 47-page research paper, the State Department's Bureau of Oceans and International Environmental and Scientific Affairs said China had no basis under international law for claims that have put Beijing on a collision course with the Philippines, Vietnam and other Southeast Asian nations. Releasing the study, a State Department statement called again on Beijing "to cease its unlawful and coercive activities in the South China Sea." China hit back, claiming the report "distorts international law and misleads the public."

Seventy-six percent of those surveyed in the poll by Quinnipiac University said they think political instability in the United States is a bigger danger than foreign threats.

A majority of those polled -- 58 percent -- said they think the nation's democracy is in danger of collapse. Thirty-seven percent disagreed.

Tough time ahead with continuing Covid surge

Govt's curbs must be well-thought-out and enforceable

S has been predicted by health experts, the number of Covid-19 cases in the country has been rising at an alarming rate. The DGHS reported 3,359 new cases and 12 deaths in 24 hours till 8am Thursday, while the positivity rate jumped from 2.43 percent on January 1 to 12.03 percent on January 13. According to a DGHS spokesperson, if all the people with symptoms get tested, the real number of infections would be much higher. That being the case, we must do everything to prevent the impending crisis before it further cripples the economy and overwhelms our hospitals

While we appreciate the health minister's concerns regarding the issue, as he warned of a massive spike in cases in the coming days, what we expect from his ministry is that they would give the necessary guidelines to all our public hospitals and prepare them with the equipment and medicines needed. According to DGHS data, around 1,300 Covid patients were admitted to hospitals as of January 12. Since more patients may need hospitalisations and oxygen support, the ministry must ensure that no hospital suffers from lack of resources. Increasing hospital beds for Covid patients must also be considered since the existing 20,000 beds may not be sufficient in case of a massive surge. In addition, the government's vaccination drives must also be expedited.

About the imposition of new Covid curbs—which took effect on January 13—we would like to point out that some of the curbs were not well-thought-out or practical: the directive given to the transport sector is one of them. Reportedly, the government ordered all public transports to run at half capacity in a bid to maintain social distancing. However, it does not seem like an enforceable idea given that all the offices, factories and shopping malls will remain open and people will have to go to their workplaces regularly. From our previous experiences, we know how difficult it would be for people to commute to their workplaces and that only the transport owners will be benefited from an increase in fares in the end. Thus, we think, the government should reconsider the decision.

Moreover, considering the effects of the pandemic on our education sector in the past two years, we think the government should not take the decision of closing down educational institutions, particularly schools, right away. The education ministry must come up with a proper plan, taking suggestions from the experts.

Since the government has already developed a zoning system to curb infections across the country, decisions about imposing restrictions should also be taken zonewise, considering the infection rates in particular zones. Last but not the least, people should be encouraged to regularly maintain health safety guidelines including wearing masks, maintaining social distancing as well as getting vaccinated as soon as possible.

No room for road safety?

Plan to expand road safety division should be reconsidered

E wonder how far removed from reality the public administration ministry must be for it to not approve the Roads and Highways Department's much-needed plan to expand its road safety division. The RHD had sent a proposal to revise its organogram to the ministry in early 2020. Among other changes, the department proposed expanding the Road Safety Division into a circle of three divisions under a new wing, which reflected an urgent need for decisive interventions to address road safety concerns. But while the ministry partially approved some of the proposed changes in October 2021, it did not acknowledge the expansion plan for the road safety division, meaning that once the new organogram comes into force, the division will cease to exist.

This is, one can argue, the opposite of what we should be doing to tackle the ever-rising number of road accidents and fatalities. Given the gravity of the situation, shouldn't the expansion plan have been looked over and approved on a priority basis? Instead, the RHD is now forced to revise its plan to somehow include road safety initiatives within its new organogram. The current road safety division consists of about 10 people, not nearly enough to handle the massive workload. Although it will be a while before the organogram comes into effect, it is unlikely that the RHD's demands for more manpower will be met.

Already, the Road Transport Act 2018 is sitting largely idle and still being redone as per demands of transport associations. If the attitude of the public administration ministry is so dismissive towards a plan that could help reduce deaths on the roads, it is certainly a cause for concern.

The RHD chief engineer has said that their next course of action would be to resend the proposal, including the road safety division provision, to the public administration ministry. We hope it will be considered so that the department is better armed to decrease the likelihood of accidents occurring on our roads. Given the country's appalling road safety scenario, if there is one sector that deserves all the resources it can get, it is the one dedicated to making our roads safer through auditing, investigation and coming up with corrective measures.

whereas it is their duty to prevent such accounting manipulation.

Finally, all these are going to distort market operations. In a free market, the market is supposed to fix the prices—i.e. determine what something is really worth. By permitting such accounting changes, the regulators are not allowing the market to operate, thereby destroying its ability to determine prices. Such market distortion is dangerous, especially in the financial sector.

Interestingly, the Bangladesh Bank issued the aforementioned directive a few hours after its meeting with some of the country's top business leaders at its headquarters, even though we are not aware of the central bank conducting any studies to estimate what effects its decision would have on the overall economy.

This, of course, is not the first time that intervention occurred in the banking sector at the behest of special interest groups: for example, when habitual defaulters were left untouched along with their banker cronies, and the state decided not to punish the wilful and habitual defaulters but to "bail out" the banks using taxpayers' money. This happened despite the fact that banks were clearly okay with, if not complicit in, the "corruption" that had destroyed their balance sheets. The state decided to shift the losses, caused by the wilful defaulters, "onto the public" by using taxpayers' money to bail the banks out. Such practices cannot lead to financial discipline and a robust banking sector.

These interventions are clearly not in the interest of the public, or the banks themselves in the long run. Even though the Bangladesh Bank is allowing banks to pretend like they are performing well, the reality is that they are becoming more vulnerable.

Now, according to the central bank, this move was necessary to ensure that businesses are able to recover from the pandemic-induced setbacks. And it is true that the government should pursue policies that are business-friendly in order to get the economy back on track. We are in favour of such policies. But the one that the Bangladesh Bank is following could allow wilful defaulters and cronies to flourish, and do little to help the genuine businessmen to operate within the law. In the long run, this can endanger our already weakened banking sector-weakened by the past policies of the regulators and their failure to stop one scam after another.

At the end of the day, what is important is that genuine businesses that make profit by providing something of value to the people get support from the government, not those who make profit by getting subsidies by lobbying to the authorities. In regards to the central bank's latest policy, how does it intend to ensure that is not the case—especially given what has happened in the banking sector over the past many years?

Around the world, governments are supporting businesses in their countries to recover from losses incurred during the pandemic. But at the same time, almost all central banks around the world are trying to get commercial banks in their countries to increase provisions in order to offset the risks brought about by the pandemic. We seem to be doing the very opposite.

Even though the Bangladesh Bank has asked banks to maintain an additional three percent (on top of the existing one percent) provisions, relaxing banking discipline and allowing habitual defaulters to potentially get more access to bank credits is dangerous, and may lead to further expansion of NPLs, which is already very high.

Again, one must ask, on what basis did the Bangladesh Bank make this decision? Was it based on any case study? The central bank owes the public an answer to this question.

T is now more than four months since the dramatic exit of US and other Western forces from Afghanistan. By chartering special flights, loosening asylum rules, and releasing funds, Western countries airlifted a few thousand lucky Afghans to safety as the Taliban retook control of the country. But those left behind have been shut off from the rest of the world.

Foreign governments have frozen international banking transactions and trade with Afghanistan, mostly at the behest of the US. As a result, Afghan public-sector salaries have dried up, and the economy has tanked. Many development-aid projects, no matter how essential, have been paralysed or cancelled.

As a result, the onset of the harsh Afghan winter has brought rising prices, and food has become increasingly scarce. Schools, clinics, and hospitals across the country have stopped functioning. So, just when the Afghan people need more help, they are being denied even the basics.

International humanitarian aid workers and Afghan communities themselves are doing their best to keep food aid moving, clinics functioning, and schools open for boys and girls. But the challenges are huge. Afghans now

face destitution, and even famine, on a

dramatic scale.

If the status quo continues, almost the entire country faces acute poverty this

entire country faces acute poverty this coming year. By the end of this winter, almost the entire country—97 percent of the population—could be too poor to survive without aid.

The rest of the world, and developed countries in particular, should not think that they can just shut the door and forget about this mounting tragedy. Basic morality aside, the instability resulting from Afghanistan's collapse will be felt far beyond the country's borders.

To be sure, it is right to stand up for Afghan girls' education. But, as the Afghan analyst Orzala Nemat of the University of London's School of Oriental and African Studies recently put it, it is not right to withhold aid for the basic services—food, water, and health care—that keep those girls alive.

The current meltdown is a nightmare. Instead of sticking its head in the sand, the international community needs to act. There are three measures in particular that can be taken without rewarding the Taliban.

First, money must be made available. The UN will seek to raise USD 4.5 billion in 2022 to help the most vulnerable in Afghanistan. This plan is a stopgap measure for more than 21 million people who need food, shelter, medicine, and protection. The international community can surely find such a sum.

In addition, the UN Security Council recently adopted a resolution exempting humanitarian activities from the sanctions regime imposed on some Taliban members. Governments and financial institutions must make the most

of this fresh opportunity. Second, there needs to be more flexibility in how donor funding can be used. For example, the World Bank holds USD 1.5 billion in trust for Afghanistan, and recently announced an agreement to transfer USD 280 million—some to the UN Children's Fund (UNICEF) to provide health care, and some to the World Food Programme. The whole fund should now be reprogrammed to help the Afghan people.

It should also be possible to use donor funding to pay public-sector workers' salaries and to help Afghan institutions deliver basic services such as healthcare and education, and still not be seen as rewarding the Taliban. Such support for essential state functions will give Afghans hope for the future and reason to stay in their country. Hollowing out the state, on the other hand, is a recipe for suffering and instability.

Third, the international community needs to become smarter about how it engages with Afghanistan. Currently, the world is waiting for the Taliban to make progress on various international norms without clearly defining what it expects of the regime. The Taliban, meanwhile, are either not inclined to meet these expectations or opaque about their intentions.

This approach virtually ensures failure. The international community needs to be much more decisive and specific in its demands, as well as far more engaged. This could include relaxing or lifting some economic sanctions, or gradually reintroducing longer-term development assistance, in response to progress on issues of international concern—including women's and girls' rights.

The world needs to provide the people of Afghanistan the support they need, because the catastrophic consequences of failure will not be theirs to suffer alone.

The long, winding road to remedy for spousal violence

HILE covering a discussion

on domestic violence last

year, like many others in

the audience, I was deeply touched by Rahela's story of helplessness. Rahela (not her real name), a domestic violence survivor from Atgharia upazila of Pabna, had been abused by her husband ever since she got married 15 years ago. Although initially her husband, a drug addict, would torture her occasionally, it became more frequent as time went by, she said, wiping her tears. But one day, during the Covid-induced lockdown last year, the 28-year-old mother of two could not bear the torture any longer. The man beat her severely with a stick, which landed her



Department of Dance—at the hands of her in-laws is a perfect example of how lack of support can force women to keep silent until their deaths.

Furthermore, in the absence of proper institutional support including shelter, psycho-social counselling, medical services and livelihood opportunities,

violence she had faced from her husband. During her eighth month of pregnancy, she said, she discovered that her husband was cheating on her, and when confronted, beat her severely. He also threatened to kick her out of the house, so she couldn't take any action against

district courts in the past 10 years, while the Barishal Chief Judicial Magistrate Court recorded only one in 2020, and that too was still pending disposal. A lawyer with 25 years of experience at the Metropolitan Magistrate Courts in Dhaka said that no one had approached him to file a case under the Act in the last 10



Rahela said that she had gone to the local UP chairman to complain about her husband's history of violence, but she was advised to go to the police station. After taking treatment at the hospital for two weeks, she went to the Atgharia Police Station, where the duty officer asked her to file a complaint, and that was all. According to Rahela, police did

Later, when I contacted her personally,

nothing about her complaint, rather, after a month and a half, she was forced to return to her abuser as her parents could not bear the extra costs of keeping her two daughters and herself, while her in-laws and neighbours made a mockery of their situation saying, in Rahela's words, she "had to return eventually, even though she went to the police to teach

Although spousal violence is the most prevalent form of violence facing women in Bangladesh-according to a 2015 Bangladesh Bureau of Statistics survey, 73 percent of ever-married women reported having experienced violence from their husbands in their lifetime—an overwhelming majority of them have to endure a similar scenario while seeking remedies. They have to go through a myriad of other challenges including social stigma.

Data obtained from the national emergency helpline 999 also shows that the number of complaints against spousal violence has increased by 1/4 percent during the past two and a half years. with 3,348 complaints recorded in 2021, 1,123 in 2020, and 388 in 2019. In 2021, such complaints were almost half (47 percent) of the gender-violence-related calls attended by 999. However, in only a few instances, cases were filed under the Women and Children Repression Prevention Act 2000, as most survivors do not want to file a case, instead they want to see the matter resolved internally. Unlike Rahela, who at least showed the courage to go to the local UP chairman and police to seek remedies, victims mostly keep silent about the bodily harm and emotional abuse suffered.

Speaking up or taking action against an abusive husband is not an easy decision, as I have discovered while interviewing many survivors of domestic violence. Many think they have little choice in this regard, with social and familial pressures always hanging over their heads. They are advised to comply and endure silently, or risk losing it all. The shocking death of Elma Chowdhury Meghla—a student of Dhaka University's

many victims are reluctant to pursue a legal battle and return to live with their tormentors. According to a 2020 Human Rights Watch report, there are only 13 longer-term government shelters for women and girls in Bangladesh, including seven Safe Custody Homes run by the Ministry of Social Welfare (two of which in Dhaka division) and six shelters run by the Ministry of Women and Children's Affairs, where women can stay for up to six months with up to two children under the age of 12.

"In addition, there are eight Victim Support Centres (VSC), which technically offer short-term shelter for up to five days, run in coordination between the Bangladesh police and NGOs. But shelter services at VSCs are inconsistent and unreliable, and activists say that in reality they often don't allow stays beyond one night in case of emergency. Finally, there are an estimated 15 additional NGO-run shelters. In total, therefore, there are a mere estimated 36 shelters in a country with over 80 million women and over 64 million children," the report stated.

Although we have a very progressive law-Domestic Violence (Prevention and Protection) Act 2010, which gives victims of domestic abuse the opportunity to get different remedies including protection orders, the right to reside at the marital home, temporary custody of children, and recovery of personal assets and assets acquired during marriage—its implementation is still very poor, due to a lack of awareness among victims as well as key implementing agencies.

For example, 28-year-old Mehroo, a caseworker at an NGO that works on preventing gender-based violence, said that even though she was aware of the DVPP Act and her rights, she could not secure remedy under the Act for the

According to Mehroo, based on her experience of working with her organisation, she found that the road to remedy under the DVPP Act is also uneven, complex as well as timeconsuming, as the implementing authorities are not well aware of these progressive provisions. In her case, it was simply impossible to pursue a prolonged legal battle as she was heavily pregnant, unable to walk properly, let alone run to courts.

A 2020 study conducted by Prof Taslima Yasmin, an associate professor of law at Dhaka University, also found that 19 of the 20 survivors interviewed had never heard of the DVPP Act. Even when they went to law enforcement agencies or administrative officers, they were not informed that they could get remedy under the law. Clearly, there is a lack of orientation and training on the provisions and usage of the law.

Taslima's study also found that victims only seek remedy when physical torture reaches a severe level, or after they were denied access to their marital residence or the husband remarried.

Another shocking discovery was that although the study found case records from the Chief Judicial Magistrate Courts in over a dozen districts, it found no case filed under the law in Bhola and Sherpur

years; he saw only one case being heard in a court during this time. Similarly, the Judicial Magistrates in Gazipur, Narsingdi, and Mymensingh informed that they rarely saw any case being filed under this law. According to the Act, the upazila

women affairs officers have been made responsible as Enforcement Officer (EO) for reporting incidents of domestic violence to the court, accessing legal aid under the Legal Aid Act 2000, referring victims to safe shelters, if necessary, and much more. However, some organisations working on preventing violence against women said that the enforcement officers remain unavailable for immediate support, as they are overburdened with duties and underequipped in the absence of any budget.





Australia on Friday. Australia retained the urn with comprehensive victories in Brisbane, Adelaide and Melbourne and while England managed to halt the juggernaut in Sydney, it

was not without a price. Wicketkeeper Jos Buttler's tour was cut short by a finger injury, while allrounder Ben Stokes (side) and middle order batsman Jonny Bairstow (finger) are doubtful for the pink-ball Test in Hobart after getting bruised in Sydney.

England are ready to play Stokes and stumperbatsman Bairstow purely as batters with Sam Billings likely to don the keeping gloves in his Test debut.

Pant ton ignites spark in Cape **Town Test**

Rishabh Pant scored a brilliant unbeaten 100 from 139 balls as India were bowled out for 198 in their second innings on the stroke of tea, to set hosts South Africa a victory target of 212 on day three of the decisive third and final Test at Newlands.

Pant took the attack to the home bowlers after lunch and smashed four sixes in an innings of high quality on a difficult wicket for batting.

With the series on the line, South Africa will have to chase their target on a pitch with prodigious seam movement and against a high-quality Indian pace attack.

A fourth innings target of over 200 has been successfully chased only three times in 133 years at Newlands as India seek to claim a first ever series win in South Africa. One of those was when South Africa chased 211 against India in 2007 to win the

South Africa scored 84 for one when the last report was filed.

'Could have learned more if Gibson stayed'

Ebadot Hossain's unbelievable spell led to something Bangladesh had never achieved in the past in New Zealand, bringing a historic milestone as the Tigers defeated the Black Caps in a Test match for the first time. It was also Bangladesh's first win in any format on Kiwi soil and the hero of that match, Ebadot Hossain, shared details of that journey with the Daily Star's Ekush Tapader while also expressing disappointment at the departure of bowling coach Ottis Gibson. The excerpts are below:

The Daily Star (DS): Two different realities before and after the New Zealand tour. Can you feel the difference?

Ebadot Hossain (EH): I've been trying to do something good for a long time. There was a willingness to do something in my mind. Everyone showed tremendous endeavour from start to finish. The biggest thing is that we are the team who started winning here. The teams who will come after can take inspiration from us and they will win too. [Khaled Mahmud] Sujon sir gave us a motivational speech that stuck in our hearts. He said 'we didn't come here only to play and go back home. Someone has to stand out.' Then we thought that we were capable and could win with collective effort.

DS: You were quite expensive early on but you had a good economy in the Pakistan series as well.

EH: I was unorganised. It is difficult to get

success in international cricket while being ill-disciplined. I was trying to express myself. All of my matches were big. I debuted against New Zealand then played against India and Pakistan. I've worked with Ottis Gibson regarding this as well.

DS: Champaka Ramanayake said you used to get disappointed after not getting wickets.

EH: Test cricket is really about patience, for both bowlers and batters. Champaka used to tell me I would be successful when I found accuracy. He called me after we won the Test and said 'remember what I told you? You are successful today because of your accuracy and the world is clapping. You have to keep it going and take the graph higher from here'.

DS: You have heard that Ottis Gibson is not staying anymore? How much will you miss him? How much did you improve under him in two years?

EH: It's disappointing. He has coached great players. [James] Anderson, Stuard Broad, Mark Wood and [Kagiso] Rabada still call him and take advice from him. It would be good for us if he stayed because the graph of improvement is strong. I think all pace bowlers improved under him. You can ask Taskin or Shoriful or Rahi and they'll say the same thing. Everyone had great chemistry with him. We have the South Africa series ahead and Ottis has

good knowledge of their conditions. We could have learned a bit more if he stayed.

DS: You were bowling at consistent speeds for a longer time. What was Ottis's influence behind this?

EH: I've been working with him since the Pakistan tour [in 2020]. It's been a pleasure working with him because I benefitted a lot. I have made changes to my bowling action according to his suggestions in loading and gathering. My previous action was a lot like Brett Lee's and couldn't find consistency when I got tired. But now I can bowl for a longer period while maintaining speed.

DS: What did you discuss with the New

EH: I spoke with Tim Southee the other day about our upcoming South Africa tour. He suggested that I analyse the current conditions of their wicket with a computer analyst so that we can pick up the correct length to bowl there. [Neil] Wagner came to us after the first Test and told us that we deserved the victory. [Trent] Boult told us ahead of the warm-up for the second Test: 'Yesterday is gone, today is a new day, so enjoy your bowling'.

DS: How would you rate the New Zealand series?

EH: It's not wise to expect to be man-ofthe-match in every match against the Test champions. There will be good days, and there will be bad. But I'll say I tried.

Stage set for youngsters to flourish

With a promise of providing glimpses of the future cricket stars, the ICC Under-19 World Cup gets underway today with two matches in Guyana, as hosts West Indies take on Australia at Providence Stadium, and Sri Lanka facing Scotland at Everest Cricket Club.

Split into four groups, 16 teams will be fighting for glory in a total of 48 matches over 22 days with the final set to take place at the Sir Vivian Richards Stadium in Antigua on February 5.

Antigua and Barbuda, Guyana, St Kitts and Nevis, and Trinidad and Tobago will be hosting the matches of the 14th edition of the tournament across 10 venues.

Will this edition see a new champion or will Rakibul Hasan's Bangladesh be able to defend their title after being crowned champions for the first time by beating India in Potchefstroom two years ago?

Rakibul, who was part of the champion side and ended as the highest wicket-taker for Bangladesh in that edition, was confident of getting off to a good start when he attended a virtual press conference on Wednesday ahead of the start of the World Cup.

The defending champions' campaign, however, will begin on Sunday when they meet England at the Warner Park in St Kitts.

The tournament will see the top two teams from each of the four groups go through to the

Trinidad and Tobago will host the Plate competition between 25 and 31 January while the Super League action will commence on 26 January in Antigua and Barbuda.

The two semi-finals will be played on February 1 and 2 at the Sir Vivian Richards Cricket Ground and Coolidge Cricket Ground respectively.

Shakib Al Hasan was there even though he really was not and ODI captain Tamim Iqbal and T20 skipper Mahmudullah Riyad wanted to be there but could not as the final group-phase matches of the ongoing Bangladesh Cricket League (BCL) one-day tournament yesterday took the shape of a virtual semifinal.

Shakib already decided about participating in two matches in Sylhet and his side Walton Central made the final before the final round of matches. So, Shakib left for Dhaka before the last round, leaving his national teammates Tamim and Mahmudullah to battle it out for East Zone and North Zone respectively.

Asked to bat, North Zone got off to a stuttering start before Mahmudullah and skipper Marshall Ayub put together a 120-run fourth-wicket rescue act. Mahmudullah departed to a run out after an 87-ball 66 and Marshall followed him back a couple of overs later before the innings crumbled, bowled out for 216.

Tamim got his side off to a smooth start and a six straight down the ground signaled his intent but Mahmudullah sent him back after a 38-ball 35. Imrul Kayes and Afif Hossain (26) held the innings together, with the former playing a match-winning 71 off 81 deliveries. Despite some wickets at the death, East Zone pulled through with a four-wicket victory.

Ultimately the victory did not bring them what they were looking for. A Walton Central Zone victory over South Zone in the other game would have seen East Zone make the final but South won by five wickets. South Zone and Central Zone will play the final on January 15.

Youngsters hardly off beaten track

Govt study finds most of them aspire to pursue mainstream career

Although the pressure to become a doctor or an engineer is gradually dissipating, the two professions still rank on the top among the youths, found a first-of-its-kind study by the government.

In most cases, they wanted to follow all the mainstream professions like doctor, engineer, teacher, banker, lawyer, mawlana [religious preachers].

According to the study, adolescents are dreaming about various off-track professions like YouTubers, professional gamers, content creators, voice artists, philanthropists, cricketers and so on.

"Yet they were trapped in the traditional classroom-learning structure, which has little or no significant role in fulfilling their dreams," said the report titled "Advancing Human Development in Bangladesh: Looking Ahead", prepared by

the Economic Relations Division. To get an understanding of the adolescents' minds regarding their dreams about the future, ERD researchers conducted an explorative survey among 145 adolescents at all eight divisions

between August and September last year. As many as 33 percent of the surveyed adolescents, which comprised of students from both Bangla- and English-medium schools and Madrasas, harboured off-track

They expressed their desire to study specific subjects that can serve their purpose to pursue their dreams like fine arts and painting, content creation, and social media growth or ICT.

"Some were even ready to quit from this traditional mainstream schooling system that is not modern and unable to

accommodate the arrays of dreams and goals of their lives," it said.

However, the most common dream of the parents is to see their children in teaching or to get into a government job, the study found.

Becoming doctors, engineers, bankers or lawyers were also the parents' aspirations.

Helping people was the adolescents' topmost aspiration, followed by simply

becoming successful.

"Another significant area of their dreams and aspirations are related to the prosperity of society and the country. Their enthusiasm to engage in the humanitarian cause and to work for the disadvantaged people is widely apparent," it said.

Becoming doctors, entrepreneurs and engineers were also coveted professions. Only a small percentage wanted to go

abroad for higher studies, while a bigger percentage wanted to become travellers. There is no other alternative but to create an environment where the next

generation of future Bangladesh can raise their voice, make them heard and exercise their agency.

This is the key to the future trajectory of the adolescents in Bangladesh," said the report, which was published yesterday.

The Madrasa-going adolescents also had a diverse range of dreams.

Many of them want their future to be constructed around their academic knowledge like becoming a Madrasa teacher, mawlana, attaining higher degrees, joining the religious universities aboard, or writing about Islam.

"Simultaneously, some of them are focused on dreams like becoming doctors, and so on," the report said.

COVID RELIEF

NGOs faced pressure from local politicos

TIB study finds; 54pc had difficulty listing beneficiaries

Nearly 54 percent of the non-government organisations involved in relief programmes during the pandemic faced challenges in preparing a list of beneficiaries, found Transparency International Bangladesh.

The NGOs were forced to include beneficiaries who were not eligible for relief due to the influence of local public representatives and politicians, said the study titled "The Role of Non-government Organisations in Response to Covid-19 Pandemic: Challenges and Way

In some cases, the local administration made the NGOs exclude the left-behind people, found the study, which was unveiled yesterday.

As many as 66.2 percent of the NGOs surveyed faced challenges at the field level in undertaking and implementing various Covid-19 response initiatives.

The initiatives include awareness programmes, distribution of health safety kits, relief distribution, emergency cash assistance, food assistance and relief, Covid-19 related healthcare services, and burial and funeral of the dead.

Three killed in Narayanganj 'mob beating'

Police yesterday recovered the bodies of three people in Narayanganj's Araihazar. Suspecting them to be robbers, locals beat

them to death, police said. But the victims' families claimed that they were drivers and owner of a leguna, a locally-

made motorised four-wheeler, and that they were killed in a planned way. The victims are Mofizul Islam, 26, and Jahirul Islam Jesnu, 27, of Bostul Boubazar area of Sonargaon upazila, and Nobi Hossain, 30, of

Madhabdi village in Araihazar upazila. Mofizul and Jahirul were drivers of the leguna and Jesnu was the owner, said family members.

Quoting locals, police said the three youths tried to rob a bus, which was carrying garments workers, in Singhodi area of Araihazar around

But the workers foiled the robbery attempt and caught the three, who were later taken to Ilomdi Bazar area. Locals beat them up, said Anichur Rahman Mollah, officer-in-charge of Araihazar Police Station.

The three died on the spot. Contacted, victim Mofizul's mother said like other days, her son went out of home with the leguna around 4:00am. Leguna's owner Jesnu was with him. "Hours later, I came to know that my son was killed."

TRAIN DERAILMENT 5 killed, 45 hurt in West Bengal Death toll likely to rise

Twelve coaches of the Guwahati-bound Bikaner Express derailed in the Moynaguri region of Indian state of West Bengal yesterday, leaving five passengers dead and many injured.

Jalpaiguri district magistrate Moumita Godara Basu said five bodies have been found till 7:00pm and 45 passengers with injuries rushed to Jalpaiguri district hospital and Moynaguri government hospital.

Many of the injured passengers were in a critical condition and the death toll may increase.

A railways spokesperson said the accident took place at 5:00pm, nearly seven minutes after the express train passed the New Domohani station. "12 coaches jumped off the tracks of which two capsized," Guneet Kaur, chief public relation officer of Northeast Frontier Railway said.

Railway officials, who rushed to the spot from different locations, said it was getting dark by the time the initial team of rescue workers reached the site.
