HC upholds BNP MP Harun's sentence

Questions raised whether he can stay a lawmaker

The trial court rightly found BNP lawmaker Harunur Rashid guilty and sentenced him correctly in the case filed over evading tax while importing a car, said the High Court in the full text of a

It upheld the five years' jail sentence of Harunur, but said the sentence would be considered served.

"... From the discussion made above and on perusal of the evidence, deposition of the prosecution witnesses, and the cross-examination made by the convict appellants [Harunur, MP of Chapainawabganj-3, Enayetur Rahman Bappi, former managing director of NTV, and Ishtiaq Sadek, owner of Sky Autos), I am of the view that the prosecution has successfully proved the charge against the convict appellants.

"The learned special judge has rightly found them guilty under Section 409/109 of the Penal Code and correctly convicted and sentenced them which must be upheld," the bench of Justice Md Salim said in the judgement.

Following the HC verdict and observation, a controversy has aroused whether Harunur can hold the office of a

Five years' imprisonment of Harunur has been upheld by the HC and therefore, he cannot remain a lawmaker under article 66 (2) (d) of the constitution, ACC's lawyer Khurshid Alam Khan told The Daily Star.

"À person shall be disqualified for election as, or for being, a member of parliament who has been, on conviction for a criminal offence involving moral turpitude, sentenced to imprisonment for a term of not less than two years, unless a period of five years has elapsed since his release," according to the article

Meanwhile, Harunur's lawyer AM Mahbub Uddin Khokon told this correspondent that there was no legal bar for his client to remain a lawmaker and to contest elections for the same post in future as he has already served 16 months.

"We will move an appeal before the Appellate Division of the Supreme Court against the High Court verdict and seek his acquittal in the case," he added.

The HC bench said, "Nevertheless, the sentence of the convict appellants Harunur Rashid, Ishtiaq Sadek and Md Enayetur Rahman is treated to have been served out as they have faced prolonged trial in the trial court since 2007 and already served out a substantial part of the sentence.'

On October 21, 2019, a Dhaka court sentenced Harunur to five years' imprisonment, Enayetur to two years' and Ishtian to three years' in the case filed by the ACC for tax evasion.



Covax delivers one billionth vaccine dose

70pc Indians fully vaccinated against Covid-19 as daily infections hit eight-month high

The Covax scheme aimed at equitable global access to Covid-19 vaccines hit a "key milestone" Saturday when it delivered its one billionth dose, one of its key backers said.

The Covax facility was set up in 2020 by the World Health Organization, Gavi the Vaccine Alliance and the Coalition for **Epidemic Preparedness Innovations** to ensure that poorer countries can access the vaccines needed to battle the pandemic.

"Covax has delivered its first billionth dose of Covid-19 vaccines to 144 countries & territories across the world," Gavi chief executive Seth Berkley tweeted.

"It's a key milestone in the largest and most rapid global vaccine rollout

All countries have been permitted to order doses through the mechanism, but lower-income countries have received the jabs free

But while reaching that one-billion milestone is impressive, Covax has fallen far short of its initial objective of delivering two billion doses by the end of 2021.

That is because it has been forced to compete with rich countries willing to pay a high price and

In a speech on Thursday, WHO chief Tedros Adhanom Ghebreyesus pointed out that while more than 9.4 billion vaccine doses had been administered around the world, more than 85 percent of people in Africa have yet to receive a single

over 93 per cent of the adult population have received at least one dose while over 69.8 percent have been fully vaccinated. The drive was rolled out on January 16 last year with healthcare workers getting inoculated in the first phase. Vaccination of frontline workers started from February 2.

HC allows Evaly to withdraw Tk 2.35cr

The High Court yesterday allowed the controversial e-commerce platform Evaly to withdraw Tk 2.35 crore from its accounts with Southeast Bank and City Bank for running the company, including paying remuneration for the board formed by the court.

The company can also sell or rent 22 cars to meet expenses.

The court also asked the Bangladesh Bank and the National Board of Revenue to give details of the wealth of Evaly, including the expenses made by its incarcerated Chief Executive Officer Mohammad Rassel and Chairperson Shamima Nasrin.

At the same time, the HC ordered the inspector general of police to deploy law enforcers at the Evaly office in the capital's Dhanmondi area to ensure the security of its officials and staff members and its creditors who flock to the venue to retrieve their money.

The order was passed by Justice Muhamad Khurshid Alam Sarkar after holding the hearing on an application submitted by lawyer Morshed Ahmed Khan on behalf of the board of directors of Evaly seeking necessary directives, Sayed Mahsib Hossain, the lawyer for an aggrieved customer named Md Farhad Hossain, told The Daily Star.

BOOSTER DOSE AT NICVD Elderly suffer for mismanagement

Hundreds of senior citizens suffered due to the mismanagement in administering Covid-19 booster shots at the National Institute of Cardiovascular Disease Institute and Hospital in Dhaka yesterday.

Visiting the hospital yesterday, this correspondent saw several elderly people standing in a long queue in front of the only booth for booster shots there.

'It is inhumane to make senior citizens stand in line for hours. This is cruelty to those who are physically disabled, and at least 20 percent of the people waiting are [disabled]," said Mohammad Ahsan Ullah, a 68-year-old physician, who came to the NICVD for his booster shot.

In his view, there were three other examples of mismanagement, including no signboard or placard indicating where the booster doses are available; no seating arrangement for the disabled; no separate lines for men and women, etc.

Speaking to The Daily Star, Hosne Ara, a 60-year-old kidney dialysis patient, said, "I am having to brace my hand against the wall for support as I have been standing in line for two

Asked, Dr Shamsul Haque, a line director and member of the covid vaccine deployment committee at the health directorate, told The Daily Star, "The booster dose has been recently introduced while the regular campaign is also going on. So, there will be some issues, but we are trying to resolve them."
