

## HC directives sought to stop use of fireworks

An SC lawyer yesterday filed a petition with the HC seeking its directive on the government to stop use of explosive substances during new year celebrations.

Advocate Mizanur Rahman submitted the petition and requested the government to give compensation to the family of Umair, a six-month old child at Mirpur, who reportedly died after being frightened at the sound of fireworks at night on December 31 last year.

was also diagnosed with pneumonia.

His first namaz-e-janaza will be held at his Supreme Court premises today at 11:30am.

Later, another namaz-janaza will take place at his residence in Mohammadpur in the capital.

He will be buried at his ancestral village Outi under Haluaghat area of Mymensingh.

Chief Justice Hasan Foez Siddique expressed deep shock at the death of the senior jurist.

The chief justice also prayed for the salvation of TH Khan's departed soul.

Besides, the pro-BNP Nationalist Lawyers Forum

and Bangladesh Supreme Court Bar Association in separate messages expressed deep shock at the news of his passing.

TH Khan was the founding president of the nationalist lawyers' forum.

Moreover, he was a former minister, an elected parliamentarian from BNP, and vice-chairman of the political party.

Born on October 21, 1920, in Haluaghat, TH Khan started his career as a lawyer in 1947.

He was appointed as a judge of the erstwhile Pakistan High Court in 1968. Later, he was appointed as a judge of the Bangladesh High Court in 1971.

## PBI given time again to finish probe

A Dhaka court yesterday asked police to submit the probe report by February 2 in a case filed against Bashundhara Group Managing Director Sayem Sobhan Anvir.

Anvir and seven others were accused in the case filed over the rape and murder of a college student in the capital's Gulshan.

Yesterday was the sixth time the PBI failed to submit the probe report, court officials said.

Anvir is the prime accused in the case and Bashundhara Group Chairman Ahmed Akbar Sobhan alias Shah Alam and six others are accused of assisting Anvir.

The other accused are Shah Alam's wife Afroza Begum, Anvir's wife Sabrina Sayem, model Faria Mahbub Piyasha, Saifa Rahman Mim, Ibrahim Ahmed Ripon and his wife Sharmin.

On April 26, police recovered the body of a 21-year-old college student in a Gulshan flat. Her elder sister then filed a case with Gulshan Police Station, accusing Anvir of abetting suicide.

## 'Children first'

## HC observes in full-text verdict

The High Court in the full text of a verdict has observed that children's welfare should be considered first, and law should not be applied in relevant cases without their welfare and wellbeing.

"Thus, in respect to the applicability of the 'Comity of Courts' it is our considered view that the child's welfare and wellbeing should be considered first and the above proposition of law should not be applied in each and every case mechanically without considering the wellbeing and welfare of the minors," said the HC bench of Justice M Enayetur Rahim (now a judge of the Appellate Division) and Justice Md Mostafizur Rahman in the full text of judgements.



The full text was released yesterday as the HC bench delivered the verdict on November 21 last year in a case regarding the custody of children Nakano Jasmine Malika (11) and Nakano Laila Lina (9), who were brought from Japan to Bangladesh in February last year.
