"President and chancellor of Comilla University appointed Dr Moyeen as the VC for four years as per section 10 (l) of the Comilla University Act, 2006," said the notification.

The incumbent VC Prof Emran Kabir Chowdhury's tenure will end on January 31.

the councillor's post of Ward 6, has had 23 cases filed against him. He was relieved from 20 and acquitted from the other three.

However, filing of another case against the incumbent councillor, also the convener of Siddhirganj Thana Jubo League, was recently postponed.

There are two cases against Abdul Karim of Ward-17, also an executive member of AL Mahanagar Committee, while Kamrul Hasan of Ward-18 is accused in three cases of fraudulence.

Meanwhile, Ward-13's BNP-affiliate councillor Maksudul Alam Khandaker Khorshed, brother of Taimur Alam Khandaker - who lost in the mayoral polls against Selina Hayat Ivy - is accused in at least 33. Despite the astonishingly high number of cases against Khorshed, locals said he still has an enduring popularity in the

area, especially due to his humanitarian work during the tougher days of the pandemic.

Khorshed also claimed that all the cases filed against him were politically motivated, as he belongs to the opposition party. He mentioned that he got relieved and acquitted from two cases.

Contacted, Badiul Alam Majumdar, secretary of Shujan (Citizens for Good Governance), said this only exposes the fragility of the Election Commission.

"This goes to show that the Election Commission didn't do its work properly. Data related to these cases are an essential part of the candidates' personal information, and it's the duty of the commission to inform the voters about this," he said.

"In this way, the EC did not uphold people's right to information. They didn't even upload the candidates' basic information on its website," Badiul added.

Contacted last night, Minister Sadhan told The Daily Star that he did not provide any DO letter to any department.

"I was totally unaware about the fraud, and no one complained to me yet," he said.

The committee was asked to submit its report before the House within one month. As per the bill, the authorised capital of Bangladesh Tourism Corporation shall be Tk 1,000 crore from existing Tk 15 crore, while the paid up capital will be Tk 400 crore from Tk 5 lakh.

The existing law states that the corporation's board shall consist of a chairperson and not fewer than two and not more than four full-time directors to be appointed by the government.

With a four-member board of directors fixed by the existing law, Bangladesh Parjatan Corporation

(BPC) now faces difficulty to take prompt decisions in coordination with other ministries and departments concerned.

Since the ministries and departments concerned have no representative in the BPC board, BPC does not get the desired assistance from agencies for developing tourism.

A. Kashem, Mr. Mohammed Shajahan, Mr. Benajir Ahmed and Ms. Rehana Rahman.

Following which, NSU filed a money suit valued at BDT 1,000,00,00,000.00 (Taka One Thousand Crores) being Money Suit No. 92 of 2021 against Mr. Dr. Sufi Sagar Shams and Protection for Legal and Human Rights Foundation claiming damages for its loss of reputation and goodwill. An injunction application was also filed by NSU to restrain Mr. Shams and the Protection for Legal and Human Rights Foundation from the spreading of such untrue, concocted and slanderous allegations against NSU and its members of the Board of Trustees. The matter has reached the Hon'ble High Court Division of the Supreme Court of Bangladesh in Civil Rule No. 718 (F.M.) of 2021, arising out of F. M. A. T. No. 315 of 2021 wherein NSU is the plaintiff-appellant-petitioner and Mr. Shams and Protection for Legal and Human Rights Foundation are the defendants-respondents-opposite party Nos. 1 and 2. In Civil Rule No. 718 (F.M.) of 2021, the Hon'ble High Court Division, on 23.12.2021, was most pleased to pass an Order issuing a Rule calling upon Mr. Shams and Protection for Legal and Human Rights Foundation (i.e. defendants-respondents-opposite party Nos. 1 and 2) :-

"to show cause as to why pending hearing of the appeal, the defendants-respondents-opposite party Nos. 1 and 2 shall not be restrained by an order of injunction from making any further statements regarding the plaintiff-appellant-petitioner, its members of the board of trustees, and its high officials and publishing the same in social media, print media, electronic media, online news portals or any other means of communication in any form and using caricature and/or image of the plaintiff-appellant-petitioner for any purpose whatsoever in any their future publications. The rule is made returnable within 2(two) weeks."
