## ‘This is not normal’

Fish shortage at Hakaluki haor leaves anglers in despair

This is usually that time of the year when anglers of Hakaluki haor smile ear to ear. “This is the time to catch large hauls from the Haor,” said angler Mansur Ali. “With the income from these few months, I have no trouble running my family of seven.”

But those like Mansur aren't smiling this year. Owing to a shortage of water in the haor, fish have almost disappeared.

“I don't have any land, my only source of income is through fishing. If there aren't any fish in the haor, I don't know how I'm going to see out the year,” a despondent Mansur told this correspondent.

“Hakaluki's fishers are facing a livelihood crisis,” said Saidul Hasan Shipon, general secretary of Kulaura Sangbadik Samitee.

“I've seen many anglers toiling all day at the haor, but returning empty-handed. This is unprecedented and not normal.”

According to sources in the fisheries department, the haor is facing this shortage of water due to low rainfall last year and lack of upstream water.

During a recent visit to Islampur Bazar under Kulaura upazila of Moulvibazar, this correspondent saw only a minimum amount of water in the canals, beels and reservoirs of the haor.

Local fishers were seen spending their time playing ludo as their luck had run out.

The same picture could be seen at Fenchuganj area of Sylhet, where many are dependent on the haor for their livelihood.

Contacted, Sultan Mahmud, assistant director of the Hilsa Resource Development and Management Project at the Dhaka Fisheries Department, said, “Hakaluki is a major source of fish stock. But the water here is drying up due to sand and sediment flowing in from connecting rivers.”

As a solution, he proposed, “April is the breeding season for fish. If fishing is banned at the haor during that time, may be the fish can increase the next season.”

He said he has already contacted the fisheries and livestock ministry in this regard, which has taken the matter seriously.

## Where have all the fish gone?

As Brahmaputra's ecosystem loses balance, 7,000 fisher families land in trouble

Prafulla Chandra Das' (48) fishing boat and nets have been drying out in the sun. His entire ancestry has been devoted to the same trade, and as such, Prafulla knows no other craft.

As fish stocks in the Brahmaputra have drastically decreased over the years, Prafulla is finding it hard to run his six-member family and pay off debt with the little money he earns from fishing.

The angler from Jorgachh Majhipara village under Chilmari upazila in Kurigram is one of 7,000 ancestral fishing families from 105 villages in the district which are suffering the same fate. Most of these families do not even have their own homestead, but live on khas land or other people's land.

“Even a few years ago, a group of four-five

anglers could catch 40-50 kg of fish per day. It has now come down to merely five-six kg, which gets us Tk 200-250 every day,” he told this correspondent.

This is not enough for his family, he said, and especially not for the loans he took out at high interest from local moneylenders.

This loan is a common feature of the fisher families' life. “We are unable to provide for our families with the little money we make from fishing. This is why we're forced to take loans from the Mahajons,” said Bisadu Chandra Das (47), a neighbour of Prafulla.

“The situation is especially bad from December to June, as water level falls during this period,” he added.

Meanwhile, 84-year-old Ashu Chandra Das from Daspara village spoke of another woe. “We are deprived of our rights despite the ‘Jal Jar Khal

## 7 DIGs set to become additional IGP

The Ministry of Public Administration has recommended promotion of seven deputy inspector general ranked police officers to the rank of Additional Inspector General of Police (IGP).

They are: Abu Hasan Muhammad Tarik of Police Headquarters, Banaj Kumar Majumder of Police Bureau of Investigation, Dr Hasan ul Haider of Central Police Hospital in Dhaka, Monirul Islam of Special Branch of Police, Shahabuddin Khan of Barishal Metropolitan Police, Mahbubur Rahman of Industrial Police and Barrister Md Harun or Rashid of Mymensingh Range Police.

The recommendation was sent to the home ministry, requesting to issue a circular in this regard.

The letter mentioned that Prime Minister Sheikh Hasina on January 21 approved the recommendation for their promotion.

## ‘Some other reason behind sanctions’ Says info minister on US step against Rab officials

Information Minister Hasan Mahmud at a programme yesterday said there must be some other reasons behind the US-imposed sanctions against Rab officials.

When a country is developing, international forces try to pull it back, and to do that, they use narratives centring human rights and similar subjects, he said.

Hasan Mahmud made these comments while addressing a programme of lawyers at Chattogram District Bar Association Auditorium.

Human rights are being violated in many countries that advocate for it. In the US, thousands of people are forcefully disappeared every year; many are killed, but human rights organisations never give statements against those incidents, he commented. For example, a few days back, the independent human rights expert of UN urged the US to close the jail at Guantanamo Bay due to reports of torturing captives and violating human rights. But no human rights organisation has given a statement about this, he claimed.

Hasan Mahmud said to err is human; no one is above making mistakes, adding that if any Rab member is involved in wrongdoing, they face investigation, trial and punishment.
