NO APPROACH ROADS Bridge lies unused for 2 decades

A bridge on a cropland at Ramakantapur village in Sujanagar upazila has remained unused since its construction over two decades ago due to lack of approach roads on either side of the unplanned bridge.

During the dry season villagers use a narrow earthen road, built beside the bridge later, to go to their destinations.

Locals said once most parts of Ramakantapur village under Dulai union and Ghoradah village under Tatiband union and a few other adjacent villages in Gaznar Beel area remained waterlogged round the year.

As there was no road link, the then upazila engineering office constructed a concrete bridge between Ramakantapur and Ghoradah in 2001, spending Tk 10 lakh, Dulai Union Parishad (UP) Chairman Sirajul Islam Sajahan said.

The bridge, built 20 to 25 foot high from the ground, brings nothing for the villagers, but left signs of unplanned work, he said.

"I was a young man back then when the bridge was built and it still of no use for the villagers," Aftab Pramanik of Ramakantapur said.

"We use small boats during the monsoon, but in the dry season we have to walk on foot over the marshy fields for years," Alam Sarkar of the village said.

Mannan Sarkar, a resident of Ghoradah village, said the unplanned bridge is nothing but complete waste of the government fund.

Contacted, Sujanagar LGED Upazila Engineer Rakib Hosain said he has no update information in this regard as the bridge was built years ago.

A tale of torture. deprivation

Birangana Shila Guha's quest for the status ever elusive

"I can't pay the rent of the house in which my daughter and I live. The landlord called us and insulted us for nonpayment. Now, I don't see any alternative to committing suicide," Birangana Shila Guha said.

The 70-year-old war heroine now has to beg for survival.

"All these years, I have been waiting for the recognition of my sacrifice but nothing has happened so far. The prime minister assured me that I would be recognised as Birangana by December 16 last year but it has not happened till today," she said.

She is now living with her daughter and grandson in a rented house on Jalalia Road in Moulvibazar's Sreemangal upazila.

Talking with this correspondent, she recently recounted the harrowing experience she went through during the Liberation War.

Shila said she was 15-16 years old in 1971. At that time she was the heroine of the theatre troupe 'Moon Light Opera'. The troupe went to Kurigram where they had been staying at Ulipur High School next to the stage. They were supposed to perform at the night when the Liberation War broke

According to locals, razakar Shahab Uddin of Ulipur along with his cohorts was supplying women to the Pakistani soldiers

Shila said one evening, the razakars came to Ulipur Girls' School by a jeep with the Pak troops.

were out then. "At gunpoint, they picked me, Sabita and Minu to an army camp at a local bungalow. There I was tortured along with

a few others," she said. She was raped by several army members, she added. Day after day, Shila and other young

women were raped by the Pakistani troops. "Due to excessive torture, I would lose consciousness. The troops used to sear my skin with burning cigarettes. One day they threw me in a nearby paddy field thinking

that I was dead," Shila said.

Next morning, local Abul Hossain and his brother Sattar found that I was breathing. They then left me in a house for treatment. But as the news spread, the army asked them to again send me to the camp. But Hossain and Sattar refused to send me there. They sent me to the house of a man named Madhu. After that I went to India with Madhu's family," she recollected.

They had two daughters. But after a few years, her husband came to know about the torture. After that, her husband left her.

Later. Shila came to Sreemangal and took shelter, with the help of a relative.

Shila said after returning from India, she has worked with many troupes. She married her two daughters off with great difficulty but the younger one returned to her after being divorced.

Shila's daughter Roma said, "My mother

Shila said after the independence of Bangladesh, she returned to her home in Kachur Hathkhola of Piyazhati in Bagerhat.

"My father Bihari Lal Saha already got the news from the locals that his daughter had been tortured by the Pak troops. Thinking of other sons and daughters, my father did not give me a place in the house,"

She said with tears rolling down her cheeks, "My father who failed to save me from the criminals was the one to judge me as impure. I again joined another theatre troupe called Banasree Opera."

Shila said a few years later, she married Jatin Guha, the driver of the troupe.

After hearing about the hardships of my mother's life, the PM assured us that due respect would be given to my mother but it has not happened till today. Now she

she is begging now. "A few days ago, she came in my office; I gave her taka two thousand," he added.
