DHAKA AIR POLLUTION Tejgaon industrial area tops the list

The air quality of 10 significant areas in the capital scored below standard throughout 2021, according to a study of the Centre for Atmospheric Pollution Studies of the Department of Environmental Science at Stamford University.

Tejgaon industrial zone topped the list of the 10 polluted zones with 70 microgrammes (mgs) of particulate matter (PM 2.5) per cubic metre whereas the

acceptable level of PM 2.5 is 15mgs per cubic metre. The study was conducted in the areas that have financial hubs, industrial zones, diplomatic and

According to the study, Shahbagh scored second on the list with 68mgs PM 2.5 per cubic metre.

Money launderers untouched

Authorities fail to submit details of offenders to High Court

The move to bring money launderers to book is not making any headway as the Anti-Corruption Commission and different government agencies have failed to submit information on the offenders, their deposits in overseas banks, and properties abroad before the High Court despite its orders to do so.

A High Court bench has been holding hearings on a suo motu rule and a writ petition in this regard for over a year but it could not pass any order for prosecuting money launderers who allegedly deposited huge sums of money in foreign banks

or purchased properties abroad. ACC lawyer Khurshid Alam Khan said the commission has limitations in tracing those who have bought properties abroad with laundered money.

He alleged that the commission sought information from the foreign and home ministries and the Bangladesh Financial Intelligence Unit (BFIU) about the launderers, but they did not give it to them.

Names of Bangladeshi nationals and two corporations came up in Panama Papers in 2016 and in Paradise Papers the following year.

The issue of Bangladeshi money launderers came to the fore on November 18, 2020 when Foreign Minister AK Abdul Momen at an event revealed that government officials were buying luxurious homes in "Begum Para" in Toronto.

Three days after Momen's comment, the HC issued a

suo motu (voluntary) rule and directed intelligence agencies to take appropriate measures to stop money laundering.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Ahmed Sohel also ordered the ACC and government authorities concerned to submit details, including names and addresses of money launderers, to the court by December 17,

The same HC bench also heard a writ petition filed in February last year, seeking actions against Bangladeshis and companies whose names reportedly came up in the papers.

Sust hunger strike ends

Students vow to continue demo for VC removal; 5 alumni get bail

After 163 hours, 28 students of Shahjalal University of Science and Technology ended their hunger strike yesterday at the request of former Sust professors Muhammed Zafar İqbal and Yasmeen Haque.

The demonstrations demanding the resignation of Vice-Chancellor Prof Farid Uddin Ahmed will continue, says a spokesperson for the demonstrators. A new demonstration plan would be chalked out after discussions among the students.

Prof Zafar and his wife Prof Yasmeen reached Sust around 4:00am yesterday and talked to the students on

With their one-point demand, 23 students had been on hunger strike since 2:50pm on January 19. Five others joined them on Sunday and Monday. The professors requested them to end their strike

reasoning that their lives were precious. The students told the couple that they would end their strike together. The 20 students, who had to be

hospitalised, were brought back to the campus and all of them ended their strike by drinking water around

Prof Zafar, a renowned writer, and Prof Yasmeen themselves gave water to the students.

Afterwards, Prof Zafar said every young adult was with "We have been assured by the upper level of the

government that your demands will be met. Both the We would have come even if we had not been sure

of it, but then we could not have told you to end your Commending the students, Prof Zafar said, "Rest

assured that the system of the universities and vicechancellors in the country will be fixed because of what you have done here."

The protesters have forced 34 VCs of the country to spend sleepless nights, he said. On VC Prof Farid, he said, "I do not want to call this

person, who is so determined to stay in his post even after seeing all this, a human being. He is a monster."

"Your lives are very precious. There's no point in risking your lives for that man," Prof Zafar said.

He said it was a matter of great sorrow that when the students were attacked by the police, no teacher came forward to tell the police that the students could not be

"The process of stopping the movement is inhumane,

cruel, and monstrous," he said.
Prof Yasmeen said, "After we got the assurance [from the government high-ups], we talked to the students over phone around 8:30pm [Tuesday]. They requested us to come fast as the physical conditions of the students were deteriorating by the hour. We, at that moment, rushed to Sust. We are grateful to the students that they trust us."

The students on hunger strike were taken to hospital for further treatment, said the spokesperson for the

The spokesperson said, "Our honourable Zafar sir and Yasmeen madam assured us that high officials told them that our demand will be met. As we honour and trust them, we decided to end the hunger strike. But the movement will continue."

EC FORMATION Make the names public

Speakers at webinar say people should know the search committee picks

Names to be recommended by the search committee for appointments of the chief election commissioner and other commissioners should be made public for ensuring transparency in the process, eminent citizens told a webinar yesterday.

They also said a parliamentary standing committee should be engaged in the process before the president finally appoints the commissioners.

Shusashoner Jonno Nagorik (Shujan) organised the webinar on the "Appointment of the Chief Election Commissioner and Election Commissioners Bill-2022" placed in parliament on Sunday.

The government move came nearly 50 years after the constitution prescribed enacting a specific law for forming the Election Commission.

Sources said the Awami League-led government wants to pass the bill as quickly as possible so that the upcoming Election Commission can be constituted through a search committee in line with the act. The tenure of the current EC, led by CEC KM Nurul Huda, expires next month.

Unique ties of close friendship

Sheikh Hasina sends 'warmest wishes' to Modi on India's Republic Day

Prime Minister Sheikh Hasina yesterday extended the "warmest wishes" to her Indian counterpart Narendra Modi and the people of India on the occasion of the country's Republic Day.

In a letter to Modi, the PM wrote, "We look forward to working with India in the next fifty years and beyond, towards realising the shared vision of building a peaceful and prosperous region.

"The unique ties of close friendship, cooperation and trust between our two countries have flourished and grown from strength to strength in recent years ... many new frontiers of cooperation alongside all traditional areas have been identified, particularly during the Covid-19 pandemic," Hasina wrote in the

She said the year 2021 "was a historic one for the Bangladesh-India relationship, marked by celebrations of epochal events and engagements at the highest levels".

Hasina said she "thankfully" recalled Modi's visit to Dhaka in March last year to join celebrations of the golden jubilee of Bangladesh's independence, the birth centenary of Father of the Nation Bangabandhu Sheikh Mujibur Rahman and 50 years of establishment of diplomatic ties between Bangladesh and India.

"Your gracious presence on these occasions had added extra enthusiasm to the celebrations and allowed us to further consolidate our excellent bilateral relations, which so happily exist between our two countries," she wrote.

The Bangladeshi PM said she recalled with gratitude the support rendered by the government and the people of India during Bangladesh's Liberation War in 1971 and said this set the foundation of "our unique relationship".

The joint celebration of "Moitri Dibosh" held across the globe on December 6, the day when India recognised Bangladesh as a sovereign and independent country in 1971, "projected this special relationshi wrote Hasina.

Set up dedicated cybercrime unit

Senior officials discuss a host of demands with IGP on 4th day of Police Week

Police high-ups yesterday started discussing with their chief a list of over 100 demands, including a replacement of long-barrel firearms with short arms for on-duty policemen, and the establishment of an independent cyber unit and a cyber and IT training academy to cope with rising cybercrimes.

Around two dozen demands were placed before the Inspector General of Police Benazir Ahmed during a day-long meeting attended by mid and high-ranking police officials on the fourth day of the ongoing police week at Rajarbagh Police Lines.

They asked for a dedicated cyber crime unit to deal solely with cyber crimes and criminals.

Under the unit, there can be wings, they suggested, in all districts to effectively deal with such cases. The proposal comes as cyber crime is growing along with the use of social media, particulary during the pandemic.

The Police Headquarters earlier asked all units to bring forth their

innovative ideas and demands to make the police a skilled, people oriented, modern and professional force. Out of the total ideas and demands, the PHQ compiled 107.

Police authorities will also raise some major demands during their meetings with the home minister, scheduled for today -- the final day of

Meeting sources said Assistant Inspector General and Deputy Inspector General of concerned units at the PHQ yesterday raised around 25 demands with the IGP. Those include the formation of an independent medical service for police, a separate prosecution service to deal with cases properly and expanding the scope for people to file general diaries online.

Other major demands, which could not be heard yesterday, include a separate police division at the home ministry, providing SP and upward officers a car loan of Tk 30 lakh and Tk 50,000 for monthly maintenance, and the formation of a cell to coordinate with the ministry or the Secretariat about implementation of

promises made by the prime minister and home minister, said a number of officials who attended the meeting.

Besides, acquiring a 100-acre land on the Padma char for Bangladesh Police Academy, and providing training allowance for policemen are also on the list of demands.

After yesterday's meeting, Haider Ali Khan, deputy inspector general (Media and Operation) at the PHQ, briefed journalists on the demands. 37 FAILED DOPE TEST

Replying to a query, Haider said the authorities have so far terminated 37 policemen after they failed the dope

He added the test has been made mandatory for the recruitment in police.

Asked whether the police authorities will take any action against policemen who have been accused of attacking and harassing students of Shahjalal University of Science and Technology (Sust) during their ongoing agitation, he said inquiry is going on about the allegations and if the allegations are found true, action will be taken.

2 arrested over rape

A schoolgirl was raped allegedly by two men in Lalmonirhat's Kaliganj upazila on Tuesday.

The victim, student of grade-VII, was picked up around 8:30pm on Monday and raped overnight in an abandoned room.

Her family members filed a case with Kaliganj Police Station on Tuesday afternoon.

Police arrested -- Ripon Mia, 27, and Monir Uddin, 19 — on the same day, said Golam Rasul, officer-in-charge of the police station.

The criminals abandoned the girl on the bank of the local Sati river around 6:00am on Tuesday and fled the scene.

Prisoner dies in Dinajpur jail

A prisoner, convicted in multiple cheque forgery cases, died in Dinajpur jail on Tuesday night. The dead is Shafiqul Islam, 35, of Chokpara village in the district's Birganj upazila.

Mokammel Hossain, the jail super of Dinajpur, said that prisoner Shafiqul had been suffering from chronic heart and kidney problems for a

He had been in jail since July 23 last year after a Dinajpur court sentenced him to 18 months prison in two separate cheque forgery cases.

He was getting treatment at the jail. The body was handed over to the family members after autopsy, the jail super added.

Moheshkhali mayor sent to jail

The municipal mayor of Moheshkhali in Cox's Bazar was sent to jail yesterday in an attempted murder case of freedom fighter Amzad Hossain.

Senior judicial magistrate Alamgir Mohammad Faruque ordered to send Mayor Maksud Mia to jail rejecting his bail prayer, said Mohammad Mostafa, lawyer of the plaintiff.

Freedom fighter Amzad was stabbed on November 24. He was admitted to a local hospital for two days after the attack.

Later, he filed a case against the mayor and 25 others.

The mayor is also the convenor of the upazila Awami League.

Earlier, mayor Maksud got advance bail for six week from high court on December 15 last year.

Prime Minister Sheikh Hasina yesterday told parliament that Bangladesh is marching towards progress at an overwhelming pace, dispelling pessimists' takes on the country's future.

In reply to lawmakers' queries, the PM said her government is determined to build a safe and integrated communication network in the country.

"The government is committed to easing traffic congestion, ensuring comfortable public transport, increasing discipline and security on roads... and developing an integrated multimedia communication network by being consistent with the existing system and changing situations of future development," she said in reply to Awami League MP Didarul

In reply to MP Momtaz Begum, Hasina "Bangladesh is marching towards development and progress, disproving all conceptions of pessimists about the future of independent Bangladesh.'

In a scripted answer, she said, "In the year of the golden jubilee of Bangladesh's independence and Bangabandhu's birth centenary celebration, UNDP recommended Bangladesh's graduation to a developing country in 2026. It's a matter of pride for us." Hasina said to dispel misconceptions about

Building it right!

Satkhira's rainwater-harvesting hospital wins UK award for World's Best New Building

Bangladeshi architect Kashef Chowdhury, director of Bangladeshi architecture firm Urbana, has been announced the winner of the 2021 International Prize for the World's Best New Building by the Royal Institute of British Architects (RIBA) for his Friendship Hospital

A model of climate-conscious design built with the bare minimum of resources, the Friendship Hospital David Chipperfield, and a cycle

Denmark by Wilkinson Evre. The RIBA award-winning hospital is located in

Bangladesh's Satkhira.

Chowdhury has designed the building to be a machine for rainwater harvesting, with every roof and courtyard surface draining into the central canal, which runs into two storage tanks at either end of the site, according to a report published in The Guardian on January 25.

It is the first "land hospital" for the NGO Friendship, for which Chowdhury has helped to convert several boats into floating hospitals in the past, designed to serve remote communities in the delta region. Built with a tight budget of just under \$2 million, their first permanent building provides a medical lifeline for thousands of people in an area that was heavily affected by a major cyclone in 2007.

Chowdhury told The Guardian: "I am encouraged that this may inspire more of us to commit to an architecture of care both for humanity and for nature, to rise collectively to the urgencies that we face today on a planetary scale."

A rising health risk

67pc of all deaths in country due to non-communicable diseases, says health minister

Non-communicable diseases (NCD) are a growing health risk and matter of concern for Bangladesh, Health Minister Zahid Maleque said yesterday.

Such diseases, which include heart disease, stroke, cancer, diabetes and chronic lung disease, are collectively responsible for almost 70 percent of all deaths worldwide, according to the World Health Organization.

"Some 67 percent of all deaths in the country are due to non-communicable diseases," Maleque said, referring to different statistics, while addressing the first National NCD Conference 2022 virtually.

Besides, around 20 percent of the population suffer from hypertension, 10 percent from diabetes, and as much as 20 lakh people suffer from cancer each year in the country, the minister said, adding that around 50,000 new patients join the list annually.

Directorate General of Health Services, Bangladesh Health Reporters Forum, Clinical Research Platform and several other organisations arranged the conference.

Researchers and physicians from around 30 organisations in home and abroad participated in the event.

The conference will conclude tomorrow.

Malegue said, "NCDs are increasing due to the change in lifestyle and diet, obesity, tobacco consumption, environmental pollution, and misuse of medicines. To control NCDs, awareness among people, alongside early detection and treatment facilities everywhere, must be increased."

Joining virtually, WHO Director General Tedros Adhanom Ghebreyesus said, "Attaining the SDG has become challenging due to non communicable diseases. NCDs are increasing due to the use of tobacco and unhealthy lifestyle. The WHO will help Bangladesh

communicable diseases. Dr Aliya Naheed, scientific officer at icddr,b and secretary of the conference organising committee, said, "As much as half of the rural population do not know they have hypertension. They start medication as per the

advice of local medicine sellers but do not go to doctors.'

She said there is a lack of knowledge among both literate and illiterate people about these diseases. "Everyone has to go for

screening at least once a year after the age of 30," she added. Unicef, UNFP, Orbis International, Trauma Center and different local and international organisations have sponsored the conference.

Tomorrow, on the concluding day, six physicians will be given posthumous awards and six will be given special awards.

ABRAR MURDER CASE HC accepts 17 jail appeals for hearing

The High Court yesterday accepted the jail appeals of 17 death-row convicts in Buet student Abrar Fahad murder case for hearing.

The HC bench of Justice Md Rezaul Haque and Justice Razik-Al-Jalil passed the order after deputy attorney general KM Masud Rumy placed the appeals before the judges.

A Dhaka court on December 8, 2021, sentenced 20 Buet students to death for their direct involvement in Abrar's murder inside a dorm room -- an incident that shook the entire nation two years ago.

The court also sentenced five other Buet students to life imprisonment in the case.

The documents of the case reached the HC on January 6 as death reference to examine the lower court's verdict.







Mayor does a first-hand inspection

Earlier, Atiqul also said they will not serve any notice to owners of illegal structures

before demolishing them. The width and length which are required for the canal have not been ensured as grabbers filled up the canal and constructed structures on it," he said.

It removed the two-year term from the bill, saying in the report that a person convicted in a criminal offence of moral turpitude for any term shall not be eligible to be appointed as CEC or election commissioner.

The same section of the bill said a person should have at least 20 years' working experience in any important government, judicial, semi-government or private post.

parliamentary The standing committee recommended to amend this to add "autonomous and other professions" to the posts already mentioned in the bill.

If the law is passed with this amendment, people from various professional bodies -- autonomous and other professions -- will be eligible for the posts.

Law Minister Anisul Hug placed the bill in parliament on January 23 seeking to give a legal shield to the current and previous Commissions Election formed through search committees.

The bill was later sent to the parliamentary standing committee on the law ministry for scrutiny.

Once passed, the law

will provide legal cover to all activities of the search committees.

The tenure of the incumbent commission, led by CEC KM Nurul Huda, expires on February 14.

Ahead of the general elections in 2014 and 2018, the president picked CECs and other commissioners in 2012 and 2017 following recommendations search committees.

The government move came nearly 50 years after the constitution prescribed enacting a specific law for forming the EC.

The bill says the previous search committees, their functions and the appointments of the CECs and other commissioners made following their recommendations will be deemed valid, and no question can be raised in any court over the matter.

It will be considered the incumbent and previous ECs were constituted as per the law.

In the bill, the previous two search committees have been given legal validity.

Although the constitution suggests that the CEC and other election commissioners be appointed under a law, that law was not formulated in the past.

'Tis the season to eat molasses

AZIBOR RAHMAN, Jhenidah

It's a relatively small window. For four months a year, from mid-November to March, farmers who sell molasses from date juice hit their peak.

Hundreds of farmers in Jhenidah are no different. Every winter, buckets upon buckets of molasses are made in its six upazilas, which are then sent to Dhaka, Chattogram, Sylhet, basically all over the country.

According to the Department of Agricultural Extension (DAE), Jhenidah, around a 1,000 tonnes of molasses are produced in the district, each kilogramme of which sells for up to Tk 200-250.

After talking to locals, namely Abdur Rahman of Kaliganj upazila and Sujit Kumar of Shailakupa upazila, it was found that each date tree fetches around Tk 10,000. The farmers meet their domestic demand with this and can earn extra money by selling the rest. The "gur" is made mostly by female farmers, who also use it to cook pitha, payesh and other sweets.

However, over this popular and profitable sector looms the shadow of timber traders and brick kiln owners, who are trying to lure them into selling the date trees. According to the DAE, the district is home to 4,32,0000 date trees.

Farmland remains waterlogged for years

Once Nurul Haque used to cultivate different types of crops in his land all around the year.

However, in recent years, the 65-year-old farmer at Dhamrai's Srirampur has been unable to cultivate one single crop in his fields. The reason lies in waterlogging, and such is the plight of hundreds of farmers from 10 adjacent areas.

Farmers who own lands in Kullibeel, a large farmland of about 700 acres, had to leave their land without any farming for years because of this very

Nurul stated other reasons behind not being able to farm the lands. Some farmers have sold their land's topsoil to brickfield owners, and only one drainage canal is filled with silt, making the whole place unsuitable for farming.

Rejaul Karim, chairman of Sutipara Union Parishad, told this correspondent that in 2019, a drain was cut along the canal, which was later filled with silt again. This claim has been confirmed by Dhamrai Upazila Agriculture Officer Md Ariful Hasan.

"I informed the matter to the UNO and other officers concerned. They have recently visited the area and assured the farmers that they will take an initiative to solve the problem," said the UP chairman.

Dhamrai UNO Hossain Mohammad Hai Jocki said, "We have recently visited the area. There was also a bridge over the canal, which got damaged last year and due to that blockage, the drainage system became dysfunctional." The UNO said it is possible to solve the crisis by re-excavating the canal. "We are working on the issue."

'Stop plastic use, save Kuakata'

Therefore, to protect the natural beauty and environment of the tourist area, the memorandum called for taking steps against use of disposable plastics.

Illegal sand lifters choking Brahmaputra

A gang of sand lifters has been choking the flow of the Brahmaputra in Roumari upazila of Kurigram district by creating a road across the river in Kartimari Boat Ghat area.

They have been filling the river to construct the road to facilitate their business, locals

Once the road is complete, it will obstruct the natural flow of the Brahmaputra river, they

The gang has been extracting sands illegally for several years from the middle of the river. Now, they have started constructing a 200-metre-long road that will connect the river bank and the mid-point of the

The road will cost around Tk three lakh and the sand

lifters will collectively bear the expenditure, said the locals and the sand traders.

"They are constructing the road spending their own money to facilitate the transportation of sand," said a resident in the area seeking anonymity.

"If the road is constructed, the river's natural flow will be obstructed. Even, boatmen would face difficulties to navigate their boats," said Abdullah Al Mamun, the lessee of Kartimari Boat Terminal.

"They (illegal sand lifters) are influential. That is why none dare to protest it," he said.

However, Zahidul Islam, president of Jadurchar Union Tractor Owners' Association and also a sand trader, claimed that they were constructing the road to help farmers transport their

Meanwhile, local people said they were passing days in fear of river erosion due to the unbridled extraction of sand from the riverbed.

Many families have already become homeless due to river erosion. Hundred hectares of arable land and a number of mosques have been devoured by the river, said farmer Mojibar Rahman in the area.

Even, Chaktabari-Dhanarchar-Rajibpur dyke collapsed due to river erosion," said the 65-year-old grower.

However, sand trader Zahidul Islam denied the claim and said, "Sand is being lifted from the middle of the river that is far away from the shore; it does not cause river erosion."

The Congress, meanwhile, stands divided over the Padma Bhushan to senior leader Ghulam Nabi Azad. While leaders like Anand Sharma, Kapil Sibal and Shashi Tharoor have congratulated Azad over the government recognition, senior leader Jairam Ramesh has commended Buddhadeb Bhattacharjee's refusal of the award.

"Right thing to do. He wants to be Azad not Ghulam," his tweet read.

'It's destructive'

Moscow warns against sanctions on Putin; France, Germany join Russia-Ukraine talks

Russia yesterday hit back at US threats of direct sanctions against President Vladimir Putin, saying moves against the Russian leader would be ineffective and hurt efforts to lower tensions over Ukraine.

Officials from France, Germany, Russia and Ukraine meanwhile started talks in Paris yesterday in the latest bid to ease a crisis sparked by fears that Moscow is preparing an invasion of its pro-Western neighbour.

The West has warned Russia of severe consequences if it does invade, and on Tuesday, Washington said there could be sanctions personally targeting Putin.

Reacting to the news, Kremlin spokesman Dmitry Peskov dismissed the threats as worthless because senior Russian officials are barred from holding assets abroad.

But such a move, he said, would do serious damage to diplomatic

efforts to ease ratcheting tensions

"Politically, it's not painful, it's destructive," Peskov told reporters.

The Kremlin has previously said any US sanctions personally targeting Putin would be akin to crossing a red line, warning the move could result in a rupture of bilateral ties.

US President Joe Biden said Tuesday that any Russian military attack on Ukraine could even "change the world".

Russia is expecting this week to receive written US responses to sweeping security demands Moscow made last year that seek to dramatically limit Nato's reach and capabilities in Eastern Europe and the ex-USSR.

Russia FM Sergei Lavrov yesterday warned in an address to lawmakers that Moscow would take "all necessary measures" if it didn't receive constructive responses and if the West continued its "aggressive policy".

KEY REPORT ON 'PARTYGATE' British PM faces moment of truth

British Prime Minister Boris Johnson braced Wednesday for a potentially damning report into lockdown-breaching parties, after the launch of a police inquiry dramatically upped the stakes.

The report from an investigation by senior civil servant Sue Gray is complete, but has not yet been submitted to Downing Street, the government said.

The explosive confirmation that London's Metropolitan Police force has now started its own investigation could complicate the release of Gray's report, but opposition parties insisted on its publication in full.

Otherwise, according to senior Labour MP Chris Bryant on BBC radio, the public will "simply say this is a cover up".

It was unclear whether Downing Street would release the report later yesterday or some other time, with Johnson facing another grilling in parliament at the weekly joust of Prime Minister's Questions from noon. He again yesterday refused to resign as opposition MPs heaped pressure on him.

At least seven backbench Conservative MPs have called publicly for Johnson's resignation. A total of 54 letters are required to trigger a party vote of no confidence.

AFGHAN HUMANITARIAN CRISIS

West links aid to human rights

Western diplomats Tuesday linked humanitarian aid to Afghanistan to an improvement in human rights after meeting a Taliban delegation on a landmark visit to Europe. On the final day of the Taliban's first official trip to Europe since returning to power in August, the fundamentalists held talks behind closed doors with several Western diplomats. The Taliban are seeking international recognition and financial aid. No country has yet recognised the fundamentalist regime. The Taliban delegation, led by Foreign Minister Amir Khan Muttaqi, met senior French foreign ministry official Bertrand Lotholary, Britain's special envoy Nigel Casey, and members of the Norwegian foreign ministry. Western diplomats laid out what they expected from the Taliban during the talks. Apart from seeking guarantees of education for both boys and girls, Norway also called on the Taliban to respect human rights, in particular those of women and minorities.

KSA, Thailand restore diplomatic ties

Saudi Arabia and Thailand have announced the resumption of diplomatic ties, after more than three decades of frozen relations linked to the theft of jewels from a Saudi palace. Thai-born janitor Kriangkrai Techamong stole \$20 million worth of precious gems in 1989 from the home of a Saudi prince, triggering a spate of murders in Bangkok and a feud between the countries dubbed the "Blue Diamond Affair". The two countries announced in a joint statement late on Tuesday "the full re-establishment of diplomatic relations" during a visit by Thailand's Prime Minister Prayut Chan-O-Cha to Riyadh. The two countries agreed to appoint ambassadors in the near future.

39 missing after boat capsizes in Florida

The US Coast Guard has launched a search for 39 people reported missing when a boat capsized off the coast of Florida in a "suspected human smuggling venture." A survivor said the boat left Bimini in the Bahamas on Saturday night, and had encountered rough weather before it capsized. Human smugglers use the Bahamas as a jumpingoff point for transporting people, many from other Caribbean countries to the United States



Are we becoming incorrigibly corrupt?

Latest CPI score paints a sorry picture of Bangladesh's progress

HE latest edition of the Corruption Perceptions Index (CPI) by Transparency International (TI) is now out. And just as predictable as this publication is at this time of the year, it pains us to see that Bangladesh's performance in this annual undertaking by the global corruption watchdog has become equally predictable. In the 2021 edition, the country has once again scored 26 out of 100—the same as in 2020, 2019 and 2018. Once again, we have ranked second-worst in South Asia, above only Afghanistan, and third-lowest among 31 countries in the Asia Pacific region. In fact, a 10-year CPI trend analysis shows that Bangladesh has stagnated in the neighbourhood of the same score over the last decade, meaning there's been no real progress during the two latest tenures of this government.

Since the CPI measures "perceived" levels of publicsector corruption, we may soon see a firm rebuttal from the government, disputing this badge of shame. True, there are questions about the methods used for measuring corruption. But one doesn't need TI to reaffirm what we already know to be true: that corruption has permeated every aspect of our lives, ranging from bribery, use of public office for private gain, diversion of public funds, and nepotism in public sector appointments to red tape and ineffective mechanisms for corruption control—to name a few areas of measurement cited by TI. We have seen repeatedly how a section of officials and politically influential people, including public representatives, indulged in various forms of corruption using their connections and poor institutional safeguards, and how they have been let go. In fact, the all-encompassing nature of corruption means that spillover effects of public sector corruption have ruined any chance of progress in the private sector too.

As a consequence, corruption has become a way of life. We can't get rid of it, but since the system has become so crooked, we can't live without it either. A key factor in the non-delivery of the pledges of "zero-tolerance" for corruption, according to the chief of the Bangladeshi chapter of TI, is the intrinsic linkage among politics, money and corruption, causing a disconnect of public decisions and actions from the common people's interests. "Without a paradigm shift in our political culture to put public interest first, replacing the practice of treating political affiliation as a licence for abuse of power, corruption cannot be controlled," he says. We cannot agree more.

To see a change in this scenario, we need drastic reforms, starting with building a political consensus on the need for insulating public institutions from the influence of politics, money and criminality. The Anti-Corruption Commission (ACC) must be empowered to do its job. There should also be legal provisions to manage conflict of interest transparently, depoliticising institutions of accountability, and establishing professional integrity and impartiality of all vital institutions, including public service, administration and law enforcement agencies. We can't continue to repeat the mistakes of the past or allow the corrupt elements to eat away at the hard-earned achievements of our nation.

A war heroine can't beg for survival

Take urgent steps to address her woes

T is disheartening to know that a brave woman who had endured torture during Bangladesh's War of Independence is now facing eviction from her house for failing to pay her rent. According to a report in this daily, Birangana Shila Guha said she had been abused by her landlord for money and, not finding any help or way out, was contemplating suicide. The 70-year-old now has to beg for survival in the streets of Sreemangal.

It is disturbing enough that her supreme sacrifice in 1971 has not been officially recognised yet. She has not been listed as a Birangana even though 50 years have gone by since those days of horror. The declaration was supposed to come by December 16 last year, but it has not happened till date. That she is going through such trouble and harassment at this stage of her life also speaks volumes about the negligence of the state about our poor elderly individuals.

Shila Guha's story of misfortune is as horrendous as that of other girls and women who had been taken to the Pakistan Army camps. She survived that experience by a stroke of luck. Her second round of tryst with fate began when her father refused to take her in after the war ended, as she had been picked up by the Pakistanis. Her life since then has been one of despair, denial and betrayal. Even her husband, when he came to know about her war-time ordeal, left her. She has been fending for herself and her daughter since then.

Shila Guha saw a ray of hope when the prime minister, in a video conference on June 20 last year, reportedly assured her that she would be accorded due respect, and her days of misery would end soon. In this regard, Sreemangal Upazila Nirbahi Officer Nazrul Islam told *The Daily Star* that her documents had been sent to the authorities concerned, but he had yet to receive any reply. We hope the government will soon intervene in this regard, and Shila Guha will finally find peace and recognition. Meanwhile, she needs succour on an urgent basis in the form of cash and kind. It's a shame for the nation when a war hero has to beg for survival.

the effectiveness of closing down the educational institutions to lower the risk of infections among children, the education minister said, "Effectiveness depends on everyone maintaining the hygiene rules." If that is the case, the parents who are taking these children to these fairs are not following hygiene rules.

And not just these fairs, the children are being taken out to attend weddings—this being the "wedding season"—and parties, shopping malls and hangouts. When this is happening, how the two-week school closure alone would help prevent the spread of the virus among the students, one might be pardoned for asking

In addition to this, the decision to allow the fairs to continue and the shopping malls to run like business as usual, while restricting the number of people who could attend events, also does not make much sense. So many people visit these fairs every day, and so many people visit shopping malls every day, so why this curb on events only? If the government's objective is to prevent public gathering, then they must come up with a holistic strategy to discourage people from congregating in one place. This should include fairs, shopping malls, airportsespecially the one in Dhaka, which is turning into a breeding ground for the

enforcing social distancing in public. Under the pressure from various actors in the transport sector, the authorities allowed public transports to operate in full capacity, meaning people are now being forced to commute in cramped public buses and water vessels.

If containing the infections through enforcement of social distancing and adherence to basic Covid hygiene is the objective, then the government needs to adopt a strategic way forward that will facilitate achieving this, not the contrary.

Also the authorities must realise that piece-meal measures and knee-jerk reactions such as closing down in-person classes, while still leaving the children vulnerable to exposure at public gatherings, would not help in keeping them safe. Nor would it help if their parents keep commuting in cramped public transports, potentially exposed to the virus. The same goes for restricting the number of people at events only.

The government must take a hard look at the measures taken so far, and its strategic plan to battle the new wave—if it has one in the first place—and take a rational and comprehensive approach that would yield effective results. Half-hearted, hasty measures will only increase public sufferings, which will not be a palatable outcome for any party involved.

PHOTO: SHEIKH NASIR he had written "20 articles and/or books published in national and international journals." What is most interesting in his profile, however, is that the number of professional associations he is involved in is half of the number of recreational clubs he belonged to.

Some months ago, the education minister observed that most of our teachers were "teachers by accident." Now I realise what she may have meant. The VC of SUST may be a good example for this phenomenon. Such an "accident" is detrimental to Bangladesh's aspirations of being an upper-middle-income country and having a knowledge-based society.

So, why should we let the like-minded VCs leave? In an undergraduate research interview, the Dean of the Faculty of Law at DU shared an interesting story. Once, a group of student leaders went

to him with the recommendation to hire the then-second-best student as a lecturer at his faculty. He explained to the student leaders why universities need the brightest students as its faculty members. Even if the student in question did not perform well, the judiciary could still place him in various non-critical positions. However, the university did not have that luxury. A second-class teacher may continue teaching in a third-class manner, which would be a disservice to students for years to come. This seems to me a good reason for why we should welcome the wishes of VC Farid's comrades and arrange a grand farewell for all 35 of them.

One may argue that the VC's job is administrative and is therefore "noncritical", with no chance of denting the quality of education in classrooms. The controversial individual in question, however, has failed to prove his ability to safeguard his students and has reportedly relied on law enforcing agencies and student cadres of the ruling party to protect himself from the agitating students. Police, as always, went the extra mile. They hurled sound grenades, beat up the students, and filed cases against hundreds of them, many of whom were injured and hospitalised. The students' attempt to exercise their freedom of speech did not please the university administration.

administration.

A more serious (rumoured) misconduct is of the VC's gratuitous comments about the female students of Jahangirnagar University, which do not warrant repetition here. I believe this person and his 35 friends do deserve a grand farewell as a first step towards improving the academic environment in our universities. The next critical step would be to ensure that people with better academic and leadership qualities, as well as integrity and self-respect, are chosen to lead higher education in the country.

Proposed EC bill doesn't ensure one's impartiality

Dr Badiul Alam Majumder, secretary of Shushashoner Jonno Nagorik (SHUJAN), discusses how the new Election Commission bill undercuts the ultimate exercise of democracy, in a conversation with **Zyma Islam** of **The Daily Star**.

Why are our Election Commissions deemed partisan?

Certain laws are only implemented to protect the interests of the current regime. A sheer lack of transparency led to the formation of the current and immediate past election commissions, such as the 2012 and 2017 gazettes issued by President Zillur Rahman and President Abdul Hamid, respectively, which decreed that the election commissioners would be chosen by a search committee. The criteria that the search committees had used for selecting the commissioners were such that anyone would fit the bill.

The criteria included being 50 years

of age, having 20 years of experience in important government or judicial service, etc. The disqualifications included having foreign citizenship, being sentenced for more than two years for criminal offence, etc. There are no mechanisms in place to test the history of honesty, courage and impartiality of the candidate. This paved the way for the appointment of our current chief election commissioner (CEC),

Huda was a bureaucrat of the 1973 batch—the batch that was appointed without any rigorous exams, just based on allegiances. Throughout his career, he was viewed to be anti-BNP. As a result, he was victimised by the BNP when they came to power in 2001. They sent him into forced retirement when he was only a joint secretary, and he had to take them to court. He won the case, but the BNP government made him officer-on-special duty (OSD). After the Awami League came to power, he was made a secretary with etroactive effect. If the search committee had worked properly and transparently, people would have realised that he would have an axe to grind against the BNP.

The search committee itself needs to comprise fair and impartial members, and the president's gazettes or the proposed Election Commission bill do not ensure that. The search committee right now is made up of two sitting judges, the chairperson of the Public Service Commission, the auditor general, and two civil society members. All of these posts would have people who are either direct beneficiaries or not independent.

How do we ensure that the criteria of a fair, impartial commissioner can be

This cannot be done by setting any criteria. These need to be met by hosting public hearings and people speaking up. The committee is there to sieve through and find out what the truth is. The critical issue here is transparency and people's voice. The names being considered and recommended should be made public. Political parties should not be the only ones giving names. Anyone should be

able to nominate a person as an election commissioner. Based on the initial scrutiny, the search committee would come up with 20 people, of whom five would be women, and host public hearings for feedback. People with something to hide would automatically stay away, rather than face public scrutiny. Later, they would send seven names to the president along with a report, and make both the documents public.

We wanted one to two months for the process. But according to the law, the government will have only 10 working days to do this. This is nothing.

The search committees that created the incumbent and immediate past Election Commissions never disclosed the names of their proposed candidates. Not even a right-to-information request yielded that. This lack of transparency enables the president to ignore the search committee's recommendations. According to Article 48 (3) of the constitution, the president's decisions must be as per the advice of the prime minister. If no one knows the names, there is no guarantee whether the commission would be formed as per the prime minister's choice.

The search committee, too, needs to be constituted differently. The search committee we proposed would comprise a retired justice of the Appellate Division, and three parliamentarians—of whom one is nominated by the leader of the House, one by the leader of the opposition, and the third by the third largest party in parliament. There would also be one constitutional position, one media personality, and one member of civil society. The media personality and the civil society member would be selected by the other five members of the search committee, unlike what the proposed EC bill stipulates. This would ensure that there is one independent voice or more.

Can you reflect on the major points of failure of this Election Commission and the past?

Looking back, some of the most critical moments of failure of the current commission were when they refused to take responsibility for election-time violence, allowing law enforcement agencies to wilfully repress the opposition candidates and their supporters, taking no action against election offences, and ballot stuffing, as revealed by the BBC, TIB, and centre-wise voting records. The Nurul Huda commission had said they would not use the electronic voting machines (EVMs) without the consensus of political parties. But he changed his mind and went ahead with EVMs in spite of a lot of resistance. Jamilur Reza Chowdhury was the head of the technical committee, and he refused to sign the recommendation to buy EVMs without voter verifiable paper audit trail

SHUJAN analysed centre-wise data from the 11th parliamentary elections and found 213 centres with over 100 percent votes. In more than 1,200 centres, BNP had zero votes, and Awami League had 100 percent votes in 600 centres. The local government elections have been rife with violence, bloodshed and people dying, but the commission has squarely evaded responsibility, claiming that it was the administration's fault. A total of 42 of us petitioned the president in December 2020 and asked him to constitute a supreme judicial council to investigate the allegations of corruption and gross misconduct against the commissioners, but to no avail. It is clear that the commission is partisan and has committed fraud with the citizens.

■ OR many people, education means → sitting in a class and mindlessly repeating what the teacher tells you. But is that really what education is about?

At the Institute of Wellbeing, we have a sizeable internship programme. It has always been dangerous not to possess the power of logical thinking, but as we are inundated with misinformation, and as the potential costs go up-not believing in the safety and efficacy of vaccines, believing that the climate crisis is a hoax-knowing how to think for yourself becomes more important than ever.

Certainly, many of the most powerful among us would prefer that people not ask questions. That we accept the gig economy, the lack of secure jobs, the gross income and gender inequality that keep the rich rich, and men powerful at the expense of so many others. That we accept the idea that the environment is dispensable; all that matters is the economy, and the economy specifically refers to the ability of the wealthy to gain ever more money and power. But do billionaires control our educational system? Do we allow them to control our minds?

As our fascination with technology continues, we seem to have lost touch with so much that is basic in our societies. Many people say they have never read a book. Children are so absorbed by smartphones that they have lost the ability to hold a conversation. Our desire for ease, speed and convenience causes us to trash our planet with plastics, and throw away our lives on the roads.

Part of why I love working with the youth is that they, like me, tend to be optimists and idealists. They believe in a brighter future. I hope to show them that that brighter future, while still possible. is fading away quickly—and will never be obtained by trusting in the wealthiest and most powerful to make decisions on our behalf. We need to regain control of our lives, our thoughts and our politics, so that we can work together to achieve a better world for this and future generations—not by repeating what we are told, but by using our minds and hearts to search for, and achieve, something truly worthwhile.

BOOK REVIEW: GRAPHIC FICTION

'SHAPOD SHONEY' A beast of a graphic novel

For the very first time in the country, a Bangla novel has been adapted as an unprecedented, **400-page** graphic novel and published just a few months back.

What comes to your mind when you encounter a graphic novel called Shapod Shoney (Graphic Bangla, 2021), which translates to 'Along with the Beast', the cover art showing a man holding a rifle under the dark sky? My first impression was that it could be something along the lines of Jim Corbett out in the wild, hunting a maneating tiger. But as I would find out soon, the hunt here is for something more sinister than a deadly beast; Shapod Shoney falls more squarely under the category of the supernatural, with horror as its subgenre. The target audience for this graphic novel, consequently, excludes anyone below 18 years because of its graphic and gory imagery, the use of alcohol and cigarettes, and the explicit language in the dialogues.

The story revolves around two main characters. First, we have the paranormal investigator, Shiplu, who would go to the farthest corners of the world for a taste of the supernatural. It is his passion more than his profession. On the other hand we have Jamshed, an SAF gold medalist shooter, with a problematic and tragic past. Quick to lose his temper and quicker to draw a gun, he accompanies Shiplu on several of his paranormal adventures. This time, however, Shiplu asks for his help in investigating a case in a remote village in Rangpur. Little does Jamshed know, it will be the most terrifying one vet.

The characters here are flawed and operate in different shades of grey. The novel explores how human beings are capable of diabolical deeds with dark motivations that even the deadliest animals don't seem to have the stomach for.

The source material was first published in 2016 as a standalone novel. A doctor by profession, Nabil Muhtasim has gained popularity as an author from a very young age for his brilliantly imaginative work. Some of his fan-favourites include Bajikor, an espionage thriller trilogy (Batighar Prokashoni, 2017), sci-fi thriller Bibhong (Abhijan Publishers, 2019), and of course, the first Shapod Shoney itself.

Muhtasim's plots characteristically have climactic twists, and the way he misleads a reader from predicting them correctly is rewarding, which was something I enjoyed in both Shapod Shoney and Bajikor. He is also adept at describing intense action scenes, and writing great dialogues in line with each character's personality. Most of all, though, I enjoy his intricate plot lines written with a nuanced simplicity, which makes it easier for any reader to follow through.

In Shapod Shoney, for example, the chapters alternate between Shiplu and Jamshed's points of view, and while in Jamshed's chapters the story progresses in a linear fashion, Shiplu's sections jump back in time through flashback sequences to several of his paranormal cases. The juxtaposition allows us to witness both protagonists in their elements, their diverging personalities, motivations, and reactions, while experiencing some blood-curdling sub-plots along the way. With the author himself hailing from Rangpur, there is generous use of local dialect delivered by the inhabitants of the village in Rangpur where our two protagonists move.

Adrian Anik, meanwhile, has been a prominent artist in the comic book industry for a while now, and is known mostly for his work in the horror comic book series, Pishach Kahini (Dhaka Comics). Talented as he may be, making a 400-page graphic novel can be a back-breaking and time-consuming process, but it was Anik himself who approached Nabil, who graciously agreed. What you will observe in the novel is his passion and determination to tell a story through his art. In the black and white colour palette, Anik's talent shines the brightest when it comes to the anatomical detailing of the 'body horror' elements and in

conceptualising nightmarish creatures. There are, however, rooms for improvement-spelling mistakes in the prose could have been avoided, and the facial expressions on some panels could have been more nuanced in certain scenes In one chapter, for example, the detailing of facial expressions—jaw lines, nasolabial folds, frown lines, etc.—are entirely missing.

Nevertheless, reading this graphic novel has made me feel optimistic about our local comic book industry. There are so many great novels in Bangla literature, and Graphic Bangla's Shapod Shoney is one huge step towards adapting them into visual work that should reach a wider-and more varied—readership. After all, as Art Spiegelman, Pulitzer Prize-winning author of Maus A Survivor's Tale tells us, "Comics are a gateway drug to literacy".

INTERVIEW Pakistani artist Shehzil Malik illustrates 'Sultana's Dream'

A designer and illustrator whose work focuses on human rights, feminism, and South Asian identity, Pakistani artist Shehzil Malik has just created an artwork based on Rokeya Sakhawat Hossain's novella Sultana's Dream (1905). Daily Star Books editor Sarah Anjum Bari got in touch with Malik to discuss her motivations and inspirations for the artwork.

When and how did you first encounter Sultana's Dream?

My younger sister is my go-to person when I need to talk about my feminist ideas (and she also studied literature), so she knew I'd love this story! Other artists have also drawn Sultana's Dreamthere is a brilliant rendition by Durga Bai in the tradition of Gond tribal art; as well as a collection of stunning linocuts by Chitra Ganesh. I was curious with what I would come up imagining a South Asian science-fiction feminist utopia!

What about the language did you find "fresh and subversive", as you mention on your social media?

I think I felt it was subversive and tongue-incheek because even though it's now 2022, we in Pakistan are still arguing over whether girls should be educated; whether it's wrong to marry girls off when they're underage; whether a woman is capable to do a job or become financially independent; whether a good Muslim woman should step out of the house... it feels like the world that Begum Rokeya was escaping, is still the

And the pandemic has only exacerbated the situation for women. The few freedoms women had—in terms of leaving the house and having network-in many ways

were snatched away, and the incidences of domestic violence worldwide have skyrocketed. In the early phase of the pandemic, everyone was instructed to stay home, and while the women easily complied, many men refused. It was unthinkable for them to have their basic freedom taken away, and

yet they still don't understand why women are angry and dream of a

How did you conceive of the physical landscape of Lady Land, the feminist utopia Begum Rokeva imagines in her novella?

I was inspired by Indian and Persian miniature paintings and their use of space and time. These paintings often show many interactions happening in a single artwork, and take the viewer through multiple perspectives and scales to tell a story. There's no one hero in these paintings, but it gives the viewer the chance to find their own meaning in the artwork. I think combining these pre-colonial methods of artmaking with a story from colonial India- and then drawing the artwork digitally in post-colonial times- it makes me excited to see the possibilities!

As an artist who works with feminist and South Asian identity, what place do you think Sultana's Dream holds in the contemporary landscape of South Asian women's lives? I think everyone in South Asia (and beyond) needs to know this story! It is so ahead of its time, and talks about the kind of technology we still don't have! It presents a sustainable and ecological future (beyond screens and the kind of dystopian science fiction that is popular today) and really gets to the heart of why we want labor-saving devices and how we can structure our work and relations with others so that it brings us peace.

Growing up with Narayan Debnath's 'Nonte-Phonte'

On a particularly slow day, all I have to do is sit down with a Nonte-Phonte comic book, and my troubles will lay forgotten to one side. I imagine it's the same for most people who are fans of Narayan Debnath and his fictional characters from the small town of Paschimpara, West Bengal.

The unique illustrations coupled with quirky and colourful Bangla vocabulary that the author undoubtedly carried over from his childhood in Shibpur, Howrah, all make for a wholesome reading experience every time one picks up a copy of these books. As a fan, I'm eternally grateful that Debnath opted to stray from their family business of gold retailing, after dropping out from the Indian Art College in the 1940s, to pursue freelance work in art and design. While he illustrated plenty of children's books throughout the 1950s, it wasn't until 1962 that he released his first comic strip, Handa-Bhonda, in Shuktara magazine.

The Nonte-Phonte series—and the witty humour with which Debnath weaved together his stories of small-town kids and their proclivity for pranking unsuspecting targets-started out in 1969 as a comic-strip in the Kishore Bharati magazines.

It all went down in an unnamed boarding school for boys in West Bengal, where the eponymous Nonte and Phonte were best friends studying and residing together as juniors alongside their constantly-scheming senior, Keltu Kumar, all under the strict supervision of the boarding's hostel superintendent sir, Patiram Hati. Over time, I even began to regard one of my cousins as the real-life counterpart of the fictional Keltu from the series—such was the comics' influence on my childhood.

Narayan Debnath succeeded in offering me that which no other comic book writerillustrator could: comfort in my personal identity. As a Bangladeshi with roots in West Bengal, the Nonte-Phonte comics

were a source of bibliotherapy for me, providing me with insight into the lives my ancestors had led. The more I read about that small town of West Bengal, the more I began to understand how the inhabitants

of said region carried themselves and interacted with each other. Having never visited my ancestral lands myself, the Nonte-Phonte comics helped me draw a parallel with the stories I'd always heard from my grandparents. I eventually came to have a better understanding behind the little things that made up parts of my cultural background, from items of food to slang from a bygone era.

What added to this sense of comfort was that, unlike most children's books that were widely available at the time, the Nonte-Phonte comics didn't come with an obvious set of moral codes for children to follow. Instead of lecturing kids on how to be a kid—which was a rather prevailing tone in the didactic children's books in the 1990s-2000s, such as Winnie the Pooh, Dr Seuss and Beatrix Potter —Debnath truly understood what it meant to be a child. There were no apologies made for playing a prank on an elderly member of the community, or for stealing homemade food from classmates.

There were other books by Debnath that left a mark on my childhood. Handa-Bhonda (Shuktara), a spiritual predecessor to Nonte-Phonte, set in the same universe, and Bantul The Great (Shuktara), which gave Bengalis our own version of Superman in the form of Batul. As an adult, however, it is with Nonte-Phonte that I relate to the most, picturing myself wandering about the streets of Paschimpara with hostel superintendent sir Patiram Hati in tow, or gorging on the cream cakes and chicken kabiraji from Abar Khabo Restora.

The wordsmith and artist behind this childhood-defining comic books is no more, having breathed his last on January 18, 2022. His legacy will continue to live on through his iconic creations.

South American stars sweating on qualification

Three of South American football's biggest stars Luis Suarez, Edinson Cavani and Alexis Sanchez risk missing out on the World Cup in Qatar as South American qualifying enters its final

straight. With Brazil and Argentina already qualified, seven nations are battling it out for the final two automatic qualifying spots with just four matches remaining.

Right now Suarez and Cavani's Uruguay and Sanchez's Chile are both sitting a point outside the crucial fourth spot held by Colombia. Uruguay are currently seventh and have changed coaches since the last round of matches in November.

After a record-breaking 15 years at the helm, iconic veteran coach Oscar Tabarez was fired following a disastrous fourth straight qualifying defeat in which Uruguay conceded 11 goals and scored just one.


Diego Alonso will take charge of the team for the first time in a bid to negotiate the tricky path towards Qatar.

Twice former winners Uruguay have not failed to qualify for the World Cup since 2006.

Uruguay travel to Paraguay on Thursday before hosting Venezuela - the only team in the single 10-nation qualifying group with no realistic hope of reaching Qatar on February 1.

Only Venezuela and the top two -- Brazil and Argentina -- have nothing to play for. But even though Paris Saint-Germain teammates Neymar and Argentina's Lionel Messi have been left back in Europe, neither side will be expected to take their remaining matches lightly.

"In the few matches that remain, no coach is going to do a lot of experimenting," Brazilian commentator Paulo Calcade of the Disney sports channels told AFP.

Ctg phase to find cure for low-scoring pitch?

Pitch remained at the centre of all discussions as the Bangabandhu Bangladesh Premier League fixtures shift from Dhaka to the port city of Chattogram

Among the eight matches played so far in the Dhaka leg, 112.5 was the average first-innings total in four games played under the daylight. In sharp contrast, the four games played under the light at the same ground produced an average first-innings total of 173, where Khulna Tigers even chased down a target of 183 against Minister Group Dhaka. At night, the highest total of 190 for 7 was posted by Chattogram Challengers against Khulna.

Interestingly, like the difference of the nature of surfaces between the day and night games, there were different opinions from the players of the participating teams regarding the lacklustre display from the batters so far.

According to Sylhet Sunrisers captain Mosaddek Hossain, it is difficult for the batters to score runs freely in the day games in Mirpur whereas the pitch does

the rest for the bowlers, who only have to hit the right areas.

However, Bangladesh ODI skipper and Dhaka opener Tamim Iqbal stated that the batters are to be blamed for the poor show instead of the pitch after his side were bundled out for just 100 runs against Sylhet to face their third defeat in four games on Tuesday.

Veteran local coach Sarwar Imran resonated with Tamim's stance. However, he points to the curators eventually

"These are not ideal T20 pitches, to be honest. But still, the batters need to adjust with the surface no matter how the pitch behaves. It's also about the mindset you get in as a batsman. And when scoring boundaries are difficult, you need to look for the singles and doubles," Imran told The Daily Star.

"Another thing is, most of our batters lack T20 techniques as they don't have the proper balance and position for a big hit. But at the same time, I really wonder why the curators are unable to prepare good pitches."

According to a former Bangladesh Cricket Board curator Badiul Alam

Khokon, curators' lack of knowledge is also a big reason for failing to produce high-scoring pitches in Dhaka.

He also revealed the reason why the upcoming Chattogram leg is expected to produce high-scoring encounters compared to Mirpur.

"First of all, the curators don't roll the Mirpur pitch enough. It's simple math, the more you roll the surface, the better it gets for batting. The other thing is the dew, as you noticed the night games produced runs because the ball skids on the surface

"I've seen the curators in Dhaka have been using cut grass in the pitch and when you have dead grass, it tends to take the pace off the ball once it lands on the surface. When the pitch gets dry it also tends to slow gradually.

for the dew factor," informed Khokhon.

"Chattogram surface, on the other hand, has live grass in it which allows the ball to generate more pace after pitching. It's also because we don't play many matches in Chattogram, so the curators get enough time to take care of the pitches properly," said Khokon.

Wiley, who had his Twitter account suspended after posting a string of anti-Semitic comments on his social media accounts in 2020, posted the photo on Instagram before deleting it.

The Jewish Chronicle newspaper published the picture, which it said was taken in Dubai on an unconfirmed date.

"I'd like to reinforce that I do not and will not condone discriminative language or behaviour of any kind aimed at the Jewish community or any other community," Rashford tweeted.

"I truly believe that tackling anti-Semitism in and outside of the game requires a greater level of attention and should very much form part of the game's anti-racism stance."

Gunathilaka back from ban

Gunathilaka, 30, had his ban lifted following an appeal and the payment of a \$50,000 fine, and is among the 20-man squad named for Australia under Dasun Shanaka.

The first two T20 matches will be at the Sydney Cricket Ground on February 11 and 13, followed by one match in Canberra and two in Melbourne.

Dazzling Tsitsipas 'in the zone'

Stefanos Tsitsipas said he was "in the zone" after producing his best match of the tournament to demolish Jannik Sinner and storm into his third Australian Open semi-final on Wednesday.

The Greek fourth seed was at his dazzling best to romp past the 11th-seeded Italian 6-3, 6-4, 6-2 in 2hr 6min and into a semi-final against Daniil Medvedev, who fought back from two sets down to beat Felix Auger Aliassime 6-7, 3-6, 7-6, 7-5, 6-4.

It was a most impressive performance from the world number four who grasped control of the quarter-final on Rod Laver Arena with a break in Sinner's opening service game and did not relinquish his firm grip.

Tsitsipas said his tennis was "way better" than his previous four matches at the year's opening major. "It was the most consistent and the best match I've had in the tournament," Tsitsipas said.

"I feel like I'm in the zone. I have no plans of getting out of it. It's part of my game.

"I was really fired up to bring the best out of my game today, and I tried to get my level as high as possible.'

Not even a rain interruption which forced the stadium's retractable roof to be closed and change match conditions early in the second set could derail the Tsitsipas momentum.

Tsitsipas also revealed that his doctor had warned him that he would not be recovered in time from right elbow surgery late last year to play in Melbourne. "Dr Frank spoke from experience that he

had with other players that he treated and he was surprised that my healing process was faster than he would have expected," he said.

Last year's French Open finalist recaptured his fluency and timing and hit the ball majestically, reeling off 30 winners -- 17 on his forehand -- and breaking Sinner's serve four times. Sinner, rated one of the hottest young talents on the men's circuit, did not get a break point in any of Tsitsipas's 14 service games and was blown away.

Tsitsipas broke immediately when the Italian overhit a forehand and served out strongly to take the opening set in 36 minutes.

The Greek grabbed another break in the third game of the second set before rain stopped play and forced the stadium roof to be closed with more threatening weather forecast. He was relentless and powered his way to a double break in the third set which gave Sinner

Tsitsipas has reached the semi-finals twice before in Melbourne and became the first Greek player to reach a major final when he lost a two-set lead to Novak Djokovic in last year's

"He served better," said Sinner. "He moved the ball better than me. He was moving better

"It's tough to play against him when especially he plays like this.'

Crashes claim 11 lives in two districts

Four female workers of Uttara EPZ died when a train hit a battery-run three-wheeler in Nilphamari Sadar upazila yesterday, while five people were killed as a bus rammed a CNG-run auto-rickshaw in Bogura's Sherpur.

Besides, crashes claimed two other lives in Bogura. In Nilphamari, the Chilahati-bound Rupsha intercity train from Khulna crashed into the three-wheeler when it was crossing an unauthorised level crossing in Sonarai Dhonipara village around 6:00am, locals said.

Three women were killed on the spot while five others and the driver of the three wheeler were critically injured. Locals said nine female workers of the nearby EPZ hired the three-wheeler, locally known as easy bike, to go

to work at different factories. The four critically injured women and the driver were rushed to Nilphamari Sadar Hospital, from there they were referred to Rangpur Medical College Hospital as their condition was very critical.

Later, another injured woman died at the medical

The deceased are Romana Akhtar, 25, Shefali Begum, 35, Sayra Banu, 24, Minara Begum, 25. They are from Sonarai Dhonipara and Koranipara villages.

Witness Afazuddin, 50, said the three-wheeler driver could not notice the approaching train as there was

Abdur Rahman Biswas, officer-in-charge of Saidpur Railway Police, said the level crossing is unauthorised and it has no gate and guard.

In Bogura, a bus rammed a CNG-run auto-rickshaw on the Bogura-Rangpur highway in Sherpur's Mirzapur around 5:00pm yesterday, killing five people, including a



woman, on the spot and injuring another.

AKM Baniul Anam, inspector of Sherpur highway police camp, said all the deceased were auto-rickshaw

There were six people in the vehicle, including the driver, he said, adding that the auto-rickshaw driver was also killed in the accident.

Pias Ahmed, a passenger of the Bogura-bound bus, aid "Near the accident spot the road condition is ba The auto-rickshaw came into the middle of the road. At the same time, our bus also overtook another vehicle. Hence the head-on-collision occurred."

Three of the deceased are Hridoy, 25, and his wife Sathia, 21, of Dhunat, and Anwar, 35, of Sherpur. The identities of two others could not be known.

In another accident, Motiur Rahman Mintu, 40, of Bogura's Kahalu, died when an intercity train hit him while he was crossing Belghoria level crossing on a motorcycle around noon.

Ashraful Haque, 55, an independent chairman candidate of Shukanpukur Union Parishad elections, was also killed in a crash around 4:00pm yesterday.

US may lift Rab sanctions if given 'accurate info'

Foreign minister tells parliament

The government hopes the US will lift sanctions on Rab if it is provided with accurate information, Foreign Minister AK Abdul Momen told parliament yesterday.

He came up with the remarks while delivering a statement in parliament under Section 300 of the parliamentary rules of procedures.

Momen informed the House that BNP and Jamaat had appointed eight lobbyist firms to ensure that the USA stops providing aid and

development assistance to Bangladesh. He also said the government has proof that the BNP, through appointing lobbyists, was linked to the slapping of the sanctions on Rab. He alleged the party also appealed to the United Nations Department of Peace Operations to ban the law enforcement agency from UN deployment.

Momen said the lobbyists have given statements that would offend the people of the country.

"BNP has told them [the US] that its security will be hindered due to Bangladesh. How can they write this? Shame on them [BNP]," the minister said amid thumping of desks by the treasury

He questioned how the BNP paid the lobbyists

and demanded an investigation in this regard.

He said there might be differences of opinion between the government and the BNP, but the country cannot be harmed by that.

Momen said hiring lobbyists in the United States is a legal process under the US law. India, Pakistan, Qatar, Saudi Arabia and other countries and organisations around the world appoint lobbyists to improve political and economic relations.

"But here the main issue is the purpose of hiring lobbyist [by BNP]," he said. He said that in 2014, Jamaat hired a firm to stop

the trial of war criminals, for which they paid one and a half lakh dollars. They hired another lobbyist firm to stop the trial process.

He said BNP had spent \$1.20 lakh each month as retainer fee and \$27 lakh each year from February 2015 to April 2017. The BNP had hired four lobbyist firms till 2017 and then one in 2019. And to prevent the trial of war criminals, Jamaat-BNP appointed three lobbyist firms.

The minister said some BNP members had written to the UN secretary general to declare Bangladesh's parliament illegal. SANCTION ON RAB

Info minister trashes TI graft report

Information Minister Hasan Mahmud yesterday dismissed the 2021 Corruption Perception Index, in which Bangladesh ranked 147 out of 180, saying the report is based on wrong data.

"Many neighbouring countries including India and others do not give emphasis to such reports, he said at a press briefing at his secretariat. Bangladesh scored 26 out of 100 in the latest

edition of Transparency International's annual flagship report, which is more or less the same as in the past decade.

Among the eight South Asian countries, Bangladesh remains the second-lowest both in score and rank.

"When a report is based on wrong data or motivated, the image of the organisation gets damaged -- their recent report is biased and conventional," he added.

Meanwhile, Anti-Corruption Commission Chairman Mohammad Moinuddin Abdullah said the government agency does not have any reaction to the report.

"We don't have any reaction on the matter. It is not a matter to accept or refuse. We will go through the report. If the report has any recommendations for us, we will try to follow those for our improvement."

Updated Covid guidelines to be published soon

The health directorate will soon publish an updated version of the Covid-19 clinical guideline to combat the Omicron variant of the coronavirus as it is the main reason behind the ongoing surge in cases.

The symptoms of the Omicron variant have been included in the fresh guideline, said Md Nazmul Islam, a spokesperson of the Directorate General of Health Services, in a media briefing yesterday.

"If we follow the health guideline, we will be able to control the pandemic," he added. Meanwhile, 17 Covid-19 patients died and 15,527 tested for the viral infection in the 24

hours to 8 am yesterday, according to a press release from the DGHS. The DGHS reported a 31.64 percent positivity rate during the period, down from 32.40 percent

in the preceding 24 hours. Of the deceased yesterday, 13 were male and four female.

Of them, the highest deaths were recorded in the Dhaka division (10), followed by Chattogram (4). There were one death each in Rajshahi, Khulna, Barishal and Mymensingh divisions.

The fresh numbers took the country's total Covid fatalities to 28,273 while the caseload went up to 1,731,524 yesterday.

Omicron risk remains very high: WHO

The risk level related to the Omicron variant remains very high, the WHO said late Tuesday, with the numbers of new Covid-19 cases hitting another record high last week.

"Over 21 million new cases were reported, representing the highest number of weekly cases recorded since the beginning of the pandemic," the World Health Organization said in its weekly epidemiological coronavirus update.

The UN health agency said the number of new infections increased by five percent in the week to Sunday -- compared to the 20 percent rise registered the week before.

The WHO said, of the available data, Omicron accounted for 89.1 percent of the cases. Delta previously the world's dominant variant -- now makes up 10.7 percent.
