BNP engaging in anti-state activities

Says info minister Hasan Mahmud

BSS, Dhaka

Information and Broadcasting Minister Dr Hasan Mahmud yesterday said BNP and their leaders are doing anti-state activities and hatching conspiracies against the country.

He said BNP as a political party could criticise the government's activities but they could not engage in treasonous and anti-national activities by sending letters against the country abroad, to hire lobbyist firms for tarnishing the country's reputation and destroying its trade and export.

Terming appointment of lobbyist firms a conspiracy against the country, Hasan said the government might carry out an investigation to find out where the illegal money went and who took it. "Action will be taken after the investigation. The prime minister also said this in her speech in Parliament recently," he said.

The minister was speaking as the chief guest at a views-exchanging meeting with journalists after inaugurating Bangabandhu Corner at Bangladesh Television, Chattogram Center.

Hasan said there was no need for BNP to send letters to foreigners if they have confidence on country's people. He said that BNP leaders and its secretary general were carrying out propaganda against the country by appointing lobbyists, to destroy the country's reputation and to obstruct the country's trade and export.

The minister said BNP has appointed lobbyists at different times and by appointing lobbyists they have tried to stop the trial of war criminals. He said Khaleda Zia had written an article in the Washington Times a few years ago to stop the GSP facility of Bangladesh.

Hasan said they have documents in support of BNP's hiring of lobbyists in different times and the reports with documents have been published in media. "We have ensured the freedom of the media."

The level of freedom enjoyed by the media in our country is not found in many developing countries," he said. He said that free flow of information is needed for a multi-dimensional social system. "The prime minister had approved private television for this. These private channels are operating very independently in Bangladesh," he added.

She observed that Prof Razzaq's basic hypothesis was that political parties of India at that time operated more in the form of political protests. He argued that they failed to align with the basic principles of democratic political parties — that parties should operate as part of an economic programme — as they were primarily working to dismantle colonial rule in India.

This means they left out major tenets of democracy, that politics must offer space for dialogue and peaceful adjustment of different opinions; that politics must have rotational power; that everyone must have equal opportunity to participate; and that no one party can become a permanent majority or minority.

"I mention these points because they are still relevant, because we still do not have these things in Bangladesh," said Prof Jahan, mentioning the book as provocative and passionate, reflecting

Razzaq's tendency to treat any form of received wisdom by questioning it, rejecting it, and proposing alternative hypotheses.

CPD chairperson Rehman Sobhan said, "We have all been a part of the great adventure of Professor Razzaq's thesis at various stages in our numerous encounters with him."

University of Liberal Arts Bangladesh Professor Salimullah Khan said, "Professor Razzaq has not shown a single unnecessary statistic in his book. It is evident that he has deeply studied economic history."

Prothom Alo Editor Matiur Rahman said, "From the Language Movement to the struggle for independence to latter movements of protest, those who participated in and led these struggles, and those who have followed in the footsteps of Professor Razzaq — our only objective is that we want to see this society becoming more tolerant. We want to live in harmony."

Anam said, "He had the image of a scholar, a truly dedicated teacher, and we the students of Dhaka University were disciples of that myth. I thank Professor Ahrar Ahmad for the intellectual labour, dedication, and sincerity he has put into this project."

Looking back at the genesis of Gyantapas Abdur Razzaq Foundation, Abul Khair Litu, chairperson of Bengal Group Ltd and member of the foundation's trustee board, said of his uncle, "Professor Razzaq taught us that if someone does you injustice or even writes against you, but if he is a good and educated human being, then accept him as he is."

The discussion also included theoretician and academic Badruddin Umar; former finance secretary and finance minister M Syeduzzaman; rights activist Hameeda Hossain; and founder trustee of Liberation War Museum Mohidul Hoque. Though slated to be present, historian and writer Muntassir Mamoon could not attend due to ill health.

laptop, 43,950 Indian rupees and 18 mobile phones from their possession.

On January 23, Indian nationals Shahil Ahmed and Asif Iqbal, students of Dr Sirajul Islam Medical College Hospital in Dhaka, were leaving for India on a two-week vacation.

Around 5:10am, while they were on their way to the airport, four masked muggers in a car intercepted them in front of the Grameen Check Showroom in Moghbazar Wireless area, near their hostel.

Brandishing sharp weapons, the muggers robbed the duo of their belongings, including a trolley bag, a handbag, a laptop, two mobile phones, 57,000 Indian rupees and Tk 7,600 in cash.

Following the incident, a case was filed with Ramna Model Police Station on the same day.

"During primary interrogation, the arrestees admitted to mugging the two Indian students," Mahub told the briefing. The DB official said the car belongs to a doctor, and was rented by Fakrul Islam Faku.

However, detectives have not found the doctor's involvement with the gang.
