Schools to stay closed for two more weeks

Schools and colleges are set to be closed for two more weeks after February 6 due to the high Covid infection rate in the country.

In the 24 hours to 8:00am yesterday, the positivity rate was 27.43 percent, down from 29.17 percent the previous day.

"We have decided that in-person classes at educational institutions will remain closed for two more weeks based on the recommendation of experts as the coronavirus infection rate is still around 30 percent," said Education Minister Dipu Mani in a statement yesterday.

Earlier on January 21, the government had closed all schools, colleges and equivalent educational institutions for two weeks

She hopes that the government will be able to restore normalcy in educational institutions and resume inperson classes as soon as the positivity rate drops.

Meanwhile, Unicef on January 28 urged governments across the world to keep schools open to avert a learning catastrophe and put children back on the learning track. "As the Omicron variant of Covid-19 continues its

KIDNEY PATIENTS IN DHAKA, CTG HOSPITALS

Held hostage to public-pvt row

Kidney patients suffered badly as dialysis services remained halted for seven hours at two public hospitals in the capital and Chattogram yesterday.

It happened after Sandor Dialysis Services Bangladesh (Pvt) Ltd, which provides the services under a Public-Private Partnership (PPP) agreement, suddenly stopped its operations at the hospitals around 8:00am, demanding dues from the Directorate General of Health Services.

Following hours of negotiations, the services resumed around 3:00pm.

Sandor officials, however, threatened they will completely shut down the services if the dues are not paid quickly.

According to the officials, the dues totalled Tk 23cr, but DGHS officials said it would be around Tk

After the services were stopped yesterday morning, kidney patients gathered in front of the National Institute of Kidney Diseases and Urology (NIKDU) near Shyamoli in protest around 1:00pm, blocking traffic on the Mirpur-Azimpur Road.

They left around half an hour later following requests by the police and the hospital authorities. Speaking to The Daily Star, 30-year-old Asim Kumar Shil, a patient, said he needs to undergo kidney dialysis twice. "I came all the way from Munshigani this morning for my dialysis. If I don't

Asim said he cannot afford the treatment at any private hospital.

get it quickly, I might be in danger."

Fifty-year-old Prafulla Kumar Nath went to the dialysis centre at Chattogram Medical College Hospital (CMCH) from the district's Mirsharai

"I have been having dialysis at this hospital since 2018. I pay only Tk 486 for each session, whereas it will be around Tk 2,000 at any private hospital."

KILLING OF 3 MIRPUR BOYS

7 years on

On February 22, 2015, three adolescent boys were shot dead in the capital's Mirpur area during a violent political movement, on suspicion that they were arsonists linked to the opposition party.

The incident, at the height of months-long arson attacks on public transport across the country, made headlines as newspapers citing autopsy findings reported that their tender bodies bore at least 56 bullet injuries.

Seven years on, families of the victims were found in the dark about the fate of the two cases one filed by the police after the incident and another by one family after they 'lost trust' in police investigation.

Police submitted the final report in May 2017, saying although it was a murder incident, they could not track down any of the perpetrators.

The names and addresses of the perpetrators in connection with the incident could not be known and the possibility of finding their names and addresses and arresting them in the near future is very slim," said the final report submitted by Sub-Inspector Md Rafiquzzaman Mia of the Detective Branch (DB) of police, also the investigation officer.

The court subsequently accepted the report, which also said police would revive the case and press charges if they identified any of the suspects.

In the meantime, a Dhaka court "summarily dismissed" the murder case filed by one of the victims' family in April 2018, shows the court's register book. The family filed the case in December 2015 in the hope that the court would

However, none of the victims' families is aware of either of the two developments over the fate of

The three boys -- Sumon, Robin and Jewel were shot in a dark alley of Baishbari area in West Kazipara on the night of February 22, hours after some locals caught them on suspicion of preparing to firebomb public transport near Krishibid Bhaban on Begum Rokeya Sarani in Mirpur.

Omicron sub-variant may be more contagious

Health officials say citing WHO, urge all to strictly maintain health rules

Health officials have urged people to follow health safety rules strictly as the World Health Organization said the new sub-variant of Omicron, already detected in 57 countries, may be even more contagious.

"There is no alternative to abiding by the health protocols to stay safe," DGHS spokesperson Dr Md Nazmul Islam said at the daily briefing on the Covid-19 situation yesterday.

In its weekly epidemiological update on Tuesday, the WHO said the variant, which accounts for over 93 percent of all coronavirus specimens collected in the past month, has several sub-lineages: BA.1, BA.1.1, BA.2 and BA.3.

The BA.1 and BA.1.1 -- the first versions identified -- still account for over 96 percent of all the Omicron sequences uploaded to the Gisaid, a global science initiative based in Munich, it said.

There has, however, been a clear rise in cases involving BA.2, which counts several different mutations from the original, including on the spike protein that dots the virus' surface and is key to entering

"BA.2 designated sequences have been submitted to Gisaid from 57 countries to date," the WHO said, adding that in some countries, the sub-variant now accounted for over half of all the Omicron sequences

Pointing to the new sub-variant, Dr Nazmul said it is necessary to act responsibly.

The pressure on the ICUs, HDUs and oxygen supplies in hospitals will increase with the rise in the number of patients. "We're preparing to tackle this pressure."

Central oxygen lines have already been set up in 119 hospitals and more than 29,000 oxygen cylinders, 2,000 high flow nasal cannulas and 2,300 oxygen concentrators are being used, he said.

"If we look at the Covid-linked deaths according to age, the highest number was reported among people aged 61-70."

Division-wise, the highest number of deaths -- 12,451 -- were reported in Dhaka - more than 43.80 percent of all Covidrelated deaths.

3 die after car rams into train

Three people were killed as a private car rammed into the wheels of a moving train at a level crossing in Dinajpur's Birampur upazila yesterday morning.

Two of the dead were identified as Md Hafisul Islam, 44, and Md Masum Islam, 39, driver of the car, from Rangpur's Badarganj upazila.

Md Saifuzzaman, the gateman of the level crossing, said the car drove into the Kurigram-bound **Kurigram Express intercity** train around 6:40am.

He added there were two barriers at the level crossing but were removed for development work on the road. The barriers were replaced by a rope, which would be raised to stop vehicles from crossing when a train would pass.

"However, the rope was not visible due to dense fog yesterday morning."

The car tore through the rope and rammed into the train from the side, he said, adding that the vehicle then flew off around 100 meters away, throwing all the passengers out. They all died on the spot, he added.

Mohidul Islam, in charge of Hili Government Railway Police (GRP) Station, said Birampur police, on information, rushed to the spot, while GRP officials also went to the area and sent the bodies to M Abdur Rahim Medical College Hospital for autopsy.

Md Mizanur Rahman, the stationmaster of Birampur Railway Station, said the process of installing new barriers at the crossing was underway.

Ashim Kumar Talukdar General Manager of Western Railway Zone in Pakshey said that a 4-member probe body has been formed making head Divisional Manager to investigate the incident.

According to the media reports and officials of the Western Railway Zone of Bangladesh Railway, at least 11 such accidents occurred throughout January in various districts, including Dinajpur, Nilphamari, At least 14 people have died.

Leaders of the Bangladesh Petroleum Dealers, Distributors, Agents and Petrol Pump Owners Association placed a six-point demand including a rise in their commission to $7.\overline{5}$ percent from 2.92 The government increased the

commission by only Tk 0.20 per litre while they increased the fuel price at Tk 15 per litre, said Mizanur Rahman Ratan, general secretary of the association's

The ministry of power, energy and mineral resources and the Bangladesh Petroleum Corporation decided on their own to reduce their losses but the people who conducted the entire process found nothing.

Charges accepted against 'Shishu Bokta' in DSA case

A Dhaka tribunal yesterday accepted charges against two people, including "Shishu Bokta" Rafiqul Islam Madani, in a case filed under the Digital Security Case.

Judge Mohammad Ash Sams Joglul Hossain of Dhaka Cyber Tribunal passed the order rejecting Madani's bail petition, which claimed he did not make any derogatory remarks on the president and the prime minister.

Madani is in jail since April last year. The other accused, Mahmudul Hasan Murtuza, was granted permanent bail by the tribunal.

It relieved accused Mohammad Amzad, HM Lokman Hossain and Tawhid Islam of the charges as the investigation officer did not find their involvement in the case.

On April 8 last year, one Syed Adnan Shanto filed the case with Motijheel Police Station.

Contract signed with Russia for Bangabandhu-2 satellite

Bangladesh Satellite Company Ltd (BSCL) yesterday signed a cooperation contract with Russian company Glavkosmos for launching Bangabandhu Satellite-2 within December next year.

Following the signing of the Memorandum of Cooperation (MoC), both the parties will work on detail technical and financial issues regarding construction and launch of the satellite, said BSCL Managing Director Md Shafiqul Islam.

"This will convert into an agreement after due diligence of financial, technical and legal aspects," he said.

Glavkosmos is a subsidiary of the State Space Corporation Roscosmos of Russia.

BSCL Chairman and Chief Executive Officer Shahjahan Mahmood and Glavkosmos Director General Dmitry Loskutov signed the contract on behalf of their respective sides.

12 migrants 'pushed back' by Greece died at border: Turkey

Ankara vesterday accused Greece of allowing 12 migrants to die in the winter cold after stripping them of their clothes and then pushing them back across the Turkish

The charges from Interior Minister Suleyman Soylu threaten to escalate simmering tensions between the rival members of the Nato defence alliance.

They also highlighted Ankara's concern that the European Union was not doing enough to support Turkey -- which hosts an estimated five million migrants and refugees -- in the face of a potential new flow of people from Afghanistan.

Soylu posted blurred images on Twitter showing bodies lying by the roadside.

Want to lease a grave? Get ready to pay lakhs!

Believe it or not, if someone wants to lease a grave -- even if it's just around 28 square feet of land -- for 25 years in an area of Dhaka South City Corporation (DSCC), they'll have to pay a hefty Tk 20 lakh!

The areas under Dhaka North City Corporation (DNCC) are no exception either. Although the rate is a bit lower , they still go for Tk 11 to 15 lakh for the same

But what is the reason behind such astounding rates? Officials of both city corporations said they have fixed high rates to discourage people from reserving graves for their loved ones, as there will be a shortage of burial spots if everyone does the same.

DSCC fixed the rate at Tk 5 lakh, 10 lakh, 15 lakh and 20 lakh for 10, 15, 20 and 25 years, respectively, for its $three\ graveyards\ in\ Jurain,\ Azimpur\ and\ Khilgaon.$

On the other hand, DNCC has fixed its prices for people who want to bury their loved ones at the reserved section of six graveyards in Banani, Rayerbazar, Mirpur,

They charge Tk 6 lakh for 15 years and Tk 11 lakh for 25 years. However, for Banani graveyard, they charge Tk 15 lakh for 25 years and Tk 8 lakh for 15 years.

However, a person has to pay three times higher if they want to lease a grave in the general section of the graveyards, said Md Enayet Hossain, DNCC's social welfare official.

Meanwhile, there is no scope to reserve a grave before someone's death. If anyone wants to get a lease, they will have to apply once their loved one is buried, Enayet said.

In the past, graves could be leased in advance, but that provision doesn't exist anymore according to new guidelines, he said.

DSCC has prepared a new guideline for their graveyards, in which they re-fixed the fee for general burial (except logistics of burial and digging fees) at Tk 1,000. This fee did not exist during the previous mayor's tenure. DNCC is taking Tk 500 as burial fees.

Md Abu Nasher, public relations officer and spokesperson of DSCC, said they have fixed the fee after a decision was reached at a DSCC board meeting.

He said they have decided to take Tk 1,000 to discourage residents from burying loved ones in city graveyards, and instead bury them in their village homes.

Among the graveyards in DNCC areas, Rayerbazar graveyard, set up on around 96 acres of land, does not allow leasing graves at all. "We do not give any reservations. We have cancelled the system recently, as a grave automatically remains for around 15 to 20 years due to the premises' vast area," said Abdul Aziz, caretaker of the graveyard.

He said lease applications for around only seven graves have been approved in the last five years.

Mirpur's Kalshi hosts a big private graveyard. It also

does not allow leases, except in special cases. Md Ripon, caretaker of Kalshi graveyard, said they have stopped leasing out graves due to the scarcity of land, although they sometimes make exceptions for some

special requests. "We take Tk 4.5 lakh for a 20-year lease in these cases." he said. However, lessees of the graveyard have complained of irregularities while speaking to this correspondent.

Md Lutful Kabir Shipon, a resident of Mirpur 12, said they had leased a pair of graves for Tk 70,000 on April 14, 2008 after his father died, way before the new regulations came to effect.

"We buried our mother in the other one on December 19, 2019. But during her burial, the graveyard authorities started demanding an additional Tk 50,000, citing that the current spike in price of reserved graves," he said, adding that they were told at the time that they will be able to keep the graves for as long as they want.



Fighting for the bare minimum

Students with disabilities at JU struggling from lack of resources

At Jahangirnagar University (JU), there's no books available in braille, neither is are there reserved seats in the dorms for students with disabilities.

As a result, these students are slipping through the cracks, as authorities do not provide them any special facilities that they desperately need. Every year, many students get admitted to

JU under the "disability quota". But with no official penmen available, the students have to go through a lot of hassle when sitting for tests and in classes. Moreover, the university is yet to have special funds to introduce a scholarship for their educational expenses.

"I have no opportunity to tutor or get any kind of part-time job. The visually impaired, like me, have to deal with an ocean of suffering," said Saiful Islam, a student of JU's history department. "My family could barely support me. I don't have an income source nor does the university give me a scholarship. How do I continue my studies?"

Since there are no reserved seats for them, the students said they have to stay at "mini gono room" at the dorms.

Abul Kalam, a visually impaired student who is struggling to live in such a room, said, "I had tried to manage a single seat upstairs, but failed after repeated attempts. This room can at best accommodate two students, but eight of us are staying here." Neither house tutors nor the hall's provost ever came to see them, he claimed.

"The day before my exam, I had to spend at least an hour to find a penman who would sit with me for the test... Ân organisation called PDF (Physically-challenged Development Foundation) tries to help us, but it's not enough. I have to depend on the mercy of others," he added.

"They don't provide books in braille for us. We have to face problems in the library too; we can't find the books we want to read there. Our central library doesn't have any special corner for braille books," said Sharmin Akhter, a student of government and politics.

Those who have other forms of physical disability face a host of other problems too. For example, there are no ramps in buildings for those who use wheelchairs. This simple issue can have major implications. In many cases, some students had to get admitted into departments situated at the ground floor just for this, despite being qualified to enrol in their preferred subjects.

Contacted, Dr Sveda Fahliza Begum, director of students' welfare and consultation centre of JU, said, "No special fund or scholarship has been introduced for them. We will discuss with the university authority in this regard. A special fund can be very helpful."

Asked about arranging reserved seats, Dr Mohammad Mujibur Rahman, president of the hall provost committee, said, "That will be a good initiative, and we'll discuss the matter. We will try to manage a floor for them in our new halls. I will discuss this with our vice-chancellor.

Rahima Kaneez, acting registrar of JU, said, "We are thinking of introducing braille books and ensuring extra facilities in the library."

ACHILLES' HILLS

Rampant hill cutting puts 200 families in Moulvibazar under risk of landslide

Even though everything came to a halt during the pandemic, hill cutting didn't.

In the name of development work, syndicates in different areas of Moulvibazar continued this illegal activity unabated throughout the lockdowns.

Take Islamnagar of Bhatera Union in Kulaura upazila, where markets and houses are being built by razing hills. As a result, more than 200 families of the area are forced to live amid risk of landslide.

Talking to this newspaper, locals alleged that despite complaints, the local administration remained indifferent.

Visiting different areas in Islamnagar recently, this correspondent found workers employed by the syndicate busy cutting hills and loading earth onto

They said that for the last few weeks, an organised group, consisting of Bhatera union residents Rahim Uddin, Bablu Mia, Azadur Rahman, driver Nur Uddin and more, have been cutting various hills in the area.

According to locals, Bablu and Azad were cutting soil from a hill owned by a UP chairperson in Islamnagar.

For a month now, the circle has also been cutting soil from the 40-foot hill, owned by one Eden Mia, a resident of Krishnapur village at Mymensingh.

There are 10 families living within 200 metres from the foot of the hill. They fear that the hill may collapse anyime and fall on their houses due to the ceaseless cutting of soil.

Contacted, Bablu Mia admitted to cutting the hill, saying, they aren't cutting the UP chair's hill in Islamnagar, but did admit to cutting the one owned

Asked, Eden Mia said, "The six-acre

hill in Islamnagar is owned by me and my three brothers. We've planted various trees there. Azir Uddin, an influential local in Islamnagar, is behind the hill cutting as he sells our soil."

Even after multiple protests, we couldn't stop it. We've never sold hill land to anyone."

However, Azir Uddin denied this and said, "I have nothing to do with the hill cutting."

All of this is worrying environmentalists and concerned citizens, who are urging authorities to intervene.

Abdul Karim Kim, executive member of Bangladesh Poribesh Andolon, said local influentials are ignoring existing environmental laws and defying the ban on hill cutting by the Department of Environment (DoE)

"Working in the shadows with government officials, they [the influentials] are involved in illegal hill cutting," he alleged.

Saheda Akther, coordinator of Bangladesh Environmental Lawyers Association, Sylhet unit, said, "As per the Environment Conservation (Amendment) Act 2010, hill cutting is a recognised offence and no government, semi-government or autonomous organisation is allowed to cut or raze hills, without prior permission from the authorities concerned."

Dr Narayan Saha, former head of forestry and environmental science department at Shahjalal University of Science and Technology, said unsustainable use of land and rampant hill-cutting are two major reasons behind the landslide vulnerability in hilly areas.

2 SSC examinees perish in road crash: 6 die across country

By this year, they would've been done with their SSC exams and become proud college students. To celebrate their last few days at school, they went to a picnic with their fellows, promising their parents to return home quickly.

But after their human haulier slipped into a roadside ditch, Ismail Hossain (16) and Saidul Mia (16) never returned home. The two SSC examinees were killed while 10 were injured from the accident that took place at Mamdamari area in Sreebordi upazila of Sherpur yesterday night.

The duo hailed from Kharia Kazir Char area. Quoting locals, Sreebordi Police Station OC Md Abul Hashim said the picnic party of 15 school students from different institutions in Sreebordi went for the picnic at Gazni in adjacent Jhenaigati upazila in the morning.

Police seized the vehicle but its driver managed to flee. A case was lodged in this connection. In another accident in Patuakhali, at least two people were killed and three others were seriously injured when a battery-run auto rickshaw collided head-on with a recklessly driven passenger bus at Ghutabacha area on the Patuakhali-Kuakata highway. The deceased autorickshaw passengers are Selim Talukder (47) and

Mohammad Bayezid (14). The accident took place around 8:00am yesterday. Witnesses believe the accident took place due to dense fog.

Roses gone, dreams dead

Virus attack leaves 1,500 flower growers of Golapgram in despair

AKLAKUR RAHMAN AKASH, Savar

This was supposed to be their time of the year. There's Pahela Falgun, then there's Valentine's Day, both occasions where people buy flowers to give to their loved ones.

But in such a crucial time, a wave of virus attacks has left rose farmers in Savar's aptly named Golapgram in despair. Since mid-December, the majority of them has been

unable to sell even a single rose from their gardens.

According to Savar upazila agriculture office, around 1,500 people from the village are involved in commercial rose cultivation, on nearly 275 hectors of land.

Rose farmer Abdul Oadud Mia (65), of Shampur area under

Golapgram, said he has been unable to sell anything this year. He farms on 75 decimals of land, and has been in this profession for $20\ years.$

"Every year, I sell 2-3 lakhs of roses ahead of Valentine's Day. I've spent around Tk 1 lakh to take care of my rose field this year, but all of it's been wasted due to the virus attack," he said.

Talking to The Daily Star, another farmer, Umed Ali, said, they've informed the matter to local agriculture officials, but they failed to take care of the issue. "We don't know if they're even trying to solve the problem," he added.

A water pump was also set up


here in the intersection for watering the garden spending around Tk one lakh, Amanullah said, adding that a temporary worker has also been employed for maintaining the garden.

Female students return to Afghan universities

UN hails move; journos released after Taliban detention

Afghanistan's public universities opened yesterday for the first time since the Taliban took over the country last year, with female students joining their male counterparts heading back to

The Taliban administration has not officially announced its plan for female university students, but education officials told Reuters women were permitted to attend classes on the condition that they were separated from male

A Reuters witness in the eastern city of Jalalabad saw female students entering via a separate door at Nangarhar University, one of the large government universities opening this

Under their previous rule from 1996 to 2001, the hardline Islamist Taliban barred women and girls from education. The group says it has changed since resuming power on Aug. 15 as foreign forces withdrew. But it has been vague on its plans and high school-aged girls in many provinces have still not been allowed to return to

Some private universities have reopened, but in many cases female students have not been able

A female medical student at Nangarhar University who asked not be named for security

reasons said that classes had already been separated by gender, but it was not clear if they were still able to be taught by male lecturers or interact outside the classroom with male students.

The international community has made education of girls and women a key part of its demands as the Taliban seek more foreign aid and the unfreezing of overseas assets.

The United Nations late on Tuesday praised the inclusion of female students at public universities, appearing to indicate official

"Let's all support the return of Afghan young female and male students to the universities across Afghanistan," the UN's Secretary General's Special Envoy for Afghanistan, Deborah Lyons, added in a Tweet.

"Supporters can consider a range of scholarship programs and ongoing support to female and male professors," she said.

Only universities in warmer provinces opened vesterday. Tertiary institutions in colder areas, including Kabul, are due to resume on Feb. 26.

Meanwhile, two Afghan journalists detained by the Taliban earlier this week were released yesterday, the news editor of their media organisation said. On Monday Ariana TV reporters Waris Hasrat and Aslam Hijab were detained by the Taliban, according to the Afghan Media Association.

Gas, nuclear get EU nod as green power

The European Commission yesterday defied protests from green campaigners and dissent in its own ranks to give a sustainable finance label to investments in both gas and nuclear power.

Opponents of gas want to discourage investment in a fossil fuel technology they say only fuels the climate change crisis, while critics of nuclear energy point to the threat posed by accidents and nuclear waste. But the EU executive, under pressure from nuclear-powered France and gas-reliant Germany, argues that both have a role to play as cleaner power sources during the transition to a net-zero carbon future.

"The end is a lowcarbon future powered by renewable energy. We do not have the capacity for that yet, but we still need to act urgently with all the means at our disposal," EU commissioner Mairead McGuinness said.

Mamata reelected as TMC chief

West Bengal Chief Minister Mamata Banerjee was re-elected Chairperson of Trinamool Congress party and urged all regional parties to put up a united front against the BJP in the 2024 general elections. Amidst differences within the party, she urged TMC leaders and workers to be united. She said TMC has to fight hard to win all the 42 Lok Sabha seats in the next polls in West Bengal. According to TMC Secretary General Partha Chatterjee, Banerjee was declared elected without a contest as no other leader entered the fray.

US to send warship, fighter jets to UAE

AFP, Dubai

The United States will send a warship and fighter jets to help defend the United Arab Emirates, officials said on Wednesday, after a series of missile attacks by Yemeni rebels left three dead in the wealthy Gulf state. The deployment, to "assist the UAE against the current threat", follows a phone call between Defence Secretary Lloyd Austin and Abu Dhabi Crown Prince Mohammed bin Zayed Al-Nahyan, the US embassy in the UAE said. The UAE, part of the Saudi-led coalition fighting Yemen's Iran-backed Huthi rebels and a major financial hub, suffered its third missile attack in consecutive weeks on Monday.



Shootings at US schools kill 3

Two campus police officers were shot and killed at a college in the US state of Virginia Tuesday, while one student was killed and another wounded in a shooting at a school in Minnesota the same day. The two officials were shot and killed around 1:30 pm at the Bridgewater College in Virginia. The suspect, a 27-year-old man named Alexander Wyatt Campbell, was later apprehended. He has already been charged with murder, police said. The motive behind the killing was not immediately known. The shooting in Minnesota occurred in the town of Richfield just outside of Minneapolis around noon, officials said, leaving one student dead and another wounded. The attackers opened fire on the students on a sidewalk outside the South Education Center before speeding away in a car. Two suspects were later arrested. President Joe Biden, who has called on Congress to enact tougher gun control laws, tweeted about the shooting, saying he and his wife "are praying for the families of those lost."

Indian officials have held heated discussions with Google, Twitter and Facebook for not proactively removing what they described as fake news on their platforms, sources told Reuters, the government's latest altercation with Big Tech.

The officials, from the Ministry of Information and Broadcasting (I&B), strongly criticised the companies and said their inaction on fake news was forcing the Indian government to order content takedowns, which in turn drew international criticism that authorities were suppressing free expression, two sources said.

The sources, who were familiar with the proceedings at the virtual meeting on Monday, described the conversation as tense and heated, signalling a new low in ties between American tech giants and Prime Minister Narendra Modi's administration.

The officials did not issue any ultimatum to the companies at the meeting, the sources said. The government has been tightening tech sector regulations but wants companies to do more on content moderation.

The meeting was a follow-up to the I&B ministry's use of "emergency powers" in December and January to order the blocking of 55 channels on Google's YouTube platform, and some Twitter and Facebook accounts.

Spare us from the crushing blow of price hikes

Govt must find better alternatives to handle subsidy pressure

T is worrying to know that the government is considering raising the prices of electricity, gas and fertilisers by March, in a bid to offset the pressure of subsidies in these sectors. If it decides to go ahead with the move, not only will it increase production costs and affect the consumers of these products, but eventually it will have a knock-on effect on the prices of daily essentials, raising the overall cost of living. Ordinary citizens, especially the poor and low-paid, are already under tremendous pressure. Inflation hit 6.05 percent in December—the highest in 14 months—overshooting the government's target of 5.30 percent for this fiscal year. Food inflation was the highest in six months, while nonfood inflation came close to 7.05 percent.

According to a report by this daily, the prices of electricity and gas could see a rise by February, while fertiliser prices may go up by March. The bid comes two months into the kerosene and diesel price hikes, the effects of which we have already witnessed. A section of officials in favour of another round of hikes believes that a "price adjustment" in the face of spiralling prices in the international market is necessary to bring the government's subsidy burden down to a "tolerable limit." They think it will help ensure funds for urgent health emergencies, like procuring additional Covid-19 vaccines and booster shots, increasing rice procurement to save farmers from incurring losses, continuing development activities, and so on.

All good points, but why wring extra money out of the public purse? It is not only politically injudicious in the last year of this government's tenure, but also an unnecessary burden the public could do without. We understand that different ministries have already sent in requests for additional subsidies to absorb the spiralling international prices. The finance ministry is reportedly reviewing the proposals and will come up with a revised budget by March. The authorities may try to lessen the subsidy burden by increasing the prices of electricity, gas and fertilisers, but we think they need to take a step back and find a way to recuperate from the losses without pushing people under the train.

Since Covid-19 is likely to continue interrupting supply chains and shooting up international prices for some more time, high inflation may continue to be a reality. But instead of sticking to raising prices, the government should think of cutting costs in other wayslike saving money lost in systemic failures, corruption and inefficiencies, establishing greater accountability, discarding or putting on hold money guzzlers like inessential development projects, etc.

Whatever the government decides to do, the solution does not lie in putting the burden on the public. The pandemic has already caused immeasurable sufferings and hardship to people, pushing a vast number of them beyond the poverty line. Unemployment has reached an alarming level. People are already struggling with the rising healthcare costs. Another round of price hike is the last thing they need.

Barishal airport needs a facelift

Authorities must start renovation work without delay

HE fastest way to travel to and from Barishal is by air. This southern district in Bangladesh has immense business prospects for the traders, and many prefer to travel by air as commuting by roads may take almost the entire day—especially if you're travelling from Dhaka. But the sole airport in the district, which began commercial flights in 1995, lies in a sorry state with its terminal and runway needing immediate repairs. It is mystifying as to why the civil aviation authority let the airport slide to its present poor condition, which may put the life of passengers and airport crew in jeopardy

According to our report, a high-level team of experts appointed by the civil aviation ministry prepared a report after visiting the airport on January 3. The team came to notice that landing aircrafts at the Barishal airport was a risky undertaking as the runway and other nearby structures were in a dilapidated condition; the terminal building was in a poor state and the runway was unprotected because of trespassing. The team also found that 75 metres of the northern end of the runway was being severely eroded by the Sugandha River. Experts are of the opinion that if the ongoing trend of erosion

continues, landing and take-off will become quite risky. We understand that the report made some important recommendations like starting repair and maintenance work of the entire terminal building, repairing asphalt surfaces of the runway, and constructing security walls around the airport. The expert team also recommended taking immediate measures to protect the airport from river erosion by coordinating with the water resources ministry, especially the Water Development Board.

Considering the significance of the airport from the perspective of business and tourism, the relevant authorities must not waste time to undertake the recommended measures, as experts have acknowledged the risks of mishaps occurring any time. There should not be any opening in the boundary wall for humans or animals to enter the airport, and it needs to be protected from river erosion. We hope the probe team report would sound the alarm bell for the higher authorities to start the renovation works on an urgent basis.

The ACC has said that it has been facing limitations in tracing the launderers along with the smuggled money, and had apparently requested information from the BFIU and the home and foreign ministries, but to no avail. Why? The foreign minister has shrugged off the responsibility, saying it's not the foreign ministry's job to find information about money launderers or their actions. Whose responsibility is it to gather such intel, then? Logic would say, the BFIU.

The lists submitted have exposed two major bottlenecks in our fight against money laundering: lack of synergy among the agencies that are supposed to be working together on the problem, and an apparent lack of ownership of specific agencies in delivering their work properly.

If we talk about specific agencies, we need to look at certain factors. Do these agencies have the right resources and logistical support to engage in intel gathering and carrying out investigations? Is there any form of lacking in their technical or institutional capacity which needs to be addressed? Or is it just a case of complacency or a lack of political will?

And why is there such a brazen lack of coordination? Are these agencies not working towards the same goal? Are they under pressure from any vested interest

It is baffling how so many responsible agencies have failed to provide concrete and comprehensive information on money smugglers whose names and faces we are familiar with.

"Money laundering is a complex and sophisticated crime. More importantly, since those involved in money laundering are not only smart, but also usually privileged and powerful people, a right combination of political will, technical skill and multipronged collaborative efforts is needed to combat it. Thankfully, the national and international legal and institutional potentials to confront money laundering have become much stronger and systematic than before. That ensuring accountability for money laundering is not impossible was already demonstrated in Bangladesh, when a high-profile, politically linked person was held to account and laundered money were repatriated from Singapore. That being said, the relevant agencies mandated to prevent, control and prosecute offences of money laundering just need to have the will, courage and skills to go to the drawing board to track the process through which that success was achieved, and try to replicate the example in collaboration with each other. Whether or not there is sufficient courage and commitment to take money laundering head-on remains an open question," said Dr Iftekharuzzaman, while speaking to this writer on this issue.

Whatever obstacles our agencies are facing in tracing the money and the criminals need to be overcome for the greater well-being of the nation and our economy. The High Court has asked the BFIU to submit the names of Bangladeshi citizens who have deposited money in foreign bank accounts, including the Swiss banks. At the same time, the court has asked the ACC and the Criminal Investigation Department (CID) of police to submit the progress report on the investigation into allegations of money smuggling against Bangladeshi nationals mentioned in the Panama and Paradise

One hopes that the agencies concerned would rise above their individual agendas and challenges, and work as a team to fight this malady together. We cannot and must not allow criminals to plunder and loot the common people's money and get away with it, no matter who these individuals are, whatever their political connections are. Money launderers are criminals and must be brought to book as per the laws of the land. We must do all we can to support the High Court in its endeavour to hold these culprits

According to Debapriya Bhattacharya, a member of the UNCDP and a distinguished fellow of the Centre for Policy Dialogue (CPD), Bangladesh may experience shortfalls equivalent to 8-10 percent of its gross export revenue due to its loss of the DFQF provisionamounting to about USD 2.5 billion

Bangladesh will also lose the advantage of a Generalised System of Preferences (GSP) under the WTO. As an LDC, Bangladesh enjoyed the privilege of the Trade-Related Intellectual Property Rights (TRIPS) waiver, which contributes enormously to the progression of the country's pharmaceutical industry. The waiver for patent authorisation will be curtailed once the country

graduates. Moreover, Bangladesh will lose its eligibility for accessing grants and soft loans under official development assistance (ODA).

Bangladesh might also effectively succumb to the "Dutch disease," due to its heavy economic dependence on the RMG sector. So, to prevent this aftermath of the graduation, Bangladesh will have to craft a host of comprehensive approaches: keep signing more FTAs and PTAs, explore more diversified markets, and not put all its eggs in one basket.

Beyond existing trade-related relational mechanisms, Bangladesh needs to prepare an extensive overseas market strategy, exploring diverse markets across different regions. Joining other trade blocs and signing bilateral and multilateral FTAs will mitigate trade-related complications such as tariffs, quotas, subsidies, or prohibitions, and facilitate further trade relations and expansion. It is also crucial for Bangladesh to diversify its export basket with leather goods, frozen food, etc.

So far, Bangladesh has only inked a bilateral PTA with Bhutan on December 6, 2020 and is considering signing more PTAs with several countries including India, Indonesia, Malaysia, and Sri Lanka. In order to substitute the soon-to-begone privileges, the current FTA domain must be expanded to engage as many countries as possible.

Given Bangladesh's lucrativeness as an emerging economic power within the Saarc trade bloc and its 165-millionpeople market, an FTA with Bangladesh will potentially be a stepping stone for Russian and other EAEU businesses and investors to have access to other South Asian markets. And most importantly, with its unique geographical position and easy accessibility to global maritime trade routes, Bangladesh could work as a central trade and manufacturing hub for South Asia and beyond. Thus, an FTA between Bangladesh and the EAEU could be a mutual win for both parties, meaningful progress and prosperity for the people in both regions, and for the world as a whole.

Children are to be nurtured, not tortured

SHAHEEN ANAM ANY societies have their own sources of shame. Genital I mutilation, honour killing, sexual abuse of children in religious institutions—there are many such practices that go against all norms of a civilised and humane society. What is ours? I can think of at least two: child marriage and child labour. I call them shame as both are condoned and enjoy social acceptance, yet violate the fundamental principles of human rights and dignity—the right to a life of freedom

The IGI Global, which conducted research on child labour with the support of the International Labour Organization (ILO), estimates that there are 420,000 child domestic workers in Bangladesh, of whom 83 percent are female, and 132,000 work in Dhaka city.

The government has committed to phase out child labour in Bangladesh and enacted a policy to this end in 2010, and issued an order in 2013 prohibiting all children under 18 years of age from working in 38 identified hazardous jobs. However, there is no implementation of this regulation as children continue to work in hazardous and dangerous situations, such as welding, in biri factories, as helpers in human hauliers, stone-cutting, etc. As for domestic work, it did not even make it to the list of hazardous work. Child rights experts, on the other hand, say that child domestic workers are particularly vulnerable as their work is inside people's homes and evades scrutiny from the authorities or those children's families. It is unregulated and unmonitored, leaving children at the total mercy of their employers. Parents with low income hand over their children, often as young as eight, to work in middleor lower middle-class households in the hope that they will be looked after, at least get better nutrition, and also contribute to their families' income.

Alas! Contrary to their expectations, domestic child workers face regular abuse and neglect. The abuse ranges from overwork, insufficient food, no recreation or education, etc to unspeakable torture such as sexual violence, severe beating, starvation, burning, scalding with hot

As per reports compiled by rights organisations such as Ain o Salish Kendra (ASK), Manusher Jonno Foundation (MJF), Bangladesh Shishu Adhikar Forum, etc. in the last five years, at least 200 child domestic workers were found dead in their employers' homes. Meanwhile, 365 were tortured physically, and 62 girls were sexually abused. In 2020-2021, as per reports compiled by MJF from six newspapers, 44 child domestic workers were victims of torture, of whom 16 died, and four died by suicide. Unless there is severe injury or death, such cases are not reported, nor are criminal cases filed. Only 30 percent of the cases of such torture are filed, with no known example of perpetrators ever getting punished for such heinous crimes against children.

The recent case of Farzana, a domestic worker aged 17 years, employed by a banker's family in Kalabagan, Dhaka revealed that physical and mental abuse can continue for years without anyone knowing about it. She suffered continuous torture for seven years, after which she finally sought help. Her

entire body shows marks of old and new wounds. She is now lying at a hospital, undergoing treatment. Her parents have filed a criminal case, but the perpetrator is already out on bail.

This is not a one-off incident. We read about such inhuman acts inflicted by members of the so-called educated or elite class on their domestic helps every so often. In November last year, little Tania, an eight-year-old child from Fulbaria. Mymensingh, was found with blade cuts all over her body. Daughter of a poor tea seller, she was hired as a household help for a monthly salary of Tk 1,000. A criminal case was filed, but again the perpetrators are out on bail. Last year, the 44 reported cases of torture inflicted on child domestic workers all tell the same story of brutal assault, starvation, scalding with hot water and iron, and so on. Medical help was given only when the child faced imminent death. Criminal cases were filed against some, but no one has faced any punishment for their act of such extreme cruelty.

Reports of suicide or attempted suicide by adolescent female domestic workers are common. Most are found hanging from the ceiling fan. Investigation into the cause of suicide is mostly inconclusive without enough evidence to file criminal cases. There is, however, strong suspicion of sexual assault by male employers.

As is obvious, the unreported cases outnumber the reported ones. No one takes notice unless the torture is severe, and the victim lands in a hospital or is dead. Cries for justice go in vain. Not a single perpetrator accused of torturing domestic help has ever been convicted. Being economically solvent, perpetrators are able to prevent cases from being filed or negotiate with the victims' families, who are too poor and powerless to continue with the cases and usually agree to out-of-court settlement.

The government has committed to eliminate all hazardous work by children by 2024 and completely eliminate child labour by 2030. By all standards, setting a deadline that is years away indicates the lack of urgency in implementing any system or policies that will end child labour soon. In the meantime, children continue to fall prey to predator employers, who think they own them and can do whatever they want.

What can we do to make child labour socially unacceptable? What kind of campaign will result in putting to shame those who employ children and mistreat them? The narrative that our socio-economic situation will not permit elimination of child labour has gone on for too long. But why should children pay the price of our inability to build a society where everyone's basic needs are met? When will children enjoy the fruits of our so-called middle-income country status?

The government should consider expanding the social safety net programmes for parents who are forced to send their children to work. An important first step is to address the invisibility of child domestic workers, because once they enter the homes of their employers, they lose all identity and often their parents are not allowed to visit them. They should be registered with the social welfare department, and given ID cards with a hotline number to call in case of emergency. The social welfare department can also organise spot visits on a trial basis to at least give the impression that there is a system in place to monitor how these children are being treated.

The other issue is that of justice. If the law is supposed to work for everyone, then how come not a single case filed against these cruel employers of child domestic workers has ever resulted in conviction? This has given the message that they will not be held to account, no matter what

cruelty they perpetrate on these children.

But a more fundamental question is: What drives normal people to such acts of cruelty? How can people—couples with families—have such double standards of adoring and protecting their own children, but slap, pinch, or worse, starve and burn others' children with hot iron? I don't think we have the answer; perhaps this phenomenon needs further study.

Finally, many of us dream of the kind of society we want. Mine is the following: The mention of "child labour" is greeted with astonishment. "Child labour! What is that? How can the two words, child and labour, go together? The only words that can be associated with children are laughter, playfulness, naughtiness, and joy!"

Is this my wishful thinking, or can it be a reality some day?

BOOK REVIEW: FICTION

In which Muslims are not "radicals"

The novel follows the story of one Palestinian-American Afaf, who is the head of Nurideen **School for** girls in Chicago. One fateful day, a white supremacist shooter attacks the school and has a chance encounter with her.

Too often, the representation of Muslims in arts and culture has been tainted by the shadow of "extremism". If a young man or a woman in a book decides to convert to Islam, we eventually see them trekking across Syria to join ISIS. A Swedish Netflix series, *Caliphate*, and Fatima Bhutto's novel, *The Runaways* (Viking, 2019), are glaring examples. Another, less severe, example is Tahmima Anam's novel, *The Good Muslim* (Harper, 2011), where Sohail's devotion to Islam is viewed through a negative lens to such an extent that I felt like it was designed to pander to a Western audience.

Sahar Mustafah's novel, *The Beauty of Your Face* (WW Norton & Company, 2020), shatters this longstanding image that many tend to associate Islam with. It was the first time I read such a narrative, with an authentic representation of Islam and Muslims, and it felt like a breath of fresh air.

The novel follows the story of one Palestinian-American Afaf, who is the head of Nurideen School for girls in Chicago. One fateful day, a white supremacist shooter attacks the school and has a chance encounter with her. The novel is concentrated mostly on the trajectory of Afaf's life up until that point; we discover

who her parents are and how their relationships strain with their children in the face of dire circumstances, such as the disappearance of Afaf's sister, Nada. We get to see how these people attempt to fit into the social fabric of an American life that always spits them out.

Afaf's father has a long stint with alcohol following Nada's disappearance. When he stumbles across Islam as his sanctuary, he ropes Afaf into this new journey. Comfort and healing descend on them, while it does not have the same effect on her apathetic brother and bitter mother. In hindsight, I can easily see how Afaf and her father's journey into Islam could come off as treading on radicalism. While the author makes it a point to show reluctance to embrace religion so wholeheartedly, her approach is still balanced and nuanced. In that her primary focus is to portray how religion can be an unshakeable refuge.

One will find solace from how accurate the representation of religious practises is in this novel: from accepting the decrees of God, to perseverance in facing life's challenges, to the daily mandatory prayers, to performing Hajj, and other essential Islamic rules and rituals. Although there are parts that a faction of practising Muslims might find debatable—such as Muslims

celebrating Thanksgiving and Christmas, and receiving piano lessons in an Islamic school the novel succeeds in turning internalised Islamophobia on its

Yet, another strong point of the novel is Mustafa's decision to give the shooter a brief backstory. Through the subplot, readers get a glimpse at why anti-Islamic sentiments run rampant in the US, and the plotpoint can also be interpreted as the writer's attempt to unveil America's hypocrisy in its intervention into the Middle Eastern foreign policy—how it unleashed long spells of violence and disasters in the name of human rights, and at the same time bred supremacists like the shooter represented in the book.

The Beauty of Your Face is a lesson not only in writing about a healing Islamic experience but also in approaching a clever structure for storytelling. The novel swings back and forth from Afaf and her family's past to scenes of the shooting in Nurideen School for Girls. This lends the story a sustained layer of suspense, one that keeps readers glued until the end.

The Rohingya conflict: A critical look from a global and regional lens

Edited by Kudret Bulbul, a professor of Political Science and Public Administration at Ankara Yildirim Beyazit University, Turkey, Md Nazmul Islam, a Bangladeshi who teaches at the Ankara Yildirim Beyazit University, and Md Sajid Khan, a research scholar in the Department of Social Work at Hacettepe University, Ankara—Rohingya Refugee Crisis in Myanmar: Ethnic Conflict and Resolution (Palgrave Macmillan, 2022) observes critical aspects of the crisis that has seen over 1.3 million Rohingyas seeking shelter from Rakhine in Bangladesh.

In the introduction and also its first chapter, Abdur Rahman Fuad and Ali Dadan dive deep into the origin of Rohingyas and the glorious past of the Muslim Kingdom in Arakan. The second chapter touches upon genocide, forced migration, and forced labour from a global perspective with regards to international law. In contrast, the third chapter narrows down in its discussion of forced migration and human trafficking in context of the Rohingya refugees in South Asia.

The work in its entirety discusses the current as well as a hypothetical future for Rohingyas. The authors propose practical approaches to resolving an ethnic conflict of this magnitude. They have tried to consider the crisis as an international issue played out by two Asian giants, namely India and China, and a number of chapters deal with the Indian policy and realpolitik for the world's most persecuted refugees and interest in the Rakhine state of Myanmar. Asif Bin Ali critically develops the Myanmar government's policies and politics against the Rohingyas. And Sariful Islam analyzes

the interest of the present Government of Bangladesh in terms of hosting Rohingyas as a humanitarian response.

The book has some flaws, however. While it does cover a wide range of topics, a significant number of the essays have been written by the same writers, including the editors themselves. Therefore, the discourse seems to create a bubble of ideas that could have been avoided by including more authors. Second, the organisation of the book has not been well planned out. And while some of the chapters have solid theoretical and empirical basis, the rest merely gather information that lacks any solid analytical support.

Conversely, the authors seek to analyse the grave issue under the theme of media representation in Bangladesh and India. In addition, the role of western countries, particularly in providing foreign aid through INGOs and NGOs, has been presented in the last two chapters of the book, along with accounts from the perspective of Rohingyas.

In its consideration of the nationalistic politics of the Myanmar government, the authors have shown how Bangladesh has become one of the primary victims of the crisis; in various capacities, they propose, Bangladesh has even made political profit out of the situation. Because of its various tools for analysing the problem, this book can be referred to for history, politics, sociology, international relations, and media studies.

"Mother's Milk" by Tahmima Anam: Anatomy of a mother's pain

In this monthly series, we review short stories that deserve to be rediscovered and appreciated.

In "Mother's Milk", a short story by Tahmima Anam which appears in *Our Many Longings: Contemporary Short Fiction from Bangladesh* (Dhauli Books, 2021), an unnamed narrator gives us brief snatches of her life as she attempts to endure...something. One can't really call it an incident; it is, seemingly, more a state of being that requires her to keep joy at bay. Consciously, deliberately.

As her "friend" in this project of endurance, the narrator seeks refuge in the newspaper, in the stories of refugees, dead babies, floods, hunger, and poverty that it brings to her everyday. They allow her to flit from flashes of pleasure and peace back to misery, even as her husband, mother, and in-laws attempt to shift her from home to (her husband's) workplace, from her own life to that of her brother's, where things look cheerier. All of these things—and more—are told to us in very brief scraps. Bearing them into one flowing, narrative

whole is the narrator's breast milk, which flows and flows, dampens her blouse during a board meeting, smears her green salwar kameez on a trip to Mymensingh, a flow that seemingly nourishes no one.

Like this outpour of milk (and maternal instincts, and the solace to be found in newspapers), many things in this short story are left open and lopsided and inexplicable, which makes reading it a distinctly different experience from those associated with the Golden Age trilogy, or the more recent, The Startup Wife (2021). Those stories came with plots, with characters who communicated their personalities and desires to the reader with clarity. Here, the metaphors aren't what you think they're about; the parallels to be drawn between characters and motifs don't quite add up in neat little boxes; grief, as in real life, looks and feels different on each new day.



Each sentence carries its own little grievance bitterly, tightly retold. Each paragraph, sowing these sentences together, tells the story of a different experience in the narrator's daily life. And Tahmima Anam shuffles these paragraphs around so deftly that the contrast, the juxtaposition of incidents, bares to the

reader a particularly raw, pink layer of the narrator's pain. It has just stopped stinging, but it will again, in a matter of seconds.

Through this hopping from pain to pain, we learn mid-way through the story that the woman has recently lost her newborn child. The incident reveals many things. How "decent" a man her husband is for not leaving her. How motherhood feels for a fleeting second. How grief is a darkness with agency: you could be "listening to music or browsing through old photographs. You haven't engaged

in risky behaviour by daring to read a book"; but it can visit you unannounced and balloon your personal pain into the pain of every suffering individual on the planet, so that you find solidarity not with another struggling mother, but with a bull that has been failing to ejaculate semen for the narrator's husband's business.

This encounter with the bull—the

way his ability to breed is labelled as "productivity" (or lack thereof)—allows the narrator to take one fragment of a step towards reconciling with her pain. At the same time, it lands her on the cusp of reflecting on the mechanical, capitalist lens through which society looks at those who procreate.

In the first sentence of "Mother's Milk", the narrator specifies that the newspapers that so helped her, do so "in black and white". Later in the story, in a fit of rage mentioned almost-too-casually in passing, she bites a newspaper into shreds with her teeth. Underneath the calm that narrates this tale of trauma, there appears to be a clawing need to rip through the absolute blacks and whites of a human's, a woman's, and a mother's experiences, and let the shades of red burst forth.

Archery's plea to football

The Bangladesh Archery Federation (BAF) urged the Bangladesh Football Federation (BFF) yesterday to coordinate with them before allotting their Bangladesh Premier League matches at Shaheed Ahsan Ullah Master Stadium in Tongi, which has been exclusively used for the archers for the last eight years.

The BFF vesterday disclosed the 66-match first phase of the professional football league starting today by keeping three matches per week (overall 33 matches) at the Tongi stadium but the BAF protested the BFF

"If the BFF holds 33 league matches at the Archery centre, then we have to lose 75 percent training time of the national archers, who are preparing to take part in Asian Games qualifiers in March and World

Cup in April,' said BAF president Lt Gen (Retired) Mainul Islam at a press conference, hurriedly arranged at the BAF office at Maulana Bhasani Hockey Stadium. "We received the

schedule of football matches this afternoon but the BFF did not discuss the schedule with us, even though the allotment letter from National Sports Council (NSC) clearly asked the football federation to coordinate the matter with the local administration and Bangladesh Archery Federation.

"NSC had allotted the stadium only for the archery federation in 2014 and we have fixed everything like water, electricity, security, cleansing and paying bills every month since. Who will take care of these things if football is played here?" informed Islam while adding they would also be questioned by the sponsors if they are unable to continue the training camp and ranking tournament.

Kings begin title defence as BPL kicks off today

Amid the drama over venues, the Bangladesh Premier League (BPL) is all set to get underway today at two separate venues outside Dhaka.

Title holders Bashundhara Kings will take on newcomers Swadhinata Krira Sangha and runners-up Sheikh Jamal DC will play against Uttar Baridhara Club.

Following the unavailability of Bangabandhu National Stadium and participating teams' unwillingness to play on sub-standard turf at the Birshreshtha Shaheed Mostafa Kamal Stadium in Kamalapur, the selection drama over the venues for the professional football league drew concerning attention as the professional league management committee kept changing their decision time and again during the past week.

Although six venues were allocated to play the home-and-away basis matches initially, the sudden surge of coronavirus forced the management to change the initial plan to three venues without a home ground concept.

The committee proceeded to cancel Kings' home ground Bashundhara Kings n just less than 48 hours befor the league set to kick off, leaving only two venues to host the league matches. In addition, the Bangladesh Archery Federation also protested against the use of Tongi stadium without consulting

Apart from the dispute over the venues, the 14th edition of the professional football league is expected to be much more competitive, largely due to the presence of four to five equal-strength sides while the lightweights have already shown their prowess in the recently concluded Independence Cup and Federation Cup.

Nevertheless, two-time professional

league champions Kings will be looking forward to taking the hat-trick league title home after failing to defend the Independence Cup and missing in action during the Federation Cup.

There is no question over the ability of Kings, who established their sole dominance in the domestic circuit by winning five consecutive trophies in the last three seasons but they have a few injury concerns before the start of the

Kings' Spanish coach Oscar Bruzon

Kings by beating them 3-0 in the final of Independence Cup, their first win over Kings in the last three years.

Abahani then kept their winning momentum intact in the Federation Cup to win back-to-back titles and have set their sights on a rare treble in a season, which was achieved by Sheikh Russel KC in the 2012-13 season.

Even though it looks like a two-way battle between Kings and Abahani is on the table, however, it would not be surprising if big-budget Sheikh Russel,



said, "It's a matter of time [when BPL is ready to start and opportunity that Kings will be contesting for the 3rd consecutive BPL title and the AFC Cup final stage. After Nazimuddin's speech at Paltan Maidan (January 27, 1952), I called a meeting of the representatives of all political parties and student organisations t the Dhaka Bar Library. Maolana Bhasani presided over the meeting. All

Party State Language Action Committee was formed at that meeting. The Committee called a strike at all educational institutions in Dhaka on February 4, 1952. We observed Flag Day on February 10. This was done

for raising funds and ensuring mass publicity. Most likely, it was in preparation for the general strike to be held on February 21. The session of the East Pakistan Provincial Assembly was scheduled to begin on the same date and the date for a strike was fixed keeping that in view.

After the promulgation of Section 144 (February 20, 1952), an emergency meeting of the All Party State Language Action Committee was called on the evening of February 20. The question of breaking section 144 the next day was the main topic of the discussion. Abul Hashim presided over the meeting.

Opinions on the violation of Section 144 were sharply divided. The kind of argument I and a few others made was that whether we should break Section 144 depends on the strength of the movement, not just in Dhaka, but

20 journos hurt as UP chair's men attack

At least 20 journalists on duty were injured during an attack on the district court premises in Barishal yesterday.

The relatives and associates of Darial Union Parishad Chairman Shahidul Islam Hawlader attacked the journalists as they were gathering information on the chairman being sent to jail in a fraud case.

Around 200 people, including the chairman's relatives, associates and his lawyers' assistants, attacked the journalists and vandalised their cameras and motorcycles, said witnesses.

The attackers hurled bricks at the journalists, leaving one critically injured. Some 13 more were hospitalised with injuries.

Azimul Haque, officer-in-charge of Kotwali Model Police Station, went to the spot and brought the situation under control as the deployed policemen on the court premises fell short to revive the crisis.

The law enforcers, however, did not arrest anyone in connection with the attack.

They will take legal actions after a proper investigation if a complaint is filed in this regard, the police official said.

According to the court sources, a Barishal court sent five people, including the chairman, to jail on charges of land fraud in their area.

The journalists took positions on the court premises to collect the news, but the police did not allow them first. As they continued their work defying the restrictions, they were attacked.

ICJ GENOCIDE CASE Myanmar NUG drops objections

Myanmar's shadow government, set up after last year's military coup, said it accepts the jurisdiction of the International Court of Justice (ICJ) to hear allegations that the country committed genocide against its Rohingya minority.

Before the military seized power last year, Myanmar's government led by the now-ousted Aung San Suu Kyi had filed preliminary objections to the ICJ over the case brought by Gambia in a move to delay proceedings.

The National Unity Government (NUG), a parallel administration including deposed lawmakers in exile, said in a statement issued on Tuesday that it had withdrawn all preliminary objections to the case.

Still, it is not clear whether this would affect the legal process since the NUG said that through a "bureaucratic idiosyncrasy" the ICJ has been communicating with Myanmar diplomats in

Brussels who were under the control of the junta. "Should the ICJ recognise the military, it would embolden the junta to continue and escalate its daily atrocity crimes," the NUG said.

It urged the ICJ to deal with Myanmar's permanent representative to the United Nations, Kyaw Moe Tun.

The ICJ did not immediately respond to a request for comment and a spokesman for Myanmar's junta did not answer a telephone call seeking comment.

US trying to lure Russia into war Says Putin amid Ukraine crisis

Nato leaders pursued diplomatic efforts on the Ukraine crisis yesterday after President Vladimir Putin accused the West of trying to draw Russia into a war but left the door open to further talks.

British Prime Minister Boris Johnson was to talk by phone to Putin a day after visiting Kyiv, where Dutch Prime Minister Mark Rutte was the latest Nato leader to visit in shows of solidarity with Ukraine.

Recent weeks have seen a flurry of diplomacy to avert a feared Russian invasion of Ukraine, after Moscow amassed troops on the pro-Western country's borders.

Western leaders have warned that any attack would be met with "severe consequences" including wide-ranging economic sanctions. In his first major remarks on the crisis in weeks, Putin

on late Tuesday accused the West of ignoring Russia's demands and suggested Washington was using Ukraine as an instrument to potentially draw Moscow into a

"Ukraine itself is just a tool to achieve this goal" of containing Russia, Putin said at a press conference with the Hungarian leader.



Man dies by suicide on Facebook live
