

## Baitul Mukarram khatib passes away

Prof Maulana Muhammad Salahuddin, khatib of Baitul Mukarram National Mosque, died at a city hospital yesterday afternoon. He was 78.

After falling sick in the afternoon at his Jigatola residence, Salahuddin was rushed to Lab Aid Hospital. Doctors later declared him dead at around 4:00pm, said sources at the religious affairs ministry.

He has been suffering from old-age complications, Islamic Foundation said in a press release.

Salahuddin left behind his wife, three daughters, one son and a host of relatives and well wishers to mourn his death.

He was appointed the khatib of Baitul Mukarram Mosque in 2009. He was also chairperson of sharia council at various banks and financial institutes.

His first namaj-e-janaza will be held at the Baitul Mukarram mosque after Juma prayers today.

The second and third janaza will be held in Jigatola and Mirpur respectively.

He will be buried in Mirpur.

President Abdul Hamid, Prime Minister Sheikh Hasina, ministers and state ministers expressed profound shock at his death.

At noon, we could not stop the crowd. The Assembly session was about to start. Everyone wanted to go that way. Everyone left hurriedly. We reached the medical college hostel.

Police fired tear gas shells which were like hand grenades. One of those did not explode. Students brought it to us. We were inside the medical barracks. They said they would throw the tear gas shell back. We did not say anything about it. We were wondering what could be done. I later heard that police fired shots at the protesters after the latter threw the shell. I also remember hearing shots a few minutes after the students came to us.

I didn't go home that night. I went underground. Police issued warrants against eight of us, including Oli Ahad, Kazi Golam Mahub and Matin.

Soon after the police firing, [Maulana Abdur Rashid] Tarkabagish, Khairat Hossain, Khan Saheb Osman Ali, Anwar Khatun, and Kushtia's Shamsuddin Ahmed walked out [of the East Pakistan Provincial Assembly] and joined the protest.

Next day, a spontaneous movement was waged and a strike was enforced. It turned out to be a mass protest. People hanged placards containing names of Nazimuddin (then prime minister of Pakistan) and

Today is the 25th death anniversary of Dr AR Mallick, an eminent educationist and the first technocrat finance minister of the country.

He was a professor of South Asian Regional Studies at the University of Pennsylvania, USA, in the early 1960s, and was the founding vice-chancellor of Chittagong University.

He was also president of the Liberation Council of Intelligentsia, the first education secretary and the first high commissioner to India.

He was elected chairman of ADB.

His publications include "British Policy and the Muslims in Bengal" and "Amar Jibon Kotha O Bangladesher Mukti Sangram". Bangla Academy published "Dr AR Mallick Sharak Grontho", comprising articles by renowned personalities from home and abroad.

Besides, Dr AR Mallick Lecture Hall has been established in Dhaka, Rajshahi and Jahangirnagar universities.

On the occasion, a milad will be held at his ancestral home in Rajapur.

● Experience of working under donor funded projects will be an added advantage;

● The consulting firm shall have sufficient and relevant managerial, financial and organizational capabilities and logistics for the assignment;

Key Experts will not be evaluated at the shortlisting stage.
