

# Short time, tough task

Justice Obaidul Hassan at the helm of the panel under EC law

STAFF CORRESPONDENT

President Abdul Hamid has formed a six-member search committee, led by Justice Obaidul Hassan, in line with the new law on forming the Election Commission.

The search committee has six working days to recommend names to the president for the appointments of the chief election commissioner and other commissioners as the tenure of the current EC, headed by CEC KM Nurul Huda, expires on February 14.

Justice Hassan, a Supreme Court judge, was a member of the previous search committee constituted in 2017.


The other members are Justice SM Kuddus Zaman, a High Court judge, Comptroller and Auditor General Mohammad Muslim Chowdhury, Public Service Commission Chairman Md Sohorab Hossain, former election commissioner Sohul Hussain, and psychiatrist and writer Anwara Syed Haq, according to a gazette issued yesterday.

The committee will perform its duties in accordance with the 'Appointments of the Chief Election Commissioner and other Election Commissioners Act-2022", the gazette said, adding that the Cabinet Division would provide all necessary assistance to it.

The gazette came nine days after parliament passed the law amid protests from opposition lawmakers.

Talking to The Daily Star, four members of the committee, including its head, said they would work sincerely to find out the right people for the EC appointments.

## Teknaf shook with 'crossfire' horror

Sinha murder verdict brings up tales of torture

Several victims of the suspended officerin-charge of Teknaf police station Pradeep Kumar Das gave testimonies against him during the murder trial of Major (retd.) Sinha Rashed Mohammad Khan.

The prosecution observed that according to the investigation report by the administration, OC Pradeep killed 204 people in crossfires -- and none got justice. The Daily Star has a copy of the 288-page

When the prosecution argued that if OC Pradeep had not been arrested for the murder of Sinha, more crossfires would have taken place, the court observed in response that this claim is valid, substantiated and carries weight.

Many women like Senowara Begum would lose their husbands to "crossfire" as she lost hers, a CNG driver.

On December 3, 2019, her husband, a CNG driver, came from Chattogram to Cox's Bazar at 9 am and called her to tell her that he is in front of Cox's Bazar masjid market. His neighbour Shah Alam was with him, he said.

Shah Alam used to be an informer of OC Pradeep, Senowara told the court.

He told her that he needed to submit a document after which he would come home. An hour went by but she was unable to reach her husband.

She then called Shah Alam, who told her that OC Pradeep's men have taken her husband away to the Teknaf police station.

She went to Teknaf police station but they did not let her inside. She sat outside the station from 2 pm to 10 pm. Shah Alam had confirmed that her husband was inside, according to the verdict.

The next day she went to the station again and tried to file a general diary. But the police did not let her in.

Then Shah Alam told her that he knows where her husband is and asked her to go home. Still, she stood outside the Teknaf police station until 10 pm that day too.

#### **ENFORCED DISAPPEARANCES** Govt doubling down on stance

Home Minister Asaduzzaman Khan yesterday said the country's law enforcement agencies are not involved in enforced disappearances.

Meanwhile, Foreign Minister AK Abdul Momen said many people listed by UN organisations as 'missing' have actually drowned in the Mediterranean.

None of the ministers, however, elaborated on these remarks.

"Whenever anyone goes missing, they return after a few days. The person may go into hiding for different reasons," Asaduzzaman said after visiting a Saraswati Puja mandap at Rajdhani High School in the capital.

These incidents are branded as 'enforced disappearances'. We have not yet received information about a couple of 'self-hiding' incidents. We think we can bring them to the fore soon."

The top ministers made these statements at a time when the UN Working Group on Enforced or Involuntary Disappearances will hold in hybrid format its 126th session from February 7-11 to examine more than 300 cases of disappearances in 24 countries.

Five independent experts will hold meetings with victims' relatives, state representatives, civil society groups and other stakeholders to exchange information on individual cases, structural issues and challenges related to enforced disappearances, according to a UN Human Rights Council statement.

# New Paxovir will be a game-changer

Experts hail Eskayef's Covid pills at seminar

The new Paxovir will be a game changer in treating Covid-19 patients with mild to moderate symptoms as it reduces the need for hospitalisation and risk of death by almost 89 percent, said speakers at a scientific seminar yesterday.

But physicians must ensure proper use of the oral antiviral drug to get the best outcome, they added.

Renowned physicians of 42 medical institutions from Bangladesh and 30 other countries participated at the discussion titled "An Update on Antivirals for Covid-19".

They also lauded Eskayef Pharmaceuticals Ltd for the fastpace introduction of the world's first generic version of Paxlovid, developed by Pfizer, with the brand name

Paxovir on December 30 last year. Paxovir can be prescribed to both vaccinated and unvaccinated Covid patients aged 12 and over.

Medicine specialist Prof Robed amin line director of the Non Communicable Disease Control at

the Directorate General of Health Services (DGHS), presented the keynote paper at the event organised by Eskayef Pharmaceuticals Ltd in its office in the capital.

"The outcome is better if Paxovir is given to patients three days within the onset of symptoms. It reduces the viral load. The drug has emerged as the lifesaver during the emergence of the new [Omicron] variant," he said.

Paxovir is a combination of nirmatrelvir, which was designed to interfere with an enzyme the coronavirus uses to make copies of itself, and ritonavir, an antiviral that slows down the body's metabolism of the other medication, he said.

Pfizer's laboratory studies indicated that Paxlovid is likely to work against the Omicron variant, which has spread across the world.

Former DGHS director general Prof MA Faiz who joined via video link said, "To win over the coronavirus, effective drugs should be applied at

the very beginning of the infection." communicable disease control at the DGHS, lauded Eskayef for introducing the drug in the local market, adding that misuse and indiscriminate use of the drug should be avoided.

The DGHS will soon publish updated treatment protocols for Covid-19, he informed.

Prof MA Jalil, former chairman of the medicine department at Bangabandhu Sheikh Mujib Medical University, who also joined online, said, "Time will tell how effective the new drugs are.'

Prof Khalilur Rahman, head of medicine department at Rajshahi Medical College, said some drugs to treat Covid-19 infection have been overused.

Prof MA Hasan Chowdhury, head of medicine department at Chattogram Medical College, said, "Paxovir is a groundbreaking drug for patients with mild to moderate

symptoms." Prof GKM Shahiduzzaman, head of medicine department at Shaheed Suhrawardy Medical

#### Suspension of in-person classes at DU extended

The suspension of inperson classes at Dhaka University (DU) has been extended till February 21.

Confirming the extension yesterday, DU Vice Chancellor (VC) Prof Md Akhtaruzzaman said, "We will extend the suspension of in-person classes for two weeks, following government decision.'

"But our crucial exams and laboratory activities will continue in-person, maintaining

guidelines," he said. DU Pro-Vice Chancellor Prof ASM Maksud Kamal said an official announcement will be

made today. On January 21, DU authorities suspended its in-person classes till February 6. Meanwhile, leaders of Bangladesh Socialist Students' Front held a rally, protesting the

government decision and

educational institutions.

To regulate the country's air quality and reduce air pollution, the government should enact the "Clean Air Act" as soon as possible, after a recent study found air pollution to be a massive health crisis, said speakers in a webinar.

Even though the air is already toxic for citizens, especially city dwellers, they alleged the government is overlooking the crisis, as the draft law has been gathering dust for years.

They were speaking at a webinar jointly organised by Bangladesh Environmental Lawyers Association (Bela), Bangladesh Lung Foundation and The Daily Star yesterday, in the wake of a recent air pollution study published by Stamford University's Center for Atmospheric Pollution Studies (CAPS).

In the welcome speech, Syeda Rizwana Hasan, chief executive of Bela, said due to air pollution, people's right to life, as bestowed by the constitution, is being violated. As per the constitution, the government not only must protect the environment but also work to improve it.

"According to the CAPS study, we did not experience fresh air for even one week of a year since 2015. How many years can we sit back and suffer due to such horrific health hazards? The draft of the law to regulate air quality, the "Clean Air Act", has been lying idle for a long time.







# Now there's ONLY SILENCE

Overlooked and underpaid, Aloobazar's band party artists enduring tough times

It's a curious term. When you hear of a "band party", you know it's different from a musical band, although a band party accomplishes the same function: to provide entertainment through music.

This age-old, traditional group has been playing soundtracks for various events for close to a hundred years, from wedding events and birthdays to election campaigns.

In Old Dhaka's Aloobazar alone, there are four band parties carrying on with the craft, with over 100 artists associated with these troupes.

But for all the history and practitioners' passion, the form has been on the decline for years, especially in hardship has pushed band party musicians to look for more stable incomes elsewhere.

The four band parties of Aloobazar are Bangladesh Band Party, Dhaka Band Party, National Band Party and New National Band Party.

The band parties of Aloobazar have a

singular origin. It all started with Mohammad Kha, who brought the culture to the old town

His four wives and five sons were band artists as well.

In 1948, his son Siraj Kha started the National Band Party. After Siraj died in 1993, it was handed down to his two sons, the younger of whom is Arman "band master".

Arman's eldest brother Mohammad Reaz founded New National Band Party

He said business was at its peak

during and right after Pakistan period. But with the advent of portable audio players, speakers and DJ parties, band party culture in general started to diminish.

Back in the glory days, a band party used to get booked for three to four events a day, which even included playing for films at times. Nowadays, they're lucky to even get one.

Twenty years ago, they used to get Tk 5,000 for a gig, minus transportation

The rest of the money earned from a gig is split between the artists, he further said. Saeed said these days, they barely get one or at maximum two gigs per week, mentioning that they got no help during the hardest phases of the pandemic, when bookings ran out altogether.

Even as they bring this time-tested art form deeper into the new century, the band party artists of Aloobazar are spending their days in disappointment dissatisfied over their economic condition and anxious about the gradual extinction of their craft.

When it comes to growing pineapples, Rangamati is on the frontlines of the race. Due to the region's favourable weather, thousands of tonnes of pineapple is produced here alone.

Usually, pineapple is cultivated between June and July. But for the last seven years, its being cultivated in January and February as well. The reason behind this early

cultivation through the off-seasons is the introduction of added hormones to the

From the eight to 11th month, when 30-40 leaves of the seedlings have sprouted, three cups of Rifen-15 mixed with 18 litres of water is sprinkled. Later, Ethrel hormones are used to fast-track the growth.

Tapan Kumar Paul, deputy director of Department of Agriculture Extension, said, "Pineapple is cultivated across 10

upazilas of Rangamati, Naniachar being the most popular. Over 2,130 hectres in Rangamati are cultivated for pineapple, bearing a total production of 55,913 tonnes.

Nirmal Chakma, a farmer from Naniachar upazila, brings around 5,000 pineapples by boat to Banarupa Samata Ghat, selling each for Tk 13 on average. He said he cultivated around 41,000 saplings this year.

Nandini Chakma, from Naniachar, said she brings around 35,000 pineapples to the weekly market and sells each for Tk 12-15, depending on the size. Almost 17,000 saplings were grown by her family.

Local trader, Md Burhan said, "We purchase each pineapple for Tk 13-15 and sell them at Tk 20-25. We make very little profit due to transportation cost."

Kamal Ahmed, a wholesale seasonal fruits trader, said prices are higher now as the pineapple season hasn't started yet, so they can make a little more profit.



Although pineapples are commonly regarded as a summer fruit, the growers of Rangamati have found a way to speed up the cultivation process and make it available to consumers even in winter. The pineapple growers board large boats with thousands of the fruit, and make their way to Banarupa Samata Ghat. This photo was taken vesterday.

#### China urges 'flexibility' from US on N Korea

China's UN ambassador on Friday called on the United States to be more flexible in its dealings with North Korea, as Beijing joined others to scrap a US-drafted Security Council joint statement condemning Pyongyang's missile launches, diplomats said.

Kim Jong Un's regime conducted an unprecedented seven weapons tests in January, including launching its most powerful missile since 2017 as it hinted it could restart long-range and nuclear testing.

Washington had proposed a statement decrying those launches, but China and Russia, along with other nations,

"If they do want to see some new breakthrough, they should show more sincerity and flexibility," China's ambassador to the UN, Zhang Jun, said of US officials ahead of a closeddoor meeting.

# 'Good but not enough'

Says Tehran after US waives sanctions on Iran's civil nuclear program

US steps on lifting sanctions are "good but not enough", Iran said yesterday, following Washington's announcement it was waiving sanctions on Iran's civilian nuclear programme.

The US action came as talks to restore a 2015 deal between Tehran and world powers over its nuclear programme reached an advanced stage, with the issue of sanctions relief a major issue.

"The lifting of some sanctions can, in the true sense of the word, translate into their good will. Americans talk about it, but it should be known that what happens on paper is good but not enough," Iranian Foreign Minister Hossein Amir-Abdollahian said, quoted by ISNA news

The secretary of Iran's Supreme National Security Council also reflected Tehran's view that the US move falls short.

"Real, effective and verifiable economic benefit for Iran is a necessary condition for the formation of an agreement," Al Shamkhani said in a tweet.

"The show of lifting sanctions is not considered a constructive effort," he added.

The US State Department on Friday said it was waiving sanctions on Iran's civilian nuclear programme in a technical step necessary to return to the 2015 Joint Comprehensive Plan of Action, or JCPOA.

State Department spokesman Ned Price insisted this US step is a sanctions waiver for the civilian nuclear program and not broader sanctions relief.

Former president Donald Trump with drew from the pact in 2018 and  $\,$ reimposed crippling sanctions on Iran,

The waiver allows other countries and companies to participate in Iran's civilian nuclear programme without triggering

US sanctions on them, in the name of promoting safety and non-proliferation. Iran's civilian programme includes increasing stockpiles of enriched uranium.

Amir-Abdollahian reiterated that one of the "main issues" in the JCPOA talks is obtaining guarantees that the US will not withdraw from the 2015 deal again.

"We seek and demand guarantees in the political, legal and economic sectors," he said, adding that "agreements have been reached in some areas".

Iran is negotiating with the UK, France, Germany, China and Russia directly and with the US indirectly in the Vienna talks which different parties say have reached a stage where the sides have to make important "political decisions".

Earlier on Saturday, foreign ministry spokesman Saeed Khatibzadeh said: "Naturally, Tehran is carefully considering any action that is in the right direction of fulfilling the obligations of the JCPOA", local media reported.

Moscow's ambassador to the LIN in Vienna, Mikhail Ulyanov, yesterday welcomed the US waiver decision as "a move in the right direction".

Talks on reviving the nuclear deal were halted last week and the negotiators returned to their capitals for consultations.

Experts say the JCPOA talks could resume next week.

#### **India arrests** Kashmir journo

A prominent journalist in Indian-administered Kashmir has been arrested by police and accused of "glorifying terrorism" and "spreading fake news" in the disputed territory, where a running press crackdown has intensified.

Fahad Shah, the editor of Kashmir Walla news portal, had already been questioned several times for his reporting by officers in recent years.

He had been arrested for "glorifying terrorism, spreading fake news and inciting general public", Kashmir police said yesterday. A police statement that followed his arrest the day before added that Shah's Facebook posts had dented "the image of law enforcing agencies".

The Committee to Protect Journalists demanded Shah's release and called on Indian authorities to respect press freedom in Kashmir.

Dozens of journalists in Indian-controlled Kashmir have regularly been summoned by police and questioned on their work since 2019, when New Delhi revoked the territory's partial autonomy and brought it under direct rule.

They have also been increasingly subject to harassment, arrests, raids and prosecution on "terrorism" related charges.

#### Everest's highest glacier rapidly losing ice: study

Ice on a glacier near the summit of Mount Everest that took millennia to form has shrunk dramatically in the last three decades due to climate change, a new study has shown.

The South Col formation may already have lost around 55 metres (180 feet) of thickness in the last 25 years, according to research led by the Maine and published University of this week by Nature.

Carbon dating showed the top layer of ice was around 2,000 years old, suggesting that the glacier was thinning more than 80 times faster than the time it took to form, the study said.

At that rate, South Col was "probably going to disappear

within very few decades", lead scientist Paul Mayewski told National Geographic. The South Col glacier is around 7,900 metres

(26,000 feet) above sea level and a kilometre below the peak of the world's highest mountain.

Other researchers have shown that Himalayan glaciers are melting at an accelerating rate. As the glaciers shrink. hundreds of lakes have formed in the foothills of Himalayan mountains that could burst and unleash floods.

Himalayan glaciers are a critical water source for nearly two billion people living around the mountains and river valleys below. They feed 10 of the world's most important river systems and also help supply billions of people with food and energy.

## UK Queen marks 70 yrs on throne

Queen Elizabeth marks 70 years on the British throne today, a milestone never reached by any of her predecessors over the last 1,000 years, and one which only a few monarchs across the globe have ever achieved.

Elizabeth, 95, became the queen of Britain and more than a dozen other realms including Canada, Australia and New Zealand on the death of her father King George VI on Feb 6, 1952, while she was in Kenya on an international tour.

The news was broken to her by her husband Prince Philip, who died last year aged 99 after more than seven decades by her side

Elizabeth will mark 'Accession Day' in private as is customary, not viewing it as something to celebrate. But there will be four days of national events to mark her Platinum Jubilee in June. In 2015, she overtook Victoria as

Britain's longest-reigning sovereign in a line that traces its origin back to Norman King William I and his 1066 conquest of England.

When she ascended the throne, Josef Stalin, Mao Zedong and Harry Truman were running the Soviet Union, China and the United States, respectively, while Winston Churchill was British prime minister.

Including Churchill, she has been served by 14 prime ministers - a quarter of all there have been in Britain since Robert Walpole 300 years ago. During her reign, there have been 14 US presidents, all of whom she has met bar Lyndon Johnson.

# Xi upends Biden's strategic calculus

China's support for Russia in the standoff over Ukraine upends the strategic calculus for US President Joe Biden, who must now contend with a second front in a geopolitical fight whose ramifications could be felt worldwide.

By jointly lashing out Friday at Washington's alleged destabilising policies in both Eastern Europe and the Asia-Pacific region, Beijing and Moscow indicated that sanctions alone would not deter their bids to play larger roles on the global stage.

Appearing publicly as the Beijing Olympics opened, Russian President Vladimir Putin and his Chinese counterpart Xi Jinping showed an "enhanced commitment to make the world safe for authoritarianism, in particular in former socialist countries," said Steve Tsang, a political scientist at the SOAS University of London.

And for Xi, taking a public stand on Ukraine demonstrates "his shared interest with Putin to challenge the US-dominated world order", Tsang told AFP.

Official Chinese media outlets have been playing up the frequent encounters between Xi and Putin since Russia's 2014 annexation of Crimea, which saw the Russian leader largely blacklisted by the West.

China's Global Times noted recently that "besides the official meetings, the two also shared some close moments like enjoying vodka, caviar and Russian ice cream and celebrating each other's birthdays".

"We know that both Russia and China value sovereignty above anything else, so alliance is still too strong of a word," said Anton Barbashin, an analyst at the Riddle think-tank in Glasgow, Scotland.

"But we are definitely going to see more coordinated action in international relations, maybe simultaneous campaigns in Europe and Asia, as well as deepening economic ties between Moscow and Beijing," he told AFP.

And the Ukraine crisis gives Xi a chance to riposte indirectly to Biden's avowed focus of containing China's ambitions in the Asia-Pacific, as evidenced by the recent US-Australia defence pact and nuclear submarines deal.

"It increases Russia's relative importance for China -- Xi couldn't have provoked Biden nor Europe this openly," said Pascal Putin that Russia was only a regional power — he wants to show that Russia plays a central role, and he's succeeding," Ausseur caid

The payoff for China, meanwhile, could be in its own backyard: More US troops focussing on Ukraine and other Eastern European nations means less military weight to compete with Beijing in the Pacific.

The US response to Moscow on any Ukraine invasion, for example, could weigh heavily on any Chinese move to take



Ausseur, a former French navy admiral and director of the Mediterranean Foundation of Strategic Studies.

"And Putin showed Xi that he knows how to take geopolitical and military risks, which Beijing must have appreciated," he said.

Putin is using the threat to invade Ukraine to demand a halt to Nato expansion and what it calls "Cold War" ideologies, and now has Beijing's explicit support in the showdown.

"Don't forget that Barack Obama told

Both Russia and China would also seize on any apparent US backdown over Ukraine to portray Washington as an unreliable partner, a potent argument as both countries look to spread their global influence, in particular in Africa.

"If the United States chooses retrenchment rather than its traditional global leadership role, both Russia and China could try to fill the void," Pezard said.

Republicans' deep divisions over the 2020 US election were laid bare Friday as the party censured two lawmakers investigating the deadly Capitol assault aimed at

stopping its certification — only to see Donald Trump rebuked by Mike Pence for claiming falsely that his former vice president could have overturned the results. An extraordinary split-screen began when Liz Cheney and Adam Kinzinger found themselves rebuked by the Republican National Committee (RNC) over their roles on the

involvement in the January 6, 2021 insurrection. Just hours after the RNC met in Utah, Pence delivered an address in Florida rejecting Trump's claims that the former Indiana senator could have overruled vote tallies in swing states as he oversaw the congressional certification of Joe Biden's victory.

House select committee probing Trump's

"President Trump is wrong. I had no right to overturn the election," Pence said at a Federalist Society event in Orlando. "The presidency belongs to the American people and the American people alone."

Trump, who retains his iron grip on the party despite losing in 2020, is expected to run for the 2024 Republican nomination, potentially against Pence.

# US Covid death toll tops 900,000

The US death toll from the Covid-19 pandemic surpassed 900,000 on Friday, according to the Johns Hopkins University coronavirus tracker. The toll had hit 800,000 dead in mid-December, just a month and a half ago. New cases linked to the Omicron variant are falling, but daily deaths are still rising, with an average of 2,400 now, according to government figures. Covid deaths usually occur a few weeks after patients get the virus, which explains why the spike in deaths occurs later than the spike in new cases. The Covid pandemic has killed at least 5.7 million people worldwide since it began in December 2019, according to an AFP tally published on Friday.

# Peru PM sacked over 'domestic violence'

Peruvian President Pedro Castillo dumped his prime minister Friday just three days after appointing him, amid outrage

over revelations he was accused of domestic violence in 2016. "I have decided to recompose the cabinet," the president said, meaning Prime Minister Hector Valer Pinto is out. Valer Pinto, 62, first came under pressure Thursday when newspapers reported that in 2016 his wife and

university-age daughter reported him for domestic violence. Valer Pinto responded to the news reports by denying he was an "abuser" and said he was never convicted of domestic violence.

# Saving little #Rayan

AFP. Bab Berred

Moroccan rescuers worked through the night into yesterday, the fifth day of an increasingly urgent and nerve-wracking effort to rescue Rayan, a five-year-old boy trapped underground in a well.

The complex, slow and risky earth-moving

operation has gripped residents of the North African kingdom and even sparked sympathy in neighbouring Algeria, a regional rival. Rayan accidentally fell about

32 metres (35 yards) down the tight, empty shaft near his home in the remote village of Ighrane in Chefchaouen province on Tuesday afternoon.

Rescue crews, using bulldozers and front-end loaders, have dug

almost all the way down but the final two metres are the most difficult because of the risk of landslides. There has been no information about the fate of the boy, but the more time that passes, the

more fears arise over whether he will be recovered alive.

Overnight, crews manoeuvred a heavy pipe into position in the area. "We're almost there,"

said one of the operation's leaders, Abdesalam Makoudi. A glacial cold has gripped this mountainous and impoverished region of Rif, which is at an elevation of about 700 metres.

On Thursday Moroccan media reported that

rescuers managed to deliver oxygen and water to the bottom of the well.

Thousands of people gathered around the site, surrounded by olive trees, where AFP reporters said the tension was palpable. Some applauded to encourage the rescuers.

The shaft, just 45 centimetres (18 inches) across, was too narrow to reach Rayan, and widening it was deemed too risky -- so earthmovers dug a wide slope into the hill to reach him from the side.

The operation has made the landscape resemble a construction site. It involves engineers and topographers, and was made more complex by the mix of rocky and sandy soils.

Red-helmeted Civil Defence personnel have at times been suspended by rope, as if on a cliff face.

"I keep up hope that my child will get out of the well alive," Rayan's father told public television 2M on Friday evening. "I thank everyone involved and those supporting us in Morocco and elsewhere."

"Rescuers are literally in the process of moving a mountain to save little #Rayan. I hope that their efforts will not be in vain and that those who prayed for him will see their prayers answered," one internet user wrote.

#### **Private airlines** barely staying afloat

Govt must provide them financial assistance, reduce their tax burdens

TE are really concerned to learn that our private airlines have been struggling with a host of problems, which are not only impeding their growth but also have forced a number of them to completely stop their operations. According to a report by The Daily Star on February 5, regulatory malfunction, excessive tariffs, high jet fuel price and undue patronisation given to their main rival, the national flag carrier Biman Bangladesh Airlines, are the major reasons

According to the Civil Aviation Authority of Bangladesh, while 1.3 million people opted for air travel in 2000, the number increased to about 6 million in 2020. While our private airlines could have expanded their operations taking advantage of the high demand for air travel, they could not do so due to a lack of support from the government and other concerned authorities, experts say.

The most important challenge for these airlines is to survive against the state-financed Biman, which has a bonded warehouse facility as well as a hangar at the airport which other airlines don't have. What this means is, when it comes to servicing an aircraft or replacing spare parts, the private airliners fall far behind Biman as they can't keep the spare parts at the airport, leading to a regular disruption of flight schedules. Sometimes, the private airlines have to wait for months to import the spare parts. Moreover, they have to import many of the parts—such as the multiple number of generators used in the aircraft, various types of LCD panels and computer displays used in the cockpit—at a very high price, due to the unreasonable tax they have to pay at the Customs. Some of the parts are taxed between 15 and 150 percent while they should be cleared on zero-tax, according to industry stakeholders. Then there is a 5 percent advance tax (AT) which has been imposed recently on the import of aircraft, engines and spares.

Another major reason why the private airlines are struggling is their due surcharges. According to aviation analysts, it is the piled-up surcharges that forced the GMG Airlines, United Airways and Regent Airways to ground their fleet. The high price of jet fuel is another

Therefore, in order to revive our aviation industry, there needs to be a clear directive from the authorities to stop the arbitrary and whimsical practice of taxation on the private airliners. They also need bonded facilities at the airport to easily service their aircraft and replace the spare parts as needed. Getting permission from the authorities to import the parts should not also take so long. Most importantly, private airlines also need financial assistance from the government, that is until the playing field for them is level.

#### Save our forests from influential locals

Govt must take firm stance to stop environmental damage

TORIES of cutting hills or ravaging forests and other natural resources by powerful individuals are so frequently published that they do not surprise us anymore. It is well-known that these people often operate with some kind of work order issued by the local administration and, importantly, with the blessings of the local political power. As a result, they remain outside the dragnet of the laws even when they do something

One such story has now come from Cox's Bazaar with details of how a wildlife sanctuary, surrounding agricultural lands and two canals are being decimated by a syndicate having links with the ruling party. According to the Youth Environment Society (YES), a Cox's Bazarbased environmental organisation, the forestland and croplands belonging to locals were excavated 30 feet deep, turning an estimated 300 acres of arable land and forestland into veritable ponds.

The story says that after damaging two canals by building dams and extracting sand, the syndicate is tearing apart the forest by scooping out sand from it and topsoil from adjacent arable land in Dulahazara union of Chakaria upazila, Cox's Bazar. Reportedly, the canals, both marked as ecologically sensitive, have been leased out to a local influential group. And as expected, they have been making hefty money out of it paying no heed

at all to the environmental damage caused. Once an eye-catching locale with pristine trees, the whole area was a sanctuary for birds and wild animals. The Fasiakhali forest, which serves as a habitat for the critically endangered Asian Elephants, is now at risk because of these activities. The extensive damage done to the entire locality has also been mentioned in a report of the Department of Environment. It found out that about 4,000 square feet of the two canals were damaged as a result of sand and soil extraction by the leaseholders. These people are well-known, just as the official response, especially from the divisional forest officer of Cox's Bazar (north), is predictably lax.

We have noticed a pattern of such irresponsible and inadequate responses from the district officials in case of such acts of destruction of the environment and overstepping legal bounds by the perpetrators. This cannot be the norm. The higher authorities must take a firm stance to save our forests and other natural resources and ensure local officers and administration take appropriate measures.

meeting. Could Sinha's murder, or that of all other victims, be avoided if he had been stopped sooner? Should we be happy that Sinha got justice, or sad that others before him did not?

This is not merely a rhetorical question. Sinha's murder may have been "pure and simple", but for a broader context, we need to de-simplify the circumstances under which the case progressed, gaining unprecedented momentum as it was transferred to the Cox's Bazar court. Our memory of a muted standoff between the police and military establishments over the retired major's murder is still fresh. What chance does a victim without such powerful backing have of getting justice in a similarly speedy manner?

Unfortunately, a victim's family can rarely file a case, according to Nur Khan Liton, secretary general of Ain o Salish Kendra. Police do not want to record such cases. Even when they do, it is hastily binned or somehow falls through. For example, Sinha's may have been the first case to get a guilty verdict but it wasn't the first to go on trial. In that first trial in 2010, the lower court in Kushtia ruled in favour of the cops, even though the victim's family insisted that the former had picked him up before "staging" the shootout.

So while we are glad that a guilty verdict has been finally reached, and so fast, we doubt this will be the norm going forward. So far, there has been no official apology issued from the home ministry. We have heard of no internal

this is the first verdict, and not the 100th or the 500th, hypothetically speaking.

It's as if the Sinha case was an embarrassment, and the sooner it goes away, the better.

For the government, however, this particular embarrassment may last longer than expected. While there has been a dip in the number of extrajudicial executions of late, it is unlikely to help its image with the widespread condemnation after the US sanctions on RAB. The verdict, far from being an affirmation of the rule of law, will instead be used as a reference point to further validate claims of state violence and torture. As image-conscious as this government may be, it doesn't seem to understand that the solution is really not to ignore or cover up crimes and failures—because nothing stays hidden for long in this age-but to own up to them and show sincere action to ensure they never happen again.

After the Sinha verdict, we are being told to be hopeful, to look ahead. But we cannot do so without also looking back. The verdict is a painful reminder that countless other victims—victims without powerful backing or those whose moment of tragedy wasn't immortalised in a viral photo or video clip-didn't get justice. Torture or staged executions by state officials reached a point that the identity of victims no longer mattered. Can we move ahead without critically questioning this failure of "the rule of law" or doing something about it?

# Can we all play nice, please?

TTH the third round of Covid surge, educational institutions in Bangladesh are once again subjected to an extended shutdown. The purpose, we are told, is to prevent the spread of the highly contagious Omicron variant. This act of concern coming from the health ministry, the primary vanguard of our well-being, could be rather puzzling, judging by their recent vaccination campaign for the same schoolchildren.

Before delving any further, let me shine some light on our tradition of discordant work practice in the public sector, especially when it comes to interministerial collaboration.

You might have seen the following episode in person or on TV, read in the papers or online, or *nidenpokkhe* heard of it: The roads and highways department lays the finishing asphalt to make a public road usable. Everyone is happy. But a week later, the happier person is the contractor of Titas Gas, who has received a work order to dig the same road to put in pipes. We need gas, man.

But wait! An even happier person waits for his cue with even larger pipes. The Dhaka Wasa has issued a separate work order. This contractor is polite enough to move in only after the gas guy has completed his work with a not-so-finished coat on the road. Therefore, there will be more digging. And finishing. Over time, the nogorbashi are finished.

The anecdote above had to be dug up

because of an unfortunate occurrence related to schoolchildren, where once again there were contradictory approaches to a common cause by two different ministries.

The education ministry spent months to plan, studied the ever-changing circumstances, learnt from other countries, trained teachers and officers, and then laid out a procedure to finally reopen schools and colleges after a long closure. Our children were protected.

During more than a year of closure, however, classes and exams had been conducted online and on television to keep the wheel of education running. The ministry was appreciably cautious about exposing students to the deadly virus. As the infection rate dropped to a somewhat tolerable level, students were allowed into classrooms physically—that, too, for two to three days per week. For the rest of the week, learning continued online.

By government order, campuses and buildings were thoroughly cleaned. At the school gates, students' body temperature was checked and their outstretched hands were sprayed with sanitiser. Mask-wearing was, of course, mandatory. Inside the classrooms, they sat at alternate desks. Safe distance and Covid protocol were mostly maintained.

It was amazing how teachers managed their students-some of them eight- to nine-year-olds-administering such a demanding task with efficiency. It was obvious that training and communication were employed methodically under the aegis of the education ministry to let everyone involved know what was expected of them. Astoundingly, this happened in tandem all across the

Then came the students' vaccination. In early January, the government made the jabs mandatory for those who were attending classes in person. A welcome

move, no doubt, and somewhat of a thrill for students aged above 12 years. But the good news ends here, because the health ministry officials and medical professionals could not ensure precautionary measures.

There was wide-scale shoving and pushing, no one was caring about wearing masks, and shouting and exchange of red eves were the order of the day. All of those gross delinquencies were committed by the parents of the children. Some children were understandably frightened.

What the education ministry developed and delivered after months of preparation was destroyed at one sweep by the health ministry and the medical practitioners involved—especially those who planned the school vaccination programme. The mindset of the innocent children, built over two years through massive campaigns on TV and radio, and through learning at home and school, went out the window. "Wash your hands, don't touch your face, wear a mask, avoid crowded places"—all this became a joke to them. Hopefully, the children know better.

Instead of saving lives, the school vaccination programme could prove to be a super spreader. Under the circumstances, perhaps the school students are better off without vaccines in such crowded situations. The health ministry should really try harder to get their act right.

My advice? Next time, don't allow parents or guardians into the vaccination premises. You will see the children behaving their best in the presence of their teachers. Let each school arrange vaccination of their respective students in their own premises. Medical professionals can visit the schools at appointed hours to administer the jabs.

Let's save lives together by learning from each other.

# 'Social engineering is vital to solve waterlogging in Bhabadaha'

**Dr Ainun Nishat**, professor emeritus of BRAC University and a water resource and climate change specialist, talks to **Naznin Tithi** of **The Daily Star** about the reasons behind the persistent waterlogging problem in the Bhabadaha area and the measures that should be taken to solve it.

It's hard to believe that over a million people in Bhabadaha in the country's south-west region have been suffering from waterlogging for so long. When did the problem start and how did it get so bad?

The waterlogging problem has been there in Bhabadaha for the last 30 years, which is the result of development activities in the sixties and the seventies. This is the result of an absence of monitoring, greed of a group of people, and the inability of the local community to push for their own agendas and ideas. In any development project, when you intervene or interfere with the natural process, you need to monitor and see what is happening. But the Water Development Board has failed to do so in the case of Bhabadaha. There are also many other factors involved.

In the coastal areas of Bangladesh, polders were constructed to protect crops from the high tide (during hide tide, croplands would go under water) and for land building. A hundred years back, these polders were called "Oshtomashi Baadh"-or, embankments that would remain functional for eight months of the year. During this period, crops would be protected and harvested, and at the beginning of monsoon, it would be cut down for the tide to come in. Together with the tide would come sediment, which would get deposited and land would be raised. Although it takes time for the land to be raised through this process, it was going on.

"Polder" is a Dutch word that basically means any embankment that prevents the movement of water from the river to inland. When it is linear, we call it an embankment. But when it encircles an area, we call it a polder. Currently, the entire coastal area of Bangladesh is empoldered—we have around 129 of them.

Åround the time of 1965/1966, when the master plan for the overall water management of Bangladesh was prepared for the first time, the demand for building permanent polders came up. A US consultant with USAID funding, in consultation with the local people, decided to build polders around the entire coastal belt of Bangladesh. Before these polders were constructed between 1965 and 1969, tides used to come in and reach the beels or wetlands. The tidal volume

was very high during monsoon—about 6 million metre cube. It would come naturally with the tidal water. The 10 to 12 large beels in the Bhabadaha area used to be filled up with the tidal sediment during

But as the permanent polders were built around the beels, the land building process inside the polders stopped because water could not enter into the polders with sediments. The tidal volume then got deposited in the surrounding rivers, reducing their depth and width. The result is, the poldered areas became lower than the riverbed, creating waterlogging during monsoon. This problem became severe especially in Keshabpur, Abhaynagar, Dumuria and Tala upazilas of Jashore, Khulna and Satkhira in the early nineties.

To sum up, the waterlogging problem in Bhabadaha is a result of polderisation. I am not against polders. Without polders, the agricultural revolution in the southwestern Bangladesh would have never been possible. After the polders were constructed in the sixties, for the first twenty years it produced excellent results. And then, in some areas, such as the Bhabadaha, the problem started to surface. And that was the time when shrimp cultivation was introduced. So, one group of the community—the powerful elite—didn't bother about the poor farmers and made money by farming shrimp.

However, the polder system is still functioning in Cox's Bazar, Chattogram, Noakhali, Laksmipur, Patuakhali and Barisal because the tidal cubature in these areas is still good with fresh water coming from the upstream. But in the southwestern part, the behaviour of the polders became different due to the extensive network of rivers. In the Bhabadaha area, especially in Keshabpur, Abhoynagar, Dumuriya and Tala upazilas of Jashore, Khulna and Satkhira, fresh water supply from the upstream has decreased because of Farakka barrage and the tidal cubature has also declined.

Has anything substantial been done by the authorities so far to solve the issue? Reportedly, the Bhabadaha Pani Nishkashan Sangram Committee

has been protesting the projects undertaken by the Water Development Board. Why?

Around 1977/78, when the government took up the delta development project, these facts were revealed and we requested a new management approach for the polders. Then in the nineties, the government undertook a project to stop the tide by constructing regulators across the river system. But the local people and the civil society organisations opposed it, demanding fresh studies to deal with the issue. The local communities, based on their traditional knowledge and wisdom, demanded implementation of the Tidal River Management (TRM) method.

Through this approach, an embankment is built around a beel leaving two cut-points for water to enter and recede from. When the water recedes during low tide, it takes the sediment deposited on the riverbed in a process of natural excavation. Under this method, water can be allowed to enter the tidal basin (the beel) for land building. In the course of a few years, the empoldered area becomes higher than the surrounding riverbed.

Although the government and the engineers of the Water Development Board were against it, the local people started implementing TRM near Chuknagar in Dumuriya upazila of Khulna. After this first TRM initiative was successfully applied by the local community, fresh studies were carried out and the TRM was approved as the technical solution of the problem. But the powerful elites of the area and the local members of parliament did not want the method to be implemented. Government officials sided with the elites. They wanted waterlogging to be there so they could cultivate fish and shrimp. But the decision was suicidal for the local communities, because they could not cultivate paddy, their main food.

During the last 15 years, the government undertook various projects for dredging the rivers and to pump out the stagnant water from the area. But, no amount of dredging will be able to lower the riverbed level. It will get filled up in two/three years. Also, people can get only temporary benefits by pumping out water

from the beels.

So, what should be done now to push the authorities to implement the TRM approach, since this is the most efficient way to solve waterlogging in the area, according to experts and

We need "social engineering" to solve the waterlogging problem of Bhabadaha—you need to allow the tide to come in and deposit the sediment in an organised manner. Doing so needs community involvement. But the WDB engineers traditionally like to work through the contractors, not through the community. Recently, the local community completed one TRM project in the Pakhimara Beel of Tala upazila in Satkhira, which has been quite successful. But the powerful local elites and the local MPs would always make attempts to foil the efforts taken by the locals.

Very recently, the government took up a project to implement TRM and go for land building, but the ministry itself opposed it.

As I have mentioned, the situation gradually deteriorated over the last 30 years. In the first 20/25 years, villagers reaped a lot of benefits from the polders. But now the hydro-morphological, tidal hydrodynamics and sediment transport mechanism has been totally altered. This requires a fresh assessment of the ground realities.

The waterlogging problem in Bhabadaha must be seen as a national problem. And the solution today would be to form a national commission with professionals from BUET and other experts who understand this particular problem and can solve it with the participation of the local people.

Needless to say, TRM is the ultimate solution. The Water Development Board should be instructed to push for implementing TRM in the Bhabadaha area. But they will have to fight with the local elites and their powerful backers who prefer using the land for shrimp cultivation. So, I think only the government can undertake this challenge, and they should not side with the powerful people at the expense of ordinary citizens.



# A good Samaritan indeed

Rickshaw-van puller Alamgir leaves profession to guard risky unmanned level crossing

**During the** daybreak, at least 2,000 EPZ workers, mostly female, from surrounding villages cross the precarious level crossing on light vehicles braving the risk.

A poor man has set an example of magnanimity voluntarily guarding an unmanned rail crossing defying the bonechilling cold and dense fog at the daybreak to caution Uttara EPZ workers about approaching trains, who are in a mad rush to reach factories in time.

Notably, on January 26, a terrific accident took away the lives of four female EPZ workers and critically injured four others as Khulna-bound Rupsha Express crushed a battery-run threewheeler carrying them on the way to their workplace at the early hours on the unguarded rail crossing at Sonarai Dhonipara village in Nilphamari Sadar

After the accident, agitated people demanded that a gate be set up and a gateman be appointed but no high officials of railway either visited the spot or gave any assurance in this regard.

Still at the daybreak, at least two thousand EPZ workers, mostly female, from surrounding villages cross the precarious level crossing on light vehicles braving the risk, locals said.

Alamgir Hossain, 40, a rickshaw-van puller who lives near the rail crossing, got worried and felt the urge to secure the level

Talking with local elderly people, Alamgir arranged bamboo poles and set them on each side of the rail crossing.

Whenever a train comes he sets the long bamboo pieces crosswise and cautions the pedestrians and vehicles to keep away from the rail tracks.

"I saw the blood-splattered bodies of the accident victims and when I found that the same risk still prevails, I became unsettled," said he.

"Every day, I come to the rail crossing at the daybreak and notice the headlight of an approaching train amid dense fog and whenever I see one I shout out to caution drivers and walkers. I have been doing this for all trains," he added.

Alamgir's son Aminur Rahman, 19, an HSC examinee, said "My father has given up pulling his rickshaw-van to guard the rail crossing, yet we respect his noble intention. To maintain the family, I and my younger brother are working at a brick kiln as our institution is closed."

Easy bike driver Shibu Roy said, "We sometimes offer him Tk 10 to Tk 20 but he never accepts.'

Sadar upazila Chairman Shahid Mahmud said, "We have requested the railway authority to build a rail gate and appoint a gateman at this risky crossing."

According to Oli Ahad, Maulana agreed. But he was not seen the next morning. We then learned that he had already left for Narsingdi. Oli Ahad became very angry with him. Later Maulana Bhasani told me that he did not confirm Oli Ahad. He left for Narsingdi because he felt that the people in the village areas needed to be informed about the situation in Dhaka.

In my opinion, the events of February 22 were more significant than the events of February 21. I learnt from my personal experience that students were less courageous than common people. If we had to rely only on the students, then there were doubts as to whether there would be a procession on February 22. The procession happened because of the participation of a large number of general people in the ghaibana janaza. A large number of employees of the secretariat participated in the janaza and the procession. Police opened fire on the demonstrators near the High Court gate. But the procession continued spontaneously. Nobody cared about Section 144.

# Teknaf shook with 'crossfire' horror

Around 10 pm Shah Alam told her that her husband would be taken to his house at 11 pm. He asked her to be there with

She waited all night for his call, which never came. So she went to his house the next morning at 7 am. She asked Shah Alam why he didn't call her. Upon getting no answer she went back home.

Meanwhile, despite Shah Alam's warning, Senowara Abdul Jabbar, a member of ward number 9.

That same afternoon, she went to meet a former MP and told him in detail what has happened. He called SI Moshiur and told him to release her husband. SI Moshiur denied having her husband in the police station. Then the MP called OC Pradeep and he too denied having her husband in their detention.

Some 15-20 days later, a local named Rafiq Ullah was taken away by OC Pradeep and his men and kept in the hajotkhana on the second storey of Teknaf police station. In the detention cell, Rafiq Ullah met Senowara's husband, who gave her phone number and asked him to contact her.

When Rafiq Ullah got Senowara and asked her to meet him. "Please don't tell anyone you met me," Rafiq told Senowara when they

She, however, told the MP what happened. The told her that her husband's MP asked her to go back to dead body was in the

and demanded to see her given him "crossfire". husband.

when But threatened her with arrest, she left the police station. She then sent a document to the superintendent narrating what happened.

Some three or four months later, OC Pradeep, Sagor Deb, Rubel Shwarma, Moshiur and 2-3 cops went to her home after the evening prayers and told her that she must pay Tk 10 lakh if she wants her husband back alive.

She told them: "My house is broken. I have no rice to cook, and my children are hungry. How will I give Tk 10 lakh?"

The verdict stated that she fell to Pradeep's feet, but the cop told her that she must manage Tk 5 lakh at least. Otherwise, she would not get her husband

To gather the Tk 5 lakh, Senowara took a Tk 1.5 lakh loan from non-governmental organisation, sold off her husband's CNG for Tk 2.5 lakh and mortgaged her home for Tk 1 lakh. It took 15 days to gather the money.

Pradeep and his team then called in at her home and picked up the amount.

The next day, Senowara called Pradeep but he did out of the station, he called not answer. She went to the police station and begged for her husband. "Pradeep did not respond -- he simply laughed."

On July 7, 2020, local journalists called her and the police station. She did morgue. OC Pradeep had

The verdict stated that

Senowara believes that her husband was tortured to death and then passed off as a "crossfire" death. He was declared to be the second-in-command of a robber named Hakim.

A local member and businessman named Ham Jalal told the court how he was extorted by the cops, and how his young brother was killed in a crossfire. On January 23, 2019, six

cops from Teknaf police visited the house and a subinspector named Sanjit told him to open the door or be shot. Four cops entered and two stood outside.

They told him that a listed drug trader had named him as a criminal. SI Sagor told him that he needed to pay Tk 20 lakh or be arrested. When Ham Jalal said

he did not have so much money, SI Sanjit called Pradeep to inform him, and the cop was instructed to detain Jalal.

Jalal was taken to the second storey of the police station where there are four rooms. In one of the rooms. detainees who would be sent off to "crossfire" are

SI Sagar then turned to him and said: "You have earned a lot of money by becoming a member. Give Tk 15 lakh and we will tell sir to let you go. Otherwise, you will be dead on Marine Drive tonight."

Jalal agreed to give the money and asked the cop to contact the upazila rental car association's

general secretary Rafiq. He was then thrown into a cell. Then 15-20 minutes before dawn, constable

Rubel brought a mobile

phone and asked him to Rafiq was on the other end and he questioned how he would gather so much money. He asked Rafiq to sell his Noah microbus for Tk 12 lakh, take Tk 1.5

lakh from his savings and borrow the rest. The next day his father went to meet OC Pradeep but was told that his son was not at the police station, the verdict said. The father went to meet Pradeep again two days later and was told to pay Tk

7 lakh in exchange for his His father bargained and offered Tk 6 lakh. That night, at 1:30 am, constables Sagar and Rubel took him to Marine Drive and asked him to recite the

"You will shoot me. I want to talk to OC sir one last time," Jalal told them. He was allowed to speak with the OC.

"I have four sons and one daughter. If you kill me, their future is doomed. I owe people around Tk 1 crore," Jalal told the OC and begged for two days. At that moment, the OC got a

The next day, he was charged with possessing 3,000 pieces of yaba. His father came to the police station, cried and said: "You took Tk 6.4 lakh from me to release my son." Jalal was in jail for three months.

Earlier on December 13,

2018, his younger brother Yusuf Jalal was detained by the police, the witness testified. He said that a Teknaf municipality driver came to their house and conveyed that Pradeep said that Yusuf can be released

for Tk 1 crore. They could not manage Tk 1 crore, and later that night, around 1 am, Yusuf was killed in a crossfire at Moulvipara neighbourhood. Nurjahan, a resident of a house nearby, witnessed the incident and fainted, Jalal

The court also took testimony from Daily Cox's Bazar Editor and Publisher Faridul Mostafa Khan, who was tortured by Pradeep for his journalism. Khan had published

news about Pradeep killing people in the name of crossfire, which angered the cop. When the cops tried to

detain Faridul, he escaped to Dhaka. He even wrote a letter to the Prime Minister, home minister and inspector general of police seeking help. The letters were submitted to the court.

Faridul had also filed a writ petition with the High Court seeking safety for himself and his family. On September 21, 2019,

Faridul was picked up from his home in Dhaka's Mirpur neighbourhood and brought to Teknaf police station.

He testified that the criminals stripped and videoed him. They rubbed chilli powder on his eyes and beat him up with

hockey sticks. He told the fate if his wife did not pay court that OC Pradeep had urinated on his face.

Later that day he was taken to Marine Drive and was threatened with crossfire, but they changed their mind and prosecuted him for drug possession instead.

"Sinha would not have been killed if Farid's journalism had been paid heed, and Pradeep transferred out of Cox's Bazar," the court said.

Another victim Baby Begum testified. In 2019. fifteen days after Eid-ul-Fitr, OC Pradeep and 14 others raided their house for yaba.

Úpon not finding yaba, they beat up her husband Ziaur Rahman, her 15-yearold daughter Nazneen Akhter and looted the house. She told the court that a constable took naga chilli peppers from the kitchen and rubbed them

on her daughter's face. Then the husband and the daughter were taken to the police station, she said. An informer visited their family and told Baby to pay Tk 5 lakh for the daughter and Tk 40 lakh for the husband.

When Baby said that she did not have that much money, they prosecuted Naznin with 2,000 pieces of vaba and OC Pradeep himself called Baby and threatened to kill Ziaur in a crossfire. Ziaur had been in illegal detention for 18

During his detention, he was taken as an eye-witness to three crossfires and threatened with the same

Baby managed Tk 15 lakh and handed it over to Pradeep via informers.

She was on her way to Cox's Bazar to see her daughter when she was picked up by cops claiming to belong to the Detective Branch and later slapped with three cases.

Baby also said that when she met her daughter at court, Naznin told her she was sexually abused by the

#### PRADEEP DEFLECTING BLAME

The verdict observed that in a last-ditch attempt to save himself, Pradeep tried to make others scapegoats.

When the prosecution finished their arguments, and the judge called the defence, Pradeep, who was standing on the docket, yelled and said he wants to say something.

"Liaqat killed Major Sinha. I did not command him to kill Sinha," he said.

When the asked him to explain sub-inspector whv Nandadulal Rakshit had said otherwise in his statement, Pradeep said: "I did all this upon the directives of SP Masud."

Contacted. Superintendent of Police ABM Masud Hossain said he had heard that Pradeep had tried to deflect blame but did not want to comment further.



# Too many yet too few caesarean section deliveries in Bangladesh

A study of a total of 27,093 women's data taken from five rounds of the Bangladesh **Demographic** and Health Survey conducted between 2004 and 2017/18 was conducted in order to reach this conclusion. According to the World Health Organisation (WHO) data published in 2021, the number of cesarean sections (CS) performed continues to climb worldwide, representing 21 percent of all deliveries currently, with significant variation among countries.

Around 42 percent of all CS procedures performed worldwide are conducted without a medical necessity. As a result, they do not contribute to improving mother and child health in the world. Even more concerning, such inappropriate use of CS can result in a variety of undesirable effects, including hemorrhage and bleeding, in addition to linked maternal mortality and economic cost. Furthermore, it has been discovered that this is associated with a long-term loss of women's productivity and increased hospitalisation, both of which add to the strain on the formal healthcare delivery system.

The use of caesarean sections (CS) is growing rapidly in Bangladesh, despite the fact that CS use is still uncommon among women from disadvantaged backgrounds. Among low-income mothers, this raises the likelihood of long-term obstetric complications, as well as the possibility of maternal and child fatalities. According to a study published in the journal PLOS Global Public Health, the researchers sought to examine the interaction impacts of women's disadvantaged characteristics on their use of contraception in Bangladesh.

A study of a total of 27,093 women's data taken from five rounds of the Bangladesh Demographic and Health Survey conducted between 2004 and 2017/18 was conducted in order to reach this conclusion. A 751 percent



increase in CS use was discovered during the study's 13-year period, with consumption rising from 3.88 percent in 2004 to 33percent in 2017. Private health facilities accounted for about 80 percent of the total CS operations, with government health facilities coming in second (15 percent).

In rural regions with no participation in formal income-generating activities showed an 11 percent lower usage of CS in 2004 than women living in urban areas with no involvement in formal income-generating activities. Over time, this correlation has been more robust, and a 51 percent decrease in CS use was observed in 2017/18, indicating a more established relationship. In a similar vein, rural poor and poorer women were shown to have decreased chances of using

CS by 12 percent to 83 percent.

CS use is increasing in Bangladesh, as evidenced by the fact that a group of women with improved socio-economic circumstances are utilising this life-saving therapy without a medical necessity, while their counterparts with disadvantaged characteristics are unable to access the

Therefore, government programmes and regulations are essential for determining the need for CS and controlling its use in general and private health facilities in particular. The government could also set regulations on private health facilities, requiring them to provide CS when medically essential among the disabled for a small fee or even free of charge when necessary.

#### **Optimising indoor** lighting may help reduce the metabolic effects of prolonged indoor lighting exposure

According to a new Diabetologia study, obese, insulin-resistant adults' sleep energy expenditure is affected by the timing of light exposure. Therefore, optimising indoor lighting more like natural light/dark cycle may help lessen negative impacts on whole-body energy and glucose metabolism.

A 24-hour cycle of light and dark is required to synchronise the body's circadian clock. Obesity and cardiovascular disease are connected to solid light exposure late at night or early in the morning. People are exposed to glare at home, at work, or via screens of electronic gadgets at night since modern light is widespread and available

24/7. Light at night (LAN) exposure is linked to an increased incidence of

type 2 diabetes in the elderly. The modern culture also lacks time spent in intense light during the day. In reality, most time is spent indoors, with artificial light levels far below natural daylight.

The study indicated that spending the day in bright light reduced blood glucose levels

before dinner. Exposure to the dim day - bright evening condition reduced sleeping metabolic rate (SMR) and energy expenditure after the meal. This illumination cycle also decreased melatonin production, which should rise 2-4 hours before bedtime to reduce natural

The study reveals that insulin-resistant people's indoor light environment can change metabolic parameters time-dependent, affecting long-term metabolic health.

#### Obesity may increase risk of some female reproductive disorders

Obesity is associated with an increased risk of developing female reproductive disorders. A study in PLOS Medicine suggests an etiological link between obesity and a range of female reproductive disorders.

Researchers conducted a study investigating the causal associations between obesity, metabolic hormones, and female reproductive disorders. They found observational associations between obesity and a range of female reproductive disorders, including uterine fibroids, polycystic ovary syndrome, heavy menstrual bleeding, and pre-eclampsia. They also found that some inherited genetic variation associated with obesity is related to female reproductive disorders. Still, the strength of those associations differed by type of obesity and reproductive condition.

The results suggest exploring the mechanisms mediating the causal associations of overweight and obesity on gynaecological health to identify disease prevention and treatment targets.

## Experts warn of increasing overmedicalisation of death and urge a radical societal rethink

Globally, health and social systems fail to provide adequate, compassionate care for dying people and their families. Millions of people suffer needlessly due to the current emphasis on aggressive treatments to prolong life, global disparities in palliative care access, and high costs of end-of-life care. The Commission recommends a compassionate community model where communities and families collaborate with health and social services for the dying. As a result of the COVID-19 pandemic, many people have died alone, only communicating with their families via digital means.

During the last 60 years, health systems have taken over responsibility for dying. Most end-of-life care is provided in hospitals in the UK. Healthcare has alienated families and communities. People rely on health systems more because of this loss. Despite this, discussions about death and dying are often complex and stressful.

The Commission sets out five principles of a new vision for death and dying:

1. To live healthier lives and die more equitable deaths, we must address the social determinants of death, dying, and grief.

2. Relationships based on connection and compassion are prioritised and made central to the care and support of people dying or grieving.

for the dying, caring, and grieving. 4. Conversations and stories about everyday death,

3. Professionals must be included in networks of care

dying, and grief can help spark larger public debates

5. Death must be recognised as having value. "Without death, every birth would be a tragedy." To achieve the widespread changes needed, the Commission sets out key recommendations for



policymakers, health and social care systems, civil society, and communities, which include:

>> Education on death, dying, and end-of-life care should be essential for people at the end of life, their families, and health and social care professionals.

>> Increasing access to pain relief at the end of life must be a global priority, and the management of suffering should sit alongside the extension of life as a research and health care priority.

>> Conversations and stories about everyday death, dying, and grief must be encouraged.

## **England** next for Langer?



#### Fresh health setback for Cairns

New Zealand cricket great Chris Cairns revealed Saturday he has suffered a further health setback and has been diagnosed with bowel cancer.

Cairns was only discharged from hospital last week, five months after he underwent a lifesaving heart operation and was then paralysed by a subsequent stroke.

"Another fight ahead but here's hoping this one is a swift upper cut and over in the first round," the 51-year-old, one of the world's top all-rounders in the early 2000s, said on social media.

"I was told yesterday I have bowel cancer... big shock and not what I was expecting.

"So, as I prepare for another round of conversations with surgeons and specialists, I keep remembering how lucky I am to be here in the first place."

# Rohit era begins today

India captain Rohit Sharma on Saturday ruled out drastic team changes in the wake of Virat Kohli's departure as skipper ahead of the hosts' 1,000th one-day international against the West Indies.

whitewashed 3-0 in ODIs. "We have played good ODI cricket over the course of few years, more than four years actually, so suddenly a loss of



series doesn't mean that there is panic," Rohit told reporters.

'South Africa series was a great learning (experience) for us as to what we didn't do collectively as a team," he

"What is important for us, moving forward, is the role clarity of certain individuals in the squad."

While Kohli was known for aggression in his seven-year term as captain across formats, Rohit, who has led the Mumbai Indians to five IPL titles, is known to lead with calm.

Rohit, called "Hitman" for his flamboyant batting and big hitting, said he will not tinker with the template that Kohli

created. "When Virat was captaining, I was the vice-captain so we pretty much went about the team in a similar fashion," said

"I just have to take it from where he left. The team pretty much knows what is expected out of them. And we want to continue the same template," he added.

"There is nothing that I need to come in and change drastically."

India's squad has been hit by Covid with four players

including Shikhar Dhawan and Shreyas Iyer testing positive ahead of the limited-overs

Rohit said Ishan Kishan remains the only opening choice in the first ODI, when India will become the first international team to have played 1,000 50-over matches.

The opening batsman said he wants to bring the spin combine of Yuzvendra Chahal and Kuldeep Yadav back into the fold.

Chahal, a leg-spinner, played the ODI series in South Africa but injury-plagued Yadav, a left-arm wrist-spinner, last played an international for India in July.

"These two guys have been great performers for us in the past and they have certainly created an impact in those vears whenever they have played together," said Rohit.

In the middle they were left out because of the combination we wanted to get... but it's certainly on my mind to get them back together, Kuldeep especially,"

he added. "But we want to get him in slowly. We don't want him to rush into things."

# Mane, Salah face off in AFCON final tonight

One of world football's most exciting attacking duos will face-off against each other in Sunday's Africa Cup of Nations final as Mohamed Salah leads Egypt against a Senegal side spearheaded by Sadio Mane.

The Liverpool pair, a combined force at club level, will be taking on talismanic roles at opposite ends for their respective countries as Egypt seek to extend their record number of Cup of Nations triumphs to eight while Senegal look to win it for the first time.

Salah has made no secret of his burning desire to win a major trophy with Egypt, which has so far evaded him, while Mane beamed with joy and giggled with delight at the post-match press conference after his team won their semi-final on

Senegal, who are Africa's top ranked team, were among the favourites and overcame a languid start to reach the final for the third time.

They scored only one goal during the opening round but still finished top of their group and have looked efficient in overcoming their opponents in the knockout stage.



But their road to the final proved a lot easier than Egypt, who lost their opening group game to Nigeria and drew heavy criticism from home fans for their early performances.

But they have gained momentum, edging the Ivory Coast in a penalty shootout in the round of 16; Morocco 2-1 after extra time in the quarterfinal and hosts Cameroon on penalties again in Thursday's semi-final.

Around 11:30am, (on February 21, 1952) police fired tear gas as students started coming out of the university in groups. Initially, we kept a list of those who were coming out as well as those who were arrested. But it was no longer possible after a while as students rushed out in large numbers.

In the morning, a part of the wall

between the university and the medical college was demolished. While I and Oli Ahad were leaving Modhur Canteen, we heard shots being fired at the Medical College dormitory compound. The students were shouting through the microphone. We started running and as soon as we reached the medical, we saw the injured students being taken to the emergency room of the hospital.

I stayed at the emergency section of the hospital. Sitting on the lawn I began to cry. I started having doubts about the decision to break Section-144. At that time several university students came to me and said that a leaflet had to be distributed immediately. They added that another leaflet had been drafted, but the convener of the All-party State Language Action Committee, Kazi Golam Mahbub, refused to sign it. I took the draft leaflet from them and met Kazi Golam Mahbub. He was also at the emergency section at that time. He started blaming

# Coastal areas still littered with them

DoE fails to comply with HC order to stop their use by 2021

The Department of Environment has failed to comply with a High Court directive that asked it to stop the use of single-use plastic in hotels, motels, and restaurants of coastal areas in two years.

The HC had issued the

directive in January 2020 in response to a writ petition filed by Bangladesh Environment Lawyers Association in mid-2019. The DoE was asked to put an end to the use of such plastic by 2021.

The government department last year launched a three-year (2021-23) project to stop the use of single-use plastic in 12 coastal districts. It has so far held just one meeting with hotel, motel owners in Cox's Bazar.

The HC in its order had also asked the DoE to submit a compliance report to it by 2021, but the government body responsible for protection of the environment is yet to do so.

Abul Kashem, general secretary of Cox's Bazar Hotel,

Motel Owners Association, said the DoE held a meeting with them in Cox's Bazar last year. Officials at the meeting encouraged hotel, motel and restaurant owners to stop using single-use plastic.

"Since then, we have not seen any step by the department to contain single-use plastic," he added.

Speaking to The Daily Star, Razinara Begum, director (waste and chemical waste management) of DoE, said they in cooperation with World Bank prepared a roadmap to stop the use of single-use plastic in hotels, motels, and restaurants.

Asked about the reason for the delay in complying with the HC directive, she said, "We need time to make people aware of pollution and prepare them mentally to look for alternatives to single-use plastic."

Razinara said they identified coastal areas exposed to plastic pollution and held consultation meetings with different stakeholders.

"We can't stop its use overnight. We have to reach the goal of zero single-use plastic with cooperation from all," she added.

Single-use plastic includes single-use cups and plates, lollipop sticks, wrappers, sachets, extruded polystyrene, plastic cutlery, cigarette filters, cotton swabs, coffee stirrers, small water and juice bottles, plastic bags and multilayer plastic packaging.

Concerns are growing worldwide about plastic pollution, especially in oceans, where nearly half of the singleuse plastic products end up, causing deaths to marine life. Plastic also enters the human food chain, multiple studies have found.

Syeda Rizwana Hasan, chief executive of Bangladesh Environment Lawyers Association, said she sees no reason why the delay in complying with the court order occurred.

#### Daily Covid deaths on the rise again

The daily death toll from Covid-19 rose again yesterday as the health directorate reported 36 deaths in 24 hours till 8:00am, up from 30 the previous day.

On Wednesday, the figure was 36, the highest since September 22 last year.

With the latest count, the total number of Covid deaths in the country went up to 28,560, according to the Directorate General of Health Services (DGHS).

At least 8,359 people tested positive for Covid-19 in the same 24-hour period, raising the total number of confirmed cases to 18,53,1887.

The positivity rate stood at 23.83 percent after testing 35,074 samples countrywide.
The overall positivity rate is 14.61 percent.
At least 7,017 Covid patients have recovered

At least 7,017 Covid patients have recovered during the 24 hours, taking the total number of recoveries to 15,94,391. The recovery rate is 86.04 percent.

Of the 36 deceased, 21 were males and 15 females.

Of them, one was aged between 21 and 30 years, two were between 31 and 40, two between 41 and 50, six between 51 and 60, and 25 were above 60 years, said a DGHS release.

Fuelled by the Covid Omicron variant, the country started witnessing the third wave of the virus in the beginning of last month. The daily positivity rate hit 34 percent mark in the last week of January, the highest in the country so far.

However, Bangladesh is seeing a decline in the number of cases since early this month.

#### Zoo, park animals dying from diseases Says fisheries minister

SM Rezaul Karim, minister for fisheries and livestock, yesterday said the foreign animals in Bangladeshi safari parks and zoos are dying from infectious diseases.

He said this while talking to the journalists at the foundation laying ceremony of the Institute of Livestock Science and Technology in Sylhet.

About the recent animal deaths at the Bangabandhu Sheikh Mujib Safari Park in Gazipur, he said, "Bangladesh's climate and environment are unfamiliar to the foreign animals, which is why they are being infected by diseases.

"The zebras died of a disease. Lab reports showed that the other animals also died from similar ailments."

The minister added, "We are looking into whether there was any negligence on our part... Different ministries are working together to make sure no wildlife dies, and the environment and climate are not destroyed."

Rangpur Zoo's only tigress dies On Friday night, the lone tigress of Rangpur Zoo died from old age, said zoo officials. Ambar Ali Talukdar, deputy curator of Rangpur Zoo, confirmed the death yesterday

The tigress, named Sawan, was brought to the zoo in 2010.

# Covid pandemic begins to ebb

## Shows weekly data; cases drop by a 10th after rising for 15 weeks, deaths rise by 16pc

The Covid-19 pandemic started to ease around the world this week after a three-and-a-half-month rampage of ever-increasing infections, AFP data published yesterday showed.

The average number of global daily cases dropped by a tenth this week to 3.03 million, after increasing for 15 weeks in a row, according to an AFP tally to Thursday. Almost every region of the world saw

an improvement over the past seven days. In the United States/Canada zone the number of new daily cases dropped by 38 percent, while Africa saw a 21 percent fall and Asia a 16 percent drop. Cases in the Latin America/Caribbean zone decreased by 13 percent and in the Middle East by four percent.

The situation was almost stable in Europe, with a one percent rise. Once a

catch-up in Australian figures is factored out, the number of infections in Oceania decreased by around a tenth.

Iran saw the biggest spike in the number of new cases this week with a 233 percent rise. The Solomon Islands in the Pacific

followed with 138 percent more cases, Armenia with 137 percent, neighbouring Azerbaijan was 133 percent up, while cases doubled in South Korea. The Dominican Republic saw the

biggest drop of the week with 65 percent fewer cases, followed by Nepal with 55 percent less, Argentina (down 51 percent), Jamaica (minus 50 percent) and Morocco (minus 49 percent).

The US remained by far the country with the highest number of new cases with 362,800 per day on average, which nevertheless was a drop of 39 percent on
