## Hasina gets list from top AL leaders

Will send the final names to Cabinet Division tomorrow

Awami League presidium members yesterday gave party chief Sheikh Hasina their recommendations of individuals who would form the next Election Commission.

The individuals recommended include a former chief justice, a former cabinet secretary, a former chief of army staff, a former inspector general of police, a retired brigadier general, a former chairman of Public Service Commission, and a former finance secretary, said a presidium member who attended the meeting with Hasina in the chair yesterday afternoon.

The prime minister said she would shortlist 10 individuals recommended by the presidium members and send it to the Cabinet Division on Thursday.

## Truck tears apart family

Runs over and kills 5 brothers, 2 other siblings now in hospital

Five brothers were killed after a pickup truck ran them over vesterday morning while they were returning from a crematorium after performing the funeral rites for their recently deceased father in Chakaria, Cox's Bazar.

The brothers who died are Anupam Shil, 47, Nirupam Shil, 45, Saran Shil, 43, Dipak Shil, 40, and Champak Shil, 30, said Safayet Hossain, officer-in-charge of Malumghat Highway Police Station in Chakaria.

The tragedy left their mother Manu Bala Shil in shock and their neighbourhood in Sagir Shah Kata village in tears.

The brothers were preparing to observe Shraadho, a ritual in Hindu religion of paying homage to a dead parent performed days after the death.

They had set up a marquee in their relatives to attend the last funeral rite for their father who died 10 days ago.

The incident happened when nine siblings were crossing the Chattogram-Cox's Bazar highway, said the officer.

Seven of them were severely injured and immediately taken to Malumghat Christian Memorial Hospital, he added.

Doctors declared four of them dead and sent Saran and Raktim to Chattogram Medical College Hospital. Saran succumbed

to his injuries in the afternoon, he said. Raktim and his sister Hira Shil are undergoing treatment at different hospitals. A sister and brother were unhurt.

The bodies of the five brothers were laid down in a row under the marquee.

### FIVE YEARS OF HUDA-LED EC Intention in

"Our first challenge is to hold a free and fair election and then to win the confidence of all political parties, including the BNP," Chief Election Commissioner KM Nurul Huda told a news briefing five years ago after

But a number of political parties, election experts and civil society members on multiple occasions said the CEC and his team failed miserably to do either.

They raised questions over the CEC's intention to hold free and fair elections as things turned worse compared to the tenure of his predecessor, Kazi Rakib Uddin.

In the controversial general election on January 5, 2014, held under Rakib-led commission, a majority of the candidates, 153 to be exact, won uncontested as the BNP and other political parties boycotted the

The Huda-led commission, which completes its five-year tenure on February 14, earned the bad name for failing to check alleged ballot stuffing the night before the 2018 parliamentary polls.

It also faced huge criticisms over the 100 percent vote cast in over 200 polling stations in that election. Besides, a record number of candidates got elected unopposed in

local government elections marred by widespread irregularities like ballot stuffing and capturing of booths. Clashes over Union Parishad polls held in phases left around a hundred people dead.

"The current commission's controversial activities rather heightened people's mistrust in the constitutional body, and caused some irreparable damage to the electoral system," said Shusashoner Jonno Nagorik (Shujan) Secretary Badiul Alam Majumdar.

"This Election Commission has snatched people's voting rights," he

The incumbent EC was formed on February 15, 2017, and held the 11th

national election on December 30, 2018.

The next day, opposition political parties raised allegations that "ballot stuffing took place on the night before the election day".

Transparency International Bangladesh in a report on January 15, 2019, said electoral irregularities like stamping ballot papers the night before the polls and ballot stuffing by capturing booths on the election day took place in 47 out of the 50 constituencies it surveyed.

Other irregularities include inaction of law enforcers and administrative officials, fake vote casting, barring of voters and polling agents to enter polling stations, and forcing

people to cast vote for a specific symbol, the study found. "Ballot stuffing on the night before the election day is a big example of how people's voting rights have been snatched," Badiul Alam said.

Citing EC data, his organisation in July 2019 said 213 polling centres of 103 constituencies saw 100 percent vote cast, which is unbelievable.

Yet the Election Commission "could do nothing".

CEC Huda said it was because no aggrieved person went to the court to complain about ballot stuffing the night before the election day.

"I cannot say anything conclusive based on allegations. Because I did not see it. You didn't see it either," he told a press meet on SEE PAGE 2 COL 3

## Letters to reach parties today seeking names


The search committee tasked with making recommendations for appointments to the next Election Commission will write to registered political parties today seeking names for chief election commissioner and election commissioners.

By noon today, letters will be sent to all registered political parties as well as civil society members, election experts and a cross-section of people for nominations, Cabinet Secretary Khandker Anwarul Islam told journalists yesterday after the search committee's twohour-long second meeting, where the decision was made.

The parties must send their proposed names either via hardcopy to the Cabinet Division or by email to gfp\_ second@cabinet.gov.bd by 5:00pm on Friday

There will be arrangements in the Cabinet Division to enable political parties and any individual to submit the

proposals, he said. The six-member search committee will hold three meetings on Saturday and Sunday -- from 11:00am to 12:30pm, and 12:45pm to 2:15pm on Saturday and from 4:00pm on Sunday -- with cross-sections of people at the Supreme Court Judges Lounge.

At least 43 Covid-19 patients died in 24 hours preceding 8:30am yesterday, the highest single-day death toll since the third wave of the virus hit the country early last month.

This is also the highest single-day fatality from novel coronavirus since September 19 last year.

On that day, the Directorate General of Health Services (DGHS) had also reported 43 deaths. At that time, the Delta Covid variant was the most prevalent strain of the virus in the country.

The new Omicron variant spread since January. The daily positivity rate rose to the all-time highest 33.37 percent on January 28, up from only 2.43 percent on January 1

Yesterday, a total of 8,354 new Covid cases were logged in those 24 hours. The positivity rate was 20.03 percent.

With the latest count, the total number of deaths rose to 28,670 and the total number of confirmed cases went up to 18,79,255. Of the 43 deceased, 26

were males and 17 females. Meanwhile, 10,800 Covid patients recovered in the same 24-hour period.

#### Dozens killed as fighting rages around Yemen city

Dozens of Yemeni progovernment fighters have been killed in a new offensive to take a rebelheld city, loyalist sources said yesterday, following a surge in violence including missile attacks on the United Arab Emirates.

Thirty-two soldiers have died and at least 100 have been wounded in three days of fighting to drive the Iran-backed rebels from Haradh, north of the capital Sanaa and near the order, the sources said.

## Not a run-of-the-mill dialogue

Set for March 20 in new reality after sanctions on Rab

US-Bangladesh Partnership Dialogue is going to be held on March 20 under a new reality when the bilateral relations witness strains following the US sanctions on Rab and not inviting Bangladesh in Biden's Democracy Summit.

Foreign Secretary Masud Bin Momen and US Under-Secretary for Political Affairs Ambassador Victoria Nuland will lead the eighth round of the dialogue, an annual meet that began in 2012. The last meeting was held in 2019.

The dialogue could not happen in the last two years due to the pandemic. So, we had proposed the dialogue be held soon. The US agreed that the talks be held on March 20," said a foreign ministry official.

It will cover overall relationships, including political, security and economic cooperation. As a host, Dhaka will prepare the dialogue agenda, he said.

"As the issue of sanctions on Rab is an important one for us, we will obviously raise it and present a true picture," the official said.

Asked, former foreign secretary Shahidul Haque said it is a big advantage that Dhaka will prepare the agenda. Thus, Dhaka can prioritise its issues.

"However, what remarks Bangladesh officials are making in public are also

being counted in Washington on the sanctions. Our overall approach is very important in dealing with the sanction issue. We also need to do reality check," he told this correspondent.

Diplomatic sources said the US is likely to focus on a free and fair national election next year, improving governance, environment, labour rights, and freedom of speech. Specifically, it will talk about amending certain provisions of the Digital Security Act that has been criticised for stifling dissents and journalists, they added.

Washington will also stress on Bangladesh's cooperation in the US Indo-Pacific Strategy aimed at ensuring free and open Indo-Pacific, they said.

During 2019 dialogue, the US had pledged that it would provide additional security assistance for Bangladesh to increase maritime domain awareness, piracy, and regional security coordination in the Bay of Bengal. Washington also had requested Dhaka to continue the discussion on protection of classified military information shared between the two countries.

In October 2019, Washington also wanted Dhaka to sign two defence agreements -- General Security of Military and the Acquisition Cross-Servicing

Agreement (ACSA), which US officials say are "foundational agreements" meant to strengthen defence relationship.

These issues may also come up during the dialogue, diplomatic sources said.

A foreign ministry official said Bangladesh will hold security dialogue with the US on April 6 when they will discuss in detail defence and security

Meanwhile, in a letter to Dhaka on December 1 last year, Washington asked Dhaka to inform in writing the consent to the Leahy Law that governs assistance for security cooperation. But Dhaka sought extension of time twice though it was scheduled to inform Washington by

Bangladesh has been getting security cooperation from the US pursuant to the Leahy Law, which came into effect in 1998, but the new consent was necessary for the amendments made last year.

Under the law, Dhaka needs to inform Washington about the security agency that will use the US assistance.

Foreign ministry officials said Dhaka and Washington were still discussing the

A diplomatic source said delay in sending the consent by Dhaka means assistance.

Indian army rescuers yesterday recovered the bodies of seven soldiers buried in an avalanche while on patrol along a remote Himalayan frontier contested by China.

The troops were part of a larger deployment in Arunachal Pradesh state and were caught at an altitude of 4,400 metres (14,500 feet) in an area that had seen heavy snowfall in the days before Sunday's avalanche.

Two days of searching in rough weather ended without the rescue team finding any survivors among the missing soldiers.

"Unfortunately, despite the best efforts of everyone involved, all seven have been confirmed deceased," Lieutenant Colonel Harsh Wardhan Pande, an army spokesman, said in a statement.

The EC in July-August 2017 held dialogues with different political parties and other stakeholders before the 11th national election. During the dialogue, BNP and its allies and some left political parties opposed the idea

of using EVMs. However, the ruling Awami League and four of its allies supported it.

"The Election Commission created controversies by using in elections. Someone can manipulate it digitally. There are still they do not have the voter verifiable paper audit trail mechanism [which allows and voters to verify that their votes have been cast]," said Badiul.

"Some developed countries are moving away from the system," he added.

Nurul Huda, however, considers EVM as an advanced system with which voters can cast their vote "accurately". He requested the next EC not to abandon the EVM system.

#### 2 including CMCH staff member sued

Govt medicine worth Tk 3.5 lakh recovered

Chattogram Medical College Hospital (CMCH) authorities yesterday filed a case against two people, including a staff member of CMCH, with Panchlaish Police Station over stealing government medicine.

Meanwhile, police recovered government medicine worth Tk 3.5 lakh from a house near CMCH, said Arafatur Rahman, additional deputy commissioner of Chattogram Metropolitan Police.

Jahedul Kabir, officer-in-charge of Panchlaish Police Station, said during primary investigation, police came to know that a nexus consisting of CMCH staff members and outsiders used to steal government medicine worth Tk 15,000 to Tk 20,000 -- from different wards of the hospital every day to sell those outside.

"We have identified the group and are trying to arrest the other members," he added.

On Monday, on-duty Ansar men and police at CMCH detained two people while syphoning government medicine from the hospital.

The detainees are Ashu Chakraborty (32), an office assistant at CMCH, and his accomplice Md Syed (50), according to sources at CMCH Police camp.

CMCH Director Brig Gen Shamim Ahsan said after searching their bag, police found government medicines that were supplied to the hospital for patients. Later, upon their confession, police conducted a drive to a nearby house and recovered more medicine that were stolen from the hospital earlier, he said.

### 'Inform the people, be transparent'

TIB, TIM call upon govts to reveal content of recently signed MoU to tackle syndicate

STAFF CORRESPONDENT

Bangladesh and Malaysia must release details of the memorandum of understanding (MoU) they signed on December 19, 2021 to recruit Bangladeshis in Malaysia, said Transparency International Bangladesh (TIB) and Transparency International Malaysia (TIM) yesterday.

They issued a press release from Dhaka and Kuala Lumpur and called on respective governments to take preventive measures against all possible forms of corruption, including syndicate control in the

recruitment process, to protect interests of Bangladeshi workers and Malaysian employers.

Citing recent media reports from both countries, TIB and TIM expressed deep concern that a section of Bangladeshi recruiting agencies are trying to manipulate the recruitment process with the (unscrupulous) efforts of their Malaysian partners, while the governments have failed to disclose the content and terms of the MoU.

governments' national and international commitments to control corruption and establish the right to

Over the last few years, Jahangirnagar University (JU) authorities have made many promises to its students regarding several unresolved issues. However, not much progress has been made on those fronts.

"We will take immediate steps" or "we will discuss the matter" are common words of reassurance coming from the authorities. However, these words have made little to no effect when it comes to resolving the issues for real.

On June 28, 2019, JU Vice-Chancellor Prof Farzana Islam declared to hold Jahangirnagar University Central Students' Union (Jucsu) polls by November that year, followed by a senate

"Once they also set fire to my net. This time, they came for our homes," Bishwanath said. "When we tried to get out [during the fire], we

found that the main gate was locked from the outside," he said. Bishwanath also mentioned that they managed

to get out through an alternative exit.

Khair Hossain, Sonaichhari Union Parishad member, suspects that the incident was a sabotage. "We have asked police to take necessary action," he told The Daily Star.

On February 4, victim Bishwanath filed a case accusing unidentified persons with Sitakunda

Police Station. However, law enforcers are yet to arrest anyone

#### North Bengal Museum receives ancient statue of mythical Nandi

Kurigram police has formally handed an ancient stone statue of a bull, recovered from the ruined site of a Shiva temple in Kurigram's Nageshwari upazila in July last year, to the North Bengal

Kurigram Superintendent of Police (SP) Syeda Jannat Ara handed over the antique statue, weighing around 20 kilograms, to SM Abraham Lincoln, founding chairman of the museum, at the museum premises in Natuan Shahar area.

According to the police, a local farmer recovered the stone statue, which is 13 inches long and 5.5 inches wide, from the debris at Gonsair Bhita village on July 10 last year.

Following a court order on February 7, the stone statue of a bull was handed to the museum authorities yesterday noon, Sub Inspector (SI) of Nageshwari Police Station Anwarul Islam said.

Locals said farmer Sridhar Chandra recovered the reddish-white statue while he was collecting brick pieces from the ruins of the Shiva temple. The matter was later reported to the local



police, who recovered the antique from Sridhar's

house the same night, they informed.
Centenarian Madhusudan Sarkar of the village said in his childhood he had seen an ancient temple made of bricks and rubble.

There was a ditch from the temple to the adjacent Kashirdara river that has a brick-built ghat on its bank.

He had heard from his grandfather that the area was once overgrown with bushes, he said, adding that a devotee, whom locals used to call Gonsai, built a temple on the bank of Kashirdara and set up a 'Shiva Linga' there.

Later, the temple became known as Gonsair arena and the village is named as Gonsair Bhita.

## Development project chokes canal

Boro cultivation uncertain



Boro cultivation on 5,500 hectares of land in Brahmanbaria's Sarail upazila is uncertain due to filling up of an important canal. The canal has been choked by the contracting firm to facilitate the development work of Ashuganj-Akhaura four-lane national highway.

Cultivation of Boro on about 5,500 hectares of land in the current season seems uncertain due to the filling up of an important canal for a development project in Sarail upazila of Brahmanbaria.

Due to the up-gradation of 50.58 km-long road from Ashuganj river port to Akhaura land port to four lanes, 11km-long canal from Ashuganj to Sarail Bishwa road intersection has been filled up resulting in complete cessation of water supply to 5,500 hectares of land.

As a result, 20 thousand farmers of 15 villages in the upazila have been spending their days amidst grave uncertainty over Boro cultivation.

Consequently, it was not possible to release water from 'Ashuganj Sabuj Prokolpo', one of the largest irrigation projects in the country. The water of the project, which would reach the farmlands through the canal, used to be released at the beginning of January every year.

Due to lack of water, seedbeds are turning red and paddy saplings are drying up, farmers said.

Farmers incurred losses last year and this year the situation is worse, they said. While visiting the area, it was seen that the trace of the canal was difficult to locate.

The irrigation crisis is hampering their Boro cultivation as water has not come to the canal though the cultivation season is about to over, they said.

They alleged that the contracting farm of the development project-Mumbai-based Afcons Infrastructure

Limited—did not dig an alternative canal although it had been stipulated in the contract.

Devdas Singh Roy, president of Bangladesh Krishak Samity, Sarail upazila unit, said the possibility of Boro production in the upazila this year is thin

The poor farmers have been worst hit due to the cessation of irrigation, he said, adding that a memorandum was submitted to the deputy commissioner in this regard.

In 2021, water flow was so low that one month into planting paddy cracks appeared in the dried up lands.

Farmers incurred losses last year and this year the situation is worse, they said. While visiting the area, it was seen that the trace of the canal was difficult

to locate. Sudhan Mia, a farmer of Shahbazpur village, said "Time is running fast but still we are not getting water. Thousands of bighas of land are lying barren due to lack of water." Aftab Mia, a resident of Islamabad

village in the upazila, said, "There is no water in the canal yet. I am in big trouble as the seedbed is becoming dry."

Upazila Agriculture officer Ekramul

Haque said, "If seedlings cannot be planted within the next 10 days, the seedbeds will be damaged. Farmers can't install shallow power pumps in such a short period."

Rubayed Foysal Al Masum, executive engineer of the Bangladesh Agricultural Development Corporation (BADC) in Brahmanbaria said the contracting firm has choked the canal.

has choked the canal.

"We are digging the soil with excavators. Farmers may avail water in the next four or five days, but the flow will be low. Next year, an RCC canal having 4.5 meters width and 2.5 meters height will be constructed to keep the water flow normal," he assured.

and independents in 1,778. According to the EC, elections to the chairman posts of 369 were not required as candidates were elected unopposed and of them, 368 were AL ticket holders.

UP Besides, members and 403 candidates for women's reserved seats were also elected uncontested.

In this year's election, a total of 369 chairmen were elected uncontested in the six phases. It was much higher than the 2016 UP poll's 207.

This year's UP polls witnessed violence across the country.

According to media reports, at least 101 people have so far been killed and several hundred injured in violence centring the polls.

#### Momentous phase

Maulana Tarkabagish, Khairat Hossain and Anwara Khatoon with all congress members of the assembly walked out. The army was then called out and they started patrolling the streets.

The following day, more people were killed by the army.

The deceased included a Dhaka High Court clerk and a rickshaw-puller. The Central State Language Action Committee was dissolved on the basis of the resolution of the committee adopted earlier. The leadership was taken over by the Youth League and university students, who raised funds, hired microphones and placed them on the roofs of the halls to address others

Ministers took shelter in the cantonment area and for about a week, police oppression continued both in Dhaka and Narayanganj.

The leaders of the movement in Dhaka went underground, but they were arrested within a week. With that, the movement

entered the second phase. A new action committee was formed with Ataur Rahman Khan as its convener.

Ahmad Kamruddin actively participated in the Language Movement in 1948. In 1952, he was a member of the All-party State Language Action Committee.

#### **2008 ATTACKS** 49 convicted in India

AFP, Ahmedabad

India convicted 49 people yesterday over a 2008 attack in the western city of Ahmedabad that left dozens dead, in what perpetrators said was retaliation for earlier deadly communal violence.

The string of bombings killed 56 and wounded more than 200 others as shrapnel ripped through markets, buses and other public places in Gujarat

state's commercial hub. A group calling itself the Indian Mujahideen claimed responsibility, and said the act was revenge for 2002 religious riots in the area that left scores dead.

Nearly 80 people were charged but 28 were acquitted prosecutor Patel told reporters.

The remaining 49 defendants were all found guilty of murder and criminal conspiracy with sentencing to be issued on Wednesday, he added.

The marathon trial has lasted nearly a decade, with more than 1,100 witnesses called to testify. Proceedings were dragged out by procedural delays, including a legal battle by four of the accused to retract their confessions.

## Talent first casualty of dynastic politics'

Modi, in parliament, blames Congress for India's woes

Indian Prime Minister Narendra Modi, blasting the Congress and the Gandhis in parliament yesterday, said "talent is the first casualty of dynastic politics" and listed how the country would have been different "if there were no Congress".

The Congress walked out in the middle of the speech.

"The Congress's problem is it has never thought beyond its dynasty. The biggest threats to democracy are dynastic parties. And when a family becomes

paramount then the first casualty is talent," Modi said in Rajya Sabha, replying to a debate on government policies. He said Mahatma Gandhi

wanted the Congress to be scrapped. "This was Mahatma Gandhi's wish - he knew what would happen if they remained and said destroy this. If Gandhi's wishes had been followed, India would have been free from nepotism," he remarked.

"If, going by Gandhi's wish, there were no Congress, there would be no stain of Emergency. Corruption would not have been institutionalised for decades. There would have been no casteism or regionalism. Sikhs would not have been massacred. There would not have been an exodus from Kashmir," he added.

Hitting back at the Congress for accusing him of destroying federalism, Modi said the party had a history of dismissing state governments. "They believed in discredit, destabilise, dismiss.' He also commented that Congress "is trapped

in the ideology of urban naxals". 'That's why their mentality is destructive. Urban naxals took advantage of the Congress and

took over their minds.' India, he said, is known as the "mother of democracy", and democracy and debate was a tradition of centuries

Congress thinks the country was born only in 1947. This mindset is harmful for the country as its policies have affected the country's progress in the last 75years. We will never learn lessons in democracy from those who trampled over democracy in

1975," PM Modi said. The Indian PM in his speech also accused the Congress of submitting to the Gandhi family. "Whenever anyone in the Congress has spoken

against a particular family, the results have been there for all to see," he said, referring to Sitaram Kesri, who was removed as party chief.

This is Modi's second attack on opposition parties in two days. Speaking in the Lok Sabha on Monday, PM Modi didn't pull any punches and blamed the Congress for not doing enough to help the poor or keep its promises. He also repeatedly invoked India's civilizational unity and alleged that the Opposition was attempting to harm the country by pursuing the colonial goal of "divide and rule".

#### At UN, Russia, China call out 'unilateral sanctions

Russia, facing the threat of Western penalties over Ukraine, and China on Monday spoke out against what they called "unilateral" sanctions imposed by countries without the backing of the **United Nations Security** Council.

"Only Security Council sanctions are legal," said Russia's Deputy Ambassador to the UN Dmitry Polyanskiy.

But Polyanskiy denounced "unilateral" measures that hurt peace efforts and interfere with the sovereignty of nations, such as in Syria, Belarus, Cuba, Venezuela, Iran, Afghanistan, Burma.

For his part, China's ambassador to the UN Zhang Jun said that "coercive unilateral sanctions were a major source of concern."

UN sanctions are currently in place against 14 regimes around the world, affecting countries such as Libya, Yemen, Sudan and militant groups such as al-Qaeda and the Islamic State.

#### Covid test in 4 mins!

Chinese scientists say they have developed a new coronavirus test that is accurate as a PCR lab test but gives results within four minutes. Polymerase chain reaction (PCR) tests are widely considered the most accurate and sensitive for the virus that causes Covid-19, but they usually take several hours. Researchers from Fudan University in Shanghai say they have a solution. In a peerreviewed article published Monday in the journal Nature Biomedical Engineering, the team said their sensor -- which uses microelectronics to analyse genetic material from swabs -- can reduce the need for time-consuming Covid lab tests. The researchers said their method offers speed, ease of operation, high sensitivity and portability.

#### HORN OF AFRICA DROUGHT

#### 13m face hunger

AFP, Nairobi

An estimated 13 million people in Kenya, Somalia and Ethiopia are facing severe hunger as the Horn of Africa experiences its worst drought in decades, the World Food Programme (WFP) said yesterday. Three consecutive rainy seasons have failed as the region has recorded its driest conditions since 1981, the UN agency said. The drought has destroyed crops and inflicted "abnormally" high livestock deaths, forcing rural families who rely on herding and farming to abandon their homes. Water and grazing land is in short supply and forecasts of below-average rainfall in coming months only threaten more misery, said Michael Dunford, WFP's regional director in East Africa. WFP said \$327 million was required to respond to immediate needs over the next six months and support pastoral communities to become more resilient against recurring climate shocks.

#### 'Biden, Trump harmed US'

Iran's Supreme Leader Ayatollah Ali accused Joe Biden and Donald Trump of damaging the reputation of the United States in rare direct criticism of US presidents, Iran's official

IRNA news agency reported yesterday. These days, the US is being hit in ways it never computed. The two American presidents - the current and former heads of state - have joined hands to tarnish the image of the United States," Khamenei said without elaborating. Iran and the United States resumed indirect talks in Vienna yesterday to revive a 2015

nuclear deal that former-US Trump left in 2018. While the US State Department says such negotiations are entering their "final stretch", Iranian officials have declared that part of their demands on sanctions removal have so far been left unaddressed in the Vienna talks.

#### \$10m for IS-K head

The United States on Monday offered a \$10-million reward for information leading to the "identification or location" of the leader of the Afghanistan regional chapter of the Islamic State group. According to Washington, Sanaullah Ghafari -- also known as Shahab al-Muhajir was appointed head of IS-K in June 2020 by the Islamic State group. IS-K is the Afghan offshoot of IS, which originated in Iraq and Syria.



## Habitual revision of projects must stop

Govt should rethink how projects are planned and executed

TE are alarmed to learn of the enormous cost citizens are having to pay for the habitual revision of ill-planned and ill-executed government projects. There is a real image now to be attached to this revising spree. According to a report by The Daily Star, if we put together all the additional allocations approved for revised projects in this fiscal year so far, it would be enough to fund the construction of two Padma Bridges (the bridge cost Tk 30,192 crore). That's until February 8, when the Executive Committee of the National Economic Council (Ecnec) approved four project revisions, in addition to the 28 approved before, bringing the combined total of additional costs to nearly Tk 60,000 crore. That's how much money being thrown down the drain simply because the government couldn't ensure timely and smooth implementation of its development projects. Let that sink in.

We have repeatedly expressed concerns about this habitual revision of projects, particularly the implementation procedures of the ministries involved that lead to frequent time and cost overruns. Even Ecnec Chairperson and Prime Minister Sheikh Hasina also expressed her dissatisfaction on several occasions, and gave clear directives to check this vicious cycle—including one that a project cannot be revised more than three times. But all warnings seem to be falling on deaf ears.

While the reasons for revisions may vary from one project to another, there are some common factors like absence of proper feasibility studies, complexities in land acquisition, and lengthy procurement process, according to experts and officials. The presence of these bottlenecks and others causes problems at every stage of the implementation, sometimes even before a project gets underway. For example, it takes at least two years to pass the development project proposal (DPP). Add to that delays in the bidding process. Due to the time taken to get the projects approved and started, the estimates based on which the proposals are prepared often become dated, necessitating additional funds. There can be unforeseeable challenges (like the outbreak of the pandemic) too, but most of the challenges faced are procedural. Throw corruption into the mix, and you have a problem that is not a problem for those profiting off it.

We think without fixing how the public authorities go about planning and implementing their projects, and without ensuring greater accountability every step of the way, we cannot get rid of this revision culture. As well as the extra money that citizens have to pay for this every year, there is another cost that is often ignored—prolonged public suffering. Considering all this, the government must take this problem without the seriousness it deserves and take prudent measures to enhance the implementation capabilities of the ministries involved and punish those responsible for the costly delays.

## Watch out for ATM fraud

Police, banks must be vigilant against transnational scammers

T'S disquieting to learn that a transnational syndicate is involved in stealing money from the ATMs of local banks. The Dhaka Metropolitan Police's Counter Terrorism and Transnational Crime (CTTC) unit recently arrested some members of this syndicate, including its alleged mastermind Hakan Zanburkan, a Turkish citizen. Reportedly, he along with some Indian and Bangladeshi nationals have long been carrying out their fraudulent activities in the country. Hakan visited Bangladesh at least six times over the last five years. Last month, he went to several ATM booths of Eastern Bank Limited and tried to withdraw money about 84 times using cloned cards of at least 40 countries. However, his attempts were foiled by the anti-skimming technology installed by the bank.

In a confessional statement given by Hakan, the detailed procedure of how the gang operated was revealed. It was known that the gang had members in India, Pakistan, Mexico, Bulgaria, Bangladesh and Turkey. The CTTC investigation also found that Hakan, along with another Turkish national and two Bangladeshis, were arrested in India's Assam in 2019 for stealing around Tk 10 lakh rupees through such fraudulence.

Since the first incident of ATM card fraud was reported in the country in 2016, several such incidents have come to light. In all the cases, the involvement of foreign nationals was found. They used not only cloned cards but also other advanced technologies to steal people's money without leaving any trace. Reportedly, some Bangladeshi nationals also took training on cloning credit cards in foreign countries such as Russia.

We appreciate the efforts of the CTTC unit so far and hope that all other members of the gang will soon be apprehended. Since Hakan is one of the masterminds of this international ATM card skimming gang, police should immediately request other countries as well as the Interpol to provide them necessary information on their operations, which will help prevent such incidents in the future.

Meanwhile, all our banks must have the modern technologies needed to foil any such attempts of ATM fraud. The latest attempt to steal money from the ATMs of Eastern Bank Limited failed only because it had a robust security system in place. All our banks should learn from this incident and protect themselves by installing antimalware and anti-skimming systems and by addressing any existing system vulnerabilities.

Anticipating the problem, concerned educationists made four-point recommendations for learning recovery when schools reopened in September. These included: a) rapid assessment of grade-level readiness of students in Bangla and math at the primary school level and Bangla, English, math and science at the secondary level; b) helping schools and teachers to implement an intensive and accelerated remedial programme for these core subjects and foregoing the public exams at the end of Classes Five and Eight; c) guiding and assisting teachers to conduct the remedial lessons with online and in-person support; and d) extending the 2021 school year till June 2022 and changing the school calendar permanently as part of a two-to-three-year recovery plan.

Unfortunately, the authorities paid no heed to these ideas and insisted on sticking to their plan of going back to the pre-Covid normal routine, with not much success so far. The proposed learning recovery strategy remains relevant and necessary. The profound impact of the pandemic—which is not yet over—cannot just be ignored.

The difficulties are compounded by a pandemic of indecision and inefficiency. The decision to bring students of 12 to 17 years under the vaccine coverage came late. The bureaucratic hurdles of registration, documentation requirements, and the inadequate logistics of the inoculation being available in an accessible way in each institution still leave most students without vaccines.

This should have been a priority when schools opened in September. The schools are not better prepared today than a year ago with a systematic plan to apply a blended approach of combining digital and in-person learning. The inefficiency and indecision perhaps also have led to decision-makers ignoring the recovery recommendations.

For the sake of efficient, timely, and crisis-solving response to this unprecedented situation, it has to be first admitted that a real crisis exists that requires imaginative action. Three points warrant attention in a crisis-response mode.

First, in the crisis-response mode, some regular normal activities will have to be put on the back-burner to give priority to the learning recovery plan consisting of the key elements noted above. The curriculum revision and rolling out of the new curriculum, for instance, should be put on hold. The curriculum board instead needs to concentrate on the recovery plan, such as the tools for rapid assessment of core competencies, designing a remedial plan and assisting schools and teachers to implement it. At the same time, as much as possible, urgent actions should be formulated keeping in view the longer-term goals. The board should work with academia and education-focused NGOs in this

Secondly, the recovery plan has to be customised for different levels of education—early childhood and preschool, primary, secondary, colleges and university. There are also specific needs for technical and vocational education, non-formal education, madrasa education and private universities. Needs and prospects for the blended approach should be different for each of these levels and types.

Thirdly, the crisis responses, to be designed in a coordinated and holistic manner and with an eye for longer-term goals, are better done through a transparent and participatory mechanism. Main stakeholders—NGOs, academia, teachers' organisations, parents—should be involved in the mechanism at national and local levels. A communicative approach should help keep the public informed of the goals and strategies, and the process of decision-making.

The critical question is how the students' presence in schools—at some risk to their health, and to the health of their teachers and families—can be made worthwhile for students from the point-of-view of learning recovery and students' social and emotional wellbeing.

## Rules for Renaming

HEN Shakespeare wrote, "What's in a name? That which we call a rose by any other name would smell as sweet," he meant that the essence of something is not determined by its label. Calling a plum a pear does not make it taste any different.

Names do have some meaning, of course. The names of Civil War generals, ex-presidents, the Sacklers (of opioid fame), and the Washington, DC, football team have been removed, refused, challenged, or changed. No reasonable person today would take on the name Hitler, or even Adolf for that matter.

Renaming controversies are everywhere nowadays. Battles over the names of teams and schools are especially intense. There have been many renamings of college and professional sports teams in the United States, in addition to disputes over the names attached to public buildings, streets, and other spaces. In many cases, people were attached to (or simply accustomed to) an old name—usually a Native American reference—that younger generations found upsetting.

In 2017, Yale University renamed Calhoun College because Senator John C. Calhoun's support of states' rights, slavery, and the nullification of federal law in the 1800s was found to be too offensive to be attached to such an important place. The college now carries the name of a pathbreaking computer scientist: Grace Murray Hopper.

Similarly, in 2020, Princeton University's Woodrow Wilson School became the Princeton School of Public and International Affairs.

By contrast, the name of the US capital seems secure, even though George

Washington was a slave owner. Indeed, many street and city names continue to memorialise people who can be associated with slavery.

The long-term question is whether any name is truly safe in the face of evolving norms and later objections. Virtually every name could eventually be associated with behaviour or beliefs that have become objectionable or deeply offensive, even if

they were apparently admired or

Three solutions to renaming conundrums are worth considering. The first idea is associated with statutes of limitation in law. Names could be subject by convention to objection for a limited period, such as 50 years.

Under this approach, the State of Washington's name is safe, even though Washington the man owned slaves. The country's name is also safe, even though it is possible that a future generation will

recognise that America is a derivative of Amerigo (Vespucci), a fifteenth-century explorer who refused to hire women as

For better or worse, it often takes a long time for social values to change. The renamed Washington Commanders football team had its previous name, the Redskins, for more than 80 years. But for this proposed solution to be effective, the social convention needs to be so strong that, after the agreed interval has passed, it will seem wrong to object to a name, however offensive it becomes.

A second idea is to borrow from the concept of term limits. Names would have a shelf life, with an understanding that the controlling organisation could choose to extend the name for another period.

Consider a name that had been assigned because of a donation, as in the case of the Sackler Institute at New York University. Here, the understanding, perhaps embodied in new laws, would be that the university is free to sell the name to a bidder. Again, nothing stops a for-profit company, like a football team, from hanging on to its name. It is market pressure that brings about changes.

Finally, there is the idea of buyouts. If the original name was not "purchased," a renaming in honor of a donor or public figure is easily accomplished. Nothing stopped Princeton from accepting a giftfrom an individual or group—that was conditioned on removing Wilson's name. This idea is not entirely novel. Theater venues and sports stadiums are often renamed for advertising purposes, and the corporate names attached to them usually come with term limits of a kind, by dint of the name being for sale.

As for sports teams, they presumably gain something from the long histories attached to their names. But if an old name is found to be offensive, a team and its critics can benefit by auctioning off a name change.

The virtue of these three approaches (which could be combined) is that each requires us to recognise that times change, that names can also change, and that some prescribed limits to renaming are possible.



Justinian era, people across Europe and the Middle East have been facing the dreaded disease called plague. ## How to fix the failures of climate finance

NE of the positive outcomes of the COP26 held in Glasgow, Scotland in November 2021 was a universal acknowledgement of the failure of developed countries to deliver climate finance to developing countries, and even of developing countries themselves to communities within their own territories.

While it is good that countries acknowledged their failure and promised to do better going forward, the devil is in the details. I will take this opportunity to provide proposals on what needs to be done and who needs to do it to make sure that promises made at COP26 are actually delivered by COP27 this November in Sharm Al Shaikh, Egypt.

The first and biggest failure was the abysmal inability of the developed countries to deliver the USD 100 billion a year they had promised at the time of the Paris Agreement in 2015. One common misconception is in thinking that the environment ministers who attend the COP are responsible, when they are not the ones with the money. In fact, it is the finance ministers of the G7 countries who have to keep their promise. Back in June 2021, they met in Cornwall in the UK and decided to renege on their commitment. They then sent their environment ministers to the COP in November to apologise on their countries' behalf.

Now, we need to see what the G7 Finance Ministers meeting in June 2022 in

Germany will decide, rather than wait for November. The question is: Will they keep their promise this year, or renege as they did last year?

The second associated failure that developed countries' finance ministers must overcome is agreeing on which country should contribute how much to reach the iconic USD 100 billion amount each year. At the moment, it is left to each country to decide what their share should be and, not surprisingly, they could only agree on less than USD 80 billion so far. The finance ministers of developed countries have to agree on what the contribution of each country will be towards meeting the agreed goal of USD 500 billion over the next five years. They also need to agree on a neutral body, such as the United Nations Framework Convention on Climate Change (UNFCCC) Secretariat or the UN Statistics Bureau, to collect and collate the data, rather than self-certifying their own contributions, as has happened so far.

A third, more forgivable failure was that the proportion of global funds that were provided counted 80 percent towards loans to support mitigation measures while only 20 percent counted for grants to support adaptation in the most vulnerable developing countries, when the expectation was for a 50-50 split between support for mitigation and adaptation. To the credit of the developed countries, they acknowledged this failure and promised to double their grant funding to support adaptation in the most vulnerable developing countries, and several countries such as the United Kingdom, Germany and the US actually announced more funds for adaptation while they were in Glasgow. However, it is not just the amount allocated that is the problem but also how it is delivered and who receives it.

This has also been a major collective failure of the contributing developed countries and agencies such as the Green Climate Fund (GCF), UNDP, World Bank and Asian Development Bank (ADB), who acted as conduits to channel the funds to the developing countries to support adaptation. The two big failures were in making the funds far too difficult to access for the most vulnerable developing countries, so much so that it took years to get the first penny out of the funds. Only 10 percent of the adaptation funds actually reached the intended most vulnerable communities.

The fund-providing developed countries, the fund management agencies and the recipient developing countries' national governments all have to raise their game to make sure that the funds are allocated at scale and disbursed speedily so that the ultimate beneficiaries, who are

the front line adapters, actually get the help they so desperately need. This will require much better coordination, better accessibility to funds and monitoring of the actual delivery—all of which are sorely lacking at present. The good news is that this collective failure has been recognised and accepted, and reforms such as the eight principles of locally-led adaptation have been adopted. But making it happen at the requisite speed is now the challenge for all concerned.

The second annual Gobeshona Global Conference at the end of March 2022 on Locally-Led Adaptation and Resilience will be an opportunity for all the relevant players to take stock and report on their progress while correcting their failures of the past.

Acknowledging failure is a positive development only if it leads to reforms to avoid making the same mistakes again.



# Hope and relief for dried fish producers

A good quantity of dried fish got decomposed last year due to unfavourable weather in the peak season. The market rate fell as well, yielding me a loss of Tk 5 lakh.

The peak season for dried fish has kept producers in Chattogram busy at work, with collection, sorting, drying, piling, warming, packing and storing going on in full swing.

Due to favourable weather and high demand in the market, they are expecting a good share of profit this year.

According to the producers, the period between late Ashwin (October) and early Falgun (March) is considered as peak season for dried fish.

Take Bastuhara Khetchar. Located on the banks of the Karnaphuli, it is one of the major hubs for dried fish production. Visiting the area recently, this correspondent saw some makeshift structures erected in its fields to facilitate activity during these busy months. Around 20 species of fish, including Ribbon (Chhuri), Bombay

luck (Loitta), Faissa, Poa and prawns were being dried in the area.

The area is buzzing with not only workers busy with the daily grind but also with children's laughter. In between playing, they also lend a hand to their parents' work. Meanwhile, toddlers rest in their mothers' lap while they continue to sort dried fish.

Md Jasim, a worker, said a kg of dried fish can be produced after drying around four kgs of raw fish. According to the workers, the entire

process requires seven to 10 days to be completed. Once the fishes are completely dried, producers send them to warehouses, mostly located in Asadganj, from where wholesalers buy them.



This correspondent found over a 100 karbari (producers) busy with work in their fields. Around 20 workers, both male and female, work under a karbari. However, there's a discrimination in wages between male and female workers.

For example, one Fatema Akter said she works for eight hours a day and receives Tk 350 for her work, while male worker Mainuddin said he works for 10 to 12 hours and gets Tk 600 a day.

Asked about this, Abdus Shukkur. president of Bastuhara Tower Dried Fish Producers and Marketers' Cooperative Association, claimed since male workers do the more labour-intensive work, they are

Meanwhile, workers said a good production mostly depends on the weather.

"A good quantity of dried fish got

decomposed last year due to unfavourable weather in the peak season. The market rate fell as well, yielding me a loss of Tk 5 lakh," said Nurul Absar, a producer.

"But the rate is far better this year and so is the weather. I expect to make a good profit," he added.

Another producer Abdur Rahim informed that he incurred a loss of Tk 7 lakh last year due to the lower prices. "This year, I'm making a profit on every trip," he said.

Currently, a kg of chhuri is priced between Tk 700 and Tk 1,600 in the wholesale market, while a kg of loitta is sold between Tk 400 and Tk 650, a kg of faissa between Tk 450 and Tk 600 and a kg of prawn between Tk 700 and Tk 1,200.

"I have made a profit worth Tk 2 lakh so far this year, and expect to cover the previous year's losses with this," hoped Rahim.

# CCC's expensive puddle

When Chattogram City Corporation (CCC) constructed two swimming pools in 2015, it was hailed by the residents. They were constructed at a portion of the city's Jatisangha Park area.

But after laying abandoned for seven years, the authorities have now taken a puzzling initiative to demolish the pools, reportedly built at a cost of almost Tk 4 crore.

"In 2012, CCC took the initiative to build the two swimming pools, along with a gymnasium. The construction of the park was completed in June 2015," said architect Abdullah Al Omar, city planner of CCC.

"We're going to demolish the pools soon. They were constructed without planning, with many technical faults," said Omar.

"The pools are 120ft long and 50ft wide. One is eight feet deep while the other is eight and a half feet," he added.

Asked how much CCC spent to construct them, architect Omar refused to answer and suggested contacting CCC Chief Engineer Rafiqul Islam in this regard, saying he'd know better about the matter.

When contacted, the chief engineer reluctantly said he didn't know how much money was spent for the pools either.

However, reports from different media outlets found that CCC spent around Tk four crores during construction.



Rahul Guha, executive engineer of Public Works Department (PWD), Chattogram (Div-1), said, "Once the swimming pools are demolished, we'll start our development work there within 4-5 months.'

Meanwhile, this is some kind of a doublewhammy for the Jatisangha Park. Ziaul Haque, a local of the area, informed this correspondent that the park had been shrunk to facilitate the swimming pools and gymnasium inside it. However, they were supposed to be added attractions for the park, but if they're demolished, even that hope is gone. Delwar Mazumder, former chairperson

of the Chattogram Center of the Institution of Engineers, Bangladesh, said, "It will be a punishable offense if the hard earned money of citizens is wasted



just because of someone's ignorance." "If there's any technical fault in the construction process, the authorities should prioritise solving the problem as opposed to demolishing the swimming pools," he said.

## Rangamati's **AMPHIBIOUS** MARKET!

Rangamati's Samata Ghat is more than just a ghat. Situated right beside the Banarupa Bazar, it is a go-to place for people of the hill tracts, who use it to trade and transport their daily essentials.

Traders from around 100 villages under six unions come here on small boats or trawlers to sell their products. But they don't just offload their items at the ghat, rather, they sell from their boats too, which turns the ghat area


into a floating market of sorts. While some traders get down to the ground and sell their items at the market, some choose to sell directly from their boats. The latter type is preferred by those who buy in bulk and then re-sell the goods themselves.

The floating part of the market says a lot of about the locals and their lives. Although it's far from a conventional in the context of Bangladesh, its popularity among locals indicate how normal such a system is for them.

Available at the market are everything, from vegetable and herbs, to fruits, to even clothes.

Traders sling bamboo baskets on their backs to carry their products around the market. These traditional baskets are called "Kalang" by the Chakmas, "Pargin" by the Marmas and "Kabang" by the Tipras.

Prices here are cheaper than the regular market. Traders say they don't just do business for profit, but also look out for people's best interests. They said another reason they can afford to sell at lower rates is that they sell

## No captaincy, please!

Who would not love to captain his side? It is something that a lot of players dream of. We often hear players say,

"It's a dream come true to

captain the side."
But we can't expect any such usual practice when it comes to the Bangladesh Premier League (BPL).

The ongoing BPL probably made headlines mostly for captaincy changes, especially for teams to replace skippers just before the start of a match. And more interestingly, most players have refused to take the role. Let's begin with the controversy surrounding Mehedi Hasan Miraz during the Chattogram leg of the competition.

The Miraz drama, which was initiated after the player was stripped of captaincy just hours before their game against Sylhet Sunrisers, eventually ended after reaching an understanding with the franchise, but the player made it clear that he would not captain the side if asked again.

Once again sudden captaincy changes took centre stage in the Sylhet leg of the tournament. After Sylhet Sunrisers surprised with a captaincy change on Monday, Chattogram Challengers yesterday had Afif Hossain replace Naeem Islam, who had in fact replaced Miraz as captain earlier.

When Chattogram had Miraz stripped off captaincy, they did not cite any issue regarding the player's performance. However, in Naeem's case, the team mentioned that the player had to be dropped due to his poor performance.

On Monday, after Sylhet replaced Mosaddek Hossain with Ravi Bopara as their captain, Sylhet team manager Kazi Al Mashuk Bari disclosed that players like Anamul Haque and Mohammad Mithun refused to take the responsibility.

It is, however, not sure if Chattogram had asked anyone else to replace Naeem before approaching Afif. But one thing is certain that the captaincy circus has reached such a stage that no one can be sure as to who will be coming in to flip the coin in BPL anymore.



## Mrittunjoy: Chattogram's beacon in the dark

There was joy and jubilation on one side, a clutter of youthful energy converging and coming through. At the other side of things, wearing a dreary look was the experienced Tamim Iqbal, stranded at the non-striker's in the last delivery after what should have been a match-winning knock of 73. Tamim would have hoped that Mohammad Naim would do something special, only his partner could not find what was required. The one who got it right was 20-year-old Mrittunjoy Chowdhury, holding his nerve against the odds in a crucial death over against experienced batters.

Young guns Afif, Nasum Ahmed, Shoriful Islam converging towards Mrittunjoy signified a young side answering for themselves amidst the circus. Most of those names have done their bit in this ongoing BPL but things have remained clumsy for the franchise.

"We're a young side. Our sense of joy in a win or disappointments in defeats is a bit more than others. We were very cheerful at the beginning [of BPL]. It was a matter of proving ourselves as youngsters. There was a lot of planning for today's game and when it won, it was difficult to contain that joy," Mrittunjoy told The Daily Star in an interview yesterday.

Tamim was set for glory, his side needing just nine runs in that last over. "Nine runs is too little to defend," the pacer remarked.

There was a quiet confidence about him and he knew how to shift his plans. From picking up Mashrafe Bin Mortaza and Qais Ahmed's wicket with slowers in previous stagell, he went to his yorkers with five deliveries remaining.

"I planned according to the batters and then tried to execute. Panic doesn't do you good. I would have tried slowers if Tamim bhai was new to the crease, but at that moment I felt he might get under it and yorkers were the better option. The change in pace was confusing them," he said, landing one of his yorkers under Tamim.

"I went very wide of the crease, I wanted to land it right [a tad outside off stump] where his bat would come down from natural stance.

"I like the challenge of death over bowling. I feel less pressure than normal and competing with batters gives me confidence. I feel I have an idea of how batters think. When I have bad days, I feel I have enough experience of bad days struggling two years with injury."

The lad has 10 wickets in five games now, including a hat-trick in one and a three-wicket over in another. A beacon for Chattogram in the dark.

"I wanted to do well this BPL for my family, my coaches, my support structure." Biggest facet of this win is that it keeps Chattogram's hopes alive.

Meanwhile, in the night game that followed, Sylhet Sunrisers' hopes of progressing to the next round faded completely despite a 49-ball 90 from Colin Ingram as they fell short by 12 runs against Fortune Barishal, who amassed 199 while batting first, the second-highest total of this BPL edition, riding on quick-fire knocks from opener Munim Shahriar (51 off 28), Shakib Al Hasan (38 off 19) and Dwayne Bravo (34 off 13) while Chris Gayle (51 off 45) anchored the innings from the top.

#### Peng Shuai makes Games appearance

"I just met her, she was here sitting in the stadium," Bach told Reuters.

"She was among the athletes, and I had the opportunity to meet with a number of athletes from Switzerland and from Germany and the U.S.". he said.

# Zouma apologises for abusing cat

West Ham and France defender Kurt Zouma has apologised after a disturbing video surfaced of him kicking and slapping a cat, with the Premier League club publicly condemning the footage.

Zouma is seen in the clip dropping, kicking and slapping the animal, while laughter can be heard in the background.

The 27-year-old then chases the cat, before throwing a pair of shoes at it and slapping its head. West Ham condemned Zouma's actions in a strongly worded statement following publication of the clip online.

"West Ham United unreservedly condemns the actions of our player, Kurt Zouma, in the video that has circulated," the club said in a statement.

"We have spoken to Kurt and will be dealing with the matter internally, but we would like to make it clear that we in no way condone cruelty towards animals."

The France international,

who joined West Ham from Chelsea in August 2021, has also released a statement expressing his regret. "I want to apologise for my actions," he said. "There are no excuses for my behaviour, which I

sincerely regret.
"I also want to say how deeply sorry I am to anyone who was upset by the video. I would like to assure everyone that our two cats are perfectly fine

Title aspirants Abahani salvaged a point in the Bangladesh Premier League as the Sky Blues came from a goal down to play out a 1-1 draw against Bangladesh Police FC at the Birshreshtha Shaheed Fl. Lt. Matiur Rahman Stadium in Munshiganj yesterday. Meanwhile, Sheikh Jamal DC, another

contender, sailed through their second game with an emphatic 3-0 win over Mukijoddha Sangsad KC at the Shaheed Ahsan Ullah Master Stadium in Tongi to claim top spot in the 12-team table with six points from two games. Solomon King gave Sheikh Jamal a 20th-minute lead before Chinedu Mathew struck twice in 37th and

55th minutes respectively.
Away at Munshiganj,
Independence Cup and Federation
Cup champions Abahani appeared a
shell of their double-winning selves,
squandering a plethora of chances,
including a penalty, before sharing
honours with a resilient Bangladesh Police.

Bangladesh Police again gave a superior side a run for their money and found themselves on the verge of upsetting sixtimes champions Abahani, but could not keep out a stoppage-time equaliser eerily

reminiscent to the stoppage-time goal they conceded in a 1-0 loss to Saif SC in their opening game.

On the back of a narrow 1-0 win over Muktijoddha Sangsad in their previous match, Abahani looked a bit of nervous, misplacing passes and squandered some easy scoring chances. Bangladesh Police goalkeeper Mohammad Nehal made some brilliant saves while Abahani's Brazilian

> forward Dorielton Gomes wasted two easy chances, including a penalty.

Around 9:00am on February 21, 1952, members of the State Language Action Committee were informed that Dhaka University students were not in agreement with the decisions taken by it and they had decided to break the law if necessary.

The students decided to have processions in batches towards
Jagannath Hall, where the assembly session was going on. The committee in this circumstance decided to depute some representatives to convince the university students not to clash with the police who, however, failed to persuade them.

At 9:30am, some boys were arrested from Nawabpur Road for picketing.  $\,$ 

Around 10:00am, in accordance with the decisions taken by the students, the first batch of the students marched in procession and reached the Medical College gate, where they were arrested and taken away by police in a van. The next batch faced the same fate.

At 2:00pm, police took position and the East Pakistan Rifles were also brought to assist them. They fired at a large crowd of students near the Medical College gate. Three bodies were brought to the college and then sent to the morgue.

By 3:00pm, members of the assembly, which was in session and insisted that Nurul Amin, the then chief minister, should go to the spot. He, however, refused to do so.

## More projects revised, costs increased

As many as four projects were revised yesterday with their costs swelling by Tk 34,483 crore.

This takes the total number of revised projects in the first eight months of the fiscal year to 32 and the additional costs to Tk 59,919 crore.

Of the four projects that were revised at yesterday's meeting of the Executive Committee of the National Economic Council, the "Fourth Health, Population and Nutrition Sector Programme" saw its cost shoot up the most: by Tk 30,448 crore to Tk 145,934 crore.

The project, which began in 2017, has 29 components including setting up primary health complexes at the upazila level and community clinics at the union level and providing health services for mothers and newborn babies.

Two new components were included in the programme -- vaccination for Rohingya people and infrastructural development of upazila health complexes' infrastructural development

-- that necessitated the revision, an official of the Prime Minister's

office told The Daily Star.
The project also got a year's

extension.

"It is not a slow-implementing project," said Nasima Begum, a member of the National Planning Commission.

The project is 63 percent complete.

"It's on track now and one year will be enough to complete it," she added.

As a result, the cost of the project, implemented with the Indian line of credit, would increase by a staggering 62.3 percent to Tk 5,791.6 crore and its implementation period by three years to June 2025

The upgradation of the link of Ashuganj river port-Sarail-Dharkhar-Akhaura land port was tabled for revision yesterday as well.

The project got a new highway package, said Md. Mamun-Al-Rashid, another member of the Planning Commission said

The 50.56-kilometre highway project has included new work components such as land acquisition, construction of flexible pavements, rapid pavements, drains, bridges, railway overpass, foot overbridges, culverts and others.

As a result, the cost of the project, implemented with the Indian line of credit, would increase by a staggering 62.3 percent to Tk 5,791.6 crore and its implementation period by three years to June 2025, according to the meeting minutes.

The improvement of Dhaka's water supply network also got the nod for revision yesterday.

The project, which started in 2016, had ended in December last year. So far, only 27 percent of the money has been spent, indicating very poor progress. Subsequently, its tenure was extended to December 2023.

About the slow progress, Rashad said Wasa had to compensate two city corporations for road excavation, which was a lengthy process.

"The project design had some errors too," he said.

The other revised project is for the improvement of the Gopalganj district's rural infrastructure.

Also at the meeting, seven fresh projects were approved.

## Independents outdo AL picks

## Take 60pc of the chairman posts in 7th phase UP polls

The ruling Awami League suffered an election debacle in the seventh phase of union parishad polls as independent chairman candidates outdid them.

In the elections held on Monday, independents won 64 percent of the chairman posts while the Awami League won only 30 percent, according to the Election Commission data unveiled last evening.

For the AL this was the lowest winning parentage in the seven phases in the staggered Union Parishad election that began in June last year.

Yesterday, the EC announced unofficial results of 134 union parishads. It shows that independent candidates won in 86 UPs and AL nominees in 40. Three nominees from the Jatiya Party and one

from Jatiya Party (JP) also won in the polls. Ruling party insiders said many of the winning independents were disgruntled AL leaders who ran as independents after failing to get the party's

The AL nominees' performance is in a gradual decline in the staggered UP polls, according to the unofficial results announced by the EC.

The EC has so far announced unofficial results of 4,027 UPs in seven phases.

#### BARAPUKURIA COAL SCAM HC clears the way for trial

The High Court yesterday cleared the way for the lower court concerned to try a corruption case filed over the "theft" of over 1.43 lakh tonnes of coal from Barapukuria Coal Mining Company Ltd (BCMCL) in Dinajpur.

The coal is worth Tk 243 crore. The HC rejected three separate

The HC rejected three separate petitions filed by six former BCMCL officials, who are accused in the case, challenging the trial court order that on November 25 last year framed charges against them.

The accused in the petitions sought exemption from the charges of the case.

The accused petitioners include former BCMCL managing directors Md Abdul Aziz Khan, SM Nurul Aurangazeb, Khurshidul Hasan, Md Kamaruzzaman, and Md Aminuzzaman, and its former official Abu Taher Md Nur-uz-Zaman Chowdhury, Anti-Corruption Commission lawyer Khurshid Alam Khan told The Daily Star.

Yesterday, the HC bench of Justice SM Kuddus Zaman and Justice Md Riaz Uddin Khan rejected all three revision petitions considering that those were not presented properly.

Lawyers Rokanuddin Mahmud and Mustafizur Rahman Khan appeared for the petitioners.

Md Anisur Rahman, manager (admin) of the coal mining company, filed the case accusing 19 people with Parbatipur Police Station in Dinajpur on July 24, 2018 in connection with the coal going missing.

According to the case statement, the accused

officials were behind the coal going missing.

## 'Now possible' to move forward

Says Macron after talks with Putin, Zelensky on Russia-Ukraine tensions

French President Emmanuel Macron said yesterday that after talks with the Russian and Ukrainian leaders he saw a path toward easing tensions.

Speaking at a joint press conference after talks with Ukrainian President Volodymyr Zelensky in Kyiv, Macron said he believed it would be possible to make progress on two fronts

Both Zelensky and Russian President Vladimir Putin, who Macron saw on Monday, said they remained committed to the 2015 Minsk peace agreements on the country's separatist conflicts, the French leader said.

"We now have the possibility to make these negotiations move forward," Macron said.

And on tensions between Russia and the West over Moscow's military build-up on Ukraine's borders, Macron said: "I believe for my part that there are concrete, practical solutions that will allow us to move forward."

As Macron sought a diplomatic solution with Kyiv, US President Joe Biden ramped up the pressure on Moscow Monday by warning he would "end" the controversial new Nord Stream 2 gas pipeline from Russia to Europe if tanks rolled into Ukraine.

After talks with Zelensky yesterday, Macron said nobody was "naive" enough to believe that the tensions were not linked to the Russian deployments, calling them "unprecedented".

"In adopting this threatening posture, Russia decided to put pressure on the international community," Macron said.

"We cannot underestimate the moment of tension that we are living through," Macron said.

"We cannot resolve this grisis in a few bours."

"We cannot resolve this crisis in a few hours of talks," he said. "It will be the day and the weeks and the months to come that will allow us to progress."
