Alimuddin was declared dead at a hospital.

# Traffic lights that never light up

On Saturday, Khulna city's Shibbari intersection was in utter chaos. It was a free-for-all, as vehicles only stopped when police officers jumped in front of them, risking their lives.

Unfortunately, such a scenario is not uncommon.

To this day, Khulna city's traffic department is still using age-old methods -- officers blowing whistles, gesturing with hands and sticks -- to control vehicular movement. The city still lacks digital traffic lights, and due to this, it is having a hard time bringing discipline to the roads, all while vehicles keep on increasing.

Although there are traffic lights at multiple points of the city, they have been out of order for a long time. Visiting 16 points, it was seen that all traffic lights were non-functional, many broken with their poles lying on the road. Residents said they don't remember the last time when they lit up.

According to Khulna City Corporation (KCC), the installation and maintenance of traffic lights started in 1984 at 16 important points. Until 2007, KCC repaired and maintained the lights, and paid the utility bills. However, the corporation eventually started overlooking the lights, as costs increased, and now, all maintenance work has been postponed.

According to Khulna Metropolitan Police's (KMP) traffic department, there is a shortage of workforce. Out of the 300 traffic-police officers in KCC, 110 get deployed for a shift.

Traffic officer Saiful Islam said, "If the lights were functional, they could reduce traffic jams and accidents, and we wouldn't have to stand in the sun to perform duties with much trouble.'

Zahid Hossain Shaikh, executive engineer (electricity) of KCC, said all the city's traffic lights are out of order. "We will modernise them. Over 70 such lights are non-functional right now.

Moreover, maintenance and electricity bills will require big funds. It is not possible for a corporation to take care of all this, unless a new project is passed. Mohammad Tazul Islam, deputy commissioner of KMP's traffic department, said city corporations are responsible for maintaining traffic lights elsewhere in the country, mentioning that no police funds are allocated for this.

Asked, KCC Mayor Talukder Abdul Khaleque said implementing any project depends on government allocation. "It is not possible to manage vehicular movement without digital traffic signals. We are going to adopt a new plan in this regard soon."

## Bangladesh can use South Korea's strategy

WB official on tackling climate change

A top World Bank official yesterday said Bangladesh can replicate South Korea's postpandemic strategy to address climate change issues, while keeping up its high economic growth.

Hoon Sahib Soh, practice manager of World Bank's Macroeconomics, Trade, Investment and Public Sector, said Korea has undertaken a postpandemic recovery strategy with an overarching theme of strengthening employment and social safety nets. Known as the "New Deal", the project will invest \$144 billion, creating up to two million jobs by 2025, he said, while addressing a webinar organised by Policy Research Institute of

Hoon, a South Korean national, said the WB is ready to support Bangladesh in developing its approach to green growth.

PRI Chairperson Dr Zaidi Sattar said without having to sacrifice its growth, Bangladesh can still address climate change and be green.

PRI Executive Director Ahsan H Mansur said the impact of climate change is already visible in southern districts, as statistics show population there was declining, with many becoming climate refugees and migrating to urban areas.

State Minister for Planning Shamsul Alam said Bangladesh has now 3.5 percent of energy coming from renewable sources. The country should not be complacent, because it has to go a long way to turn its economy into a green one.

## **VC'S RESIGNATION** Sust students continue protests

The students of Shahjalal University of Science of Technology (Sust) brought out a procession on the campus yesterday, as their demand for Vice-Chancellor Prof Farid Uddin Ahmed's resignation

Holding placards and photographs, they marched the campus during the procession, demanding that the VC must resign without any further delay.

The photographs showcased the brutal police attack on them on January 16.

On January 13, the residents of a female hall started a movement demanding resignation of the provost over misbehaviour. Later on January 16, it turned into anti-VC movement after police clashed with the protesters, leaving at least 40 students injured.

On January 19, 23 students started a hunger strike demanding the VC's resignation. Later they broke their fast on request of two former professors of the university -- Dr Muhammed Zafar Iqbal and his wife Dr Yasmeen Haque.


