### 87,600 hours and counting

Justice ever elusive for the murder of journo couple Sagar-Runi

Numbers in the quest for justice in Sagar-Runi murder keep getting longer as investigators continue to fail to make any headway in the

After the journalist couple was slain on this day in 2012, then home minister Sahara Khatun had vowed to catch the killers in 48 hours. The promise has not been fulfilled even in 10 years or roughly 87,600 hours.

Over the last 10 years, the investigation officer was changed six times, and the Rab and other agencies have taken 85 dates from court to complete the probe. But they have not been able to submit the investigation report.

Meanwhile, their repeated appeals for time extension to complete the probe created frustration among the victims' relatives.

"It's almost clear by now that we will not get justice during the tenure of this government. I really doubt its intention," Runi's brother Nowsher Alam Roman told The Daily Star recently.

"There is something fishy. Maybe, some influential people were involved in the killing ... After 10 years, I now feel ashamed to seek justice," he said.


Sagar Sarowar, news editor at private TV channel Maasranga, and Meherun Runi, a senior reporter at ATN Bangla, were killed in the early hours of February 11, 2012, at their rented flat in the capital's West

The couple's only child Mahir Sarowar Megh, only five at the time, was in the apartment.

Megh, now 15, used to live with his grandmother Nurun Nahar Mirza, but she passed away on January 15 this year, at the age of 64.

"My mother waited 10 agonising years for justice, but she was not able to see it served in her lifetime," said a frustrated Roman.

### They all long to be in EC

At least 180 people pitch themselves for CEC, EC posts; 5 political parties submit names

At least 180 people submitted their own names to the cabinet division for nomination for the new Election Commission.

Among them are former bureaucrats, former judges and other private citizens, said cabinet division officials.

Apart from them, five political parties submitted their picks to the cabinet division. Main opposition in parliament Jatiya Party and Jatiya Samajtantrik Dal (JSD) were among them.

"Today was the last day for individuals" submission of names. We have received 180 to 190 names," Shafiul Azim, joint secretary of the cabinet division, told The Daily Star vesterday.

When asked who sought nomination for the posts of chief election commissioner and other election commissioners, he refused to elaborate but said the individuals submitted names after meeting the criteria.

An individual must be at least a 50-yearold Bangladeshi citizen with 20 years or more work experience in important government, semi-government, private or judicial posts to be nominated for the new EC.

Sources said many of the former bureaucrats and former judges submitted their own names in person and some sent their names via email.

#### BBS to make database of all citizens

Bangladesh Bureau of Statistics is going to prepare a comprehensive database incorporating all data of every citizen. Known as National Population Register

(NPR), the database will keep record of the details of a citizen that will enable the government to implement its various services such as the social safety nets.

Dr Shahadat Hossain, team leader of the NPR and a former director of BBS, disclosed the project details in a presentation during a workshop held at the BBS auditorium in the capital

Addressing the event, Planning Minister MA Mannan said the NPR would be something similar to the Indian government's Aadhaar programme.

He directed the BBS officials to implement the project properly.

### Power cost keeps spiralling Study blames it on overcapacity

Capacity payments for under-utilised independent power producers (IPPs) are heavily affecting the power generation cost, putting pressure on the government to raise the tariff, said a recent study.

The rising power purchase cost and further dependence on imported fossil fuels like LNG are enhancing the need for hiking power tariff, said the US-based Institute for Energy Economics and Financial Analysis (IEEFA) in its report, which was prepared based on the annual reports of the Bangladesh Power Development Board (BPDB).

Capacity payment is a sort of penalty that the buyer pays to plant owners if it fails to buy a certain portion of power readily

The cost of electricity purchased from IPPs now represents more than 50 percent of BPDB's total operating expenses for

A 58 percent increase in the IPP costs in fiscal 2020-21 was partly as a result of increased power units purchased from the plants -- 34.6 Terawatt-hour [TWh], up from 25 TWh the

The per unit cost of each kilowatt hour [kWh] power purchased from the IPPs rose to more than Tk 8/kWh last fiscal year from Tk 7/kWh in fiscal 2019-20.

#### IT'S MURDER

#### Say family members of student killed in Khagrachhari crash

With a blank expression, not long after he landed in Chattogram from Qatar, Lokman Hossain sat on a chair at his home and stared into the ambulance where the dead body of his 18-year-old daughter was kept in a coffin.

The 60-year-old expatriate returned to Chattogram around 11:00am yesterday to bid his daughter Nisha Moni a final goodbye after learning that she, along with 16-year-old Mishu Akter, had died when a speeding jeep ran them over in the district's Fatikchhari upazila on Wednesday.

Police said yesterday that the jeep, known locally as chander gari, did not have valid documents.

"Oh, my daughter please come back. How can we live without you? How do I live with this pain?" Lokman sobbed as Nisha's mother cried helplessly following her the namaz-ejanaza around 3:30pm.

Nisha and Mishu were both SSC candidates from Haidchakia High School and the accident on the Chattogram-Khagrachhari highway's Felagazi area left two families bereft, a day after five brothers were killed in a road crash in Chakaria.

We demand justice ... it is not an accident; it is a murder," said Md Ayub Ali, Mishu's uncle.

Md Robiul Islam, officerin-charge of Fatickchari Police Station, said Ayub Ali filed a case against jeep driver Mohammad Alauddin and other unnamed accused with the station, but police were yet to make an arrest.

OC Robiul told this newspaper that the jeep was plying the road without valid documents.

According to the case statement, Highway Police Traffic Inspector (TI) Nikhil Chakma, and Traffic Sergeant Alamin had signalled the paddy-laden jeep to stop, and when the driver tried to flee, the vehicle ran over the two students, killing them on the spot.

### Introduce death penalty for graft

HC suggests in full verdict on Haji Salim, asks the lawmaker to surrender before the trial court in 30 days

Corruption is a mental disease that cannot be cured only by corporal punishment, the High Court said in the full text of a verdict in a graft case recommending introduction of the death penalty for such offences.

Upholding 10 years' imprisonment of Haji Md Salim, Awami League lawmaker from Dhaka-7, for amassing illegal wealth worth Tk 14.65 crore, the court also directed him to surrender before the trial court concerned within 30 days.

The countdown of the 30 days will start from the day the trial court receives the copy of the HC judgment.

The HC blasted the Anti-Corruption Commission for its failure to take appropriate action against corruption and for its dependence on media coverage.

"We are ashamed of our rank because of some corrupt persons who have managed to set themselves up in every sector in disguise with mental illnesses.

"They are powerful, organised and syndicated, therefore, on the basis of seriousness, arrogant and protracted offenders of corruption, capital punishment could be introduced," the bench of Justice Md Moinul Islam Chowdhury and Justice AKM Zahirul Hug observed in the 66-page full text of judgment which was released yesterday.

About the HC's suggestion for introducing capital punishment for corruption, Law Minister Anisul Huq told The Daily Star that he could not make comments on this issue as he was yet to read the full verdict.

He also declined to comment on whether Salim can hold the office of parliamentary membership following the HC verdict.

But ACC's lawyer Khurshid Alam Khan said Salim is no more a Jatiya Sangsad member as per article (2) (d) of the constitution from the moment the HC delivered the verdict.

In the full text of the judgment, the HC judges said, "We have cautiously noticed that the commission [ACC] still does not have capacity or courage to form such kind of belief even there are thousands of apparent corrupt persons possessing properties and money, but hardly at its own initiatives, rather, unfortunately still depends upon media coverage to form its belief for taking action under sections 26 and 27 of the Anti-Corruption Commission Ain, 2004.

'We desire to see a commission which must be effective and active in finding out root of all corruption within the holders of constitutional post and nonconstitutional ordinary servants of the

"We know that it will be a difficult and dismissing an appeal of Salim.

risky task because an honest person may fall prey to a corrupt person, but we have to start from somewhere to be a civilised and a corruption free nation," the HC bench observed.

The HC upheld the lower court's judgment that convicted and sentenced Salim to 10 years in prison in the case filed by the ACC during the militarybacked caretaker government in 2007.

ACC lawyer Khurshid said the trial court will send Salim to jail if he surrenders before it.

Salim will have to seek bail from the Appellate Division of the Supreme Court after going to jail in this case, he added.

Salim's lawyer Sayed Ahmed Raza, however, said his client would move an appeal before the Appellate Division challenging the HC verdict.

Salim is unwell and therefore, he will seek bail from the trial court after surrendering to it, he added.

"Disqualification under the constitution to be a member of parliament will depend on the result of the appeal. Because the conviction will be under challenge before the Appellate Division. When the conviction is under challenge, it [conviction] cannot be termed final," the lawyer said.

On October 7, 2020, he submitted a progress report into the double murder. He sought time extensions eight times last year to submit the probe report.

In the progress report, he said evidence seized from the crime scene was sent to the Independent Forensic Service (IFS), USA for DNA

The IFS identified the DNA of two unidentified men. Later, another US DNA lab, Parabon Snapshot, communicated for identifying the two, according to the report.

On January 24 this year, the Rab official once again failed to submit the probe report and then again filed for time extension. The court then set February 23 for the submission.

Contacted, IO Shafiqul said he would not make any comment for the "sake of investigation". Home Minister

Asaduzzaman Khan did not respond to our phone calls for comment yesterday. Noted rights activist Nur Khan termed it a

"total failure" of the law

enforcement agencies. "From the beginning of this case, the investigation agency tried to convey a wrong message to the people that the investigation is almost done. In reality, it is the complete opposite. They gave false promises,"

"The investigation agency is also not communicating with the victims' families. A perception has been created among people that some influential people are involved here," he added.

The IEEFA projected that with more coal-based IPPs under construction and with large capacity LNG-based IPPs planned, the BPDB's IPP cost is likely to continue going up significantly.

According to the BPDB, 12,967 megawatts (MW) of new power capacity is under construction and 19,651 MW more is planned to be added by the end of fiscal 2024-25.

Power plants with a total capacity of 3,990MW would be shut down by fiscal 2024-25, according to the BPDB's annual report for fiscal 2020-21.

Overall power plant utilisation will drop further by fiscal 2024-25 as a result of these large capacity additions, the report said.

The IEEFA said even if power generation grows percent per annum until

He said results will be handed over to Prime Minister Sheikh Hasina through a virtual programme at International Mother Language Institute. The education minister will hold press conference there after the programme.

Last year's exams were held on fewer subjects and a shortened syllabus. It was held eight months later than the usual schedule as the government waited for the coronavirus infections to come under control.

The examinees took tests only in three optional subjects. They did not have to sit for tests in compulsory subjects like Bangla and English. The exams carried fewer marks.

About 11.4 lakh students participated in the exams under nine general boards.

Say speakers on enforced disappearances, calling for justice for victims

#### **ENFORCED DISAPPEARANCE AND RESPONSIBILITIES OF THE STATE**

- Not just victims' families, all should fight for justice
- Overhauling entire system
- Law enforcers must serve people, not the state



Whenever a party is in power, it shrugs off all responsibility of enforced disappearances, said speakers at a virtual discussion yesterday.

At the event, titled "Enforced disappearance and responsibilities of the state", hosted by Centre for Governance Studies (CGS), speakers questioned why such incidents have not been occurring since international pressure turned up. This proves that they were all staged.

"For whatever reason, enforced disappearances are happening; this needs to end. This is a human rights violation," said Ashim Kumar Ukil, a ruling party parliamentarian from Netrakona.

He said victims' family members should not be the only ones fighting for justice, but everyone involved in running the state should as well.

Victims' families cannot file cases, nor can they mention that law enforcers were involved. The victims of these incidents are people in conflict with the law, or people with opposing views, or those tagged as extremists.

"Let us strengthen democracy. With stronger pillars of democracy, unnatural phenomena like enforced disappearances will stop," said Ukil.

BNP lawmaker Harunur Rashid Harun pointed out that the United Nations Working Group on Enforced Disappearance wants to visit and investigate, but the government has not allowed

"It is very heart-breaking when those in charge of running the state, deny the charges," he said. We will protest incidents like these, even if our party is affiliated with it."

He then narrated an incident of "crossfire" that took place in his constituency in 2020.

"A day-labourer was picked up by law enforcers and killed in a crossfire. The most tragic incident is that his own two brothers were accused of the 'murder'," he said. "Also implicated were two people who were with me in the parliament on the day of the incident. When I sent a written complaint to the home ministry, no steps were taken."

Dr Manjur Ahmed Chowdhury, chairperson of CGS, said not only is a person forcibly disappeared but all evidence gets destroyed as well.

ASK secretary-general Nur Khan Liton reiterated that victims' families cannot file cases, nor can they mention that law enforcers were involved. "The victims of these incidents are people in conflict with the law, or people with opposing views, or those tagged as extremists," he said.

#### 'We are servants of the state, not bureaucracy'

#### **Engineers protest** directive empowering DCs to oversee dev projects

Engineers yesterday protested the recent directive of public administration ministry -- empowering deputy commissioners (DC) to oversee development projects at district level.

At human chains in all district headquarters and in the capital, engineers said they will not follow the directive and demanded it be withdrawn immediately. Organised by Institute of Engineers, Bangladesh (IEB), around 800 engineers protested in front IEB at Shahbagh.

On January 18, the ministry issued directives asking DCs to open a wing under an additional deputy commissioner for monitoring and evaluating projects, and send reports to IMED under the planning ministry.

Speaking at the human chain, IEB Services and Welfare Committee's Chairman SM Monjurul Haque Monju said the directives are illogical and an obstacle to development projects. "We are servants of the state, not of bureaucracy," he said.

IEB honorary general secretary Shahadat Hossain Shiblu said there is still a process of evaluating and monitoring project-work under the planning ministry, and engineers are accountable to the ministry's IMED.

"Please do your duty properly. One of your main duties is land acquisition. Many projects get delayed as land acquisition is not done in time," he said, referring to DCs. "We have no conflict with you."

### 'We don't want syndication'

Say recruiting agencies of Bangladesh, Malaysia STAFF CORRESPONDENT

Recruiting agencies of both Bangladesh and Malaysia yesterday said they don't want "syndication" in the process of sending Bangladeshi migrant workers to Southeast Asian countries.

During a press conference organised by "Members of Baira" at a city hotel, they urged Malaysia to ensure a process without syndication for Bangladesh, currently applicable for other source countries.

They voiced concern that syndication will again lead to irregularities, corruption and high migration cost, factors leading to market closure in the past.

Malaysia and Bangladesh signed a memorandum of understanding on labour cooperation in December 2021. However, the labour-sending process is yet to be finalised amid concern over not keeping the market open for all Bangladeshi recruiting agencies.

Earlier, a syndicate of 10 recruiting agencies allegedly caused corruption and irregularities in



Meanwhile, Malaysia's home ministry in a letter to Dhaka said Khairuzzaman was arrested for breaching the immigration law, Shahriar Alam vesterday. But he could not give any details of the law that has been breached.

He was an army major when Syed Nazrul Islam, acting president of Bangladesh government in exile, Tajuddin Ahmed, prime minister, M Mansur Ali, finance minister, and AHM Qamaruzzaman, minister of home affairs, relief and rehabilitation, were assassinated inside Dhaka Central Jail on November 3, 1975.

He was an accused in a case filed in connection with the killings.

After his retirement from the army, Khairuzzaman was placed in the foreign service. He was the ambassador of Bangladesh to the Philippines in 1996 when the Awami League government recalled him.

He came back to Bangladesh and was sent to jail as the trial proceedings of the case went on. In 2004, a lower court

acquitted him in the jail killing cases were given killing case.

The High Court and the Appellate Division later upheld the lower court verdict.

They did not allow the VC to come out of his office from 11:00am to 3:30pm when a meeting of PUST's highest decisionmaking forum -- Regent Board – was foiled, said registrar Bijon Kumar Brahma.

At the meeting, the faculty members were expected to discuss around 60 agendas including their promotions but the VC first placed his nephew's recruitment and other recruitment matters.

This made the teachers agitated, said the university's teacher Abdul Halim.

Later, Pabna-1 lawmaker Shamsul Haque Tuku went there and assured the teachers to discuss their issues at a meeting on February 24.

### Once there were hills

MINTU DESHWARA, back from Habiganj

Once, Rupaichhara government hills in Habiganj used to be around 500 feet high. Due to sand extraction and tree felling, they now stand on the verge of extinction.

This correspondent recently visited Rupaichhara Rubber Garden in Bahubal upazila and found two hills on the west and the north already cut, along with the trees. Around 19 acres of rubber plantation were gone as well.

Locals alleged that an influential quarter has been behind the illegal hill cutting and sand extraction -- backed up by a ruling party leader.

Meanwhile, the Department of Environment officials and local administration are silent observers when it comes to hill cutting, alleged locals.

According to Rupaichhara Rubber Garden authorities, the total area of the garden is 1,963 acres. There are 17government-owned rubber plantations in the country, four of which are located in Sylhet division. One of them is Habigani's Rupaichhara.

Talking to the rubber-garden authorities and locals, it was known that Putijuri Union Parishad's former chair and Habiganj District Tanti League's president Md Muddat Ali has occupied about 19 acres of the garden's lands, and claimed three more acres.

Besides, few other sand traders are continuing illegal sand extraction from the Soshanchhara stream flowing through

Saddam Hossain, a resident of the rubber-garden slum, said the garden and hills are unprotected as there's no boundary wall, and this situation makes them a target for those looking to extract sand and cut trees.

"The authorities never took any action," he alleged.

"Hills are being cut every night. An eight-bigha playground, a 10-acre rubber garden nursery on the east side of the

The penalty for cutting hills without approval is up to two years imprisonment, a fine of Tk 2 lakh, or both, for a first offence. For a subsequent offence, the penalty is up to ten years of rigorous imprisonment or a fine of Tk 10 lakh or both.

field, and a 12-foot wide road have been destroyed to cater to Muddat Ali's land business," alleged Sadek Mia, a resident of Kalyanpur village.

However, when this correspondent contacted Muddat Ali, he denied the allegations and said sand has been extracted from his privately-owned land. When asked whether privately-owned hills can be cut under the Sand and Land Management Act, he said, "I have the approval of the Ministry of Mineral

Resources to extract sand."

Shah Shaheda Akther, Sylhet divisional coordinator of Bangladesh Environmental Lawyers Association (Bela), said as per the Environment Conservation (Amendment) Act 2010, hill cutting is a cognisable offence and no government, semigovernment, or autonomous organisation is allowed to cut or raze hills without prior permission from the authorities concerned.

The penalty for cutting hills without approval is up to two years imprisonment, a fine of Tk 2 lakh, or both, for a first offence. For a subsequent offence, the penalty is up to ten years of rigorous imprisonment or a fine of Tk 10 lakh or

"Astonishingly, the government proposes to increase forest land to 20 percent of the country's total land by 2030, while every year, government hills are being cut with the help of government officials," said Tofazzal Sohel, general secretary of Bangladesh Poribesh Andolon's Habigani chapter.

"We desperately need the hills to ensure the survival of our wildlife and conserve biodiversity." he added.

Abdul Baki, Rupaichhara Rubber Garden's manager, acknowledged that the garden is indeed unprotected without a boundary wall.

"Muddat Ali told us that he was extracting sand from his own lands. We will investigate and take necessary steps regarding the issue," said the garden manager.

Police arrest four over 20 robberies, muggings in two nights in port city

On Sunday, four youths stormed into a roadside medicine shop in the port city at midnight and held the staff hostage at gunpoint. They then took cash and mobile phones, and fled the scene

This was just one of at least 20 robberies and muggings they conducted in two consecutive nights, on February 6 and 7. The gang was inspired to embark on this crime spree after watching a movie, according to law enforcers.

After conducting separate drives for 96 hours, police arrested the four in connection with the incidents from different areas yesterday. The arrestees are Md Belal Hossain Aslam (27),

Tanvir Islam Rukun (27), Sohel Uddin (28) and Mohiuddin Kamal (28). Aslam is a mason, and Sohel and Kamal are drivers. During investigation, Baizid Bostami police

found that the gang robbed and mugged multiple pedestrians and local shops across the port city during this period. Investigators said the car they were using was

snatched from Sitakunda upazila's Banshbaria area on Saturday night. OC Md Kamruzzaman of Baizid Bostami Police

Station said, "So far, we have found that the gang conducted at least 20 robberies and muggings with the stolen car." The criminals plotted everything after watching a movie recently.

According to investigators, the group, pretending to be passengers, boarded the private car in Alangkar area and held the driver hostage on Dhaka-Chattogram highway. They then snatched the car. The criminals later came to Baizid area, robbed the medicine shop, and took Tk 59,000 cash and electronic devices.

"The criminals robbed and mugged in Baizid, Nimtala-Customs, Halishahar, Muradpur, Sholoshahar, Bakalia and Kaptai Rastar Matha-Kazir Hat areas," said OC Kamruzzaman.

Every night, they started their operation at 11:30pm and continued till 5:30am. They would then park the car in front of Chattogram Medical College Hospital," added the OC.

The car, 10 mobile phones, a makeshift gun, four cartridges, a knife and wrench were seized from their possession. They stand accused in different cases, including drugs and arms cases.



### Muazzin's success in beekeeping

In the last week of December, 2021, I heard an interesting story of a young man, who has built his dream around the bees. His name is Muazzin Hossain. It was a quite cold morning when I left for Manikganj's Singair upazila to see his activities. The nature was covered with thick fog and the villages just started to wake when I was close to Kanchan Nagar village. I noticed many bee boxes along vast mustard fields and Muazzin was already there. The young man, aged just over 30 years, greeted me with a big smile. The crazy youth did his BBA, and MBA from a private university. Usually, men and women of such age dream of government or corporate jobs. But Muazzin was different. "While studying MBA, I saw one of your videos on bee farming on YouTube which attract my interest. Then I started studying on bee farming," Muazzin said.

"My father was shocked when

I told him that I want to start farming bees at home," he added. One day Muazzin left his home and went to a famous beekeeper in Bagerhat and requested him to teach him about beekeeping. During his stay there he only had three times meal in exchange of his whole day labour. In the next three months, he learned everything about beekeeping, Muazzin said, adding that, "My beekeeper guru gave me four bee boxes as gift when I left his place, and now I have 64 bee boxes of my own."

For Muazzin, beekeeping is more than just a commercial aspect. He keeps on learning the miraculous life cycle of the bees. In the last six

and a half years, this young man has been able to go deeper into the extraordinary life of the bees. In other words, he is a keen observer of the bees' life cycle.

He was sharing his experience, bees mainly collect honey from fresh flowers. For half a kg of honey, 600 bees have to travel around 20 lakh (2 million) flowers and worker bee has to travel a distance of about 14.5 lakh kilometres. Muazzin is not only impressed with the orderly management and honey production, but also with the chain of command among the bees. Every bee box is a colony and each colony has a specific system of governance. There is also change in power when necessary. There is a natural process of protection and care of the most influential queen bee in every colony.

Finally, I saw a queen bee of one of the beehives roaming around hundreds of bees, mostly soldier bees. One don bee was relentlessly protecting the queen while the worker bees were continuously cleaning queen's path. The queen was looking for a place to lay eggs in the beehive and finally laid some eggs in several places. Interestingly when worker bees comprehend that the queen cannot produce quality eggs, they all kill the queen and bring a new queen to their hive.

As far as I know, there are about 25,000 beekeepers in Bangladesh and honey has turned

into an industry now. The country produces 10,000 tonnes of honey against the demand of 30,000 tonnes, which is usually produced from black cumin, coriander, litchi and mustard flowers. Honey is mostly collected from mustard flower, but in the southern part of the country, honey is collected from the Sundarbans.

In the last few years, many educated young entrepreneurs have started commercial beekeeping and honey production. "Although, the wholesale market fluctuates, the retail market is not bad at all," Muazzin said. A total of 64 boxes or colonies costs Muazzin around Tk 4 lakh (USD 4,654) throughout the year and he gets a profit of around Tk 4 lakh.

I have been reporting on various issues, including commercial expansion of bee farming, market opportunities and agricultural credits for beekeepers. As a result, bee farming has been included in the agricultural credit policy of the Bangladesh Bank. The demand and market for our local honey are increasing. Things are turning out to be positive. More positively, educated young entrepreneurs like Muazzin are coming to beekeeping that can bring new opportunities to this industry. I believe, beekeeping industry will go a long way with inquisitive minds, confidence and sincerity of farmers like Muazzin.

In 2003, the government took the initiative to build the BSCIC Tannery Industrial Estate on 200 acres in Hemayetpur after moving all tanneries from the capital's Hazaribagh in order to prevent pollution and protect the Buriganga.

According to statistics placed before the standing committee, the estate has the capacity to treat around 25,000 cubic metres of liquid waste every day, but the tanners generate around 40,000.

That means 15,000 cubic metres of untreated liquid waste are now dumped into the Dhaleshwari.

The estate also does not have the facility to treat solid waste, including heavy metals and chromium, which is also dumped into the Dhaleshwari, Saber Hossain said, adding that around 1.60 lakh cubic metres of solid waste have been dumped in the river over the past three years.

### 87,600 hours and counting

Justice ever elusive for the murder of journo couple Sagar, Runi

Numbers in the quest for justice in Sagar-Runi murder keep getting longer as investigators continue to fail to make any headway in the

After the journalist couple was slain on this day in 2012, then home minister Sahara Khatun had vowed to catch the killers in 48 hours. The promise has not been fulfilled even in 10 years or roughly 87,600 hours.

Over the last 10 years, the investigation officer was changed six times, and the Rab and other agencies have taken 85 dates from court to complete the probe. But they have not been able to submit the investigation report.

Meanwhile, their repeated appeals for time extension to complete the probe created frustration among the victims' relatives.

"It's almost clear by now that we will not get justice during the tenure of this government. I really doubt its intention," Runi's brother Nowsher Alam Roman told The Daily Star recently.

"There is something fishy. Maybe, some influential people were involved in the killing ... After 10 years, I now feel ashamed to seek justice," he said.

Sagar Sarowar, news editor at private TV channel Maasranga, and Meherun Runi, a senior reporter at ATN Bangla, were killed in the early hours of February 11, 2012, at their rented flat in the capital's West

The couple's only child Mahir Sarowar Megh, only five at the time, was in the apartment.

Megh, now 15, used to live with his grandmother Nurun Nahar Mirza, but she passed away on January 15 this year, at the age of 64.

"My mother waited 10 agonising years for justice, but she was not able to see it served in her lifetime," said a frustrated Roman.

"Today was the last day for individuals" submission of names. We have received 180 to 190 names," Shafiul Azim, joint secretary of the cabinet division, told The Daily Star yesterday.

When asked who sought nomination for the posts of chief election commissioner and other election commissioners, he refused to elaborate but said the individuals submitted names after meeting the criteria.

An individual must be at least a 50-yearold Bangladeshi citizen with 20 years or more work experience in important government, semi-government, private or judicial posts to be nominated for the new EC.

Sources said many of the former bureaucrats and former judges submitted their own names in person and some sent their names via email.

### Power cost keeps spiralling Study blames it on overcapacity

Capacity payments for under-utilised independent power producers (IPPs) are heavily affecting the power generation cost, putting pressure on the government to raise the tariff, said a recent study.

The rising power purchase cost and further dependence on imported fossil fuels like LNG are enhancing the need for hiking power tariff, said the US-based Institute for Energy Economics and Financial Analysis (IEEFA) in its report, which was prepared based on the annual reports of the Bangladesh Power Development Board (BPDB).

Capacity payment is a sort of penalty that the buyer pays to plant owners if it fails to buy a certain portion of power readily

The cost of electricity purchased from IPPs now represents more than 50 percent of BPDB's total operating expenses for

A 58 percent increase in the IPP costs in fiscal 2020-21 was partly as a result of increased power units purchased from the plants -- 34.6 Terawatt-hour [TWh], up from 25 TWh the

The per unit cost of each kilowatt hour [kWh] power purchased from the IPPs rose to more than Tk 8/kWh last fiscal year from Tk 7/kWh in fiscal 2019-20.

### **Proposed water** price hike totally unacceptable

Govt should try to ease people's burden, not increase it

ARD on the heels of the price hikes of diesel and kerosene in last November, and amid continuing rise in edible oil prices, the price of water in the capital is also set to see a sharp rise after Dhaka Wasa proposed a 20 percent hike in tariffs. If the government approves it, it would cause a big dent on the residents' wallet, not to mention the domino effect it may have on the prices of kitchen market commodities, especially with the month of Ramadan approaching. At a time when people are already at their wit's end trying to cope with the pandemic-induced economic pain and adjust their budget to erratic market behaviour, the Wasa proposal comes as a big shock indeed.

The proposal for increasing water price by 20 percent is not comprehensible, as technically, Dhaka Wasa can increase the tariff by 5 percent each year as per Section 22 of the Wasa Act, 1996. But in his defence, Dhaka Wasa's managing director said that a 5 percent hike is not "sufficient" as it cannot match the production cost even with the government's subsidy of Tk 10 per litre of water. As per the new proposal, the price of each unit (1,000 litres) of water should be Tk 21 for residential use and Tk 55 for commercial use, whereas the current prices are Tk 15.18 and Tk 42 respectively. As well as bringing down subsidies, the other reason cited for the proposed hike is the need to pay back Wasa's foreign loans with

Unfortunately, while Wasa officials seem keen to enhance water tariff at every opportunity—which they have done twice in the last two years and 15 times in the last 13 years—they have never shown much enthusiasm in fulfilling their pledge of providing clean, safe drinking water to the vast majority of the capital's over two crore residents. Seldom do they feel the need to answer for their failure to do so, while residents continue to suffer the brunt of their lack of competence, vision and accountability. The proposal for water price hike is especially troubling with all the talk of raising the prices of electricity, gas and fertilisers by March.

The combined effect of all these price hikes coming in quick succession would be unimaginable. The pandemic has already caused immeasurable suffering and hardship to the people, pushing a vast number of them beyond the poverty line. Unemployment has reached an alarming level. People are also struggling with the rising healthcare costs. This is no time to compound their suffering. We urge the government to see the bigger picture here and not entertain the misguided Dhaka Wasa proposal. The government should also find alternative ways to fund or manage its subsidies.

### Check the wave of cybercrimes

Govt should make digital space safe for women and children

TE are quite concerned at the increasing incidents of cybercrimes against women and children in Bangladesh. According to Ain o Salish Kendra (ASK), 70 percent of the victims of cybercrimes are women. The rights organisation has found this after analysing data from a recent police survey. In a separate survey, the ministry of posts, telecommunications and information technology has found that 49 percent of schoolchildren are becoming victims of cyberbullying. The real situation can be worse, as many victims or their families do not report these crimes to the police, fearing social stigma or further victimisation.

Cybercrimes have increased particularly during this pandemic which led to a rise in the number of internet users. From January 2020 to August 2021, the number of internet users has increased by 26.21 million in the country, according to the Bangladesh Telecommunication Regulatory Commission. A large portion of them are teenagers who are using internet mainly for academic purposes, as schools and colleges have resorted to online classes to contain the spread of the coronavirus.


Unfortunately, most teenagers and young adults have no awareness of the danger internet poses. A survey conducted by the University of Liberal Arts Bangladesh last year found that teenage girls are less aware than boys of the risks of cyberbullying, stalking, harassment, sexual abuse and production or consumption of illegal materials. Although police introduced a helpline to provide support to the victims in 2020, few people used that to report crimes. And those who did and sought help, less than half of them got any legal advice and assistance, ASK found.

Amidst such a grim situation, what needs to be done on a priority basis is raise awareness among young users about the harmful aspects of the internet. ASK has also identified some reasons—such as lack of importance given to children's mental health, domestic violence, absence of sexual and reproductive health and cyber security education—behind the increase in cybercrimes. Addressing these issues is crucial, and parents and educational institutions have a key role to play here.

Of course, a major part of the responsibility to stop such crimes falls on our police force, especially the cybercrime fighting unit. Since police have a specific unit to work on the issue, they must have the willingness and required manpower and tools to reach out to all the victims who report to them and provide them prompt and necessary support. Also, cases filed in connection with cybercrimes must be disposed of quickly, which will act as a deterrent to prospective criminals.

in Paragraph 64, states, "The Working Group reiterates its concern regarding the situation of enforced disappearances in Bangladesh, which it has been raising in similar reports for several years with scarce engagement by the government. In this regard, the Working Group notes that it has not received replies to any outstanding cases during the reporting period, and that only one case has been clarified by the government since the Working Group transmitted the first case in 1996. The Working Group hopes to receive information on the outstanding cases as soon as possible. Allegations of enforced disappearances, notably those carried out by the members of the Rapid Action Battalion (Rab), should be promptly investigated and those responsible prosecuted." In Paragraph 65, it states, "The Working Group reiterates its interest in undertaking a visit to Bangladesh, as expressed in several communications transmitted since 2013."

As is obvious from the WGEID report, they have been in touch with our government since 1996—in other words, for the last 26 years. Since 2013, the group wanted to visit Bangladesh, but no permission was granted. When the foreign minister accuses WGEID of "no research," the answer lies in the fact that we didn't allow them a fact-finding visit since their first request nine years ago. Why? What have we to hide?

We could verify that at least on three occasions—September 2013, November 2013, and October 2015—the Permanent Mission of Bangladesh in Geneva acknowledged the receipt of communication from the Working Group and replied saying, "The Permanent Mission has the honour to assure that the contents of the communication have been duly noted and forwarded to the

I think our foreign ministry owes an explanation to the people and especially to the prime minister as to their inexplicable inaction over more than two decades, and especially since 2013.

The "real reason" for the sanction by the US, the foreign minister said, is neither human rights nor disappearances but "to put pressure on us." In doing so, he is directly pointing fingers at the US and accusing them of duplicity. How diplomatic is that, especially when you are negotiating for its reversal? Putting pressure is the name of the game in relations between superpowers and the rest—who does not know it? But shouldn't our minister handle it diplomatically, through secret negotiations, subtle messaging, third parties, meetings under different guise, visits, etc? How does it help if he says publicly that we have become an "eyesore"? Earlier, when the US did not invite Bangladesh to the Democracy Summit, he said it was possibly because the US only invited weak" democracies. Diplomacy, indeed.

Glib media responses and accusatory comments about countries who have temporary problems with us do not diplomacy make. Matured engagements do. Our pathological aversion to accountability will not take us very far. Our tendency towards overconfidence due to recent economic success may prove to be counterproductive—in some cases, extremely so.

Please do not take our international partners for fools. They deserve our most serious engagement—especially as we now aspire to be a developed country.


#### Why Chandrashekhar Dasgupta's book is the last word on India's role in 1971

Shamsher M Chowdhury, BB is the former Foreign Secretary of Banaladesh RETIRED Indian diplomat Chandrashekhar Dasgupta's recollection of the events of 1971, centring on the Bangladesh Liberation War as captured in his recently published book, India and the Bangladesh Liberation War: The Definitive Story (juggernaut, 2021), is

indeed what the sub-caption of the book suggests—it is arguably the most definitive story. As the author says in his introduction, the book is not about the military operations of December 1971, nor is it a global history of the war; it is about India's grand strategy in 1971 and how this was played out comprehensively and in a seamlessly coordinated manner, employing all the resources available to a state—diplomatic, military and economic—to achieve a political objective.

Dasgupta highlights that even the absence of an institutionalised coordination mechanism in the establishment did not stand in the way of its execution. Going through it, any reader would agree that the book is the product of lengthy research by, and sheer perseverance of, the author. This explains the minute details of the events of the period, both inside India and in the international arena. Dasgupta goes to great lengths to talk of the interactions and discourse between and among the major stakeholders-the government of India, the Bangladesh government in exile and the key players in the global arena. Dasgupta's emotional attachment to the events is perhaps explained partly by his personal experience of being among the first few Indian diplomats to be assigned to the just-opened Indian diplomatic mission in Dhaka—an assignment any Indian diplomat would have coveted and cherished—and partly by his own desire to understand, and record, the entire gamut of what transpired at various stages during the nine months between March and December of 1971.

The book is, at once, illuminating and instructive. It starts off with a potent quote from Bengal's highly-revered political leader, Abul Mansur Ahmad, on how little there was in common between the two wings of Pakistan. This reflects Chandrashekhar Dasgupta's deep insight into the political, social and cultural reality of Pakistan. In the opening two chapters, Dasgupta expands on Ahmad's quote to understand how the fissure that existed at the country's very birth, tectonically morphed into a gaping fault line and then led to its inevitable disintegration, and how Sheikh Mujibur Rahman was a central figure in this historic passage. An entire chapter is devoted to the Bangladesh Mukti Bahini; its birth, its growth and its critical role leading to the final liberation of the

During the nine months of the Liberation War, that Pakistan's military leadership, and Zulfiqar Ali Bhutto, had their heads buried in the sand is all too well-known, that the Nixon administration—especially his principal analyst, Henry Kissinger—got it all wrong from the very beginning is also clear, and that, in the end, China's posturing for Pakistan would not be matched by any military action also became evident. The book graphically elaborates on all of the above in finer details. What is illuminating in the book is its descriptive revelation of the process of convergence of minds between India and the then Soviet Union. This was not a given, as many erroneously thought it was. Dasgupta writes in great detail about how the process evolved. No denying that the prevailing Cold War played its part in this, but the driving force behind it was India's well-choreographed diplomacy, anchored by Prime Minister Indira Gandhi herself, aided as she was by a highly-astute team of technocrats in the persons of PN Haksar, DP Dhar, TN Kaul, RN Kao, et al. The passage of the Soviet position—from one of initial circumspection to that of an ally, culminating in the historic Indo-Soviet Treaty of Peace, Friendship and Cooperation in August 1971—was clearly the outcome of deft diplomatic handling by India and an equally mature response from Moscow. Dasgupta carries the reader through the entire process of negotiations step-by-step, with focus on dealing with the tricky Article 9. The Treaty was a game changer in more ways than one. It hardened the Soviet stance towards Islamabad, starting with cutting off arms delivery. Dasgupta amplifies this in Chapter 10 where Andrei Gromyko, the crafty Soviet Foreign Minister, made it known to the visiting Pakistan Foreign Secretary Sultan Mohammad Khan in September that Moscow's words to the Pakistani leadership to not provoke a war with a treaty partner and to ensure the safety of Sheikh Mujibur Rahman was not a request. The strategically important convergence between India and the Soviet Union also gave the Nixon administration and China enough food for thought. For one, it served India to use this convergence as a countervailing tool against the emerging Sino-US entente. It also enabled Mrs Gandhi to talk with the leaders in Washington, London, and in other Western countries from a

position of confidence. Importantly, it caused Soviet leader Leonid Brezhnev to recognise that the Bangladesh freedom struggle was a war for national liberation and also of the crucial role the Bangladesh Mukti Bahini played in this process.

The author quotes a senior Indian diplomat involved in the earlier stages of the negotiations, who aptly commented, "Article 9 has just the right amount of substance and shadow to confound our enemies and hearten our friends."

In the book, Chandrashekhar Dasgupta explains that the impact of India's role in the Bangladesh Liberation War, besides changing the geographical and political landscape of South Asia forever, was also felt on the critical issue of Kashmir between India and Pakistan. An important outcome of the 1972 Shimla Summit between the two countries was an agreement to take the issue out of the ambit of any multilateral framework (read: the UN) and confine it to bilateral arrangements. It also led to a rearrangement of the Line of Control in Kashmir.

Chandrashekhar Dasgupta's book derives its strength from the fact that it is based on indisputable evidence, irrefutable logic and undeniable truth. It is objective, succinct in both its form and content, easily readable and even easier to absorb. The book also reaffirms the point made by current Indian External Affairs Minister Dr S. Jaishankar in his own book, The India Way, that India's role in the Bangladesh Liberation War was the former's greatest diplomatic and military triumph.

One could be excused for wondering why it took so long for such key details to emerge in their totality. The counterargument would be that the timing of the book's launch coinciding with the 50th anniversary of the Liberation War of Bangladesh, and India's decisive role in it, makes the whole exercise more relevant.

Former Indian Foreign Secretary and National Security Advisor, Shiv Shankar Menon—undoubtedly one of the finest minds in India's foreign policy establishment—describes the book in one word: "Brilliant." He goes on to add that it is a must-read for scholars of history and geopolitics, diplomats and anybody willing to study the emergence of a different South Asia. Chandrashekhar Dasgupta's masterful scholarly work is all that, and then some.

HE one issue dominating British politics for weeks is nothing other than the partying going on at the heart of the government, at 10 Downing Street, the office-cum-residence of the prime minister. This scandalous partying, now dubbed as "Partygate" by the British media, raises serious questions about not only the standards in public life, but whether one of the world's oldest democracies can cling on to its global standing. Prime minister Boris Johnson's influence and grip over the nearly 200-years-old party, the Conservatives, has been quite remarkable and unprecedented.

Johnson's electoral successes, both in the Brexit referendum and in the 2019 general election, almost made him larger than his party. A veteran of British political journalism, Andrew Marr, wrote in *The New York Times*, that the Conservatives are in an agonised, self-flagellating panic. Should they get rid of Boris Johnson, their populist leader whose deceit and flouting of lockdown rules has infuriated a chunk of the country and embarrassed his party? Or should they stick with a man who, so far, has kept them in power?

The Partygate scandal is not about just one party for which Prime Minister Boris Johnson was in attendance, but over a dozen other similar ones that took place at 10 Downing Street, and which are now contributing to the description of the government's "partying culture." Twelve of those parties are being investigated by London's Metropolitan Police. The police investigation, however, has given PM Johnson some time to stave-off mounting pressure for resignation, by requesting the Cabinet office to withhold publication of the report of the other investigation—carried out by a top civil servant Sue Gray. Gray, who served as the director-general for Propriety and Ethics in the Cabinet Office from 2012 to 2018, is known for having forced out three ministers during her tenure.

Despite heavy redactions, Gray's report

had enough damning elements against the prime minister as it criticised "failures of leadership and judgement" at the heart of the British government. The report said, "At least some of the gatherings in question represent a serious failure to observe not just the high standards expected of those working at the heart of Government but also of the standards expected of the entire British population at the time." The scandal has engulfed Johnson's government so much that he had to cancel his prescheduled telephone call to President Putin to talk about the Ukraine crisis and attend parliament instead to table the Sue Gray report and respond to its findings.

Opinion polls show that the Partygate scandal has severely dented the electoral prospects of the Conservatives, giving the Labour party an advantage varying between 10 and 14 points. At least 15 MPs from his own backbench have openly called for Johnson to quit. The actual number of rebelling MPs, however, is speculated to be three times higher. It is hard for many people outside Britain to understand how Johnson is still holding on to his position, despite losing so much support outside and within his party. The main reason is that he holds a majority of more than 80 seats in the Commons, which frustrates any potential move by opposition parties to have a no-confidence vote.

The only option left for his removal is a clear, no-confidence vote within his party. But the Conservatives' internal rule stipulates that discussing any proposal to replace the leader requires a written submission to the chairman of the backbench committee (known as 1922 committee) by at least 15 percent of its MPs. This means that about 54 MPs have to officially call for a leadership change. But that does not automatically seal the fate of an incumbent leader of the Tory party. The party rules say that if the current leader is able to retain a majority within the parliamentary party, his/her position is secured for at least another year.

Despite such rigid rules of the Tory party, many pundits say there are signs that, despite Johnson's long history of beating the odds and pulling through rough waters, this Partygate scandal could end his premiership. According to them, if the police investigation results in him being handed a penalty for breaking lockdown rules or if Sue Gray's final report finds he lied to parliament, then it would be

terminal. Few others say, if the upcoming local elections in May show that Johnson is no longer a vote-winner, as the opinion polls have been indicating consistently,

then a sufficient number of party MPs would rally round his likely challengers.

Amidst the Partygate turmoil that prompted a series of high profile resignations and clearing out at Downing Street, and an attempt to revamp his administration, PM Johnson has come under renewed attack from all sides following an unruly mob confronting the Labour leader Sir Keir Starmer outside parliament on Monday. MPs from all sides angrily accused Boris Johnson of whipping up political poison by falsely accusing Sir Keir of protecting a notorious paedophile, Jimmy Savile. Johnson provoked widespread fury last week when he suggested Sir Keir had protected Savile during his time as director of public prosecutions. This latest incident has now fueled speculation that many more Tory MPs will have pens poised to write to the 1922 committee chief demanding a vote of confidence.


As the Bangladesh Premier League (BPL) heads towards the closing stages, the upcoming Afghanistan series, slated to begin with the ODI series on February 23, starts to come into view.

While Bangladesh find ODIs easier to deal with, their T20I skipper Mahmudullah Riyad would have to resist a strong Afghan T20I outfit in the twomatch T20 series, slated to be played between March 3-5 at Dhaka's Mirpur. The focus would be on the top-order form, especially the opening batters such as Mohammad Naim, who is lacking in form in the BPL following Bangladesh's T20 World Cup debacle.

Bangladesh's troubles at the top was further defined when Saif Hassan, initially earmarked as a Test opener, was played in the Pakistan T20Is at home. With Afghanistan's strength in the format is of particular concern, the ongoing BPL gives ndications of form and what the selector might be thinking.

'Naim is our regular opener in the T20s. Last year, Naim was the highest run-getter in T20Is [575 runs in 26 innings] for us. He's having a bad patch but this year, his BPL is not going well. However, not much time left," national selector Habibul Bashar told The Daily Star yesterday.

Naim has come in at number three, number four and number seven so far. In the match against Chattogram, he was pushed back to number eight, almost being shielded during a crucial run-chase with Tamim carrying the side. Then he failed to take advantage of a no-ball against Mrittunjoy in that last over, only



would want Naim, being last year's topscorer, to bat in other positions to increase his power-hitting abilities, Bashar said: 'Not at all, he's an opener. When he plays for Bangladesh, he will open."

Liton Das has been amongst the runs since the UAE debacle and has found runs in the BPL with two crafty knocks but consistency is an issue.

"He [Liton] wasn't dropped but rested and that time out worked for him. He's one of our best batsmen and has played well in the other two formats too. He is a bit off-colour in T20s but has the ability. Since Tamim isn't playing, his performance will be crucial at opening slot," Bashar said.

With everything considered, a rightleft opening combination would not be mandatory where 'the best two should play', according to Bashar.

Soumya Sarkar, too, has found runs in his last two BPL matches (43 and 82\*). Anamul Haque Bijoy (248 runs in 8 matches) is the fourth-highest run-getter in the tournament. Mahmudul Hasan Joy, looks like he has the head and the shots for the format, have paced himself well with a strike-rate of 132 -- the highest among local batters that are among top run-getters. 23-year-old Munim Shahriar appears to have the T20 mindset as well.

"We're thinking of everyone. It's good when top-order batters find runs in domestic cricket since it gives us options."

Head coach Russell Domingo is due to return on 19th of this month. "We will talk over Zoom [with Domingo] when we select the team," Bashar concluded.

The impact of leg-spinners in modern-day cricket cannot be understated, with teams around the world tending to focus more on this difficult art of bowling.

From the early days, when the likes of BS Chandrasekhar, Bill O'Reilly, and Abdul Qadir would dominate, the legacy of leg-spin continued. Australian spin legend Shane Warne took the art to the next level alongside flag-bearers like Stuart MacGill, Anil Kumble and Mushtaq Ahmed.

In the modern day, the likes of Rashid Khan, Adam Zampa, Adil Rashid, Shadab Khan, Imran Tahir, Yuzvendra Chahal and others have added excitement and become trump cards given their ability to turn things around single-handedly.

Unfortunately, despite the reputation for producing left-arm spinners since earning Test status in 2000, Bangladesh have failed to produce a single quality leg-spinner.

Alok Kapali registered Bangladesh's maiden hattrick in Test cricket with his legspin, but was hardly considered a specialist leg-spinner in the domestic circuit.

A few names popped up from time to time, like Jubair Hossain Likhon. He showed great promise and even made his Test debut for the Tigers at a very early age, but eventually faded away due to lack of

Aminul Islam Biplob, a batsman who turned into a specialist leg-spinner is among the latest casualties. Despite a decent T20I debut in 2019, the 22-year-old, nowadays struggles like Likhon to even make the playing eleven in the domestic circuit.

However, according to prominent coach Wahidul Gani, a former national spinner, there is no shortage of leg-spinners in Bangladesh in age-level cricket. He also believes it is important to put more emphasis into setting up a proper structure.

"We do have leg spinners in age-level but they don't get the opportunity to play. It is important to realise the importance of leg-spin. In club cricket, teams want to win games which is the reason they don't want to risk having a leg-spinner in the side because they can be expensive at times," Wahidul told The Daily Star.

give you wickets because they are attacking bowlers. It's important for teams to have a back-up in the bowling unit to accommodate a leg-spinner. If we can have special camps for leg-spinners like we have had for the pace-bowling unit, it will certainly help us find more leg spinners.'

It is widely suggested that aspiring cricketers in different age-level groups are deterred from taking up leg-spin as a serious option due to the difficulties and lack of assurances associated with the craft.

"You need to realise that there are different types of bowlers for specific formats. India's Chahal only plays the T20 format because he bowls a bit flatter and quicker. In Tests vou need someone who gives more air to the ball. So we need to pick those talents and make them fit for the specific role.

"I have seen youngsters interested in becoming leg-spinners because they also know there the country needs leg-spinners. We need someone like Imran Khan, who had fought with selectors to include Abdul Qadir in the team. And we all know what he did

Mentionable leg-spinning allrounders include Mohammad Ashraful, Alok Kapali and Sabbir Rahman.

At the moment, Aminul Islam Biplob is the only specialist leg-spinner in the national set-up.

There is no leg-spinner among the 24 cricketers with central contracts from the Bangladesh Cricket Board.

When asked if he felt it was fair to force teams to pick a leg-spinner in the playing eleven, national selector Abdur Razzak, a notable left-arm spinner in his day, responded: "Yes, there were instructions to have leg spinners in the side. But if you don't have a quality leg-spinner, you cannot push the team and that's why we don't see them playing in the BPL. We tried a few leg-spinners in the national team even after average performances. But when it comes to franchise cricket,

for the sake of providing opportunities. When we picked Jubair Hossain Likhon, he did well in Tests but suddenly has not performed since then. Consequently, he is out of the team. Aminul Islam Biplob also did reasonably well in India but since then has been unable to perform in domestic leagues. # The sorry tale of a Bangladeshi leggie

Jubair Hossain Likhon was quick to catch attention when he became Bangladesh's first specialist leg-spinner to play a Test in October 2014. But despite initially impressive performances, he disappeared from the scene almost as swiftly as he arrived. The Daily Star's Sabbir

*Hossain* caught up with the leg-spinner, who opened up and discussed various issues. The excerpts are

The Daily Star (DS): Talk us through your journey as a leg-spinner?

**Jubair Hossain Likhon** (JHL): I started as an opening batter but failed to do well. Then I started leg-spin after advice from my older brother. He told me there was no quality leg-spinner in the country so there was a chance for me to play at the top level.

DS: When did you realise you could master leg-spin?

**JHL:** Leg-spinners seem to have some natural gifts and I have my fair share. I have strength in my shoulders. I can bowl the googly and generate power from my fingers. When I started, I was getting turn. Then I realised that if I tried, I might do

**DS:** You made your international debut in 2014 but haven't had a chance to play since 2015. How does that feel?

**JHL:** All the players want to play for the national team. When I played, life was different, fun. I thought that I would provide my services for a long time. But unfortunately, I could not. However, the main obstacle to my return to the national set-up is that I don't get many chances to play in the domestic league.

**DS:** Can you elaborate?

JHL: An out-of-favour player can only return to the national side through good performances in domestic cricket. But in my case, I do not get chances at the domestic level. Many have said I am not good at all and discarded me. These sorts of words only damage your confidence and demotivate you. The same thing happened with the

rest of our leg-spinners. For a leg-spinner, one or two bad performances means the whole tournament is over for him. That is not case for others.

> **DS:** Where does the problem lie?

JHL: When I was dropped from the national side, the BCB kept me in the A team and HP team. The board has always encouraged leg-spinners,

but our domestic league officials don't have faith in us.

**DS:** What are your thoughts on the future of leg-spinners in the country?

JHL: If you look into it, you will find that leg-spinners have not been getting chances to play on a regular basis. We hardly have the opportunities to play two or three games a year. Of course, we need to practice a lot but there is no alternative to playing matches. If we only practice and barely play, it will have no impact. We won't be able to understand match situations. Some might say that I did not do well enough, but what about the rest of the leg-spinners in the country? Is there no one good enough to play regularly? Aminul Islam Biplob is in the national team now, but how many domestic matches has he played so far?

### You need to bowl 15 to 20 overs every day'

While Bangladesh are still searching for legspinners, Afghanistan have made producing world-class leg-spinners their forte. Rashid Khan has established himself among the best in world cricket, but the country has many other quality leg-spinners such as Qais Ahmed, who has become a sensation in franchise cricket worldwide. The 21-year-old, currently playing for Minister Dhaka in the ongoing Bangabandhu Bangladesh Premier League spoke to *The Daily Star's Mazhar Uddin* and discussed the subtleties to the art of leg-spin. The excerpts of the interview are below:

The Daily Star (DS): How much are you enjoying life as a global T20 cricketer?

Qais Ahmed (QA): I enjoy playing worldwide and sharing dressing rooms with great cricketers around the world. It feels really great to perform among those players and they also share their experience with me. I am learning a lot.

**DS:** Leg-spinners are dominating across the globe, especially in the shortest format. Can you describe the challenges a modern-day leg-spinner faces?

QA: Obviously leg-spinners have the ability to turn things around. In the shortest formats, batters tend to go after leg-spinners and this gives them an opportunity to outfox the opposition. It's a challenge to bowl a good line and length consistently. But once you adapt to it and bowl consistently, it makes life difficult for batters and then you start getting

**DS:** What is the secret to Afghanistan's production of quality spinners?

**QA:** There is no secret to producing quality spinners. To become a good leg spinner, you need to work really hard. You need to do a lot of spot bowling in the nets and you need to bowl at least 15 to 20 overs every day. That helps you assess yourself as a bowler. Legspin is a difficult art that you need to master. Without proper training, it's not possible.

DS: How can domestic cricket help leg-

spinners grow? QA: We have at least five-six leg-spinners in all the academies in Afghanistan and the competition is very tough. We have talent hunts, where youngsters come in and give trials. Then we gradually step towards grade

1, 2 and 3 level cricket.

And then they can

reach club level. The competition is very stiff have a lot of leg-spinners in Afghanistan at almost every level. By the time they reach the club level, they mature by playing games. It is very important for leg-spinners to play as many games as possible because it will

**DS:** How challenging will it be for Afghanistan to play Bangladesh at home in the coming series?

QA: It will be a challenge for Bangladesh at home considering the conditions and wickets. They have got some top-quality batters and bowlers such as Shakib Al Hasan and Mahmudullah Riyad. But we have been working hard. We had a training camp in Qatar and preparation-wise, we are ready.

DS: You made your Test debut against Bangladesh in 2019 and that remains the only Test you have played so far. You must want to establish yourself in the longest format as

QA: Who doesn't want to play Test cricket for their nation? I made my Test debut against Bangladesh and I am definitely willing to play all formats for Afghanistan. But we have got some worldclass spinners in the side

### **Engines of Biman's** Dash-8 'damaged'

Officials claim pilot erroneously used emergency power, failed to report; year-old plane grounded

A relatively new De Havilland Canada Dash-8 aircraft of Biman Bangladesh Airlines has been grounded since February 2 due to "damaged engines caused by pilot error".

The damage allegedly happened when pilot Ali Rubyat Chowdhury deployed the aircraft's emergency power system -- typically used to avoid an impending

accident -- in mid-air on the way to Sylhet from Dhaka on February 1, according to Biman officials well-versed on the matter.

This caused damage to the aircraft's two engines, which will now cost the carrier a huge sum to repair, the officials

claimed. As is practice, the pilot is supposed to report the incident

to the proper authorities, the airline's flight crew

members told The Daily Star on condition of anonymity.

As a result, the "unfit aircraft" was used on the return flight to Dhaka with 49 passengers on

There was a real possibility of the engines exploding during the flight, they claimed.

Even after landing in Dhaka, the matter was not reported to the engineering department. And the plane was being prepared for use the next day.

At the last minute, the aviation engineering department revoked the flight permit seeing data in the system logs that the emergency power was

Since then, the 74-seater aircraft, one of the three purchased from Canada's De Havilland, has remained grounded. De Havilland Canada and engine

manufacturer Pratt & Whitney have been asked to assess the damage. The plane was brought to Dhaka in February

last year, said Abu Saleh Mostafa Kamal, managing director and chief executive officer of Biman. Biman has formed a probe body to know under what circumstances did the pilot use the

emergency power, and whether there was any fault in his handling of the aircraft.

Chowdhury could not be reached for comment.

#### Shut Savar tanneries down

JS body asks environment directorate

A parliamentary body yesterday asked the environment directorate to shut down the Savar Tannery Industrial Estate, as the joint management committee (JMC) that runs the estate failed to comply with environmental standards.

The parliamentary standing committee on the environment ministry in a meeting also said the industry will remain shut until it takes steps to treat all the waste generated by tanneries.

The environment directorate in December sent a show-cause notice to the JMC, asking why the industry should not be shut down due to severe environmental pollution.

### Government to bring back Khairuzzaman

May face probe over 1975 jail killings

Former Bangladesh high commissioner to Malaysia, Mohammed Khairuzzaman, who was arrested by Malaysian police Wednesday morning, will be brought back home and could be investigated for his role in the historic jail killings

"Khairuzzaman is at a deportation centre in Malaysia right now. As far as I understand, there is scope to interrogate him again and investigate him," State Minister for Foreign Affairs Shahriar Alam said.

The home and law ministries will check whether the jail killing case can be revived and how Khairuzzaman, aged 70, could be investigated, Shahriar told reporters at the foreign ministry vesterday.

Khairuzzaman, who has been living in Malaysia with a refugee status since 2009, was arrested by the country's immigration police at his home in Ampang. Following his arrest, Malaysian Home Minister

Hamzah Zainudin said the arrest was made after a request from Bangladesh.

#### Food delivery man killed as lorry hits his cycle in city STAFF CORRESPONDENT

A food delivery man was killed after his bicycle was hit, allegedly by a lorry near the Palashi intersection in the capital yesterday.

The deceased was identified as Md Yeasin, 30. The incident occurred around 3:15pm when he was heading towards Palashi from Nilkhet, leaving him critically injured, said Sub-inspector Kawsar Ahmed Bhuiyan of Shahbagh Police Station.

Police said the lorry driver, Manik, along with some passers-by took the injured to Dhaka Medical College Hospital where doctors declared him dead around 3:45pm. Kawsar said they seized the vehicle and detained

However, Manik told reporters at DMCH that Yeasin fell on the road and was injured after a rickshaw hit his bicycle.

Yeasin, like every other day, left his Jigatola home in the morning on his bicycle to deliver food. The body was sent to the hospital morgue for autopsy, said SI Kawsar.
