#### Consumers paying for misdeeds of Wasa Say speakers at **CAB** discussion

The consumers are paying for the extravagance, mismanagement and corruption of Dhaka Water

Supply and Sewerage

Authority, said speakers at a virtual discussion. The Consumers Association Bangladesh (CAB) vesterday organised the discussion on the

proposed hike in water, gas

and electricity prices. They questioned Dhaka Wasa Managing Director Taqsem A Khan's Tk 6.15 lakh salary and the Tk 40 crore stimulus package that Wasa officials received last year.

Voktakantho Editor Kazi Abdul Hannan, also the keynote speaker at the event, said, "Tagsem A Khan has received a 421 percent salary raise [making it around Tk 6.15 lakh from Tk 1.20 lakh] since 2009 and his organisation increased water tariff 14 times during his tenure."

Wasa authorities proposed the price hike mentioning their loss, but their revenue is now Tk 7,000 crore whereas it was Tk 700 crore earlier, he

Hannan said Wasa wants to increase the price by 20 percent but the reality is different.

CAB President Ghulam Rahman asked, "Do the staffers and officials, who make extra profit by putting the burden of excessive price on consumers, deserve a bonus?'

"My request to the political leaders is to be accountable to the people everywhere, and provide relief to people ensuring SEE PAGE 6 COL 6

# Wasa grabbing money?

Md Belal Hossain, a pensioner from Old Dhaka, was livid when he picked up the morning paper on Wednesday: he learnt that Wasa was pushing to hike the water tariff by up to 40 percent.

"Is this a joke that I will have to pay more for the smelly, yellow water that flows out of my tap?" a furious Hossain told The Daily Star yesterday.

Rarely does he get clear water, and even then, the water is not fit to put in the mouth: there is a foul smell.

"This is just not acceptable. On what basis is Wasa raising the price?" he said,

while demanding better service quality. Like Hossain, hundreds of thousands of city dwellers are indignantly questioning the rationale behind the tariff hike -- which would be Wasa's third in three years and 16th in 13 years -- despite failing to fulfil the pledge of providing safe drinking water to



the vast majority of the capital's two crore residents.

And when one combs through the annual reports, Wasa's bid to hike the tariff - by 38.8 percent to Tk 21 per unit (1,000 litres) for residential use and by 31 percent to Tk 55 per unit -- seems like moneygrabbing.

Water Supply and Sewerage Authority

(Wasa) logged in a profit of Tk 49.6 crore, up 7 percent year-on-year, according to its audited financial report.

In fiscal 2016-17, it was Tk 22.6 crore, meaning the state-owned organisation's profit has more than doubled in five years.

"I don't see any logic behind the price hike of water as it is making profits over the last several years and has huge retained earnings," said Khondaker Golam Moazzem, research director of the Centre for Policy Dialogue.

Retained earnings are the portion of a company's cumulative profit that is held or retained and saved for future use, particularly for investment purposes. At the end of fiscal 2020-21, Dhaka Wasa's retained earnings stood at a staggering Tk 892 crore.

'Wasa could very well have dipped into its retained earnings instead of going for a tariff hike when the inflation is already on

#### **UNFIT VEHICLES** 5 lakh still on the road

More than five lakh registered vehicles are now on the road without fitness clearance mainly due to poor monitoring by the authorities amid the pandemic.

Many unregistered vehicles are running without undergoing any fitness test.

Also, unlicensed drivers are at the wheel of at least 10 lakh registered vehicles, indicates latest data of the Bangladesh Road Transport Authority (BRTA).

All these are making the country's thoroughfares riskier as statistics show that the number of road crashes increased sharply in recent years.

At least 5,088 people were killed in 5,472 road accidents last year, said police.

The number of deaths and road crashes were 3,918 and 4,198 respectively in 2020, meaning the figures rose by 29.86 percent and 30.34 percent last year.

The police's figures, collected based on the First Information Report (FIR) and General Dairy (GD), are much lower than those of the road

till last year. According to existing rules, motorcycles don't need fitness clearance.

Also, new cars, SUVs and microbuses are not required to have it in the first five years. After that period, they have to have their fitness cleared once every two years.

As these three types of vehicles had to take fitness clearances annually before January 2020, the number of vehicles eligible for fitness test should have been lower now and the number of unfit vehicles should have been smaller.

However, BRTA data shows 5.08 lakh registered vehicles, which are eligible for fitness test, did not renew their documents till last month. The figure had never been so large previously, sources said.

The number of unfit vehicles was 4.79 lakh in July 2019, according to a BRTA report submitted to the High Court as per its directive.


The state-run BRTA's 2020-21 annual report said 6.75 lakh vehicles received fitness certificates in the last fiscal year. The number was 7.5 lakh in 2019-20 and 7.06 lakh

An official of the government agency said around 2 lakh out of the 5.08 lakh vehicles are three-wheelers, which are used outside Dhaka. Besides, many of them are

# The sun comes down on Sandhya

"Ei poth jodi na sesh hoi...." The voice in the Uttam Kumar-Suchitra Sen-starrer film "Saptapadi', which has kept Bengali music lovers spellbound for generations, has fallen forever

silent. Singing legend Sandhya Mukhopadhyay, the last of the Mohicans of Bengal's golden era of modern music, passed away at eastern Kolkata's Apollo Hospital yesterday evening after suffering a massive cardiac attack at the age of 90.

She is survived by daughter Soumi Sengupta and son-in-law.

Sandhya was admitted to hospital on the evening of January 27, a day after she fell in her bathroom. She was later diagnosed with Covid-19 infection.

West Bengal Chief Minister Mamata Banerjee said "Sandhya'di" had recovered from Covid-19 but there was a sudden deterioration in her condition.

#### Ex MP chargesheeted in trader murder case **Probe finds involvement**

Former lawmaker MA Awal was the mastermind behind the killing of trader Md Shahinuddin, a police probe found.

The murder in front of the victim's seven-year-old son in broad daylight in the capital's Pallabi on May 16 last year made national headlines.

After a probe for around nine months, Syed Iftekhar Hossain, investigation officer and an inspector of the Detective Branch of police, submitted a charge sheet to the Chief Metropolitan Magistrate's Court of Dhaka on Monday, stating that the trader was killed under Awal's direction.

Besides the former Laxmipur-1 MP, 14 others were involved in the killing, the probe report said.

They are Sumon Bepary, Mohammad Taher, Golam Kibria Khan, Mohammad Murad, Titu Sheikh, Mohammad Rocky Talukder, Nur Mohammad Hasan, Mohammad Sharif, Iqbal Hossain, Tariqul Islam Imon, Tuhin Miah, Shafiqul Islam, Harunur Rashid and Ibrahim Sumon.

According to the charge sheet, Awal and Shahinuddin got locked into a conflict as the former lawmaker failed to grab the latter's land for a project in 2004.

Awal had drawn up a blueprint for the killing with Sumon and Taher in his Kalabagan office, it further said.

On May 16, Sumon and 12 others, whom he had hired for the murder, went to Mirpur 12 after asking Shahinuddin to meet them there to "settle the land

Around 4:00pm, Shahinuddin arrived at the spot with his son.

In front of the child, the group swooped on him and and indiscriminately hacked him with sharp weapons, killing him on the spot.

According to the charge sheet, Sumon then called Awal on the phone and said, "Sir, finished."

MA Awal was arrested in the case on May 20 last year. After remand, he was sent to jail on May 26.

The IO had dropped names of 13 accused from the charges as their involvement was not found during the investigation.

He also appealed to the court to issue arrest warrants against Shafiqul and Ibrahim as they were shown fugitives in the charge sheet.

During the investigation, Sumon, Rocky, Murad, Nur, Sharif and Iqbal gave confessional statements before magistrates on different dates.

Two others accused -- Monir and Manik -- were killed in "gunfights" with law enforcers.

The next hearing on the case is scheduled for February 17.

#### **ANTIMICROBIAL API** Kirtankhola worst affected in the world

The Kirtankhola river has the greatest excess of an antimicrobial API in the world, according to a global study that found levels of metronidazole in the river water to be more than 300 times the safe limit.

In an article titled "Pharmaceutical pollution of the world's rivers", the researchers said the findings are crucial for Bangladesh as environmental exposures of antimicrobial APIs (active pharmaceutical ingredients) may result in antimicrobial resistance (AMR) crises locally and globally.

Antimicrobial APIs come from antibiotics, according to the article published in the Proceedings of the National Academy of Sciences journal

on Monday. Besides, the study indicated that the surveillance of pharmaceutical waste management in the country is

lackluster, experts said. Tapos Kormoker, one of the 127 researchers involved in the study, told The Daily Star yesterday that it will take another study to know the reason for the high concentration of

metronidazole in the Kirtankhola. "The revelation indicates a very

dangerous situation. The germs will easily develop resistance against metronidazole at community level as the river water is consumed by many means," Dr Muniruddin Ahmed, professor of the Department of Clinical Pharmacy and Pharmacology of Dhaka University, told this newspaper yesterday.

The Kirtankhola was one of the 258 urban-centric rivers that have been surveyed in 104 countries in all the continents, according to the article.

A total of 61 APIs was measured under the study.

Tapos Kormoker, a researcher from the energy management department at Patuakhali Science and Technology University, collected water samples from 10 points along 2.5km of the river near Barishal city to measure the API concentration in April 2018.

Of all the APIs measured, concentration of 60 were found within the safe limit.

"The higher concentration of metronidazole indicates that waste containing metronidazole APIs are being discharged into the river without treatment and waste of industries, where different types of chemicals are used, may be the main factor," Tapos said.

About other APIs, he said, "Around four years have passed since we measured the water. So, it is highly likely that most other APIs have also crossed the limit.

"Most probably, the water in other urban-centric rivers, especially the three rivers near Dhaka city, have become polluted with APIs."Metronidazole is an antibiotic and antiprotozoal medication used either alone or with other antibiotics to treat pelvic inflammatory disease, endocarditis, and bacterial vaginosis, according to the experts.

Prof Muniruddin Ahmed said, "The API pollution is not good at all and requires controlling. But the Directorate General of Drug Administration does not have much control over it."

According to DGDA officials, each pharmaceutical factory must treat their liquid waste through effluent treatment plants (ETPs) while solid waste has to be incinerated.

Md Ayub Hossain, a director and spokesperson of the DGDA, said, "No pharmaceutical company can operate a plant without an ETP. Besides, they must follow proper waste management procedures. We h regular surveillance in this regard."

#### Khairuzzaman can't be deported: Malaysia HC

The Malaysian High Court yesterday barred the country's immigration department from deporting Mohamed Khairuzzaman, former Bangladeshi high commissioner to Malaysia.

Judge Mohamed Zaini Mazlan granted the order after holding a hearing of a habeas corpus plea, reported Free Malaysia Today.

Khairuzzaman was picked up by immigration authorities from his residence in Ámpang on February 10.

The detention led to speculations in Dhaka about whether he could be investigated for his role in the killing of Bangladesh's four national leaders in jail in 1975.

#### DGHS plans to inoculate 1cr on Feb 26

The Directorate General of Health Services plans to inoculate one crore people with the first jab in a special vaccination campaign on February 26.

The government will reach its vaccination target for the first dose through the special campaign, said Prof Abul Bashar Mohammad Khurshid Alam, director general of the DGHS.

"We would urge everyone to take the vaccine," he told a press briefing.

The government has inoculated around 10.06 crore people with the first dose as of Monday. Meanwhile, the DGHS yesterday reported 34

deaths from Covid-19 and 4,746 new cases of the coronavirus.

#### Pradeep, Liakat seek acquittal

Condemned convicts Pradeep Kunar Das and Liakat Ali yesterday filed three separate appeals with the High Court, seeking cancellation of their punishments and requesting acquittal.

The suspended police officers were convicted in the sensational murder case of Major (retd) Sinha Md Rashed Khan.

Pradeep and Liakat claimed in their appeal that they were innocent and the charges against them were faulty.

On January 31, Cox's Bazar District and Sessions Judge Mohammad Ismail sentenced Pradeep and Liakat to death and six others to life in prison.

#### Fortify Rights wants arms embargo on Myanmar

Fortify Rights has urged ASEAN to support the establishment of a UN Security Councilmandated global embargo on the sale of weapons and military technology to Myanmar.

The Myanmar military massacred civilians, used human shields, and committed other atrocities in Karenni State in acts that may amount to war crimes, said Fortify Rights in a report published yesterday.

At least 61 civilians in Karenni State were murdered by the Myanmar military, it said. The call comes ahead of ASEAN foreign ministers' annual retreat today.

#### 5 lakh still on the road

10.13 LAKH UNLICENSED **DRIVERS** 

Till June 2021, BRTA issued 37.63 lakh driving licences against 47.76 lakh registered vehicles, indicating that 10.13 lakh vehicles are being run by unlicensed drivers.

The actual number of licensed drivers may be less issued because many people collect more than one -one for a motorbike or a light vehicle and another for a heavy vehicle, a BRTA official said.

Moreover, more than 10-20 lakh unregistered vehicles, including locally-"Nasiman" and

"Kariman", are plying roads without undergoing any fitness test. Drivers of those do not have any licence either, said people involved in the transport sector.

**GETTING** SITUATION WORSE

expert Prof Transport Moazzem Hossain said there was a trend among drivers to run vehicles than the number of licences without a licence or with a fake one. Besides, many vehicle owners avoid fitness test for fear of hassle at the BRTA office.

The trend has grown now, resulting in the rise in the number of accidents mainly because of the BRTA's management incapability and a lack of

transparency, he said. For example, BRTA

provided a very limited number of digital licence cards to drivers over the last two years. It provided manual tokens to licence seekers and extended time for the delivery of licence cards several times, creating scope for using fake licences, Moazzem told The Daily Star on February 9.

she said, "As we started the fair behind schedule this time, I think we can continue it for a full month. Besides, there is also


a demand from publishers to extend its duration.' Noting that she shouldn't take the decision alone, she directed authorities concerned to consider this.

#### Seven sued under DSA

Seven people, including editor of a Bangla daily and chief-editor of a news portal, have been sued under Digital Security Act on charge of publishing and circulating false, defamatory and offensive information.

They are Bangladesh Pratidin Editor Naem Nizam; its publisher Moynal Hossain Chowdhury; news portal Bangla Insider chief editor Syed Borhan Kabir; and admin, narrator, videomaker and technician of Facebook page Viral Protidin.

Barrister M Sarwar Hossain filed the case with the Cyber Tribunal of Dhaka vesterday, court sources said.

On August 17 last year, Sarwar took part in the hearing of a no-confidence petition filed against the final report that cleared Bashundhara Managing Director Sayem Sobhan Anvir from charges of abetting suicide of a college student.

After a hearing yesterday, Justice Mohammad Ash Sams Joglul Hossain recorded the complainant's statements and directed Criminal Investigation Department (CID) to submit a report before the tribunal by March 15, after investigating the case.

According to case documents, Naem Nizam and Moynal Hossain Chowdhury on

The High Court yesterday wanted to know the major sources of air pollution in the country and the government's action plan to curb it.

In response to a petition, the court directed the government to identify and make a list of the activities mainly responsible for air pollution.

It asked the authorities to prepare a time-bound mitigation plan for setting up air quality monitoring systems at appropriate places and introduce a system to prevent people's exposure to unhealthy air.

The officials have also been directed to develop an action plan about switching to alternate of burnt bricks and to submit a report to the HC in four months, said petitioner's lawyer Syeda Rizwana Hasan.

The HC also issued a rule in this regard.

Secretaries concerned of the ministries of cabinet division; local government and rural development; forest, environment and climate change; industries; housing and public works; health and family planning; road, transport and bridges; finance; mayors of DNCC and DSCC: directorgeneral of DoE; chairperson of Rajuk; chief engineer of RHD; chairman of BRTA; and DoE director (monitoring and enforcement), have been made respondents to the directives

said Dhaka was almost at the top of air pollution in the world at the beginning of 2022 and its residents have inhaled clean air for only 38 days in the last six years, according to a study conducted by Stamford University's Center for Atmospheric Pollution Studies (CAPS), from 2016 to 2021.

Different countries have issued urgent health alerts to protect their people from hazardous air quality. However, Bangladesh took no such initiative yet, although 1.53 lakh people die every year due to air pollution. Rizwana Hasan appeared for Bela while DAG Samarendranath Biswas represented the state during

pollution and construction sites are contributing largely to deteriorate air quality.

Tejgaon topped in air quality deterioration in Dhaka, while Gazipur ranked first among districts, according to the study.

Development works outdo other sources of pollution as brick kilns and unfit vehicles used to occupy the most and second most contributor of air pollution. The air quality falls far below national standard level. The permissible limit of Particulate Matter (PM 2.5) is 15 micrograms, while Dhaka dwellers inhale the highest 70 micrograms and lowest 50 micrograms- both are well below the standard level.

#### It will only reduce the aspirants' options

Says Samajtantrik **Chhatra Front on** scrapping 'D' unit entry tests at DU

Samajtantrik Chhatra Front's Dhaka University chapter yesterday demanded cancellation of the university's decision to scrap "D" unit admission tests under the social sciences faculty.

Leaders of the left-leaning student organisation during a press conference at Madhur Canteen at DU said the university authorities have taken the decision ignoring the recommendation of 16 departments of the faculty.

The decision will reduce opportunities for admission aspirants.

On February 7, DU general admission committee decided to cancel the D unit admission test to reduce pressure on aspirants. The decision is supposed to be implemented from the academic year of 2021-2022.

DU Vice-Chancellor Professor Akhteruzzaman said this issue had been in discussion since last year.

"Some teachers disagreed with the decision but we went ahead anyway following a democratic process in our forum. We want to reduce exam pressure on aspirants."

#### Rubana Huq new VC of AUW

The trustee board of Asian University for Women (AUW) in Chattogram appointed Rubana Huq as the new vice chancellor of the university. Huq, who gained prominence as the first

female president of Bangladesh Garment Manufacturers' and Exporters' Association (BGMEA), has been a trustee of AUW and was recently elected as vice

chairperson of the board. A published poet, she earned her PhD in literature from India's Jadavpur University, according to an AUW statement. She was instrumental in

launching AUW's Pathways for Promise programme, which enables exceptionally talented workers from Bangladesh's readymade garment (RMG) factories to enrol at AUW.

In announcing Huq's appointment, Education Minister Dipu Moni, chair of the AUW trustee board, said, "In Dr Rubana Hug, the trustees found an exemplary leader and administrator to lead AUW to its next stage of development."

While accepting the appointment, Huq said, "To me, AUW has always been a symbol of creativity and ingenuity. The institution's unassailable commitment to both scholarship and education, the calibre of the faculty, and the spirit of the students from all over Asia make AUW unique."

Huq succeeds noted political scientist Professor Nirmala Rao, who was VC for five years.

#### **ONLINE TICKETING**

#### Railway hires new operator

After 15 years, Bangladesh Railway has changed its vendor for its ticketing services, which often comes under fire for mismanagement.

BR yesterday hired a joint-venture firm led by Shohoz Limited to deal with its ticketing services for the next five years. Synesis IT Ltd and Vincen consultancy pvt ltd are partners in the firm.

Sardar Shahadat Ali, additional director general (operations) of BR, and Maliha M Quadir, managing director of Shohoz, signed the contract at the capital's Rail Bhaban.

The new vendor is slated to start work from the 22nd working day of the contract, upon successful handover from the present vendor.

"We will deploy our solution within 18 months. In the meantime, we will use the current vendor's solutions, both hardware and software, which actually belongs to the railway," Maliha told The Daily Star last night.

Railways Minister Nurul Islam Sujan said ticketing is one of BR's most contested issues, with allegations of black marketing tickets rife over the years. He said fixing this has been one of the major initiatives he undertook after taking charge of the ministry in 2019. Whereas current vendor Computer Network System or CNS Ltd gets around Tk 3 as service charge per ticket, the new vendor is set to get Tk 0.25 for per ticket.

CNS Ltd has been providing the service since 2007, when BR first started selling train tickets online. Currently, BR sells 50 percent of its total tickets for intercity trains online. Meanwhile, though Shohoz Limited came out as the successful bidder, CNS has filed a case with the High Court, which forced BR to continue with CNS as long as the case was pending, Sujan said. The case has been resolved now.



#### Hope for the newborns

90 couples show interest to adopt two abandoned infants

At least 90 couples from across the country have expressed their interest to adopt two newborn babies found abandoned in Lalmonirhat and Chattogram.

For the baby rescued from Lalmonirhat, at least forty couples from different parts of the country have applied to adopt the newborn, expressing their interest over phone to Lalmonirhat Sadar Police Station on Monday, confirmed OC Shah Alam.

The newborn is undergoing treatment at Lalmonirhat Sadar Hospital. The OC said investigations are on to identify her real parents. They will submit a report to the court, which will make the final decision.

Someone left the newborn on the road next to a dustbin at Puranbazar on Monday morning. Police rescued the child and admitted her to the hospital.


In Chattogram, at least 50 couples have shown interest to adopt the newborn rescued from the city's Anwara Health Complex on Monday.

# They don't know what historic grounds they stand on

5/1, Becharam Dewri now just another semi-commercial space



The Language Movement did not just come to be. Behind the historic movement, that brought about a turn of events for Bangladesh, are a million stories — of people, of premises, of places. In this 10-part series, we explore some of the places and premises vital to the movement. Establishments that we've lost to time, buildings that today bear no sign of the glories they once played host to. For part four, we take you to 5/1, Becharam Dewri, a stronghold of the movement's Old Town chapter.

**DIPAN NANDY** 

Becharam Dewri. The name itself comes with the fragrance of various kinds of biriyani, all of which taste different too.

But the area takes up a different kind of significance when discussed as part of the Language Movement's history, and it all started with one building: 5/1, Becharam Dewri. The home of AKM Golam Mostafa and Golam Mortuza, 5/1, Becharam Dewri was a refuge for the movement's organisers. Over time, it became a bastion of the movement's Old Town chapter too.

According to MR Mahbub's "Ekushev'r Sharok", numerous important meetings of the movement were held here. Back in 1947-48, most people around the Old Town were against the movement, but even in such an adverse climate 5/1, Becharam Dewri continued to house revolutionary

Recalling memories of those times, AKM Golam Mostafa wrote, "Our 5/1, Becharam Dewri was at the centre of discussions

related to the movement. Numerous secret meetings were organised here, while it also sheltered many pro-movement activists of Old Dhaka. After a point, important figures of the time started visiting us-Bangabandhu Sheikh Mujibur Rahman, Mawlana Bhashani and Abdur Rashid Tarkabagish, all of them came here from time to time.'

In a 2015 interview, Language Movement veteran Muhammad Takiullah said, "I've been there many times. Both Golam Mortuza and Mostafa were old acquaintances. From 1948-1952, this was the unofficial office of the movement."

Language veteran Dr Ahmed Rafiq also had a lot to say about the building. "Golam Mortuza was quite despondent over how their residence and Old Dhaka's contributions to the movement were

never spotlighted. He'd often lament and say "us Dhakaiyas had a role to play, but it remained neglected by writers and historians."

"In '52, especially after February 21, the newspapers didn't recount their roles, nor was the addresses of the martyrs highlighted. Researchers and historians of the new generation should come forward to compile these details of the movement."

Today, 5/1, Becharam Dewri houses four shops -- a biriyani house and three hardware stores -- while some rentees live on its first floor. Despite circling it a couple of times, this correspondent could not find any plaques, signs or memorials retelling its glory days.

Dulal Mostafa, son of AKM Golam Mostafa and current owner of the house, told The Daily Star, "These premises were significant for the Language Movement. But due to circumstances, we could not keep it for ourselves. Those who are renting and using it today do not know what historic grounds they stand on."

Golam Mortuza was quite despondent over how their residence and Old Dhaka's contributions to the movement were never spotlighted. He'd often lament and say "us Dhakaiyas had a role to play, but it remained neglected by writers and historians.

# 850 lives saved by 2

Quick-witted locals save Banalata Express from disaster

In something of a miraculous development, the Dhaka-bound inter-city train Banalata Express narrowly escaped an accident in Charghat upazila of Rajshahi yesterday morning.

The train was carrying 850 passengers, railway officials said.

The accident was prevented thanks to two locals - Ziaur Rahman and Hablu Miah. Around 7:30am, they found a crack on the railway track in Ramchandrapur village between Arani and Nandangachhi railway stations, railway sources said. Seeing that the train was rushing in, they immediately hoisted their red towels (gamchha) to alert the driver of impending doom.

Seeing the signal, the train immediately ground to a halt, saving many lives in the process. After this, railway authorities

started an emergency repair work. Following two hours of suspension, train communication resumed around 9:30am.

The incident occurred merely four days after a similar situation in Arani area of the neighbouring Bagha upazila. On the day, a temporary railway gateman detected a large crack on

the track and saved a train carrying 300 passengers from accident by hoisting red flag. Talking to The Daily Star, West Zone General Manager of Bangladesh Railway Ashim Kumar Talukder said the railway tracks on which the cracks were found are more than 50 years old.

"Yesterday's crack appeared as the gap between the slippers was bigger than required," the GM said, adding that the track was repaired only a few years ago.

Meanwhile, the two incidents have left their marks on the neighbourhood, as locals said they have been gripped with panic as faults on the track are being found almost every week for the last two months. They said it is fortunate that the faults are being found ahead of time, but a fatal accident could take place any time.

Saiful Islam, a social worker from Charghat, said, "Even though these tracks see 32 trains every day, it hasn't been repaired in recent years."

The tracks are developing all these cracks due to this high pressure of trains," he said. Railway GM Ashim Kumar Talukder said they

have already sent proposals to set-up new tracks

and install concrete slippers on the tracks.

### After a year in office, what did the Ctg mayor achieve?

One year has passed since Chattogram City Corporation (CCC) Mayor Rezaul Karim Chowdhury took charge, but most of his prioritised pledges are yet to be fulfilled.

In his manifesto, Rezaul, who was an Awami League candidate, made 37 pledges, which he would fulfil, if voted mayor. He assumed office on February 15, 2021.

The pledges include addressing waterlogging, traffic congestion and mosquito menace; evicting illegal occupation from canals, drains and footpaths; improving garbage management and health services; and ensuring adequate LED lights for roads.

This correspondent talked to some prominent citizens to evaluate the mayor's activities in the last one year.

Contacted, Consumers Association of Bangladesh (CAB) Vice President Nazer Hossain said a year is not enough to judge the mayor, who has been elected for a five-year tenure.

Even then, there are some failings, he said. "For example, three people, including a university student, died after falling into drains recently, but CCC failed to handle the issue properly. Instead of taking steps to build retaining walls or slabs around open drains, the mayor blamed CDA [Chatogram Development Authority for the accidents.'

BNP Chattogram city unit president Dr Shahadat Hossain, who was Rezaul's main rival in the CCC polls, said "We have seen CCC and CDA blaming one another for waterlogging and accidents in open drains.'

"The mayor has failed to take proper initiatives to fulfil his pledges," he said. Dr Mahfuzur Rahman, convener of Public Health Rights Protection Committee, SEE PAGE 4 COL 6

#### Plastic, chemical pollution beyond planet's safe limit

AFP, Stockholm

The torrent of man-made chemical and plastic waste worldwide has massively exceeded limits safe for humanity or the planet, and production caps are urgently needed, scientists have concluded for the first time.

There are an estimated 350,000 different manufactured chemicals on the market and large volumes of them end up in the environment.

"The impacts that we're starting to see today are large enough to be impacting crucial functions of planet Earth and its systems", Bethanie Carney Almroth, co-author of a new study told AFP in an interview.

The study, by the Stockholm Resilience Centre, comes ahead of a UN meeting in Nairobi

at the end of the month on tackling plastic pollution "from source to sea", UN Environment Programme head Inger Andersen said on Monday.

Chemicals and plastics are affecting biodiversity, piling additional stress on already stressed ecosystems.

Pesticides kill living organisms indiscriminately and plastics are ingested by living things

"Some chemicals are interfering with hormone systems, disrupting growth, metabolism and reproduction in wildlife," Carney Almroth said.

While greater efforts are needed to prevent these substances being released into the environment, scientists are now pushing for more drastic solutions, such as production caps.

Recycling has so far yielded only mediocre results. Less than 10 percent of the world's plastic is currently recycled, even as production has doubled to 367 million tonnes since 2000.

Today, the total weight of plastic on Earth is now four times the biomass of all living animals, according to recent studies

#### Myanmar junta won't attend Asean summit

Myanmar's junta on Monday said it would not attend an upcoming Asean summit after the bloc's "regrettable" exclusion of its top diplomat over a lack of progress in defusing post-coup violence. Asean invited Myanmar to send a "non political representative" to this week's foreign ministers' meeting, citing a lack of progress on a consensus agreed last year to facilitate dialogue with opponents of the coup. The Southeast Asian country has been in turmoil since the military ousted Aung San Suu Kyi's civilian government, with more than 1,500 civilians since killed in crackdowns on anti-junta protests, according to a local monitoring group.

## India's hijab dispute reaches UP

A dispute over restrictions on the wearing of the hijab by female students in a southern Indian state has now reached India's most populous state of Uttar Pradesh, with a group of youngsters asking a college to ban the head covering.

Authorities closed colleges in Karnataka in India's south last week after a new uniform policy barred students from wearing headscarves in classrooms, leading to protests by Muslim students and counter protests by Hindu students.

Muslims have criticised the ban as another way of marginalising a community that accounts for about 13 percent of Hindu-majority India's 1.35 billion people.

In Uttar Pradesh, in the country's north and bordering New Delhi, a group of more than two dozen young men reached the Dharma Samaj College in Aligarh district on Monday and handed a memorandum to its officials seeking a complete ban on the hijab within its compound.

They had saffron shawls around their necks - typically worn by Hindus - said the college's chief

proctor, Mukesh Bharadwaj, adding he did not recognise the people. Currently, religious garb is not allowed in classrooms, but can be worn elsewhere on campus.

Uttar Pradesh is ruled by a Hindu monk from PM Narendra Modi's party and is in the midst of a multiphase election that ends next month. Hindu-Muslim disputes are often used for political gains in the state.

The hijab issue has already reached court in Karnataka. Hearings were scheduled to resume yesterday on whether the hijab should be allowed in class.

#### Vital tasks ahead for the search committee

It should nominate persons of integrity who can withstand undue pressure

E commend the search committee formed to nominate candidates for the next Election Commission (EC) for publishing the names that were submitted to them. The names of 322 individuals were published on the website of the Cabinet Division, although details of their endorsers were left out. Some major political parties have refrained from making any recommendations. Despite that, we have to acknowledge that this departure from the tradition of not disclosing names is the first step to what we hope would be a fruitful endeavour in finding the most suitable candidates to form the next EC.

The task for the committee now is to sift through the submissions, assess if the names of the best candidates came up, and finally propose 10 names to the president, who will pick five for the EC posts. We hope the identities of the 10 will be published too, with justifications provided for their nominations. However, there's no getting around the fact that in order for this process to be successful and accepted, it should be as representative as possible. That some opposition parties have boycotted this process of EC formation is, thus, troubling. If this is a sign of things to come, we may soon see a repeat of the acrimonious circumstances under which the last two highly controversial parliamentary elections were held.

It will be unwise to overestimate the power of a search committee in such a state of affairs. It has no control over whether all political parties will agree on the formation of the EC or an election-time government. But it has the vital task to roll the first dice and build confidence in the subsequent process, which it can do by ensuring that concerns raised by the boycotting parties are properly addressed.

A primary analysis of the names published shows that almost one-third of them are former bureaucrats. There are also former judges and military officials, academics, lawyers, and representatives of various other professions. While evaluating their eligibility, the committee should let us know what it is going to do to uphold the principles of integrity and neutrality. It should set, and subsequently publish, a clear guideline dictating the terms of acceptance and rejection. One criterion that we feel must be included is that no one with a past history of political allegiance, gainful engagement with the ruling party, or allegations of corruption and irregularity will be considered. The committee should also come clean about the endorsements of all political parties, so that the public can scrutinise them. Finally, it should hold public inquiries of the individuals being considered for the sake of transparency and confidence-building.

All these are vital for making the nomination process a success, and for the search committee to avoid a credibility crisis.

# No respite from illegal brick kilns

Illegal brick kilns in Brahmanbaria must be shut down

T is alarming to know that at least 99 brick kilns in Brahmanbaria are operating illegally, posing serious threats to the environment and public health. A report by this daily states how these brick kilns have been set up beside bazaars, croplands, educational institutions and fruit gardens, and how their emissions are damaging seasonal crops. While the Department of Environment (DoE) claims that there are 181 brick kilns—some of them currently closed—in the nine upazilas of the district, the actual number is believed to be much higher.

Unfortunately, illegal operation of brick kilns is prevalent across many other districts in the country as well. For instance, two illegal brick kilns in Lalmonirhat, demolished by the DoE in February last year after protests from the local farmers, were found to have resumed their operations last month. The same happened in Barguna, where five demolished brick kilns began their operations again. Obviously, the Brick Making and Kiln Establishment (Control) Act, 2013 is not being enforced properly. Otherwise, so many brick kilns would not be able to operate without a licence, often flouting the rule of keeping a three–kilometre distance from residential or agricultural areas.

With Dhaka frequently being one of the cities with the worst air quality, are we pushing the rest of our country in the same direction?

Earlier this month, a team of experts presented pioneering research on the air quality of all 64 districts in the country (Brahmanbaria and Dhaka being among the 18 most polluted), citing brick kilns as a major polluter. They suggested shutting down the brick kilns as a short-term solution. But even before this study, it was a known fact how badly brick kilns were polluting our environment, with little intervention from the DoE.

We urge the government to take the threat posed by these brick kilns seriously. The DoE must recognise its crucial role in bringing down their number, and ensure that even those with a licence operate strictly within the bounds of the law. We can't continue to allow them to harm our environment, agricultural prospects and, most importantly, the health of our citizens.

# Three legacies of the Election Commission

HE 12th Election Commission (EC) of Bangladesh, headed by KM Nurul Huda, completed its tenure on February 14, 2022. With its term coming to an end, some obvious questions arise: What legacy are the commission and the chief election commissioner (CEC) leaving behind? What are the lessons learnt from the past five years of this commission's activities? Assessment of the past is not only a matter of introspection, but can also help identify what impacts the past has on the future, and how it will shape

Notwithstanding the importance of the details of how a daytime election became a nocturnal exercise, we must understand that this reflected a larger issue. Ballot stuffing as a tactic of election manipulation is not new in Bangladesh and many other parts of the world; authoritarian regimes are adept in this regard, so are the hybrid regimes, which combine authoritarian and democratic traits. Hybrid regimes are of two categories: competitive electoral authoritarianism, and hegemonic electoral authoritarianism. Both require elections of some kind, because elections are the key to their legitimation process. However, a major difference between these two categories is how the election is conducted. In competitive electoral authoritarianism. while the entire political process is highly repressive and the media are muzzled, the election does engender some form of uncertainty. Steven

and authoritarian regime survival," published in 2019, provides evidence in this regard.)

The EC of the past years has participated in the process of regime transformation from a competitive authoritarian system to a hegemonic electoral authoritarianism. Of course, the EC alone should not be credited for the transformation-instead a combination of political processes, a de facto one-party legislative body, and judiciary facilitated the process. But the EC's role was pivotal to the process. This was done through shattering public confidence in the electoral process, consequently hollowing out the electoral system altogether. The low voter turnout in subsequent elections demonstrated this phenomenon, while the EC cheerfully claimed that the elections were successful. This will remain the legacy of the Nurul Huda-led Election Commission, because it has shaped the subsequent behaviour of the incumbent



future trajectories. This has become more important in 2022, considering that the nation's politics is standing at a critical juncture. The coming days will determine the trajectory of the nation's politics—particularly its governance.

Undoubtedly, CEC Nurul Huda and his colleagues will join eight other election commissioners of the past 50 years who were derelict in their constitutional duties to ensure a free election, which would have allowed the citizens to exercise their right to vote freely and fairly. But this EC also earned an unprecedented "honour," being asked to be investigated. Fortytwo noted citizens asked the president to form a judicial council to investigate this commission's "serious financial corruption and gross election-related misconduct." Although the president didn't heed their call, this will remain a part of the history of the institution.

Under this EC, an array of local elections has taken place, but we will remember very few of them in the coming years-many will be consigned to forgotten history. Success in a few local elections does not determine the legacy of any EC. The Election Commission in Bangladesh is judged by how it has conducted the parliamentary election. What nobody will forget is the Jatiya Sangsad (national parliament) election held in December 2018. The events surrounding the 2018 election, the election itself and the role of the EC are well known. Perhaps the best description was provided by the international media, particularly *The Economist*, as it called the election a "transparently fraudulent"

One of the defining features of the 2018 election was the ballot stuffing the night before Election Day, which CEC Nurul Huda seemed to have acknowledged in 2019, saying the use of electronic voting machines (EVMs) can prevent stuffing ballot boxes. But now, years later, on his way out, he has either become a victim of selective amnesia or presumes that our collective memory is short-lived. He has questioned the veracity of it by saying he has not seen it and cannot be conclusive about it. Evidence abounds, yet that fact is not what drove the CEC in the past five

Levitsky and Lucan A Way, in a perceptive essay titled "The Rise of Competitive Authoritarianism" (2002), discussed the characteristics of these regimes and mentioned that in competitive authoritarian systems, "elections may generate considerable uncertainty." On the contrary, in hegemonic electoral authoritarianism elections, manipulation is institutionalised in a manner that competition is rendered useless and removes the uncertainty. The removal of uncertainty is achieved through various measures, including constitutional changes and electoral processes, but it requires the electoral commission to become a tool that works in unison with other state apparatuses in favour of the incumbent.

As such, it was not surprising to see what happened in Bangladesh in 2018. The election revealed how the law enforcement agencies, the ruling party and the local administration became one entity. This entire process was given legitimacy by the Election Commission—not by turning a blind eye or being a silent spectator due to a lack of power to stop it, but by being an active participant. The power vested on the commission under the existing laws was sufficient to stop this on the track, but the Nurul Huda commission deliberately decided to be a party to this endeavour.

party to this endeavour. One can argue that he was no different from his predecessor Kazi Rakibuddin Ahmed. The 2014 election conducted under the leadership of Kazi Rakibuddin Ahmed had similar characteristics. There is no denying that the 2014 election, held without the participation of the opposition and marred by large-scale irregularities, is also an example of the dereliction of constitutional duties. But the most important difference is the institutionalisation of a system of election which practically ensures a victory to the incumbent. Such institutionalisation is key to the survival of hegemonic electoral authoritarianism. (A study on elections in 262 authoritarian regimes between 1946 and 2010 by Michael Bernhard, Amanda B Edgell, and Staffan I Lindberg, titled "Institutionalising electoral uncertainty

and paved the future trajectory of the nation.

The second legacy of the EC is the introduction of EVMs in elections. This technology was touted by the EC before the parliamentary election in 2018 as a marker of progress and a tool to prevent vote-rigging. It was pushed back by various political parties in 2018, but gradually it has been introduced. The EVM technology has been a matter of concern in many countries, and many have abandoned the technology (Ali Riaz, "A Pointless Debate," The Daily Star, September 2, 2018). Additionally, the technology adopted by the EC does not have the Voter-Verifiable Paper Audit Trail (VVPAT) system. As these machines are likely to continue to be used in future elections, the suspicions and controversy will only become louder. There are allegations that these machines are manipulable, and an absence of a paper trail means there is no way to challenge the accuracy of counting. Programming of the EVMs can be manipulated to skew the results in favour of a candidate.

The third legacy of the EC can also be described as an unintended consequence. The behaviour of the Nurul Huda commission has proven that an election commission appointed by a partisan government cannot hold a free and fair election under the same regime. It was proven in the 2014 election, but now it has become the incontrovertible truth. Those who expected after the 2014 election that a change in personnel in the EC would chart a different course acknowledge this—at times begrudgingly. The CEC and his colleagues evidently didn't want to send the message, but their actions have made the message loud and clear. It is neither the laws that guide the EC, nor who is at the helm, but the nature of the government at the time of election that decides whether the EC will be an effective institution or not. As the new EC appointment is now in process, this lesson is well to bear in mind. The incumbent government seems to have learnt the lesson well and is acting accordingly. The question is whether the opposition parties have also learnt it. If so, what will they do?

# Young, dumb, and broke

N the Bollywood film 3 Idiots, one of the characters, Chatur aka Silencer, mocks what he presumes to be the protagonist's profession thus (in loose translation)—"Namaste Masterji. What heights you've reached! You've become a schoolteacher in the village! A for apple, B

Now, despite how on the nose the film can be, I've always felt that it more or less makes up for it with its sense of humour and heart. However, in this climactic scene, where Chatur, an annoying but amusing pseudo-antagonist, is about to get his comeuppance, the film is unable to hold on to what it has tried to teach us for the last two-and-a-half hours, with the protagonist repeating several times throughout, "Don't run after success. Run after excellence. Success will follow suit."

The problem is that the comeuppance is only successful because the protagonist is not just a schoolteacher; he is primarily one of the world's leading inventors and scientists whom, as Silencer states, even "the Japanese are desperate to work with." After all, how else could his success be validated, if not through the eyes of the developed world, without whose seal of approval a person's worth would find no legitimacy?

The film is not at fault for falling into its own trap. Like many of us, its ideals and values are in the right place: it wishes to show us that there is great pleasure in the very act of learning, and inspires us to question authority, to value those who differ from us, to pursue our passions. But, in the process, like us, it too cannot shed how it defines success: through validation from foreigners, through corporations which wish nothing more than to sell our ideas to the highest bidder, through humiliating the villain by beating him at his own game.

After all, what value can a mere schoolteacher hope to retain, teaching the alphabet in some remote corner of Ladakh? What validation will he or she receive from only the approving admiration of children—young, dumb, and broke as they are? What contribution to



society is brought from providing guidance to the so-called future of a nation as their eves burn with hunger to experience new things, as their minds expand to learn not only "A for apple, B for ball," but also discipline and manners, morality and truth, the ability to think and question and respond, to empathise with their fellow human beings?

We condescend to schoolteachers for teaching our children the alphabet without understanding that every single word, every sentence, every paragraph and essay that our children will one day go on to write will be derived from the combination of these mere letters. We give them the responsibility of teaching our children everything they need in order to become responsible members of society, upstanding citizens of the country, contributing cogs in the machine of our economy. And then we pay them neither with the respect nor the finances worthy of perhaps playing the most important role in our children's lives.

What ambitious and principled individual would dream of becoming a schoolteacher, then? There is no doubt that we revere our teachers and honour them for having been some of our biggest influences. And, sometimes, we come across young individuals who genuinely do wish to become schoolteachers, finding great pleasure and satisfaction in guiding children through what is indubitably their most formative years. But that is its nobility: to perhaps have the most important job in the world, but not to be

rewarded with gold or recognition, but in finding oneself in the memory of adults scattered across the country and the world.

Such unsung heroes are rare, thoughnot because of some moral bankruptcy in the new generation, but for the generations preceding who have failed to recognise the invaluable, uncountable contributions our schools make in the lives of children. This is evident in how, for example, during the earlier years of my schooling, up until about Grade 5, "teachers" were always women (and I think they still are).

Afterwards, when we had somewhat matured, deemed worthy of wielding pens which left permanent stains on our notebooks, could the men, the "sirs," be bothered to interact with us.

(Experiences and mileage may vary). It truly boggles the mind that, year on vear, we create a budget that promises prosperity, but ignores the very ground on which prosperity is built, ignoring the very "A for apple, B for ball" Silencer was so eager to dismiss, ignoring perhaps the most overused axiom of our childhoods-"Education is the backbone of a nation"—spending much, much lower than the rest of our neighbours. It not only highlights our shallow definitions of success-big flats and even bigger flyovers-but also how our children have become the most marginalised members of our society, collateral damage on our journey towards prosperity, only for us to turn back and ask them to fulfil their

If I may paraphrase a few words from a Kenyan proverb: The Earth has not been given to us by our children. It has been loaned to us by our children.

But not to worry: we have more or less ensured that most of our childrenyoung, dumb and broke as they are—will grow up to be adults who will lack the capacity to understand that, along with their potential, the Earth has also been destroyed, that too by those who were tasked to protect them.

# Locally led adaptation: We can lead the world

→ HE Global Center on Adaptation (GCA) was set up with its headquarters in the Netherlands a couple of years ago, and has already developed into a major platform focusing on supporting countries to adapt to the adverse impacts of climate change. It has already set up regional centres in China and Africa, and is about to launch the regional centre for South Asia in Dhaka, Bangladesh, in conjunction with the government.

I have the privilege of being a senior adviser to the GCA, and am pleased that they have decided that their Dhaka office will become their global hub on Locally Led Adaptation (LLA) to climate change, in recognition of Bangladesh's long experience in promoting LLA by both the government and the NGOs.

Let's look at how Bangladesh, in a whole-of-society manner, can truly become a global leader on LLA, and share that knowledge with other developing countries—especially the ones most vulnerable to the climate impacts.

The first lesson that Bangladesh can share with others is how to develop a national adaptation plan with a whole-ofsociety approach, which is essential for any plan to be effectively implemented. Bangladesh has a long history of planning for adaptation to climate change and incorporating those plans into national development programmes. The latest versions of this will be the Bangladesh National Adaptation Plan (NAP) and the Mujib Climate Prosperity Plan (MCPP), both of which will emphasise investment in LLA as a way to achieve transformational adaptation over the next decade.

The second major lesson is making topdown national plans while also investing in enabling bottom-up inputs from the vulnerable communities so that the plans are implemented without failure. So, there needs to be a paradigm shift: instead of looking at the vulnerable communities as mere targets or beneficiaries of support from the top, we need to take them as the agents of change themselves who know

best what needs to be done, and those who wish to support them must listen to them first. These ideas have been included in the eight principles of LLA, which has now been adopted by many governments, donor agencies and others. Now, these principles need to be put into practice. A major element here is capacity-building of young girls and boys, and putting women at the centre of LLA.

The third lesson is including knowledge partners in the exercise and planning for the long term—not just for shortterm projects—to make LLA effective. This is essential because climate change is a science-based issue, in which the adaptation practitioners need to be continually provided with scientific information on the climate risks in each geographic location they work at, and at the same time, the experiential learning of the practitioners themselves must be recorded as they implement adaptation plans. Thus, the knowledge of climate impacts is an essential input to any adaptation plan, and the knowledge of adaptation will be its output. Hence engaging a knowledge partner such as a university or a research institute is essential, rather than simply hiring consultants who will leave once a project

The final lesson is to design adaptation investment plans for long-term implementation, rather than focusing on short-term projects only. This requires a longer-term programmatic approach from the financiers. However, even if funding is provided to projects with limited duration, emphasis must be placed on what the projects will leave behind once they are over, rather than on what is done during project implementation. Thus, investment in adaptation to climate change should be seen as investment in long-term capacitybuilding.

If all the sectors in Bangladesh can join forces to make our own country more resilient and prosperous in spite of climate change, we can also share that knowledge with other countries through peer-topeer exchange visits, as well as the annual Gobeshona Global Conference on Locally Led Adaptation and Resilience, organised by the International Centre for Climate Change and Development (ICCCAD). Bangladesh can indeed become the world leader in LLA if everyone concerned work together, effectively and with a whole-ofsociety approach.



Pedestrians in the port city cannot walk on footpaths for more than 200 yards at a stretch uninterruptedly. The reason: illegal occupation by vendors, hawkers and shopkeepers.

This correspondent recently visited some of the main roads of the port city. In Nawab Sirajuddaula Road, steel almirah makers were seen spraying colours on their products on the footpath beside the Chawkbazar Post Office. Pedestrians were seen walking on the road avoiding the footpath.

Salma Akter, a resident of Chattogram College East Gate area, was seen crossing the road to avoid the spray paint.

"All the shops keep their materials on the footpath for which pedestrians have to walk in the middle of the road," she told this correspondent.

Mithu Rudra, a school teacher, said the illegal occupations have been going on for years but nobody did anything about it.
This correspondent found illegal

occupations



at least six points of this road, including Dewan Bazar Didar Market area, Jainab Colony and Room Ghata areas.

In Didar Market area, furniture shops were seen to occupy the footpath, while in Jainab Colony, Room Ghata and Sub, groceries, bakery shops and street vendors



took over those.

Flower shops had been occupying footpaths in Cheragi Pahar Intersection for years in Momin road. Upon complaints from locals, Shaibal Das Suman, Chattogram City Corporation (CCC) ward councillor of Ward 21, discussed the issue with representatives of flower traders' recently and convinced them to yacate the footpaths.

"I met with flower traders and requested them to shift the vases from the footpath to inside, and they agreed," said Suman.

Appreciating the councillor's initiative, Pampi Barua, a resident of Jamal Khan area, said, "Had the other councillors taken such initiatives to free footpaths in their respective areas, the sufferings of the residents would have stopped."

In Telipotti Road, footpaths were seen to be occupied by sanitary items shops in Chawkbazar, while in Fazlul Quader Road, they were taken over by medicine shops and street vendors in Chattogram Medical College Hospital area.

A restaurant is currently in operation

occupying a large portion of the footpath in front of Chevron Clinical Laboratory in Praborttak area.

"It's getting increasingly difficult to walk on the streets. The city corporation and traffic department should take steps to free the footpaths from illegal occupation," said Sajjad Hossain, a student of Chittagong University.

Contacted, Saleh Mohammed Tanvir, CMP commissioner, said CMP's traffic department conducted regular drives to free the roads from hawkers and vendors. He, however, said to conduct drives on footpaths and impose fines, police need a magistrate's authorisation.

The commissioner also mentioned that despite multiple drives by police, vendors and shop owners were still operating on the same spots from where they were evicted.

Contacted, CCC mayor Rezaul Karim Chowdhury said he would take steps to free footpaths from illegal occupation.

"We will be stricter regarding the issue," he assured

# Tale of port city's own racer

At only 18, Aiman Sadat journeyed all the way from Chattogram to Dubai, to participate in the NGK UAE Pro-Cup Championship held in Dubai Autodrome, a fully integrated and FIA sanctioned sports venue in United Arab Emirates.

In what was the first time participating in this championship, Aiman managed to place second in two categories of the competition.

In the Dubai Race, he drove a Gen-3 car when all other participants were driving much more advanced Gen-5 cars, which makes his success all the more deserving.

But this was not his first time he won an international trophy. His first taste of success came when he competed in the Volkswagen Ameo Cup, held in Chennai, and became the youngest champion in its history.

Outpacing many skilled drivers, he won the trophy on his first go, following the footsteps of his elder brother Affan, who stood runner-up at the Volkswagen Junior Ameo cup before.

But even this was made difficult as Covid-19 set in worldwide. Unable to attend or apply for any race, Aiman was kept in touch by his brother Affan, who gave him theoretical training about cars, race tracks, safety measures, racing protocols and strength training.

No racer is certain where they will be in five or 10 years, but Aiman told The Daily Star that he wants to keep getting better. He wants to keep his passion high and continue serving his country by bringing in international recognition through his success in the sport.



# An international bamboo garden!

#### BFRI centre hosts, preserves 36 species from home and abroad

Almost 10 lakh tonnes of green bamboo are used for different purposes across the country.

It's about 10 feet tall in height. At first sight, it may look like a wooden pitcher, but it's actually bamboo that came to Bangladesh's soil from Vietnam. This particular species of bamboo is called "Ghoti".

Like Ghoti, around 36 species of bamboo from home and abroad are being cultivated at the bamboo garden of Bangladesh Forest Research Institute (BFRI) in Sholashahar of the port city. Among them, 24 species are native while 12 were imported from China

and Southeast Asian countries, said

The bamboo garden was built on a five-acre land in 1973. Apart from conserving bamboo species, the park also functions as a bamboo plant management, seedling production, seed conservation and training centre.

During a recent visit to the BFRI garden, this correspondent noticed a signboard that contains the names of all 36 species of bamboos in the



museum, complete with their scientific names and origins. There are also nameplates in front

of every species.

In the garden, some bamboos are thick, while others are twisted. All of them are distinct from each other in terms of their size and shape. There are "Kata", "Ora", small-sized "Mitinga", and "Mithia" bamboos -- 12-14 feet in

According to the global bamboo resource report published by the Food and

Agricultural Organization (FAO), Bangladesh stands eighth in the world in terms of bamboo varieties. Almost 10 lakh tonnes of green bamboo are used for different purposes across the country.

Recently, four new bamboo species were added to the collection, said Dr Md Mahbubur Rahman, lead researcher of the silviculture department at BFRI.

He said bamboo gene varieties are preserved at the institute as bamboo seedlings are

not readily available. A seedling is produced through cuttings of bamboo stalks and tissue culture, he said.

"At least 10,000 saplings are uprooted from this garden every year. The saplings are being used for creating gardens and forests in different parts of Bangladesh," he added.

Dr MA Gafur, former professor of the department of botany at Chittagong University, said the genetic diversity of indigenous varieties of bamboo is being preserved here. Of them, Bhudum, Muli and Baijjar have a lot of economic importance. The genetic diversity of these species are important not only for Bangladesh, but the world as well, he added.



# 'Waiting on the sidelines was a blessing in disguise'

Following a promising Test debut last year, batter Yasir Ali Chowdhury struck his maiden fifty in New Zealand earlier this year and was rewarded with the inclusion in the Tigers ODI side for the upcoming three-match series against Afghanistan. The cricketer from Chattogram, who has been a consistent performer in the domestic circuit and is expecting to make his fifty-over debut, spoke to The Daily Star's Mazhar Uddin about his batting among other aspects during an interview. The excerpts of the interview are below:

**The Daily Star (DS):** Despite being part of the national team set-up for over two years, you finally made your Test debut against Pakistan last year Now after getting into the ODI team for the upcoming Afghanistan series, how confident are you about making your ODI debut, which arrived earlier this time?

**Yasir Ali (YA):** To be honest, waiting on the sidelines for over two years to make my international debut was a blessing in disguise. Traveling with the team and taking catches while fielding as a substitute, actually gave me a good idea of the flavour of international cricket and helped me to adjust quickly. I have seen this before and went through tough phases. Tamim Iqbal bhai used to give me advice and later I became mentally strong. So, whether I'm able to make my ODI debut or

not, I will continue to improve and perform formats for Bangladesh? as a player and look forward to it.

**DS**: What will your challenges as a batter be when it comes to adapting from Test cricket to fifty-over format?

YA: I feel it's more challenging for a batter to adapt from



T20 format instead. T20 cricket, you hardly get enough time and have to go for shots right from the start of innings. On the other hand, shifting to the fifty-over format will be important for me being a batsman in the middle-order, where you have to build an innings.So I'm working on that aspect and confident about it if I get a chance in the playing eleven.

DS: You were in good touch during the Bangladesh Premier League (BPL) and also displayed a sound technique. Do you believe you can play across all three

YA: I really back my technique and believe I can represent Bangladesh in all three formats. Cricket is no longer a recreation or entertainment as it became a passion for me. In modern-day cricket, you have to adjust and adapt as a batsman and it's important to know how to shift the tempo of an innings.

**DS**: The maiden fifty in Christchurch against New Zealand in the second Test must have boosted your confidence.

YA: Definitely! It gave me a lot of confidence. Playing in New Zealand in such conditions, against some top-quality bowlers, was a great experience for me. I was playing just my third Test and it really gave me the confidence so early in my career. I think my experience from Test cricket will help me in the fifty-over format.

DS: Can you recall being concussed after receiving a blow on the head from Shaheen Afridi on your debut Test against

YA: Obviously, it came as a shock as I really wanted to bat. It was disappointing for me but at the same time, I'm also lucky because it could've been nasty too. I was batting well and was looking set with Liton Das at the other end. We really wanted to build up a partnership as it was vital for us. But whatever happens it happens for good.

#### NZ aim to break S Africa drought

New Zealand enter unfamiliar territory when the first Test against South Africa begins in Christchurch on Thursday, without batting greats Ross Taylor and Kane Williamson.

It has been 14 years since the hosts started a Test without either Taylor or Williamson -- their top two all-time Test run scorers respectively and they have the extra burden of trying to win a series against South Africa for the first time.

Taylor retired last month and Williamson is injured, leaving the Black Caps without

the pair's steadying influence against a dynamic Proteas pace attack.

South Africa arrived on a high after completing a double of Test and one-day series wins at home against India.

The

inaugural World Test champions begin the series as favourites, lying second in the ICC Test rankings, with South Africa fifth.

But they have never won a Test series against South Africa and have recorded only one home victory over the Proteas in 20 attempts.

#### 'IPL auction no distraction from Windies series'

This week's multi-million-dollar Indian Premier League auction will not distract India's players from the T20 internationals against the West Indies, captain Rohit Sharma said Tuesday. Sharma said he had asked the players

to focus on the three-match series beginning at Eden Gardens in Kolkata on Wednesday.

They will have gone through 'ups and downs" at the auction, he told a virtual press conference ahead of the T20 series.

"It is an emotional feeling which team you are going to play for and all," he said.

Yesterday I had a great meeting with the boys, I asked them to focus on the colour blue, which is most important,"

he added, referring to India's one-day uniform. "All these guys are professionals, once they are in India colours nothing else matters."

The IPL -- the world's most lucrative cricket tournament -- should not overshadow international commitments, the 34-year-old said, adding they play in the competition for just two months in a year, compared to 10 months for

"So I just want to focus on what we do for Team India and that's what matters."

The second T20 will be played on Friday followed by the third and final game on Sunday.

#### Freedom of choice over **Grand Slam for Djokovic**

Novak Djokovic is prepared to miss the French Open and Wimbledon if COVID-19 vaccination becomes mandatory at the Grand Slams but he is not against inoculation, the world number one tennis player said.

Djokovic, who is unvaccinated, was barred from competing in this year's Australian Open, depriving the 34-yearold Serbian of the chance to become the most successful men's player of all time with 21 Grand Slam titles.

"I understand the consequences of my decision," Djokovic told the BBC, adding that he was prepared not to travel to Australia due to his unvaccinated status.

"I understand that not being vaccinated today, I am unable to travel to most of the tournaments at the moment. Yes, that is the price that I'm willing to pay.'

A steely-eyed Djokovic said he hoped to compete for "many more years" but added that the freedom to choose what he wants to put into his body was more important to him than any title.

The Serbian, however, distanced himself from the anti-vaccination movement and said he was keeping an open mind about taking the jab. "I was never against vaccination," he

said, adding that he took vaccines as a child. "But I've always supported the freedom to choose what you put

in your body. "I understand that globally, everyone is trying to put a big effort into handling this virus and seeing, hopefully, an end soon to this

Djokovic is set to

# Political parties have time till Feb 24

Political parties that have yet to make their recommendations for forming the new election commission can still send the names of their nominees to the search committee by February 24.

The committee is likely to send a list of 10 names to President Abdul Hamid on February 24. The president will choose the new chief election commissioner and four election commissioners from the list.

The committee held meetings with senior journalists yesterday at the Supreme Court Judges Lounge and heard their opinions regarding the formation of the next EC.

The journalists suggested that the names on the final list be made public if the individuals named on the list

gree. They also suggested that competent, courageous and honest individuals, including women and those from the minority communities be in the Election Commission.

"I said publishing the 322 names was not a right decision as many [of the individuals] were unaware," Manjurul Ahsan Bulbul, former president of Bangladesh Federal Union of Journalists (BFUJ), told reporters after the meeting.

The time for political parties to send their recommendations has been extended and the search committee will consider if any political parties propose names, he said.

Bangladesh Pratidin Editor Naeem Nizam said before disclosing the final nominations, consent of the nominees must be taken.

# Ukraine crisis shows sign of de-escalation

Russia pulls back some troops; West seeks proof; Dhaka asks Bangladeshis to consider leaving

Russia said yesterday some of its military units were returning to their bases after exercises near Ukraine and mocked repeated Western warnings about a looming invasion, but Nato said it had yet to see any sign of deescalation on the ground.

Russia did not say how many units were being withdrawn, and how far, after a build-up of some 130,000 Russian troops to the north, east and south of Ukraine that has triggered one of the worst crises in relations with the West since the Cold War.

"We've always said the troops will return to their bases after the exercises are over. This is the case this time as well," Kremlin spokesperson Dmitry Peskov said.

Nato's chief welcomed signals from Russia in the past two days that it may be looking for a diplomatic solution but urged Moscow to demonstrate its will to act. "There are signs from Moscow that diplomacy should continue...But so far we have not seen any sign of

de-escalation on the ground from the Russian side," Nato Secretary-General Jens Stoltenberg told reporters.

Ukraine's Foreign Minister Dmytro Kuleba said Kyiv would only believe that Russia was moving to de-escalate the situation if it saw for itself that Russian troops were being pulled back, reports Reuters. Britain, which with the US

has led the warnings of imminent action, reacted cautiously. "The Russians have claimed that they

have no plans for an invasion, but we will need to see a full scale removal of troops to show that is true," Foreign Secretary Liz Truss told LBC radio.

Meanwhile, Bangladesh Embassy in Poland has said Bangladeshi nationals in Ukraine may consider leaving the country temporarily in view of the current SEE PAGE 6 COL 5
