SIGNBOARDS IN BANGLA HC order widely ignored

It's a lack of inner urge, says Prof Serajul Islam Choudhury

Buildings on either side of Satmasjid Road between Jigatala and Shankar in the capital's Dhanmondi are teeming with signs and hoardings of different sizes and colours, mostly in English.

A few of the signs, however, are emblazoned with businesses' names written in both Bangla and English, but the Bangla letters are so small that it is quite difficult to read those.

Visiting the area on Friday, this newspaper found at least 20 signs of businesses, mostly eateries, in just one building, are all written in English.

English signs, displays, and brand logos is a very common sight in many other parts of the capital, including Baridhara, Gulshan, Banani, Paltan, Science Laboratory and Arambagh.

This situation has been prevailing even 70 years after the historic Language Movement. A law -- Bangla Bhasha Procholon Ain -- was enacted in 1987 for ensuring compulsory use of Bangla in all spheres of life.

Also, the High Court in February 2014 directed the government to ensure use of Bangla in signs, billboards, and banners.

But the authorities are yet to make any significant progress in this regard.

Senior secretary pulled strings

Sharif Uddin says about his firing

Sacked ACC officer Sharif Uddin said the senior secretary of a ministry. who had links to the land acquisition scammers in Cox's Bazar, used his influence to get him fired from his job.

The sacked deputy assistant director of Anti-Corruption Commission told The Daily Star yesterday that he found in his investigation that Cox's Bazar Municipality Mayor Mujibur Rahman played a key role in a syndicate that stole Tk 78 crore from government projects through forgery.

Involvement of top administration and police officials in the district was found in the investigation.

The senior secretary was linked to the aforesaid individuals, Sharif said, adding that the bureaucrat made sure that officials working at the ACC on deputation slowed down his investigation.

Sharif said the senior secretary who is from a southern district

Both Sumon Mia and his wife Modina Begum were at work when a fire ravaged their home in Seedstore area of Mymensingh's Bhaluka upazila on Sunday night, killing all their three children on the spot.

The fire originated from a gas cylinder explosion in the kitchen of one of their neighbours around 9:15pm. It spread to five adjacent tin-roofed houses, including that of Sumon, said Al Mamun, senior station officer of Fire Service and Civil Defence in Bhaluka.

11 ZEBRAS' DEATHS High nitrate levels in grass linked: probe STAR REPORT

High levels of nitrate in the grass fed to zebras at the Bangabandhu Sheikh Mujib Safari Park in Gazipur was linked to the deaths of 11 of the animals last month.

A member of the probe committee investigating the deaths revealed this information yesterday after the probe report was submitted on Sunday. The environment, forest and climate change ministry on January 26 formed the probe committee, led by Sanjay Kumar Bhowmik, additional secretary of the ministry.

Dr Noor Ali, the committee member and a professor of the pathology department of the veterinary science faculty at Bangladesh Agricultural University (BAU), said the samples of the zebras were tested at the university's pathology and pharmacology departments.

Noor Ali, also the director of BAU Research System, said the park authorities had asked the contractor to supply "tender" grass instead of "mature" grass for zebras since December 18 last vear.

The presence of trace amounts of nitrate was higher than the normal limit in the tender grass, resulting in nitrate poisoning of the zebras, he said quoting the probe report.

In many cases, the cultivators of the grass use excess doses of urea for rapid growth and in those cases, they have to wait for a few days so that the concentration of nitrate naturally decreases, he said. Since the park authorities wanted tender grass for the zebras, they possibly did not wait long enough, he added.

Another member of the committee said nitrate was not the single cause of the deaths; the concentration of nitrate weakened the immune systems of the

UKRAINE PEACE SUMMIT PLAN Russia pours cold water

Says it's 'premature' to organise Biden-Putin meeting; UK claims Russia's plan to invade has 'already begun'

The Kremlin warned yesterday there are no concrete plans for a summit between the Russian and US leaders, as diplomats scrambled to head off the threat of a Russian invasion of Ukraine.

The idea of a meeting between presidents Vladimir Putin and Joe Biden has been championed by France and cautiously welcomed by Ukraine as a way to avert a catastrophic war in Europe.

But Putin's spokesman Dmitry Peskov said: "It's premature to talk about any specific plans for organising any kind of summits" adding that no "concrete plans" had been put in place.

France's President Emmanuel Macron called Putin on Sunday and afterwards his office said that both the Russian and Biden were open to the idea.

The summit would go ahead, however, only "on the condition that Russia does not invade Ukraine."

'There is a diplomatic hope," France's minister for European Affairs Clement Beaune told LCI television.

"If there is still a chance to avoid war, to id a confrontation and build a political

take it," he said.

But in Washington, a senior US administration official told AFP: "Timing to be determined. Format to be determined. So it's all completely notional."

Visiting Brussels, Ukraine's foreign minister welcomed the French effort. "We believe that every effort aimed a diplomatic solution is worth trying," Dmytro Kuleba said.

Kuleba also said the European Union had agreed "in principle" to set up an advisory military instructor mission in Ukraine, but the details have yet to be thrashed out.

Defence Minister Oleksiy Reznikov said there was no sign of Russian forces withdrawing from the border, and that Moscow-backed rebels continue to shell Ukrainian positions.

"Since the beginning of this day, as of 09:00, 14 attacks have already been recorded, 13 of them from weapons prohibited by the Minsk agreements," he told reporters in Kyiv.

Ukraine vesterday firmly denied Russian claims that Russian forces had killed five Ukrainian "saboteurs" who allegedly

necessary to consider an appeal from the leaders of two breakaway regions in eastern Ukraine for Russia to recognise them as independent.

Putin also said in televised remarks yesterday that the threat to Russia would substantially increase if Ukraine were to join Nato.

In recent weeks, according to US intelligence, Moscow has massed more than 150,000 troops and sailors around Ukraine's borders in Belarus, Russia, Crimea and the Black Sea, reports Reuters.

A spokesman for UK Prime Minister Boris Johnson told a media briefing yesterday that intelligence reports suggest Putin intends to launch an invasion of Ukraine, reports BBC.

"The intelligence we are seeing suggests that Russia intends to launch an invasion and that President Putin's plan has already begun," the spokesman said.

US National Security Advisor Jake Sullivan said vesterday intelligence suggests any Russian invasion of Ukraine would employ a particularly brutal strategy to "crush" the civilian population.

A man's death sparked protests in Shantiganj, Sunamganj, amid allegations that he was tortured in custody at a police station.

Wazir Mia, 40, of Shatrumardan area, died at Sylhet MAG Osmani Medical College Hospital yesterday, 10 days after he was released on bail. Grieving family members said he died because

police tortured him at Shantiganj Police Station after arresting him in the early hours of February

Villagers later blocked Sunamganj-Sylhet road at Pagla Bazar for three hours, demanding justice for Wazir.

Police said Wazir was arrested on charges of stealing cows.

His brother Dalim Mia said, "He was severely tortured. He was released on bail the next day, but fell ill. We took him to the hospital in critical condition."

Superintendent of Police in Sunamganj Mizanur Rahman said there will be an autopsy and actions will be taken if evidence of torture is found.

College student dies in garage collapse

Simplify scientific terms in Bangla Urges PM for students' benefit

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday called for simplifying the use of scientific terminology in Bangla to attract more students to study science.

"I think that no nation can step forward without flourishing science-based education," she said while inaugurating a four-day programme of the International Mother Language Institute at Shegunbagicha to mark Amar Ekushey and International Mother Language Day.

'We have to pursue technological education. We can't advance without it," she said. "Research in every sector, like health, education, science and even in industry, is of utmost importance," she said.

Regarding the uses of scientific terminology, she said use of a tough terminology in Bangla might not be understandable for all.

"Widely used words and internationally accepted words can be used as it is, we have to accept the word that is used widely in the international arena," she said.

In this connection, she said using tough terminology could bring forth a non-understandable situation and that should be avoided. "I do not believe in using terminology or translation everywhere," she said.

Name-only job agency busted

Law enforcers claimed to have arrested seven persons for running a racket that duped people by promising jobs. In only the last six months, they defrauded more than 700 job seekers.

A team of Rab-1 carried out a raid at their office, Sinthiya Security Service Limited, in Dhaka's Uttarkhan on Sunday and made the arrests, Abdullah Al Momen, commanding officer of Rab-1, told a press conference yesterday.

The arrestees are managing director Shamsunnahar Maya, general manager Jewel Mia, deputy general manger Kamruzzaman, Farhana Yeasmin, Mehedi Hasan, Al Mamun and Tajbir Hasan.

They used to lure job seekers by publishing advertisement for body guards, house managers, caretakers, security supervisors and guards, taking Tk 12,500 from each applicant as security deposit and other costs.

The Rab official said the gang used to promise jobs with monthly salaries of Tk 10,000-15,000. However, they'd later refuse to get them jobs or pay the money back.

Officials of Anti-Corruption Commission are having a hard time keeping their faith in the high-ups, and job uncertainty has gripped them, following the instant termination of one of their colleagues.

Out of fear, ACC officials have united, and for the first time in history, have formed ACC Service Association to press home their demands for welfare.

After former ACC deputy assistant director Sharif Uddin, who came into the limelight for unearthing massive corruption in Cox's Bazar, was terminated without any explanation under section 54(2) of the corresponding service rule, their fear has intensified.

Section 54(2) of Anti-Corruption Commission (Service) Rule, 2008 empowers ACC to terminate an official without showing any explanation.

The incumbent commission took charge in March last year. In the last 11 months, over 100 officials were show-caused, and departmental procedures (DP) were initiated against around 30.

"We don't have any representation in the top tiers. Of the top 12 posts, 10 are filled by former and current bureaucrats. They don't look after us," said an ACC official, preferring anonymity.

"We can't trust them. That's why we've united to raise our demands," he said, adding that the full-fledged committee of the association will be declared within a day or two.

According to ACC's organogram, there is a three-member commission comprising the ACC chairman. The ACC secretary works under the commission, and there are eight director generals under the secretary.

On February 20, ACC officials gave a letter to the chairman through the secretary.

"Recently, we're seeing a tendency of magnifying our small mistakes and seeking explanations on each incident," reads the letter. "DPs are being initiated, saying that our explanations are unsatisfactory, which is abnormal.'

So far, five commissions have completed their tenure, and this is the sixth commission. "The SEE PAGE 4 COL 4

However, all this didn't exactly translate into great sales for the publishers. Monirul Haque, proprietor of Ananya, said, "But this is not a problem. February 21 is more about carrying on the spirit of Ekushey."

Pushing through the crowd, Soumik Biswas and Afroza Nazneen from Indira Road could be seen with their sons Pratya and Priyam. Pratya said he bought Humayun Ahmed's "Best of Misir Ali", Imdadul Haque Milon's "Best Ten Novels" and Zaheer Raihan's novel "Arek Falgun", while little Priyam bought a book on birds.

He, however, said he was more happy with the tattoo he got as a gift for buying the book.

A total of 224 new books were published yesterday.

current one is putting irrational pressure on ACC officials," it added. "We're being asked to submit three reports each month. The frequent issuance of showcause and DP is damaging the work environment."

"An investigation officer is burdened with 40/50 inquiries and investigations. On top of that, the irrational pressure of submitting three reports each month is affecting us both mentally and physically," the letter reads.

Preferring anonymity, an ACC official said, "They [ACC officials] face the wrath when an investigation report goes against the will of a DG or high-up. Sometimes, we're asked not to press charges on a particular person."

Pointing out little progress in the BASIC Bank scam, he said, "In many cases, we're asked by high-ups to go slow or change our case priority. Later on, when we give our explanation regarding the cases, they are not accepted, and we're show-

caused." In the letter, the association requested ACC chairman to withdraw the revision appeal on the removal of section 54(2). At a press conference





The bloodstains on the streets were still fresh. All of East Pakistan was boiling over the massacre of February 21. In a spontaneous move, students of Dhaka Medical College Hospital (DMCH) built the city's first Shaheed Minar to immortalise the martyrs.

The monument was demolished by police after just three days. But what they could not erase was its place in history. Unfortunately, today, a dispensary of

DMCH stands at the same place, with no signs or memorials to remind us of its significance.

It can be known from history that the minar was completed on February 23, 1952, a result of a night's labour of the students. It was known as the Shaheed

Why English?

Official letters sent to tea workers in language they can't even understand

For a group of people whose most members haven't even gone to school, many tea workers of the country are forced to maintain official communication with their employers in English.

As bizarre as it may sound, this is happening in most of the tea gardens, for decades. Understandably, this language barrier has become a major issue for the workers.

Currently, over 1.40 lakh workers are employed across 166 tea gardens in the country. Most of them are in Moulvibazar, Habiganj and Sylhet, according to the statistical handbook on Bangladesh Tea Industry 2019.

Most of these gardens were established way back during the colonial period. As the then employers were British, they used to communicate in English. But even after 75 years of their exit and 50 years of Bangladesh's independence, the practice is still here, said workers and researchers. Whenever tea garden authorities issue any official letter, order or directive to workers,

they are written in English. But as almost all workers are unfamiliar with the language, the documents end up In case a

In case a response is needed, the workers take the documents to someone who knows English and have them read it for them and write its response.

to someone who knows English and have them read it for them and write its response. "This leads to a loss in privacy. When someone gets an official letter stating something personal, like termination or wage negotiations, the information ends up spreading to everyone," said Nipen Paul, acting GS of Cha Sramik Union.

If the letters are issued in Bangla, at least some of the workers' family members would be able to read and explain it to them. Asked, Golam Mohammad Shibly, chairman of the Sylhet chapter of Bangladesh Cha Sangsad, a platform of tea garden owners, said, "We have already asked all garden authorities to issue letters in Bangla."

Researcher Philip Gain raised questions about the very legality of such letters in English, citing that the original Labour Act-2006 is in Bangla. Mahbubul Hasan, DIG of department of

inspection for factories, said none has so far filed any complaints in this regard. "If anyone does, we will take necessary measures."



From prisoner of war to **CULTURAL ICON**

Ekushey Padak awardee Iqbal Ahmed relives his wartime story

In 1970, a young Rabindra Sangeet the cantonment. singer caused a sensation, when his rendition of "Jani Jani Go" made its way to number one rank on the country's best-selling chart. This feat shattered the general assumption that Rabindra Sangeet was not "commercially viable". Only a year later, he was imprisoned and tortured by the Pakistani Army, formally accused of "inciting the people with nationalistic and revolutionary songs". Iqbal Ahmed's legacy, however, started in the late 1960s, when he led spirited groups of activists in favour

of our Independence movement- not with weapons, but with the power of Gono Sangeet (patriotic songs for the masses) and Rabindra Sangeet. A student of the Department of Economics at Dhaka University, the cultural secretary of DUCSU (Dhaka University Central Students' Union), and a leading member of Sangskritik Sansad, a progressive cultural body of DU, Iqbal Ahmed would play a role in the mass uprising of 1969 with his deep, roaring voice.

His fearless presence in the cultural arena, which extended to just days before West Pakistan launched a genocide upon us, had brought him in their crosshairs. In fact, he had delivered memorable Gono Sangeet performances on television only two days prior to the military operation. He also created an impact in the programme titled 'Nobin er Aloke", where his powerful speech about oppression and economic deprivation of Bengalis, inspired many watching the programme. 'At three in the morning sometime in May, they (the Pakistani army) knocked on our door, asking for me and my brothers,' said Iqbal Ahmed, speaking with The Daily Star at their family residence in Gulshan, remembering the day on which he was

"Who is Wahidul Haque?" demanded an officer from the Field Interrogation Unit (FIU), when Iqbal was brought in for questioning. "Did you go to India with him?"

Iqbal, also a student of Chhayanaut's third batch, and later an instructor there, was mentored by the likes of Sanjida Khatun, Wahidul Haque, Zahidur Rahim, Sheikh Lutfor Rahman, Altaf Mahmud, and Kalim Sharafi. He, alongside his troupe of singers, was the central figure of the cultural activities of the Sarbadaliya Chhatra Sangram Parishad (All Party Student Action Committee) and its programmes, delivering patriotic slogans and singing their hearts out at jampacked venues like the Paltan maydan and the Shahid Minar.

Alongside other cultural activists and students, they would go around the city in places like New Market, Azimpur, Gopibag, Farmgate, Sadarghat etc, in open defiance of the administration.

As they interrogated me, I understood that they had been monitoring me, as Wahid bhai did ask me to go to India to lead a Gono Sangeet group there," asserted the singer.

The brutal atrocities and tortures committed in the camp, over 7 months in 1971, left him traumatised.

"Where do I even start? The day I was transferred to the 'prisoner of war' camp, they had asked us (the prisoners) to do a 'frogjump' across the field. I was obviously not accustomed to this. I faltered after two steps. As a soldier started thrashing me with the butt of his rifle, I somehow crawled through," said Igbal. "I felt like I had received an electric shock. It turned out that he had kicked me on my spine, with full force.' On the same day, the captors once took the singer to an empty spot in the field, and asked him to shout "Iqbal Gaddar!" (Traitor Iqbal!) "Before I could understand what was going on, one of them took a hold of me, as if to hug me. The other thrashed me so hard, so mercilessly, that I sustained internal injuries," he said. "As I tried to get up, bleeding from the ears, I felt like my head was exploding. He noted that even after undergoing

purpose of documenting evidence against him.

Little did I know that it was heard throughout the interrogation center with their powerful speakers," reminisced Iqbal. "I was so weak from the beatings they gave me, that I could barely sing. However, at that point, I was instilled with pride - it was a unique experience."

Unbeknownst to him, all the prisoners at the center had heard him, and had derived courage from his voice. The incident had been narrated and documented by a Bengali CSP officer, who was interrogated in the same building, at that time.

"Towards the end of October, I was transferred from the army prison camp in the cantonment, to the Dhaka Central Jail. I don't know why, but life changed for the better from then on," he said. "As the end came near, we used to hear the sound of bombing by plane, and rumours would float around that the end of the Pakistani oppression was near. We heard flares and gunshots, and knew that we were nearing victory. However, a fear still lurked, whether or not they would kill us before the Mukti Bahini could reach us?"

On December 16, the jailor let the prisoners know that Pakistan had officially surrendered at the Race Course field.

We got out on December 17, and as the Mukti Bahini supposedly tore through the gate, I saw some of the jailors change into a convict's uniform, in order to escape scrutiny!'

As Iqbal Ahmed walked free after eight months of inhuman torture, not knowing where exactly his parents were living, the singer went to his aunt's residence in Dhanmondi. His parents picked him up later that afternoon. "After an emotional reunion, we went home to many visitors, who had come to rejoice with us. Suddenly, a microbus belonging to a television channel came by, and out emerged Mustafizur Rahman, Sakhina Akhtar and another producer."

"They informed me that they were about to start Bangladesh Television, and wanted me to participate in its first musical programme. When I reached the station, I met Babu bhai (Zahidur Rahim) and Bilkis Nasiruddin, two of my mentors, and they wanted me to take the lead," smiled Iqbal. "Your mentors asking you to take the lead in their presence, there is nothing quite like it."

After our independence, the eminent singer represented Bangladesh in important delegations, including 1972's "Maitree Mela" held in Kolkata, and the Berlin Youth Festival in 1973, after receiving blessings from Bangabandhu Sheikh Mujibur Rahman himself. In 1973, he received the Ford Foundation Scholarship to study in Cambridge University, from where he obtained his PHD in Economics.

The many renditions of Rabindra Sangeet and Gono Sangeet recorded in his voice still endure as an exemplary mix of power and grace, as evident in his HMV records in 1970, and CDs published by Bengal Foundation and Asia Foundation in later years.

For all of Iqbal Ahmed's talent, contribution, and sacrifices, his Ekushey Padak this year only cements the fact that the artiste is not only a musical force, but also a cultural icon who showed courage and fought for our country, when it was most needed.



"I think that person actually saved me from a lot of torture on that particular occasion; but to this day, I don't know why he did it. I think he belonged to the Baloch regiment."

Perhaps the most poetic moment of the singer's imprisonment came when he was taken to the Field Interrogation Center (FIC), and was asked to record some songs for the

UN TOP COURT Myanmar hits out at Rohingya genocide case

AFP, The Hague

Myanmar yesterday hit out at a genocide case brought against it by The Gambia for alleged persecution of Rohingya Muslims, urging the UN's highest court to drop the claim on legal grounds.

Banjul dragged Myanmar before the International Court of Justice in 2019, accusing the predominantly Buddhist country of genocide against the Rohingya Muslim minority after a bloody 2017 military crackdown.

When the case opened in December 2019 Aung San Suu Kyi personally represented Myanmar at the Haguebased ICJ, but she was ousted as the Asian country's civilian leader in a military coup last year.

"Myanmar is... not seeking to impede the judicial process of the court," its agent Ko Ko Hlaing told the judges in the imposing courtroom at the Peace Palace in The Hague.

"On the contrary it is seeking to answer the proper administration of justice," Myanmar's international cooperation minister said. Both Hlaing, who was in court and Myanmar's attorney general Thida Oo, who was attending virtually, have been hit with US sanctions over the coup.

Christopher Staker, another lawyer for Myanmar, said the ICJ did not have the jurisdiction because it was not a case brought by two states, as required by the ICJ's statutes. "The court lacks jurisdiction and... the application is inadmissible because the real applicant in these proceedings is the Organisation of Islamic Cooperation," Staker said.

Pak clamps down on fake news

Pakistan's government has introduced a new cybercrime law that could see social media users jailed for up to five years for posting "fake news" about the military, judiciary or public officials.

Critics say the legislation is the latest example of creeping restrictions on freedom of expression in the nation, already ranked among the world's most dangerous for media workers.

It was approved by Prime Minister Imran Khan's cabinet and swiftly adopted into law by President Arif Alvi over the weekend, an official in the presidential office said yesterday.

UKRAINE INVASION THREAT Russia plans to target dissidents, US tells UN

The United States has warned the United Nations it has information that Russia has lists of Ukrainians "to be killed or sent to camps" in the event of an invasion, according to a letter sent to the UN rights chief and obtained by AFP Sunday.

The letter, which came as Washington warned of an imminent invasion by Russian troops massed near the Ukrainian border, said the United States is "deeply concerned" and warns of a potential "human rights catastrophe."

The United States has "credible information that allies have estimated. indicates Russian forces are creating lists of identified Ukrainians to be killed or sent to camps following a military occupation," the letter said. "We also have credible information that

Russian forces will likely use lethal measures to disperse peaceful protests or otherwise counter peaceful exercises of perceived resistance from civilian populations," said the message, addressed to UN High Commissioner for Human Rights Michelle Bachelet.

> The note, signed by Bathsheba Nell Crocker, US ambassador to the UN in Geneva, warns a Russian invasion of Ukraine could bring with it abuses such as kidnappings or torture, and could target political dissidents and religious and ethnic minorities, among others. Russia has placed more than

ICJ's fresh hearings into Rohingya case

The world must come together for the cause


E welcome the International Court of Justice's initiative to start a fresh round of hearings into the Rohingya genocide case filed by the Gambia over two years ago. The hearings will be held in two rounds starting from today. The Gambia, on behalf of the Organisation of Islamic Cooperation (OIC), filed the case in November 2019 with an aim to bring Myanmar to account for its genocidal actions against the Rohingya. The court, after holding a preliminary hearing, found the claims to be substantial and ordered Myanmar to take provisional measures to prevent further acts of genocide in the Rakhine State. Two years have passed since then. but Myanmar has not taken any such measures yet. It has not taken any initiative to grant citizenship or ensure other basic rights of the Rohingya.

According to Fortify Rights, in October 2016 and in August and September 2017, the Myanmar military deployed more than 11,000 soldiers who, along with police and civilian perpetrators, systematically massacred Rohingya men, women and children, raped Rohingva women and razed several hundred villages in all three townships of northern Rakhine. In August and September 2017 alone, some 750,000 Rohingyas fled to Bangladesh and joined some 300,000 others who had fled waves of violence since the 1980s in Rakhine. The UN Independent Fact-Finding Mission also made a confidential list of more than 100 individuals suspected of being involved in genocide, crimes against humanity, and war crimes. However, the UN Security Council failed to take any actions against Myanmar.

Against this backdrop, the case filed by the Gambia was seen as a big achievement. But the proceedings could not get momentum due to various reasons. The Suu Kyiled government in Myanmar had raised objections early last year over the eligibility of the Gambia in filing the case. But later, after the country's military seized power, the National Unity Government led by Suu Kyi withdrew all preliminary objections to the case and accepted the jurisdiction of the ICJ for hearing the allegations. In fact, the NUG is now trying to gain international recognition by cooperating with the ICJ. Reportedly, it has many secret documents proving the military junta's genocidal intent, which can establish the genocide case in the ICJ.

Therefore, the start of fresh hearings into the case gives us hope for justice. According to experts, the Myanmar military is now under serious international pressure, and even the ASEAN is not including it in its meetings. So, we think this is the right time for the international community to work together for the case of Rohingya justice, their citizenship and repatriation.

Note that while the ACC may not need to allow the right to self-defence if clause 54(2) is applied, it does become mandatory under 40(6) of the same service rules if the dismissal occurs on the ground of accusations brought against him. By ACC's own admission, the claim that the termination took place under 54(2) was thus made untenable, because it is no longer a case of 54(2) but one of disciplinary action on unsubstantiated grounds.

Be that as it may, no one is above unaccountability, and hence, as efficient and courageous as he may be, if Sharif is found guilty of misconduct in the due process, he should face disciplinary action proportionate to the offence, if established in the due credible and unbiased process. The question is: since the ACC claims it to be a disciplinary issue, why did he have to be dismissed without being allowed the mandatory right to self-defence?

According to credible sources, Sharif Uddin's annual performance assessment was consistently of high-grade. But this took a U-turn when his investigations raised eyebrows within the ACC, which also raises the question whether it was part of a design to victimise Sharif and whether there are vested quarters at the higher management level in ACC who are amongst the protectors of the politically and administratively linked sections of the corruption syndicate whose impunity Sharif proceeded to challenge.

A sense of job insecurity among a large section of the ACC staff following Sharif's dismissal led to an unprecedented act of protest which has subsequently taken the course of organising themselves to establish their job-related rights. This speaks volumes about the extent of management weaknesses within the ACC-a matter of grave concern for the organisational effectiveness of this organisation.

The dismissal comes as an acid test for the commission. A critical question that ACC needs to ask itself is what it means by "reputational damage". Even if all the reported allegations against Sharif were proved valid, and actions duly taken, any potential harm thus caused would be peanuts compared to the huge reputational gain that the ACC could have achieved if it could take action on the basis of the progress he made towards holding to account the powerful syndicates of grand corruption.

What the people would like to know is, while it was expected of the ACC to stand by Sharif and ensure his full protection in the discharge of his duties, why has the commission taken the course of outright dismissal and thereby put at risk their reputation and credibility in the eyes of the public? Was the ACC afraid that if it didn't get rid of Sharif, and if it allowed the accountability process against the said powerful syndicate to continue, the higher-ups in the ACC could also be a target of vengeance of the same powerful forces within or outside the ACC? It remains to be seen if and how the ACC tries to salvage its self-inflicted reputational damage.

We urge caution and clarity

HE government's decision to lift all Covid-19 restrictions, however poorly implemented, comes as a relief as it means resuming, with greater confidence, what has been a frequently halted journey back to normalcy. After two years of living with varied degrees of restrictions-like maintaining social distancing, no congregation, no school or college, no public train/bus service, work from home, and so on-people are set to feel the taste of unrestricted life. However, the rule of wearing masks outside home will remain as a safety precaution.

The government decision comes following a steady decline in coronavirus transmission, with a 7.82 percent positivity rate recorded on Sunday. We're hopefully seeing an end to the Omicron scare which saw cases shoot up since early last month. It makes sense then that instructions have been given to reopen schools (secondary and higher) from today and primary schools on March 1. Understandably, all higher educational institutions will follow suit and all offices, both public and private, will go back to their pre-restriction routine. This will provide the citizens with the opportunity to rebuild their economy and education sectors, the two worst affected areas after public health.

True, there has been widespread criticism over the government's handling of the Covid crisis since its outbreak in early 2020, but its response after the emergence of the Omicron variant, especially the ramping up of the vaccination drive, has been largely satisfactory. So far, 10.25 crore people, or around 86 percent of the target population, have been vaccinated with the first dose. The government has already introduced booster doses, initially for senior citizens and frontline workers, and is mulling vaccinating children under 12. The latter move, once underway, will help preteen students get back to their classrooms.

The danger, however, is not over, far from it actually. Although the positivity rate has fallen, people are still vulnerable to infections and attendant health challenges. A total of 21 Covid patients died in the 24 hours till 8 am on Sunday, raising the total number of Covid fatalities to 28,965. This is a time when we, all of us, need to be careful to make sure the declining positivity rate is not turned around. The media must play its role to increase vaccine awareness. The public must continue to wear masks and follow other health guidelines with due seriousness. And equally importantly, the government must bring all citizens under the vaccination coverage as soon as possible-thereby increasing the immunisation rate-and send a clear message about the importance of continued mask-wearing and social distancing. Letting our guards down before the virus is fully eliminated may prove to be perilous.

HERE was little cause for geopolitical optimism in 2021, and this grim trend has continued at the start of 2022. Almost every month over the last couple of years, a fresh emergency has dominated the news, contributing to a sense of a mounting tide of crises that threatens to overwhelm us.

The world is struggling to cope simultaneously with the seemingly endless COVID-19 pandemic, the rise of illiberal forces in many countries, the failure of international interventions that were supposed to stabilise conflict-ridden regions, rising great-power tensions, and military buildups in key territories. Beyond these immediate concerns, the impact of climate change, a major longterm threat to humanity, has become all too tangible-and political leaders have yet to mount a sufficiently forceful response. Who could be blamed for feeling overwhelmed?

In the eyes of many citizens, politicians seem far from getting a grip on today's urgent problems and steering the world away from catastrophe. And the seemingly endless series of crises threatens to erode the public's confidence that they and their political leaders can shape a better future.

The current malaise arguably resembles "learned helplessness," a phenomenon first described by the psychologists Martin Seligman of the University of Pennsylvania and Steven Maier of the University of Colorado in the 1960s. In an experiment, Seligman and Maier were surprised to find that

control their fate. So, they just gave updespite having the chance to escape. Seligman and his colleagues compared the dogs' behaviour to the symptoms exhibited by depressed people, and suspected that clinical depression results from a real or perceived lack of control over the outcome of a situation. The same may be true of groups. Smaller or larger groups of people, and perhaps even whole societies, may collectively come to believe that they are unable to effect positive change and, as a result,

stop trying. If so, the recent sequence of crises, and political leaders' apparent inability to cope with them, may be fostering a form of collective learned helplessness. According to new data from the Munich Security Index 2022, based on publicopinion surveys in the G7 countries and the BRICS (Brazil, Russia, India, China, and South Africa), those who agree with the statement that they feel helpless in the face of global events constitute the largest group in all the countries polled.In the democracies surveyed, the "helpless" are in the majority: 57 percent of respondents agree with the statement, while only 12 percent disagree. China is the only country among the 12 in which more than a quarter of respondents (27 percent) disagree with the statement. Similarly, although the figures are in general slightly lower, majorities or pluralities of respondents in all 12 countries agree that their countries have no control over global events.

Of course, one might ask why anyone should believe that they or their countries can steer global events. But the promise of control, even if an illusion, has been a

crucial element of politics in the modern age, when human beings, rather than God or fate, are supposed to be pulling the strings.

This helps to explain why the widespread perception of a loss of control, and a longing to regain it, are key political themes of our time. Slogans such as "take back control," "America first," "strategic autonomy," and "European sovereignty" all reflect the same underlying impulse.

The danger is that a widespread feeling of collective helplessness risks preventing the world from addressing the most important crises until it is too late. Societies overwhelmed by a wave of emergencies may end up meekly accepting what happens to them, even though they have the tools and resources to change it. In many countries, for example, people do not believe that the international community can successfully mitigate climate change, or do not trust others to do their fair share.

But while today's challenges are huge, our ability to cope with them will depend to a significant degree on our self-perception. Do we really believe that we are collectively helpless? Or are we willing to use our collective resources and intensify international cooperation because we believe we can turn the tide?

Above all, political leaders need to show that we can collectively "unlearn helplessness." Despite-or perhaps because of-the challenges liberal democracy faces, leaders need to inspire a new sense of confidence at home and abroad that they can tackle the crises in front of us.

And there is a silver lining. Notwithstanding all the angst about the future of democracy, Munich Security Index data also show that people still think democracies are better able than undemocratic countries to solve the problems of the future. Now they need to prove it.

The tragedy of a fallen remittance fighter

other citizens.'

OHURUL Islam of Gaibandha was a remittance fighter. He was barely 18 when he left Bangladesh to work as a construction worker in Malaysia. In the initial years. he would frequently send money to his family and visit home at regular intervals. There came a time when his parents passed away. This coincided with his legal status in Malaysia coming to an end. Thereafter, he never returned to Bangladesh, afraid that he would not be able to go back to Malaysia. He tried unsuccessfully to regain his legality, did any work that he could find and was still sending remittances whenever he could. It is to be noted that expatriates rarely lose their legal status through their own fault they are often victims of unscrupulous officials, agents and employers.

Away from family and friends and not having access to proper healthcare, his physical and mental health deteriorated. He last spoke to his niece, Rumana, in early October, 2021. He said he had severe fever and abdominal pain but told her not to worry and that he would recover soon and send some money for her family. That was his last contact with his relatives. On October 21, 2021, he died a lonely death in a hospital in Ipoh, about 200 km north of Kuala Lumpur. A remittance fighter, who sacrificed all his adult life for the economic liberation of his country, fell on the battleground at the age of 55.

Johurul Islam had no proper identification documents when he died. As a result, his relatives in Bangladesh became aware of his death much later when a picture of his dead body circulated on social media. A London based organisation, Voice for Global Bangladeshis, requested its representative in Malaysia to seek the High Commission's assistance. The High Commission was extremely sympathetic but its position was that, as Johurul Islam had no legal status in Malaysia when he passed away, the government of Bangladesh would not be able to bear the repatriation costs. This was also confirmed in a newspaper report (Naya Diganta, November 2, 2021) quoting an anonymous official of the High Commission.

Johurul Islam's relatives unsuccessfully contacted the officials in Bangladesh for financial help to bring back the body. Having no means, they sent a request to the hospital authority in Malaysia to bury him there. Being aware of this sad predicament, the diaspora in Malaysia raised funds for the repatriation costs. While they received support from the High Commission, the bureaucratic process in Bangladesh took a painfully long time for the preparation of the relevant paperwork. Finally, on January 1 this year, his body arrived at Dhaka. The government offered BDT 35,000 which was gratefully received by the bereaved relatives. His janaza was attended by hundreds of villagers.

The Ministry of Expatriates' Welfare and Overseas Employment has come a long way since its inception in 2001. It is committed to ensuring the welfare and rights of over one crore expatriates in 174 countries of the world. The ever-growing remittance flow in the country even in difficult times-USD 25 billion in the year 2020/2021-is an indictment of not only the hard work and patriotism of the remittance fighters worldwide, but also the visionary policies of the ministry. Indeed, Minister Imran Ahmed and his team have gained widespread respect, especially for their empathy and helpful policies during the difficulties of the Covid-19 pandemic.

While this article applauds the ministry and, indeed, acknowledges it as one of the most successful ministries of the current government, it highlights the case of Johurul Islam to illustrate a grave concern that the ministry should consider addressing urgently.

The Overseas Employment and Migrants Act is the primary legislation that deals with migration and related issues. However, neither the legislation nor any relevant rules directly addresses the issues of the duty of the ministry regarding the death of an expatriate worker. There appears to be a policy, narrated in the annual report of 2020/21, indicating that the ministry ensures that the employer of the deceased pays for the repatriation of the body, subject to the wishes of the relatives. It also states that where such an employer is not found, the Wage Earners' Welfare Board, a branch of the ministry, takes the responsibility for such expenses.

A worker, illegal at the time of his death, would unlikely have an employer willing to financially assist in any way. These workers are also unlikely to have family back home who would be able to bear the cost of their body being sent home. It also seems that the Board provides assistance regarding body expatriation only to those with legal status.

This situation appears to be morally and legally unsustainable. The legality issue of an individual abroad should not affect their rights as a citizen of



ILLUSTRATION: SUSHMITA S PREETHA Bangladesh. Discriminating between two citizens abroad on such grounds breaches the equal treatment rights guaranteed by the constitution. It could be the case that the ministry is failing in its statutory duty by denying responsibility in relation to such deceased persons. Furthermore, from a moral point of view, this particular group of remittance fighters is the most vulnerable and, therefore, deserving of extra help and respect from the state.

It is hoped that the ministry would look into this carefully and rectify its policy so that hundreds of families each year, like Johurul Islam's, do not have to

go through the trauma of uncertainties. Indeed, as I pen this article, I receive the news of another fallen remittance fighter with "irregular documentation". Salim Bhuiya died in late January 2022, following a heart attack in Maldives. His body lays in the hospital morgue, while his family appeals for help to the Bangladeshi diaspora, who are trying to raise the money to return Salim Bhuiya's body to Bangladesh. These fallen remittance fighters and their families deserve to be treated with more dignity and respect by the government of Bangladesh.

YOUTH IN ACTION A guiding light for the visually impaired

Masrur Ishraq founded Third Eye in 2019 to help the visually impaired students at his educational institution, University of Chittagong (CU). For his efforts, he won the Joy Bangla Youth

stenography during exams. "I knew about the visually impaired students when I

enrolled in CU," says Masrur. "I thought the university helps them with exams somehow. But during my first-year final exams in 2018, I saw some visually impaired students searching for stenographers while everyone else focused on their exams."

When Masrur approached the visually impaired students after his exams were over, he was quite shocked to know that they had to find their own stenographers, as well as helpers for recording study materials.

As a result, he wanted to create a team that would help the visually impaired students with audiobooks and exam hall stenography.

With this aim in mind, Masrur posted his idea in several internal online groups of CU via Facebook, Messenger, and WhatsApp. At first, many responded to his call. However, only eight people appeared in the first team meeting of Third Eye in January 2019.

Today, the platform has expanded outside the campus of CU, reaching five districts of the country.

They have over 550 active volunteers in Chattogram, Dhaka, Jashore, Feni, and Rajshahi. A 31-member executive committee is selected every six months, based on work performance to lead the organisation.

They follow rules like stenographers cannot be from the same department as the visually impaired students, and one stenographer cannot give multiple exams for the same visually impaired student.

Third Eye also involves visually impaired individuals in their work.

"As a volunteer and visually impaired student, Third Eve has been helping me with my studies since their inception," says Faisal Mohammad Ibrahim, former head of marketing and promotion of the organisation.

Currently, Third Eye offers debate, computer and pronunciation training for the visually impaired, alongside other vocational and personal skill development projects.

During the lockdowns in 2020, the platform utilised online content writing, workshops, and YouTube videos to raise awareness.

"In 2020, I became a certified trainer with Competency-Based Training and Assessment (CBT&A) from Bangladesh Technical Education Board, in hopes to establish a vocational training centre, which could help bear the management costs of Third Eye," reveals Masrur.

"CBT&A also included lessons on how to teach individuals with special needs, which I integrated into plans for Third Eye.'

Masur hopes for the day when no visually impaired person will feel like an outcast in society.

INTERVIEW Building a space-sharing marketplace

CHAYA is a novel space-sharing marketplace in Bangladesh, launched by Farhia Tabassum and Mehraab Anwar. Unoccupied and unused spaces can be listed by their owners on CHAYA's website, for users to browse and find what they need. Farhia is one of the entrepreneurs in the Dhaka Hub Global Shapers 2021 Cohort. The Global Shapers are a community of young leaders and change makers, aged between 20 and 30, curated by the World Economic Forum. The Dhaka Hub was founded in 2014. In an interview with The Daily Star, Farhia talks about the vision behind CHAYA, and more.

What was the first step to starting CHAYA? In early 2019, while searching for a place to arrange a photoshoot for a friend's company, we noticed a gap in the market. Locations and customers existed, but there was no middle man to connect them with each other.

Mehraab and I came up with the idea that we could use other people's homes the same way we use our friends' houses for shoots.

In October 2019, we opened an Instagram page and reached out to friends, parents, and restaurant owners in the hope that they will open up their spaces. In a month, we expanded our business to a multi-purpose space-sharing platform.

> What were some challenges you faced in the early stages of the business?

It was the typical 'chicken and egg' problem - do we get people to list their properties first or do we ensure we have some customers? Eventually, we decided to focus on the supply side first, although it was difficult as we had no traction or customers.

Fortunately, after we got the initial four to five spaces, we found customers with appropriate demands.

What is CHAYA currently focused on? We are concentrating on housing for bachelors as they are immensely underserved. Single women, in particular, struggle to find proper housing in this country. We aim to access a network of housing that fulfills the needs of people who are struggling to find reliable housing in safe areas. As a woman building a business, what has your experience been like?

Sometimes in meetings, people are quick to assume that I am an intern. Even when they know that I am one of the co-founders of CHAYA, they don't consider me as their equal. However, thankfully, there are mentorship programmes connecting us to other female entrepreneurs. In our culture, there is a pre-existing notion that women are inferior, so I always feel the need to work harder than my male counterparts.



Behaviour of the typical low and slow pitches in Bangladesh have been on the receiving end of a barrage of criticism, and remained near the centre of discussion among players.

The poor nature of surfaces had raised fingers on the curators and their ability to produce sporting pitches was repeatedly questioned. The Sher-e-Bangla National Stadium in Mirpur, especially, brought Bangladesh Cricket Board's (BCB) head curator Gamini de Silva under the radar of scrutiny as the Sri Lankan has been in charge for some time now.

Interestingly, the chairman of the BCB's grounds committee and influential board director Mahbubul Anam, who was in Chattogram ahead of the ODI series against Afghanistan, pointed fingers at the cricketers and defended the curators instead, saying that good players can score runs on all surfaces.

"When questions arise over lack of runs on the pitch, I think the problem is on the players and not the pitch. Those who can play well are able to



score runs in all sorts of pitches," Mahbubul told the media yesterday. "Cricket is a game of uncertainty, which comes through the pitches, and there won't be an excitement if it was absent," the BCB director added while reiterating that the onus is on the players to 'develop their skills in different pitches' as the 'behaviour of the pitch depends on the weather'. However, Mahbubul ended up mentioning that Chattogram has always produced sporting tracks and the upcoming three ODIs at the port city will have everything for a good cricketing contest.

Following a long gap of over seven months since Bangladesh played their last ODI series against Zimbabwe in July last year, the Tigers ODI captain Tamim Iqbal is set to return to international stage with the upcoming three-match ODI series against Afghanistan, starting from tomorrow.

A finger injury after that Zimbabwe series led to Tamim missing in action in five Tests and 24 T20Is for the Tigers up until now. It surely became the longest inactive period, during which Tamim had to remain out of international cricket, ever since the dashing lefty made his debut for Bangladesh back in 2007.

He remained among the top three rungetters in the tournament, scoring 407 runs in nine games with a strike rate of 132.57, striking a hundred and four fifties.

So, all eyes will be on Tamim as he makes a comeback to national colours in the favoured ODI format after an extended pause. Given the type of character Tamim

Whereas, on the leading front, it will be a big challenge for Tamim, who took over the ODI captaincy last year from Mashrafe Bin Mortaza. Since then, the Tigers lost to New Zealand in the three-match series but went on to seal series victories against Sri Lanka and Zimbabwe under Tamim's captaincy.

Tuchel fights to rekindle Chelsea fire

Villarreal welcome Juventus

Thomas Tuchel admits Chelsea are fighting to "survive" as the spluttering Champions League holders prepare to face Lille in the last 16 first leg tonight.

Tuchel's side have won their last five games in all competitions, but there was little joy on the German's face when he reflected on Saturday's 1-0 victory at Crystal Palace.

The honeymoon is definitely over for Tuchel as he approaches the business end of his first full season as Chelsea boss.

In just five months in charge last term, Tuchel led Chelsea to the Champions League crown and the FA Cup final, as well as a top four finish in the Premier League.

When Romelu Lukaku was signed from Inter Milan for a club record £97 million (\$131 million), it was expected the Belgium striker would help Chelsea enjoy a period of sustained dominance.

Chelsea were tipped to emerge as serious challengers for the Premier League title and in the early weeks of this season it seemed they might live up to the hype.

But in the grip of a windswept winter in Britain, Tuchel has found it increasingly tricky to keep Chelsea from being blown off course. The first signs of discontent behind the scenes emerged when Lukaku went public with complaints about the way

he was being deployed by Tuchel. Forced to apologise, Lukaku has cut a disconsolate figure ever since and remains without a league goal since December.

Lukaku was completely anonymous against Palace and had only seven touches -- the lowest by a player over 90 minutes since Opta started recording the statistic in 2003-04.


That victory at Palace was only Chelsea's third in their last nine league games, a dismal run that effectively shattered their title hopes. Chelsea are 13 points behind leaders Manchester City, making retaining the Champions League their main goal for the rest of the season.

Meanwhile, Juventus made a splash in the January transfer window when they snatched hot prospect Dusan Vlahovic and Switzerland midfielder Denis Zakaria, but their arrival has yet to provide the hopedfor boost ahead of Tuesday's Champions League visit to Villarreal.

Massimiliano Allegri's side travel to Spain as the only Italian side with a realistic hope of making the last eight after Inter Milan were beaten 2-0 at the San Siro by Liverpool on Wednesday.

However they go into the first leg of their last 16 tie in unsure form, with results and above all performances that have left fans unsatisfied with Allegri's first season back in black and white.

Dhaka and Delhi have begun preparations for Prime Minister Sheikh Hasina's visit to India later this year.


This visit is expected to further accelerate the friendship between the two countries that are celebrating the 50 years of diplomatic relationship this year.

The study result by researchers of Heidelberg University in Germany is challenging the idea that the human brain's functioning speed declines from the age of 20-30, reports BBC. The scientists used an online task to estimate the decision-making times of 1.2 million people, aged 10 to 80, according to the study published in Nature Human Behaviour. The study found that the mental speed of those aged between 30 and 60 remained relatively stable.

Bangla, English mandatory for 2022 SSC, HSC

In-person classes resume today STAFF CORRESPONDENT

As secondary schools and colleges partially resume in-person classes today, education boards have decided that SSC and HSC candidates of 2022 will need to sit for Bangla and English exams besides three optional subjects.

Meanwhile, the government has decided to hold the Secondary School Certificate and Higher Secondary Certificate exams in mid-June and mid-August respectively.

All the exams will be held with curtailed syllabuses and fewer marks, Professor Gazi Hasan Kamal, chairman of Mymensingh education board, told The Daily Star.

The syllabuses were revised and marks curtailed as schools and colleges were shut down for long due to Covid-19, he said.

Prof Md Moshiuzzaman, member of National Curriculum and Textbook Board, said they have already prepared a short syllabus for all subjects and notified all concerned regarding the matter.

Last year, SSC and HSC candidates took the tests only in three optional subjects with a shortened syllabus and the fewer marks, due to the pandemic.
