No legal bar to continuing Kajol's trial

The High Court yesterday rejected three petitions seeking cancellation of charges framed against photojournalist Shafiqul Islam Kajol by a tribunal in three cases filed under the Digital Security Act.

The bench of Justice ASM Abdul Mobin and Justice Mohi Uddin Shamim issued the rejection order because the petitions were not presented properly, Deputy Attorney General Sujit Chatterjee told The

There is no longer any legal bar for the tribunal concerned to continue the trial proceedings, he added.

Kajol's lawyer Jyotirmoy Barua told this correspondent that he will move three separate appeals before the HC so that he can place arguments in detail against the tribunal's illegal charge framing order in the false cases.

A Dhaka tribunal on November 8 last year framed charges against Kajol in the

Awami League lawmaker from Magura-1 Saifuzzaman Shikhor, Jubo Mahila League central committee members Usmin Ara Belly and Sumaiya Chowdhury Bonya filed three cases with Sher-e-Bangla Nagar, Hazaribagh and Kamrangirchar police stations under the DSA on March 9, 10 and 11 in 2020.

Sub-inspector Mohammad Russell Mollah of Detective Branch of police pressed charges in the cases to the Chief Metropolitan Magistrate's Court of Dhaka on February 4, March 14 and April 8 last

Kajol was charged with circulating indecent, defamatory, objectionable, and fake information about several ministers, lawmakers, and top Jubo Mahila League leaders on Facebook.

Kajol went missing on March 10, 2020. Officials said the Border Guard Bangladesh found him roaming around the Benapole border area on May 3 the same year and detained him. He was then sent to jail by a Jashore court.

He was later shown on documents as arrested in the three cases filed under the

The lower court denied him bail for seven months until the High Court on November 24, 2020, granted him bail in one of the cases. The HC on December 17, 2020, granted him bail in two other cases after Kajol's lawyer argued that probes had to be completed within 75 days of filing of the cases, and the investigators failed to do so.

Criminal cases to be filed for zebra deaths

Probe finds Gazipur safari park staffers tore open bellies of 3 of the dead animals

The ministry of environment, forest and climate change yesterday decided to lodge criminal cases against those involved with the death of 11 zebras at the Bangabandhu Sheikh Mujib Safari Park in recent weeks.

The development comes after the probe committee formed by the ministry on January 26 following the deaths of the animals submitted its 18-page report on Sunday. The probe found

the employees of Bangabandhu Sheikh Mujib Safari Park tore open the bellies of three dead zebras with a sharp weapon to pass off their death to injury.

As many as eight zebras died in the safari park last month, but the park officials tried to conceal the matter from Mostafa Kamal, the secretary of the ministry, when he called in on January

"So it shows that they were trying to hide the incidents of death of zebras,

the report said, while calling for further investigation on the matter.

The probe committee also found negligence in duty on the part of the in-charge of the safari park as he did not form any medical board

> vhen the zebras started dying towards the end of December last year though he is empowered to do that if necessary.

Also at the meeting yesterday, it was decided that departmental cases will be filed against the officials responsible for the death of animals. The meeting also

decided to implement all recommendations made by the probe committee in phases.

To improve the operation quality and protect the animals from unnatural deaths, the probe committee gave 24 recommendations: 11 are to be implemented in the short-term, four in the mid-term and nine in the long-term.

Earlier, the probe committee members said the 11 zebras died from nitrate poisoning.

Hike prices and get slapped with cases **DNCRP warns** essentials traders

The Directorate of National Consumers Right Protection (DNCRP) will file cases against retailers found selling essentials at an inflated price ahead of Ramadan, as the government looks to rein in prices from spiralling out of the means for the poor and the fixed-income people.

"If someone sells goods at a price of their own will, we will file a case against him. Fines will also be imposed. The shop will be sealed," said Monjur Mohammad Shariar, director (additional charge) for admin and finance at DNCRP, after a meeting yesterday with representatives of wholesale markets.

Instructions were given to businesspeople in view of the recent increase in prices of essential commodities and Ramadan.

SANCTIONS ON RAB

Decision to lodge case in US court expected this week

Bangladesh could decide this week to lodge a case with a US court to fight that country's sanctions against Rab and seven of its current and former officials.

"We are very close to a decision to appoint a representative for speaking and fighting legally on our behalf," State Minister for Foreign Affairs Shahriar Alam told reporters at the foreign ministry yesterday.

He said the government spoke with three law firms and is expected to take a decision this week.

Shahriar said Dhaka will make both legal and diplomatic efforts to have the sanctions imposed in December last year over Rab's alleged human rights violations -- withdrawn.

"They [primary school students] will also return to school. As teachers and other staffers have already been inoculated, there will be no problem," he told journalists at Bangladesh College of Physicians and Surgeons in Dhaka on Saturday while talking about the upcoming countrywide special Covid-19 first dose vaccine

There will be 16,000 vaccine centers in rural areas and 8,500 in the urban areas and more than 70,000 vaccinators and volunteers for the one-day special campaign. No one will require any document or prior registration.

"After this, the activities to give second and the booster dose will be strengthened," he said. Meanwhile, the health directorate has reported
