and colleges and gathered at Amtala. A debate broke out over the question of breaking Section 144. We, female students, were in favour of violating Section 144. Seeing the student leaders confused, we boycotted the meeting and went to the girls' common room. Later, we came back and attended the meeting in the greater interest of students' unity.

The police took position in front of University Gate. As soon as groups of male students hit the road, police arrested and picked them up in a truck. Male students could not move forward. Then I along with other female students came out in groups. Police did not stop us. More female students joined us and it became a small procession.

When we reached the present entrance of the Medical College police started baton-charging and firing tear gas shells. I got injured during the charge.

Initially, I took shelter behind some wrecked rickshaws. Then, I rushed to the provost quarter and took shelter there. Later, we came back to our hostel. Prof Munier Chowdhury accompanied us. Female students also participated in raising fund and nursing the wounded in the following days.

Justice tangled up in lengthy procedures

The trial of the second case was delayed due to the pandemic, he told The Daily Star.

The lawyer hoped that the trial would be completed this year.

Aminul Islam, a defence lawyer in the second case, said the trial court has so far recorded statements of around 170 witnesses out of 1,264.

It still remains uncertain when the court would finish the trial and when the 200 accused, acquitted by the HC, would be freed,

he said.

At least three more years will be needed for completing the trial of the case in the lower court, Aminul said.

Former BDR member Abdur Rashid was acquitted in the killing case by the lower court. The prosecution did not file any appeal with the higher court against his acquittal, but he is yet to be freed as he stand accused in the second case, said his family members.

Rashid's son Abdullah Al Mamun Shakil said they

were absolutely helpless now.

"My mother often cries thinking of my father's plight. My father joined office at the BDR headquarters in Palkhara just a couple of days before the mutiny."

Shakil said petitions were filed thrice seeking bail for his father in the second case, but the lower court denied him bail and even did not issue any written order. And that's why his father cannot lodge a bail petition with the HC.

"So far I know, there are at least 24 people, including my father, who were acquitted by the trial court and the High Court and the state have not filed any appeal against their acquittal. But they are still behind bars," he added.

Babul Mia, brother-in-law of Major Mosharaff, who was killed in the mutiny, said they were satisfied with the verdict in the carnage case.

"We want the verdict to be implemented at the earliest," he told The Daily Star.

As per fire service officials, the fire broke out at 5:17pm, and it took eight firefighter units to douse the blaze around 7:10pm.

Firefighters recovered three bodies from inside the factory, one of whom was burnt beyond recognition.

The two deceased who could be identified are Sumaiya (12), daughter of Imarat Hossain of Tangail, and Shahanara Begum (45) from Khulna.

Abdul Alim, fire service's deputy assistant director (zone-04), confirmed that the factory had no approval from fire service.

"There is no emergency gate, and that is what led to the three deaths," said Alim.

Fire service officials

suspect that the fire originated from a factory machine, and stored chemicals helped escalate it further.

This correspondent was unable to reach the factory authorities.

Contacted, Jahirul Islam Talukder, deputy director of Department of Environment (Dhaka), said the factory had DoE's approval. He didn't elaborate further on the matter.

Sub-inspector Sudip Kumar Gop of Ashulia Police Station said preparations for legal steps are underway.

"The unidentified body has been sent for DNA test. We are yet to contact the factory authorities as they are on the run," he said.

have led to this," he added.

Sanjit Mahato Rony, president of JU's Indigenous Students' Association, said, "I'm from the Mahato community in Sirajganj. I only have four Mahato students on the campus, and that's why we cannot perform any community-specific rituals or festivals here. The same can be said about students from other ethnic minority communities, despite coming from a rich and diverse culture."

"Our languages, rituals and culture need protection and patronisation from the government, to save them from extinction and cultural invasion," said Sanjit.

However, the indigenous students of JU have not lost all hope of preserving their culture and languages. They still have hopes for the emancipation of all languages and the right to their mother languages, embracing the true spirit of Ekushey.
