Prof Hadiuzzaman, director of Buet's Accident Research Institute, who was also on the meeting's participant list, said many decisions were taken at meetings. "But those decisions are being implemented at snail's pace."

"Problems regarding road safety and their solution is very much known to all. Implementation of recommendations is more important instead of making new recommendations and policy spending people's money," he added.

In 2021, a total of 5,088 people were killed in 5,472 road crashes, says the police report. However, the figures are much lesser than those compiled by road safety organisations.

Operation of a higher number of small vehicles, including motorcycles and illegal three-wheelers, and poor monitoring amid the pandemic has been blamed for the rise in the number of accidents and fatalities.

Alongside, the government's failure to develop a robust public transport system and lack of implementation of recommendations, including training drivers, were also blamed.

a row. I fell too, and lied with the pile of corpses for a while," Abinash recalled.

The Pakistan army then set piles of straw ablaze.

"I don't know how long I lied there, but then I heard a village girl asking if anyone was alive."

"All I could ask for was some water." The girl went and fetched drinking water from a nearby canal. By the time he could stand up, he could feel injuries on both his legs and that he was bleeding from the wounds.

"On that day, 26 people, including seven from my family, were martyred at the same place. 19 houses and six cattle rooms were set on fire and looted." The bodies were later buried in a mass grave in the village.

Ankar Mia, another survivor of the massacre, said, "Abinash's family were quite wealthy. The fire set at their barn burned for almost two weeks, turning everything into dust."

"Noria is all peace and quiet today. Our Hindu-Muslim harmony is unparalleled," Ankar said.

Despite this, the village still suffers from the massacre's aftermath. The families that went destitute are yet to get back to their feet, hoping to this day that the government comes forward to help them.

They also demand a memorial to remember the genocide of May 8, 1971, on the same spot of its occurrence, where a slaughterhouse stands today.

was elected general secretary of the party. He was later re-elected to the post several times till 2012, when he was elected as president.

The party congress had decided that year that no leaders shall be elected president and general secretary more than twice.

During the 12th Congress, there were proposals to bring a change regarding this policy, but they were withdrawn in the end, said several delegates.

Before this, Selim was in the 43-member central committee that was elected by delegates of the congress.

The committee comprises of 11 new faces, including Kaberi Gayen, Aslam Khan, Manabendra Deb, Lucky Akter, Nimai Ganguly, Motaleb Molla, Ainun Nahar Lipi and Abid Hossain.

While the outgoing committee had six women, the new one has nine.

The new committee will sit in a meeting on Friday to elect the new president, general secretary, presidium and other secretariat members. Several top CPB leaders said there are discussions that either Mohammad Shah Alam or Mrinal Chowdhury can become president.

Meanwhile, anyone among Ruhin Hossain Prince, Abdullah Al Kafee Ratan, Sazzad Zahir Chandan and Mihir Gosh can become general secretary.


