Ex-minister's brother held

Mohtesam faces Tk 2,535.11cr money laundering case

Khandaker Mohtesam Hossain Babar established control over all activities in Faridpur and exerted his influence over the district Awami League after his brother Khandaker Mosharraf Hossain was elected a lawmaker in the 2008 national elections and later became a minister, said investigators.

Having a nexus with some people, he manipulated all tenders of different government departments in the district through an illegal syndicate. He helped people win government contracts in exchange for a commission on the total contract value, a CID probe

Sixty-seven-year old Mohtesam, also the Faridpur district AL vice-president, was

arrested in the capital early yesterday in a Tk 2,535.11 crore money laundering case. He had been on the run since March 3 last year when the Criminal Investigation Department submitted the charge sheet in the case against him and nine others.

A team of Faridpur Kotwali police picked him up from a house in the capital's Bashundhara residential area around 1:30am. He was later taken to Faridpur, said MA Jalil, officer-in-charge of Kotwali Police Station.

Home beckons

Sailors return today, a week after attack on ship in Ukraine

The 28 crew members of the ill-fated Bangladeshi ship are finally on their way home, having escaped death when the ship came under attack in Ukraine on March 2.

After a weeklong ordeal, they are expected to reach Dhaka around

The "missile" attack on "Banglar Samriddhi" claimed the life of one of their crewmates, Third Engineer Hadisur Rahman. They were rescued from the ship after around 21 long hours and took shelter in a bunker in the war-ravaged European country.

After two days, they reached Romania via Moldova and left for Bangladesh from Bucharest by a special flight last night.

Md Daud Ali, Bangladesh ambassador to Romania, told The Daily Star that all 28 crew members would fly from Romania by a special flight of Turkish Airlines.

"The crewmen will have a stopover at Istanbul and from there they will fly for Dhaka. Hopefully they will reach Dhaka by noon tomorrow [today]," he said.

Hadisur's body is still in Ukraine, and efforts are underway to bring the body home, he added.

Although relieved to be safe, the sailors are haunted by the shelling incident and the death of one of their fellow sailors.

This newspaper talked to one of the crew members who described the entire journey over phone vesterday from Romania.

US, UK ban Russian oil

Ukrainians flee besieged cities as war rages

US President Joe Biden yesterday banned imports of Russian oil to punish Moscow for its invasion of Ukraine as desperate civilians fled besieged cities and fresh fighting raged.

Britain said it would also phase out Russian oil by the end of the year and the EU planned to slash gas imports by two-thirds, as Western sanctions finally began to target the economic lifeline for Russia's war.

Russian President Vladimir Putin has pressed on despite unprecedented sanctions, although Moscow agreed set up "humanitarian corridors" from four Ukrainian cities on the 13th day of the conflict.

The number of refugees flooding across Ukraine's borders to escape towns devastated by shelling and air strikes passed two million, in Europe's fastest-growing refugee crisis since World War II, the UN said.

Buses streamed out through an evacuation corridor from the northeastern city of Sumy -- where 21 people were killed in air strikes overnight -- while civilians on foot took an unofficial escape route out of the bombarded Kyiv suburb of Irpin.

Land scam by AL men 'may be true'

Dipu Moni says; the alleged fraud delaying the start of academic activities

Uncertainty looms over the planned launching of academic activities at Chandpur Science and Technology University (CSTU) this year as the land acquisition process remains stalled over alleged price manipulation by some local ruling party men, reportedly close to Education Minister Dipu Moni.

The CSTU authorities had planned to begin academic activities on a limited scale in the existing buildings on the proposed land.

But as the local administration raised the issue that the government would lose Tk 360 crore due to the abnormally overpriced land, the matter is now pending with the High

On Thursday, Attorney General AM Amin Uddin told the court that 139 of the land deeds were registered with corrupt motives to

embezzle public money in the name of land acquisition for the university.

Contacted, CSTU Vice-Chancellor Nasim Akhtar said the university authorities wanted to enrol students from this year in five departments in the existing buildings.

"If the matter is not settled soon, the academic session will stumble and local Awami League men would have to shoulder

the responsibility," he said early last month. Dipu Moni on Monday told The Daily Star that the allegations of price manipulation were likely true, but did not go into detail.

Meanwhile, the VC on Sunday sent a letter to the education ministry, requesting it to allocate the estimated Tk 193.9 crore for the acquisition within 120 work days.

Carbon user fee to cut emission by 12pc by 2030: IMF

Bangladesh could bring down carbon dioxide emission by 12 percent by 2030 by introducing a carbon user fee on the energy sector as it strives to transition to a lowcarbon economy and build climate resilience, said the International Monetary Fund.

The country has targeted to bring down carbon dioxide by 6.73 percent in that timeframe.

The carbon fee can start from this year at \$3 per metric ton of carbon dioxide on the energy and the industrial processes and product use sectors and increase to \$25 per metric ton by 2030, said the Washingtonbased multilateral lender in its 'Selected Issues' paper on Bangladesh.

The paper was prepared by a staff team of the IMF as background documentation based on the information available as of February 15 for the periodic consultation with Bangladesh.

"This may be an opportune time for Bangladesh to align with interests and net-zero goals of its export consumers, donors and the private investors following the renewed pledges at COP26."

With the early adoption of carbon pricing, Bangladesh will provide a strong and credible signal to donors and investors on its commitment to a greener economy.

The fee will be easily implementable," the IMF said. The gradual increase in the fee will help firms to plan for decarbonising their production processes and improving energy efficiency, thereby reducing stranded assets, risks to competitiveness and job losses in the future.

'Motherly affection will win people over' PM tells Dubai **Expo 2020**

Prime Minister Sheikh Hasina yesterday said that people will continue to support her due to her motherly affection as a leader of the country.

She made the remark at a high-level power panel titled "Redefining the Future for Women" held at the Women's Pavilion in the Dubai Expo 2020 arranged to mark International Women's Day.

Hasina said she has won the support and trust of her people and that is her main strength. "People know that if I'm there. they'll be benefited.'

But this journey was not easy, she said, adding that almost her entire family was assassinated and only she and her sister survived.

The PM said she faced repeated attempts on her life along with smear campaigns. "But I didn't care. All I thought about was continuing my work for the people.

About the Bangladesh parliament with regard to women empowerment, she said now the Speaker, the Leader of the House, the Leader of Opposition and the Deputy Leader of the House are all women.

She said that when she formed the government in 1996 after the 21-year rule of military dictators, she found no women in power, adding that she took initiatives for the development and empowerment of women. She also tried to create job opportunities for them in the higher posts like the judiciary, police and other

Describing the Father of the Nation as her mentor, the PM said she learned about the country and its problems from him.

"I learned from my father, my mentor. I learned how to harbour compassion and love for the people and the country, as well as how to work for the poor."

'Please save us'

5 Bangladeshis in a Ukraine detention camp appeal to govt

Five Bangladeshis, reportedly detained at a camp in the Ukrainian city of Zhuravychi, said they were not being given enough food, their phones were seized and they were being tortured.

They requested the Bangladesh government to take action so that they can leave the camp.

Yesterday morning, Riyad Malik, one of the five Bangladeshis, sent The Daily Star a 40-second-long audio message using another person's phone.

On Saturday, the Bangladeshis told this newspaper that they were being held there to be used as "human shields".

They posted a video message the day before on social media where they sought assistance from the government. Details of their sufferings were published in The Daily Star and other prominent media.

Using someone else's phone, Malik yesterday managed to have a brief chat with The Daily Star. In a shaky voice, he said, "I'm using another detainee's phone. We are being tortured. There is no food and water supply at the camp. Zhuravychi is now a full-fledged war front. The detention camp is under the control of the Ukrainian army. We can hear sounds of bombardment from every direction. If the

Russian forces attack the camp or drops bombs, all 120 detainees, including the five of us, will die. Is there anyone out there who can save us? Can't the government save us? Can't they free us? We don't want to die..."

Regarding communications with the Bangladesh Embassy in Poland, Malik said, "We could establish communications but we feel that they are proceeding very slowly. We are not saying they are not working. But if the embassy or the government of Bangladesh does not take rapid action, we will not survive."

Around 60 people, including two Bangladeshis, are stranded in another detention camp in Mykolaiv. One detainee is Jahirul Islam, while another requested not to be named.

On Monday, he said, "Our situation has not changed. As the power connection has been severed, the heating system is not working and we are suffering under extreme temperatures while there is also a water and food crisis. The Russian army is now controlling the city."

He too alleged that the civilian detainees were being used as "human shields" by the

CO₂ emissions from energy sector rises by 6 percent

Global energy-related carbon dioxide emissions rose by six percent in 2021 to a record 36.3 billion tonnes, their highest ever level, the International Energy Agency said yesterday.

"The increase in global CO2 emissions of over 2 billion tonnes was the largest in history in absolute terms, more than offsetting the previous year's pandemic-induced decline," it said.

It pointed to the widespread use of coal to power growth as the world economy rebounded from the Covid crisis.

The IEA said the rebound of global CO2 emissions above prepandemic levels was largely driven by China, where they increased by 750 million tonnes between 2019 and 2021.

Truck kills child going to school

A schoolboy was killed after a speeding truck hit him in Dinajpur's Chirirbandar upazila yesterday, while a woman was killed in a separate road accident in Birampur upazila on Monday.

In Chirirbandar, Ashiqur Rahman, an 11-year old sixth grader of Z Residential Model School, was on his way to school on a bicycle when a speeding truck ran over him in Ghugratoli area, leaving him dead on the spot, said Bazlur Rashid, OC of Chirirbandar Police Station.

In Birampur, Arati, 40, of Joypurhat, was killed when a speeding truck hit a van carrying her and her husband Sunil Baske on Monday on their way back home, police said.

HC questions discriminations against women

Mohtesam last year. Following the arrest, police in a press release yesterday said, "Mohtesam amassed a lot of property at home and abroad with illegally earned money using his political influence and that of his brother's."

It also said the arrestee amassed the ill-gotten money as commission and bribes for helping people win tenders in government offices and getting jobs.

SM Miraj Al Mahmud, a CID inspector, filed the case with Kafrul Police Station in Dhaka against former Faridpur AL leader Sajjad Hossain Barkat and his brother Imtiaz Hasan Rubel under the money laundering prevention act on June 26, 2020.

After probe, the CID submitted the charge sheet to a Dhaka court against Mohtesam, former minister Khandaker Mosharraf's assistant personal secretary AHM Fuad, also an exconvener of Faridpur district Jubo League, Barkat, Rubel,

and six others. According to the probe report, Barkat and his brother Rubel amassed Tk 2,535.11 crore beyond their

known sources of income. The siblings amassed the wealth after winning different contracts government departments in the district through manipulation since 2010. They were also allegedly involved in drug smuggling and land grabbing.

The two brothers had a nexus with Mohtesam and Fuad, and through an illegal syndicate the siblings manipulated all tenders of roads and highways, public works, and health departments, LGED ministry, BRTA. municipalities,

parishads, Development Board, and medical colleges. also

illegally collected commission from (markets), haats district land registrars' offices and extorted money from the transport sector, found the CID probe.

The other charge sheeted accused are: former Faridpur town Jubo League president Khandakar Nazmul Islam Levi, former general secretary of the unit Ashiqur Rahman Farhan, Faridpur Swechchhasebak district League General Secretary Fahad bin Wazed Fahim, former joint convenor of Faridpur town Jubo League Kamrul Hasan David. district Jubo League Joint Convener Mohammad Ali Minar, and Faridpur town Jubo League Joint Convenor Tarigul Islam Nasim.

Of them, Barkat, Rubel, Fuad and Nasim are now behind bars while Levi and

Farhan are on bail. Barkat. Rubel, Farhan and Levi made confessional statements before magistrates about Mohtesam's involvement in money laundering, said court sources.

All the accused but Mohtesam have been expelled from respective organisations.

A district Jubo League leader, also a contractor, vesterdav said anvone looking to secure a project contract had to give Mohtesam a commission of 10 to 15 percent of the total project cost.

"He was known in Faridpur as Mr 15 percent," he told The Daily Star, wishing anonymity.

Contacted, Khandaker Mosharraf said if his brother is found involved in any crime, he would be punished as per law.

found that 63.549 acres of land in Laxmipur Mouza no. 115, selected for the university, were heavily overpriced.

The Chandpur Deputy Commissioner's office began the CSTU land acquisition in May 2021. The DC office estimates that at the artificially hiked rate, the government would have to pay about Tk 553 crore when the actual price of the land is about Tk 193

This unusually huge gap was discovered by comparing prices of the acquired and non-acquired lands in the same area. The estimate by the DC office past 12 months' average land price in the area.

For instance, a 0.99 acre of the proposed land was sold for Tk 23.75 lakh at Tk 24 lakh an acre in different times between May and July 2019. A year later, about 0.31 acre of that property was sold for Tk 1.24 crore, at around Tk 4 crore per acre, according to the land deeds.

However, land prices beyond the acquisition area under the same mouza increased only slightly since

Some local ruling party men were allegedly behind this sharp increase in prices before the acquisition

Chairman of Laxmipur union Selim Khan, also the Awami League president of the union unit, and his family members bought about 14.46 acres of land for Tk 38.16 crore between over the sub-registrar June 2020 and April 2021, according to the deeds.

Besides, Chairman of Chandpur's Faridganj

upazila Jahidul Islam purchased 1.73 acres at Tk 3.5 crore; Vice-president of Chandpur Sadar upazila Avub Ali Bepari bought about 1 acre at Tk 2.45 crore; Vice-president of Chandpur District unit of Awami League Dr Jawadur Rahim Wadud, who is also brother of Education Minister Dipu Moni, purchased about 0.99 acre at Tk 2.71 crore and the minister's Personal Officer Tutul Mazumder bought 0.4 acre for Tk 1.13 crore, the papers show.

All of them bought the land in one year from May 2020, and there are allegations that some land owners were paid much less than the amount is based on the immediate mentioned in the land deeds.

There are also allegations that Selim Khan forced locals to sell their properties, but he refuted them.

Wishing to be unnamed, a labourer said Selim took about 45 decimals of his inherited farmland in exchange for 30 decimals of land in another area. He was given a simple

choice: either hand over the land willingly or lose it, the labourer said. "We gave the land out of fear," he said, adding that

on November 16, 2021. The CSTU VC who had sent a letter to the DC office requesting it to acquire land for the university, said the education ministry gave the administration approval along with the specific ledger numbers.

I have no part in this. You'll see that the total land size is 62.549 acres; neither 63 acres nor 62 acres. It is only possible after calculation of the exact land volume in the ledgers," he

Additional Secretary (development) of the Secondary and Higher Education Division Belayet Hossain Talukdar said, "That's not correct. It is the DC office that keeps the land records."

However, Selim Khan in a letter on January 17, 2021, requested the education minister to acquire 13.83 acres of land under ledger numbers 2132-2153; 2155, 2160-2185 and 2193-2199 for the university. He sent the letter four

months after the enactment of the CSTU Act on September 9, 2020. On the same day, Dipu

Talking to The Daily Star to the education secretary with a note saying: "The two pieces of land are adjacent to each other. It may be good if the land can be acquired for the university. Take measures."

Later, the land was earmarked for student dormitories.

Contacted, Selim Khan said he had bought the land by paying taxes and following legal procedures and did not force anyone to

bought so much land in the allegations of price a short period at a hefty price, he said he would not comment on the matter because there was a writ petition pending before the court over the issue.

In late January, when different media reported foul play by local ruling party leaders close to the education minister over the land acquisition, Dipu Moni told a press conference that she has close political relations with Selim Khan.

of the education minister, said he bought the land to build a hospital and a retirement home. "I sold the land to Selim

conflict of interest as my sister is education minister," he said, adding that he transferred the ownership on December 6, 2021.

Education minister's Personal Officer Tutul said that he did not show the land in his wealth statement.

"I get a small amount in salary. It is not taxable. I bought the land borrowing money from my relatives, he claimed.

Save Tetultala playground Locals call upon PM

Residents of Ward-17 in Dhanmondi under Dhaka South City Corporation (DSCC) yesterday demanded the prime minister save their 50-year-old playground and keep it open for all.

Local police installed barbed-wire fences around Tetultala playground in January.

'There is no other place for our kids to play. We have been going to the field for the last 50 years. But on January 31, the local police station set up barbed wires to construct their new station on the field, and we heard that they purchased the land for Tk 28 crore," said Syada Ratna. coordinator of Tetultola Math Rokkhya Andolon, at a press conference at Dhaka Reporters Unity.

She said they do not know how the authority purchased land that has been used as an open space for decades.

Ratna said according to the law, changing characteristics of a playground, open space and waterbody is illegal.

At the conference, Iqbal Habib, joint secretary of Bapa, said in the proposed Detailed Area Plan, Tetultala playground is not earmarked as a playground. However, in sub-zone-17 (Dhanmondi, Zigatola, Kalabagan and Kathalbagan) they proposed keeping sufficient open space for the areas.

23 high-polluting tanneries to face music

Move to protect Dhaleshwari from Savar Tannery Estate's untreated waste

Twenty-three tanneries that are causing high levels of pollution are set to be shut down, a parliamentary body said yesterday.

Meanwhile, utility services of seven tanneries have already been disconnected over environment pollution, stated the parliamentary standing committee on environment, forest and climate change ministry at a meeting at Jatiya Sangsad

All of these tanneries operate under Savar Tannery Estate, which comprises around 120 tanneries.

"Braving various obstacles, we were able to take action against Savar Tannery Estate, shutting down several tanneries, Saber Hossain Chowdhury, chief of the parliamentary watchdog, told reporters after the meeting.

"There will be no compromise on the issue of environmental pollution," he

In 2003, the government took an initiative to build the BSCIC Tannery Industrial Estate on 200 acres in Savar's Hemayetpur area, after moving all tanneries from the capital's Hazaribagh to prevent pollution and protect the Buriganga river.

According to Department of Environment data, the central effluent treatment plant of the estate has the capacity to treat around 25,000 cubic metres of liquid waste every day.

But the tanners generate around

That means 15,000 cubic metres of untreated waste are now being dumped into the Dhaleshwari river.

The estate also does not have the facility to treat solid waste, including heavy metals and chromium, which is also dumped into the Dhaleshwari.

Around 1.60 lakh cubic metres of solid waste have been dumped into the river

over the past three years.

In November, 2021, the environment ministry agreed to the watchdog's recommendation to shut down Savar Tannery Industrial Estate immediately, as the estate has been running without the environmental clearance for the last 10 years and lacks facilities to treat its liquid

parliamentary standing committee's recommendation.

However, the JS body said they are not satisfied with the BSCIC's reply.

A nightmare far too long

Two years of living in the age of Covid

Around 19.48 lakh confirmed cases and 29,096

What began on March 8, 2020, continued to haunt the country for two long years. In the last two years, for what feels like a nightmare way too long, 6.29 million lives were claimed across the globe. The country, since then, has witnessed three waves of the Covid-19. With 74 percent of its population recently vaccinated, the fear and uncertainty have faded. No restrictions on movement are currently at play.

However, health officials, as well as public health experts, think that the threat is still looming like a recurring shadow.

In the past seven days till yesterday, the daily average number of fatalities caused by the virus was more than seven, with 446 reported cases.

"Omicron's higher transmissibility has led to the final stage of the pandemic. However, chances are high that a new variant would cause a fresh spike," Prof Ridwanur Rahman, a specialist on infectious disease, told The Daily Star yesterday

However, Prof Rahman also thinks that any new variant will not be severe due to massive vaccine coverage. "If the virus stays with us like normal flu, we have to accept it and prepare for yearly vaccination."

So far, the WHO has identified five variants of the virus as causes of concern. "Many are assuming that Omicron has less impact. The virus, on the other hand, is mutating," said Prof Robed Amin, spokesperson of the DGHS, during an online briefing on Sunday. **THE FIRST STRIKE**

"Today we are unable to say what we had been saying until now. We have found three patients...'

These were the words of the then IEDCR director Prof Meerjady Sabrina Flora on March 8, after the first detection of Covid-19 cases in Bangladesh. The

announcement came 68 days after Wuhan Municipal **Health Commission** in China reported the first cases of Covid-19 to the WHO.

Since then, infections multiplied, the number of deaths increased with every passing day and the pandemic laid bare the vulnerability of the

country's healthcare system. The country has so far witnessed five spikes in Covid-19 cases. The first one -- caused by the Alpha variant -- struck during May-June in 2020, while the second one during November-December the same year -- caused by the Beta variant -- was milder. The third one struck during March-April last year, but the fourth and the deadliest one occurred during July-August the same year -- caused by the Delta variant. The fifth one was the least destructive during January February this year, caused by Omicron variant. DELTA: THE DEADLIEST EVER Despite lockdowns enforced on July 1 last year,

Dr Abu Jamil Faisel, member of Epidemiology and Public Health Expert Committee at the DGHS, told The Daily Star yesterday, "We have seen that the transmission had risen following stable situation earlier. So we're not out of danger until the virus is eliminated from the world."



Talking to The Daily Star, Assistant Commissioner (AC) Ashraful Alam of Sitakunda Land Office said, "Some pieces of land were grabbed in Jungle Salimpur area, and the matter is now pending in court. We have nothing to do about right now."

According to two recent studies conducted by Chittagong University and Bangladesh Agricultural University, Chattogram had around 200 large and small hills near the city and its adjacent areas. Over the last two decades, half of them have been razed for residential and commercial purposes.



What's strange is that this Yasin is nowhere to be found. His or the samity's contact

number has not been made available anywhere, with the samity's local agents doing all the dealings. His offers, however, are very much there.

New ownership will be offered for Tk 7 to 12 lakh per plot. And the cherry on top is that fighting over ownership in court is

wander. In fact, the whole area surrounding Bayezid Bostami-Faujdarhat Link Road has seen a surge in such projects in recent vears.

The only problem is that these are hill areas, where constructing such structures is completely illegal without the right permits in the first

While talking to this correspondent, Mofidul Alam, director (Chattogram division) of Department of Environment (DoE), informed that Arefin Nagar and its surrounding area is listed as khas land.

He said he has visited the site after learning about how hills are being cut there. Authorities have agreed to strengthen monitoring activities in a meeting presided over by the divisional commissioner on February

District Commissioner (DC) Mohammed Mominur Rahaman, however, said he was not aware of any housing project in the area. Had there been any such incidents, they would have taken action.

"We entered Palanca in Moldova around 12:20am on March 6 and arrived at the Moldova-Romania border around 5:30am. We crossed the Romanian border around an hour later and reached the hotel in Bucharest around 1:00pm,"

Boy, 11, travels 1,200km alone

A boy has arrived safely in Slovakia after travelling some 1,200km (750 miles) from eastern Ukraine with no more than two small bags, a passport and his relatives' phone number.

Hassan, 11, left his home in Zaporizhzhia because his mother could not leave her elderly mother.

She put him on a train, and when he finally got to the border he was helped across by customs officers. Officials said he was a true hero and had won over everyone with his smile.

The boy arrived at the border carrying a plastic bag, a small red backpack and his passport. He was taken in by volunteers who gave him food and a drink while border officials got in touch with relatives in the Slovak capital Bratislava.

His mother, in a video posted by Slovak police, thanked everyone for taking care of her son.

What is the Z symbol?

AGENCIES

First spotted on the side of Russian tanks and military vehicles amassing on the border with Ukraine, the letter "Z" has since become the main symbol of public support for Russia's war in Ukraine. Following the February 24 invasion, government supporters have used the letter, which does not

exist in the Cyrillic alphabet used in Russia, to show solidarity with the armed forces fighting in the neighbouring

There have been various theories put forward since Z was first seen emblazoned on military hardware, alongside other letters, including V and O.

The most popular theory used by military experts to explain the letters is that they were written according to the respective areas where the Russian troops are usually stationed, with Z potentially standing for Zapad (west).

The Russian defense ministry itself has not commented on any of the theories, and instead posted on its Instagram channel that Z meant Za pobedu ("for victory") and V stood for "power of truth".

Covid toll hits 6m

Over six million people have died worldwide from Covid-19 since the pandemic began, according to a tally from official sources compiled by AFP vesterday. A total of 6,001,585 people have succumbed to the virus, AFP counted at 0900 GMT. The milestone comes as the number of infections and deaths continues to plummet in most regions of the world, except in Asia, where Hong Kong is suffering its worst-ever outbreak, and Oceania, where New Zealand has recorded a jump in cases. Average global daily deaths over the past seven days have fallen to 7,170, down 18 percent in a week.

Bachelet to visit China in May

AFP, Geneva

The UN rights chief Michelle Bachelet yesterday announced that she will visit China in May, with her team heading soon to Xinjiang, where Beijing stands accused of serious abuses, to prepare. Rights groups say that at least one million mostly Muslim minorities have been incarcerated in "re-education camps" in Xinjiang, a far-western region where China is accused of widespread human rights abuses including forced sterilisations of women and forced labour. Beijing vehemently denies all such charges.


Pak opposition rally to oust PM

Thousands of Pakistani opposition party supporters yesterday rallied to demand Prime Minister Imran Khan's ouster, accusing him of mismanaging the economy and poor governance, in the toughest challenge he has faced since taking power in 2018. The opposition campaign, led by the Pakistan People's Party (PPP), raises the prospect of political turmoil in the nuclear armed nation. "Resign in 24 hours and face us in an election," PPP leader Bilawal Bhutto Zardari told a rally just outside the capital Islamabad, directing his comments at Khan The opposition later submitted a formal request requiring Khan to seek a parliamentary vote of confidence. The opposition needs a simple majority of 172 and says it requires just 11 more votes to force Khan out in such a vote. The speaker of the lower house must now convene parliament within two weeks.

Dishonest traders, ready excuses

Strict monitoring, legal measures can keep prices in check

E, in Bangladesh, are used to the whims and greed of the dishonest traders and businessmen, particularly those who deal in food items and other consumer goods. They never miss a chance to raise prices on ever so flimsy grounds, like an odd thunder shower or a wildcat strike by transport owners. We have often seen prices of fast-moving consumer items go up, in spite of adequate reserve and normal demand. Unfortunately, in a sellers' market, consumers are captive to the syndicate's machinations that dictate the supply of essential goods. Regrettably, the administration, despite assurances, have not been able to rein in this wayward group of traders who continue to call the shots and dictate prices at will.

Noticeable is the disturbing fact that prices of food items go up before every Ramadan. Admittedly, demands during the fasting month go up considerably, but actually seldom outrun the supply. And unlike in other countries, where economic laws are allowed to function, in Bangladesh prices that go up once never come down with the demand curve flattening out. And this has much to do with the state's inability to make the market mechanism function as per its natural manner.

It is therefore, disquieting, though not surprising, to see that the prices of essential goods are going up once again. It was not unexpected, with Ramadan less than a month away, but the added excuse at the disposal of the traders is the ongoing Russo-Ukraine war. Admittedly, the conflict will have an effect on the market—to a greater or lesser degree—but it defies logic that the war has been going on for hardly a fortnight, and waves have already reached our shores. Are we to believe that our stock position is so poor that it can't withstand an erratic market for a short time? Experts disagree that the war is the cause. They believe that the lag time for the effect of the current conflict between Russia and Ukraine is at least three weeks. Indeed, the pandemic had disrupted the supply chain, but the rise in prices in Bangladesh has been much more than the international prices.

The real cause is the unmitigated greed of a section of traders. It is, therefore, immoral—and illegal—on their part to exploit the situation and milk the consumers. How do the traders account for the hike in cost of even those items that have not been imported from these two countries in the last eight months? We believe that the administration at the central as well as the local level should start monitoring the market strictly, instead of dispensing homilies to the traders and consumers. Dishonest traders must be brought to account and hoarding must be dealt with severely. At the planning level, all the steps of supply chain management should be strictly conformed to, to offset the consequences of supply disruption.

Don't make women jump through the hoops

Provide collateral-free loans to female entrepreneurs

ESPITE having a good track record of utilising bank loans and paying interests on time, women entrepreneurs in Bangladesh still have to circumvent various stumbling blocks while seeking loans from financing institutions. It is unfortunate that despite being important players in the overall economic growth of the country, neither the government nor financial institutions have taken effective initiatives to simplify the loan sanctioning process. For entrepreneurs and businesswomen to stand on their own feet, we need to remove the unnecessary hassle and encourage them to dream big—not be burdened by bureaucracy.

At a roundtable titled "Financial Inclusion for Women's Economic Empowerment," organised on the occasion of International Women's Day, women leaders and researchers asked the pertinent question: When thousands of crores of taka are plundered every year by male sharks, and bad loans are increasing at an alarming rate, why is it that women entrepreneurs have to meet stringent requirements to get loans of even small

Admittedly, the Bangladesh Bank in recent times has undertaken some positive initiatives to ensure financial inclusion of women. According to a circular issued by the central bank in 2019, 10 percent of the banks' total disbursements to the cottage, micro, small and medium entrepreneurs (CMSME) must be to women, and the percentage is to be raised to at least 15 percent by 2024. At the same time, the size of Bangladesh Bank's own source fund named "Small Enterprise Refinance Scheme" has been increased from Tk 850 crore to Tk 1,500 crore to include more women. Furthermore, to face financial challenges during the Covid-19 pandemic, the government declared stimulus packages of Tk 20,000 crore for the CMSME sector.

However, the latest Bangladesh Bank statistics show that women entrepreneurs received only 3.78 percent of the banks' total disbursements to CMSMEs. It is apparent that policies alone will not be enough to bridge the gap, when women are being barred from accessing the loans, because they lack the long list of official documents

needed to be eligible for the loans.

Sociocultural constraints, patriarchal mindsets, lack of control over decision-making processes, and low digital-technology literacy are some of the reasons holding women back from financial inclusion. Giving due recognition to the fact that their collective contribution would largely boost the country's economy, the government should formulate time-befitting womenfriendly financial policies. We believe that collateral-free bank loans, if introduced, would attract more women to start their own enterprises and become successful employers in the long run.

Only reduced costs can end migrants' exploitation

REZAUL Mia from Tangail spent about Tk 4.5 lakh, which he acquired through a loan, to get a labourer's job in Saudi Arabia last year. He paid most of this money to the local intermediary who processed his recruitment. Rezaul earns less than Tk 25,000 per month, and he does not know when he will be able to finish paying off his debt.

There are more than 700,000 migrant Bangladeshi workers who can relate to Rezaul's situation. Every year, Bangladeshis leave home for abroad to change their destiny. Currently, there are over 10 million Bangladeshis working abroad. Every year, they send an estimated USD 20 billion in remittance, which is six times higher than the total foreign aid the country receives, and it constitutes at least eight percent of the GDP. Last year alone, they sent over USD 22 billion in remittance to Bangladesh.

Whenever I describe Bangladesh to foreigners, I tell them, "It is a country of 'EFG,' where 'E' stands for expatriate workers, 'F' for farmers, and 'G' for garment workers." Thanks to the migrants, Bangladesh now has a foreign exchange reserve of more than USD 43 billion. But despite these contributions, our migrant workers are exploited both at home and abroad. Most of the problems they face are linked with high migration costs.

According to the World Bank and International Organization for Migration (IOM), the cost of labour migration from Bangladesh is the highest in the world, but compared to that, the income of Bangladeshi migrant workers is the lowest. The Bangladesh Bureau of Statistics (BBS) conducted a large-scale survey on the cost of migration from Bangladesh in 2020, which revealed the same fact.

According to the BBS survey, male workers spend around Tk 4.71 lakh each on average, while female workers' recruitment costs Tk 1 lakh to migrate to their countries of employment. The report says Bangladeshi workers need nearly 18 months on average to recover their migration costs.

Why is the cost so high? Because of the recruiting agencies, middlemen, and fraudulent agencies who purchase and sell visas at high prices. The migration process in Bangladesh is still driven by middlemen, who charge hefty amounts for their services. Visa trading is also a common practice where several middlemen are involved in illegal selling and buying of work visas, ultimately increasing the cost of migration.

The problem is the same in the destination countries. Once migrant workers reach there, they often face

harassment in different forms, such as inhumane workload, dire living conditions, exploitation or abuses because of the high migration costs.

Though the government has fixed the migration cost for 14 countries at a maximum of Tk 1.66 lakh, in almost every case, job-seekers have to pay way more than that. According to the BBS report, the cost of migration to Singapore is Tk 5.74 lakh, Saudi Arabia Tk 4.36 lakh, Malaysia Tk 4.04 lakh, Qatar Tk 4.02 lakh, and Oman Tk 3.08 lakh.

The problem is so severe that Prime Minister Sheikh Hasina recently mentioned the high migration costs at a cabinet meeting and asked the relevant officials to deal with these issues and stop the exploitation of migrant workers.

How can the migration costs be reduced? Of course, awareness has a role to play, but first of all, the entire migration process must be digitalised. See, most of the recruiting agencies are in Dhaka. If a worker from Tangail wants to go abroad, he has to go to a middleman in his area. This needs to be addressed.

Registration on a digital platform can be a good alternative to middlemen. If anyone wants to go abroad, they would have to register, and the digital platform would create a functional database according to their skills. Then the agencies can hire potential migrants according to their skills listed in the database.

Of course, this is not a new idea. According to the Overseas Employment and Migrant Act, this should have been initiated in 2013. The recruiting agencies always complain that they don't find qualified workers from the database of the Bureau of Manpower, Employment and Training (BMET), so they have to depend on middlemen. BMET says it is currently trying to make a strong database through an app, and such a digitalisation process can reduce the migration cost.

On the other hand, those who are going abroad from Bangladesh are not very conscious, and they want to go at any cost. This practice is dangerous. Before going abroad, everyone should calculate how much money they can earn and what their migration cost is. The government, NGOs and other stakeholders can work together to make people aware of the risks and consequences before they decide to go abroad.

Another big reason for the high migration cost is unskilled labour. Potential migrants from Bangladesh are ready to pay much higher costs, rather than spend a little portion of that on skills training. Skills training must get priority. Particularly, after Covid-19 and due to the Fourth Industrial Revolution, there is a huge demand for skilled workers. We have to start preparing for that now.

To reduce migration costs, there is no alternative to strong government monitoring. The government can fix realistic migration costs. Migration costs are mostly divided into three parts. The first consists of various government fees, such as registration fees, welfare fees, smart card fees, etc. These costs are fixed no matter where the workers go. The second type of cost varies from country to country, such as visa fees, work permit fees, attestation fees, etc. The last part includes costs like airfare, which can always change.

However, for ethical recruitment, rather than fixating on the migration costs, we must also be vocal about employers' pay models. If there is a need for an employee, it is the responsibility of the employers to bear the recruitment costs. To establish this, negotiations need to take place globally.

Admittedly, there are many achievements in the country's migration sector, and the government has taken various positive initiatives. But there is still a long way to go, especially to reduce the migration costs, and it is never possible without all the stakeholders working together. We must understand that if the migration cost is not reduced, the problems that our migrant workers face will never end.

Another, more recent development under the CVF and V20 Joint Multi-Donor Fund has been the beginning of a new funding window to support the communities suffering the climate impacts in CVF countries, and get support to address the impacts of climate change after they have occurred. As the world has now entered the new era of loss and damage, the CVF and V20 fund is now the first UN fund to explicitly work on climate-related loss and damage.

It is important to note that the finance ministers are not involved in the climate change negotiations under the United Nations Framework Convention on Climate Change (UNFCCC), but they have to seek the money needed to cope with climate disasters such as floods, cyclones and droughts. Hence, they are by now well aware of the adverse impacts of climate change in their respective countries. They have, therefore, agreed to set up their own loss and damage fund under the CVF and V20 fund—a programme of assistance to the victims of climate change that welcomes contributions from others in the spirit of solidarity, and without invoking any liability or compensation.

It is expected that this loss and damage fund and other programmes of the CVF and V20 can kick-start both funding and actions to address loss and damage from climate change, which might have a positive influence on the upcoming discussions on setting up a facility for financing loss and damage at COP27, set to be held in Egypt in November this year.

HE Climate Vulnerable Forum (CVF) was launched over 10 years ago, by then President Mohamed Nasheed of the Maldives, and has been operating since then with a different head of government in charge of it for a two-year tenure

The current chair of CVF is Prime Minister Sheikh Hasina of Bangladesh, whose term is scheduled to end later this year, and the president of Ghana will take over the position. However, Bangladesh's involvement with the CVF will continue for two more terms as a member of the governing troika of past chairs who continue to support the current head of the forum.

The CVF consisted of 48 member countries when Bangladesh took charge, and has now grown to include 55 developing countries after Prime Minister Sheikh Hasina led the group at the 26th Climate Change Conference (COP26) in Glasgow, Scotland last year.

Over the years, the CVF has become a leading group of countries tackling climate change, and has evolved from emphasising their vulnerability to highlighting their resilience. And now, under Bangladesh's leadership, it is focusing on climate prosperity with the development of Climate Prosperity Plans, and with Bangladesh set to release its Mujib Climate Prosperity Plan (MCPP).

Another major development that took

taken by the CVF finance ministers was the creation of the CVF and V20 Joint Multi-Donor Fund, with an initial funding from the CVF countries themselves, and then further contributions from international foundations and the government of Germany. The fund is managed by the United Nations Office for Project Services (UNOPS) on behalf of the CVF and V20.

The V20, with support from the fund, recently initiated a major programme with a 21-million-euro contribution from Germany to join the InsuResilience initiative to provide support for subsidised

"The church is closely tied to the current government. There is mounting hostility (towards) its ruling class because of its ostentatious consumption, luxury, power, and repression. People feel that the church has become obsessed with earthly goods. This is risky because sooner or later, power will change hands," said a Russian political scientist in an email exchange.

Risky as it may be, many in the Balkans fear that the church could help make Bosnia and Herzegovina one of Putin's next targets, should he subdue and maintain control of Ukraine.


"Russia sees the Balkans as Nato's soft underbelly where they can foment chaos and create a mess," said Bosnian journalist and scholar Harun Karcic.

Noting that church support was a prerequisite for electoral success in countries like Serbia, Greece, Montenegro, and Macedonia, Karcic asserted that "whatever happens in Ukraine will not stop in Ukraine. Bosnia will likely be one of the next countries of interest."

The journalist-scholar described Milorad Dodik, the Serb member of the tripartite Bosnian presidency, as "a major Russian player who is a great supporter of the Russian Orthodox Church... Here we have a full Russian proxy who is a very public fan of the Russian Orthodox Church, who effectively controls half of

Last year, Dodik put Bosnia on tenterhooks, pulling Republika Srpska, the Serb constituent element of the country, out of key government institutions, including the military, the judiciary, and the tax administration. The move threatens to destabilise Bosnia, almost three decades after it was founded on the ashes of a bitter ethnic and

sectarian war. Dodik is in good company. Serbia itself has emerged as a potential monkey wrench in the Balkans by breaking with Europe and refusing to close its airspace to Russian flights. Moreover, Air Serbia has doubled to 15 from seven the number of weekly flights it operates from Belgrade

in part by asserting that President Volodymyr Zelenskyy's government had been preparing for the "destruction" of the Ukrainian Orthodox Church.

The Russian president was referring to that part of the church that remained loyal to the Moscow Patriarch after the Ukrainian church in 2018 declared itself independent. Unwittingly, Putin may have been acknowledging that all may not be well in the church—at least not from his perspective.

Choosing his words carefully, Metropolitan Onufriy, the head of the pro-Moscow wing of the church, called for an end to the fighting.

"Forget mutual quarrels and misunderstandings and ... unite with love for God and our Motherland," Onufriy

The metropolitan's call contrasted starkly with maximalist remarks by the Moscow church's patriarch, Archbishop Kirill, a staunch supporter of Putin. "When I say 'Russian,' I use the ancient expression from 'A Tale of Bygone Years: Where from has the Russian land come, the land which now includes Russia and Ukraine and Belarus and other tribes and peoples," the patriarch said.

In his war, Putin's notion of religious fault lines amounts to drawing a landscape in which much of the terrain is covered and out of sight.

Putin would have less of a problem with the repression, becoming known

in powerful Evangelist communities in the United States, it could undermine empathy for Putin as a conservative defender of family and traditional values.

"Moscow sees religion as a key front in the battle to control both Crimea and Donbas and to project influence into the rest of Ukraine," said John E Herbst, a former US ambassador to Ukraine.

Similarly, largely unnoticed in the discussion about Ukraine are demographic concerns among Russian nationalists and the Orthodox church. Demographers predict that, with birth rates declining among ethnic Russians and increasing among Muslims, Islam







The slow, painful death of BAIN LOOM

We have no

We have no project for weavers. The bain-loom industry is in danger of extinction in absence of patronisation for its immediate revival.

The back-strap handloom, popularly known as "Bain" loom, is a centuries-old textiles craft of the indigenous people of Khagrachhari district. But faced with continuous aggression from the power-loom industry, weavers are being compelled to leave their ancestral profession.

In addition, the high price of raw materials, coupled with the low-cost of finished products, has made the situation worsen over the years.

According to Bangladesh Handloom Board, around 12,000 looms have shut down in the district in the past 30 years.

Even in the '90s, there were as many as 40,000 looms in the district, which has now come down to 28,000.

According to sources, many traditional weavers have been compelled to switch crafts after incurring huge losses over the years.

For example, there were more than 100 looms in Dhumnighat area of Sindukchhari, but that number has now come down to 50, said Dahen Bikash Tripura, a resident at the area. "Once upon a time, the knocking sound of the loom was heard day and night across Dhumnighat. But we're past those days now."

nys now." He said many of the traditional weavers have now switched to jhum cultivation.

During a recent visit to the area, this correspondent saw weaver Maryam Tripura spinning yarn and running the loom to make traditional Thami.

"I have a passion for our traditional Bain-loom industry. Whenever I find time after finishing my studies, I start running the loom in my own bid to keep the industry

alive," she said.

She said weavers don't get much profit anymore due to increase in raw material prices.

"A loom-made winter blanket is sold at Tk 600 to 700. But to make the blanket, we have to buy wool for around Tk 450 to 500," said Maryam Tripura.

Besides, lack of capital and problems related to marketing and distribution were

also behind handloom sector's gradual downfall, said Pranab Kumar Das, liaison officer of Bangladesh Handloom Board of Khagrachhari.

The government trains a small number of weavers every year, which is much less than the demand. In 2022, only 30 weavers will be trained, sources said.

Shapla Tripura from Khagrachari has been working in the weaving industry for 15 years. She received the Joyeeta Award for her work for the bain-loom industry.

She has a Bain Textile outlet in Khagrachhari city. "Before, we used to weave 30 to 50 pieces. Now, we get no more than five or six orders a month," she lamented.

She said in order to sustain this industry, marginal entrepreneurs have to be given benefits

Md Mainuddin, coordinating Officer of Bangladesh Small and Cottage Industries Corporation of Khagrachhari, told The Daily Star, "We have no project for weavers. The bain-loom industry is in danger of extinction in absence of patronisation for its immediate revival."

According to the Handloom Census 2018, carried out by Bangladesh Bureau of Statistics, there were 116,006 handloom units in the country, which is a 36.79 percent fall from 2003, when there were 183,512.

Household waste stinks up the city

CCC's door-to-door garbage collection programme in shambles

Among the many problems that consume a metro, the one that has become a headache for port city dwellers is poor waste management.

Residents across different areas of the city are being compelled to keep domestic waste in front of their homes or adjacent roads, as conservancy workers of Chattogram City Corporation (CCC) are irregular in collecting them.

During a recent visit to KB Aman Ali Road, Ujir Ali Shah by-lane, Momin Road and DC Road areas, it was seen that household waste wrapped in poly bags were kept on the road and in front of residential buildings. "Conservancy workers used to come every day

but they started coming thrice a week since April 2020, right after the pandemic hit," said Abul Kashem, a resident of Ujir Ali Shah by-lane.

"Since January this year, they have started to come twice a week," he added.

Sources said CCC started collecting waste from door-to-door in January 2017. It distributed over 900,000 bins to the houses so that conservancy workers could collect the waste from them daily.

Over 2,000 conservancy workers were appointed on a daily wage basis under the scheme as well.

Himadri Biswas, a resident of KB Aman Ali Road, said, "The authorities have also removed the trash cans. Where do we keep the waste

This correspondent, during recent visits, saw open trash cans in many areas.

Conservancy workers were seen keeping household and commercial waste in both open and container cans at Chawkbazar Kitchen Market, Katalganj, Chatteshwari Road and KB Aman Ali

Road — causing discomfort for pedestrians. Contacted, CCC chief conservancy officer Shafiqul

Mannan Siddique said there are supervisors in every ward to look into the works of the conservancy workers.

"I will ask the supervisors. Negligence in duty will not be tolerated," said Shafiqul.

Almost 90 percent of the 1,350 open bins and 96 container bins have already been removed, informed the official. "We will remove the remaining open ones soon," he added.

Asked, Hridoy, a conservancy worker in

Baghmoniram, said the number of workers has not increased in five years. On the other hand, the population of the city has increased manifolds.

"It's not possible for workers to cover this many buildings," said Hridoy.

This correspondent could not reach the CCC mayor for comments despite repeated attempts.

Bablu Chowdhury, a sales official at Baatighar, said demand for novels and books on Bangabandhu was the highest at their stall, adding that daily sales overall was satisfactory.

Contacted, Nisar Uddin Ahmed Monju, convener of the book fair, said necessary steps have been taken for the overall security of the fair. Besides, instructions have been given to abide by the health rules. The fair grounds are under CCTV observation, he said.

The book fair will continue till March 10. A total of 95 publishers from Dhaka and Chattogram are participating at the fair. The fair is running from 3:00pm to 9:00pm every day and from 10:00am to 9:00pm on holidays.

A makeshift market for USED LIFEBOATS

Spotting used, red lifeboats parked on the canal banks beside Dhaka-Chattogram Highway at Sitakunda upazila, one might scratch their heads and ask why they're kept there. But these boats are in fact of great value, being displayed for sale.

Acquired from local shipbreaking yards, these boats have now formed a makeshift boat market in Sitakunda, which meets the local and national demand.

Depending on size and condition, the lifeboats are sold at Tk 25,000 to Tk 10 lakh each.

A lifeboat, or liferaft, is a small, rigid or inflatable boat carried for emergency evacuation in the event of a disaster aboard a ship.

Buyers across the country come to Sitakunda's Madambibir Hat, Kumira, Bhatiari, Madanhat and other areas to buy the used lifeboats for their affordability and strength, which is much better than their wooden alternative. Government and private marine fisheries, fishers, resort owners and travel agencies are their main customers.

It's noteworthy that most renowned shipbreaking yards are located in Sitakunda's seashore, where various items like kitchen tools, electronic products, antique showpieces, different machinery and stationaries taken from scrapped ships are also sold.

At first, sellers collect the used lifeboats from scrap ships. The boats are then docked on the canal bed for display

Visiting Sitakunda, Bhatiari and Kumira recently, this correspondent saw hundreds of different sized lifeboats on both sides of the canal bank. Buyers were inspecting the boats floating on the water.

Used or new motor engines are installed on the boats after they're sold. The sellers said sometimes they customise the boats as per demand.

The sellers informed that fishers are buying small sized lifeboats for their lightweight and affordable price, shifting from the use of "dingi" boats.

M/s Khaja Alam
Enterprise's proprietor

Md Didarul Alam, who's been involved in the lifeboat business for the last 29 years, said, "I started the business with two lifeboats and Tk 10,000. At first, people were reluctant to purchase them, since the demand for wooden boats were high. But after a while, the fiber boats became popular."

Monir Hossain, owner of Moonstar Enterprise, said due to high price of wooden planks, a medium to small sized boat will cost around Tk 5 lakh but one can get a medium sized fibre boat with half that price, although it carries the same volume of passengers and goods. The sellers, however, said sometimes, the boats can lay abandoned for a long time, which is one negative aspect of the business.

SA pick IPL players for **BD ODIs**

Eight South African cricketers with Indian Premier League contracts will play in a one-day home series against Bangladesh before leaving

Cricket South Africa on Tuesday named a 16-man squad for the three-match series, which is part of the

World Cup Super League. The series will be played between March 18 and 23.

The IPL starts on March 26 which means that the South African players may miss the start of the tournament because of quarantine requirements.

But it is not yet clear whether IPL-bound players will be available to play for South Africa in two World Championship Tests against Bangladesh which follow the one-day games and only finish on April 12.

Fast bowler Anrich Nortje, who has not played for South Africa since the T20 World Cup in November, remains unavailable as he continues rehabilitation following a hip injury and it appears his participation in the Tests and in the IPL is in doubt.

The only change from the squad which beat India 3-0 in January is the absence of fast bowler Sisanda Magala, who failed a fitness test.

The IPL players in the squad are Quinton de Kock, Marco Jansen, Aiden Markram, David Miller, Lungi Ngidi, Dwaine Pretorius, Kagiso Rabada and Rassie van der Dussen.

Jansen, Markram, Ngidi, Rabada and van der Dussen would all probably feature in a full-strength Test squad.

'Need to put a full stop'

Bangladesh national team's team director Khaled Mahmud struck a conciliatory tone over Shakib Al Hasan's remarks regarding him not being ready to play international cricket while making it clear that the board needs to put a 'full stop' to such situations where a senior player can pick or choose what formats he is willing to play right before a series.

Mahmud dictated that players like Shakib have given the team and the country a lot. The board is considerate of issues that players face, especially during pandemic times with bio-bubble protocols making life difficult. However, he was clear regarding what the BCB needs to do and the problems that the management faces when someone like Shakib chooses to play in particular tournaments.

'It's true that players get exhausted. Those of us who have played, know this. During our playing days, there weren't so many matches. Even I get exhausted as team director now. There is bio-bubble all day and it's just hotel and grounds. It's difficult. If we think straight, then a player can say things like that but my thinking is that Shakib could have said it sooner,"

Mahmud said. Shakib had not featured in the Tigers' Test tour of Sri Lanka in April-May last vear due to his IPL involvement. He then missed one home Test against Pakistan through injury and then opted out of the away Test series against New Zealand. This time he was initially given permission

to miss the South Africa Tests and only feature in the ODIs, but following his IPL snub, BCB president Nazmul Hassan told him to play the upcoming Test series as

Shakib had agreed to that following the ODI series but last Saturday, before he left the country, Shakib reiterated not being mentally or physically ready to play international



More confusion was added as Shakib said that it may well be that he misses the South Africa ODIs and play the

"At BCB, we want that our best available team always plays. We know we will miss Mustafizur [Rahman] in the Tests but we have accepted that he doesn't want to play Tests nowadays," Mahmud noted.

Mahmud, however, struck the same tone as BCB president had on Monday. The question of seniors not having clarity over which formats they want to play, is

hampering team management's processes regarding future stars.

"It's not a problem if Tamim or Shakib plays a series but problem is that we're playing someone instead of them but when Shakib returns, what happens to that player? We're not being able to create a team. If Shakib doesn't want to play Tests, then he shouldn't and I don't care. BCB is not concerned and can't force him. We want him to play as long as he is fit but if he says he isn't enjoying, then he should say that he doesn't want to play Tests, ODIs, T20s or that he doesn't want to play a particular format or even two formats. From BCB's side, there is the matter of establishing someone in Shakib's place."

With Shakib and others such as Tamim Iqbal, Mushfiqur Rahim and Mahmudullah Riyad nearing the twilight of their career. Mahmud was more eager for continuity of the team building process. The former national team captain made it clear that the last call on the Shakib issue rests with BCB.

"Board won't make requests; they will dictate since these are contracted players. Shakib has been given two days' time, so it's better not to say something. I am hoping he will go because it makes a difference for us at the moment. If Shakib wants to play he will go, if he doesn't, the board will take a decision. It's high time now and we need to put a full stop to it. It can't happen every time that someone doesn't want to play and he doesn't play," he concluded.

'Free speech, privacy will be imperilled'

45 groups urge BTRC to scrap draft

Forty-five organisations wrote to the Bangladesh Telecommunication Regulatory Commission to drop the draft regulations for digital and social media, and OTT platforms, saying, it "imperils people's freedom of expression and the right to privacy, undermines encryption and weakens online safety"

The organisations include Article 19, Human Rights Watch, Committee to Protect Journalists, Internet Society, Open Knowledge Foundation, Wikimedia Foundation, Business & Human Rights Resource Centre, Association for Progressive Communications, PEN America, Asian Forum for Human Rights and Development (FORUM-ASIA), The Tor Project and others.

The letter urged the BTRC to protect people's rights and freedoms and enable an open, free and secure internet in Bangladesh.

"If enforced, the regulations will have a deleterious impact on human rights, and put journalists, dissidents, activists and vulnerable communities, in particular, at greater risk," the organisations wrote.

"The Bangladesh Telecommunication Regulatory Commission Regulation for Digital, Social Media and OTT Platforms' seeks to implement a content governance framework devoid of adequate judicial oversight, clarity and predictability, and integration of human rights and due process,' the letter read

Bangladesh's position fairly balanced

Says ex-foreign secretary

Former Foreign Secretary Shahidul Haque yesterday said Bangladesh's position on the Russia-Ukraine issue was "neutral and fairly balanced" but it might require a review in the coming days.

"Neutrality may not always be the preferred path," he said as he felt the necessity for revisiting the policy when

Bangladesh is still watching how the war evolves and has apparently taken an "interim" position. "In every aspect we'll feel the impact whatever position we take."

The former foreign secretary was addressing a seminar titled "Russia-Ukraine War: Whose Profits and Whose Losses?" organised by the Centre for Peace Studies (CPS) of the South Asian Institute of Policy and Governance at North South University.

Haque said the "global military complex" will be the most beneficiary of the Russia-Ukraine war while everyone will be affected more or less, including the loss

PRICE HIKE OF ESSENTIALS

The poor plumb the depths of misery

No matter how hard Md Shaon, a day labourer, and his wife, a domestic help, work, their attempts fall short against the skyrocketing price to make ends meet for their family of five.

"Name any item -- rice, oil, vegetable -- they are getting costlier," said a crestfallen

Shaon. While Shaon is struggling to keep his head above water, he came to know that a hike in house rent is coming into effect from June.

"We don't know how we would survive in this situation," he added.

Shaon's concern is shared by a good number of people, especially the fixed income

group and those at the lower rung of the society.

The prices of oil, onion, potato, beef, mutton, chicken, flour, cardamom and sugar have increased within a week. according to the Trading Corporation of Bangladesh.

The logical price chart of the Department of Agriculture Marketing shows that the average prices of 39 daily items have shot up almost 17 percent from last year.

However, there are instances where the government rate is not reflected at the retail level, leading to long queues in front of the open market sales trucks.

One such long line was found in front of a truck in the Motijheel's AGB Colony area where over a hundred people were waiting to buy essentials.

Over at Kawran Bazar, Dhaka's wholesale hub, Monir Hossain, a resident of Moghbazar's Pearabag, was hoping to buy loose soybean oil at a low price but had to make do with palm oil at Tk 160 a kg.

"I know that the price of per kg palm oil is Tk 133 -- I was told it was an old price," he said.

The hike in soybean oil price has also had an impact on mustard oil as people are buying it as an alternative.

Within 10 days, the price of mustard oil (general quality) shot up from Tk 186 a litre to Tk 250. Last year, the price of mustard of the same quality was

Onion, which sold at Tk 40 per kg last week, now costs about Tk 70 though this is the harvesting season of the tuber.

The country has sufficient stock of edible oil to meet the demand tili kamadan, but the market remains voiatlie, said the Directorate of National Consumer Rights Protection (DNCRP).

The consumers' rights body DNCRP made the statement in a meeting with the edible oil refiners and dealers in the capital's Karwan Bazar area yesterday.

DNCRP Director General AHM Shafiquzzaman said the country had around 6 lakh tonnes of edible oil stored which was enough to meet the demand till Ramadan. Another 183,000 tonnes are on its way to

Bangladeshwhile 175,000 tonnes are waiting to be processed at refineries, he added. Referring to the stock, he said the oil was imported at

a cost of \$1,400 per tonne and the government fixed the rate in line with the price.

'So, there is no scope of oil price hike till Ramadan,"

"The current price of edible oil in the international market is \$1,900, but no one opened any LC (letter of credit) to buy it. So, why this crisis?" he asked.

He also said a blame game was ongoing as dealers were blaming the refiners for not supplying oil as per their supply order and refiners were blaming dealers for an exorbitant price.

Meanwhile, Dokan Malik Samiti President Helal Uddin urged the DNCRP to check the flow of supply in the

He doubted the DNCRP's information on stock was correct.

"Each day we need around 10,000 tonnes of supply. DNCRP and business body representatives can monitor the refineries at the mill gate."
