## OMS can't keep up with queues

Nasima Begum, in the advanced stages of pregnancy and carrying her two-yearold, was waiting for over two hours at the designated point in the capital's Kazipara Bus Stand for a TCB truck to arrive with daily essentials.

The 25-year-old defied her doctor's advice to avoid strenuous activities in her desperation to buy essentials at lower prices from a mobile shop of the Trading Corporation of Bangladesh (TCB). But the truck was nowhere in sight.

"I returned home empty-handed for the last two days. I am here again today to get some essentials. We were already struggling with daily expenses, but this time the prices have just gone out of reach," said Nasima, whose husband, a construction worker, is the breadwinner in the family.

Like Nasima, several thousand lowincome people and middle-class residents in Dhaka have been scrambling to buy essentials at different open market sales (OMS) points of the TCB.

OMS is a government price support programme for the low-income group to cushion the blow of rising food prices. The food ministry is running 1,948 OMS centres across the country -- of which 177 are in Dhaka city -- where lentil, edible oils, onion and sugar are sold at subsidised prices.

However, the queues in front of the TCB trucks are getting longer than ever with many returning home empty handed as the supply of goods remains inadequate.

Talking to The Daily Star, a number of people said their suffering was due to a flawed system.

### Ration cards a pressing need now

The demand for the reintroduction of ration cards has been growing in recent times with the continued rise in the price of essentials.

The High Court on Tuesday, in response to a writ petition, ordered the government authorities concerned to distribute daily essentials -- edible oil. onion, rice, wheat, sugar, and lentils -- among the people through ration cards under the open market sale (OMS) policy

But the OMS has proved to be too scanty to provide the support to the poor who often return emptyhanded from long queues before OMS trucks. This has prompted many,

### **EDIBLE OIL PRICES** Hike on despite the tax cuts

The prices of edible oil have gone up at the wholesale level yesterday despite the 30 percent tax exemption at the import and production stages

Amid public outcry over the spiral in the prices of edible oil, the government on March 14 waived 15 percent value-added tax at the production stage and 5 percent at the retail level. Two days later, another 10 percent VAT was cut at the import stage.

And yet, the wholesale prices of soybean and palm oils increased by Tk 200-Tk 280 per maund in a day to Tk 6,200 and Tk 5,250 respectively at Khatunganj in Chattogram.

Retailers at several kitchen markets in Dhaka were seen selling a litre of bottled soybean oil for Tk 168 while the five-litre bottle was selling at Tk 795. Loose soybean oil was not available at most of the shops in the capital yesterday.

However, data from the Trading Corporation of Bangladesh (TCB) showed that the price of bottled soybean oil has remained unchanged in Dhaka since March 14.

### 'Tear down' the new wall in Europe

### Ukraine president pleads as shelling kills dozens; Biden slams 'war criminal' Putin

Ukraine's leader yesterday charged Moscow with building a new Cold War wall across Europe "between freedom and bondage", as his government said Russian shelling had killed 21 civilians near one city.

Three weeks in to their devastating invasion, Russian forces also stood accused of bombing a theatre sheltering many civilians and marked with the word "children".

Kyiv emerged from a 35-hour curfew to new destruction, as Russian troops try to encircle the Ukrainian capital as part of their slow-moving offensive.

Beneath a Kyiv apartment block damaged by a downed rocket, AFP journalists saw a distraught man crouched over a body draped in a bloodstained cloth, after the latest in a series of early-morning attacks.

The 21 were killed when overnight artillery fire pounded a school and a cultural centre in the town of Merefa outside the hard-hit eastern city of Kharkiv, regional prosecutors said.

In besieged Mariupol to the south, searchers were combing through the smoking rubble of the Drama Theatre where more than 1,000 civilians had been sheltering in a basement bomb shelter, and Ukrainian officials said that Russian shelling was continuing.

Kremlin denied it had targeted the theatre, and also rejected an order by the top UN court to halt its Ukraine invasion.

President Volodymyr Zelensky yesterday addressed the German parliament a day after a speech to the US Congress, when he secured \$1 billion in new US military aid, including Stinger anti-aircraft missiles used against Soviet forces in Afghanistan.

Zelensky reached back to that Cold War era as he drew on a 1987 speech in Berlin by US president Ronald Reagan: "Dear Mr Scholz, tear down this Wall," he implored German Chancellor Olaf Scholz

### 18 Teknaf fishermen still missing

Eighteen fishermen, who went missing from the Naf river in Cox's Bazar's Teknaf upazila on Tuesday, remained traceless till last night.

According to their family members, they were detained by the Border Guard Police (BGP) of Myanmar, a claim that could not be verified.

A local fisherman, who claimed to be a witness, said the fishermen were returning to Shah Porir Dwip after catching fish. A BGP speedboat chased them in Naikyangdia area and took them away at gunpoint.

Abdus Salam, a member of ward-9 in the upazila's Sabrang union, also confirmed that the fishermen went

Contacted, Teknaf Upazila Nirbahi Officer Parvez Chowdhury said the matter was reported to Border Guard Bangladesh (BGB).

Also, the local administration distributed food and gave financial assistance to the victims' family members, he added.

Talking to this newspaper, BGB-2 Commander Lt Col Sheikh Khalid Mohammad Iftekhar said they sent a letter to the BGP asking if they detained the Bangladeshi fishermen.

However, they have not received any response as of 10:00pm.

## PM vows to build a beautiful future for kids

She reiterated that her government's

Hasina said though there had been a reign of killers, war criminals, Al-Badr and Razakars (collaborators of Pakistani forces) in the country after the assassination of her family members, she returned home to fulfill the dream of his father.

A Chhatra League leader was stabbed to death by a group of unidentified criminals in Rangamati town on early yesterday.

Joy Tripura was attacked just as he walked out of Rangamati General Hospital in Debashish Nagar after visiting a patient around 2:00am, said Kabir Hossain, OC of Rangamati Kotwali Police Station.

The attackers stabbed him in front of the hospital gate and fled. He was immediately taken back inside the hospital, where emergency doctors declared him dead, he said, adding that an investigation was underway.

He added that they have given names of some suspects to the police.

### Man found alive inside sack dumped in river

A man was found alive inside a sack in the Sati River in Lalmonirhat's Sadar upazila yesterday

Shaha Alam, OC of Sadar Police Station, said they were yet to find out why Jahid was stuffed inside a sack with his hands legs tied and left to die.

Eyewitness Kartik Kumar Acharya, assistant head teacher of Saral Khan High School, told the Daily Star, that he was on his morning walk when he noticed a full sack in the now-shallow river.

He and other locals caught the sack, found Jahid unconscious inside and immediately contacted police, who sent the victim to hospital.

Dr Kamrul Hasan Prince, resident medical officer of Lalmonirhat Sadar Hospital, said Jahid was possibly anaesthesised when he was found. "He is healthy now, but it will take time for him to recover completely."

OC Shaha said police are now waiting for Jahid oget better so that they can talk to him further investigate the incident.

### Belarus slammed at UN for OMS can't keep up with queues abuses, invasion role

Diplomats at the United Nations yesterday voiced outrage over Belarus's widespread human rights violations at home, and also for "enabling" Russia's invasion of

At the UN Human Rights Council in Geneva, a wide range of countries decried Minsk's role in supporting Moscow's war against its pro-Western neighbour, which began on February 24.

US Ambassador Michele Taylor called out authoritarian Belarus leader Alexander Lukashenko for the "enabling of Russia's unprovoked war".

"The Belarus authorities' facilitation of Russian aggression has contributed to an unconscionable humanitarian toll on the people of Ukraine... and to a dangerous crisis which could irrevocably harm global security and that of every sovereign state," she told the

else, he added. The government can

also give cash support to the vulnerable people as it did during the lockdown, he said. Food Minister Sadhan

Chandra Majumder said the authorities have already increased the coverage area of OMS programme. "We will not increase it further as the same person

Muhammad said the ration system was first introduced in the sub-continent during the British rule centring the famine in 1943. After the partition in 1947, both India and Pakistan continued the ration system. He said, after the Liberation War in 1971, Bangladesh continued it to support the people of the

war-ravaged country. "During the famine in 1974 when the price essentials increased hugely, people from lowto middle- income families were heavily dependent on rations," he said.

A person could purchase a certain amount of food

and oil once a week round the year under the system. "The quality of rice

and wheat was bad at that time. Besides, many dealers became rich by selling ration products in the black market," he said.

Despite irregularities, the number of deaths in famine could have been several times higher than its actual figure without the ration system, added Anu Muhammad.

An estimated 1.5 million people died in the 1974-75 famine. He said the initiative to

cancel the rationing system, which was very effective in controlling food price hikes, started in the late 1970s with the prescription of USAID and World Bank, and finally it was abolished at the beginning of the 1990s.

### Abul Mansur Ahmad's 43rd anniversary of death today

Today is the 43rd death anniversary of Abul Mansur Ahmad, a renowned litterateur, journalist, and politician of the sub-continent. He died in 1979.

One of the greatest satirists of Bangla literature, he was also a pioneer of modern and progressive journalism. He worked for prominent newspapers such as Krishak, Nabajug, Sultan, and Mohammadi, and was editor of the Kolkata-based Daily Ittehad from 1946 to 1948.

### 'A threat to freedom of expression'

#### Tech companies, rights bodies slam draft rules on social media

The new draft social media regulation poses a threat to freedom of expression, said Global Network Initiative (GNI), a collective of top tech companies and rights bodies of the world.

The collective's members include Meta, Microsoft, Uber, Zoom, Telenor Group, Yahoo, Google, Nokia, Vodafone, Verizon, Human Rights Watch, Wikimedia, Committee to Protect Journalists and more.

GNI made these remarks in a letter sent to Bangiadesn Telecommunication Regulatory Commission on March 9.

"We are concerned by the very broad scope of the bill, from the companies and content it covers, to the significant, oftenvaguely defined obligations and enforcement authorities, to potential 'traceability' and datasharing provisions that may infringe on privacy rights," said the letter.

The statement expressed alarm at the fact that the regulation includes a "sweeping range of content and conduct that intermediaries

### Used as a field for 50 years, Tetultola now on way to becoming a police station

At first glance it may not seem like much: a small piece of land, devoid of greenery or any sort of facility. But to locals, especially children, the Tetultola playground has always been a place to escape from the daily grind of life.

But the same place that was full of frolicking children even two months back, a place that has welcomed all for the last 50 years, is now surrounded by barbed wires.

On January 31, Dhaka deputy commissioner's office handed over the playground's land to Dhaka Metropolitan Police (DMP) to set up an establishment for Kalabagan Police Station, which is currently located at a rented place on 30 North Road.

Amid a dearth of open spaces in the capital, this is yet another example of how the city dwellers are continuing to be deprived of playgrounds and parks.

However, residents refuse to give up hope to retain the playground. For several months, they've been demonstrating with the demand keep it as it is, for the sake of children.

Over the years, Tetultola playground, which covers around one bigha of land, has been in use in multiple ways. It has acted as a playground, an Eidgah, and a place for namaz-e-janaza.

"There is no other place for our children to play. We've been playing in the field for the last 50 years," said Syeda Ratna, coordinator of Tetultola Math Rokkhya Andolon.

According to Kalabagan resident Masud Mahbub Shamim, a former engineer of DIT used to own the land. After he left the country, it was recorded as abandoned property through the then president's order, following the Liberation War. It then came under the housing and public works ministry.

After the place was announced abandoned, different people and

groups tried to grab the land using fake documents, but each of their ploys was foiled by locals, Shamim added.

On behalf of locals, Shamim even wrote a letter to the prime minister on January 20, 2014, requesting her to save the land from grabbers. Following the letter, the premier had directed authorities to look after the matter, he

### Bangladesh should respond to **UN concerns**

#### Says HRW on human rights

STAFF CORRESPONDENT

Human Rights Watch (HRW) yesterday urged the government to meaningfully respond to United Nations' concerns regarding grave allegations of torture, enforced disappearance, and extrajudicial killings in the country.

The US has already sanctioned the country's Rapid Action Battalion (Rab) under the Global Magnitsky Human Rights Accountability Act for serious rights violations and should be excluded from UN peacekeeping deployment, the New York-based human rights organisation demanded in a report published on its website.

On March 3, the UN Office of the High Commissioner for Human Rights urged the government to follow through on its commitment to respond to allegations of torture reported during a 2019 review of its obligations under the Convention against Torture.

That same day, during a meeting with UN Secretary-General António Guterres, Foreign



Abul Mansur Ahmad was the author of the Ekush Dafa (21-point programme) election manifesto of Jukta Front in the 1954 election through which the Muslim League was ousted from

The Ekush Dafa was the first comprehensive articulation of the political, economic and cultural demands of the Bangalees of the then eastern part of Pakistan.

He was elected a member of East Bengal Provincial Assembly in that election. and served as health minister in the United Front cabinet under Shere-Bangla AK Fazlul Huq. In 1955, he was elected a member of Pakistan Constituent Assembly.

He was the minister for education in the United Front government of East Pakistan in 1956 and the minister for commerce and trade in 1956-1957. After the promulgation of martial law by Ayub Khan in 1958, he was imprisoned and subsequently released in 1962.

He then retired from politics.

Abul Mansur Ahmad known for his strong stand in favour of regional autonomy of East Pakistan. He also made remarkable contributions industrialisation of the long neglected East

secularism in a manner unparalleled in the forties,

Ahmad's publications include great satires like "Aina", "Asmani Purdah", "Gulliverer Safar Nama" and "Food Conference". He also penned insightful works on social and political history of Bengal such as "Bangladesher Culture". He has two autobiographical writings -- "Atma Katha" and "Amar Dekha Rajnitir Panchash Bachar".

appropriate UN guidance, for all military and police personnel proposed for deployment in UN peace missions and ensure that no person or unit implicated in the commission of torture, extrajudicial killing, disappearances or other serious human rights violations is selected for service."

However. the government not demonstrated any efforts to improve vetting, and instead is seeking more senior UN peacekeeping positions for its police and military personnel, HRW claimed.

HRW added, government has not responded to repeated requests by the UN Working Group on Enforced or Involuntary Disappearances to visit Bangladesh, first sent on March 12, 2013, and most recently re-issued on April 23, 2020."

According Bangladeshi human rights groups, nearly 600 people have been forcibly disappeared by security forces since Prime Minister Sheikh Hasina took office in 2009.

While some victims have been released or produced in court after weeks or months of secret detention, others became victims of extrajudicial killings that are falsely claimed to be deaths during gunfights, HRW said.

HRW has documented 86 of these cases in which victims remain missing. The government has repeatedly denied that security forces routinely commit enforced disappearances.

## Bangladesh, WB sign \$120m financing deal

The government and World Bank have signed a \$120 million financing agreement to help improve the irrigated agricultural and fisheries production and increase the incomes of 170,000 poor people vulnerable to climate change.

The Climate-Smart Agriculture and Water Management Project will improve climate resilience by modernising flood management, drainage and irrigation infrastructures.

The project will help with climate resilient and improved irrigation, flood management and drainage service covering 120,000 hectares of land, which will reduce damage to crops from floods by 60 percent, said the

global lending agency vesterday. "Bangladesh's success is well-rooted in the agriculture sector. With a large population and scarce arable land, it is a major accomplishment for the country to achieve its level of food production today. But the climate change and increased natural disasters pose threat to food security," said Dandan Chen, acting WB country

director for Bangladesh and Bhutan. The agreement was signed by Fatima Yasmin, secretary, Economic Relations Division, and Dandan Chen on behalf of Bangladesh and World Bank, respectively.

The credit is from the World Bank's International Development Association (IDA), and has a 35-year term, including a five-year grace period.

# AMBULANCE service in trains

Railway to add 4 such cars to its fleet as part of project to procure 200 new carriages

Bangladesh Railway (BR) is on course to procure 200 broad gauge (BG) passenger carriages to meet the ongoing crisis of rail engines and expand its services by adding new trains to its fleet.

Among the carriages, there will be four AC ambulance sleeper cars as well.

Once the sleeper cars are added to the fleet, for the first time a train in Bangladesh will have ambulance facilities for ailing patients, BR sources said.

The state-run transport agency will procure the carriages under a Tk 1,704.34 crore project within June

The project, where European Investment Bank will provide Tk 1,331.20 crore as loan, is likely to be placed before the next Ecnec meeting on Tuesday, BR sources

The development comes at a time when 190 BG carriages, out of 468 (around 41 percent), are overaged, causing obstruction to train operations and improvement of passengers services, they said.

Once the new carriages are added to the fleet, it will also increase the availability of carriages and help to replace the old and overaged carriages.

Moreover, BR will be able to operate more trains on new routes to meet growing demands and increase revenue of the losing concern, the sources added.

According to project documents, of the 200 carriages, 80 will be Shovan Chair Cars, 42 AC Chair Cars, 25 AC Sleeper Cars, 16 Shovan Chair Cars with dining car and prayer room, and 26 AC Power Cars with luggage van and guard brake.

A BR official, who is well-informed about the project, said the ambulance sleeper cars will have all facilities a usual ICU ambulance provides.

Each of the cars will have such facilities for 12 ailing patients.

Huge traffic congestion on the road and providing people with improved services at a relatively low cost are the reason behind introducing the ambulance service, the BR mechanical engineer told The Daily Star yesterday.

### WHY MORE CARRIAGES?

Currently, BR has a total of 3,093km rail lines across 43 districts, of which 879.85km are Broad Gauge (BG) while 533.7km are Dual Gauge (DG) while the rest are Metre Gauge lines, according to BR's latest Information Book.

All BG lines are in the west zone.

However, the railway is currently implementing a 30-year master-plan for 2016 to 2045, divided into six

A total of 230 projects, with an estimated cost of Tk 5,53,662 crore, have been proposed in the plan.

According to the masterplan, gauge conversion to BG is to be accomplished gradually so that within 30 to 35 years, the whole track will be converted to BG as part of the infrastructure rationalisation policy, show

Additionally, the construction of Padma Bridge with rail line and dedicated railway bridge over the Jamuna river will improve connectivity between railways zones as well as with neighbouring countries, which will ultimately enhance passenger and freight traffic

Internal enhanced demand, replacement of old carriages and ensuring internal traffic handling will create a necessity of 400 BG passenger carriages within two to four years, of which 200 will be required soon, reads the document.

The number of BG carriages were 324 in 2010, out of which 114 were more than 35 years old. In 2019, the number increased to 467 and stood at 468 till October last year.

Once the 200 new carriages are added to fleet, the replaced carriages could be used in local or commuter trains, based on condition reports.

Mentionable, railway has a total of 1,203 metre gauge carriages, and at least 52 percent of them are overaged.

Monjur-ul-alam Chowdhury, additional director general (Rolling Stock) of BR, and Mohammed Kudrat-E-Khuda, chief mechanical engineer (west), who is leading the project, could not be reached over phone for comments, despite several attempts.

### 6 killed, 2 hurt in road accidents

Six people were killed and two injured in road accidents in four districts during the last two days, according to reports from our correspondents.

In Narsingdi, three people died when a bus collided head-on with a microbus on Dhaka-Sylhet highway near Morjal bus stand around 4:00am yesterday, said SÍ Khaled Mahmud of Bhairab highway Police Station. The deceased - the driver and two passengers of the microbus could not be identified immediately.

In Manikganj, a pedestrian was killed after being hit by a battery-run auto-rickshaw yesterday, said OC Riyaz Uddin Ahmed Biplob of Ghior Police Station. The deceased, Md Jalal Uddin (70), was a resident of Sribari.

In Dinajpur, two people were injured as three trucks crashed into four roadside shops in Phulbari area yesterday. Hasu Sheikh (52), one of the truckers from Pabna; and Golap Hossain (50) from Dinajpur were undergoing treatment at Phulbari Upazila Health Complex. The incident happened at Laxmipur village, said OC Md Ashraful Islam of Phulbari Police Station.

Initially, a truck rammed into a roadside shop as its driver lost control over the vehicle after one of its tyres got punctured, said the OC. Later, two other Dhaka-bound trucks hit three shops.

In Natore, a bicyclist was killed as his cycle and a human haulier collided at Moukharahat in Baraigram yesterday. Shahidul Islam (40) from Uttarpara was declared dead at a hospital.

In Kaharol upazila, Md Sultan Ahmed (40) died after a speeding truck hit his cycle at Ichhail village on Wednesday.

### **CMCH introduces** neonatal unit

With a view to providing better treatment to critical neonatal patients, the authorities of Chattogram Medical College Hospital introduced Special Care Neonatal Unit yesterday, marking the birth anniversary of Bangabandhu Sheikh Mujibur Rahman and National Children's Day.

CMCH Director Brig Gen Shamim Ahsan inaugurated the 30-bed unit established under

the Neonatal Ward at the hospital. The critical neonatal patients — aged between 0 day and 28 days - will benefit from the unit,

said doctors. Earlier, the newborns had to receive treatment with other patients at the Neonatal Ward, hospital sources said.

Tahmina Begum, who transferred her premature baby to the newly-introduced unit from a private hospital, said doctors at the private hospital suggested her to keep the baby in an incubator, which she could not afford.

"At the neonatal unit, babies like mine will get better treatment for free," she said. According to doctors, not only the newborns,

but also babies born underweight, with infection and breathing difficulties will be treated there. The unit is equipped with modern treatment

facilities -- including phototherapy, ventilator and maintenance of temperature, said the director.

Prof Dr Jagadis Chandra Das, head of Neonatal Ward, said alongside other facilities, Kangaroo Mother Care has been introduced at the unit.

Kangaroo care, also called skin-to-skin contact, is a technique of newborn care where babies are kept chest-to-chest and skin-toskin with a parent, typically their mother, said Dr Dhiman Chowdhury, a consultant at the pediatric ward of the hospital.




### Poster of Shyam Benegal's biopic on Bangabandhu unveiled

## riddled with dead fish

A new shoal covering an area of about 5,000 acres has sprung up in the deep Bay of Bengal, about 30-km south of Kuakata.

Tourists have dubbed it "Char Bijoy", after discovering it in the month of December in 2017. Due to the free movement of migrant birds and red crabs, the shoal has started attracting seasonal tourists, who mostly come from Kuakata on trawlers and speed boats.

Patuakahali Forest Department has already started planting 1.5 lakh trees in the shoal. Thousands of tourists have visited the shoal this season to enjoy the natural beauty and they are still coming.

Although it remains submerged in the rainy season, it resurfaced in the winter with an area of 5,000 acres.

Fishermen stay here and in the vicinity during the winter

season to catch fish including hilsa. They make temporary shelters for fishing and drying up the fish. Due to the less movement of people, guest birds flock here in winter. Host of red crabs and guest birds are adding a new dimension to the beauty of the shoal.

Some seasonal tourists come here from Kuakata in hired trawlers or speed boats to enjoy the serenity of the pristine shoal. Arifur Rahman, a tourist,

said more than a hundred seasonal fishermen were seen fishing and drying up fish there. During low tide, they bury small nets in the sand, and at certain distances, they place bamboo twigs next to the nets. When the water recedes during low tide, large and small fish of various species get caught in the nets. The big fish are collected by the fishermen but the small fish are left there: they die.

For this practice, various

species of fish are being killed prematurely, he added.

He said, "I have seen innumerable small dead fish in several nets while roaming in the char."

Authorities need to take immediate action to stop the killing of such fish, he added.

Contacted, Patuakhali Divisional Forest Officer Abdullah Al Mamun said, they have already started planting 1.5 lakh trees in the char this year. This will make the char permanent and the birds will be able to take shelter.

District Fisheries Officer Mollah Edadullah said, fishermen were not allowed to fish there and proper surveillance could not be carried out as the char was isolated and there was no water vessel to patrol there.

The matter of killing small fish was not known but action will be taken in this regard, he said.

### WASHINGTON'S NEW ARMS FOR UKRAINE

Ukraine's leader Volodymyr Zelensky made a desperate appeal for help against Russia to the US Congress on Wednesday, and within hours of the speech, President Joe Biden responded by promising \$1 billion in new weapons to fight "war criminal" Vladimir Putin's invading army. The new arms and equipment includes: S-300 MISSILE DEFENSE: Ukraine has had the ability to shoot down Russian aircraft and cruise missiles at relatively close quarters. Washington is arranging for it to acquire systems that can strike attacking aircraft much further away. According to a military source, the systems are the Soviet/Russian-made S-300, which like the US-made Patriot system, is a fully automated, ground-based radar-and-missile launcher unit that can detect, track and fire at multiple incoming aerial threats at long distances.

'SAINT JAVELIN': Western allies have already provided the Ukrainian army with some 17,000 lightweight, shoulder-launched self-guided missiles which have become the weapon of choice in the ground war. Among those, the US-made Javelin, with dual charges designed to defeat Russian tanks' anti-missile defenses, has become legendary in its effectiveness. Biden said Washington will send 2,000 more javelin missiles.

ANTI-AIRCRAFT STINGERS: The United States is also

ANTI-AIRCRAFT STINGERS: The United States is also giving 800 more Stingers, which are shoulder-mounted infrared anti-aircraft missiles. Ukrainians have used them effectively against Russian helicopters and slower, lower-flying fixed-wing attack aircraft.

GUNS, AMMUNITION, BODY ARMOR: The new US arms provisions also include 7,000 other anti-armor weapons, thousands of machine guns, rifles, and grenade launchers, 20 million rounds of small arms ammunition fitting both Russian and Nato standards, and 25,000 sets of body armor and helmets.

## Russians feeling the pinch

Russians are starting to feel the economic pinch after Western countries imposed an unprecedented set of sanctions over Moscow's invasion of Ukraine.

Following weeks of mounting tensions, Russian President Vladimir Putin ordered a land, sea and air invasion on February 24, triggering a wave of financial restrictions that have plunged the value of the rouble, skyrocketed inflation and left many jobles.

The official Rosstat statistics agency said on Wednesday inflation was 2.1 percent between March 5-11, the second-highest weekly figure in more than 20 years. According to the ministry of economics, annual inflation jumped to 12.5 percent as of March 11 from 10.4 percent the previous week.

The business newspaper Kommersant reported a 10.4 percent increase in food prices from February 26 to March 4 – the highest rise since 1998

The Russian currency has lost an estimated 20 percent of its value over the past three weeks, triggering many retailers to raise their prices.

One of these is Procter & Gamble, which raised its prices by an average of 40 percent, Kommersant reported, because of higher costs in logistics, materials and the drop in the rouble. Female hygiene products now cost as much as 30 percent

To contrast cost increases, retailers committed to a five percent markup of basic goods, including dairy products and some vegetables, TASS news agency reported.

Sasha, a woman living in Saint Petersburg, who asked to remain anonymous, described an "endless queue" in front of pharmacies with prices of medicine increasing. Two of her friends, she said, were considering going to Finland to get needed medication.

While sales of drugs are not subjected to sanctions, prices are expected to increase, though not as much as other goods, after major shipping companies halted their services to Russia. Local media reported drug prices in the Saratov region increased by 2.3-6.7 percent.

After some hesitation, Western nations agreed to remove some Russian banks from the SWIFT international payment system, meaning companies like Visa, Mastercard and others would greatly limit their services.

Such a move, coupled with other sanctions, could cause Russia's economy to contract by 10 percent, according to Elina Ribakova, an economist at the Institute of International Finance.

While official numbers are not yet available, the closure or departure of a large number of multinational companies such as Apple and IKEA are expected to have a significant effect on employment figures. US fast-food franchise McDonald's lamented the fallout for about 62,000 people employed at 850 restaurants in Russia before halting its operations on March 8.

An analyst quoted by Kommersant estimated an "inevitable" fall in wages and an increase in unemployment of about seven percent by the end of 2022.

But three weeks after the invasion of Ukraine, Beijing has shown few signs of abandoning its friends in the Kremlin.

# UN establishes formal ties

The UN Security Council yesterday voted to establish formal ties with Taliban-run Afghanistan, which has yet to win widespread international recognition.

It did so in approving a resolution that does not use the word Taliban and spells out the new one-year mandate of the UN political mission in Afghanistan, which it said was "crucial" to peace in the country.

The vote was 14 in favor, with one abstention, by Russia. The resolution includes several strands of cooperation, on the humanitarian, political and human rights fronts, including those of women, children and journalists.

"This new mandate for UNAMA (the UN mission to Afghanistan) is crucial not only to respond to the immediate humanitarian and economic crisis, but also to reach our overarching goal of peace and stability in Afghanistan," Norwegian UN ambassador Mona Juul, whose country drafted the resolution, told AFP after the vote.

The Taliban seized power on August 15 amid a hasty withdrawal of US-led foreign forces, and since then the country's humanitarian crisis has deepened.

### Global Covid cases up by 8pc: WHO

The World Health

After falling for weeks, reported Covid cases rose globally by eight percent last week, with more than 11 million cases and over 43,000 new deaths registered, WHO said.

WHO chief Tedros Adhanom Ghebreyesus warned that the lack of visibility due to reduced testing meant "the cases we are seeing are just the tip of the iceberg."

"And we know that when cases increase, so do deaths," he said. "We call on all countries to remain vigilant," he said, stressing "the pandemic is not over".

### No excuse for ACC's bias for top govt officials

What is the point of having an anti-graft watchdog, if not to investigate graft?

TE are appalled to learn about the "soft stance" of the Anti-Corruption Commission towards top government officials, particularly those in the admin cadre. According to a report published in this daily, the ACC top brass is reluctant to pursue graft cases against the admin cadre officials; instead, they ask the ACC investigators to go after petty employees. Our report has cited at least three instances where corruption allegations against some of the top bureaucrats were swept under the rug by the top tier of ACC. Rather than take action against those systematically swindling taxpayers' money, the ACC seems more keen on reprimanding those investigators who dared try to expose the corruption.

Reportedly, in 2017, an ACC commissioner (investigation) ordered an assistant director of the commission to probe a graft allegation raised against the government's social safety net programme in Narail's Lohagara upazila—about Tk 2 crore was allegedly misappropriated through fake projects to pocket funds from the government scheme. As the commission filed two cases against the government officials and others involved, and were preparing to file two more cases, the assistant director investigating the matter was served a show-cause notice by the commission. The ACC then appointed a new investigation officer who recommended submitting a final report, instead of a charge sheet, before the court. Eventually, the two cases that were filed in this connection were also closed.

The ACC's apparent bias towards the country's top bureaucrats was exposed recently when the commission sacked Sharif Uddin, a deputy assistant director of the commission. According to ACC insiders, he was "punished" for bringing corruption charges against some top government officials.

This begs the question: What is the point of the antigraft watchdog, if not to look into graft charges and take appropriate actions? ACC was formed as an independent body to investigate and curb corruption. Sadly, it is gradually losing its independent character and seems to be giving in to the pressure from the corrupt quarters, as exposed by the incidents mentioned above. It has also been reported that ACC investigations are dominated by former bureaucrats sent to the commission on deputation. Naturally, they have little knowledge about ACC's investigation method, which also comes in the way of an impartial investigation.

We urge the ACC to play its designated role and not give a clean chit to the corrupt government officials. They must take action against those who are corrupt, no matter how powerful they are. If the ACC fails to do so, they will not only lose their reputation, but also public trust.

### Why spend crores if you won't finish the projects?

Inefficient river excavation work too frequent to be forgiven

TE are puzzled by Bangladesh Water Development Board's (BWDB) excavation strategy for the country's rivers and canals. According to a report by this daily, over Tk 23 crore was spent last year to excavate a 65km stretch of rivers and canals in five upazilas of Lalmonirhat. But the excavated earth, piled up on the banks, made their way back into the water bodies, rendering the project redundant.

Moreover, the project was not even completed as per the original plan. Initially, a work order of over Tk 35 crore was given to contractors for the re-excavation of a 98.1km stretch of small rivers and canals in the five upazilas. However, only 66 percent of the work had been done by the project's deadline, which was June last year. Though the Lalmonirhat Water Development Board refunded around Tk 16 crore to the government, the fact remains that this was a most poorly done job, through

While excavating rivers and canals to improve navigability is done routinely in Bangladesh, it is rarely ever successful. Either the work is done inefficiently by the relevant board and contractors, or the project is left unfinished. Unfortunately, both of these have happened for the case in point.

As to why the excavation work was unsuccessful on their end, the executive engineer of Lalmonirhat Water Development Board said the contractor could not work fully due to obstruction by the land owners along the rivers and canals. Are we to believe that an organisation under the government lacks the tact and resources to work around such issues? We are beginning to doubt how important these organisations deemed the excavation project to be, given how they let their work—and crores of public money—be lost for nothing. Unfortunately, this is not an outlying event and is proof that the BWDB is perhaps not learning from its past failures in terms of river excavation. In 2020, it had reportedly excavated an 80km stretch of the Charalkantha River in Nilphamari, only for the dug-up earth to flow back in and re-obstruct the river's flow, even narrowing it down to a mere channel in places.

Not only do such poorly done projects waste public money, but they also exacerbate the suffering of citizens. The BWDB and its district offices must be held to account for their inefficiency. It's not acceptable that funds and time should be wasted in this way while officials move on to the next large-scale, government-funded project—only to presumably do that ineffectively, too.

# The impossible quest for an ideal CEC

■ HE formation or the journey of an Election Commission has rarely been a welcoming event in Bangladesh. It is always the chief election commissioners (CECs) who are blamed for all electoral evils. Their image starts to tarnish as soon as they are sworn in. But the simple truth is that, irrespective of whether they are impartial or want to hold credible elections, there is little space for them to act independently. We may not like it, but a CEC has no choice but to follow the sitting government'smore precisely, the ruling party'sarrangements in Bangladesh.

Ironically, however, a failed Election Commission is negatively branded with its CEC's name. I have little doubt that the defamed CECs would have performed differently under a neutral government, whereas they surrendered their conscience to the government—either because they were weak or because their appointment demanded unconditional loyalty. Even with this knowledge, people want to see a CEC having the courage to disregard the establishment. To me, they want a TN Seshan taking the role of their CEC—an impossibility at the present moment.

Many would ask: Why couldn't we find a TN Seshan—i.e. the man who cleaned up the Indian electoral system in the 1990s—in Bangladesh? I can cite at least two reasons. To begin with, Indian politicians, even in their quest for power, did not intend to completely destroy their constitutional institutions. On the other hand, I am sure Indian pressure groups or intellectuals would not have accepted any such move. As a result, TN Seshan had a fertile land in which to work independently, without fear.

In Bangladesh, we are still looking for an ideal CEC. Will one be born? If yes, will they be able to work independently? Mahbub Talukdar, a member of the Nurul Huda commission, showed some courage. Yet, he was not the decisionmaker. KM Nurul Huda, probably the most incompetent and shameless CEC in Bangladesh's history, sidelined Mahbub

If we analyse the elections held in recent times during the Awami League's regime, what can we conclude? The party's mindset is completely focused on winning elections, by whatever means possible—not on credible elections. They are not bothered about the gradual disappearance of the institution of democracy. The parliamentary elections of 2014 and 2018 were nothing if not farcical; yet, it wasn't just the ruling party activists but also many of the country's top intellectuals who extended their unequivocal support for the regime. The common objective of this coterie comprising both political and nonpolitical elements have left no scope for acceptable elections in Bangladesh under a partisan government.

Unsurprisingly, a few people are always excited about new laws. For those having common sense, this enthusiasm

is misplaced. We all know that neither the enactment of legislations nor even the sacred provisions of the constitution can protect the people's rights—unless their enforcers are willing to do so. Who can deny the long saga of abuses of our constitution and our laws for the last 50 years? The newly passed legislation in order to form an Election Commission has also proven to be unhelpful. The Awami League's intention behind enacting the law is not clear. Was it in good faith?

The appointment of the current Election Commission under the Chief **Election Commissioner and Other** Election Commissioners' Appointment Act, 2022 has brought no significant changes to the existing situation. Whoever becomes a CEC through the given process is unlikely to serve impartially. The apparatuses of the state are fully controlled by the sitting government and will not act against the leader's wish.

Habibul Awal's action will prove whether he will act as TN Seshan. Only time will tell whether the ruling party will start to engineer the upcoming general elections in the way they did before to ensure their return to power. If they do, Bangladesh is certain to experience another controversial election in late 2023 or early 2024. No legislation, including the newest one, can prevent that from happening.

In Bangladesh, the legal framework for holding a free and fair election existed under the applicable laws, even before the enactment of the new law. The difficulty lies in the lack of will of those running the government and those who follow them. The ruling party and their ideological intellectuals or pressure groups are adamant to hold on to power. Unless this attitude changes, an entire generation will be deprived of the chance to cast their

For Bangladesh, the sole mechanism to ensure trustworthy elections is returning to the interim government who will exercise constitutional powers to impartially conduct general elections. Despite the Supreme Court's verdict against the non-party caretaker government, which in my opinion is a judgment of misconceived jurisprudence, our politicians must act for an ultimate consensus-that of restoration of the interim government for free, fair and impartial elections.

A legislation or a Kazi Habibul Awal will not be able to rescue us.

# On to the next hurdle

TTH Julian Assange still, for no rational reason, held in maximum security, the legal process around his extradition continues to meander its way through the overgrown bridleways of the UK's legal system. On March 14, 2022, the Supreme Court refused to hear Julian's appeal, which was based on the grounds of his health and the effect upon it of incarceration in the conditions of the US prison service. It stated that his appeal had "no arguable legal grounds."

This is a setback that's most likely going to keep Assange in jail for at least another year.

The legal grounds, which the High Court had previously ruled to be arguable, were that the US government should not have been permitted to give at appeal new (and highly conditional) diplomatic assurances about Julian's treatment, which had not been offered at the court of first instance to be considered in the initial decision. One important argument is that, if given to the original court, the defence could argue about the value and conditionality of such assurances; evidence could be called and the matter weighed by the court.

By introducing the assurances only at the appeal stage, the US avoided any scrutiny of their validity. The Home Office has always argued that diplomatic assurances must simply be accepted without question. The Home Office is keen on this stance, because it makes extradition to countries with appalling human rights records much easier.

and are to be taken at face value—which has been a major point of controversy in recent jurisprudence. It is now settled that we will send someone back to Saudi Arabia if the Saudis give us a piece of paper promising not to chop their head

It interested me in particular that the Supreme Court refused to hear Julian's appeal on the basis that there was "no arguable point of law." When the Supreme Court refused to hear my own appeal against imprisonment, they rather stated their alternative formulation; there was "no arguable point of law of general public interest." Meaning there was an arguable point of law, but it was merely an individual injustice that did not matter to anyone except Craig Murray

My own view is that, with the Tory government very open about their desire to clip the wings of judges and reduce the reach of the Supreme Court in particular, the court is simply avoiding hot potatoes at present.

So the case now goes to Home Secretary Priti Patel to decide whether to extradite Assange or not. The defence has four weeks to make representations to Patel, which she must hear. There are those on the libertarian right of the Tory party, who oppose the extradition on freedom of speech grounds, but Patel does not have a libertarian thought in her head and appears to revel in deportation, so personally I hold out no particular hope for this stage.

Assuming Patel does authorise extradition, the matter returns to the original magistrate's court and to Judge Baraitser for execution. That is where this process takes a remarkable twist.

The appeals process that has just concluded was the appeal initiated by the US government, against Baraitser's original ruling that the combination of Julian's health and the conditions he would face in US jails meant that he could not be extradited. The US government succeeded in this appeal at the High Court. Julian then tried to appeal against that High Court verdict to the Supreme Court, and was refused permission.

But Julian himself has not yet appealed to the High Court, and he can do so once the matter has been sent back to Baraitser by Patel. His appeal will be against the grounds which Baraitser initially found in favour of the US. These are principally: i) Misuse of the extradition treaty which specifically prohibits political extradition; ii) Breach of the right of freedom of speech; iii) Misuse of the US Espionage Act; iv) Use of tainted, paid evidence from a convicted fraudster who has since publicly admitted his evidence was false; and v) Lack of foundation to the hacking

None of these points have yet been considered by the High Court. It seems a remarkably strange procedure that, having been through the appeals process once, the whole thing starts again after Priti Patel has made her decision, but that is the crazy game of snake and ladders the law puts us through. It is fine for the political establishment, of course, because it enables them to keep Julian locked up under maximum security in Belmarsh.

The defence asked the High Court to consider what are called the "crossappeal" points at the same time as hearing the US appeal, but the High Court refused.

So the ray of light that was Baraitser's ruling on health and prison conditions is now definitively snuffed out. That means that rather than the possibility of release by the Supreme Court this summer, Julian faces at least another year in Belmarsh, which must be a huge blow to him just before his wedding.

On the brighter side, it means that finally, in a senior court, the arguments that will really matter will be heard. I have always felt ambivalent about arguments based on Julian's health, when there is so much more at stake, and I have never personally reported the health issues out of respect for his privacy. But now the High Court will have to consider whether it really wishes to extradite a journalist for publishing evidence of systematic war crimes by the state requesting his

Now that will be worth reporting.

# Bangladeshi media's troubling tango with fake news

ftentimes, we hear politicians, academics and journalists laying great emphasis on how the mainstream media can play its part to fight the menace of fake news and misinformation. In such a discussion last year, speakers said the role of the media was "more important than ever amid a growing surge of false information intended to mislead the public."

But sadly, in Bangladesh, we have been witnessing a disappointing phenomenon where some mainstream media outlets have been amplifying misinformation. instead of combating it. It may sound unpleasant to many, but the reality is that a section of the media has been contributing to the proliferation of misinformation online.

On February 3, 2022, international news agency AFP's fact-checking unit rated a news story published by a reputed Bangladeshi TV station, which recently reached the landmark of 10 million subscribers on its YouTube channel, as "false information." Crediting the stateowned Saudi Press Agency (SPA), the story claimed that the Saudi government had approved a draft amendment to redesign its national flag to remove Kalima Tayyiba (Islamic declaration of faith) from it. Currently, the green flag of Saudi Arabia is emblazoned with Kalima Tayyiba above

However, in reality, neither the SPA nor any other Saudi news media said anything like this in their reports about the approval of the draft amendment, which actually was revised to propose new regulations regarding the use of the flag. Rather, some Saudi newspapers categorically mentioned in their reports that the revised draft did not propose any changes to the contents of the flag.

Interestingly, not only that leading TV channel, but several other top media outlets in Bangladesh—newspapers and online portals-published this fake news, leading to a flood of reproduction on

social media platforms.

This incident is no anomaly, as outright false information, photos and video footage are frequently being carried by top Bangladeshi media outlets.

as fake news proliferators during the same period. Those fake news items were mostly centred around health, politics and religious sentiments. The year 2021 saw a similar trend when Boom Bangladesh encountered 11 fake news stories in the media. Other fact-checking organisations also detected misleading news stories in Bangladeshi media in the same vear.

As a fact-checker who has been working with different organisations for around five years, I have to struggle to name five news outlets in the country that have not been rated at least once as spreaders of fake news. While the media in Bangladesh, which has ranked low in the Press Freedom Index for years, has contributed immensely to the development of the country, despite all odds, the problem of fake news that it currently faces can diminish its credibility among the public.

Sometimes, some fake news or outof-context information does not seem harmful to anyone. But we know as a matter of fact that this menace can turn deadly at any time. Bangladesh has seen, in recent past, murders of innocent people due to rumours spread on Facebook. Widespread violence against religious minorities was sparked by online misinformation on many occasions. When the problem is this big, the media has a crucial role to work out how to deal with the threat. And the first thing to do is ensure that it has not become a vehicle of fake news.

Analysing the types of fake news that have been carried by our mainstream media, we can identify two major factors that have contributed to the problem: One is a lack of proper understanding about scientific topics, including health-related issues, that journalists were reporting on, and the other is mistranslation from English.

Exhaustive information ecosystem, especially the volumes of user generated content (UGC), makes anyone vulnerable to fake news. But for a journalist, verifying a piece of information found online is no tough job at all. What they need is the desire to be fool-proof when it comes to the accuracy of information. Oftentimes, some simple searches on Google about the origin of the content or basic image and video verification techniques can save a newsperson from falling into the trap of fabricated information. Present-day journalists, especially those who deal with the UGC, have to have a standard level of knowledge of how to verify a piece of information using modern technologies.

While social media platforms are increasingly becoming sources of revenue for the media in developing countries, tech companies like Facebook and Twitter have turned against the publishers of fake news, penalising them in the strictest ways possible. Under the third-party factchecking programme of Facebook, pages of several Bangladeshi media outlets faced temporary restrictions in terms of reach and revenue, and the programme is only expanding. So, the newsroom bosses in Bangladesh have to be more watchful about what is being published and broadcast in their outlets.

# Are celebrities liable for the brands they endorse?

N December 4 last year, in the immediate aftermath of the crumbling of Evaly's empire of sand, celebrities Rafiath Rashid Mithila, Tahsan Khan and Shabnam Faria were sued by a customer of the e-commerce platform for "aiding and abetting fraud."

Over the next few weeks, the issue became something of a sensation on social media, sparking conversations in some intellectual quarters about the premise of the lawsuit, about whether the three very popular celebrities could be held responsible for Evaly's wrongdoings.

Though the conversation died down soon—as is always the case on social media—the issue stuck with me. What really is the ethics of celebrity endorsements, which have become an integral and rather indispensable part of the equation in this current phase of capitalism?

Before we get to an answer to this, let's consider what actually happens when a celebrity figure, or an influencer, endorses a brand or business in exchange for

It's simple, really. A celebrity, throughout their career, builds up a rapport with the public. This imbues the celebrity with a certain kind of aurathere's the trustworthy celebrity, the bad boy, the family-first person, the celebrity with professional expertise, and the list

This rapport (or, social capital) is then "sold" to a company in exchange for the company's money. The transaction

here, then, is one of monetary capital for social capital, and vice versa. Beyond just face value, when a celebrity appears on our screens representing a company, we immediately link the celebrity's brand value or aura with that of the company.

The three celebrities in question over the Evaly scam all possess the same trustworthy sort of face value. Mithila is widely regarded as a strong, sincere feminist personality. Tahsan Khan has a carefully curated brand name for being a kind and gentle soul. And Shabnam Faria comes off as a sincere and loyal person, thanks to all the roles she has played onscreen over the years.

If we agree that a popular figure's brand value is not just a result of their real selves, but can also be calculated quite carefully and with intent, we can shed light on how this element works in the discourse of celebrity endorsements.

There are two layers of "deception" that operate here. On one hand, the performer-artiste poses as being different from how they are in order to obtain a certain kind of social capital from their audience. For the second layer, the artiste uses that social capital to strike deals with brands and drive their audience towards

Given how the Evaly scam played out, the more pressing concerns of the issue came to the fore quite forcefully. But this issue is not just limited to fraudulence.

When a celebrity, known for their good health, lends their social capital to a beverage company whose product can have debilitating effects on consumers' health, is it not the same kind of deception?

You see, given how society works today, a brand cannot build a relationship with its market without a little help from figures who already have a connection with the people. Seen this way, a celebrity who has once signed

activities of corporations are deemed not innocent due to those being done only for profit, shouldn't the role of celebrities in enhancing the corporations' success be scrutinised as

the contract to endorse a brand can no longer be seen separately from it, or from the consequences of its business. So when things come crumbling down, the affiliated celebrities cannot just be allowed to run and hide, claiming they didn't know any better.

Brands themselves are aware of this, and don't wait even a second before cutting off their prized endorsee when a controversy develops in the latter's personal life. Case in point: Cristiano Ronaldo and Nike.

Another case study that sheds light on this issue is that of Scarlett Johansson's role as an ambassador for both Israeli soda-maker Sodastream and the INGO Oxfam. After online activists found out that one of Sodastream's factories is located in an illegal settlement on the West Bank, they started hounding Johansson for her connection to the company—a criticism which also extended to Oxfam for their connection with her.

As this case illustrates, when the activities of corporations stop being innocent in the name of doing business and raising a country's GDP, should not the role of celebrities in enhancing the corporations' fate be scrutinised as well?

As the activities of corporations are deemed not innocent due to those being done only for profit, shouldn't the role of celebrities in enhancing the corporations' success be scrutinised as well?

But beyond just scrutiny, we ought to move into a culture wherein, before signing a deal, a celebrity conducts background research on a brand—the same way brands do, quite extensively, when taking a celebrity on board. And this fact-checking exercise shouldn't be limited to legal matters or instances of public backlash, but also in terms of whether a celebrity's philosophy aligns with the company's. If a self-proclaimed nature-lover signs up for a top-five polluter, for instance, that's more than a little contradictory.

Whether to focus on the batting line-up's form and ability to counter South Africa's pacers or to focus on their own pace battery's performance on South African soil is what may boggle the Bangladesh think-tank most going into the first ODI at Centurion today.

Bangladesh have never won on South African soil in any format, so rather than going in with shaky feelings and a halfhearted approach borne from past defeats, Tamim Iqbal opted for brevity. "We know that South Africa is always a difficult tour for us. We want to change that and for that we have to prepare ourselves for a difficult challenge and be brave," the ODI skipper claimed at the press conference yesterday, a day ahead of the game.

Bangladesh have historically struggled in South Africa, especially with the pace and bounce. The likes of Kagiso Rabada terrorised them in the recent T20I World Cup at UAE too. Anrich Nortje's pace could be a handful while in Tabraiz Shamsi they have the kind of bowler that Bangladesh have not really had much experience with.

The ground at Centurion has produced runs in the last three ODIs, with the latest two being the Proteas' series against Pakistan. Tamim, who said that his side had been able to get a feel of the pitch by practicing in the centre wickets, was finding hope from the team's last match against South Africa in ODI format -- a 21-run win at The Oval in the 2019 World Cup.

"This is a ground where, if you go by the statistics, you see that a lot of runs are scored because the ground is a bit smaller and the outfield is fast. But whatever the statistics say, you have to accept that we have to play well. We're ready for the challenge. We know they will be onto us. We have to handle the pressure. We played well against them recently and I believe there is no reason not to do well. The most important thing will be how we start tomorrow," Tamim said.

>> Bangladesh are already on top of the ICC ODI Super League table with 100 points from 15 matches. Even a single win from the three-match series against South Africa would further solidify the Tigers' chances of qualifying for the 2023 ODI World Cup in India.

>> South Africa, meanwhile, are 10th in the Super League table with just 39 points from 10 matches. Bangladesh are yet to win in any formats away to South Africa. The Tigers have played nine ODIs, six Tests and four T20Is against the Proteas in their backyard.

>> Playing in 14 of the 21 ODIs between

Bangladesh and South Africa, Shakib Al Hasan has scored 397 runs – the highest among the players from the current squads of the two sides.

- >> Quinton de Kock is just behind Shakib in the top-scorers' chart. However, De Kock took only seven matches to score 354 runs at an average of 59.
- >> With 13 wickets in seven ODIs, Kagiso Rabada is the active player with the most number of wickets against Bangladesh.
- Shakib also scalped the same number of wickets as Rabada but the allrounder played seven more games than the pacer.

The team will be buoyed by the fact that taking on the Proteas as well. "He is with the team and he's fully available for all the matches. Shakib is waiting for tomorrow's match and he wants to do well. Just like I want to do well, the other members of the team want to do the same," Tamim informed.

Alongside exactly how much of an advantage fast bowlers will get on tracks that might be flat, the main worry may be how the top-order can weather and push past the early storm.

"We know it will be challenging. If you think about it, bar one or two, most of the members of our side are quite experienced with at least 40-50 ODIs in the bag. Everyone knows what to expect. The most important day, I feel we can beat any side anywhere in the world," Tamim said.

South Africa captain Temba Bavuma was counting on having a good day too. Bangladesh had the experience and for Bavuma the Tigers deserved respect.

"The players you mentioned [Shakib, Mushfiqur Rahim, Tamim] are very experienced. They are guys who have played here in South Africa... they are guys who have played in Australia. So, from a mental point of view, they know what to expect. They [Bangladesh] are on top of the [ICC ODI Super League, so we will give them the respect. But it's what happens on the day that matters," he concluded.

### Diya, Nasrin dazzle to guarantee gold

The celebrations among the Reds stood in stark contrast to the body language of Manchester City at the final whistle against Crystal Palace on Tuesday, which, coupled with Liverpool's win, saw their lead at the top reduced to just one point.

Osteoporosis is a disease of the bones. The word means "porous bone". It weakens your bones and makes them more prone to fractures.

Bone is a kind of living tissue which gets broken down and replaced, and osteoporosis usually happens when formation of new hones hannens slower than the loss of old bones.

Elderly people, especially women who are past menopause, are more prone to the disease

If not managed, it can hamper the daily lives of patients. In the early stages, it is hard to detect. But once it advances, symptoms like back pain, loss of height, bones breaking easily are noticed.

Prevention of osteoporosis should be given more importance as its treatment can be tricky.

In order to prevent this disease, we need to be mindful of our bone health.

Good nutrition and exercise are necessary to keep bones healthy and



## 'The mother, not Napa syrup, killed the boys'

Says SP of Brahmanbaria

It wasn't the Napa syrup that killed the two children at Durgapur village, after all. It was their mother who had poisoned them so that she could marry her boyfriend.

"After a thorough investigation, we have found evidence that the mother in association with her boyfriend committed the killings," said Mohammad Anisur Rahman, superintendent of police (SP) of Brahmanbaria, at a press conference yesterday.

Their mother Rima extramarital affair with one Shafiullah, who she met while working at a rice mill in Bagoir area in Ashuganj upazila.

Shafiullah agreed to marry her on the condition that she leaves behind her children

Yasin Khan, 7, and Morsalin Khan, 5. They hatched the plan to kill the two boys. On the evening of March 10, Rima fed her two sons poisoned sweets provided by Shafiullah.

The boys fell sick and were initially taken to Ashuganj Upazila Health Complex. They were sent to the Brahmanbaria General Hospital. Curiously, the boys were not admitted to the hospital.

Yasin died on the way home from the hospital, while Mursalin breathed his last upon reaching home, Rahman said at the press conference.

Rima claimed to local journalists that her sons fell ill after consuming Napa syrup bought from a local pharmacy and started to vomit. Later, they died.

The children's death drew the attention of all concerned across the country.

The Directorate General of Health Services, the Directorate General of Drug Administration and Brahmanbaria General Hospital authorities formed three investigation committees to probe

The drug administration authorities collected samples of Napa syrup of particular batches, including the one in question, and tested them in labs. But the authorities found no harmful ingredients.

Meanwhile, on Wednesday, the children's father Ismail Hossain Khan, who is visually impaired, filed a case against Rima and her 'boyfriend' Shafiullah.

The police investigated the thread further and found that Rima had called Shafiullah 15 times on the day the children died.

During the investigation, police found that the family took the boys to the Brahmanbaria General Hospital and bought a ticket for taking treatment in the emergency department. But they fled from the hospital without receiving

In the early hours of yesterday, police arrested Rima, who admitted to her crime in primary interrogation, Rahman said.

Yesterday, Rima was produced before the Chief Judicial Magistrate's Court of Brahmanbaria, where she also gave a confessional statement, said Kazi Dider Ul Alam, inspector of Brahmanbaria Court Police. Later, the court sent her to jail, he said.


