# 14,111 shut down during pandemic

Covid-19 has taken a heavy toll on privately run primary schools, resulting in permanent closure of 14,111 of the institutions just in one year as they failed to bear the operational costs, says a government report.

The pandemic also saw a drastic fall in the number of teachers and students in the non-government primary schools, including kindergartens.

The Annual Primary School Census (APSC) 2021 shows the number of teachers declined by 83,268 and students by 14,61,634 in a year since 2020.

The report, prepared by the Directorate of Primary Education, has no data on English-medium schools and Qawmi madrasas. It says the institutions shut down during the pandemic were mostly kindergartens or run

"There needs to be some kind of incentive for the schools that had to stop their

activities. But that should be done after bringing all the institutions under a regulatory framework with a

specific guideline," Rasheda K Choudhury, executive director of Campaign for Popular Education (CAMPE), told The Daily Star. Iqbal Bahar Chowdhury, chairman of Bangladesh Kindergarten School and College Oikya Parishad, said the situation for kindergartens was grave. "Our estimate

shows at least 20,000 kindergartens were closed down during the pandemic and many teachers lost jobs. He added, "The remaining 40,000 kindergartens are

not in good shape either." During the pandemic, they have sought financial assistance for teachers, soft loans for owners of kindergartens and waiver of utility bills of the hard-hit schools. "If we get that assistance now, it would help us

survive," he added. In 2020, there were 1,33,002 primary-level educational institutions, including public, private, NGO-run and kindergartens. The figure stood at 1,18,891 last year, according to APSC 2020 and APSC 2021.

According to the reports, there were 14,211 NGOnumber decreased to 3,958 in 2021. There were 29,897 kindergartens in 2020 and 28,193 in 2021.

"Due to the permanent closures, students from these private institutions went to government primary schools," Alamgir Mohammed Monsurul Alam, director general of DPE, told The Daily Star.

The reports say 60.52 percent of all primary school students were enrolled in government institutions in

2020 and that increased to 70.23 percent. According to the APSC, the number of teachers in all primary schools was 7,40,471 in 2020 and it decreased to

6,57,203 in 2021. The reason behind this is, a DPE director said, most of the teachers who lost jobs did not get that back or return to the profession.

For the second day in a row, many neighbourhoods in the capital suffered an acute gas crisis yesterday, as the authorities struggled to fix the technical problems that occurred at Bibivana Gas Field in Svlhet on Sundav

Residents of Mirpur, Pallabi, Lalmatia, Shahjahanpur, Mohammadpur, Tejturi Bazar, Razabazar and Dhanmondi complained of severe gas shortage, and said they had to buy food and iftar items from restaurants.

According to Bangladesh Oil, Gas and Mineral Corporation (Petrobangla), consumers in different city areas have been experiencing shortages or low pressure in gas supply from Sunday following technical glitches at

Officials at Chevron Bangladesh, the operator of Bibiyana Gas Field, said, two of the five gas-processing trains and six of the 26 wells at the gas field faced technical problems around 1:15am on Sunday, reducing the field's gas production to around 800 million cubic feet per day (mmcfd) from 1,250 mmcfd.

President Gotabaya Rajapaksa's overture came as armed troops looked to quell more demonstrations over what the government acknowledges is the country's most severe economic crisis since independence from Britain in

cannon to disperse thousands the private home of the prime minister -- the president's elder brother and the head of the family political clan -- in Tangalle, once a bastion of support for the Rajapaksas in the island's south.

The president asked opposition parties represented in parliament to "join the effort to seek solutions to the national crisis," after the late-night resignation of nearly all cabinet ministers to pave the way for a revamped administration.

But the leftist People's Liberation Front (JVP) responded by urging Gotabaya Rakapaksa

and his once popular and powerful family to immediately step down.

"He really must be a lunatic to think that opposition MPs will prop up a government that is crumbling," JVP lawmaker Anura Dissanayake told reporters in Colombo.

The main minority opposition party, the Tamil National Alliance (TNA), also dismissed the idea of their joining a Rajapaksa-led administration.

"His offer to reconstitute the cabinet with opposition MPs is nonsensical and infuriates the people who have been demanding his resignation,'

# Cop suspended for harassing teacher over wearing 'teep'

Amid outrage on social media and bevond, Dhaka Metropolitan Police yesterday suspended constable Nazmul Tareque, who was accused of harassing a college teacher for wearing a "teep" on her forehead.

DMP has taken the move hours after its Tejgaon Division identified the constable from CCTV footages and intelligence information, confirmed Md Faruk Hossain, deputy commissioner of DMP, to The Daily Star.

A probe body, comprising additional deputy commissioner of protection unit and assistant commissioner of Tejgaon Division of DMP, was also formed to investigate the incident.

The committee was instructed to submit a report within three working days, according to an order signed by Mostaq Ahmed, deputy commissioner (protection unit) of the DMP.

Earlier on Saturday, Tejgaon College teacher Lata Samaddar filed a general diary with Sher-e-Bangla Nagar Police Station saying a policeman harassed

# 2 inmates die in prison Family of one alleges negligence

Two inmates of Chattogram Central Jail died yesterday at Chattogram Medical College Hospital (CMCH) after both fell

One of the deceased was identified as Md Rafiq, 58, who landed in jail on March 27 in a case filed with Chandanish Police Station over a clash between two rival

Around 4:00am yesterday, he fell sick and the on-duty guards took him to the prison's hospital, said Dewan Md Tariqul Islam, the jailor of Chattogram Central Jail.

As Rafiq's physical condition deteriorated, he was taken to the CMCH, where the on-duty doctors declared him

Rafiq's family maintains his death was due to the negligence of the jail authorities and the police in giving him proper treatment.

"We have a longstanding rivalry with our political opponent in our area. On March 26, our opponent group attacked us with lethal weapons -- my brother was seriously injured in the attack," said Jamal

Uddin, Rafiq's elder brother.

Rafiq managed to flee the scene of violence and went to the Chandanish

police station for safety. But the police locked him up on the charge of his involvement in the bout. His rivals went to the police station and beat him up in the absence of the officer-incharge, Jamal said.

Later, Rafiq was shown arrested in a case of violence filed by the other side.

"My brother was not given proper treatment in the police station. Rather, he was sent to jail the next day with his physical injuries," Jamal added.

Anwar Hossain, the OC of Chandanish police station, denies the allegations of an attack on Rafiq inside the police station.

Rafiq and their rival group locked into a clash in the village and the police registered cases against both groups. The OC, however, did not elaborate on the

In a separate incident, Md Babul Mia, 38. died at CMCH after complaining of chest pains in the early hours of yesterday.

Babul, who landed in jail on November 18 last year in a drug case field with Chandanish police station, was taken to the prison hospital. Later, he was shifted to the CMCH's emergency ward, where he

Both the bodies were sent to CMCH morgue for autopsy, Islam said.

# Ensure proper use of water

Urges Sheikh Hasina

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said her government has adopted plans to ensure better use of surface water and the reduction of its underground extraction.

"Another name for water is 'life'; it is important [for us] to preserve this resource. We have taken plans to increase the use of surface water," she said while addressing a programme on World Water Day 2022, organised by the water resources ministry at Pani Bhaban in the capital. This year's theme is

"Groundwater, making the invisible visible".

Attending the event virtually from the Gono Bhaban, the PM mentioned that two billion people in the world are suffering from a lack of safe drinking water.

"If we can use this resource properly, then there will be no sullering for our country's peop and we will be able to supply [safe]

water to the world [market]. We have to do our work keeping that in

Hasina said the government has already begun supplying river water after purification. Even at the district level, the government is supplying treated river water to save

> underground water. Hasina mentioned the government has given the highest priority

to dredging, which will not only increase navigability, but also improve waterways. "We will be able to transport our goods at lower

She said river beds have silted for a lack of dredging for a long time. As a result, rivers have widened unnecessarily.

"We can reclaim land through dredging and reduce the river widths. We have already reclaimed a good amount of land this way."

Hasina said earth generated from dredging must not be put on arable land and can instead be preserved by creating pockets in rivers.

She also asked to make sure that there will be no obstruction on water flow due to any development project.

While constructing any building, the premier said, "We have to consider some preservation of rainwater and having a water reservoir."

She mentioned that if the underground water is used excessively, probability of earthquakes may increase in the country as Bangladesh situated on a plate under which stability is achieved due to the water level.

Hasina said unplanned and indiscriminate construction of dams have to be restricted.

"In the name of increasing the height of dam, I know, the amount of expenditure will be increased and some people will get commission. This kind of mentality has to be shunned. Plans that benefit the country have to be made.'

The PM urged all to maintain austerity in using pipe water and stop the misuse of water for any purpose. "We all have to remain alert in this regard."

# Headmaster beats student, fractures her hand

A schoolgirl fractured her hand as she was beaten up by the headmaster at Tarash Government High School in Sirajganj's Tarash upazila on Saturday. Mahiya Rahman, a 10th grader at the school, is

currently undergoing treatment at home. According to her father Mojibar Rahman, Mahiya refused to take private tuition from headmaster Ali Hasan, which angered him. "He tortured my daughter inhumanly."

After hearing about it, Mojibar rushed to the school and took his daughter to Tarash upazila health complex, where doctors said her hand was fractured and there were injury marks elsewhere on her body.

Mahiya is undergoing treatment at home. Headmaster Hasan Ali said, "I heard she was using a mobile phone in school. When I told her to hand it over, she used foul language with me. So, I beat her with a stick. It wasn't as bad as to fracture her hand."

Meanwhile, Majbahul Karim, upazila nirbahi officer, said a three-member committee, headed by Upazila Education Officer Jakir Hossain, was formed to probe the allegation and submit a report within three working days.

# Madrasa teacher killed in clash

A madrasa teacher was killed while trying to stop a clash between people of two villages in Sylhet's Jaintapur upazila yesterday.

The dead, Mawlana Saleh Ahmed, was a teacher of Tahfizur Ouran Madrasa of Sylhet's Majortila area and a resident of the upazila.

The clash started at Haripur bazaar, over land dispute between Rafique Ahmed of Hadpara village, and Rashif Ahmed, of Shyampur village.

As it went on all night, a group of local Islamic clerics, Imams and teachers came to the spot to settle the matter around 7:00am. However, the violence intensified and Saleh was beaten to death

Lutfur Rahman, additional superintendent of Sylhet District Police, said, "Police brought under control...A case is being filed in this regard and we are trying to arrest those behind the killing.'

# Sweden, TIB sign 5-yr grant deal

Aiming to strengthen the existing cooperation in preventing corruption, Sweden Embassy in Dhaka and Transparency International Bangladesh (TIB) signed a five-year grant agreement yesterday.

# Small vehicles BIG PROBLEMS

Public transport in a shambles, as bikes, cars dominate roads

Fewer than three percent of registered vehicles in Dhaka city are buses and minibuses, exposing the poor public transport situation of the capital, where over two crore people live.

In contrast, around 70 percent of registered vehicles comprise motorcycles and private cars, which are considered as major reasons behind traffic congestion and road crashes.

The picture is grimmer in other parts of the country, shows government data.

Only 1.51 percent of registered vehicles across the country are buses and minibuses. This has led to a boom of illegal and unsafe small vehicles, like easy-bikes and locally-made three-wheelers.

Over 70.15 percent of the country's vehicles are motorcycles, while 7.54 percent are private cars, show data of Bangladesh Road Transport Authority (BRTA).

Traffic congestion is a perennial problem for Dhaka city, but it has intensified, as the capital returned to normalcy after the Covid-19 situation improved and all educational institutions reopened. Following the start of Ramadan, commuters are suffering even more. SMALL VEHICLES: ROOT CAUSE OF

JAMS, CRASHES Transport expert Prof Shamsul Hoque said small vehicles are a major reason behind traffic congestion in Dhaka city. If the number of such vehicles can be reduced. buses and minibuses will get more space on the roads, leading to more trips.

Instead of discouraging small vehicles, the government policy actually encourages them, he said.

The government has halved bike registration fees and is providing loans to its officials for buying cars. Cars are also being procured under different projects,

Lack of public transport behind boom of illegal, unsafe three-wheelers

Discouraging use of small vehicles, increasing buses, minibuses the solution, say experts

said Prof Shamsul, former director of Buet's Accident Research Institute.

In this situation, Dhaka's traffic jams will not reduce but increase, he said. Increasing the number of buses without reducing the number of small vehicles will not improve

The government has to discourage usage of small vehicles and quickly introduce the bus franchising system, he added.

He said lack of public transport is a reason behind the boom of illegal and unsafe three-wheelers, which is a major reason behind the rise in road crashes.

According to Road Safety Foundation, at least 589 people were killed and 647 injured in 458 road crashes during the last month, which means 19 people were killed

every day on average.

Bikes were involved in 22 percent of accidents, while locally-made threewheelers were involved in 16.12 percent of crashes, the organisation said yesterday.

The more alarming fact is that bikes were involved in 37.52 percent of accidents that resulted in death, it said.

A total of 5,084 people were killed in 5,472 road crashes in 2021, 30 percent higher than the previous year, according to a police report.

Road-safety organisations put the figure much higher.

POOR SHOW OF PUBLIC TRANSPORT A total of 51.10 lakh vehicles have been registered with BRTA across the country till February this year, of which only 49,673 (0.97 percent) are buses and 27,617 (0.54 percent) minibuses. In contrast, 35,85,488 bikes (70.15 percent) and 3,85,113 (7.54 percent) private cars have been registered.

In Dhaka, 18.10 lakh vehicles have been registered till February, of which 37,593 (2.08 percent) are buses and 9,891 (0.55 percent) minibuses. A total of 9,14,817 (50.53 percent) bikes and 3,17,509 (17.54 percent) private cars have been registered, shows BRTA data.

In the first two months of this year, only 315 buses and 72 minibuses were registered across the country, in contrast to 84,583 bikes and 3,123 private cars.

Contacted, BRTA Chairperson Nur Mohammad Mazumder said people are buying more private cars as their financial condition is improving and they are getting easy loans from banks.

Meanwhile, ride-sharing services are the reason behind the rise of bikes in the city, he told The Daily Star yesterday.

Procuring vehicles for government

employees is nothing new, he said, as the SEE PAGE 4 COL 5

# Can't extract sand from Meghna: SC

The Supreme Court chamber judge yesterday stayed a High Court verdict that allowed a local Awami League leader, Selim Khan, to extract sand from the Meghna river in Chandpur.

The stay order means that no sand can be extracted from the river in the district, and if Selim Khan or any other person does it further, the local administration can take legal action against them, Deputy Attorney General Kazi Mynul Hassan told The Daily Star.

Justice M Enayetur Rahim, chamber judge of the SC's Appellate Division, passed the stay order following a petition filed by the state seeking cancellation of the HC directive.

The judge also sent the petition to its full bench for hearing on April 25.

Following a petition, the HC on April 5, 2018 allowed Selim Khan, now chairman of Chandpur's Laxmipur union and also the Awami

# Easy bikes cannot run on highways

SC passes order STAFF CORRESPONDENT

The Supreme Court yesterday allowed threewheelers, known as easy bikes, on roads in rural areas across the country. The apex court order means such vehicles cannot run on the highways. The Appellate Division of the SC passed the

order, modifying a High Court directive. The HC on December 15 last year had directed

the government to identify illegal three-wheeler easy-bikes plying and to take necessary steps to remove them.

The court also issued a rule asking the authorities to explain why their inaction in restraining import of illegal three-wheeler easy bikes and their manufacturing in the country should not be declared "illegal".

# **MOTIVE BEHIND SAGAR-RUNI MURDER** HC set to hear 10-year-old rule

The High Court is set to hold a hearing soon on a 10-year-old rule over the government's move to identify the motive behind the murders of journalist couple Sagar Sarowar and Meherun

The bench of Justice Md Mozibur Rahman Miah and Justice Ahmed Sohel yesterday ordered the officials concerned to include the matter in its hearing list. It passed the order following a prayer moved by petitioner's lawyer Manzill Murshid.

Murshid told The Daily Star that the HC may start hearing on the rule within a few days as it will be added to today's cause list.

Following the petition filed by Human Rights and Peace for Bangladesh, the HC on February 28, 2012 issued the rule asking the government to explain within two weeks why it should not be directed to identify the motive behind the murders of Sagar and Runi and bring the killers

Murshid told this correspondent that the authorities concerned of the government are yet to reply to the HC rule.

port area causing damage water animals or pollution to water or environment, the person or vessel will be punished under the Environment Conservation Act, 1995.

As per the bill, the punishment for harming environment by polluting water, land and coast has been raised to one-year imprisonment or a fine of Tk 5 lakh or both. The fine is Tk 50.000 in the existing ordinance.

According to a new provision incorporated in the bill, the punishment for dodging toll, fee and other charges of the port will invite a one-year jail term or a fine of Tk 1 lakh or both. If anyone defies the law, he will be sentenced to six months in jail or be fined Tk 2 lakh or by both. The punishment is only a six-month jail and a fine of Tk 50,000 in the existing ordinance.

According to the bill, there will be a sevenmember board to run the port. The number of the board members is now

## Two Hindu families living in fear for raising allegations against local influentials

Two Hindu families in Dinajpur are now passing days in fear of reprisal from local influentials -- including the local lawmaker's brother, land officials and police against whom the families have brought allegations of

The victims, who have already been ostracised, are now facing continuous threats of eviction from the vested quarters.

Some people appointed by the influential quarters are also holding processions and human chains, citing that the allegations against them are politically-motivated.

Bikash Roy of Phulbari upazila's Pukhurihat village and Ram Tudu of Faridabad village held press conferences at Dinajpur Press Club recently.

Bikash alleged Mushfiqur Rahman Babul, general secretary of Awami League's Phulbari unit and younger brother of the local lawmaker, runs a land-grabbing gang. Bikash's ancestors acquired a pond covering around 2.40 acres at Pukhuri Mouza in Phulbari from the local zamindar. However, it was listed as a vested property in 2003-2004 unlawfully, he said.

"We came to know about it in 2012. We filed a case against it. The case is currently under trial," he said.

Phulbari's incumbent assistant commissioner (ACland) Shamima Akter and former AC-land Kaniz Afroz leased out the pond to a local influential, who is a close aide to Babul. Subsequently, Babul took possession of the pond, said Bikash.

Phulbari Police Station's officer-in-charge Ashraful Islam was also involved with the process, alleged Bikash.

Bikash said he was being harassed by the influential quarters for raising his voice about the issue. They also filed four "false" cases against him. "We don't feel safe even inside our home. Locals have stopped selling food

Ram Tudu brought similar allegations saying his ancestors had 1.20-acre land at Faridabad. But the land was enlisted as a vested property in 2012. The officials leased out the disputed land to Babul's close-aides and four "false" cases have also been filed against him.

Contacted, Shamima Akter said she leased out the land as per law. OC Ashraful Islam said the allegations against him are baseless. Babul also denied the allegations and said he does not know anything about it.



# disaster waiting to happen

The Ratnai Bridge on Lalmonirhat-Mughalhat road in Durakuti area of Sadar upazila has turned risky as it has tilted on the west end.

The bridge over the Ratnai river may collapse at any time and cause major accidents.

Locals said the bridge has been lying in a precarious condition for long and there have been no visible steps from the Roads and Highways Department (RHD) yet. Two years ago, the 20-kilometre stretch of the road was widened and revamped spending Tk 28 crore.

But the risky bridge was not repaired or replaced with a new one to facilitate the movement of heavy vehicles. Currently the road is off limit to heavy vehicles.

Shaha Alam, a businessman from Mogholhat area, said as trucks cannot cross the bridge they have to bring goods on light vehicles increasing the



transportation costs.

Chairman of Mogholhat Union Parishad Habibur Rahman said that Ratnai Bridge is very old. It should have been declared abandoned long ago. The pillars of the bridge are now in grave danger.

The authorities concerned have been contacted on several times but no solution has been found so far, said the chairman.

Khalid Saifullah Sardar, executive engineer of RHD in Lalmonirhat, said they have got the approval and funding for the construction of a new bridge over the river at Durakuti point.

The construction work of the new bridge will start by September this year, he added.

Ukraine was preparing for what its general staff said were about 60,000 Russian reservists called in to reinforce the offensive there, while British military intelligence also said Russian troops, including contractors from the Wagner private military company, were moving to the east.

German Chancellor Olaf Scholz said Russian President Vladimir Putin and his supporters would "feel the consequences" of events in Bucha.

Western allies would agree on further sanctions against Moscow in coming days, he said, though it was not clear how quickly a new package could come together or if it would include Russian energy exports.

France's Macron said new sanctions were needed, including on oil and coal, and there were very "clear clues pointing to war crimes" by Russian forces.

His actions have created huge uncertainty in Islamabad, with constitutional experts debating their legality and pondering whether Khan and his rivals can find a way forward.

"We (the United States) don't need Pakistan as a conduit to the Taliban. Qatar is definitely playing that role now," said Lisa Curtis, director of the Indo-Pacific Security Program at the Center for a New American Security think-tank.

Khan has consistently emphasised China's positive role in Pakistan and in the world at large.

At the same time, the \$60-billion China-Pakistan Economic Corridor (CPEC) which binds the neighbours together was actually conceptualised and launched under Pakistan's two established political parties, both of which want Khan out of power.

There have been no formal diplomatic talks between the rivals for years because of deep distrust over a range of issues including Khan's extreme criticism of Indian Prime Minister Narendra Modi for his handling of attacks on minority Muslims in India.

# 99pc of people on Earth breathing polluted air: WHO

A full 99 percent of people on Earth breathe air containing too many pollutants, the World Health Organization said yesterday, blaming poor air quality for millions of deaths each year.

Fresh data from the UN health agency showed that every corner of the globe is dealing with air pollution, although the problem is much worse in poorer countries. "Almost 100 percent of the global population is still

breathing air that exceeds the standards recommended by the World Health Organization," the agency's environment, climate change and health director Maria Neira told reporters. "This is a major public health issue."

In its previous report four years ago, WHO had already found that over 90 percent of the global population was affected, but it has since tightened its limits, it said.

"The evidence base for the harm caused by air pollution has been growing rapidly and points

to significant harm caused by even low levels of many air pollutants," WHO said.

While UN data last year indicated that pandemic lockdowns and travel restrictions caused short-lived improvements in air quality, WHO said air pollution remains a towering problem.

"After surviving a pandemic, it is unacceptable to still have seven million preventable deaths and countless preventable lost years of good health due to air pollution," Neira said.

# Hong Kong leader to leave office

Hong Kong's leader Carrie Lam announced vesterday that she will step down in June, ending a divisive term that saw democracy protests squashed and strict pandemic curbs plunge the business hub into international isolation. Ending months of speculation, Lam confirmed she would not seek a second term when a committee made up of the city's political elite chooses a new leader next month. "I will complete my five-year term as chief executive on June 30, and officially conclude my 42-year career in government," Lam told reporters. Lam said China's leaders "understood and respected" her choice not to seek another term and that she wanted to spend more time with her family.

# **MED BOAT TRAGEDY** Nearly 100 die in int'l waters: MSF

Nearly 100 people have died in international waters after setting off from Libya in an overcrowded boat, international organisations said. A commercial tanker, Alegria 1, rescued four

people from a life raft in the Mediterranean early Saturday morning, the Doctors Without Borders charity said. "We know from our initial contact with Alegria 1 that the survivors reported being at sea for at least four days on a boat with nearly 100 people on board," the charity, which goes by its French

acronym MSF, said in a tweet. According to a transcript of the logbook of exchanges with the tanker, seen by AFP, the tanker said "around 96 people died in the water.'

# 'Now or never'

## Landmark UN report says only severe emissions cuts will avoid climate extremes

Drastic cuts to fossil fuel use. Growing forests and eating less meat. These are just some of the actions needed in this decade to contain global warming to 1.5 degrees Celsius above preindustrial temperatures, a major report by the UN climate science agency said vesterday.

Despite climate change warnings issued by the Intergovernmental Panel on Climate Change (IPCC) since 1990, global emissions have continued to rise in the last decade, reaching their highest point in history.

The result: global emissions are on track to blow past the 1.5 degrees C warming limit

envisioned in the 2015 Paris Agreement and reach some 3.2 degrees C by century's end.

"We left COP26 in Glasgow with a naive optimism, based on new promises and commitments," UN Secretary-General Antonio Guterres said with the report's release.

"But current climate pledges would (still) mean a 14% increase in emissions. And most major emitters are not taking the steps needed to fulfill even these inadequate promises."

At this point, only severe emissions cuts in this decade across all sectors, from agriculture and transport to energy and buildings, can turn things around, the report

has said he will not be a part of the process, that's his choice.

"We have sent two names (to the president) today. If (Shehbaz) does not send the names within seven days, one of these will be finalised".

Earlier in the day, the Cabinet Secretariat issued a notification stating that Khan had "ceased to hold the office of the prime minister of Pakistan with immediate effect".

However, under Article 94 of the Constitution, the president "may ask the Prime Minister to continue to hold office until his successor enters upon the office of Prime Minister".

"Mr Imran Ahmad Khan Niazi, shall continue as Prime Minister till the appointment of caretaker Prime Minister under Article 224 A (4) of the Constitution of the Islamic Republic of Pakistan," the

President said on Twitter. President Alvi had dissolved the National Assembly (NA) on the advice of Prime Minister Khan, minutes after Deputy Speaker Qasim Suri rejected a noconfidence motion against the premier, who had effectively lost the majority in the 342-member lower house of Parliament.

Supreme Court Chief

Justice Umar Ata Bandial, after taking a suo motu cognizance of the political situation in the country, said that all orders and actions initiated by the Prime Minister and the President regarding the dissolution of the National Assembly will be subject to the court's order as he adjourned for one day the hearing of the high-profile case.

A three-member bench held the initial hearing and issued notices to all the respondents, including President Alvi and Deputy Speaker of the NA Suri.

The Supreme Court also ordered all parties not to take any "unconstitutional" measures and adjourned the hearing until yesterday.

The opposition has challenged Khan's decision in the legal case that began yesterday, with a five-member Supreme Court bench hearing arguments in a packed courtroom.

The court failed to come to a verdict during the three-hour hearing and will return today.

Ahsan Bhoon, President, Supreme Court Bar, said that the action of the prime minister and deputy speaker was against the constitution and "they should be prosecuted for treason under Article 6 of the constitution".

# Make emergency helpline service more efficient

Install automatic location identification system, address manpower crisis

HAT'S the point of having a national emergency helpline if citizens don't have help coming their way on time? According to a report published by this daily, the helpline 999—which allows citizens in trouble to call and ask for help from police, fire service or ambulance service providers in case of any crime, accident or other emergencies—responds to distress calls at a much slower pace than that of the developed countries. While the average response time of the 999 unit in Bangladesh is about 20 minutes, it is only seven minutes in countries such as the US, the UK, and Japan. Many service-seekers even alleged that they had to wait for hours after calling the helpline.

While the helpline unit, which started its operation in December 2017, initially received 8,000 to 12,000 calls every day, now there are around 30,000 calls. And while the unit is expected to have the capacity to attend to at least 500 calls at a time, it can only take 100 calls. This is because it doesn't have sufficient manpower, or the technological/logistical support necessary to cater to the increased number of service-seekers.

The unit, importantly, doesn't have the automatic caller identification and location system, which can locate a caller's exact address instantly and significantly cut down the response time. This system, crucial for any emergency helpline, hasn't been installed even after a decision by the authorities to do so in August 2019. As a result, too much time is lost in trying to identify the locations of service seekers as the callers themselves have to provide all the information that service providers need before the latter can send a team to help them.

Also, everything—from pinpointing their locations to communicating with the various service providers to finally assigning a team to rescue or help them—is currently done manually, which is a time-consuming process. This is another example of the inefficiency of the system.

The authorities must upgrade it according to international standards. In order for the helpline to work efficiently, greater coordination among all the ministries and departments concerned is needed, because getting the required information from all is key to making the system work. In addition, the manpower crisis identified by the relevant officials must be addressed on a priority basis if the people are to get any service from the helpline. Awareness must also be raised about the importance of such an emergency service so that no one abuses the system or the service providers through blank or prank calls. These measures and reforms are vital for the system to do its work.

# A real tragedy is unfolding in Sri Lanka

# It should serve as an alarming lesson for us in Bangladesh


E are heartbroken by what is happening in Sri Lanka. Years of mismanagement and nepotism, followed by the Covid-19 pandemic and global economic instability because of the war in Ukraine, have left its economy in shambles. We sympathise with the Sri Lankans, who after years of turmoil due to civil war, have once again been thrust into great difficulty, even though they have no blame for what is currently transpiring in their country.

The island nation of nearly 22 million people has been grappling with rolling blackouts for up to 13 hours a day, as the government scrambles to secure foreign exchange to pay for fuel and other essential imports. Sri Lanka's acute foreign currency shortage has largely been driven by sharp declines in tourism and remittances—its two main sources of foreign currency. Failing to diversify its export basket over the years has pushed Sri Lanka into the worst economic turmoil in the country's history since its independence in 1948. The family-based politics practised in Sri Lanka have also led to years of nepotism and unchecked corruption, and years of poor debt management ultimately overburdened the economy to the point of complete collapse.

According to experts, what's happening in Sri Lanka should serve as a strong lesson for Bangladesh, which suffers from many of the same problems that its government high-ups refuse to even acknowledge, let alone address. And one can only hope that our government officials have the capacity to take heed of it before it's too late. While Sri Lanka is somewhat a victim of Black Swan events, its leaders totally failed to prepare the country's economy to face any unpredictable economic shocks—which somewhat predictably is bound to happen at some point. Similarly, we have also seen government high-ups in Bangladesh come out when things go wrong and claim that there was no way of them predicting the external circumstances, so what happened was not their fault. While the former might be true to some extent, there is no excuse for not establishing strong economic pillars in the country that

The tragic collapse of the Sri Lankan economy, followed by the civil strife and mass resignation of its cabinet members, should wake us up to the grave danger that we ourselves could face. We must work towards diversifying our exports and securing our macroeconomic stability, and send a strong message to our political class of the danger of them living in their own bubbles, ignoring experts' warnings and people's

# How can we stop migrant workers' deaths abroad?

→ HOBUJ, a young man from Tangail, in his late twenties, was reluctant to comply with his supervisor's instruction to enter a sewage pipe for maintenance work without an oxygen cylinder. He thought it was too risky. He had been in the Middle East for more than a year and, despite fulfilling the stipulated obligations of his work contract, his company was not issuing him the Iqama (residence card tied to employment). Shobuj was aware that the document was critical to prove his bona fide stay and employment in that land, and failure to show it on demand to the members of law enforcement agencies might entail a prison term for irregular stay. After weighing the pros and cons of not doing the task—that bore the risk of termination and deportation—and his supervisor's reassurance that the matter of his *Igama* would soon be sorted out, Shobuj descended into the unsafe sewage pipe with a couple of his workmates. Soon, they suffered from asphyxiation (presumably from entrapped gas), and Shobuj subsequently succumbed to it.

To this day, Shobuj's family has not received any explanation as to why no appropriate safety equipment was provided to him, nor what precluded the company from issuing him the *Iqama* for such a long time. No less important was the absence of any explanation as to why the family would not get any compensation for the death of an employee in an accident while performing a task that was assigned to him.

Shobuj's case is not an isolated one. Each year, thousands of workers from the Asian region die in the countries where they go to earn a livelihood. While a section of these mostly young men and women die due to road accidents and explainable causes, many such deaths cannot, in reality, be attributed to "natural causes" (that are marked in the official records), and are deemed to be "avoidable" if appropriate mitigating measures were taken by the

authorities concerned. About 70-80 percent of the 58 million migrant workers who work in the Gulf states of Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates (UAE) are engaged in low paid sectors: domestic work, hospitality or construction. A good section of them work under the open sky—those in construction sites, maintenance tasks, orchards or tending animals. Their exposure to heat, humidity and dust storms is relatively higher than those who work in covered compounds. Despite periodic expressions of concerns by a few international rights bodies and limited reporting in the mainstream media, there is a paucity of organised information, data and research on this important issue. A recent multi-country research and advocacy initiative, named the Vital Signs, produced a report titled "The Deaths of Migrants in Destinations" and helped trigger discussions at the national level in a few countries of origin, including Bangladesh.

The principal focus of this initiative is to gather evidence about the experiences of migrant workers who often work and live in difficult and unsafe conditions that can lead to their deaths. It also attempts to engage with members of the workers' families to understand the

trauma and uncertainties they endure when often the sole breadwinners in their families meet untimely and unwarranted deaths. The study and the related national consultations of stakeholders that were held in Bangladesh, India and Nepal in March 2022 have noted that the lack of recognition of the migrant workforce's contributions in the economic development of the countries of destination (CoDs) and the absence of a right-based regime for workers increase their vulnerability. The destination states' lack of initiative for protection of lowskilled migrant workers, and their ability to source workers from another country if one country insists on better protection of its nationals, accord them with undue economic and political leverages over the sending countries. In addition, competition among the labour sending countries to secure a share of the Gulf labour market and the perceived benefits of outward migration (most importantly in the form of remittances) have often discouraged those countries to collectively articulate the demand for better protection of their migrant workforce in the regional and global forums and processes.

Over the years, right groups, trade unions, academics and the media have made detailed documentation of serious abuses of workers and the gaping holes in the protection systems of the destination countries. They also underscored the critical gap in research pertaining to how many workers are dying and the reasons for their deaths. Allegations have been rife that the Gulf states have largely avoided structural labour reforms, while the countries of origin (CoOs) have been unable to ensure proper protection for their citizens abroad.

Studies have claimed that none of the Gulf states have laws to adequately mitigate the risks faced by outdoor workers in extremely harsh climates, and have only addressed the issue with rudimentary blanket ban for stipulated hours during summer. Recent findings in medical research have noted that migrant workers engaged in strenuous work in harsh climatic conditions are likely to suffer from chronic kidney disease (CKD). There is also growing evidence that links poor air quality with acute mortality.

All these, compounded by the challenging-if not abusive-working conditions, including excessive working hours, also take toll on the physical and mental well-being of the migrant workers. Feelings of alienation and isolation and the lack of rest and leisure also contribute to their sufferings. Job insecurity, unhygienic living conditions, lack of access to redress mechanisms, and pressure of debt repayment expose migrant workers to long-term chronic psychosocial stress and are likely to have a detrimental impact on their mental and physical health. There is a growing body of evidence that highlights dangers inherent in work and lax occupational health and safety practices in sectors that employ low-skilled migrant workers. Psychiatric experts in the Gulf have noted that the mental health of migrant workers in the region "is underdocumented, underresearched and underreported."

Demanding and long working hours without rest, leisure and weekly or annual holiday, having to serve in more than one establishment, lack of privacy and private space, and lack of freedom to move and communicate with relatives and friends (including over phone) contribute to the alienation and isolation felt by female workers. In some instances, this is further compounded by physical, verbal and sexual abuse by their employers, followed

by distrust and mental torture inflicted by their partners residing in their home countries. All these take a toll on female workers' mental and physical well-being.

The condition of workers with irregular status is particularly dire. Their insecurity of job and poor working and living conditions harm their mental health. The constant worry of being apprehended, incarcerated and subsequently deported precludes them from accessing healthcare services when they fall sick. It may be noted that in many instances, irregularity in status of migrant workers is not a matter of choice for the concerned workers.

The Covid pandemic has further exacerbated the pre-existing fissures in the healthcare services for low-skilled migrant workers in the CoDs. In view of the fresh evidence generated by the multicountry study on the deaths of migrant workers, both CoOs and CoDs need to take measures to mitigate the health and safety problems that contribute to the untimely and unfortunate deaths of a section of low-skilled migrant workers.

The CoDs need to establish specialised teams of inspectors and medical examiners to ensure that all deaths of migrant workers are investigated and certified in accordance with best international practices. They should commission independent investigations into the causes of migrant workers' deaths, and examine the possible role played by heat and humidity, overwork, air pollution, psychosocial stress, and the workers' ability to access healthcare. There is also the need to take account of circumstances and contexts where invasive autopsies are not possible, and introduce non-invasive and verbal autopsy procedures after consultation with experts.

The CoDs should pass legislation to address the occupational risk of heat stress and ensure mandatory break times. They should also conduct widespread screening and treatment programmes for hypertension and institute studies to find the prevalence of CKD or early-stage kidney disease among low-paid migrant workers.

Destination countries should make primary and emergency healthcare for low-paid migrant workers free of charge, irrespective of their immigration status, and ensure that they have access to mental as well as physical healthcare. CoDs also need to improve the quality of available data on mortality statistics for migrants disaggregated by age, gender, occupation, nationality, date of death, and underlying cause of death to allow comparison across multiple categories.

The CoOs should collect and make available all data on deaths of overseas workers, disaggregated by destination. occupation, age, gender, date of death and cause of death, adhering to the World Health Organization's International Classification of Diseases. In cases where death certificates provide no underlying cause of death—for example, when they are certified without further context or explanation to "natural causes," "cardiac arrest," "acute heart failure" or "acute respiratory failure"—they should be attributed to the ICD code that refers to "ill-defined or unknown cause of mortality" in government records.

The CoOs need to strengthen the capacity of their embassies to deal with death cases and ensure that families can secure compensation when they are entitled to it. The countries of origin should ensure that the issues of investigation into their migrant workers' deaths, protection from risks to migrant workers' health, and migrant workers' access to healthcare are on the agenda of regional processes such as the Abu Dhabi Dialogue and the Colombo Process.

# A travesty of democracy

**¬** ACING the ignominy of being ♦ voted out, Pakistan's Prime Minister Imran Khan has taken an unprecedented step—advising the president for dissolution of the National Assembly and calling for early elections. In what many believe to be a blatant violation of the rules, the deputy speaker declared the no-confidence motion illegal on the basis of what he described as a "foreign conspiracy," thereby scuttling the much-anticipated vote that would decide whether Imran Khan remained in office

Reacting in the immediate aftermath of Sunday morning's events, Ahmed Bilal Mehboob, who heads the think tank Pildat, pointed out in a TV broadcast that Fawad Chaudhry had hardly finished asking Qasim Suri for a ruling that the former deputy speaker began to read out a ruling—no doubt prepared in advance-showing that there had been no "application of mind" to the matter and a pre-prepared plan had been followed.

It was evident that with the crumbling of the ruling coalition and defeat looming in the numbers game, the prime minister had lost the confidence of the house, and that this was a last-ditch attempt to escape his imminent ouster. The development has now plunged the country into a constitutional crisis. The Supreme Court has taken suo motu notice of the matter, and the whole country is awaiting its ruling over the government action.

Lawyer Faisal Chaudhry, who is the brother of former Information Minister Fawad Chaudhry, said there were judgments of the Supreme Court that put Article 5 of the constitution "above all other matters.'

Speaking on a TV channel, he also said that the court would have to have a deeper look into the "Lettergate" affair—a reference to the "threat letter" from a foreign country that Prime Minister Khan has repeatedly alluded to as proof that the no-confidence move was a part of a global conspiracy.

Last week, the PTI government had approached the military leadership to salvage the situation. Over the past several months, the security establishment had taken a step back, leaving the government to fight its own political battles with a re-energised opposition alliance. This



decision seemed to encourage the opposition to step up its attacks on the government.

It also triggered an unravelling of the fragile coalition and led to a rise in the number of dissidents within the ruling party's ranks. The PTI government has been floundering for some time, but no one expected it to unravel so quickly. The rising number of party defectors had also shaken the government and things were looking extremely grim for the embattled prime minister.

By his own admission, the ISI chief had reportedly given Imran Khan three options: face the no-confidence vote, resign or go for elections. Imran Khan apparently opted for the third option, provided the opposition withdrew the no-confidence motion. The shrewd opposition, however, refused and asked for the prime minister's resignation in order to end the showdown. That, many believe,

Meanwhile, the prime minister piloted a fresh narrative: that the opposition's no-confidence motion was part of a "USbacked conspiracy." He also claimed that he was being threatened for not accepting foreign dictation and for pursuing an

change in Pakistan.

The line that most people point to in the communiqué issued after the meeting is, "The committee concluded that the communication amounted to blatant interference in the internal affairs of Pakistan by the country in question, which was unacceptable under any circumstances."

However, any expert will tell you that this is standard diplomatic parlance whenever a third country comments on matters considered internal by any sovereign state.

But the contention was used by the government to throw out the noconfidence motion.

What is most troubling is that the PTI government is using the issue to declare opposition leaders "foreign agents" and "traitors." The use of this "ultra-nationalist" card could prove to be extremely dangerous for the country and could harm Pakistan's national interest. The prime minister has been using religion to galvanise his right wing support base. He has declared the unfolding power struggle "a battle between good and evil"-rhetoric that has made the political environment extremely volatile.

Imran Khan's latest move is a further demonstration of his contempt for parliament and the democratic process. Such unconstitutional steps will only weaken democracy further. Surely, elections are the only solution to current political crisis in the country, but the "apparently unconstitutional" means employed to block voting on the noconfidence resolution sets a bad precedent and cannot be tolerated.

In the words of Deputy Attorney General Raja Khalid Mehmood Khan, the federal government has "toyed" with the law of the land. In his view, the deputy speaker's action was totally in violation of the constitution.

What we witnessed in the National Assembly on Sunday was a travesty of democracy, and what the prime minister doesn't realise is that his surprise "trump card" could easily turn into a nightmare for him if the Supreme Court deems the government's actions "not kosher."

The global movement, which empowers women at societal and policy-making levels, has now spread over to 27 countries, including an active chapter in Bangladesh, which started out in 2019.



Having played spinners in surfaces that are more conducive to spin, it was surprising that Mominul Haque and his troops were not up to the mark with the bat, having fought so well over four days.

"We couldn't handle the pressure of losing three wickets yesterday very well. I don't see any other reason," Mominul said at a press conference yesterday after Bangladesh's 220-run loss.

"I think it's a crime to give wickets to spinners on foreign soil. You should not give wickets to spinners while playing overseas. And that's why I think I am the one most accountable for such a plight. Obviously, it is a batting failure," the skipper added.

That Bangladesh gave South Africa a fight for four days and had a real opportunity in the game, chasing 274 in the fourth innings, could also be seen from the way South Africa tried to provoke the Tigers, often in verbal terms. Mominul felt that the on-field behaviour from the Proteas often went overboard. South Africa

however managed to rile up the Tigers, who had been frustrated with a few umpiring calls on day

"It is normal that there will be sledging on the field. But if sledging crosses the line, then it's a problem," Mominul opined on the matter.

Despite the controversial issues,

Despite the controversial issues, Bangladesh can take heart from their performances in the first Test. Mahmudul Hasan Joy's 137 -- becoming the first Bangladesh batter to score a Test ton against South Africa --

showed how to handle pressure situations and Khaled Ahmed's four-fer in the first innings made pacers' contribution more pronounced.

Mominul felt his team will be able to bounce back from this match but it remains to be seen whether experienced heads such as his and Mushfiqur Rahim's, who batted during those crucial stages when Bangladesh were dwindling to spin, can take up the challenge and put up better contributions in the next Test at Port Elizabeth on April 8. Bangladesh's **53** in the second innings against South Africa in the first Test is the Tigers' second-lowest total in Tests and also the lowest by any team in Durban.

Keshav Maharaj and Simon Harmer's **10** wickets in the second innings is only the third instance of South Africa's spinners taking all the wickets in an innings.

It is the first time in **72** years that South Africa scalped all 10 wickets in an innings in Tests with spinners.

It was the first time in over **100** years that a seamer didn't bowl a single delivery in a completed innings for South Africa.

Bangladesh's second innings lasted for **114** deliveries. There have only been five instances of a complete innings lasting fewer deliveries in the last **50** years.

Big-budget outfit Sheikh Russel survived another scare in the Bangladesh Premier League when they came from behind to play out a 1-1 draw against Rahmatganj MFS at the Bashundhara Kings arena yesterday.

# Guardiola promises new tactics against Atletico Madrid

Benfica face a gargantuan task in the Champions League quarter-finals on Tuesday but after already knocking out Barcelona and Ajax, there is belief they can spring another surprise against Liverpool.

Many circled Benfica as the kindest opponent available when the draw was made in Nyon last month, with this the furthest the Portuguese club have gone in the Champions League in six years.

The last time Benfica made the semis, they went on to reach the final, in 1990, when a team coached by Sven-Goran Eriksson lost 1-0 to AC Milan and missed

out on lifting their third European Cup.
That was the last time Benfica really belonged with Europe's elite and it would be the shock of the round if they were to upset Liverpool, who, along with Manchester City, are surely this year's tournament favourites.



"We know it's Liverpool, but we have to fight, we can play better," interim coach Nelson Verissimo said on Friday.

Meanwhile, Manchester City manager Pep Guardiola admitted that he overthinks and comes up with "stupid tactics" in the Champions League but would not have it any other way as he prepares for Tuesday's quarter-final tie with Atletico Madrid.

Guardiola, a two-time winner of the

competition as a manager with Barcelona, has not won the trophy in 11 years and his teams have often fallen in the knockout stages due to unexpected tactical tweaks and team selection which have caused his system to fail.

"In the Champions League I always overthink -- new tactics, tomorrow you will see a new one. I overthink a lot, that's why I have very good results in the Champions League," Guardiola told reporters on

Monday.
"It would be boring if I always played the same way. If people think I play the same against Atletico and Liverpool, I don't like

(that).
"The movements are different, the players are all different with different personalities. That's why I overthink and create stupid tactics. Tonight I take inspiration and I'm going to (come up with) incredible tactics tomorrow."

# Mominul takes the blame for Durban debacle

It took just 55 minutes and 13 overs for South Africa to wrap the game up on the fifth day of their first Test against Bangladesh as Keshav Maharaj and Simon Harmer spun the hosts to a crushing 220-run victory at Kingsmead in Durban yesterday.

Resuming the final day on 11 for three in chase of a 274-run target, Mominul Haque and his troops were bundled out for just 53 -- the Tigers' second-lowest total in Tests. This is also the lowest ever second-innings score

Left-arm spinner Maharaj registered his best bowling igure at home, picking up his eighth five-wicket haul. He bagged seven wickets for 32 runs in 10 overs. Off-spinner Harmer, who too scalped seven wickets in the game, bagged three in the second innings as the two spinners accounted for all the ten wickets of the visitors.

Maharaj and Harmer shared 14 wickets between them in the Test as the Bangladeshi batters surrendered helplessly on the final day despite remaining competitive till the fourth day of the match.

The game was not free of dispute as questions were raised by the Bangladesh team management over a few decisions by the umpires. Bangladesh players were also not happy with the sledging faced during the game.

Bangladesh skipper Mominul, however, admitted that he was unable to lead from the front and held himself accountable for the debacle in the second innings.

"Being the captain, I am the one most accountable. I could not take responsibility in both innings. So, I take full responsibility. As a captain, I could not lead from the front. If I were able to lead from the front in both the innings, the result of the match would have been

# Imran nominates ex-CJ as caretaker premier

Move comes as SC adjourns without ruling on his decision to dissolve parliament, call for snap polls

Embattled Pakistani leader Imran Khan yesterday nominated former chief justice Gulzar Ahmed for the office of caretaker prime minister, as the top court adjourned without deciding on the legality of Khan's actions blocking an opposition attempt

Former information minister and senior leader of the Pakistan Tehreek-e-Insaf party Fawad Chaudhry said that Khan made the decision after approval from the party's core

The announcement comes after President Arif Alvi sent letters to Khan and Leader of the Opposition Shehbaz Sharif yesterday seeking suggestions for the appointment of a caretaker prime minister.

"In response to the President's letter, after consultation and approval by the PTI Core Committee, Prime Minister Imran Khan has nominated Pakistan's former chief justice Gulzar Ahmed for the post of caretaker Prime Minister," Chaudhry said.

In his letter, President Alvi told them in case they do not agree on the appointment within three days of the dissolution of the Parliament, they shall forward two nominees each to a committee to be constituted

> by the Speaker, comprising eight members of the outgoing assembly, or the Senate, or both, having equal representation from the treasury and the opposition, reports The D

The Constitution has empowered the president to appoint a caretaker prime minister in consultation with the prime minister and the leader of the opposition in the outgoing National Assembly, the

President's Secretariat said in a statement. Imran Khan is supposed to continue as Prime Minister until a caretaker premier is appointed, according to the notification issued by President

Meanwhile, Shehbaz Sharif said that he would not take part in the process and termed it "illegal", saying that the President and Khan had broken the law and questioned how they could approach the opposition, reports NDTV online.

Reacting to Sharif's decision, outgoing information minister Fawad Chaudhry said: "Pakistan is gearing up for the elections... Shehbaz

# Man's phone last traced in Uttara

The family of a pisciculturist, who allegedly became a victim of enforced disappearance, has claimed that the last known location of his iPhone, traced using an app, was adjacent to the Rab-1 office in the capital's Uttara.

Imam Mahadi Hasan Dollar was picked up on November 6 last year from Mymensingh, by men in plainclothes, his wife Mumta Hena Pinky said at a press conference at the Jatiya Press Club yesterday.

"Dollar's motorcycle was parked on the main road. The area is called Bottola-Chhankanda. He was walking back to the bike from his fishery. This was when he was picked up," said Pinky.

Locals in the area, who witnessed the incident, described to the family members what happened: four to five men hauled Dollar into a microbus and left. There were also two motorbikes. All of them were in plainclothes. The time was around

"One of the witnesses who knew our family, informed the matter to my father-in-law. They said the microbus had been parked at that spot all day," said Pinky.

"Two days after the incident, we filed a general diary over the matter," said

Pinky. "We did not file a

case, because when we went to the Fulbaria Police Station, and the Mymensingh CID office, they told us that it was useless to file a case. I asked for advice and they recommended filing a general diary."

She added that she had also gone to the Mymensingh Detective Branch office, looking for her

husband, a week after his disappearance. An officer there told her, "I understand what happened to your husband. Go home and pray to Allah. Maybe you will get a phone call, telling you where he is, or that he will come home on his

Pinky said, "I asked him to register a complaint and investigate. He said it was not possible."

Dollar's younger brother Rezvi said they tried to locate Dollar's mobile phone using an app available on all iPhones.

The app that helps recover lost or stolen devices located the phone inside the Rab-1 compound, claimed Rezvi.

location taken on December 12, 2021. In another screenshot, the phone was located on Shayesta Khan Avenue, the road right adjacent to the compound.

"It was December 12 when his phone could be located last. I haven't found it since then," said Rezvi, claiming the app has been turned off on his brother's phone.

The family has contacted the National Human Rights Commission, which sent a letter to the home ministry requesting an explanation regarding Dollar's alleged disappearance. They are still waiting for a response.

"A month ago, officers from Rab-14 came and took his passport, saying they were filing a report on missing people. They asked my father-in-law to submit a statement stating he is missing, and he did it," said Pinky.

# Global outrage spreads

## Moscow denies accusations of war crimes

Global outrage spread yesterday at civilian killings in north Ukraine, including evidence of bound bodies shot at close range and a mass grave found in areas retaken from Russian troops, as fighting raged on in the country's south and east.

Taras Shapravskyi, deputy mayor of Bucha, a town around 40 km northwest of Kyiv city, said 50 of some 300 bodies found after Kremlin forces withdrew late last week were the victims of extra-judicial killings carried out by Russian troops.

Ukrainian authorities said they were investigating possible war crimes there, a description also used by French President Emmanuel Macron. The Kremlin categorically denied any accusations related to the murder of civilians in the

Reuters reporters in Bucha saw one man sprawled by the roadside, his hands tied behind his back and a bullet wound to his head. A mass grave at a church

remained open, with hands and feet poking through red clay heaped on top.

Pictures of the destruction and civilian deaths in Bucha looked set to galvanise the United States and Europe into fresh sanctions against Moscow.

The images were also poised to overshadow peace talks between Russia and Ukraine, due to restart by video link yesterday against a backdrop of artillery bombardments in Ukraine's south and east, where Russia says it is now focusing its operations after withdrawing from around Kviv.

Ukrainian television showed smoking fuel tanks and fire trucks near the Black Sea port of Odesa.

In Mariupol, another strategic southern port that has been under siege and shelled for weeks, the skeletal remains of residential tower blocks and other buildings surrounded by white cement dust and debris dominated the skyline, Reuters images showed.
